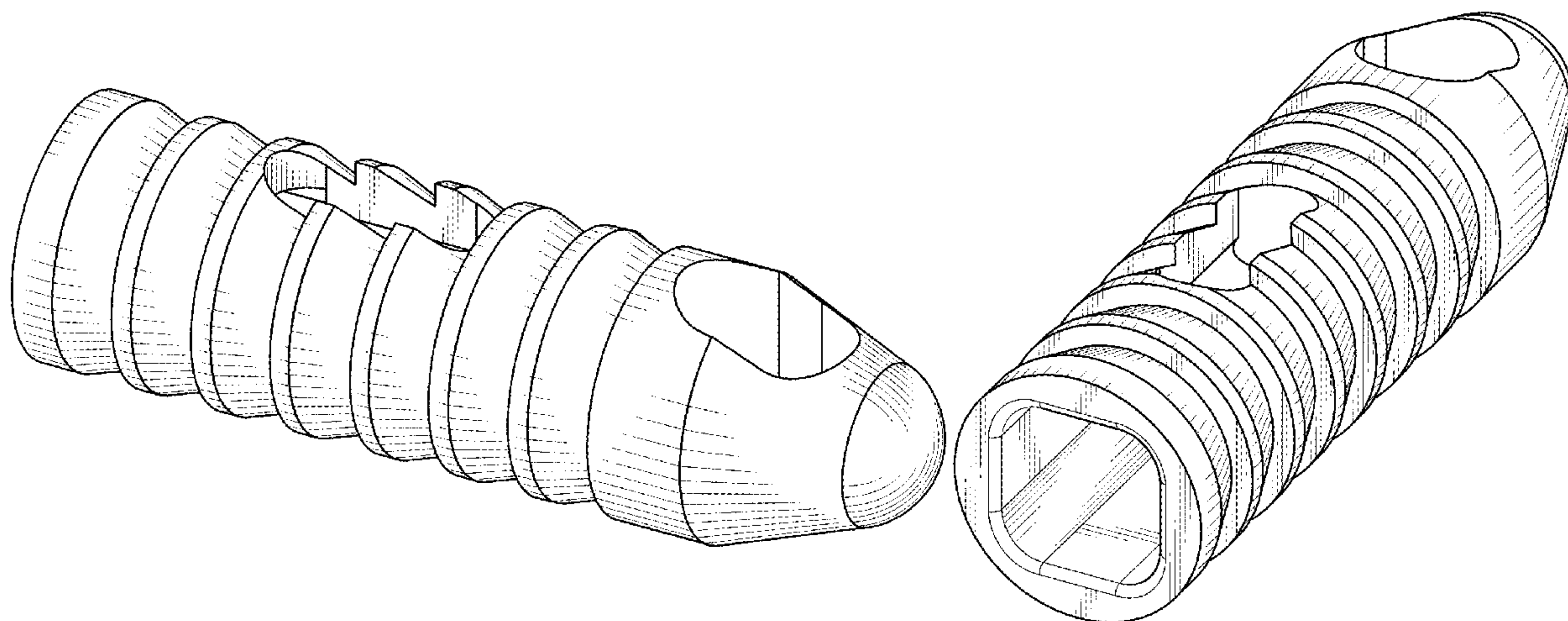
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an suture anchor showing my new, original and ornamental design;
 FIG. 2 is a rear perspective view thereof;
 FIG. 3 is a top view thereof, the bottom view thereof being identical in appearance;
 FIG. 4 is a side view thereof, the opposite side view thereof being identical in appearance;
 FIG. 5 is an enlarged front end view thereof; and,
 FIG. 6 is an enlarged rear end view thereof.

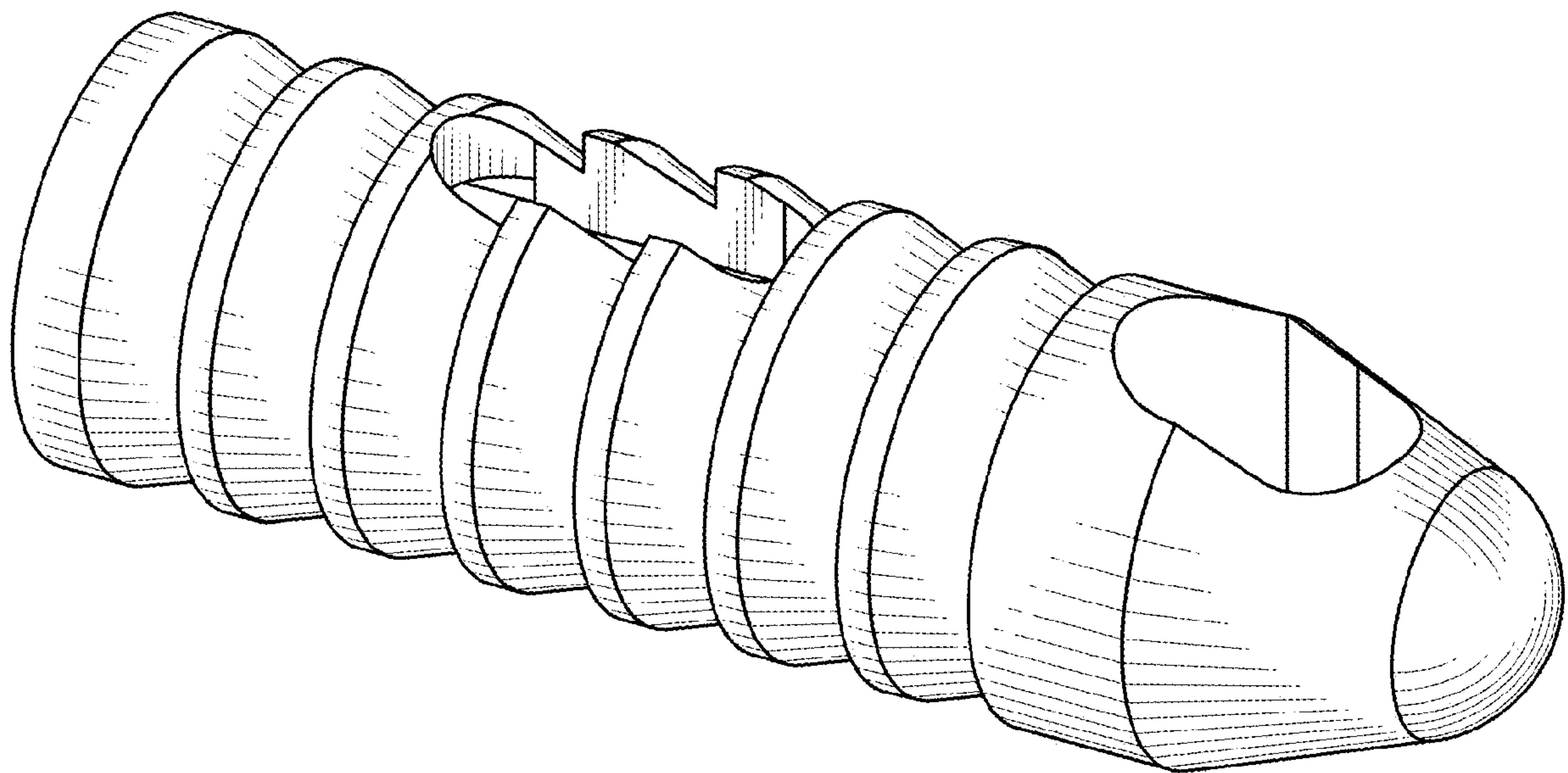

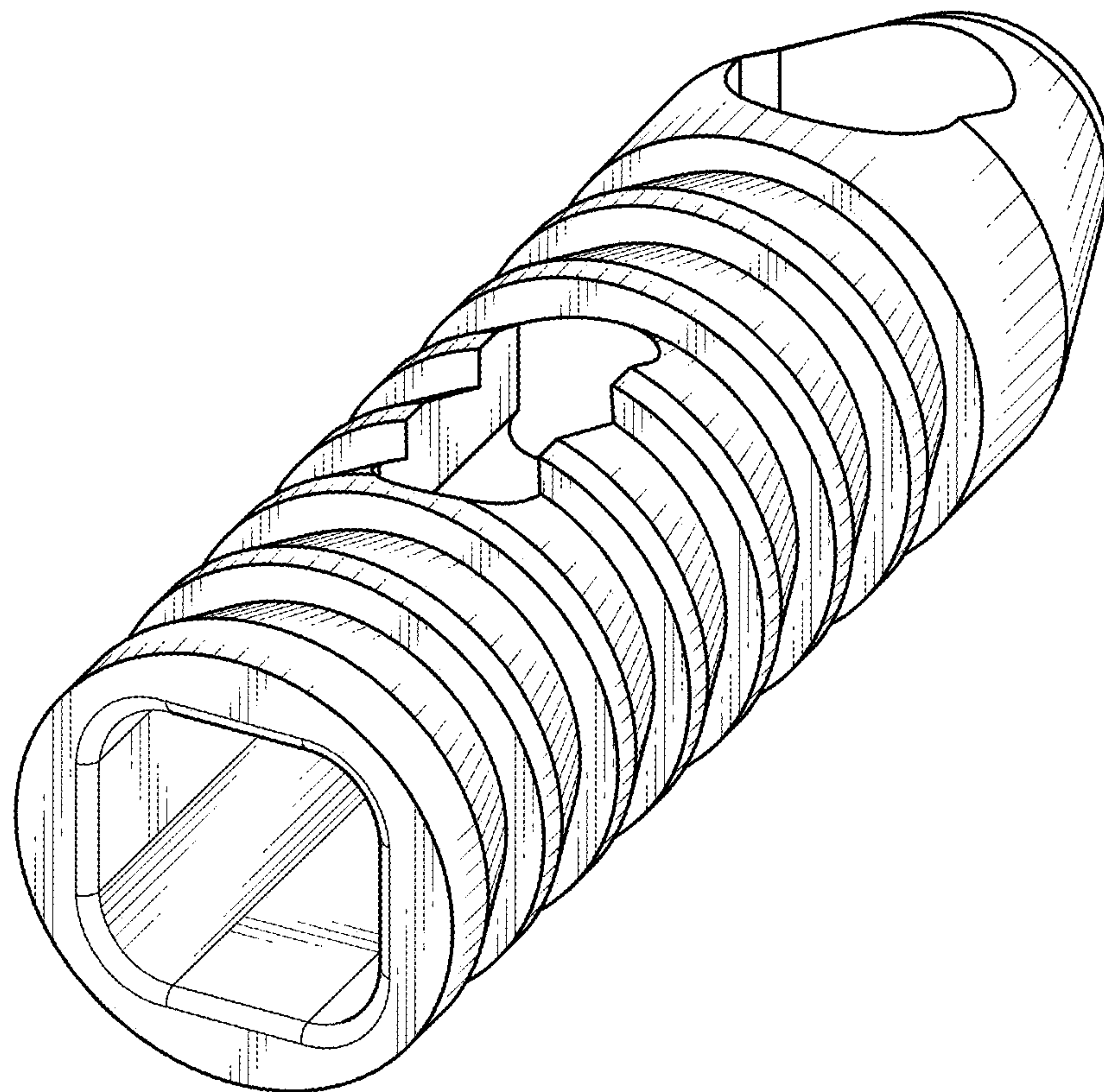

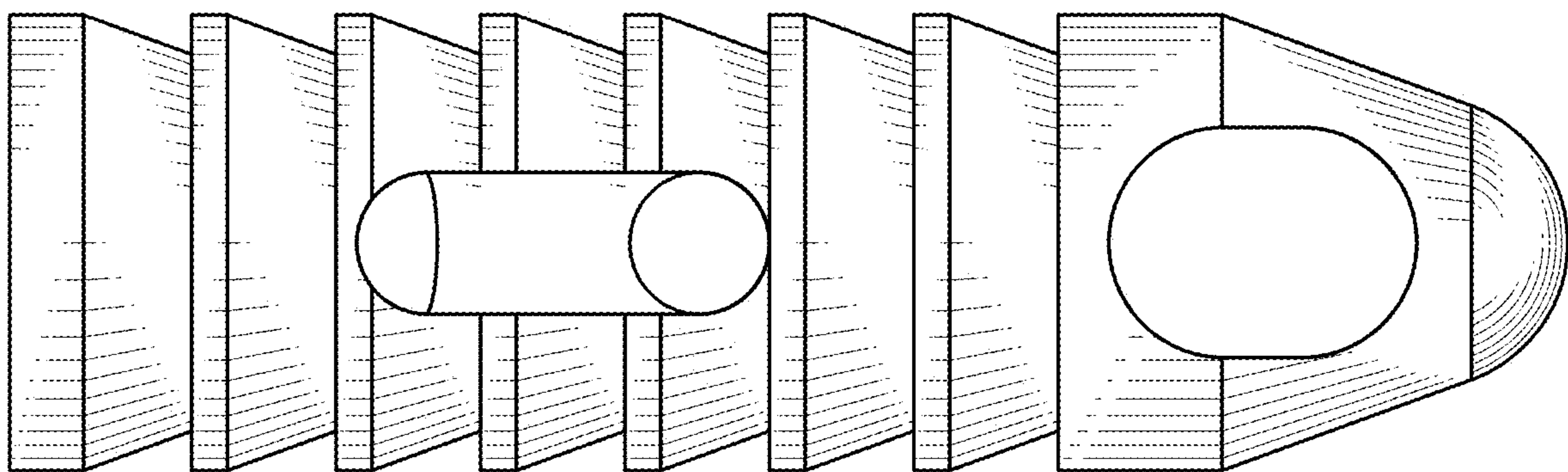

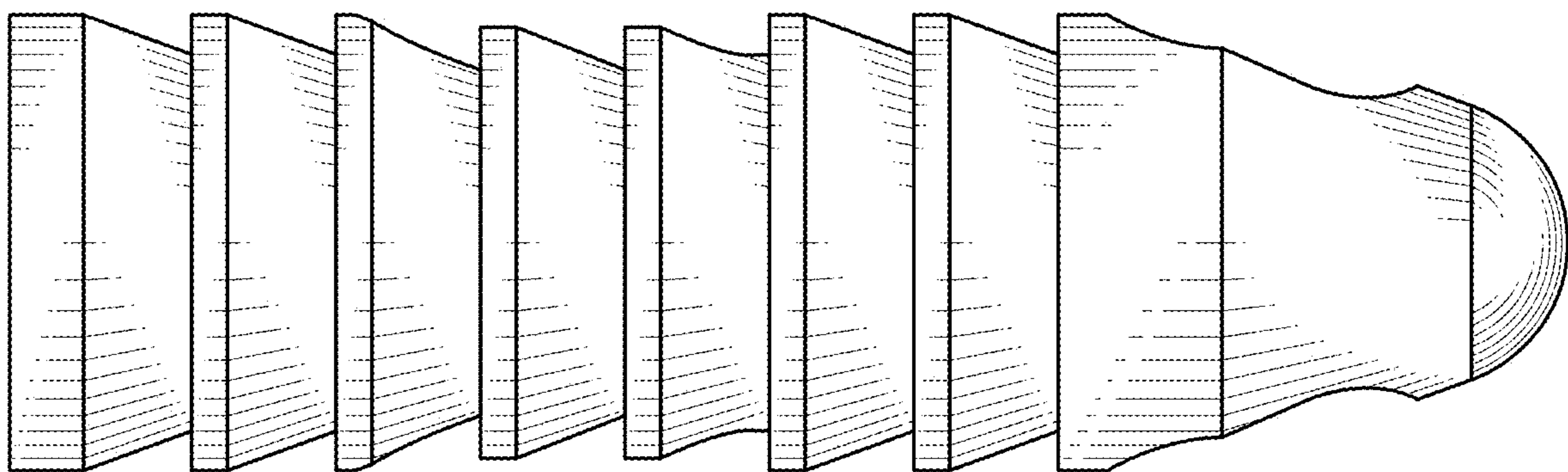

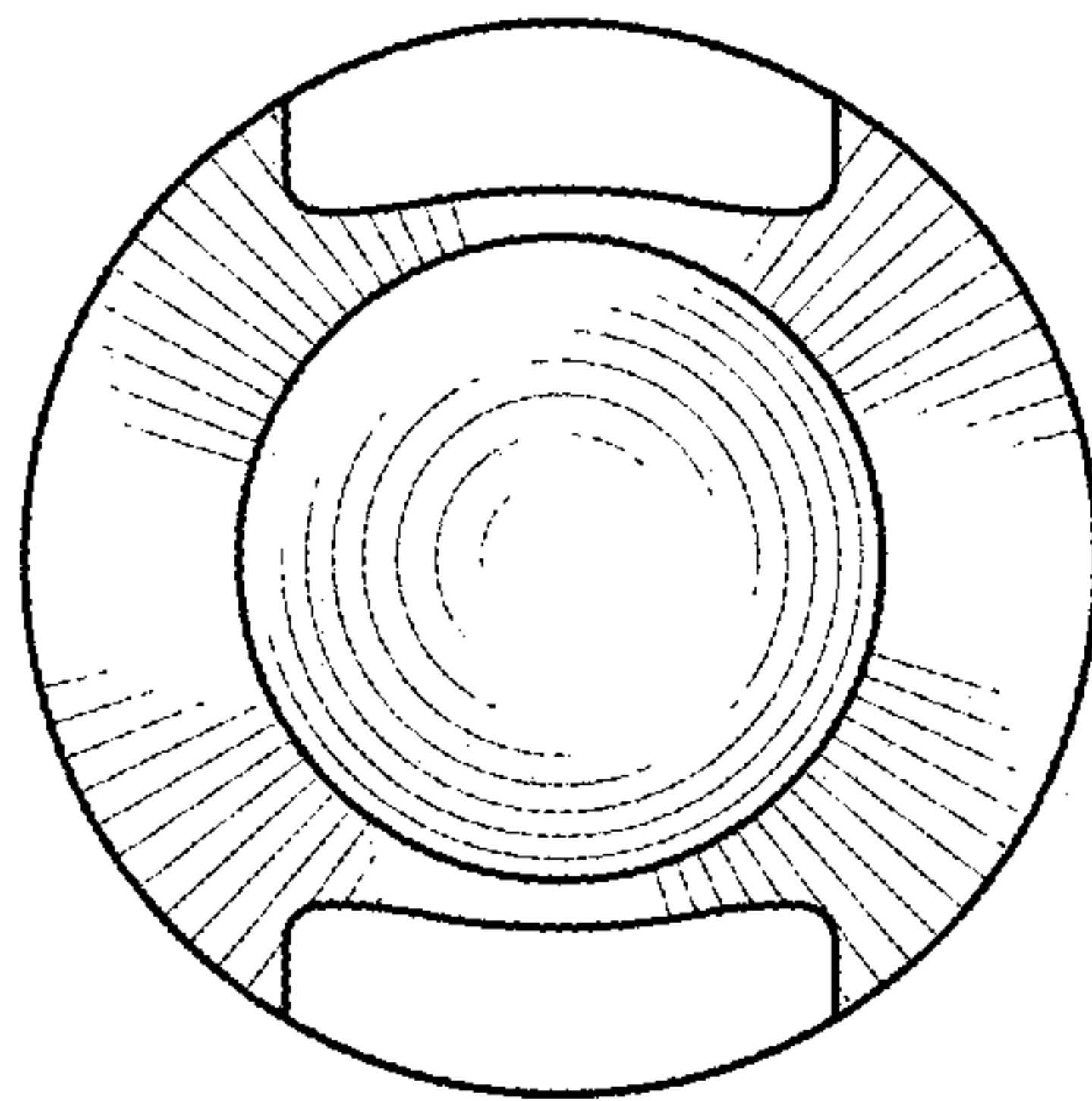

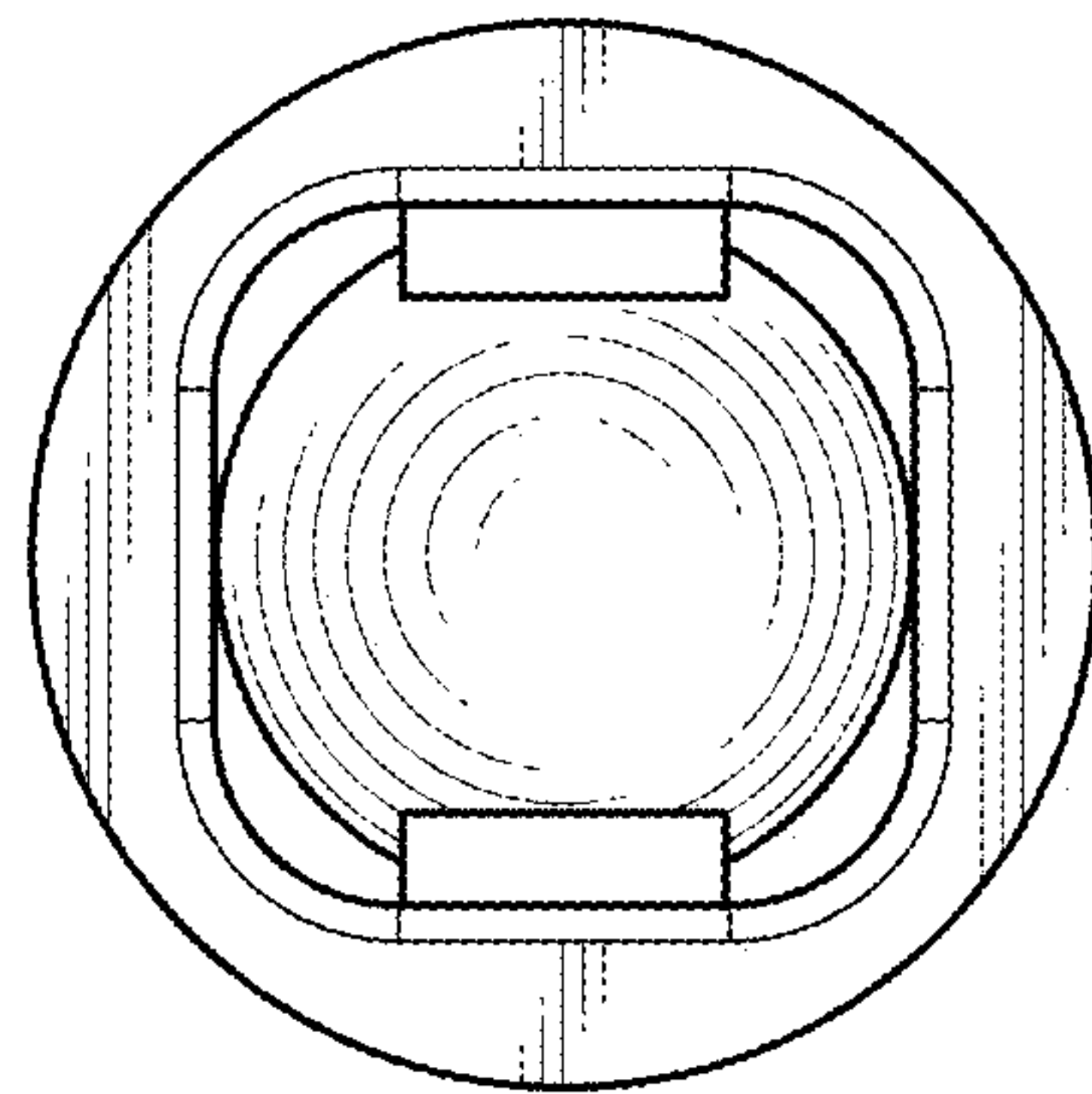
