The ornamental design for a nose tab, as shown and described.

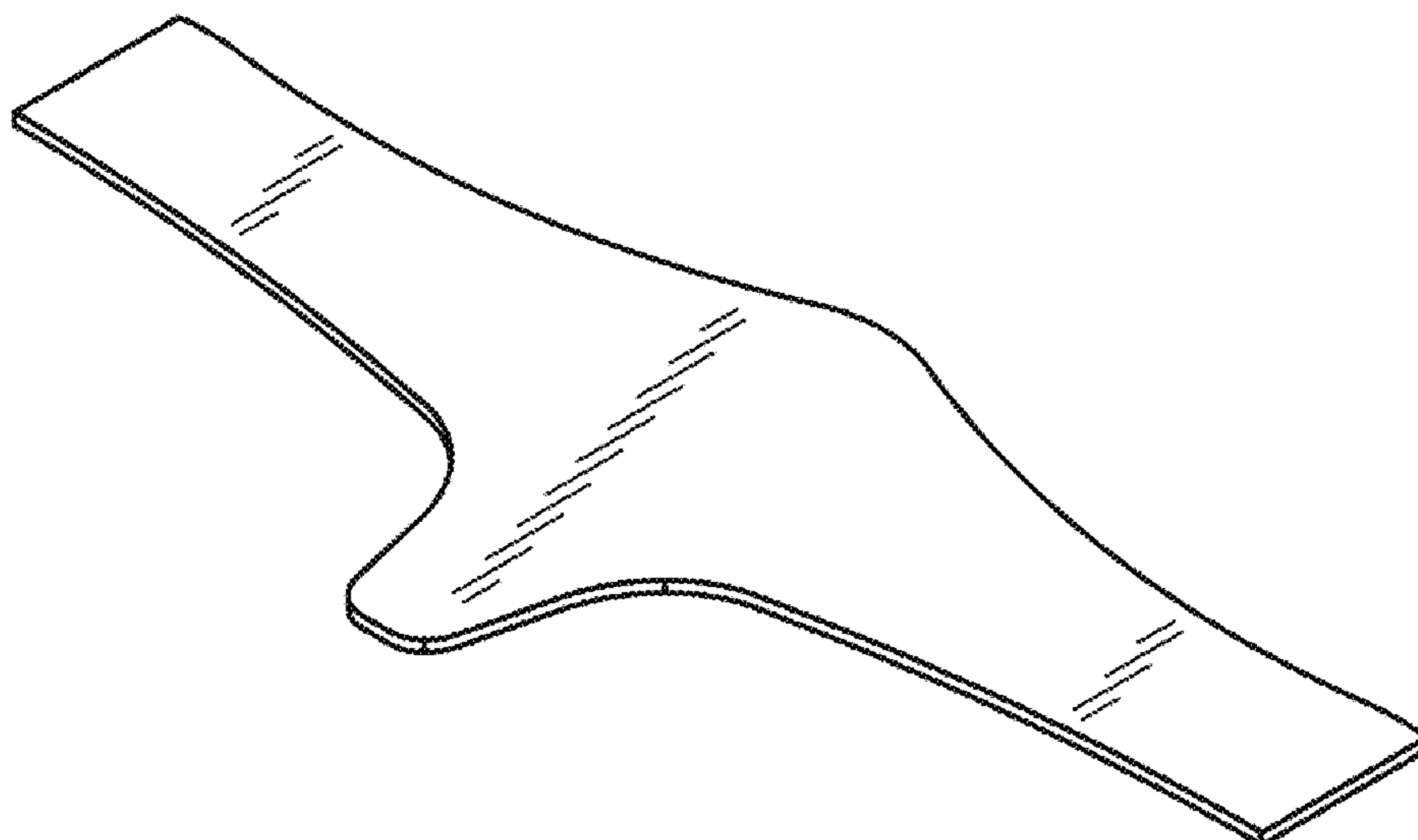
DESCRIPTION

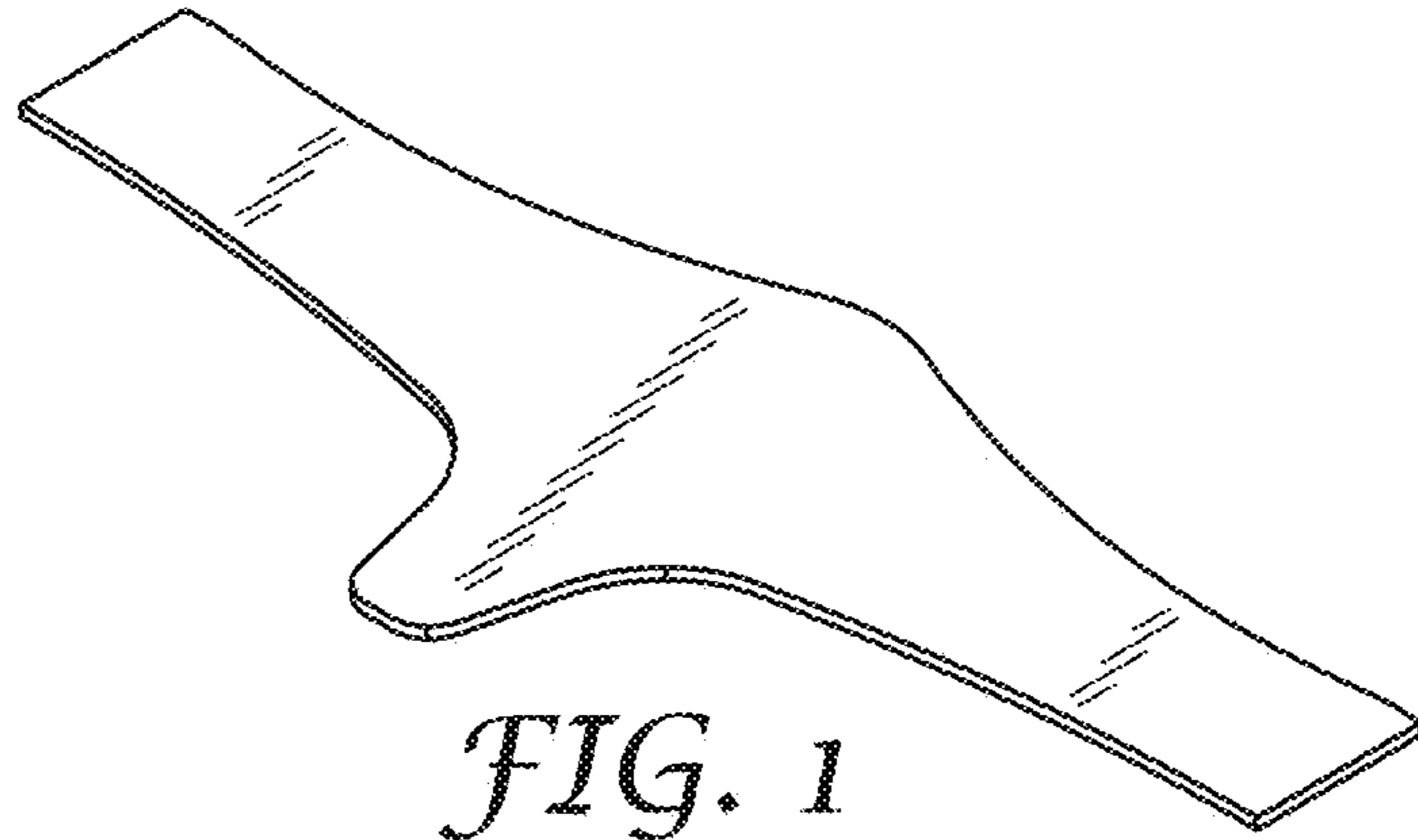

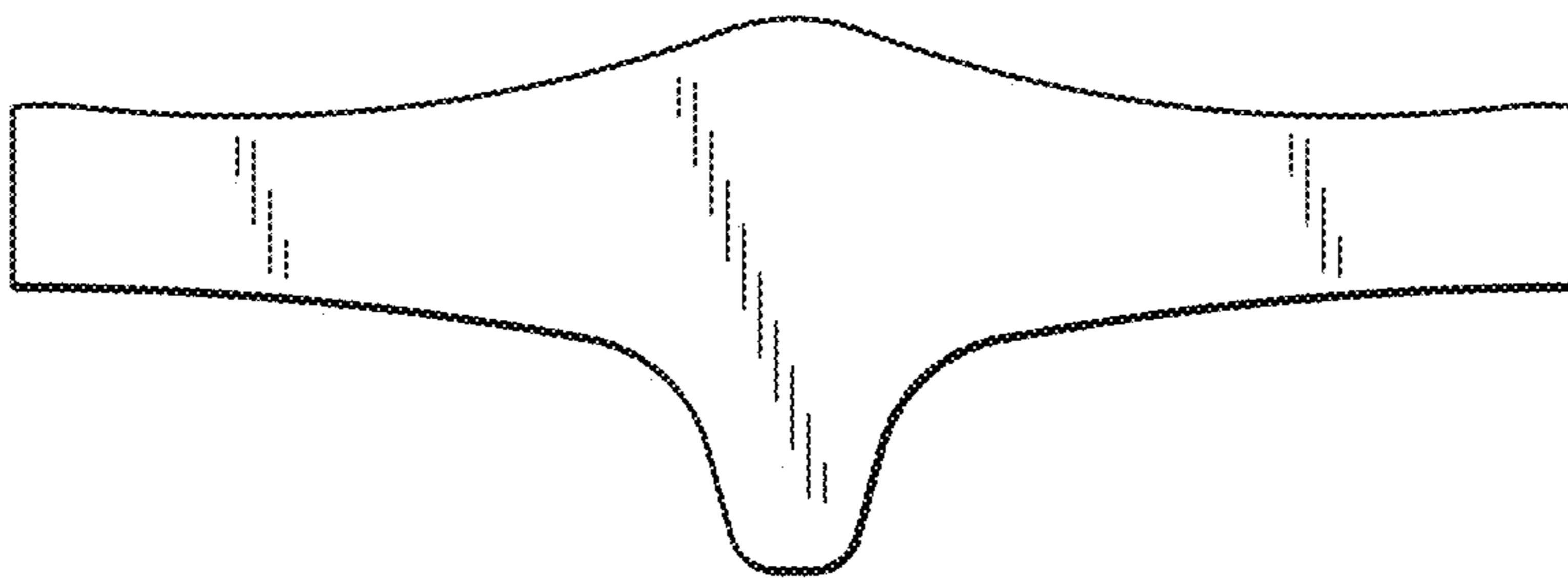

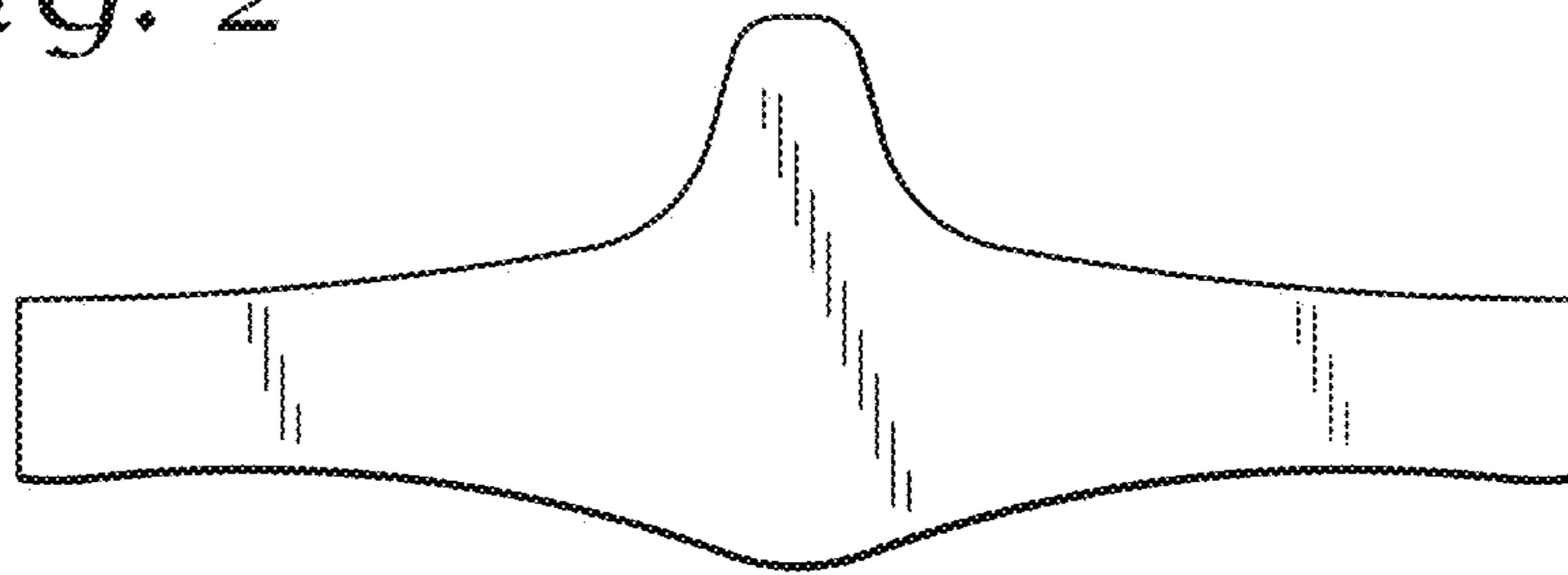
