(57) **CLAIM**

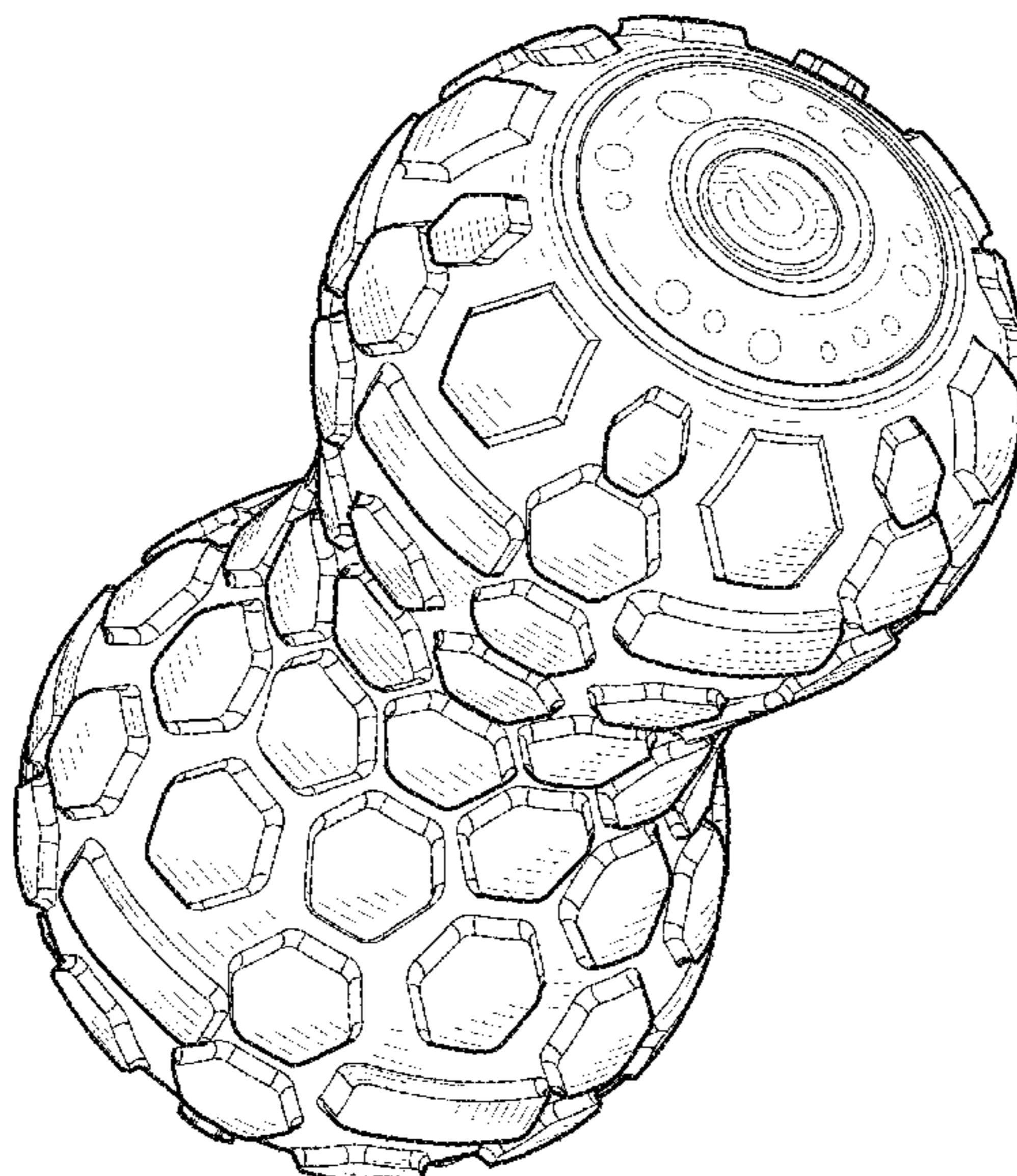
The ornamental design for a massage roller, as shown and described.

**DESCRIPTION**

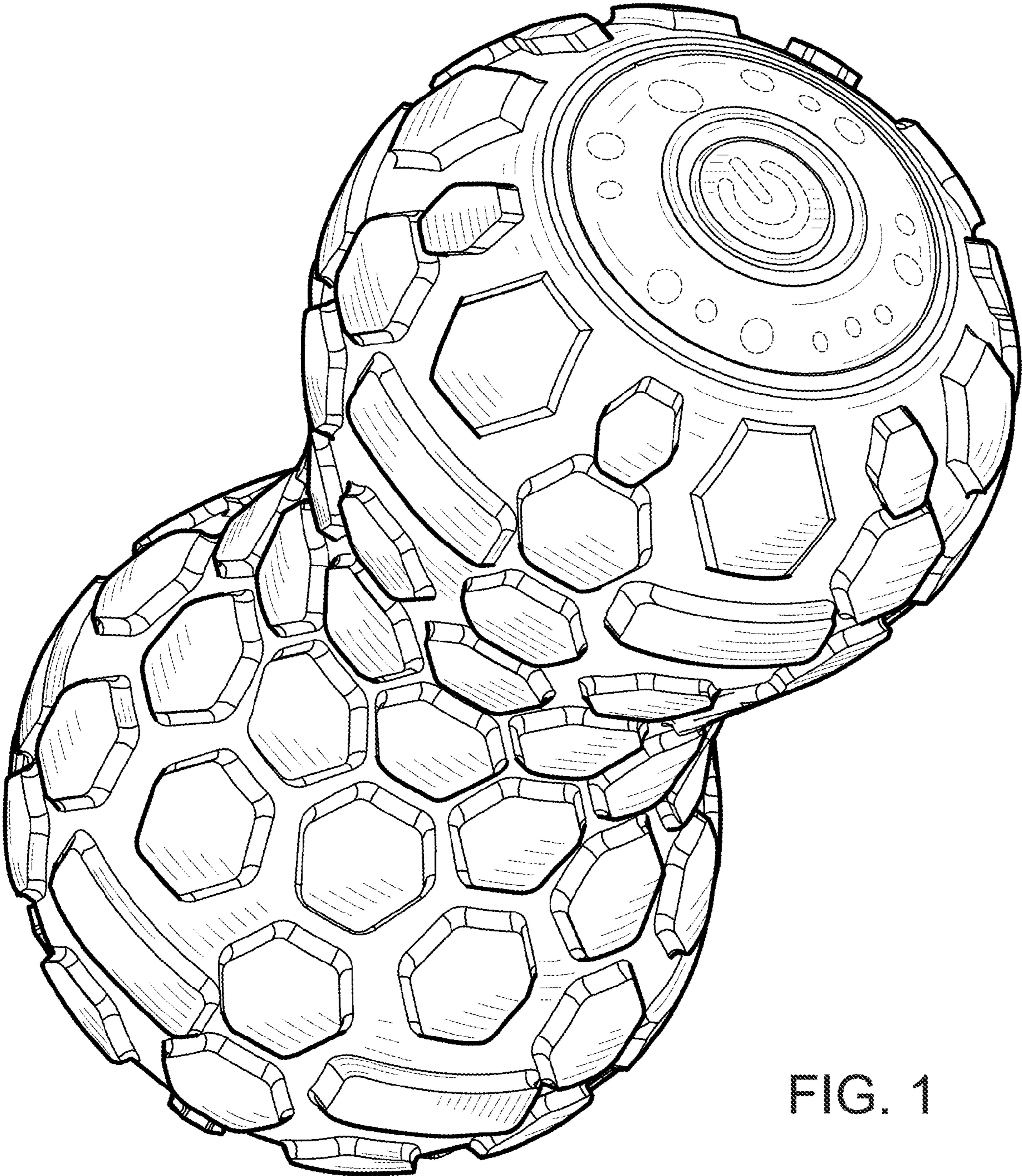

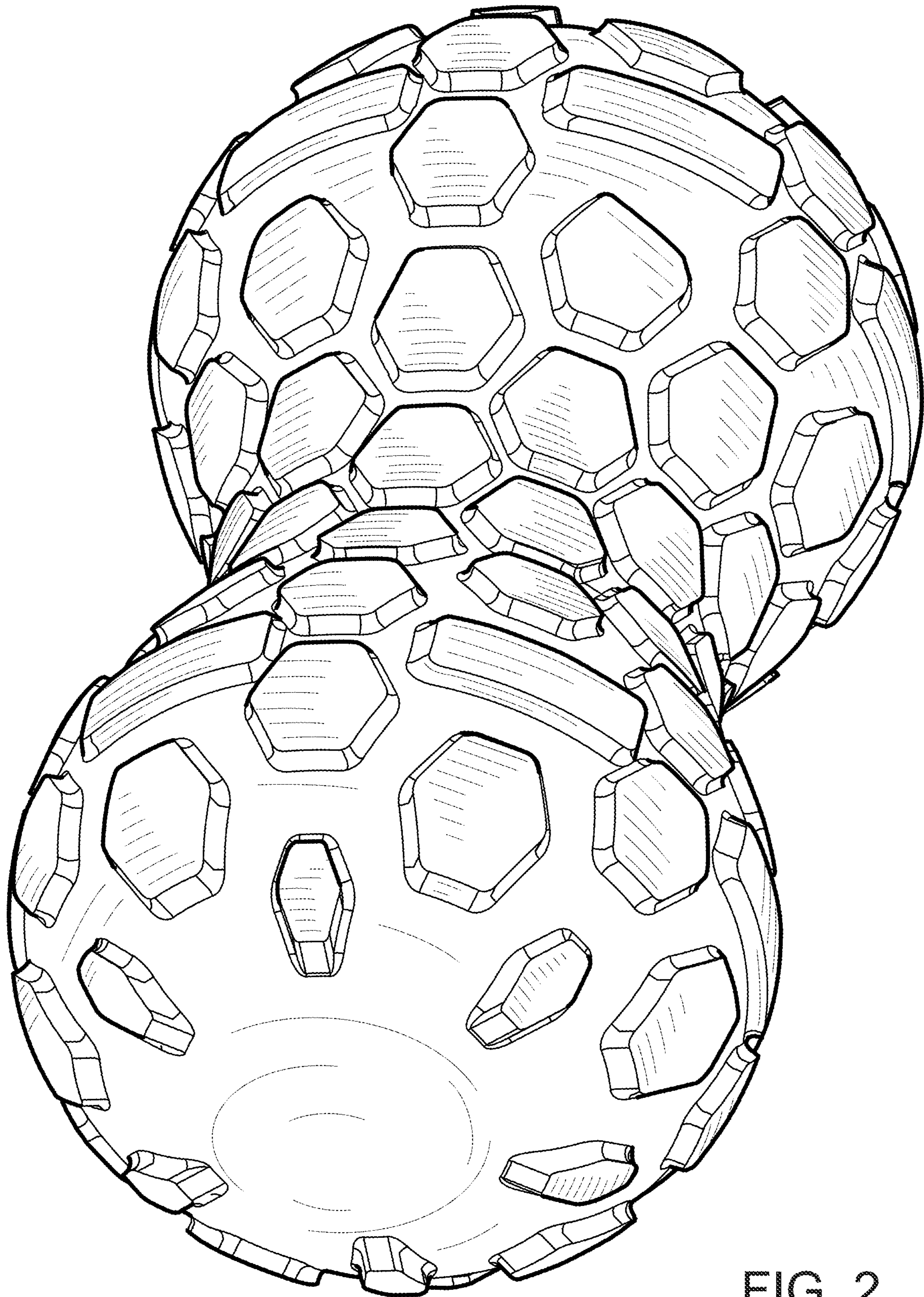

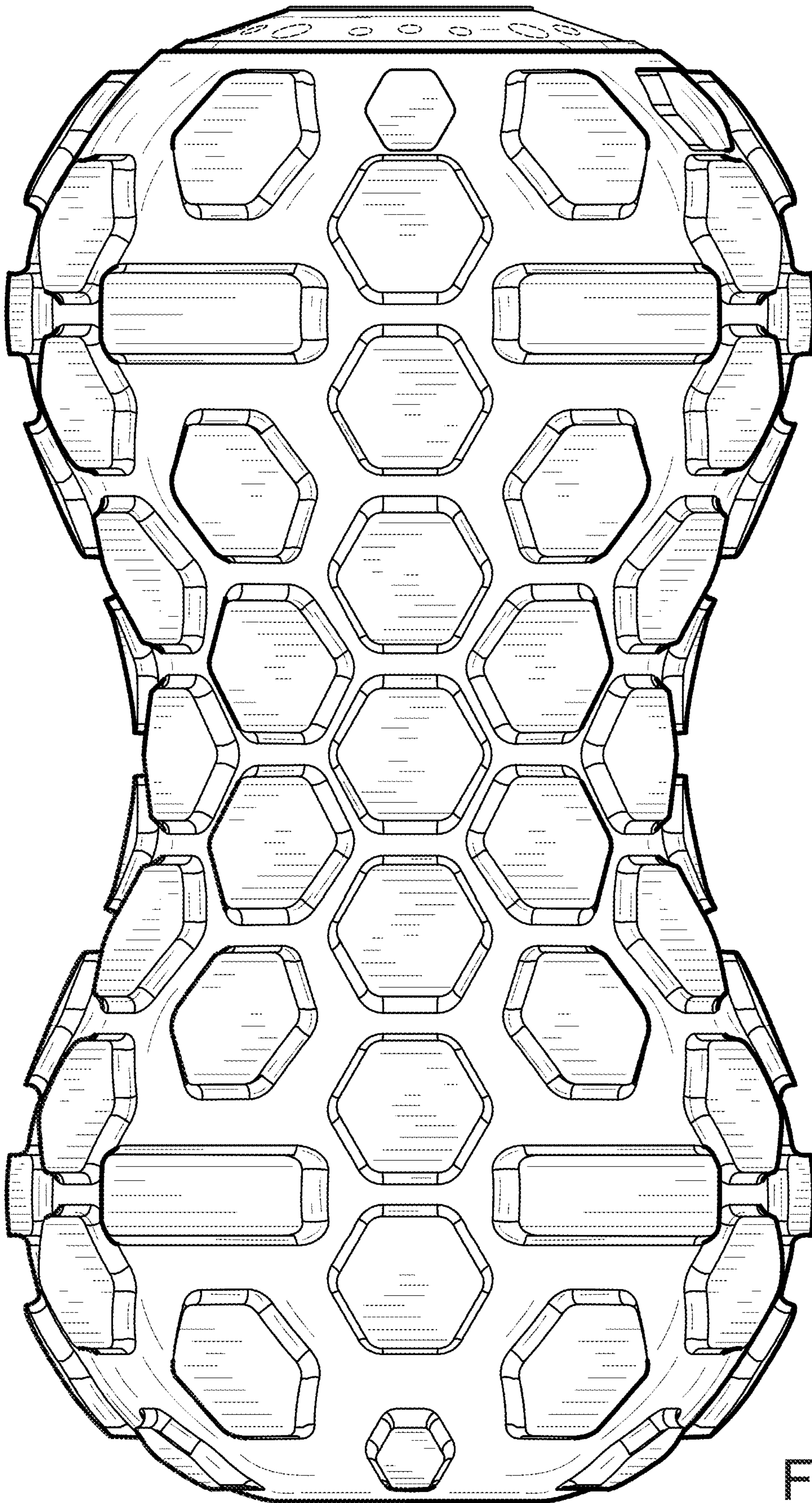

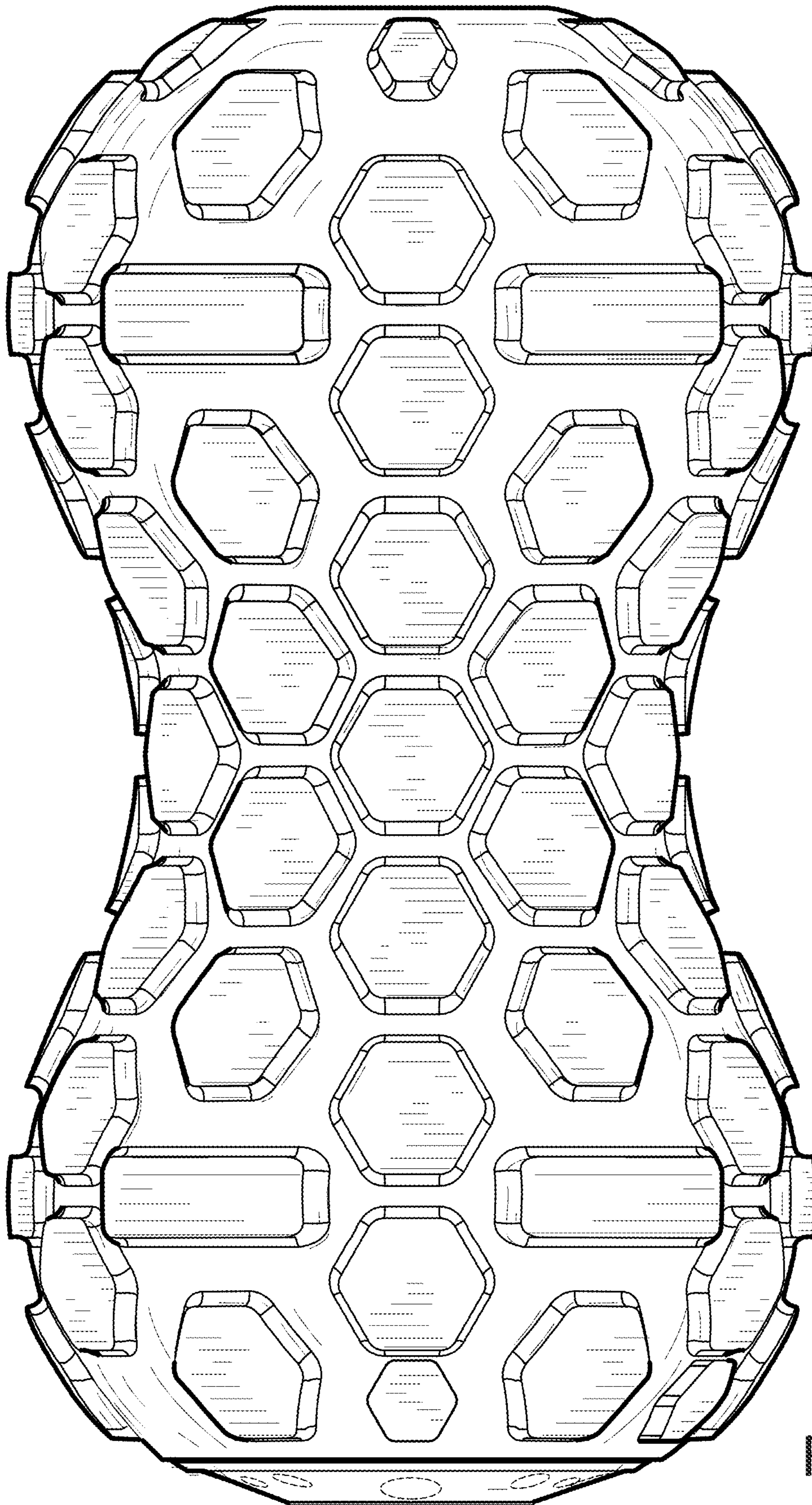

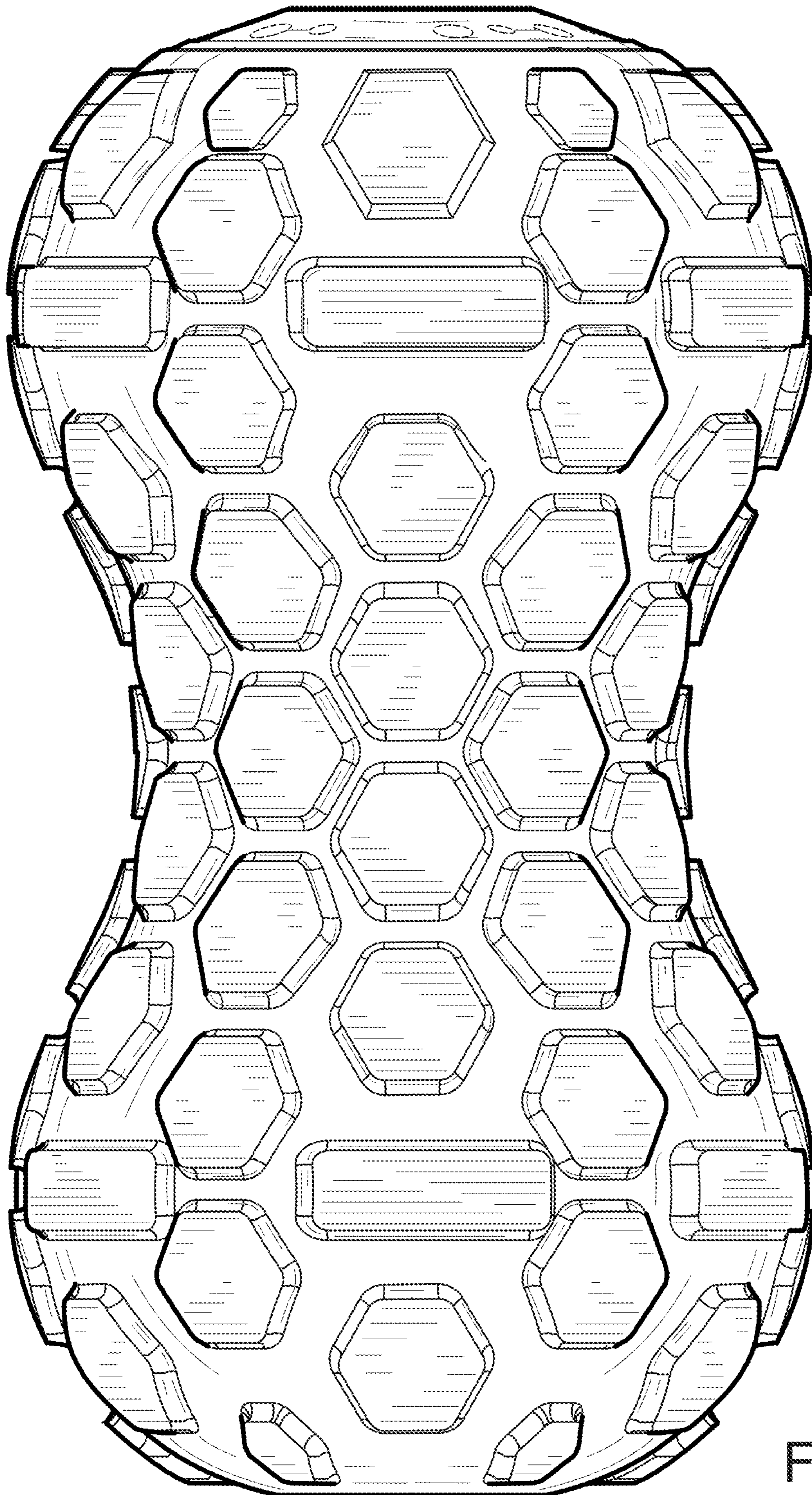

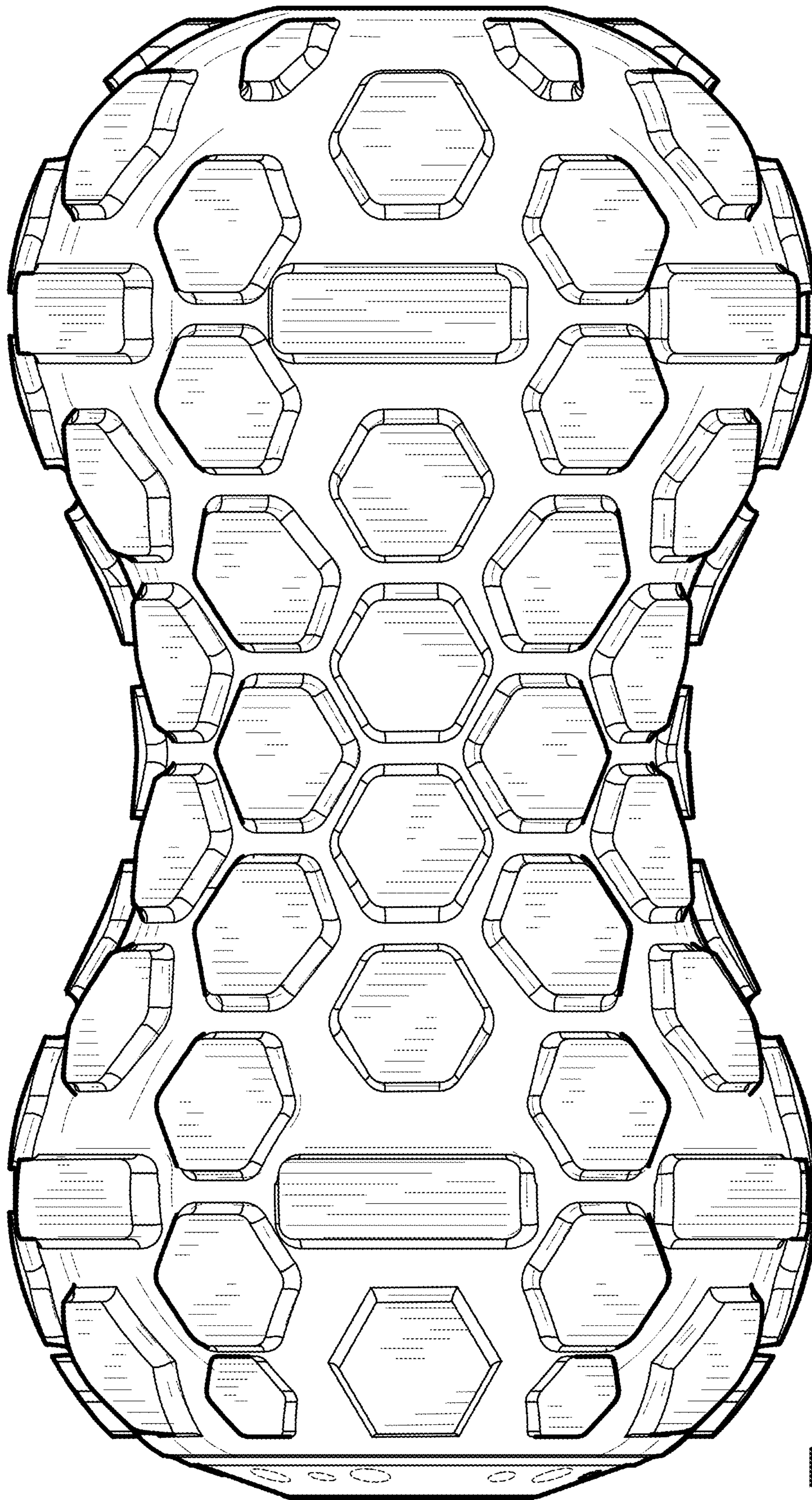

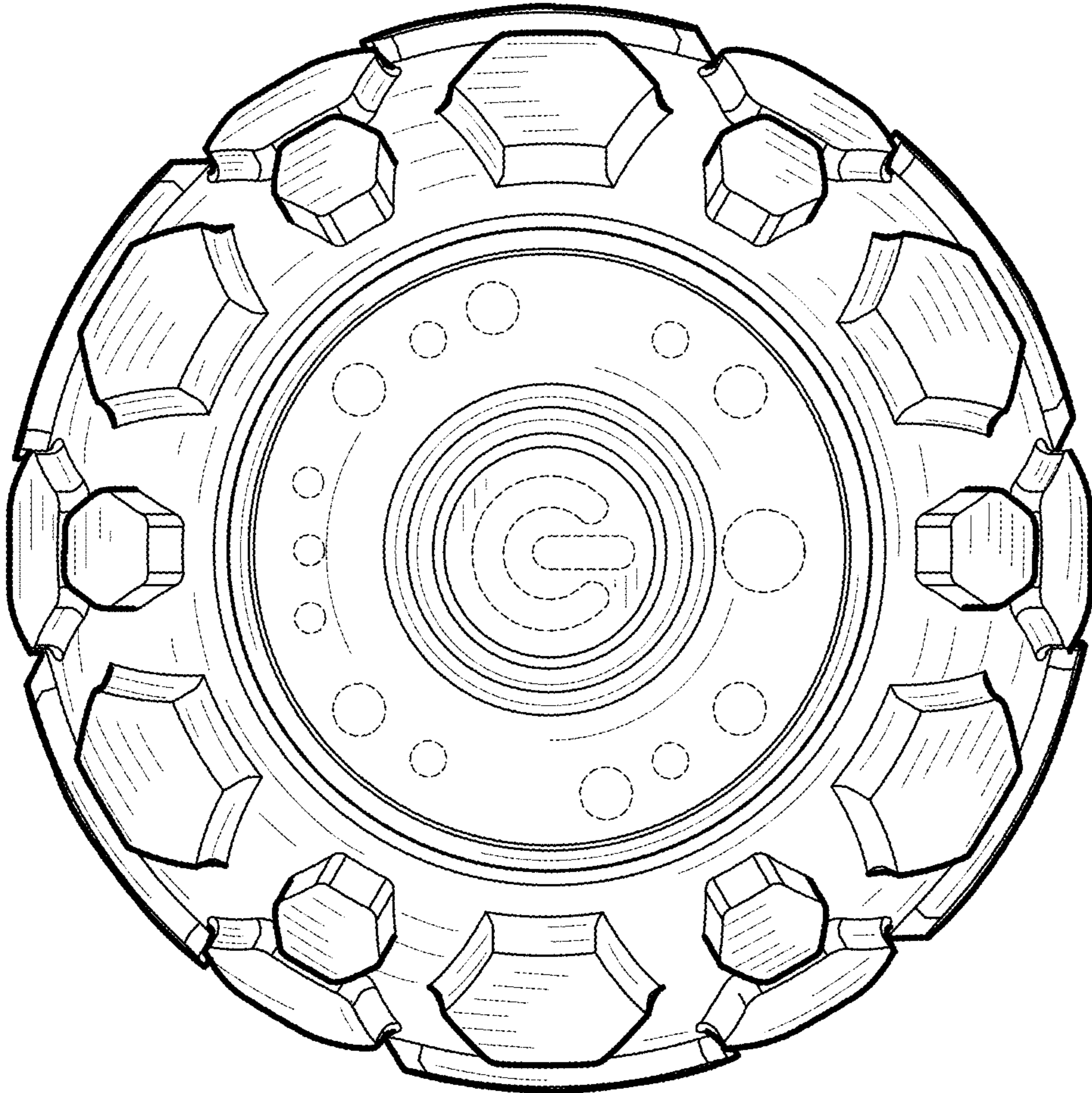

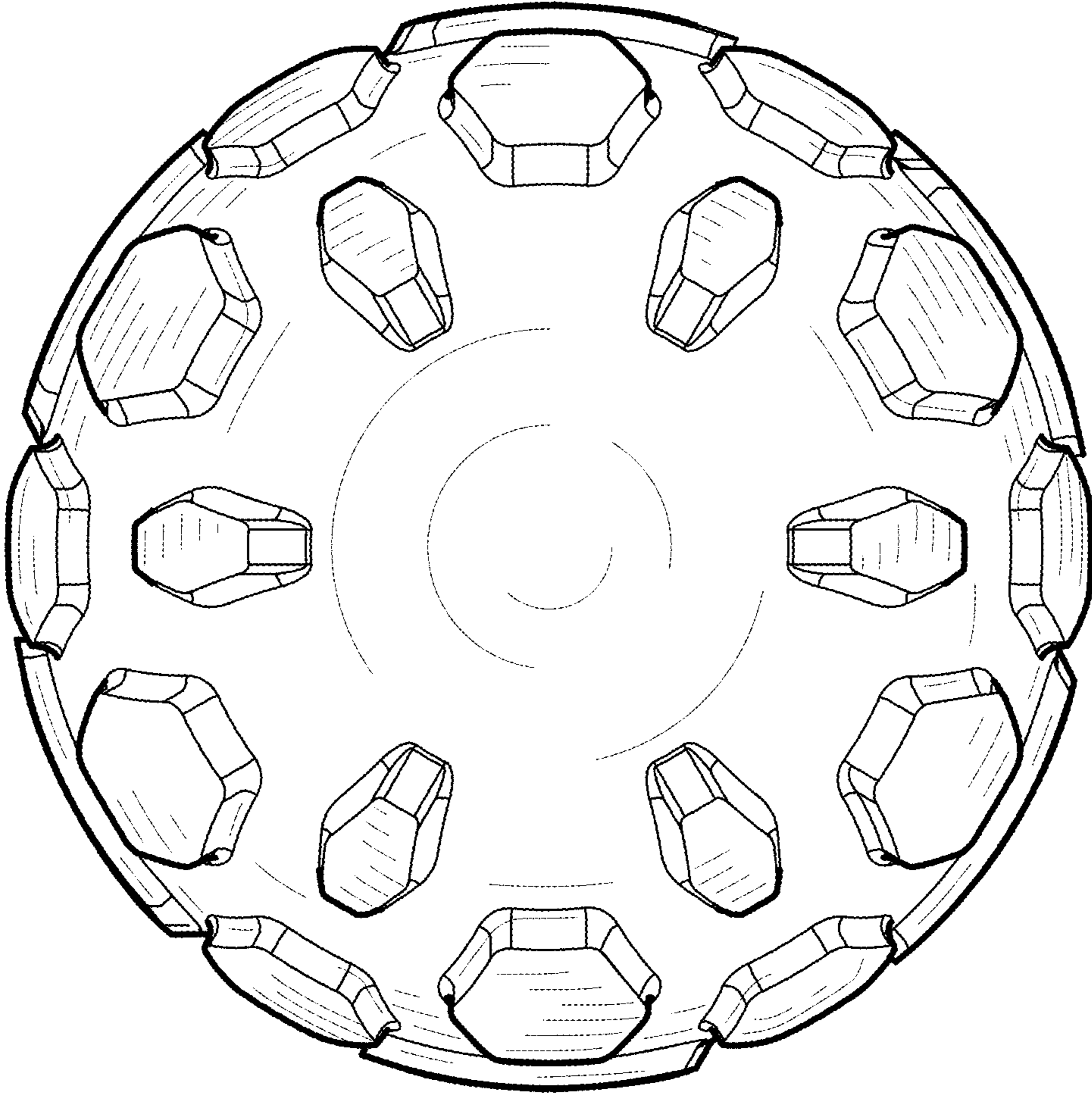
