DESCRIPTION

FIG. 1 is a perspective view of an escutcheon for a swimming pool ladder showing my new design; FIG. 2 is a side elevational view thereof as seen from the left hand side of FIG. 1; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

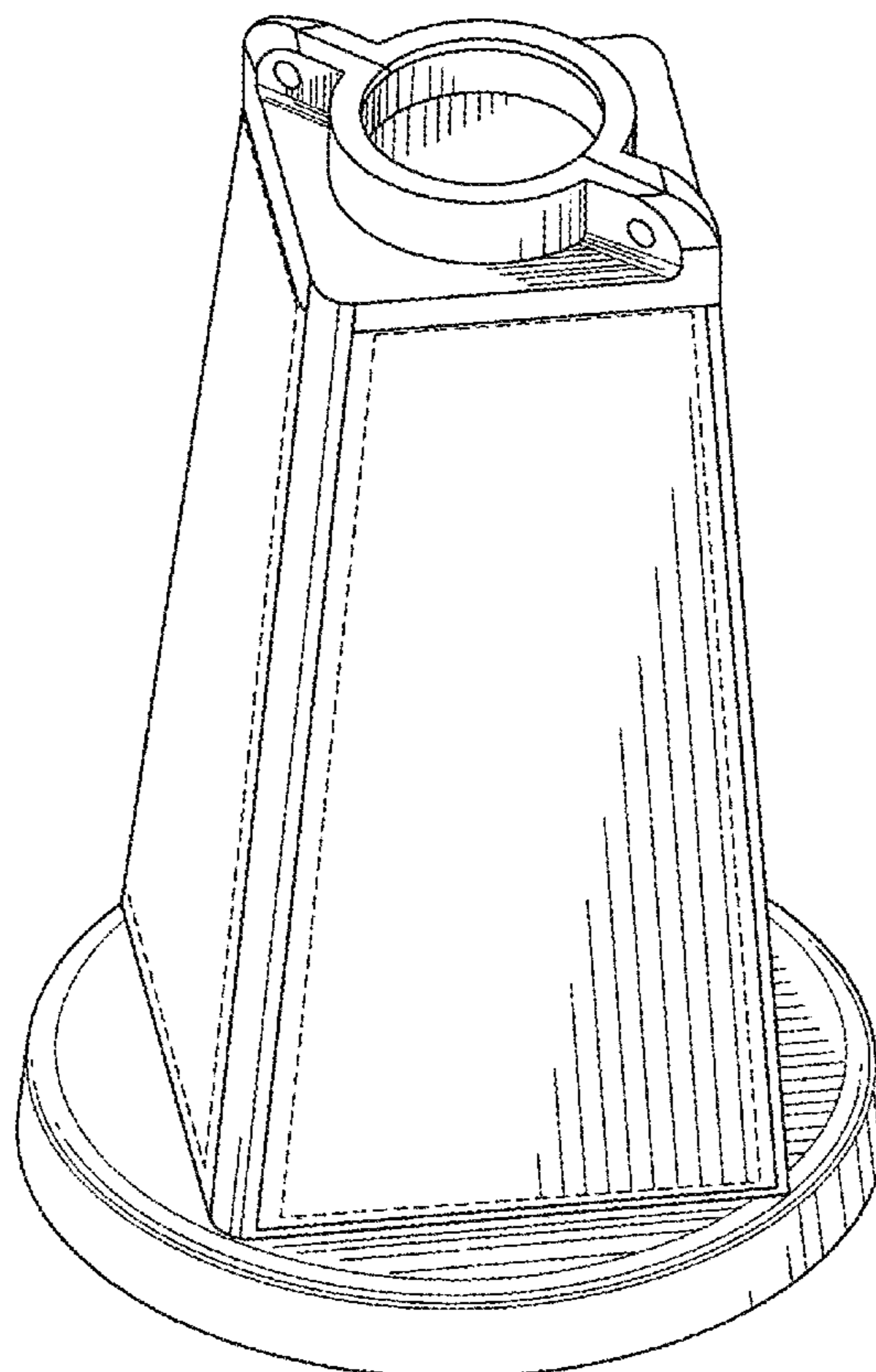

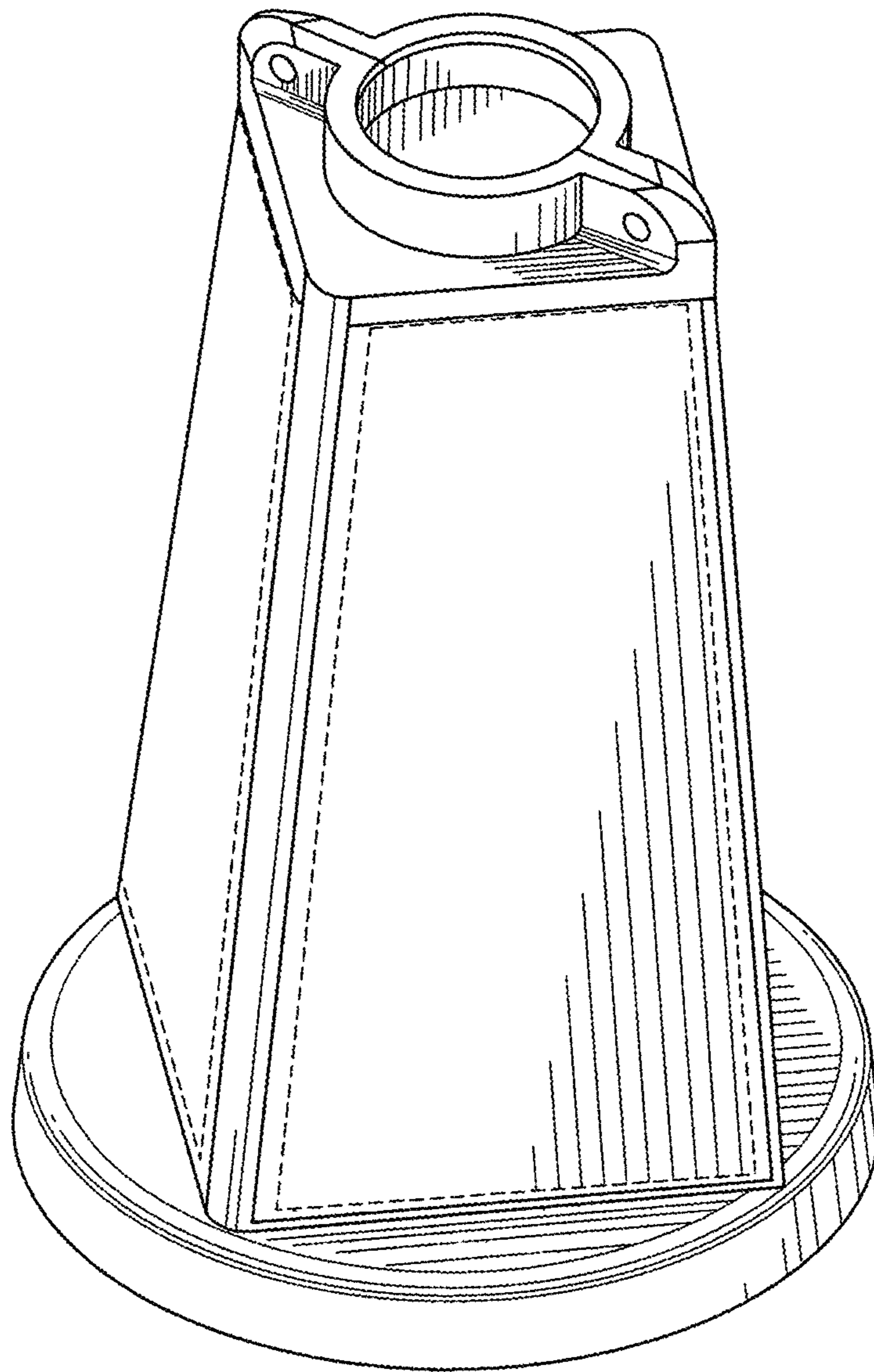

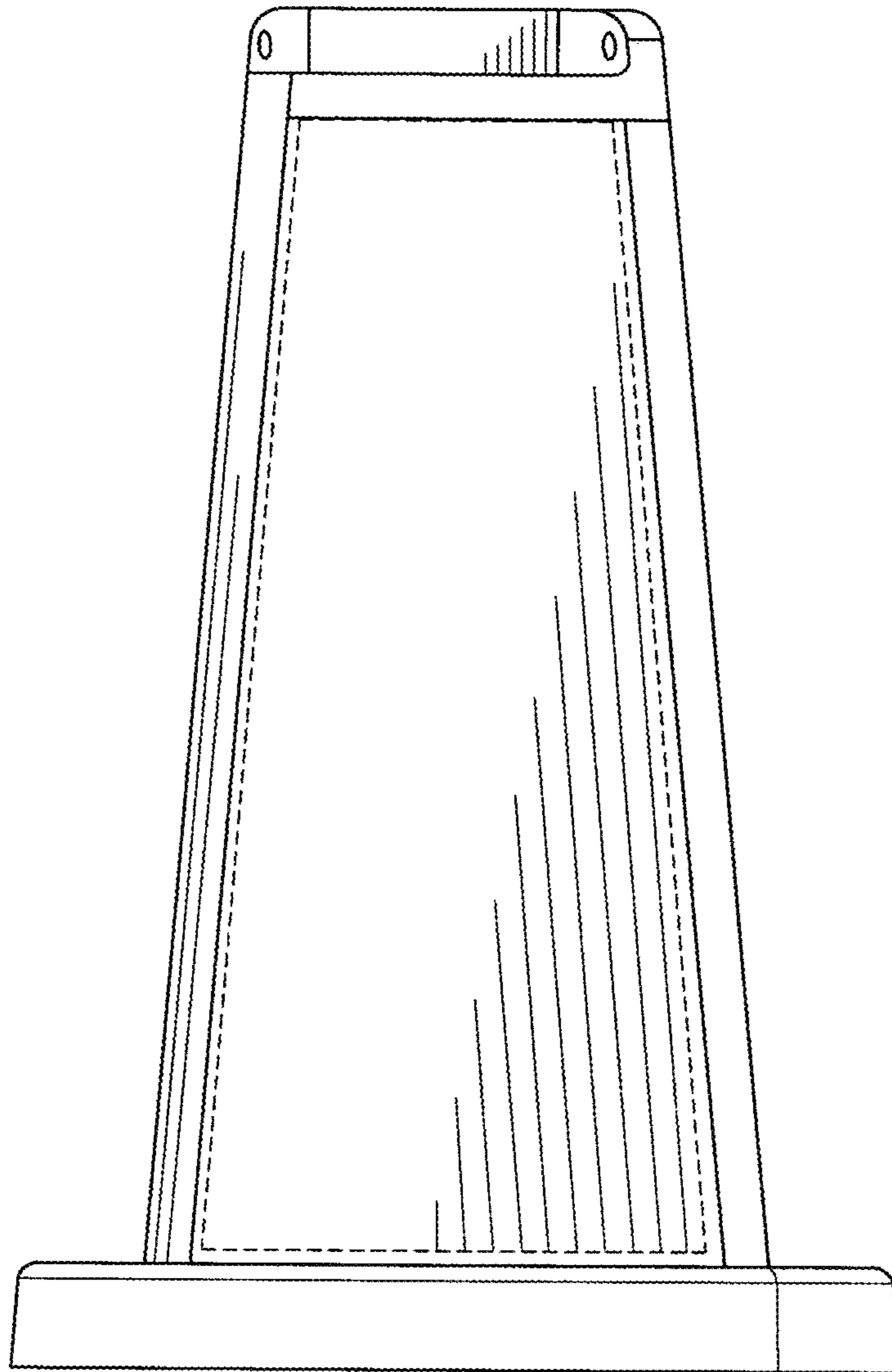

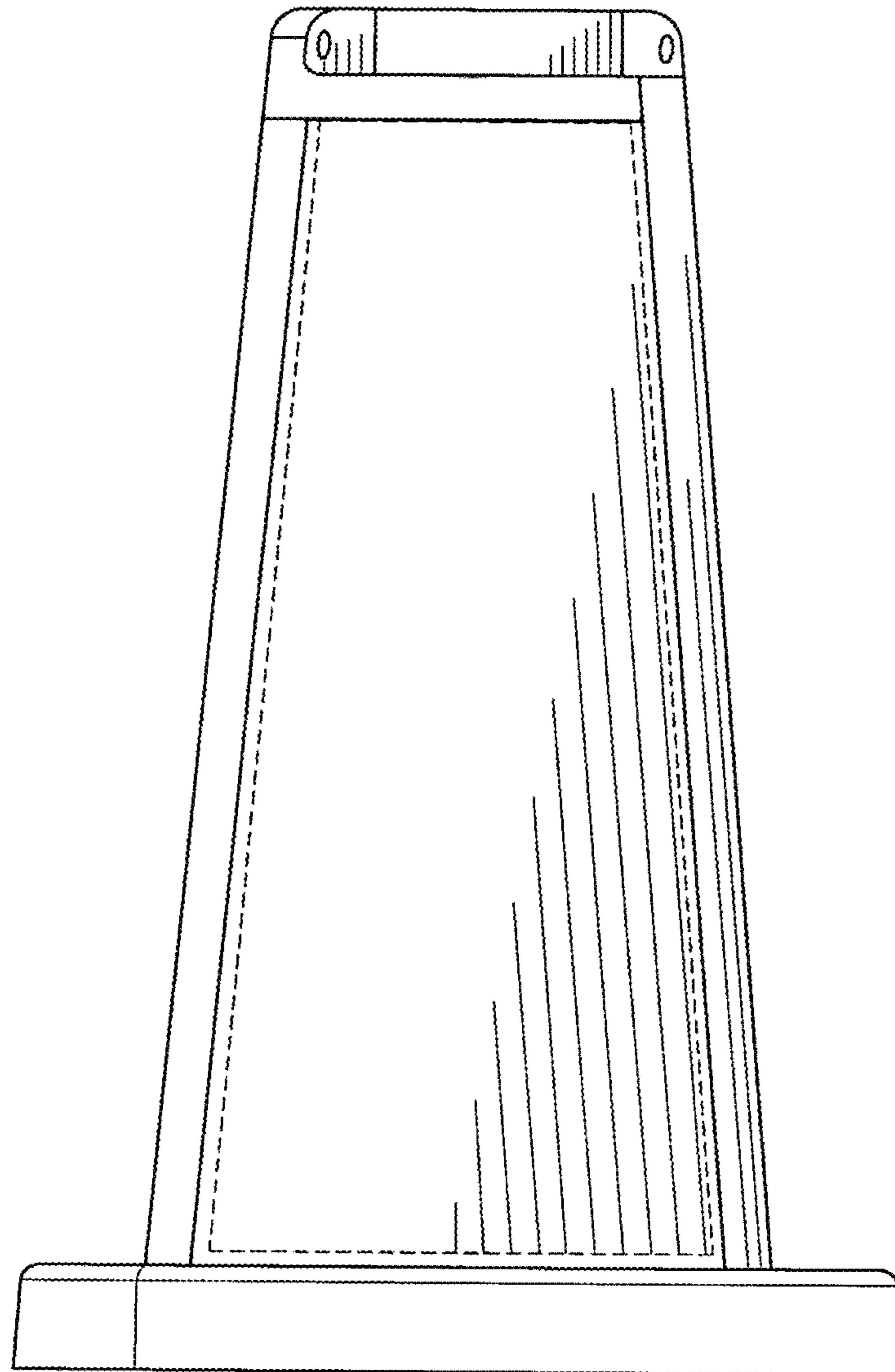

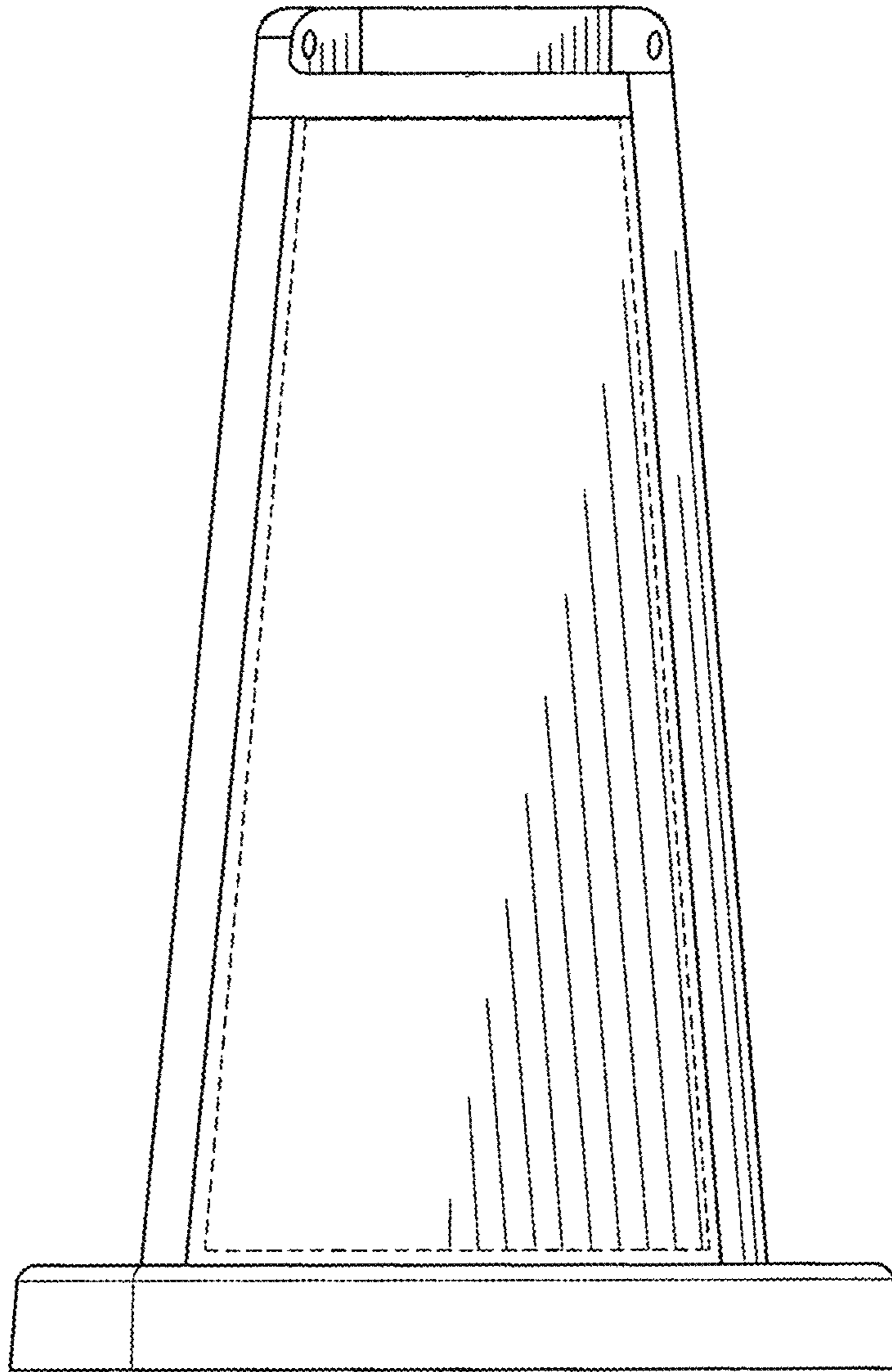

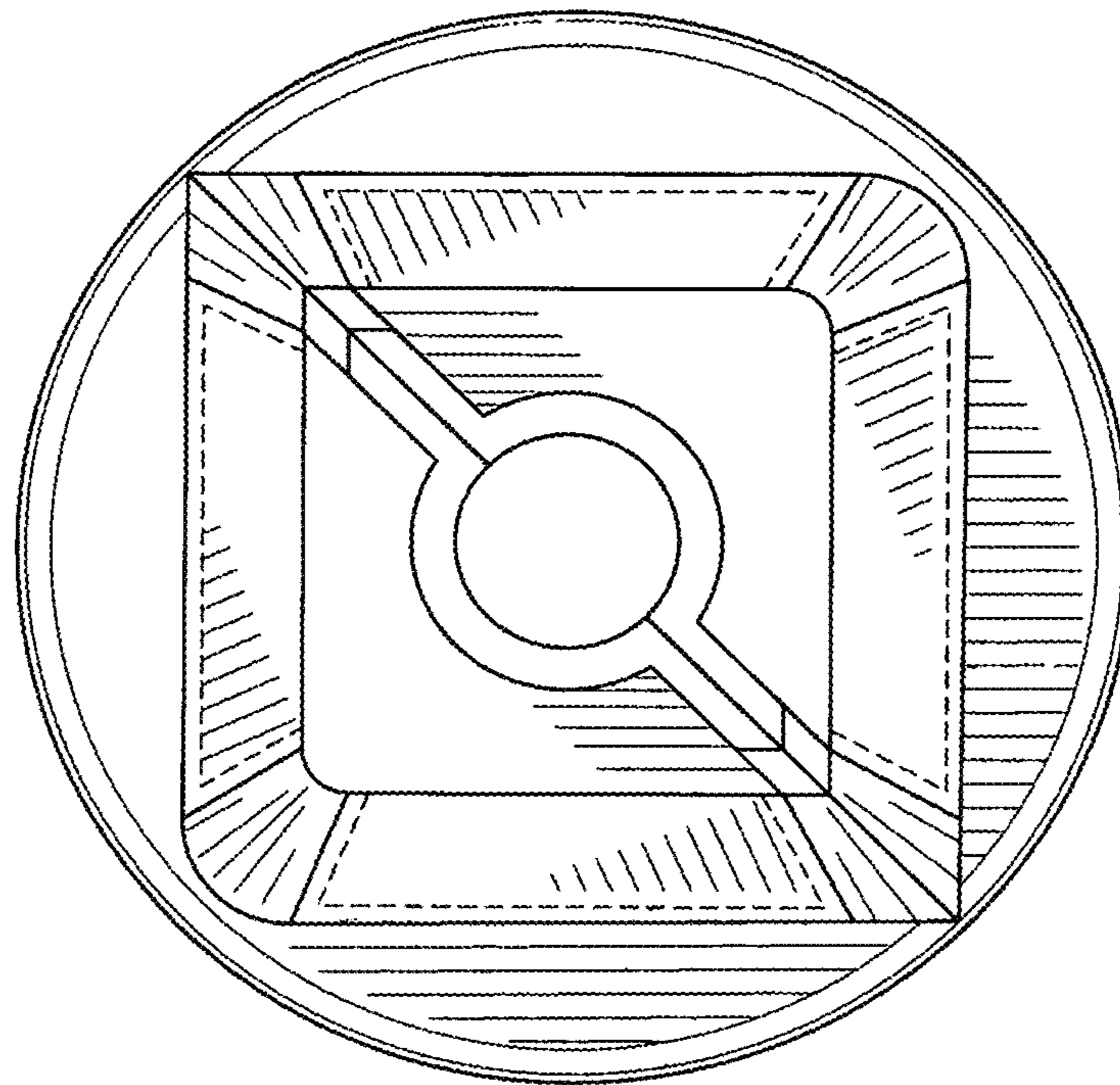

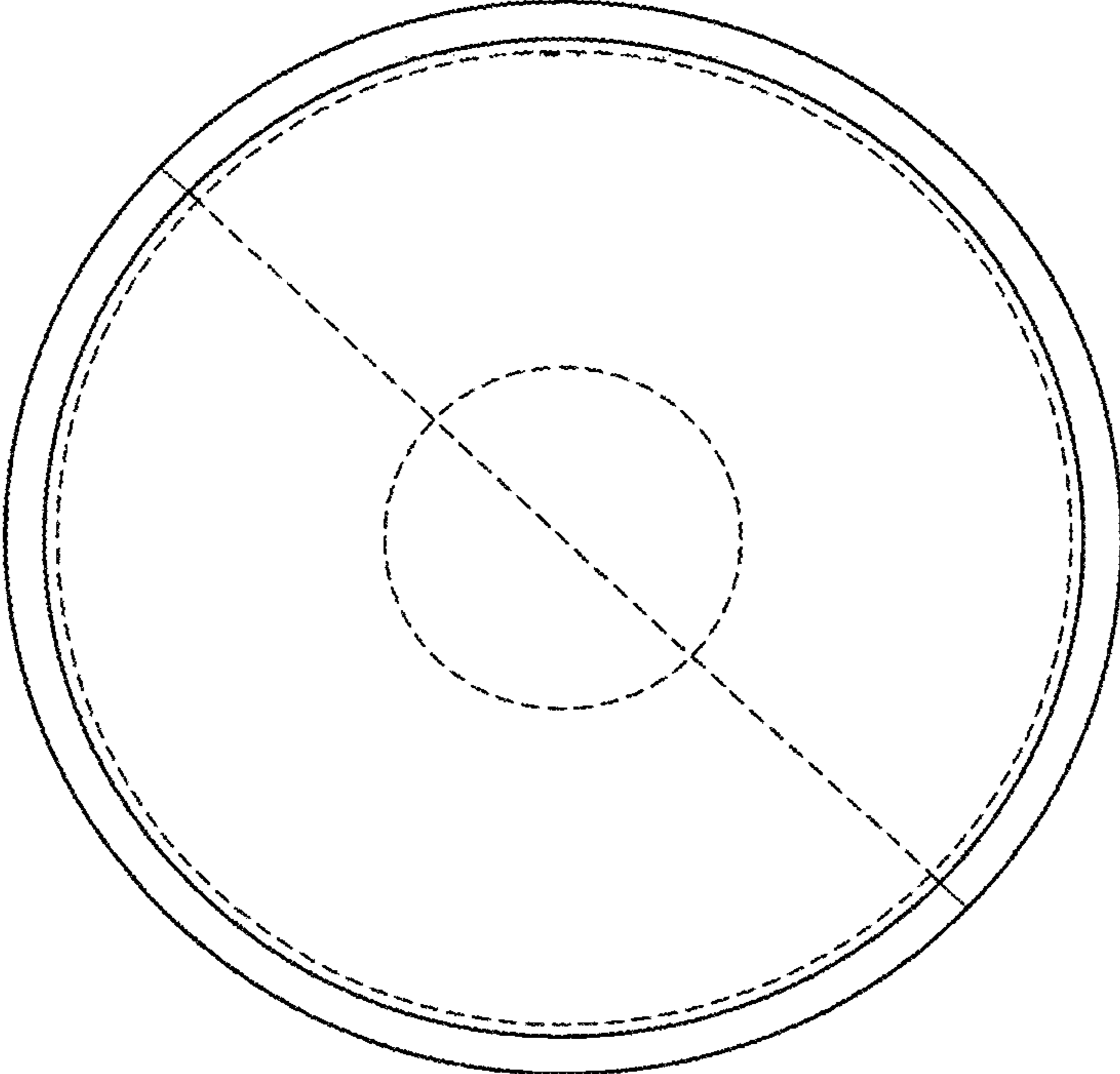
