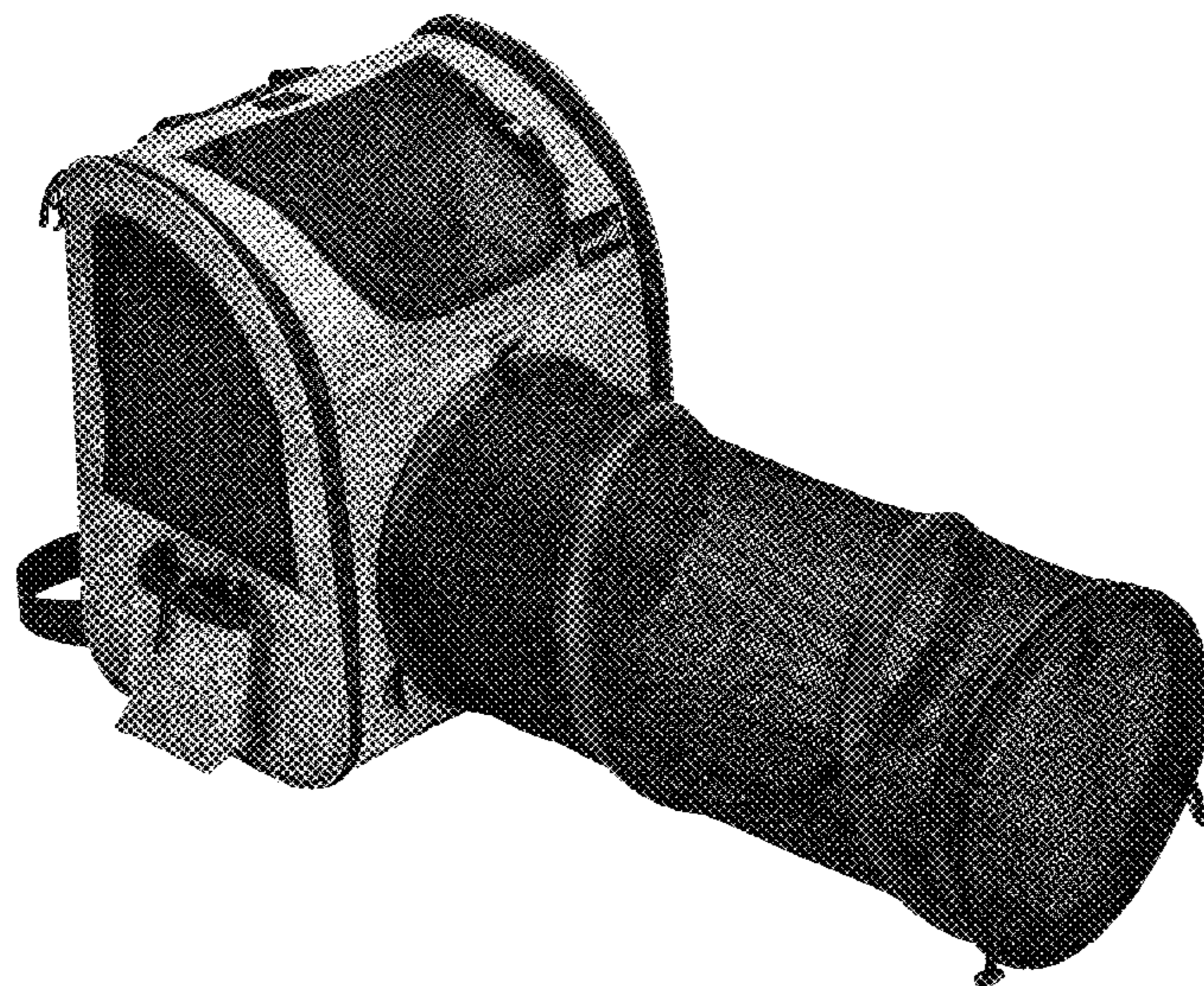
(57) **CLAIM**

The ornamental design for a cat backpack with tunnel, as shown and described.

DESCRIPTION

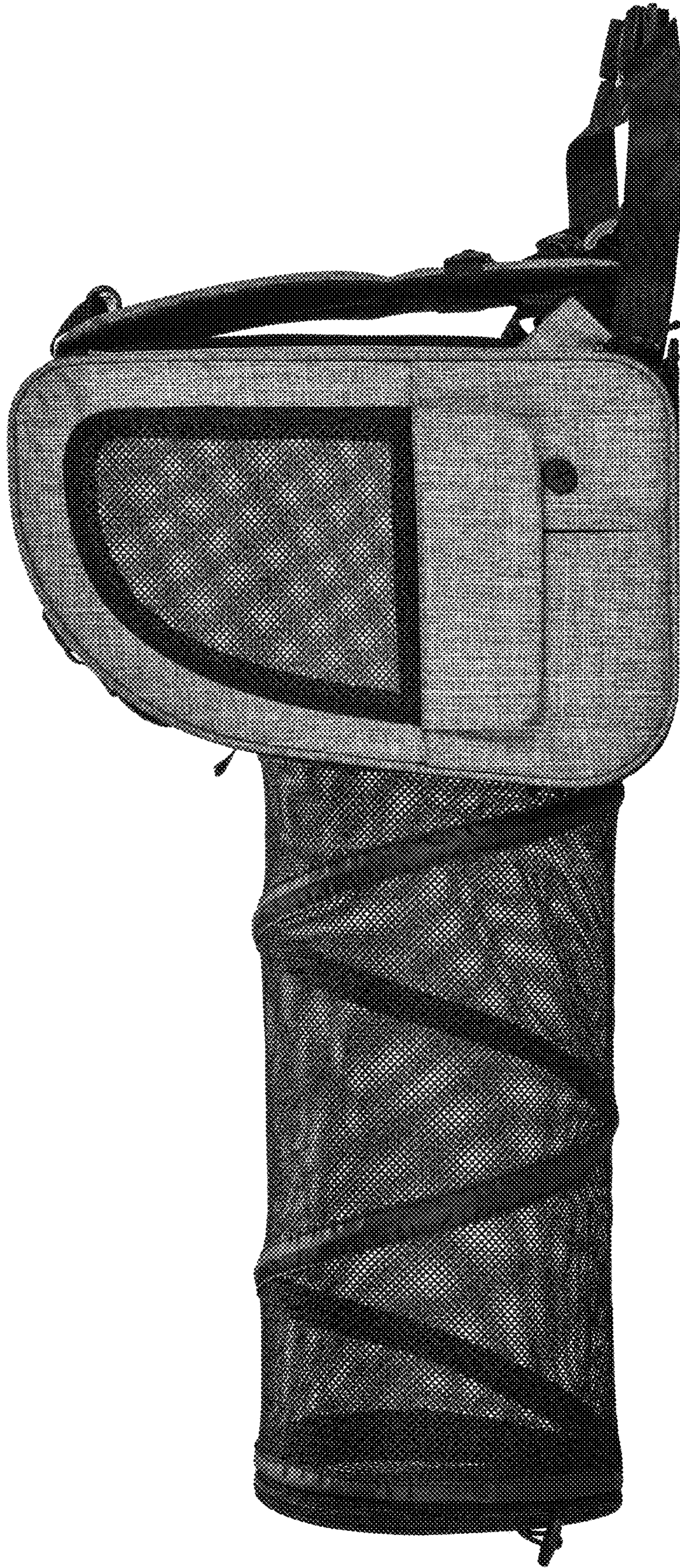

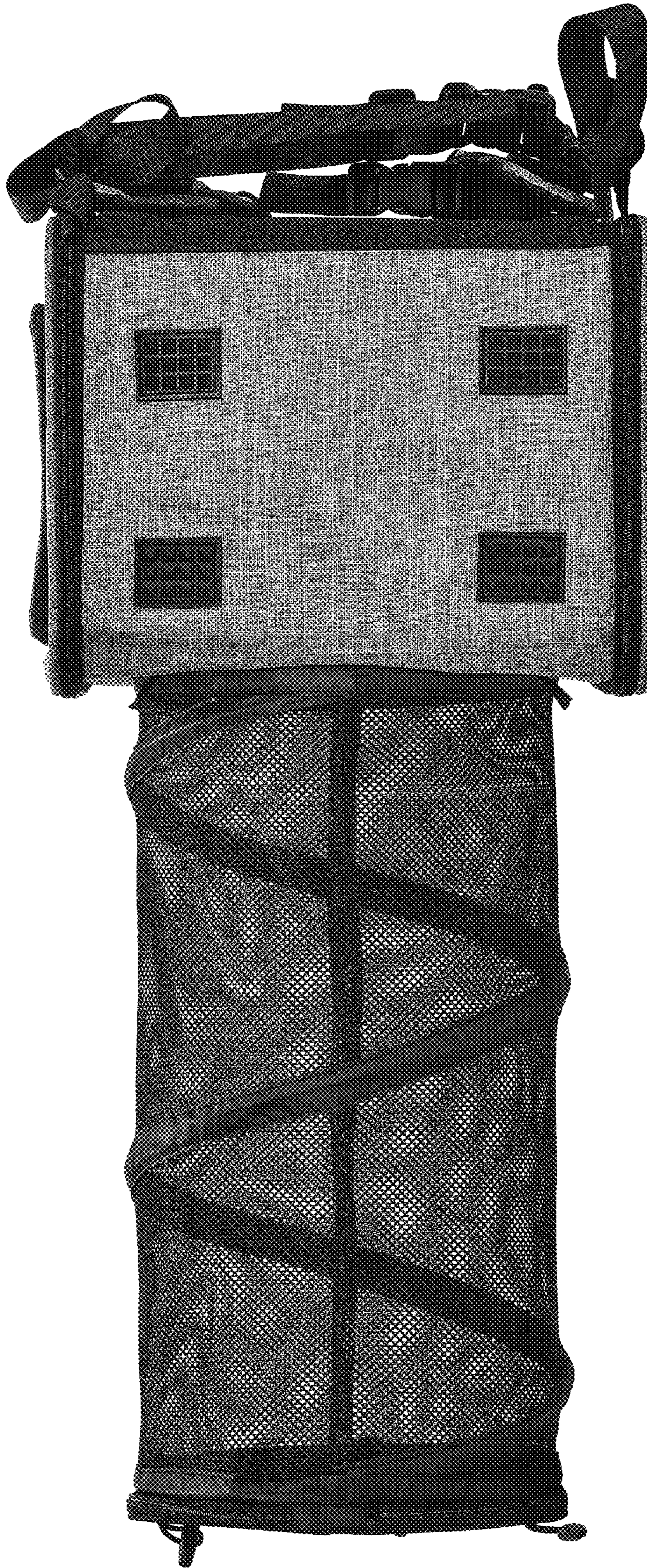
