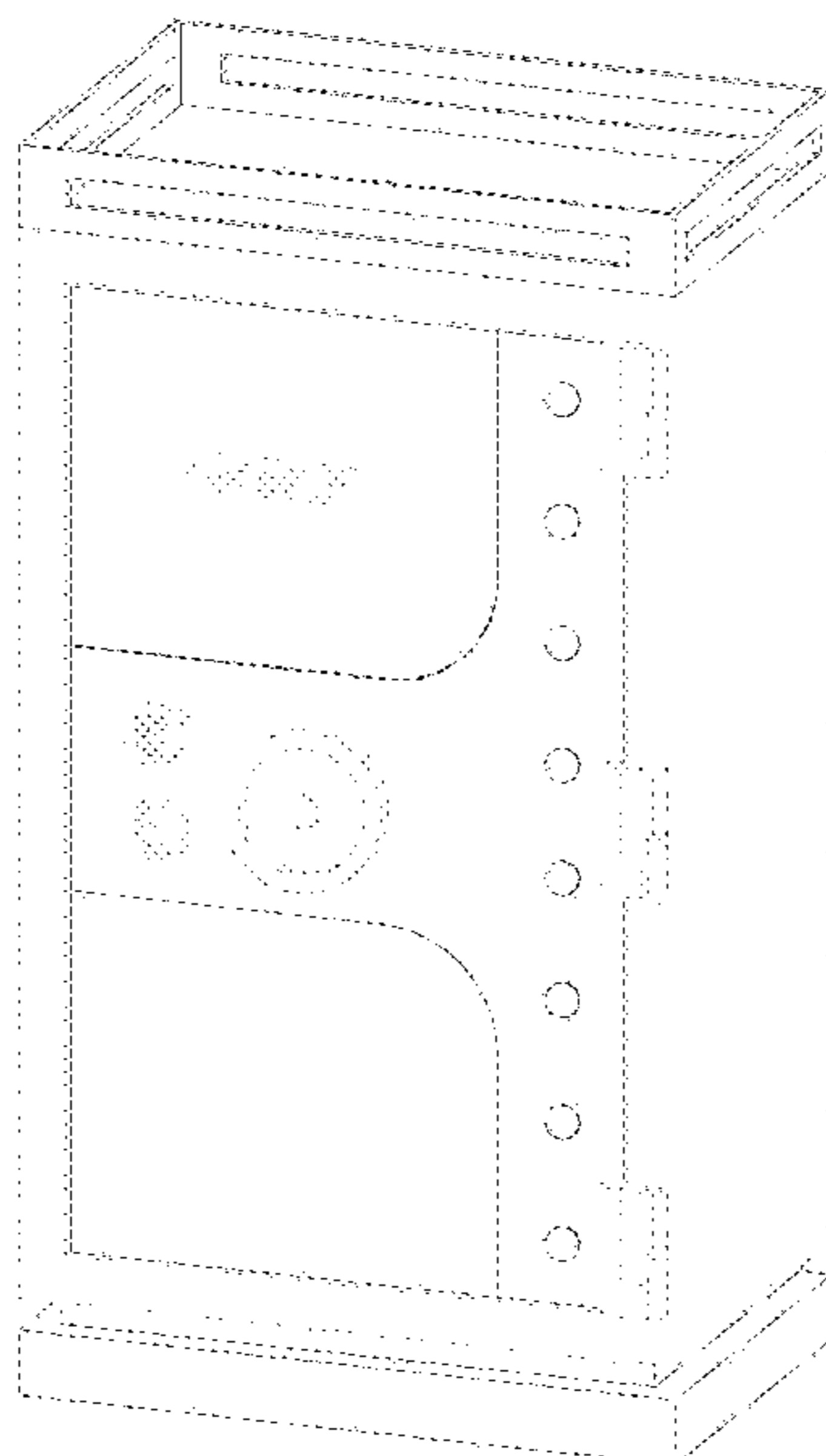
(57) **CLAIM**

The ornamental design for a safe door, upper equipment cradle, and floor pedestal as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a safe door, upper equipment cradle, and floor pedestal showing my new design;

FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;

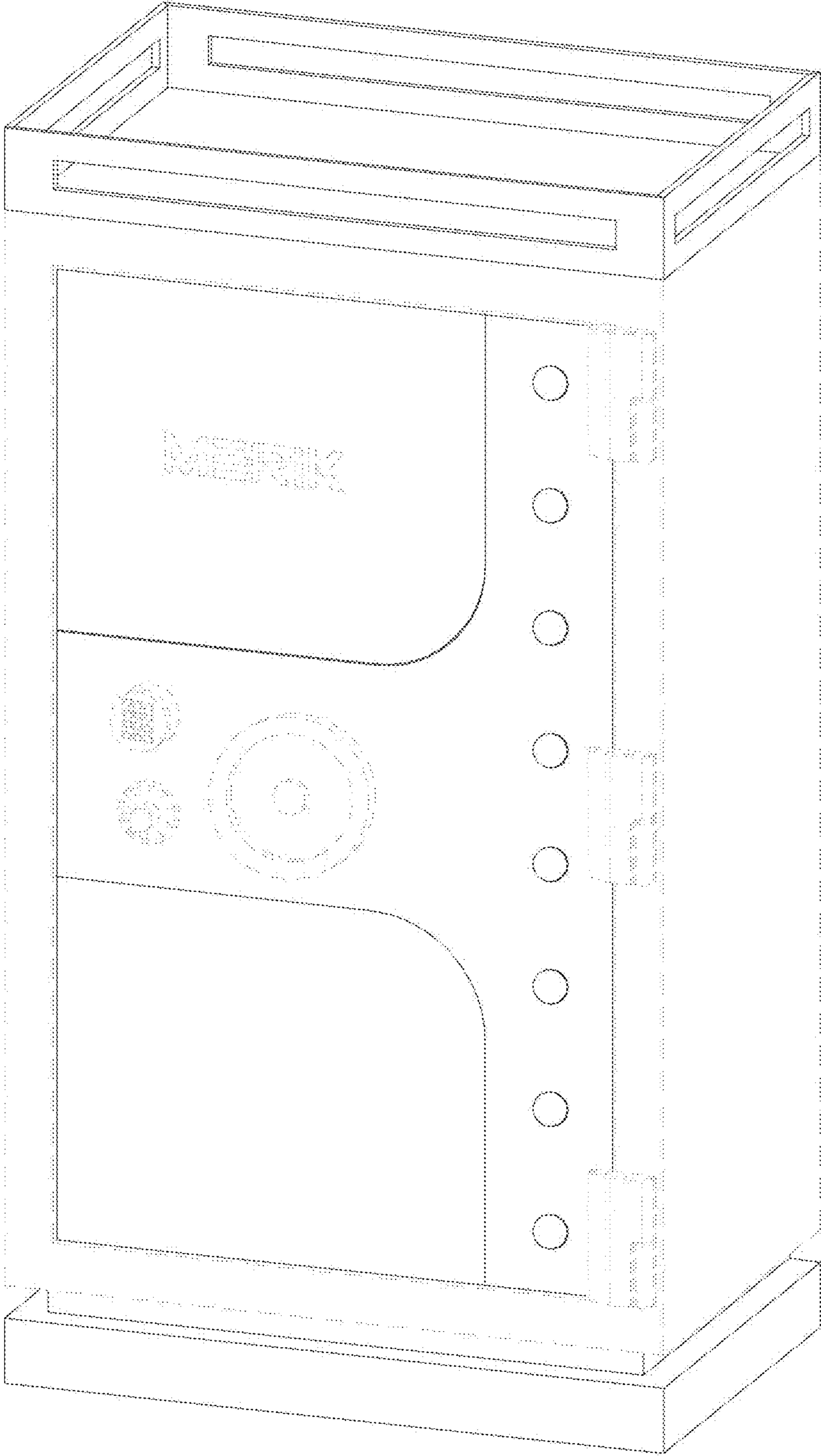

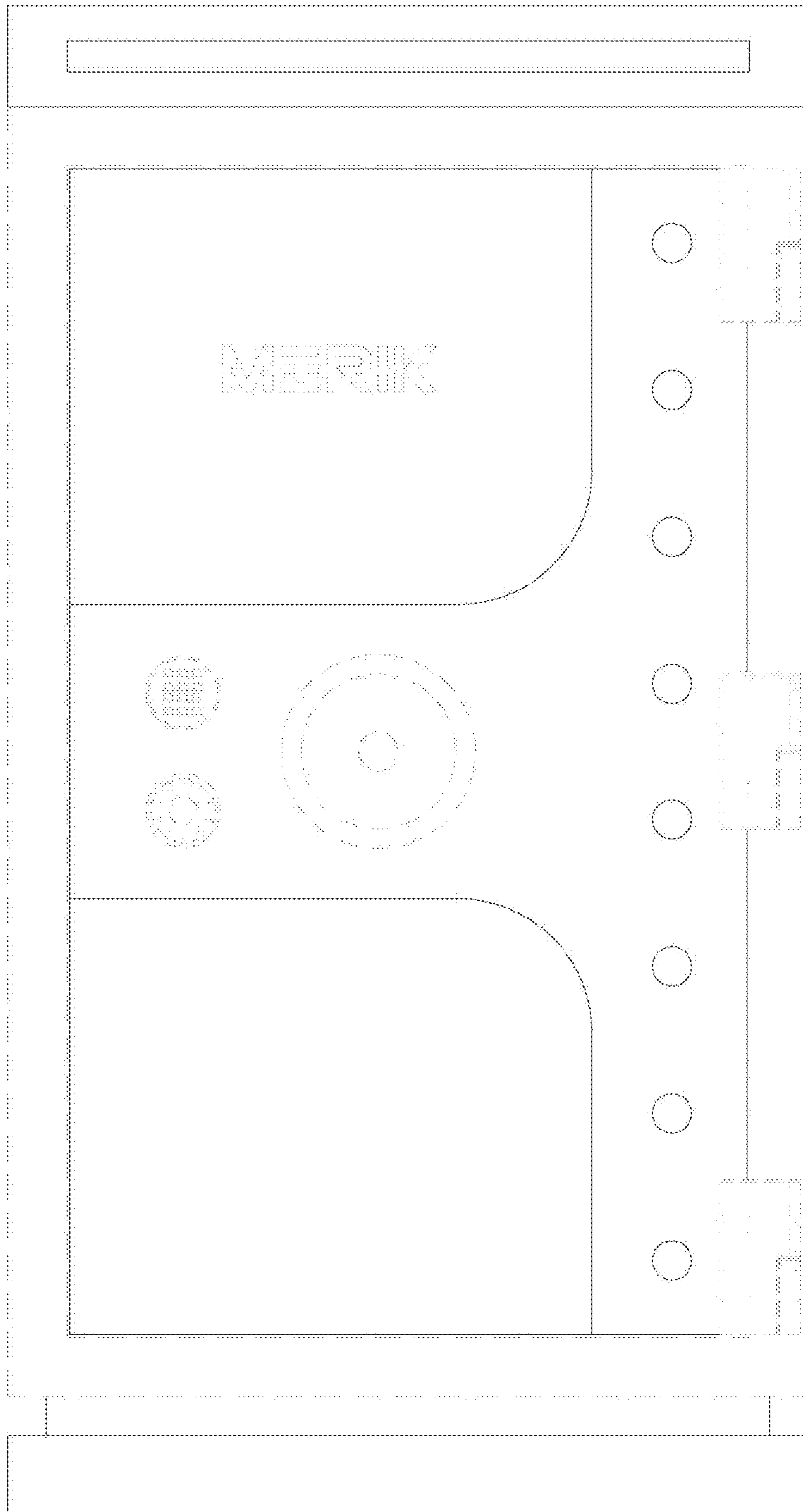

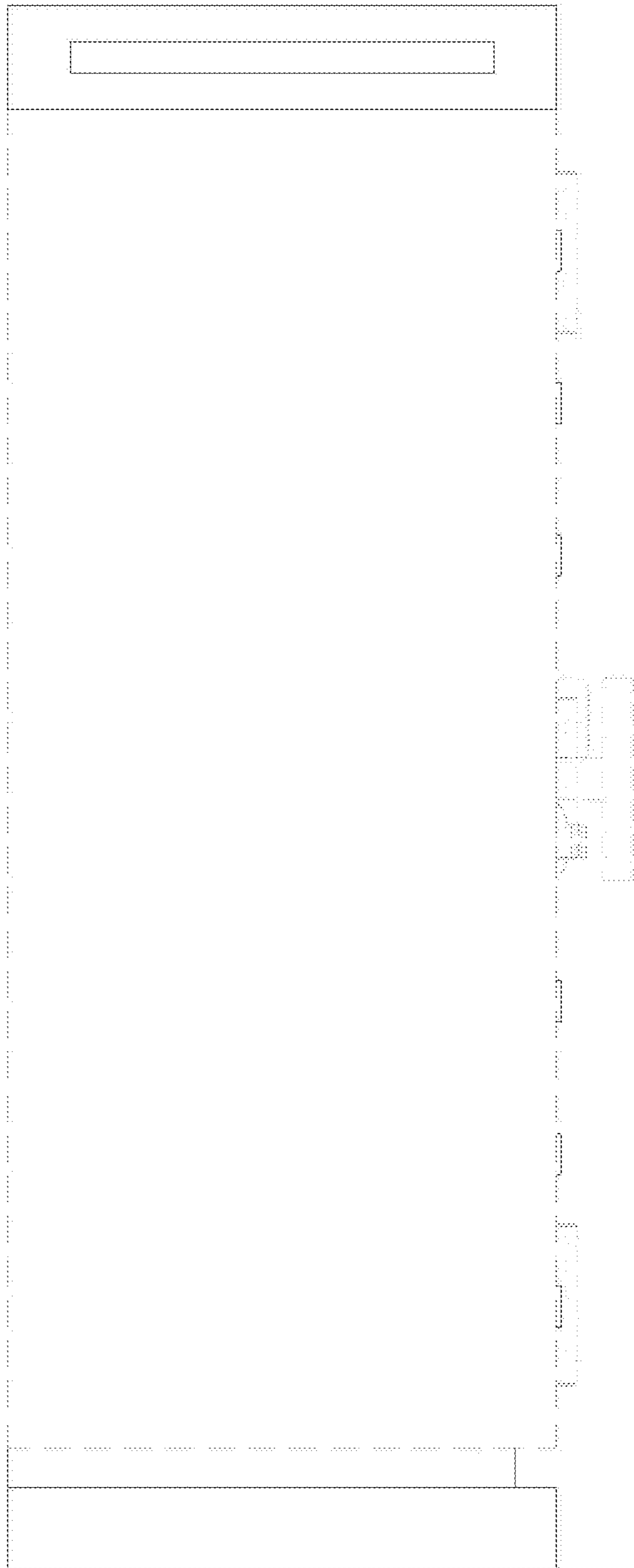

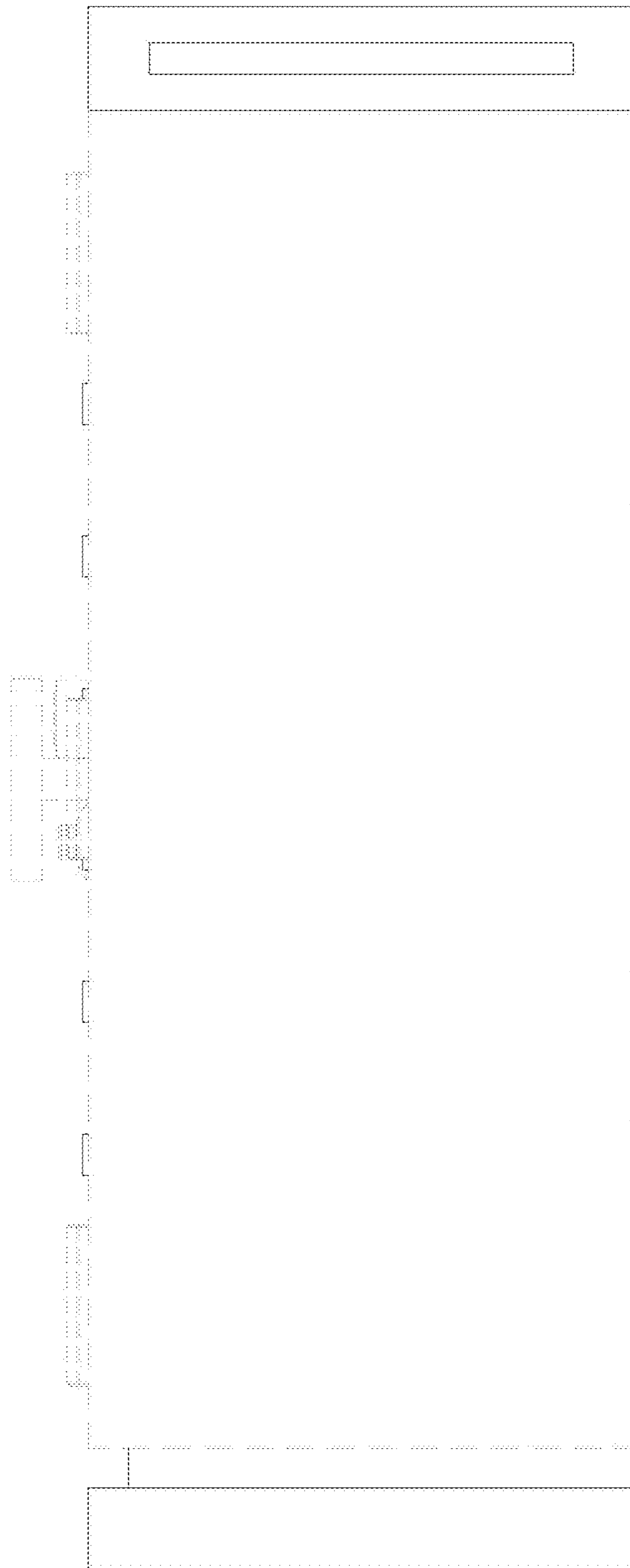

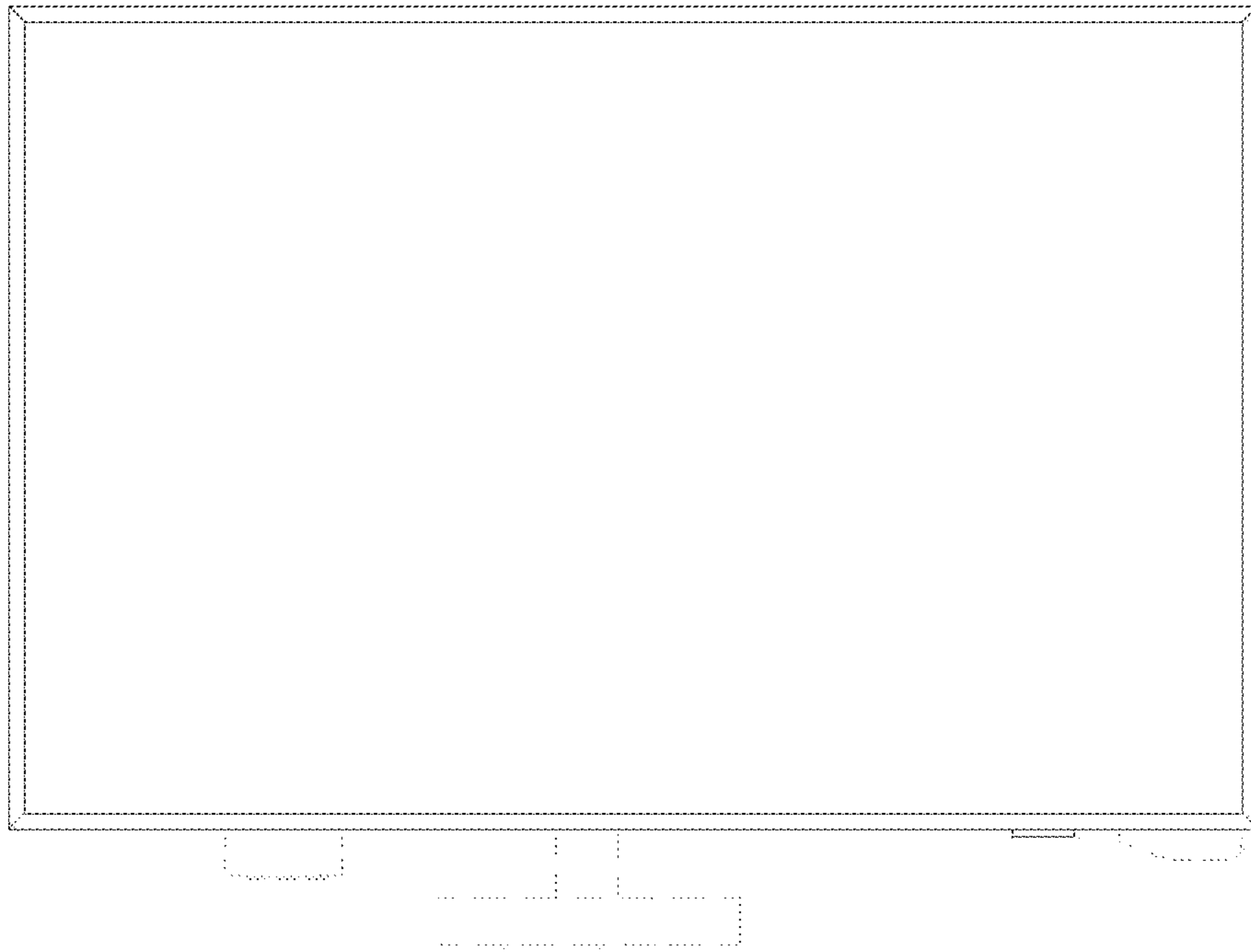

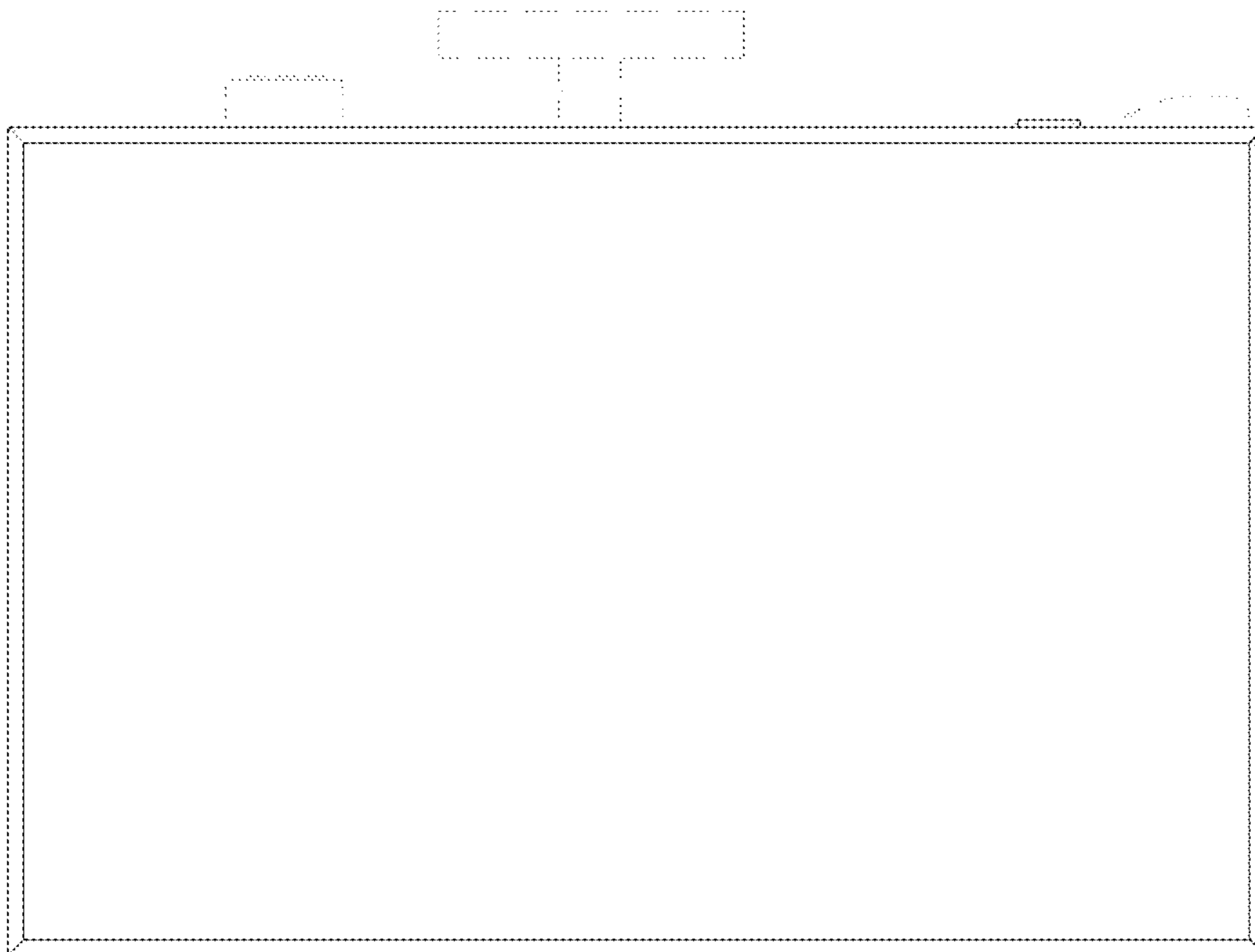

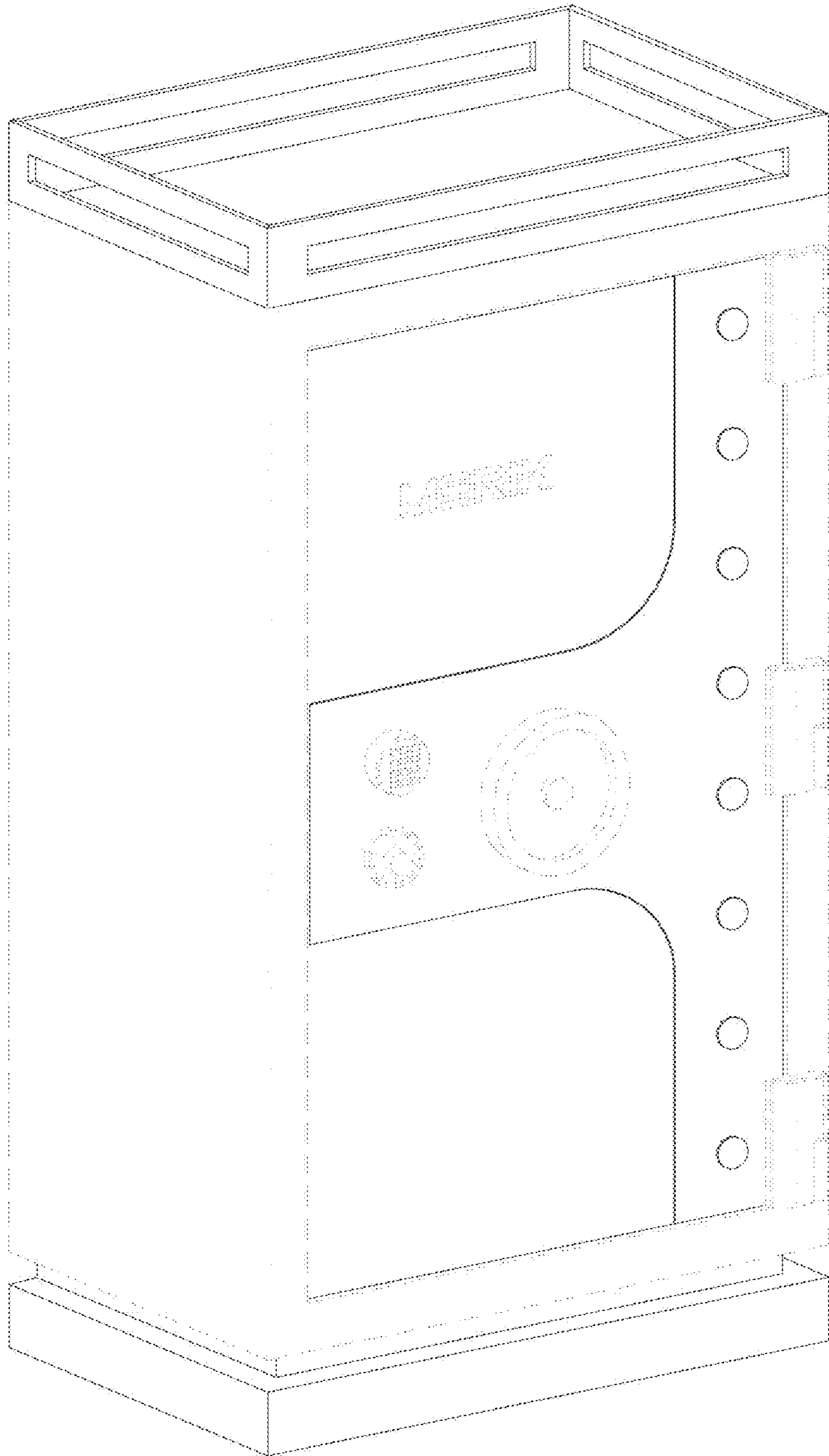
