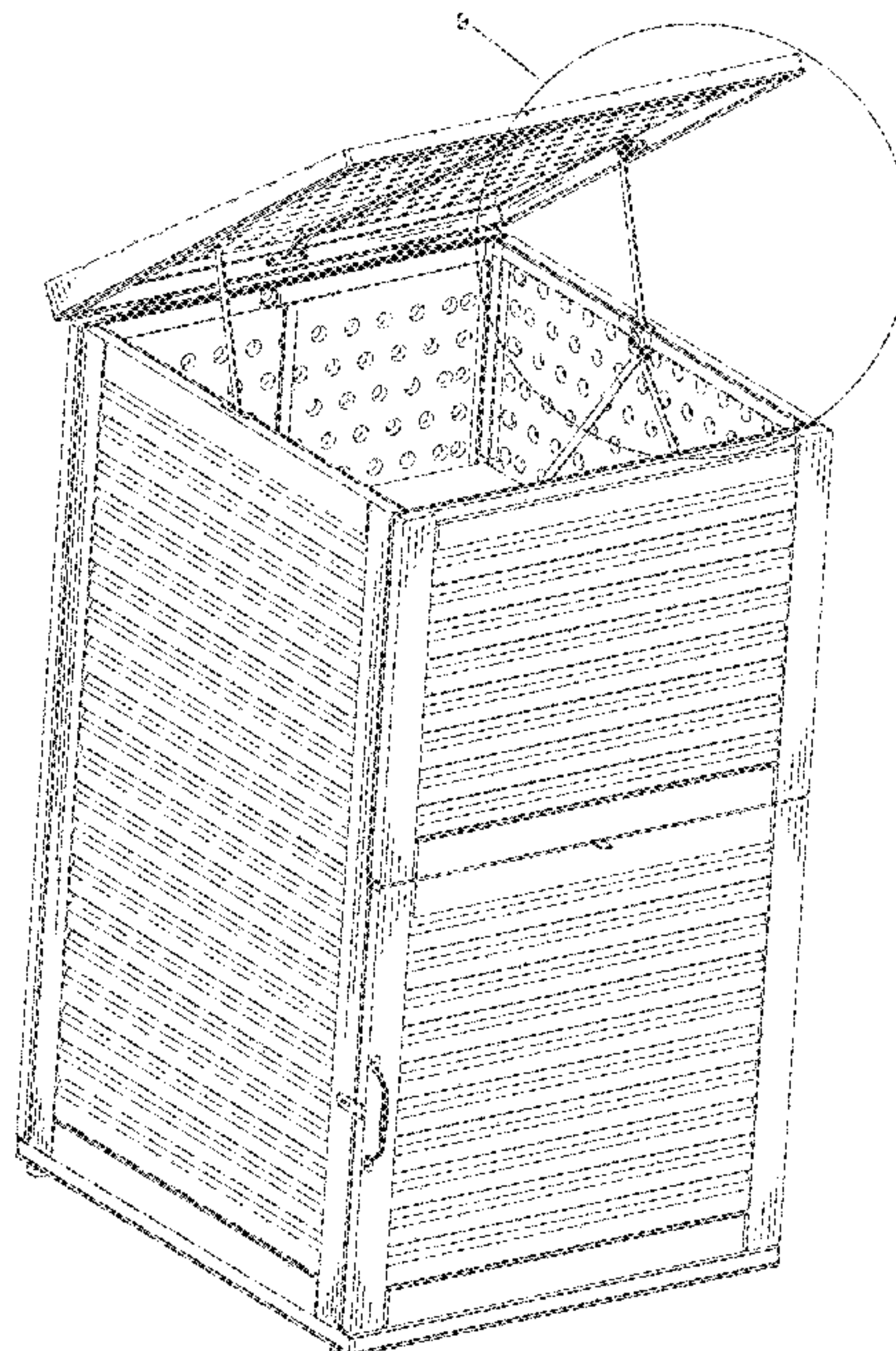
(57) **CLAIM**

The ornamental design for a storage cabinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a storage cabinet showing the new design;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a perspective view thereof in a first position;  
FIG. 8 is a perspective view thereof in a second position; and,  
FIG. 9 is an enlarged detailed view showing a portion of the storage cabinet taken from the encircled area 9 shown in FIG. 8.

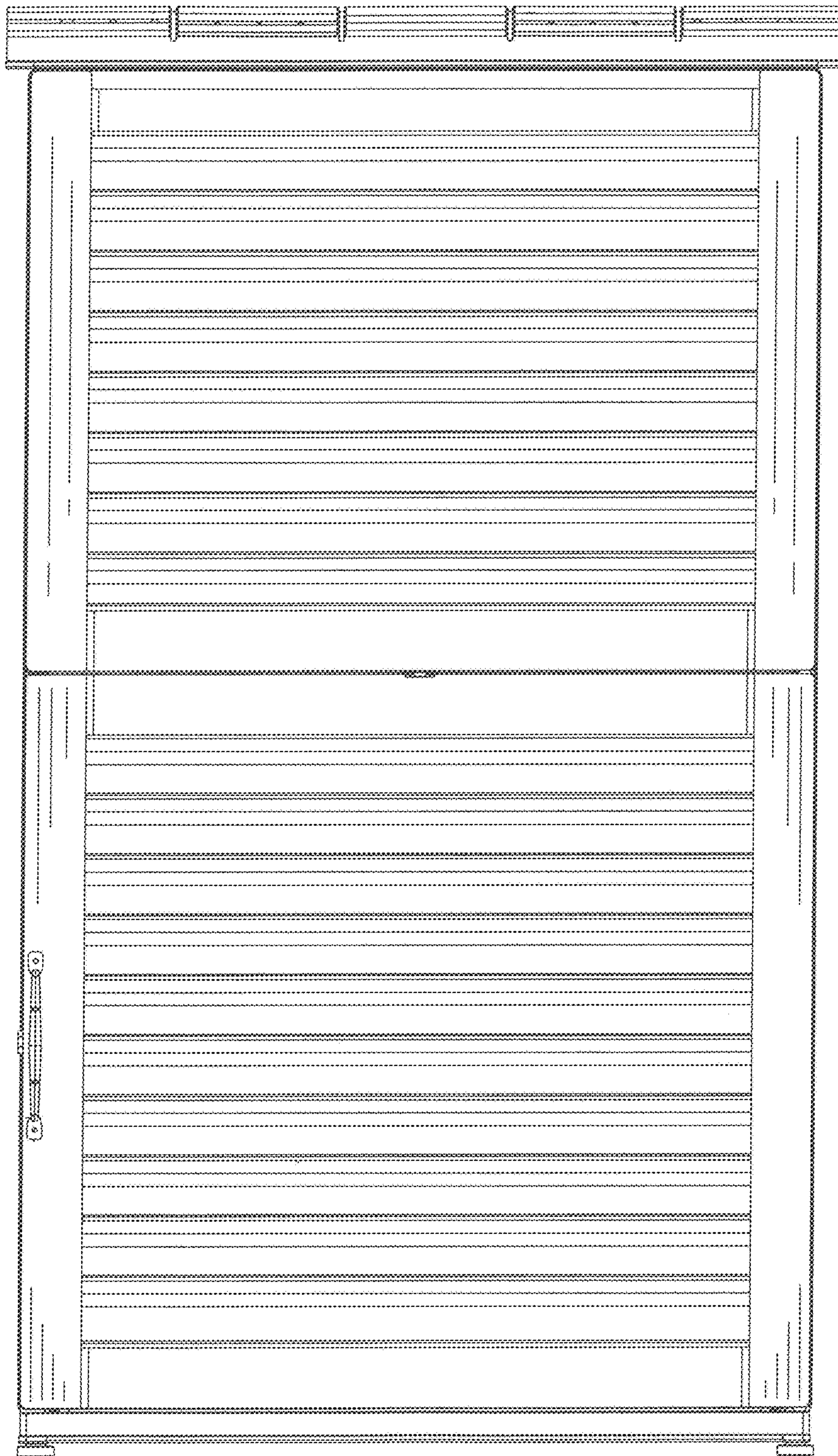

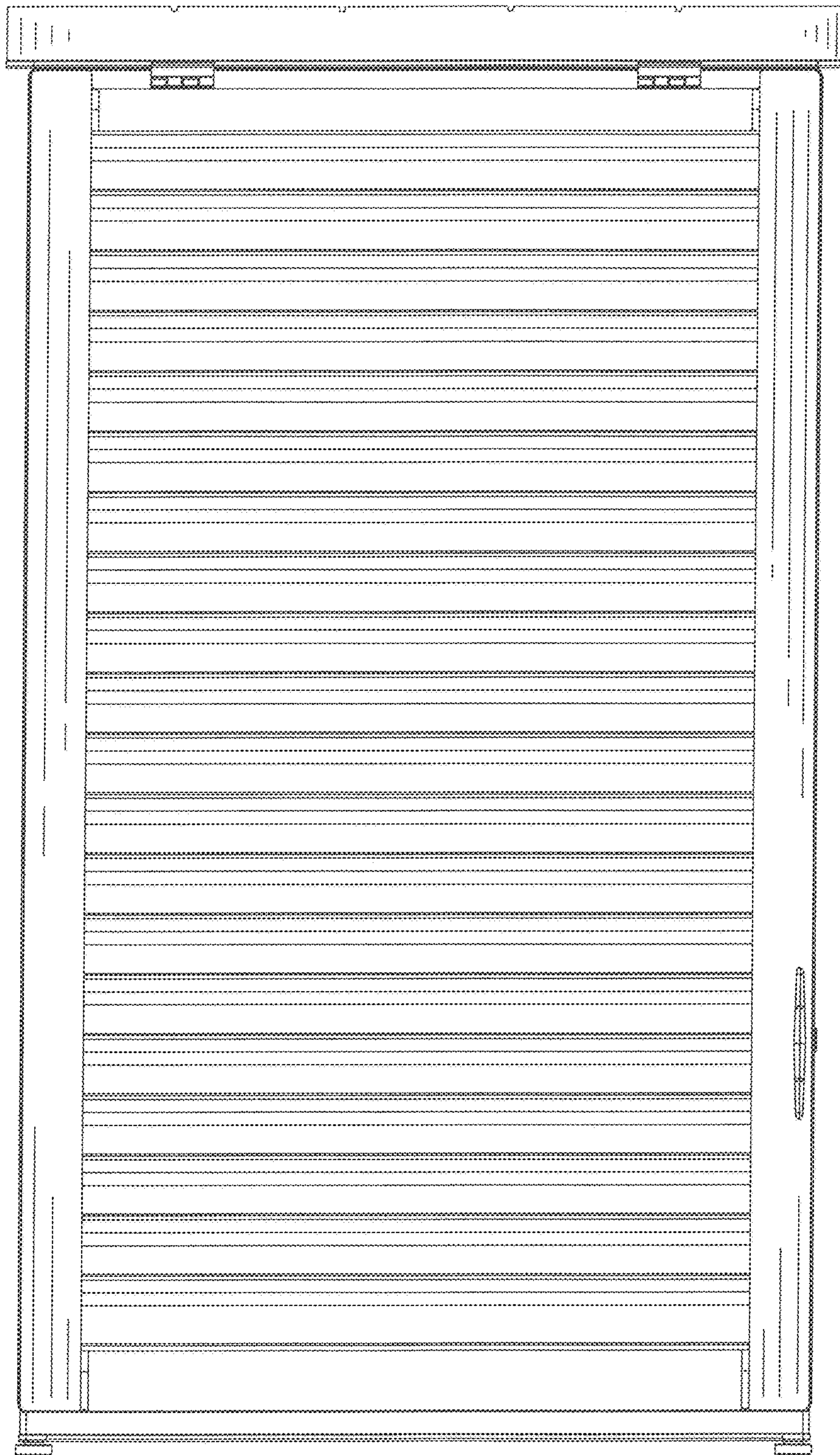

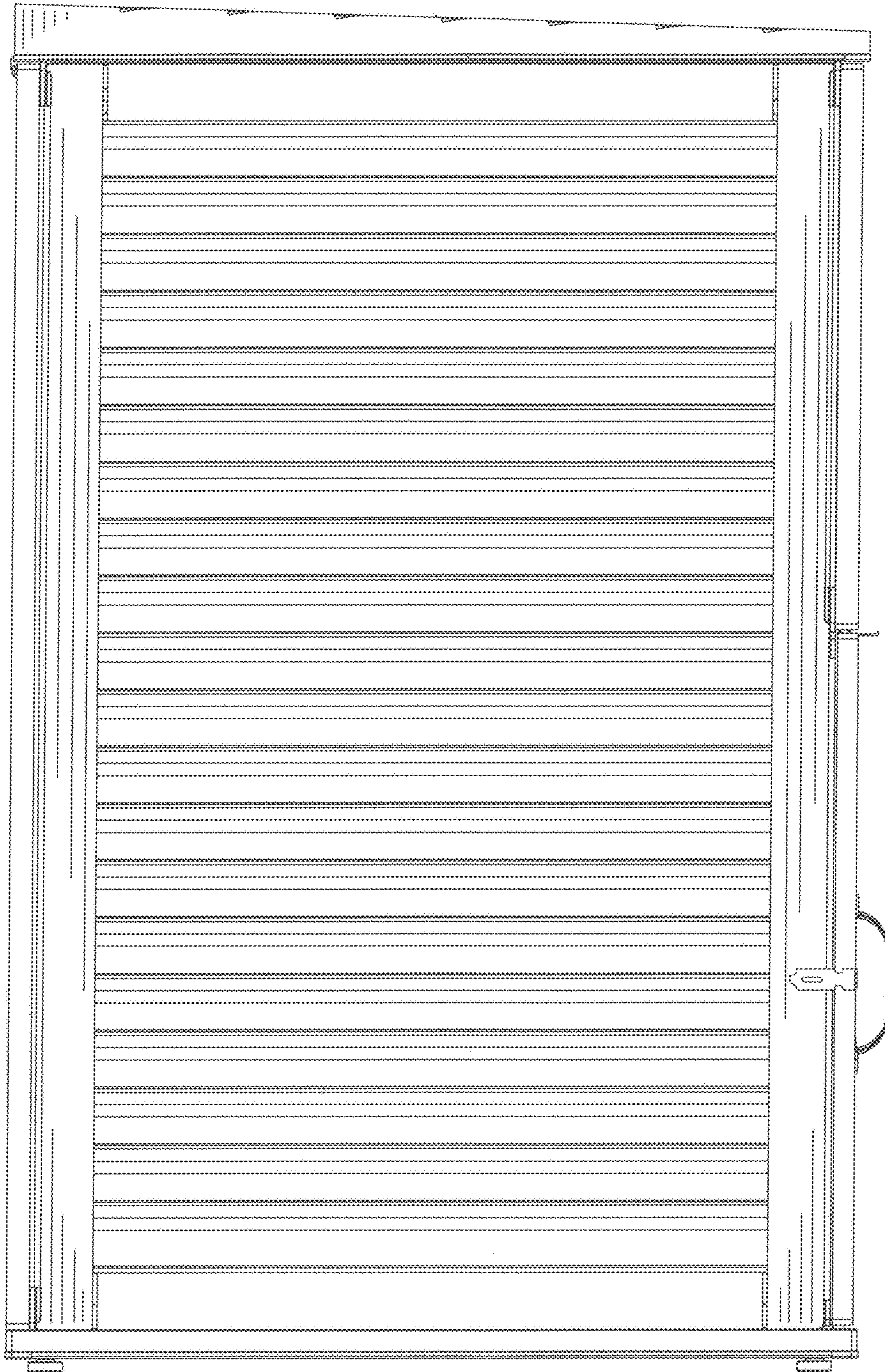

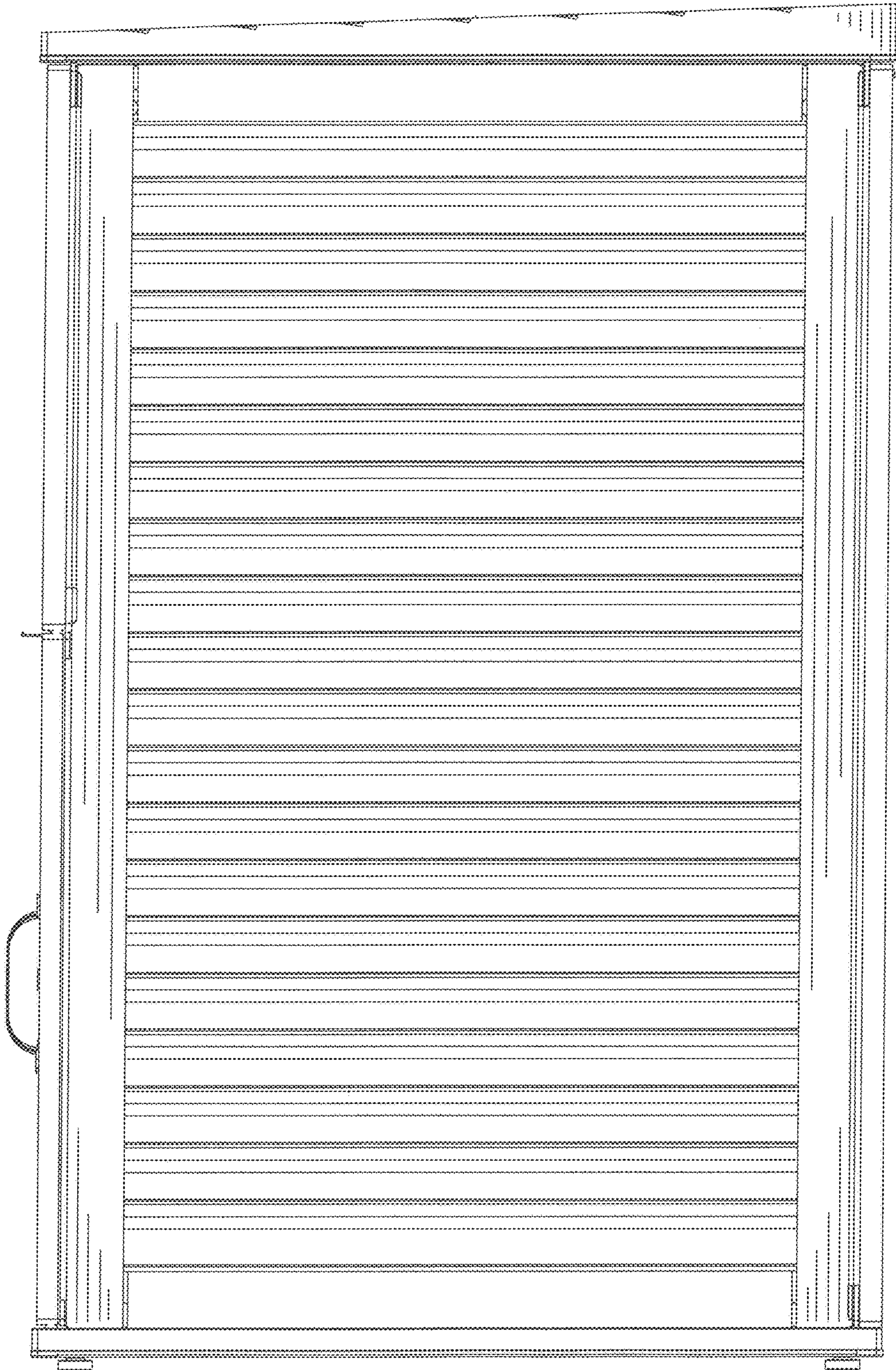

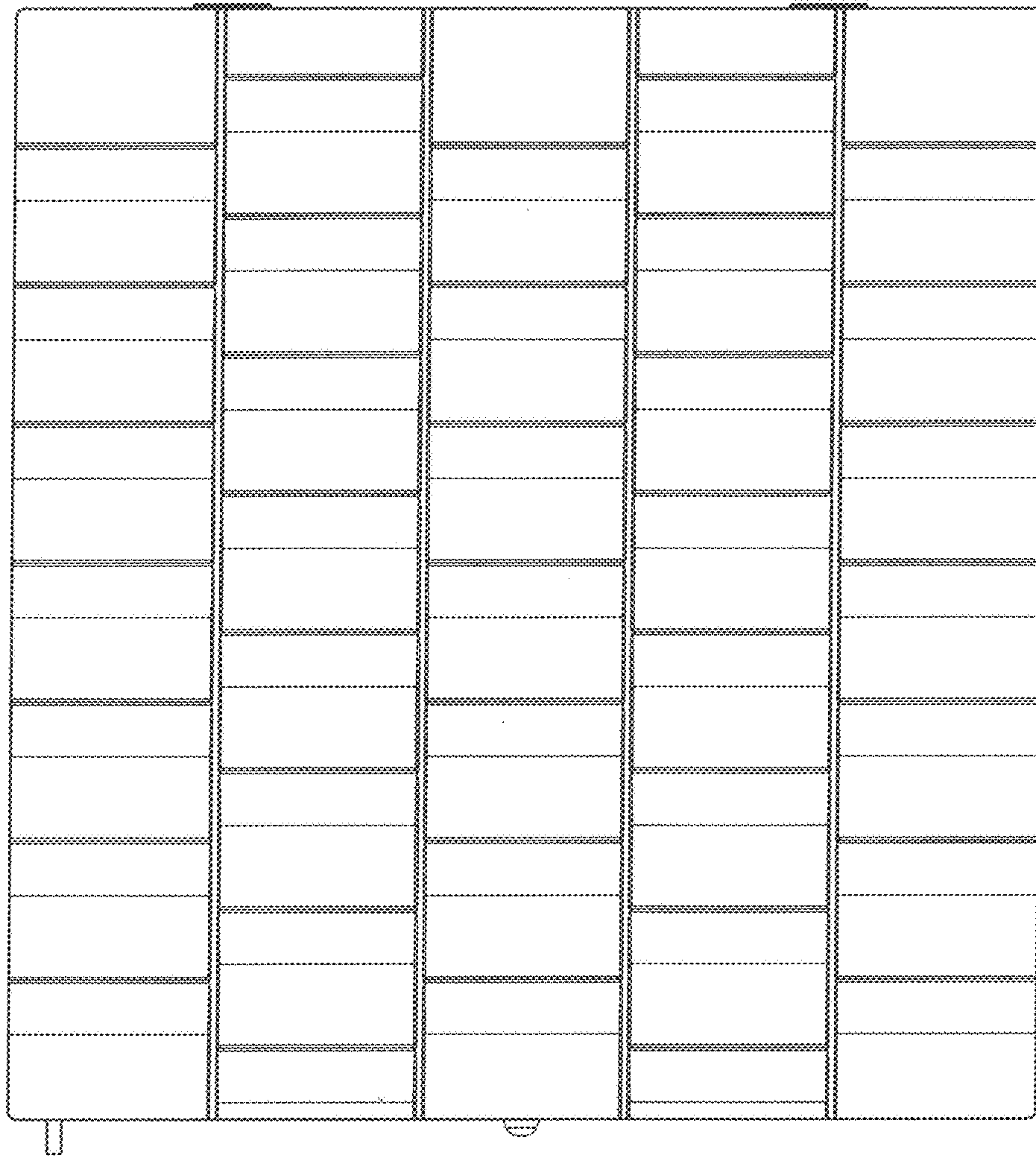

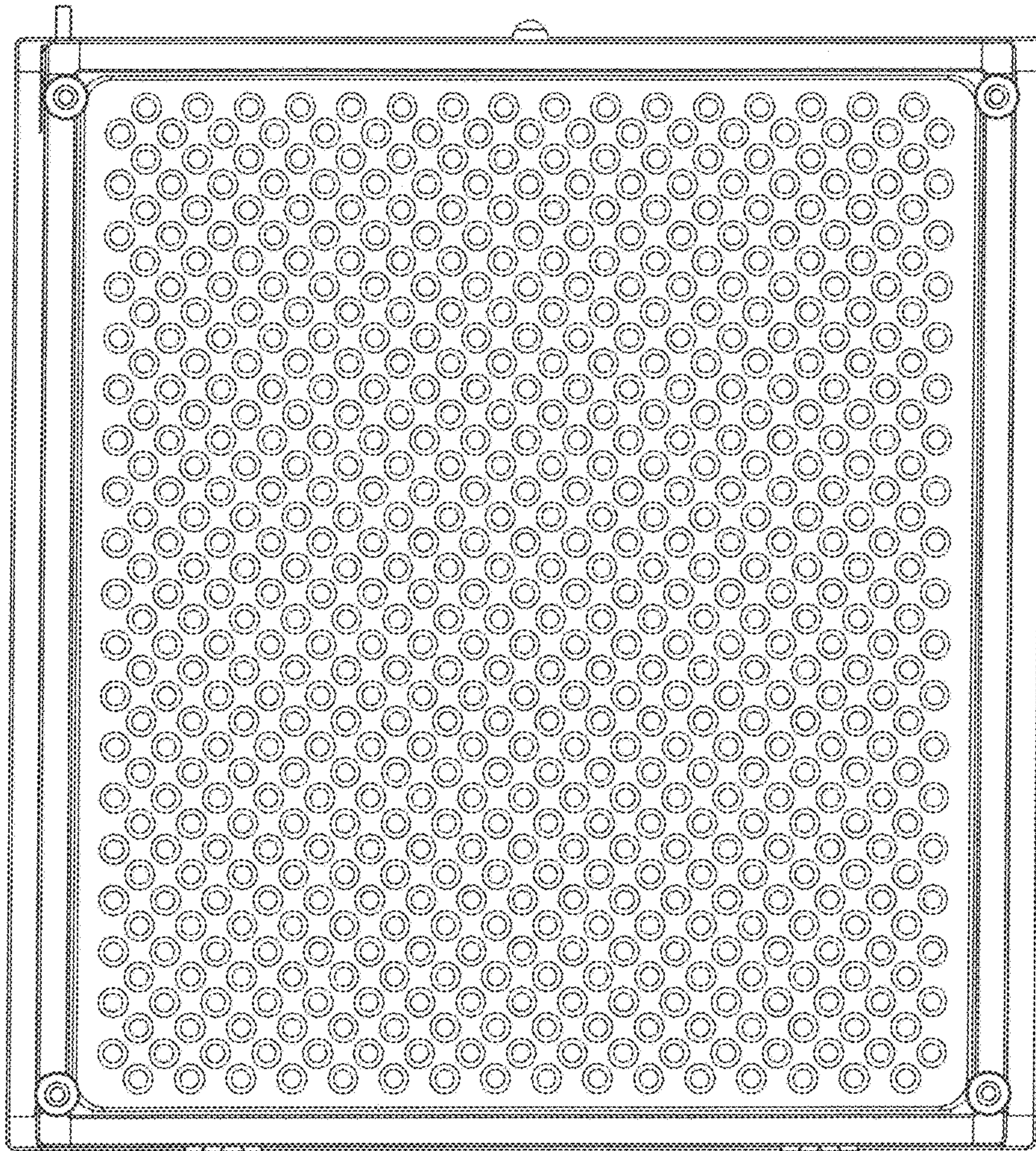

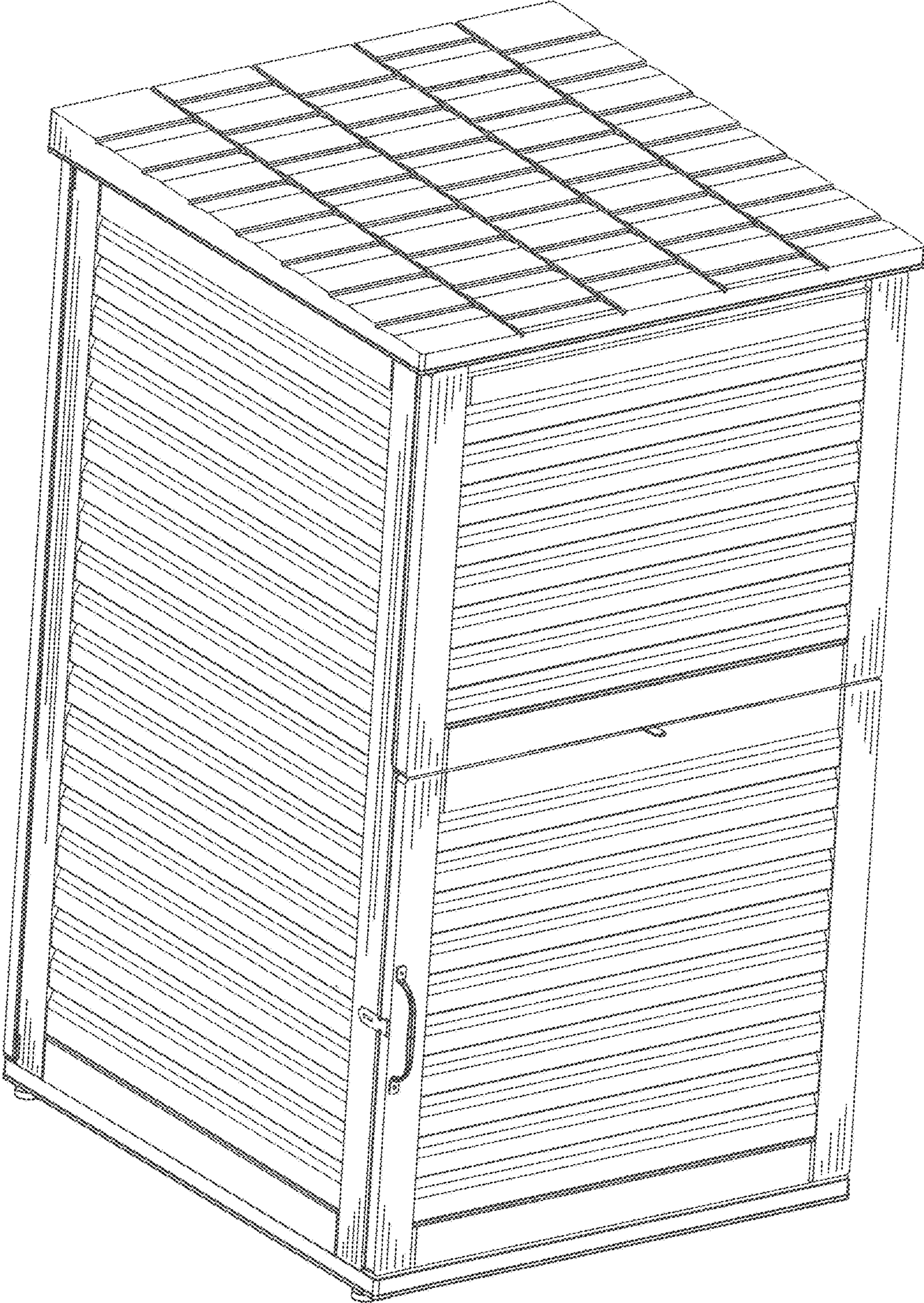

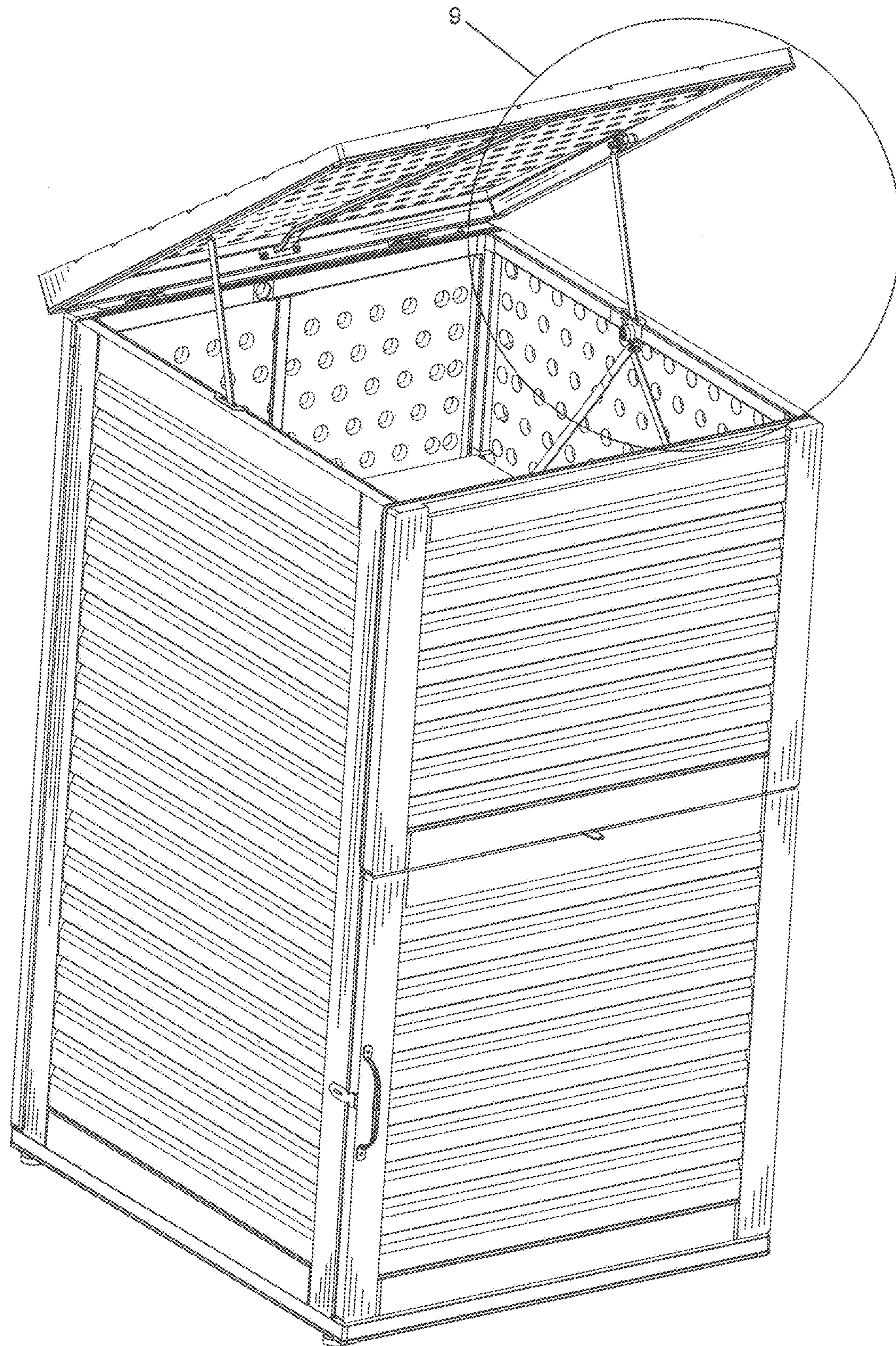

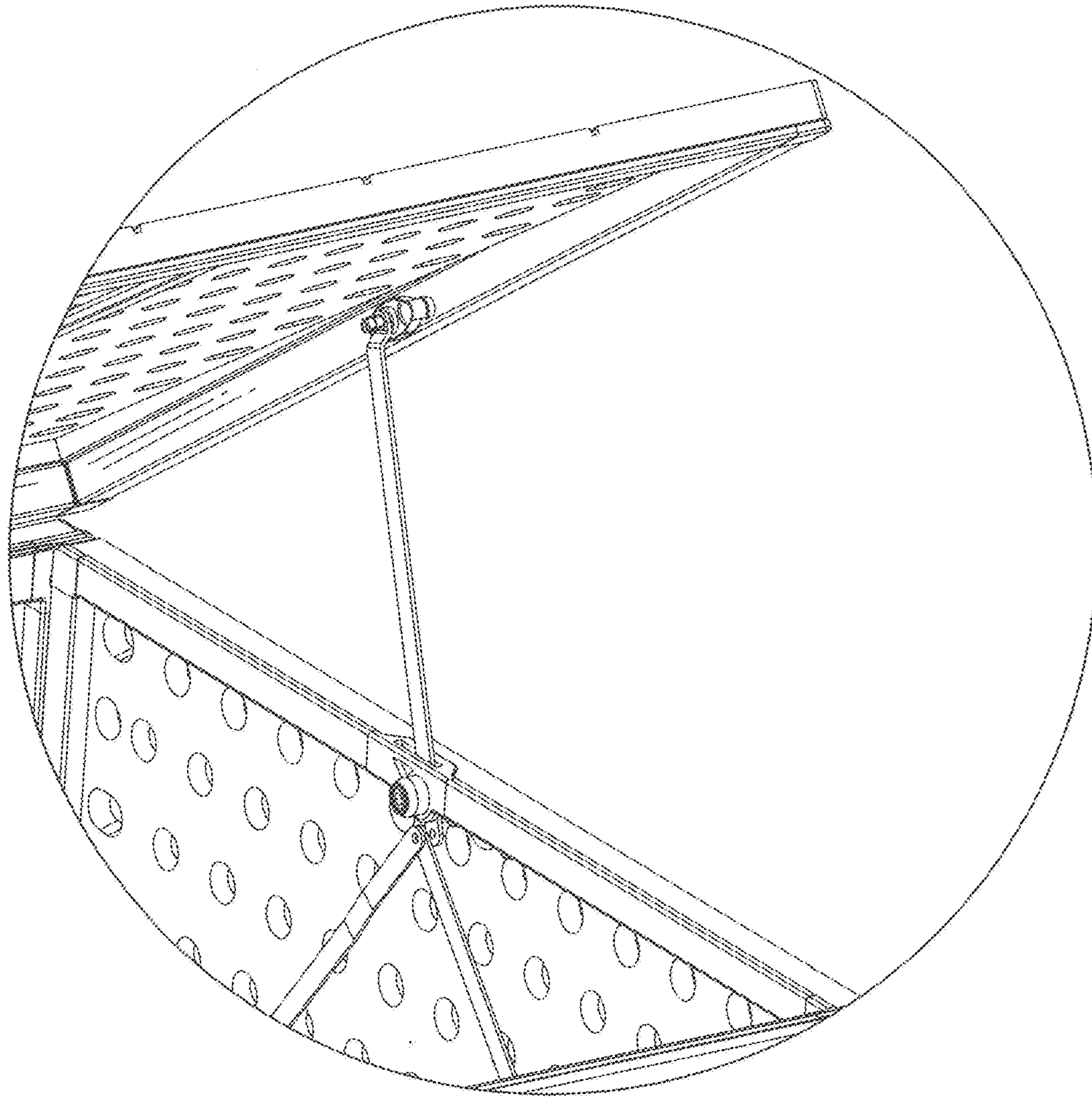
