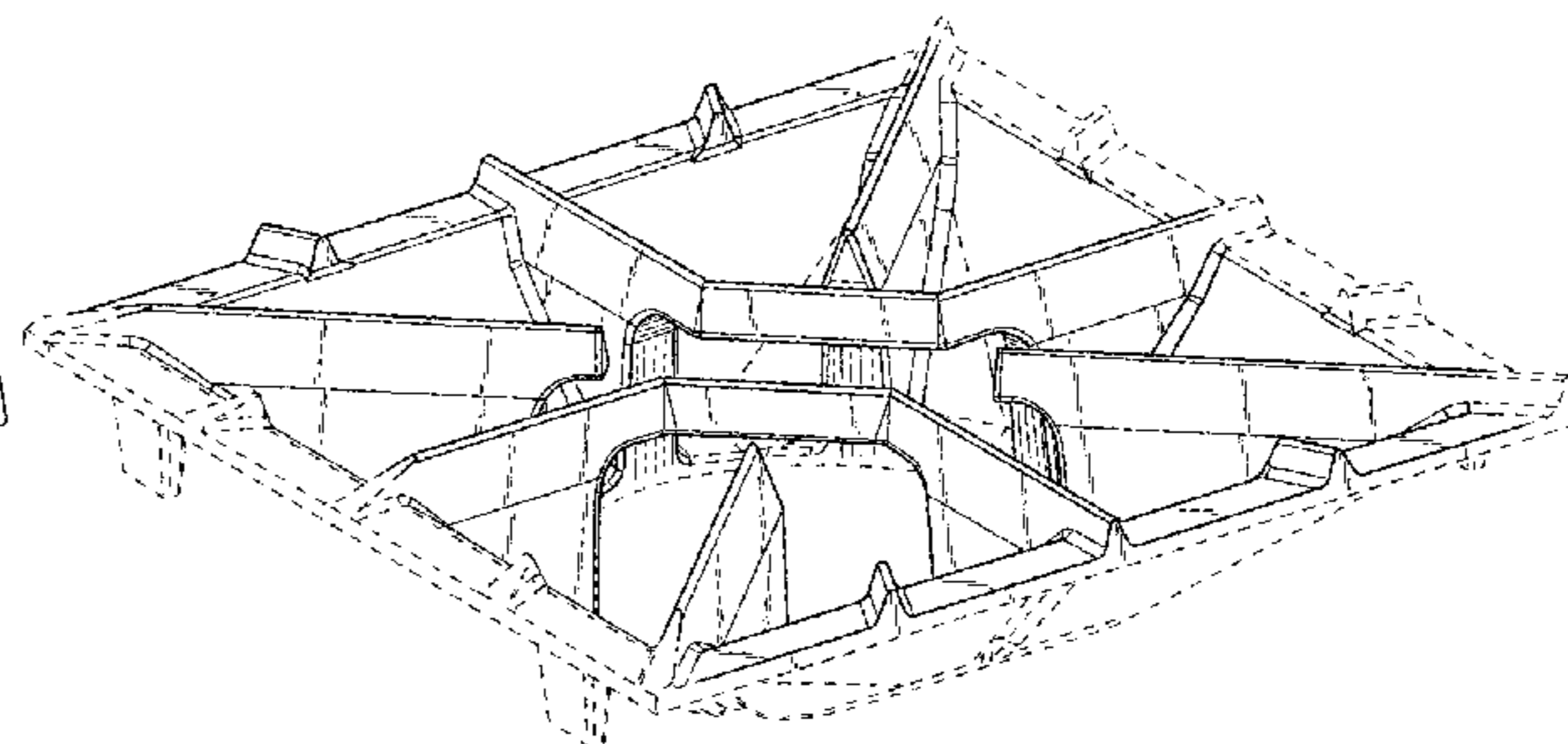
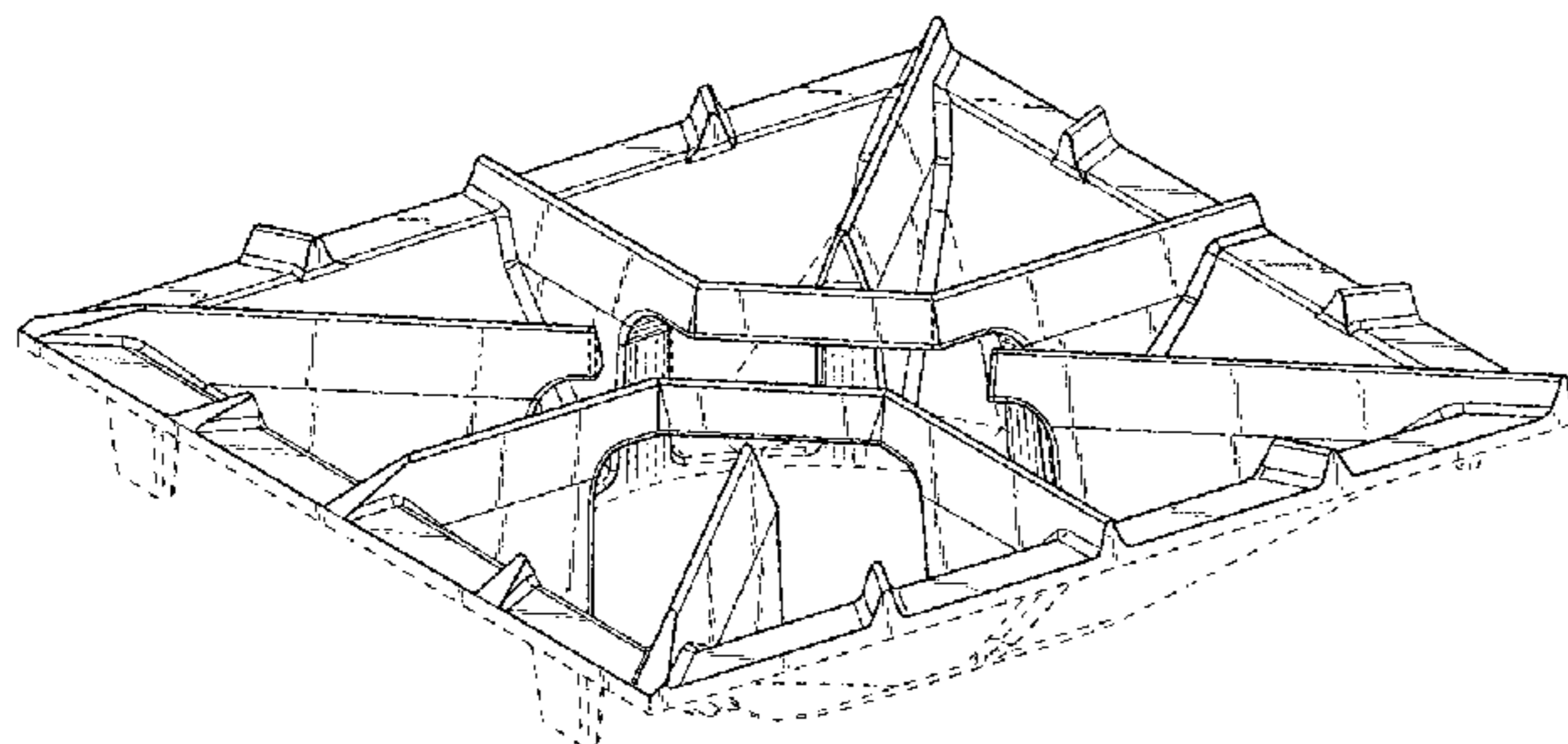
I claim the ornamental design for a grate, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a first embodiment of a grate;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a right side elevation view thereof;
 FIG. 7 is a left side elevation view thereof;
 FIG. 8 is a top rear perspective view thereof;
 FIG. 9 is a top front perspective view of a second embodiment of a grate;
 FIG. 10 is a front elevation view thereof;
 FIG. 11 is a rear elevation view thereof;
 FIG. 12 is a top plan view thereof;
 FIG. 13 is a bottom plan view thereof;
 FIG. 14 is a right side elevation view thereof;
 FIG. 15 is a left side elevation view thereof; and,
 FIG. 16 is a top plan view of a grate, shown in an environment.

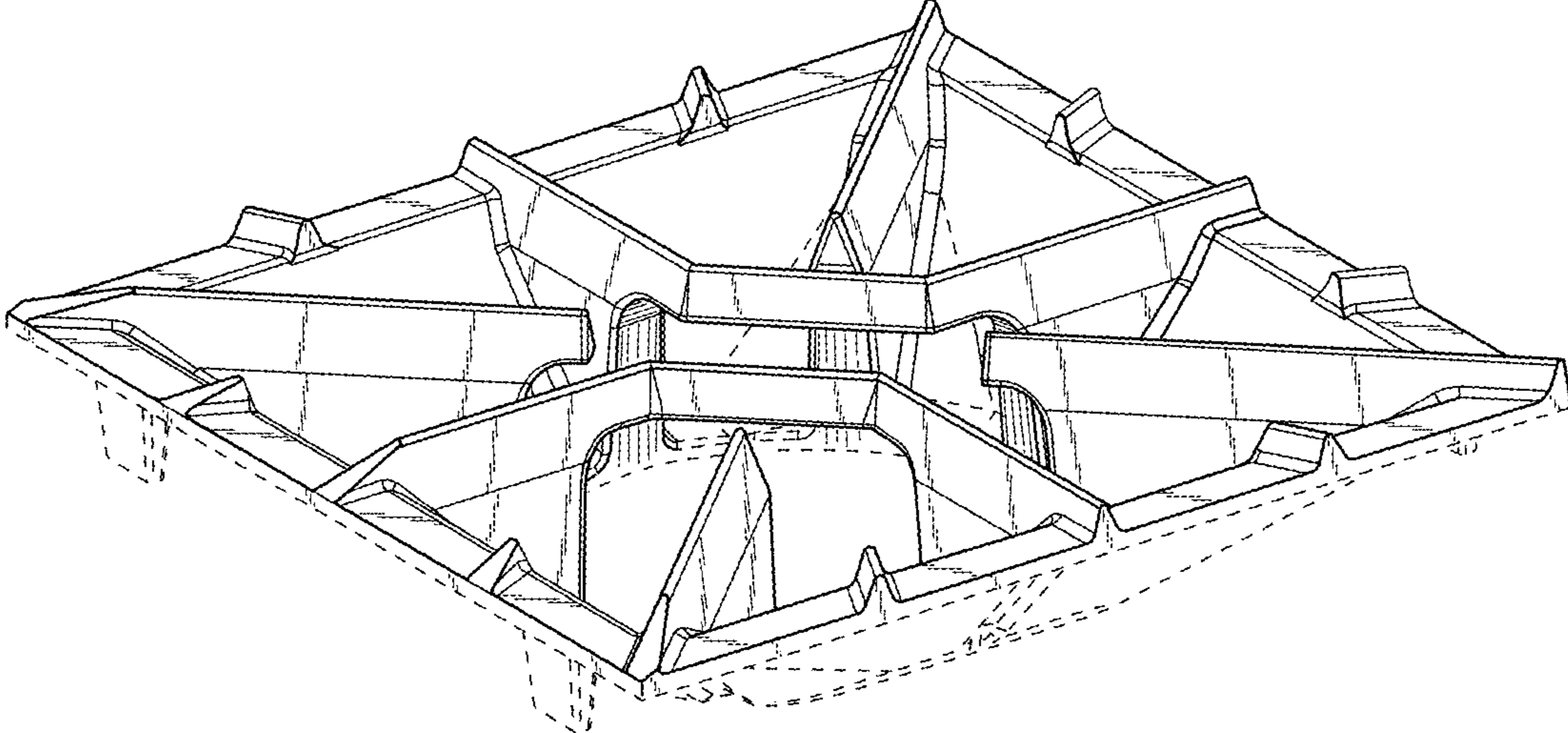

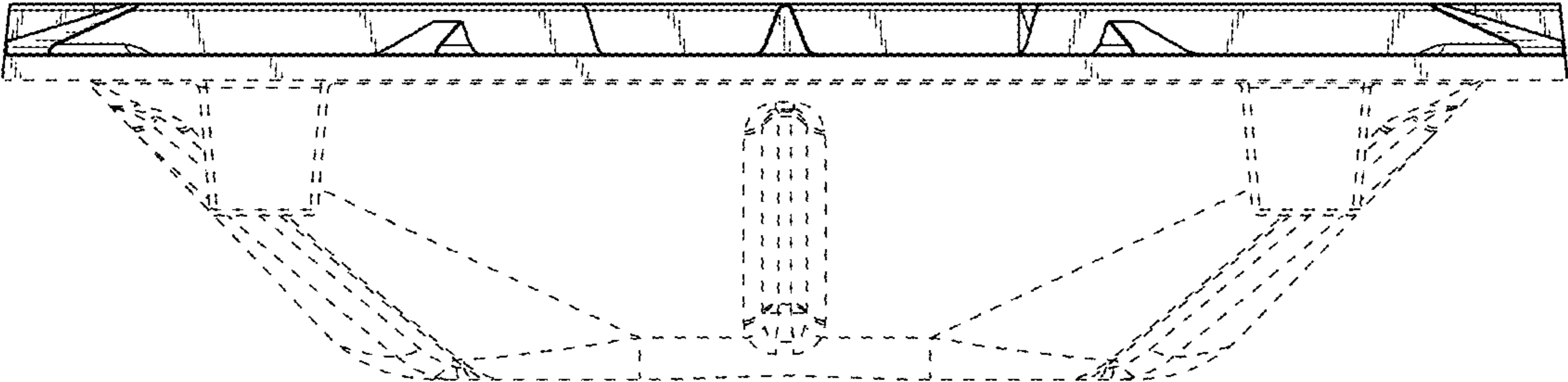

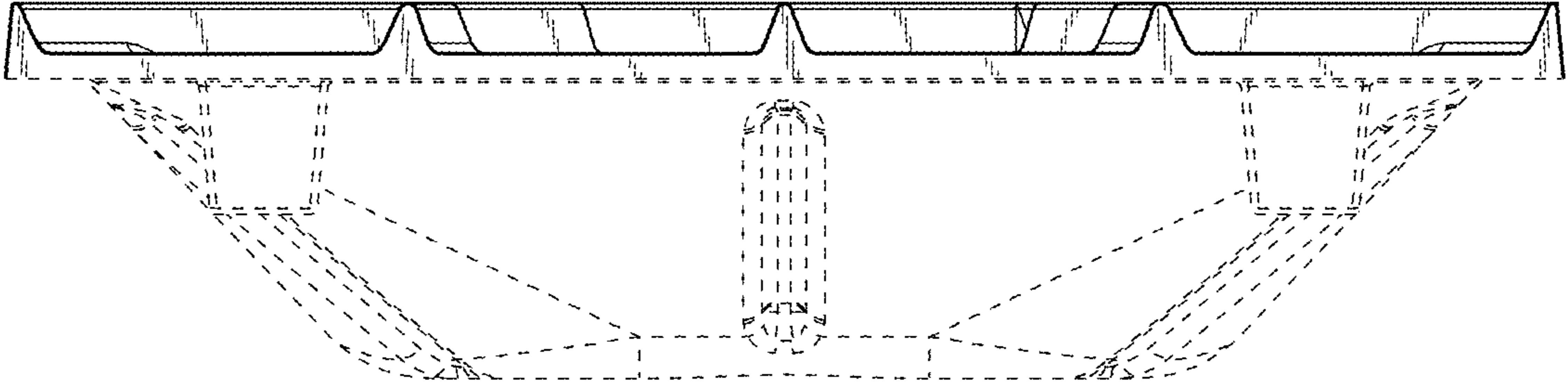

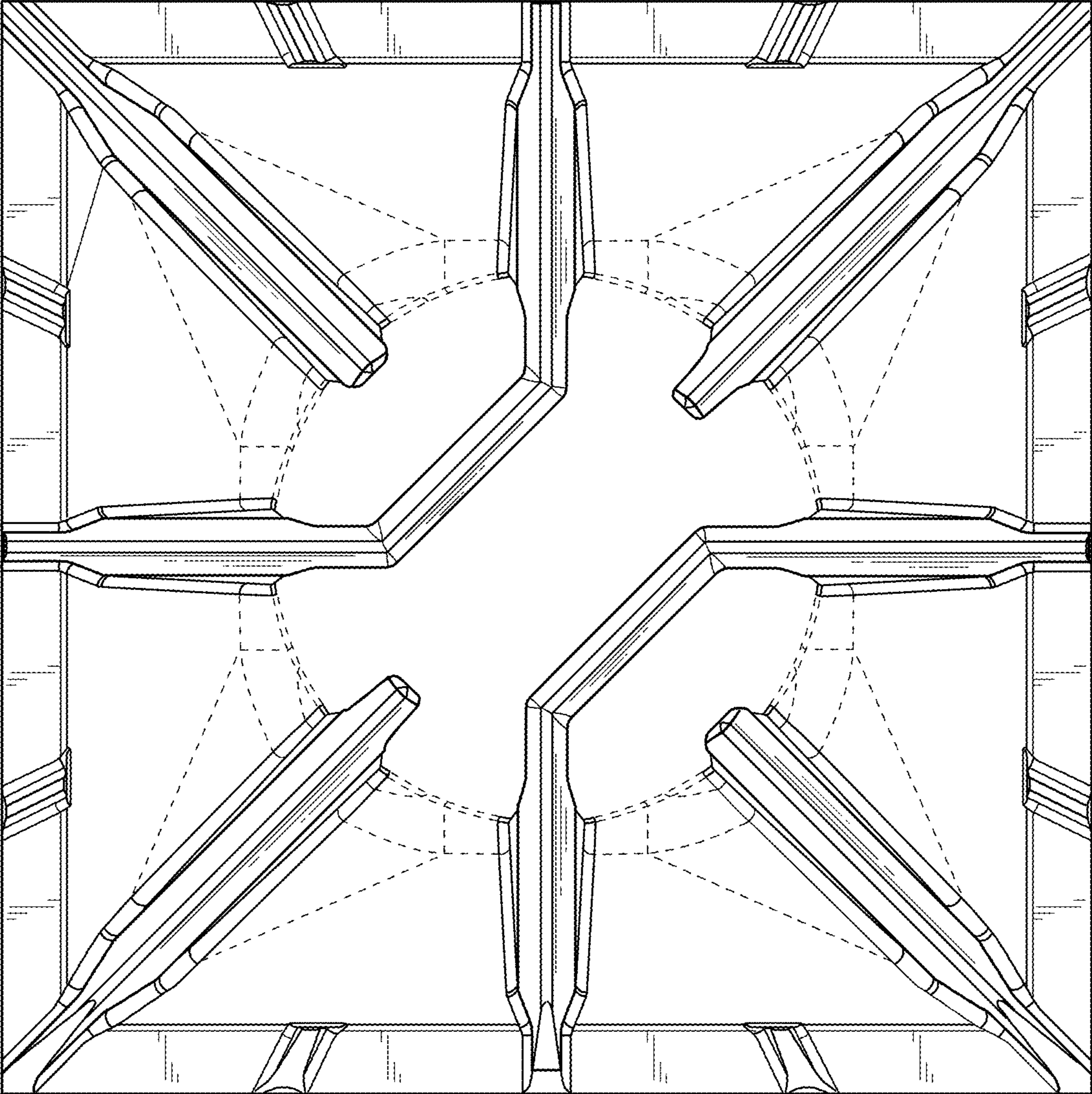

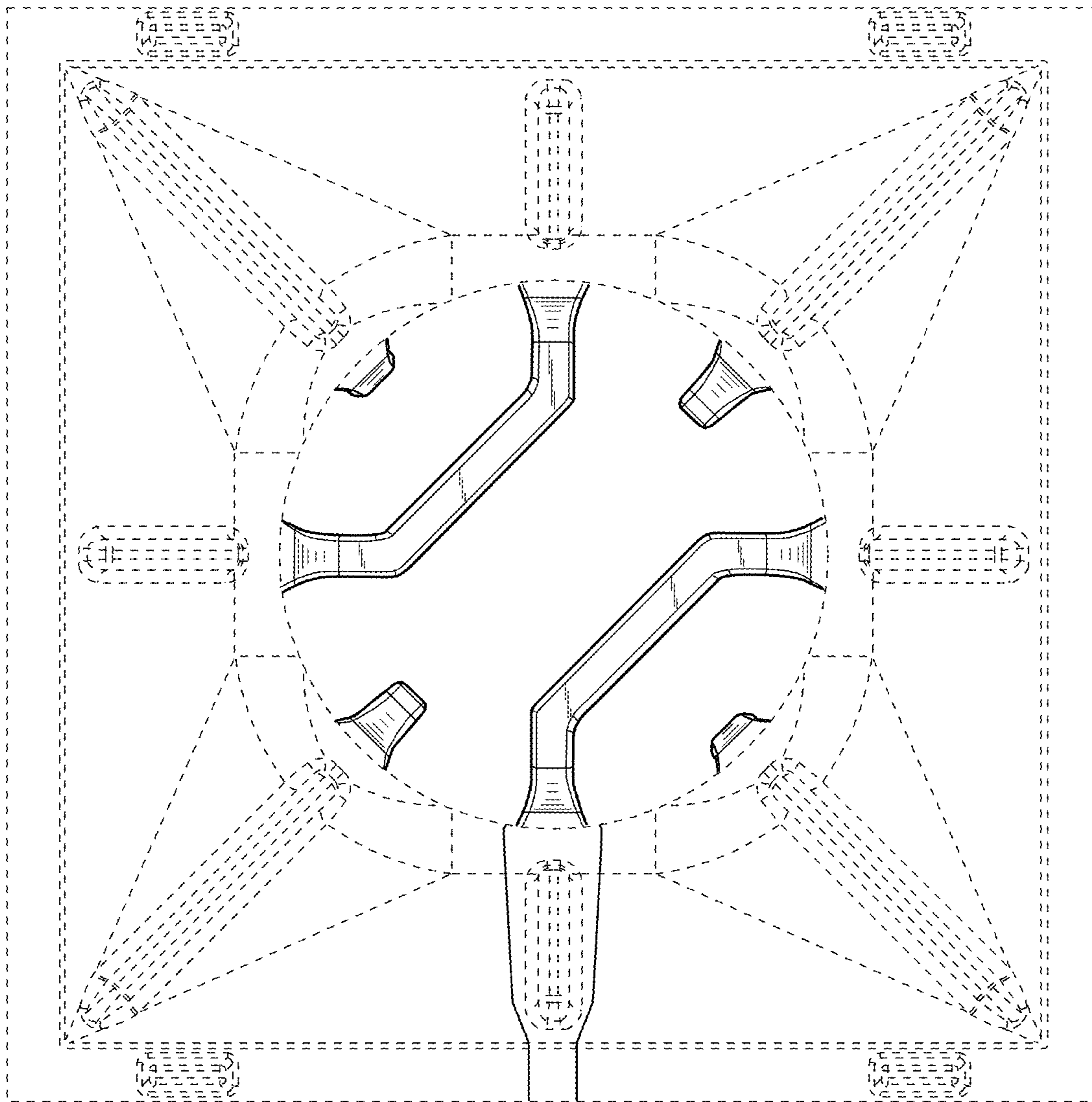

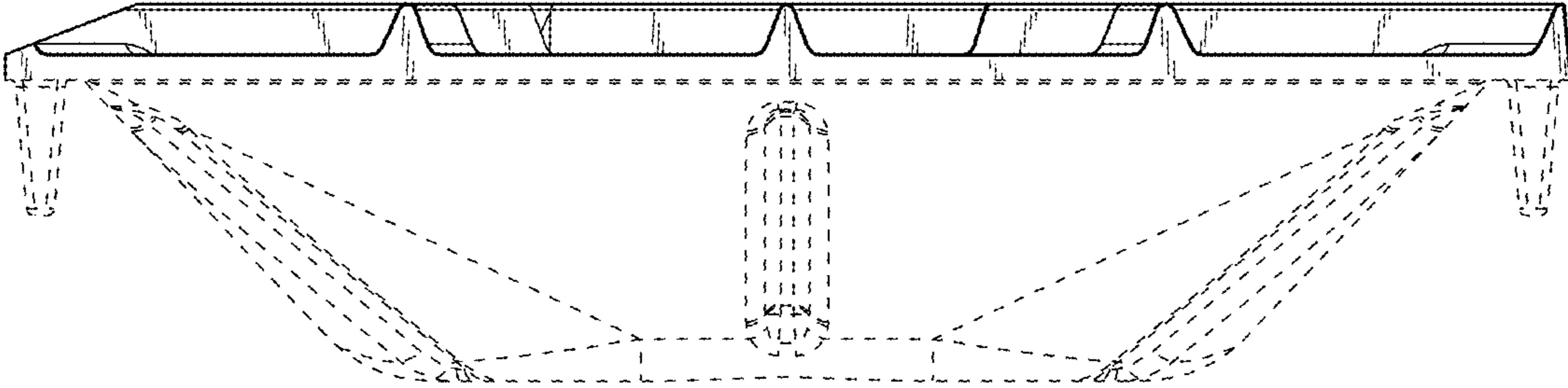

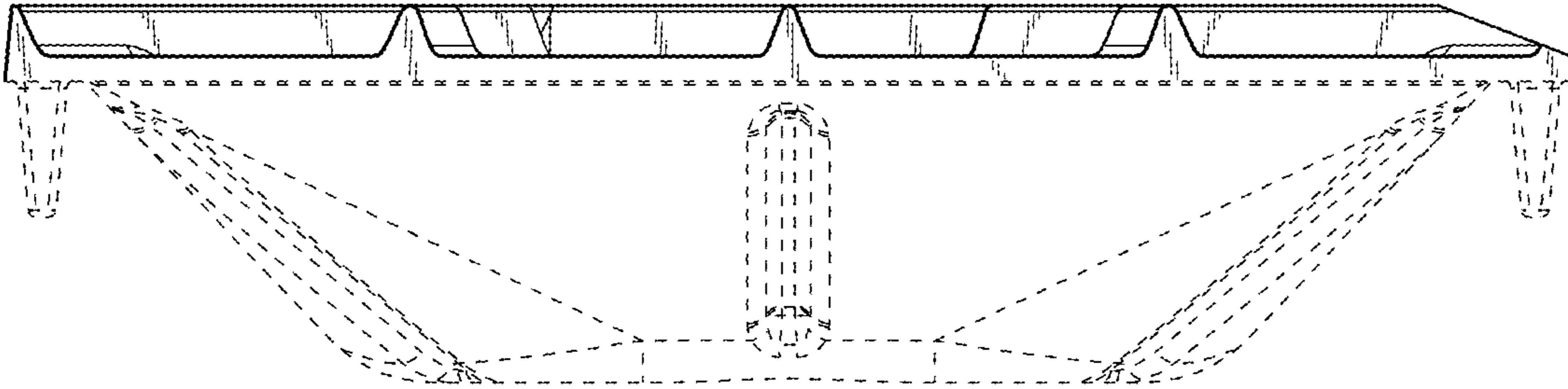

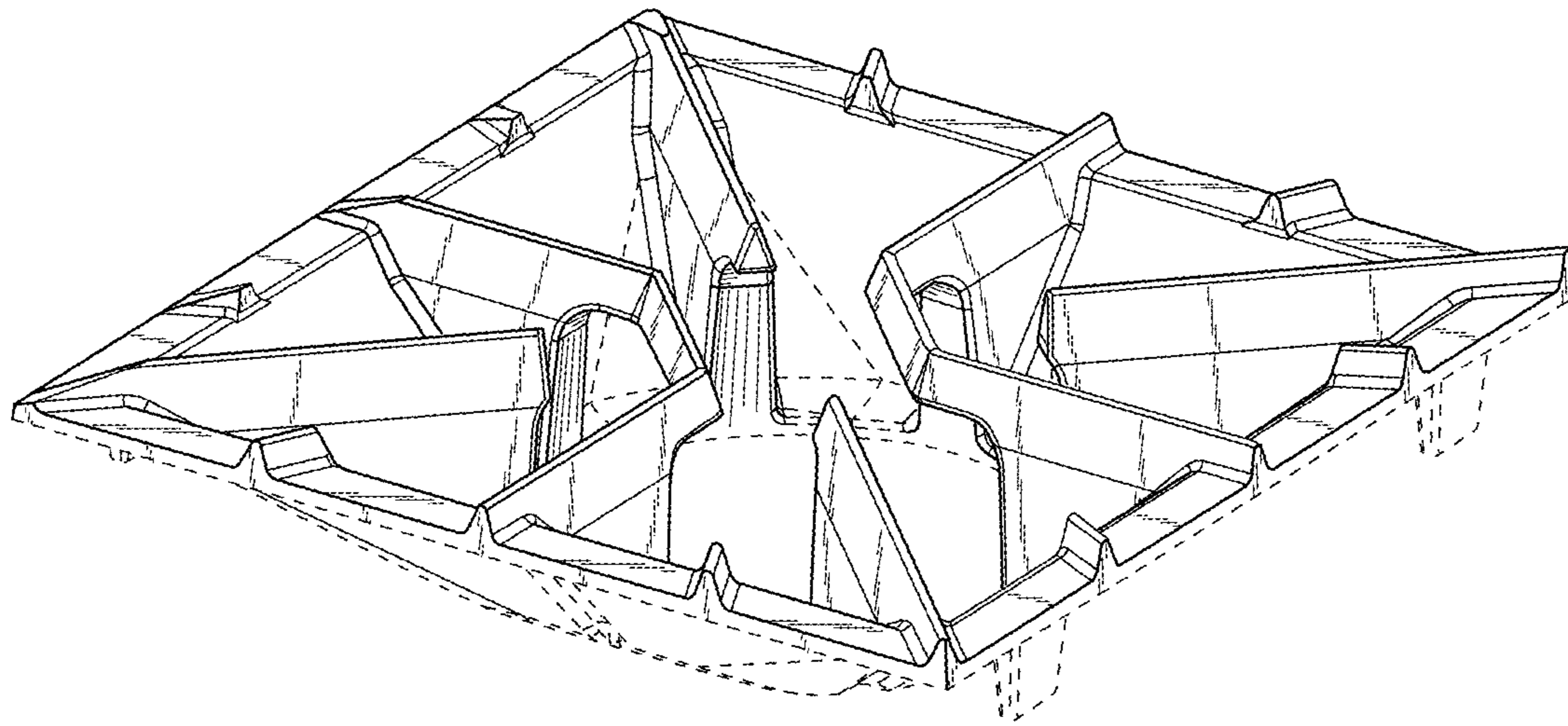

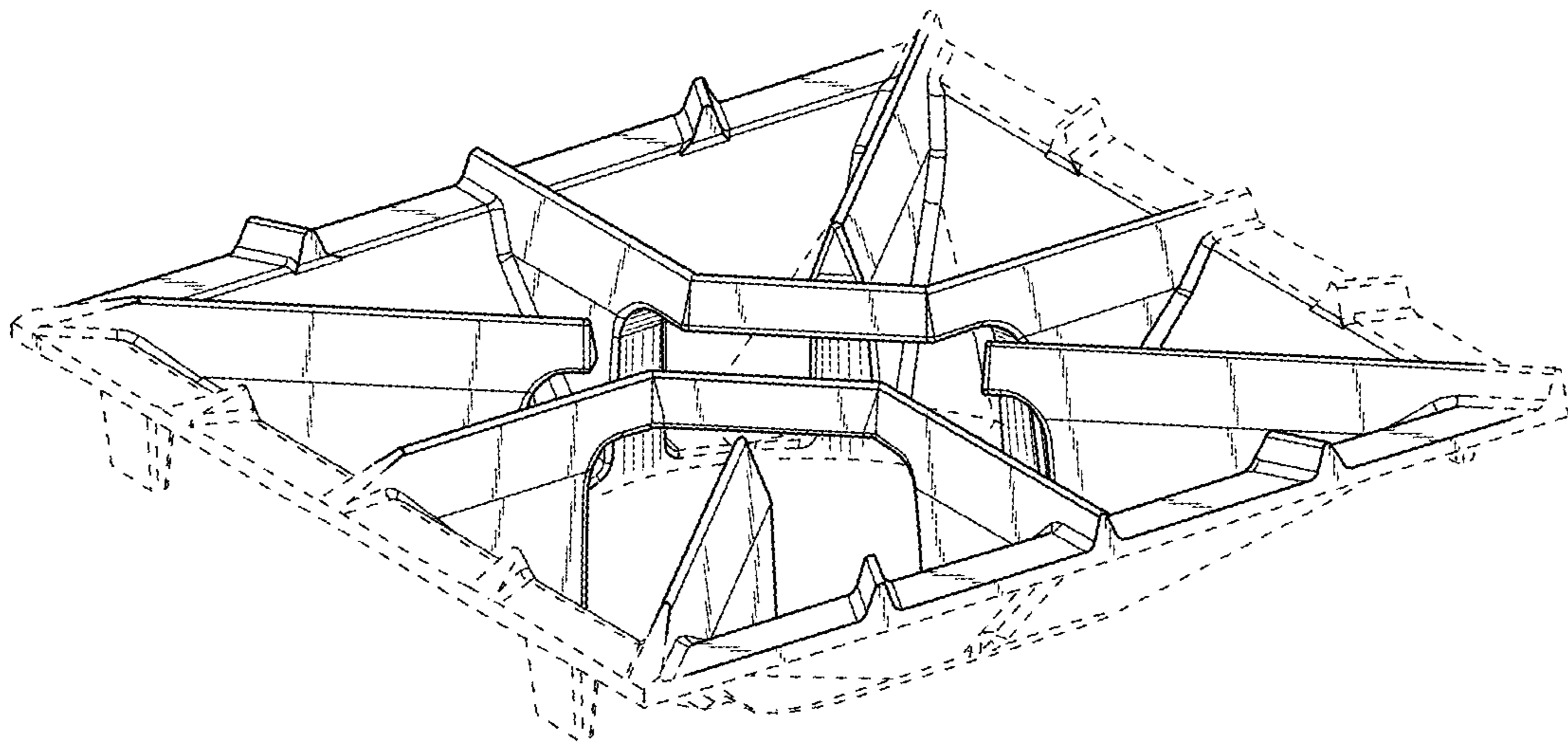

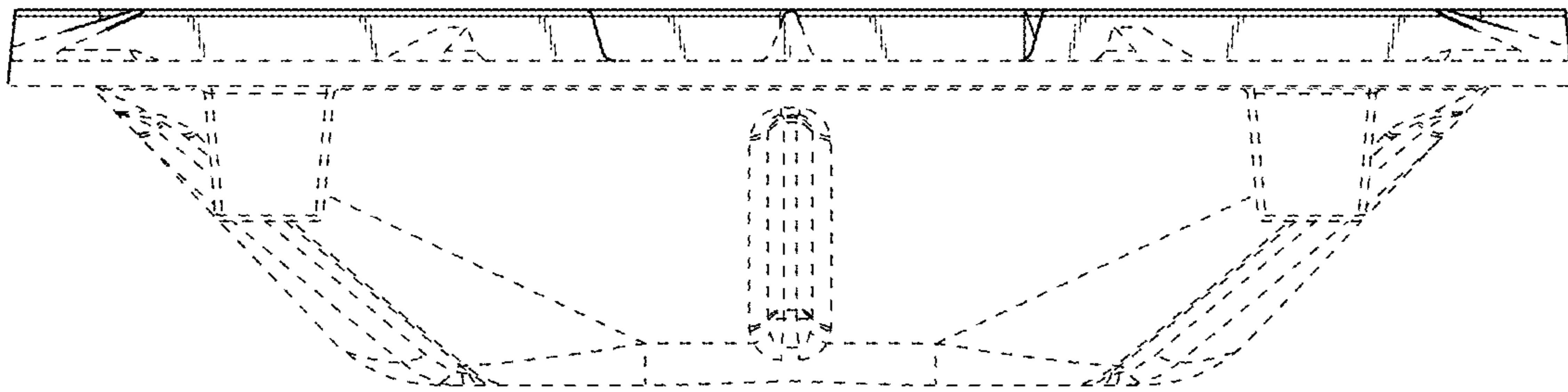

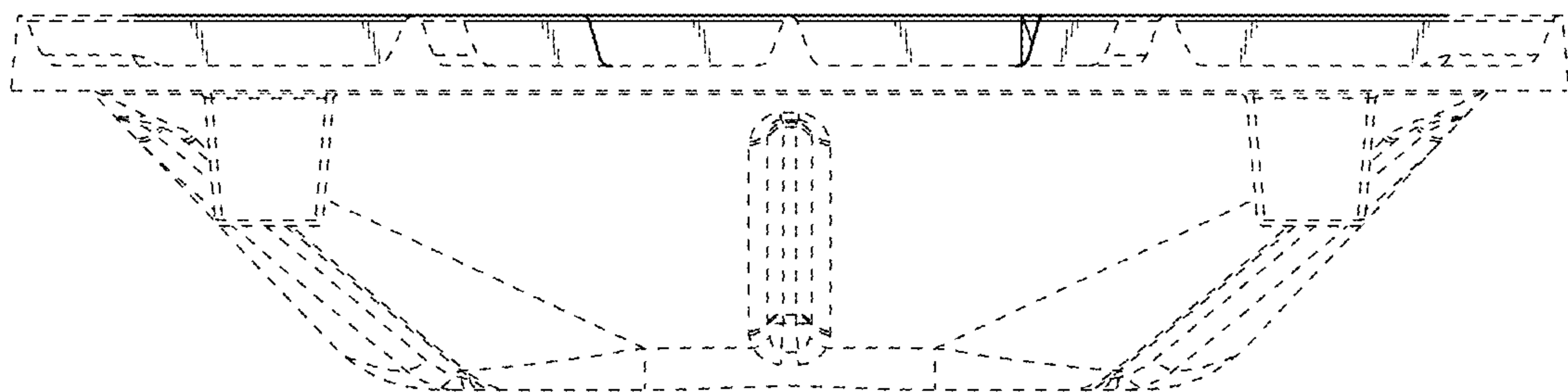

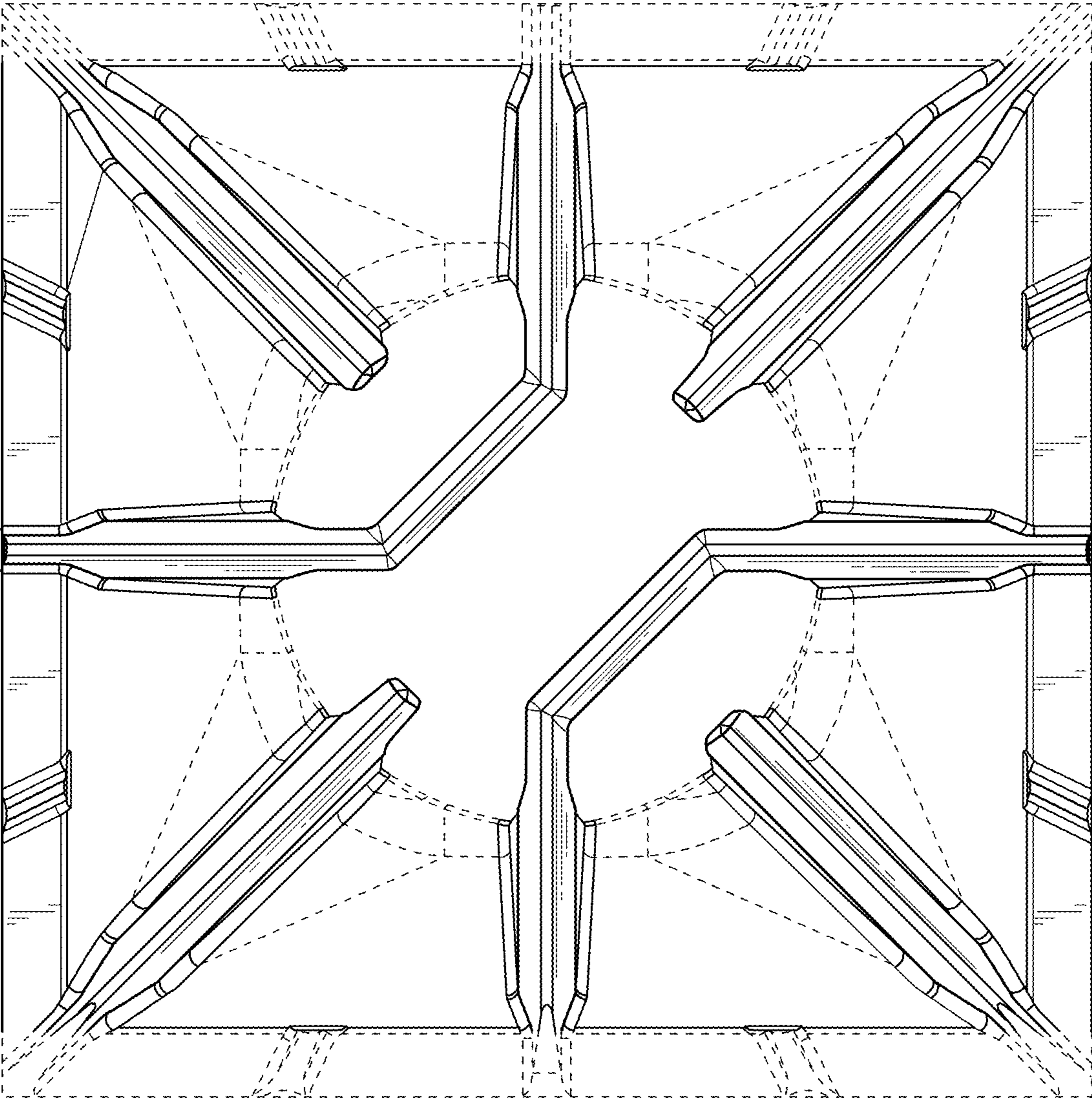

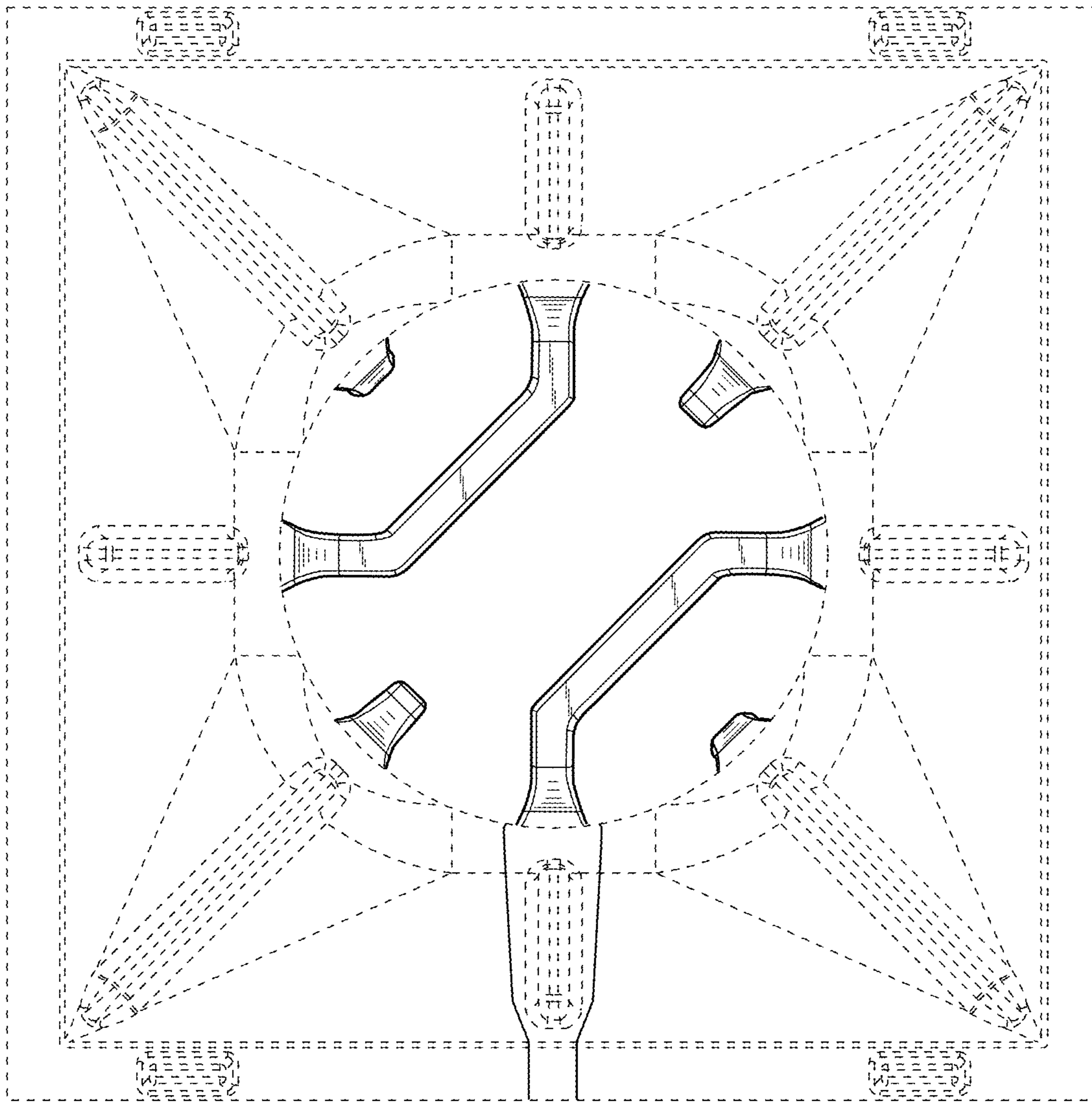

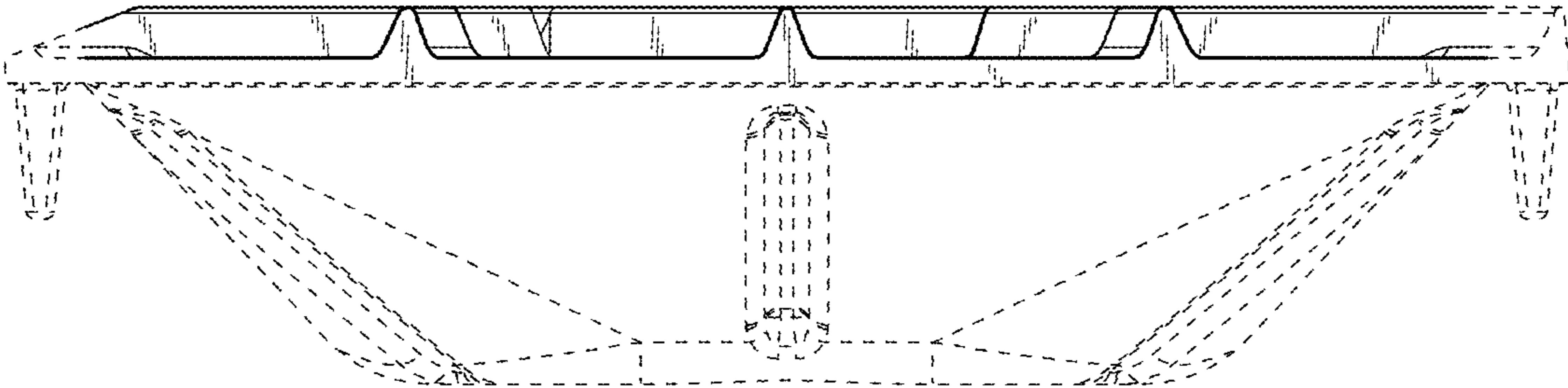

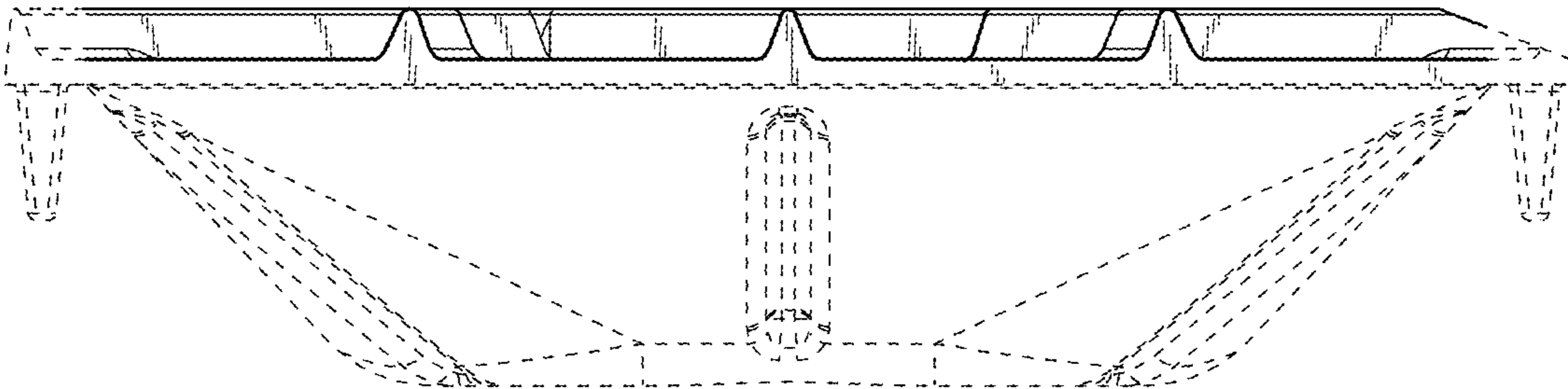
