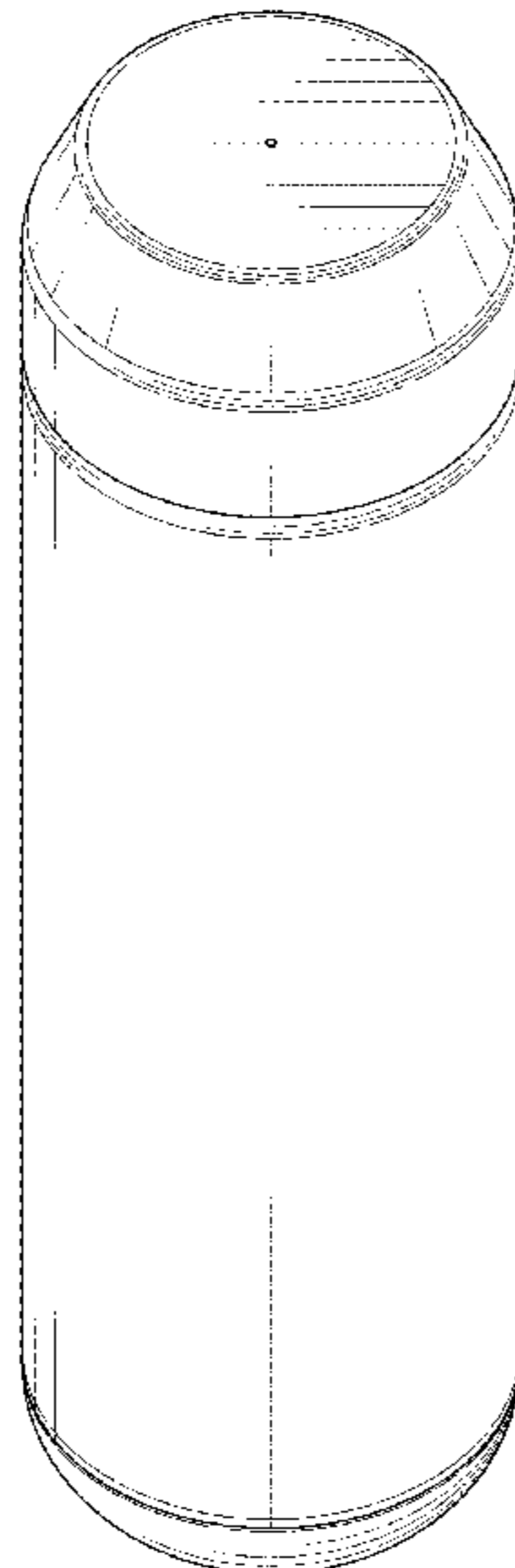
The ornamental design for a bottle, as shown and described.

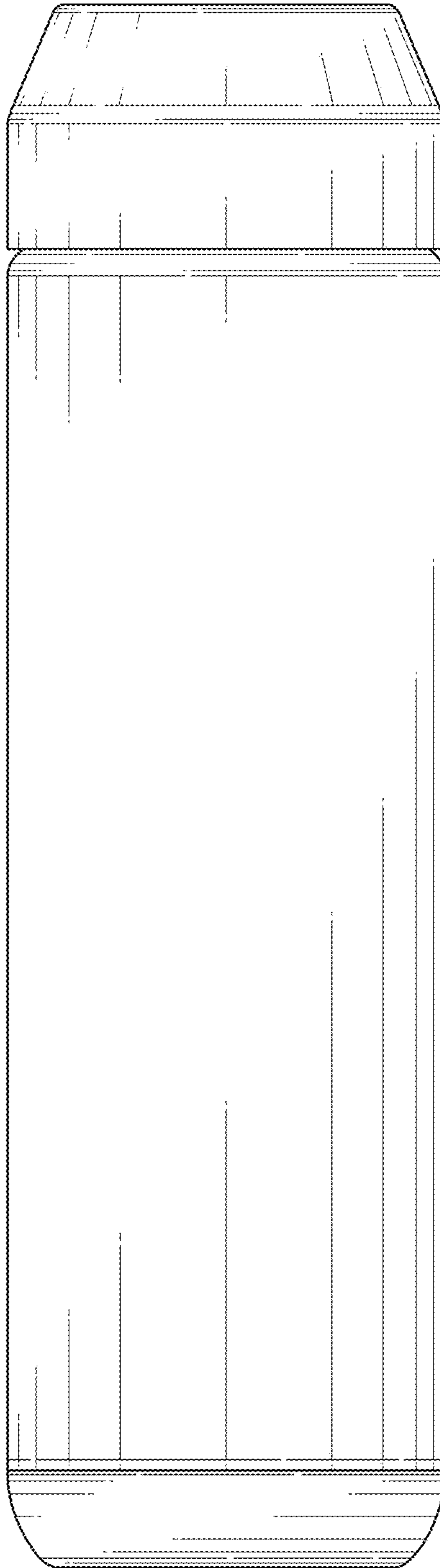

- Fig. 1.7 Top

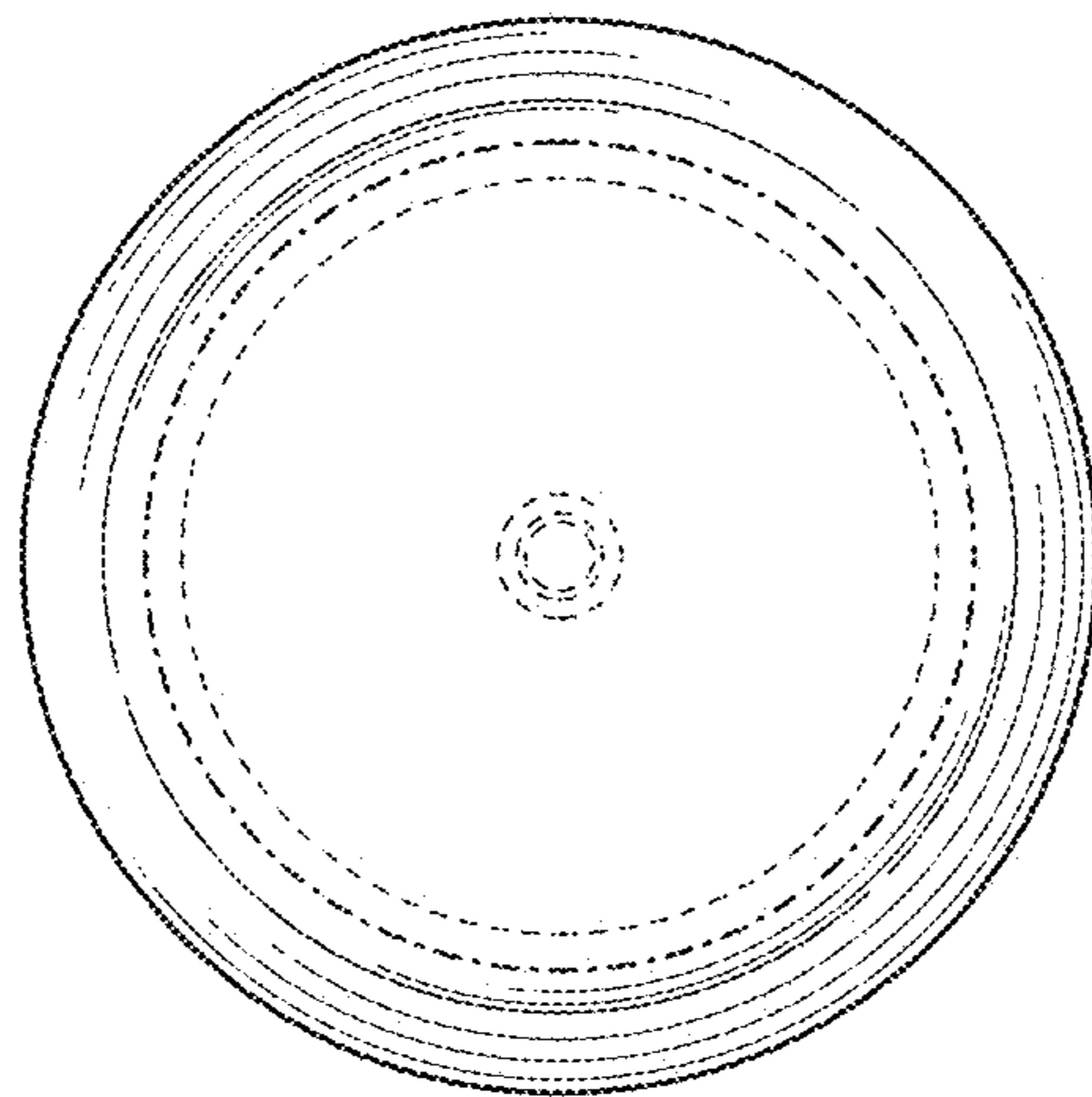

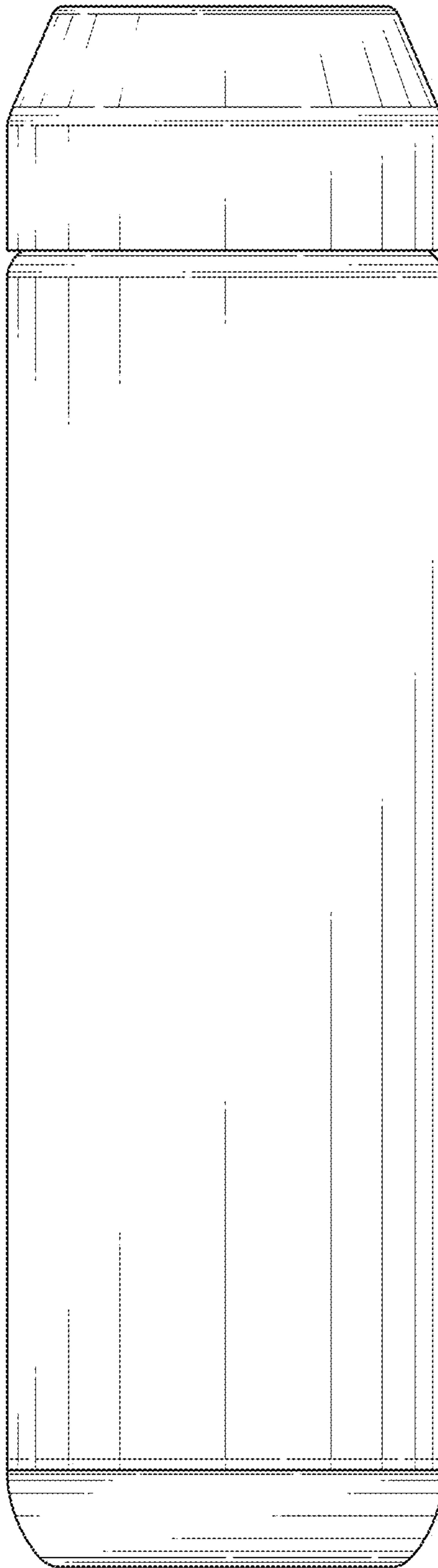




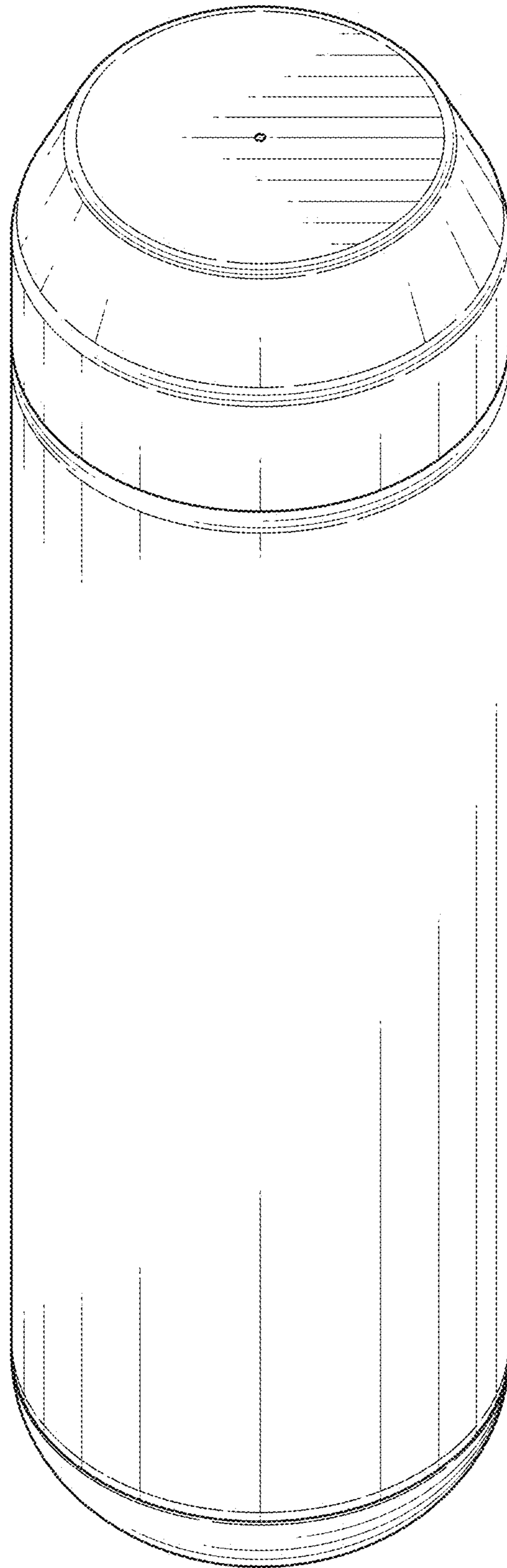

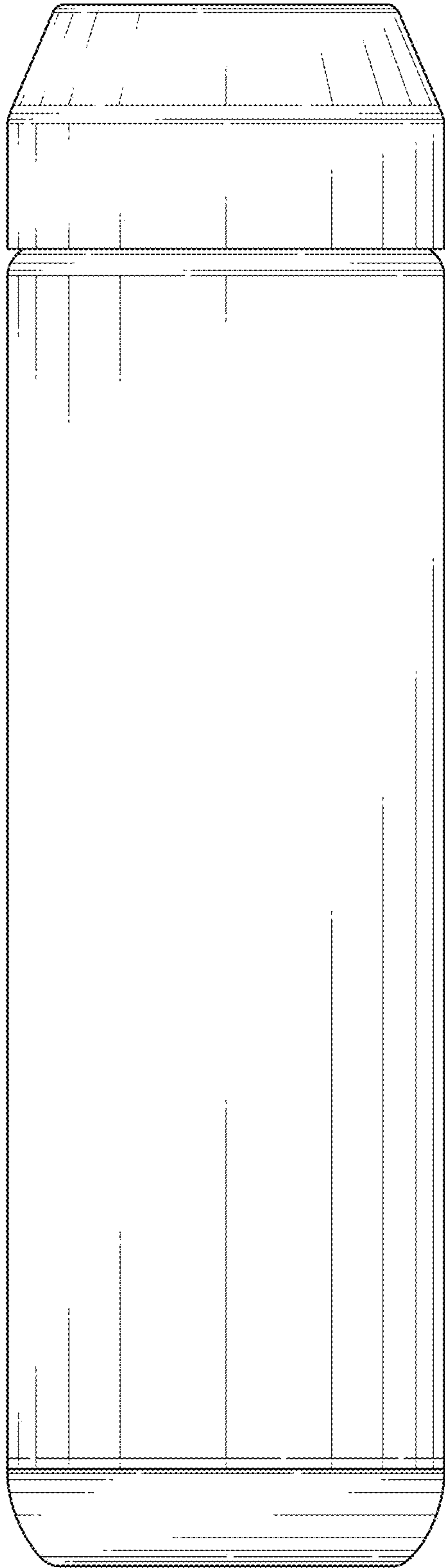

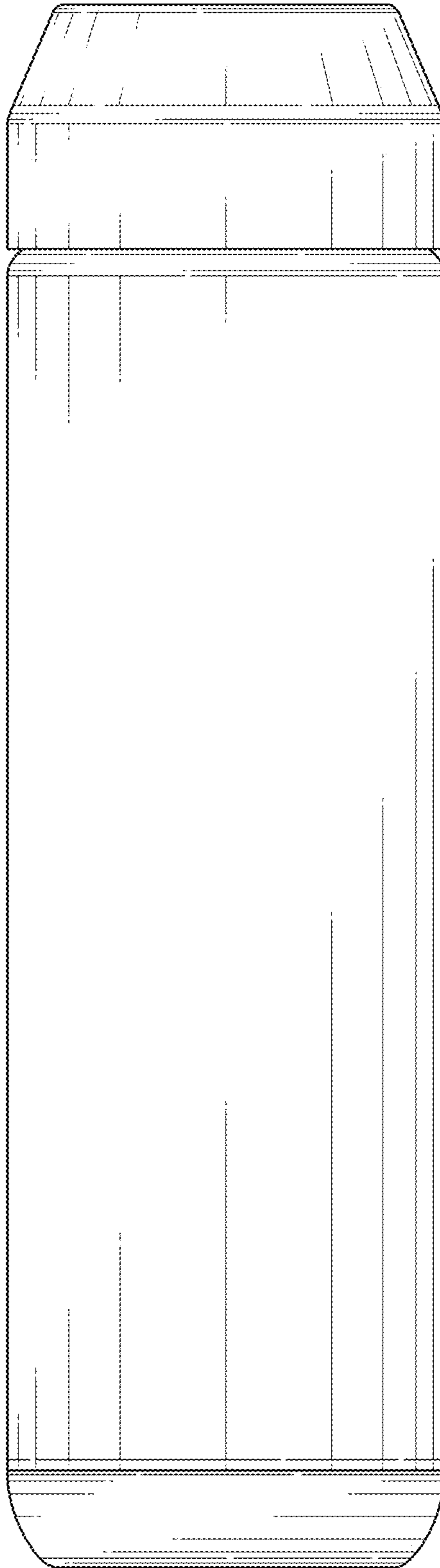

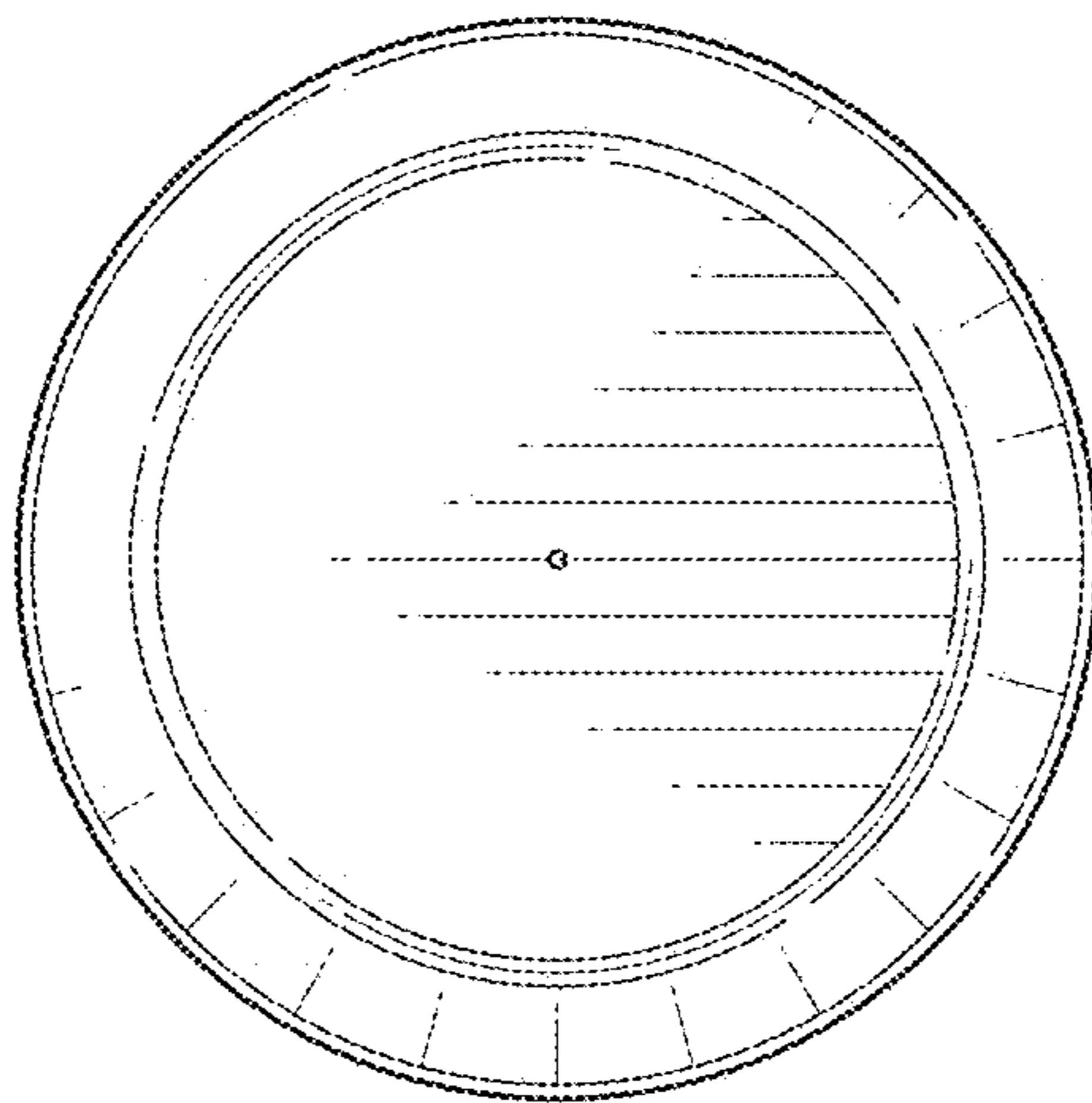
