DESCRIPTION

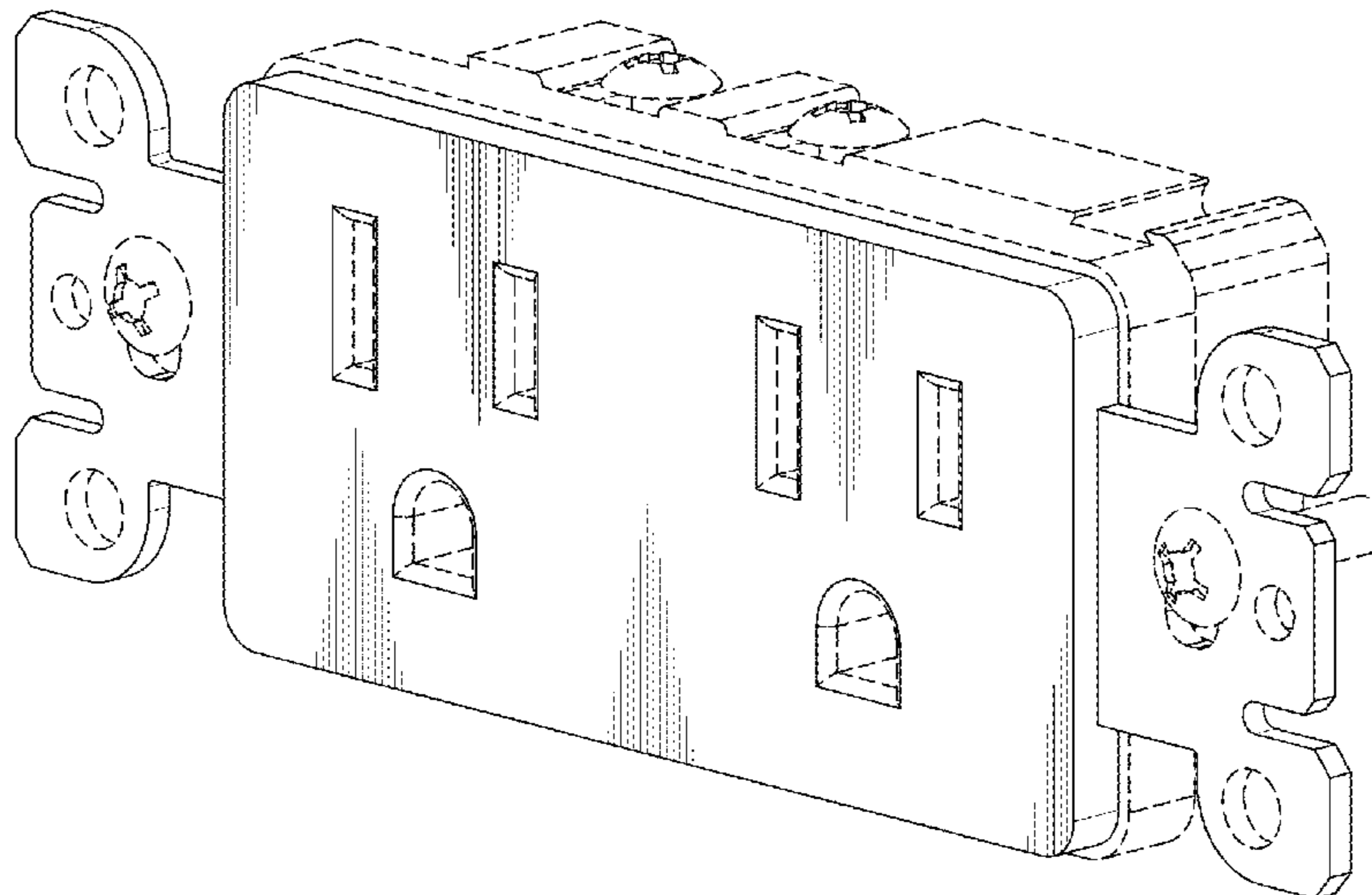
FIG. 1 is a top perspective view of the duplex horizontal receptacle according to the present invention.

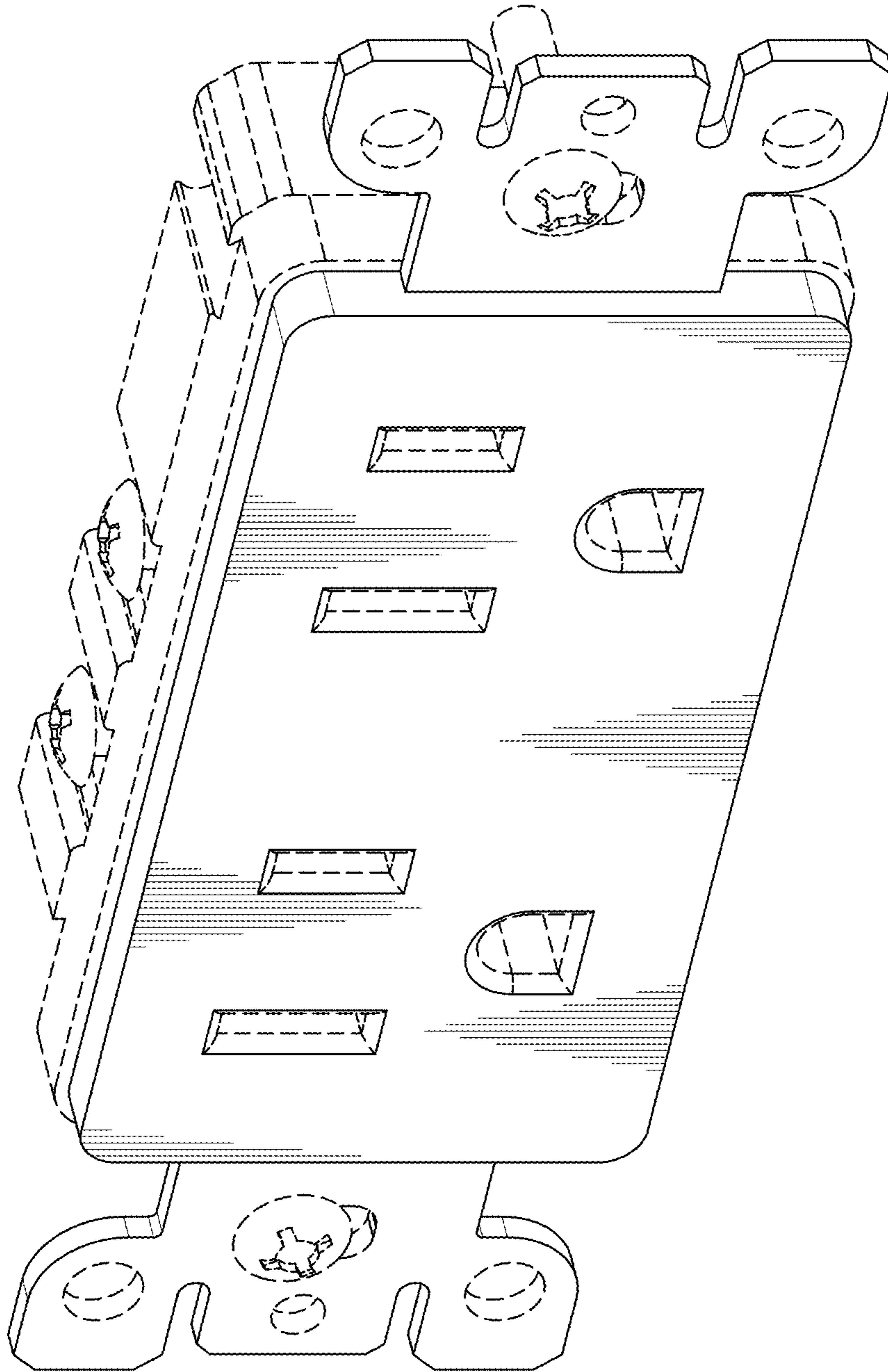

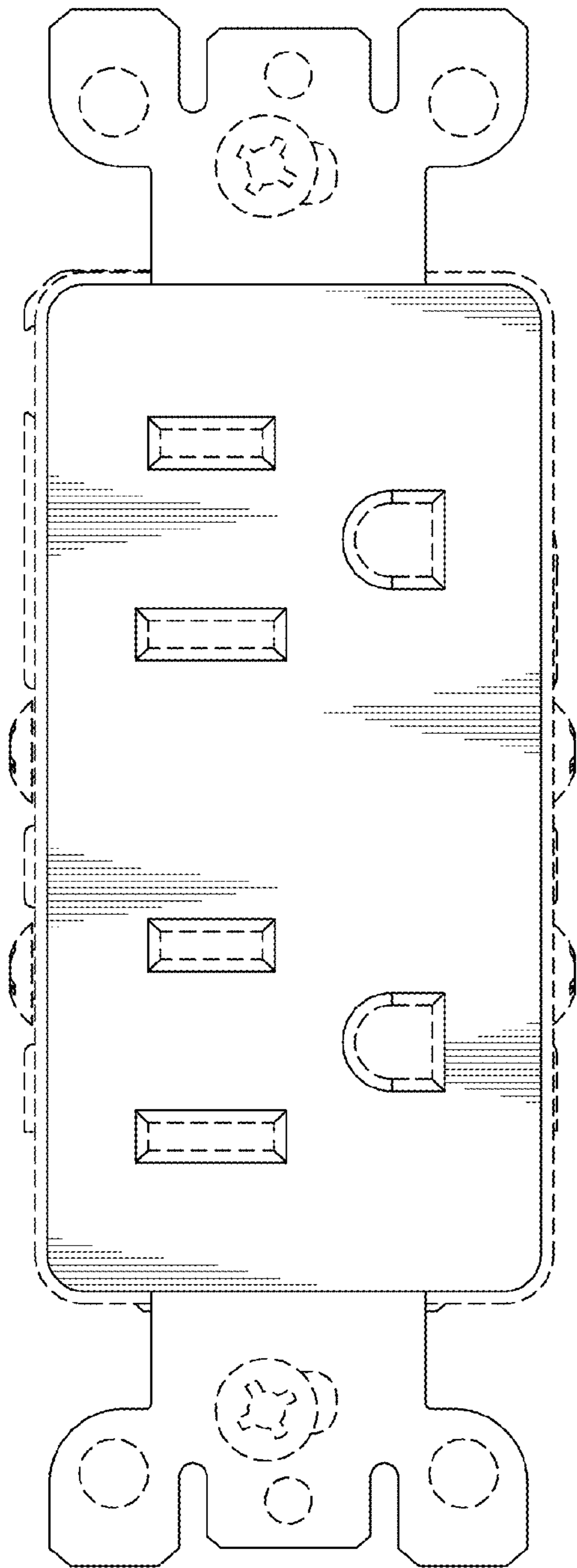

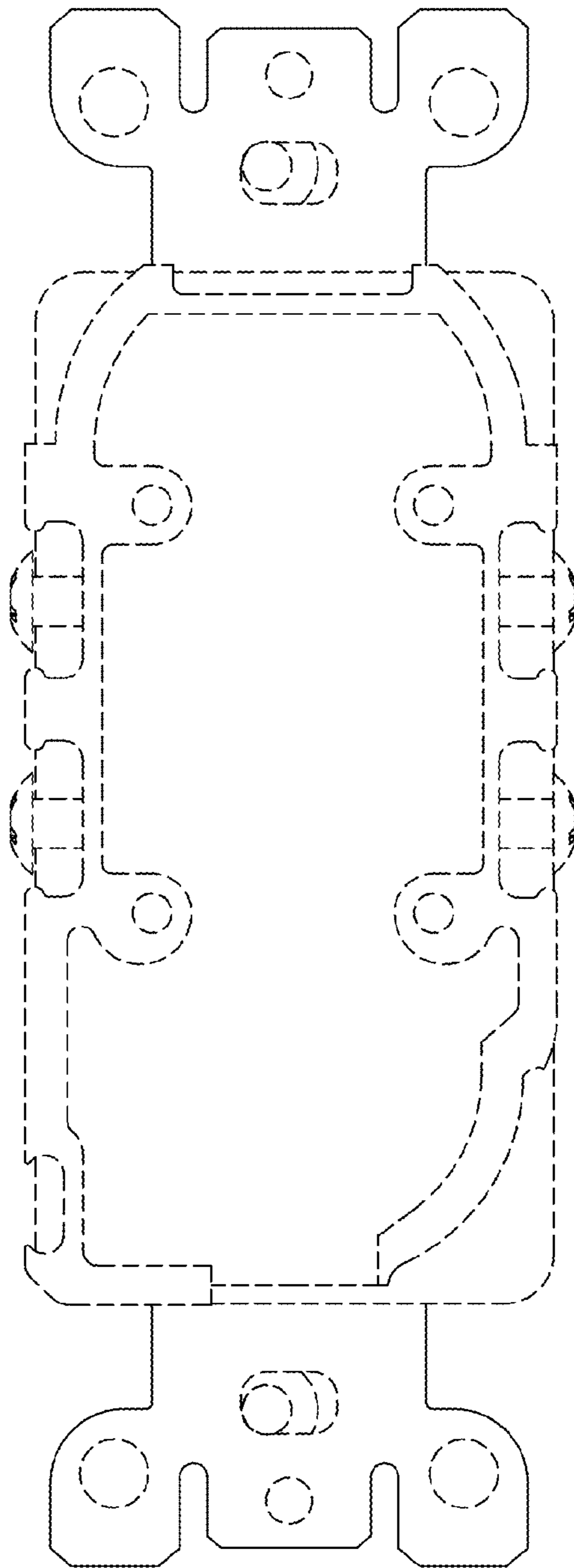

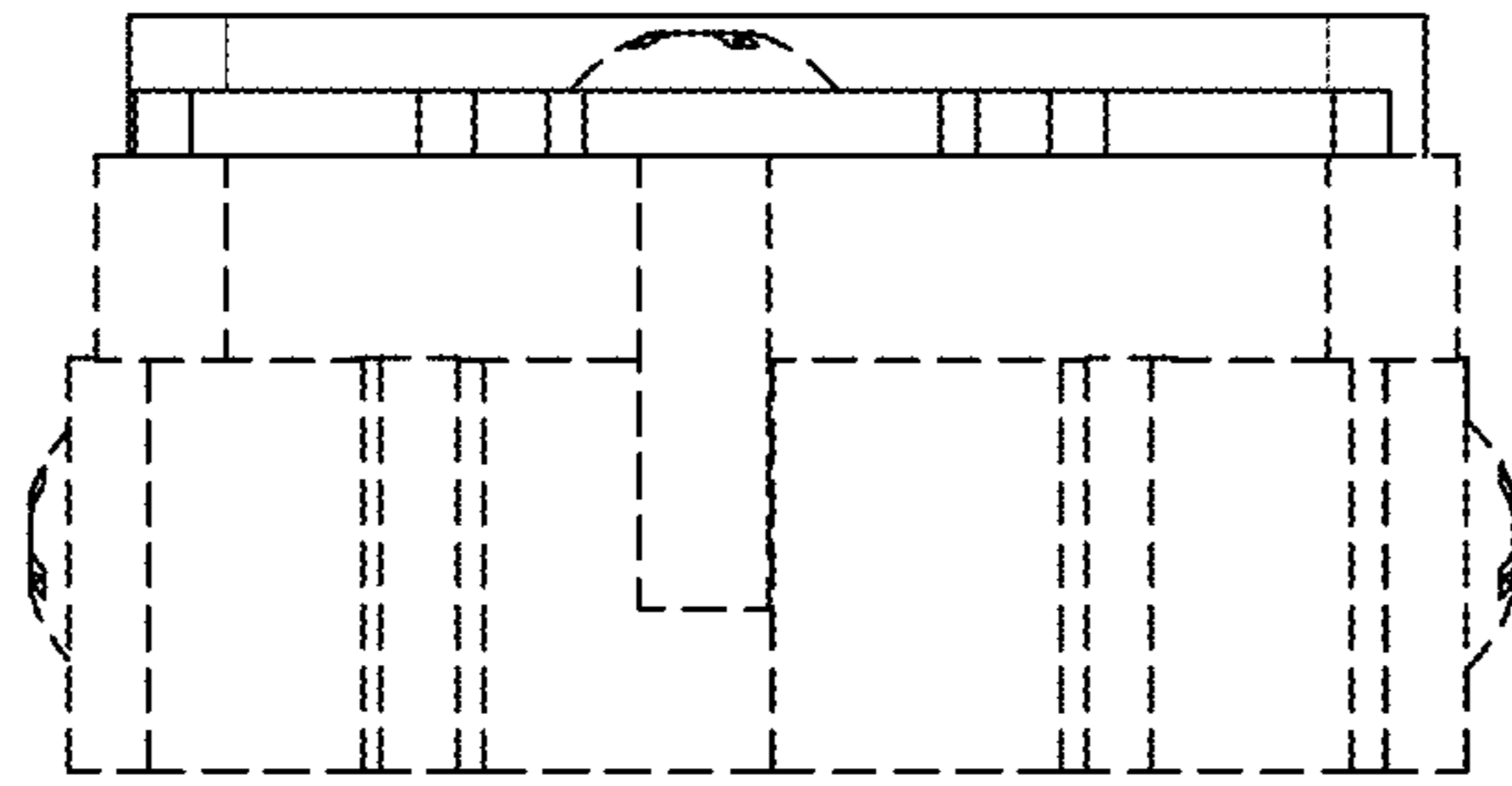

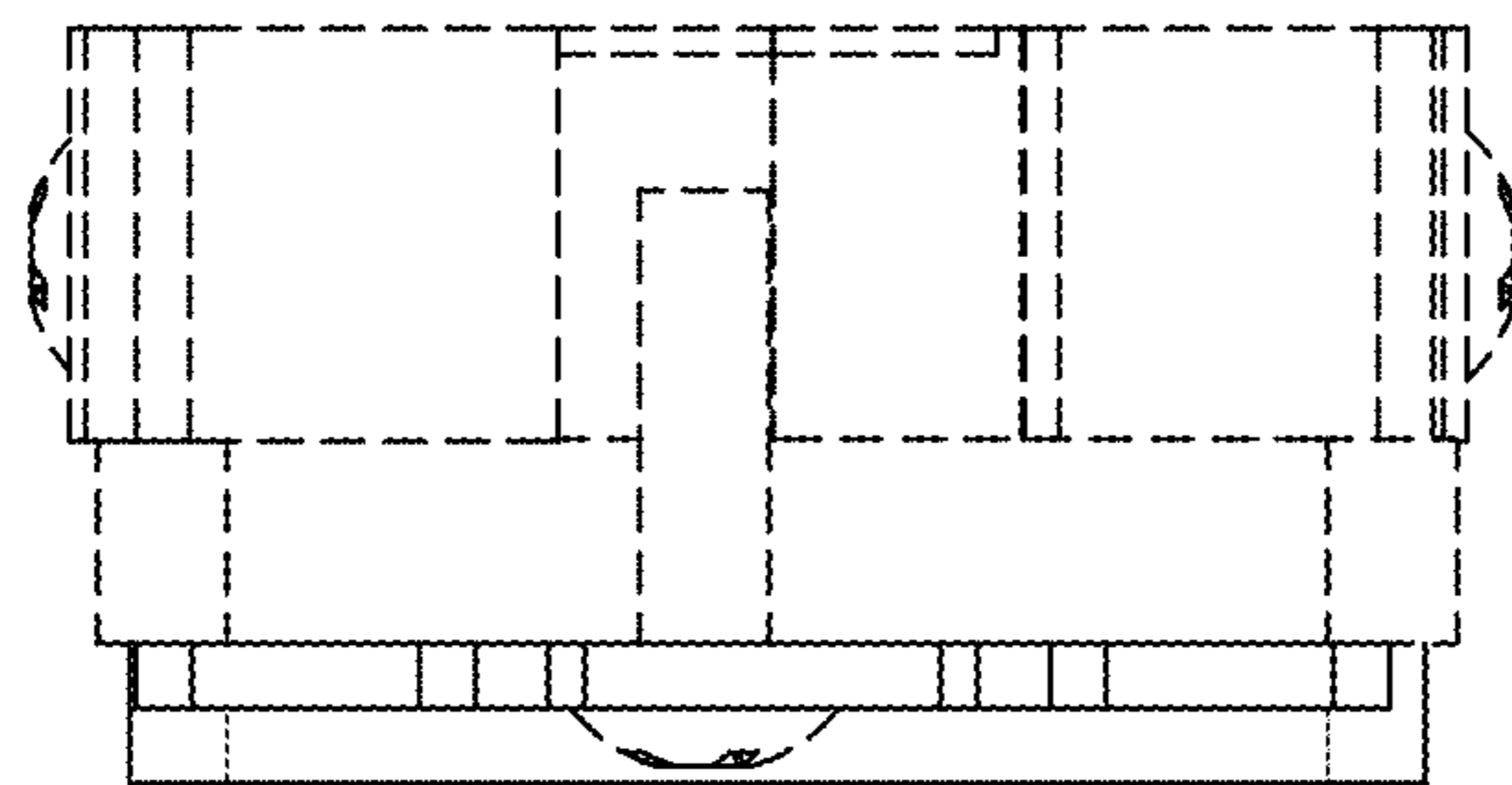

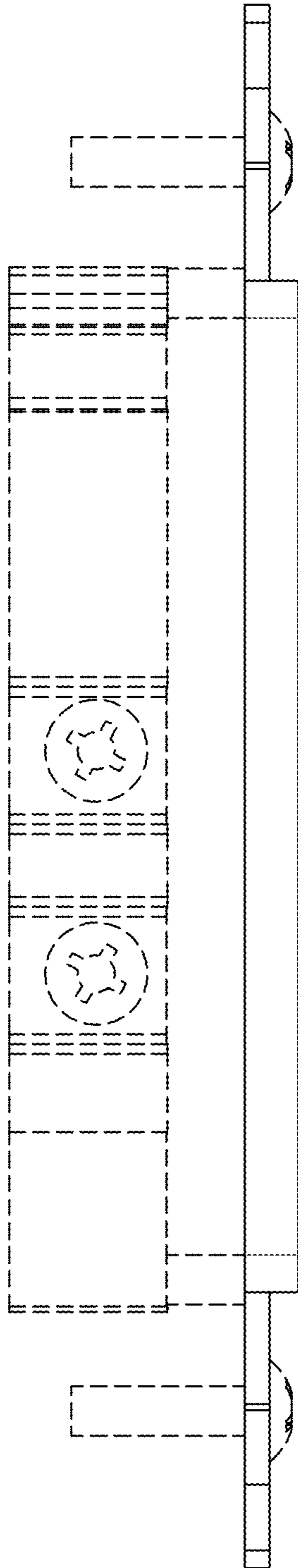

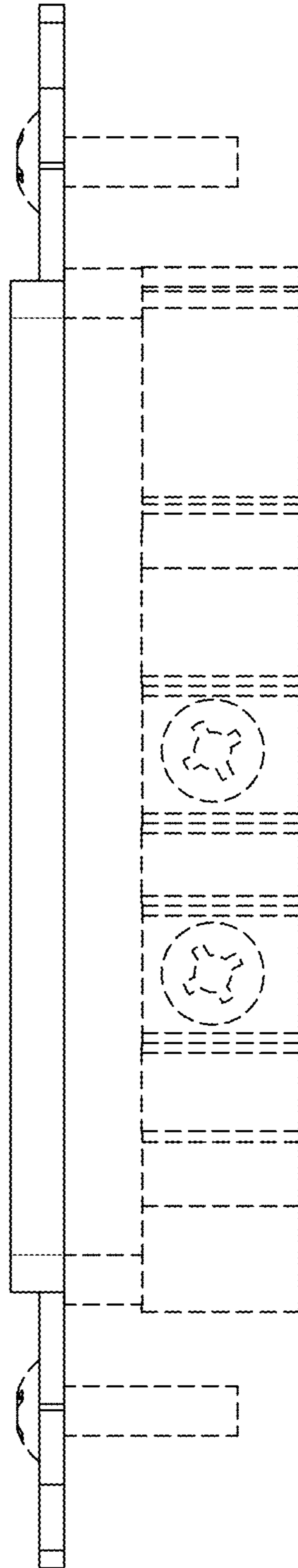
