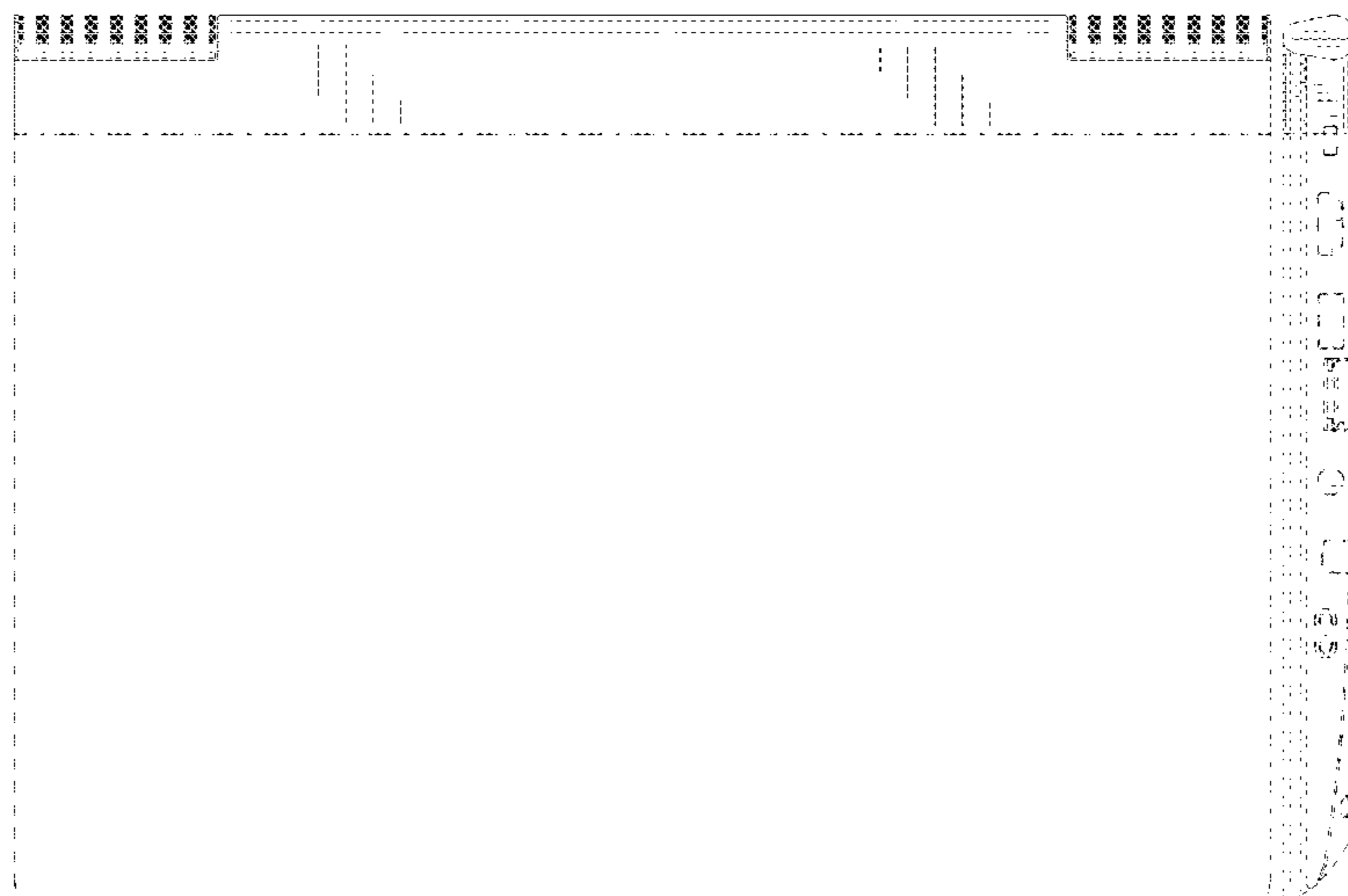
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of laptop computer showing the new design;

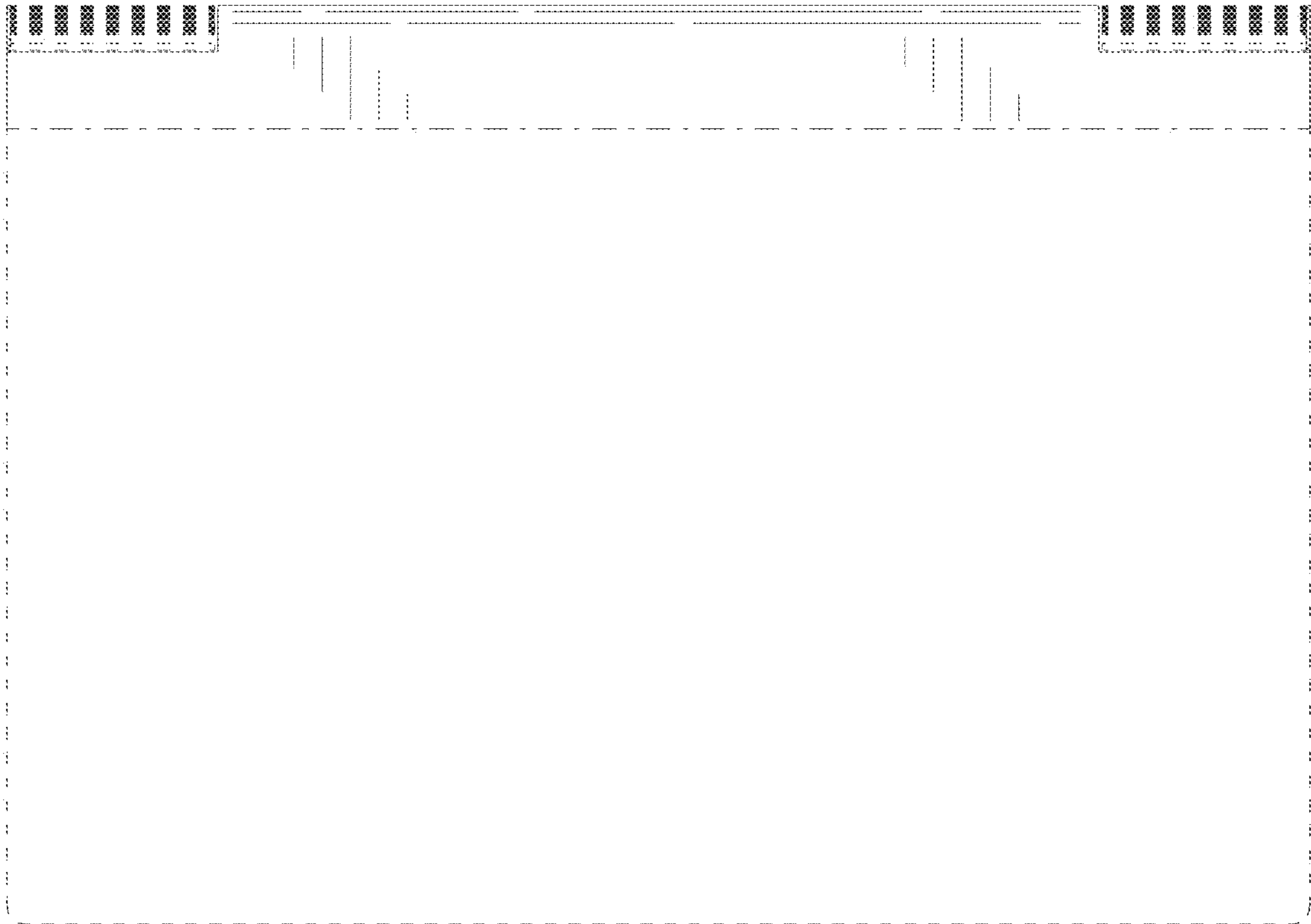

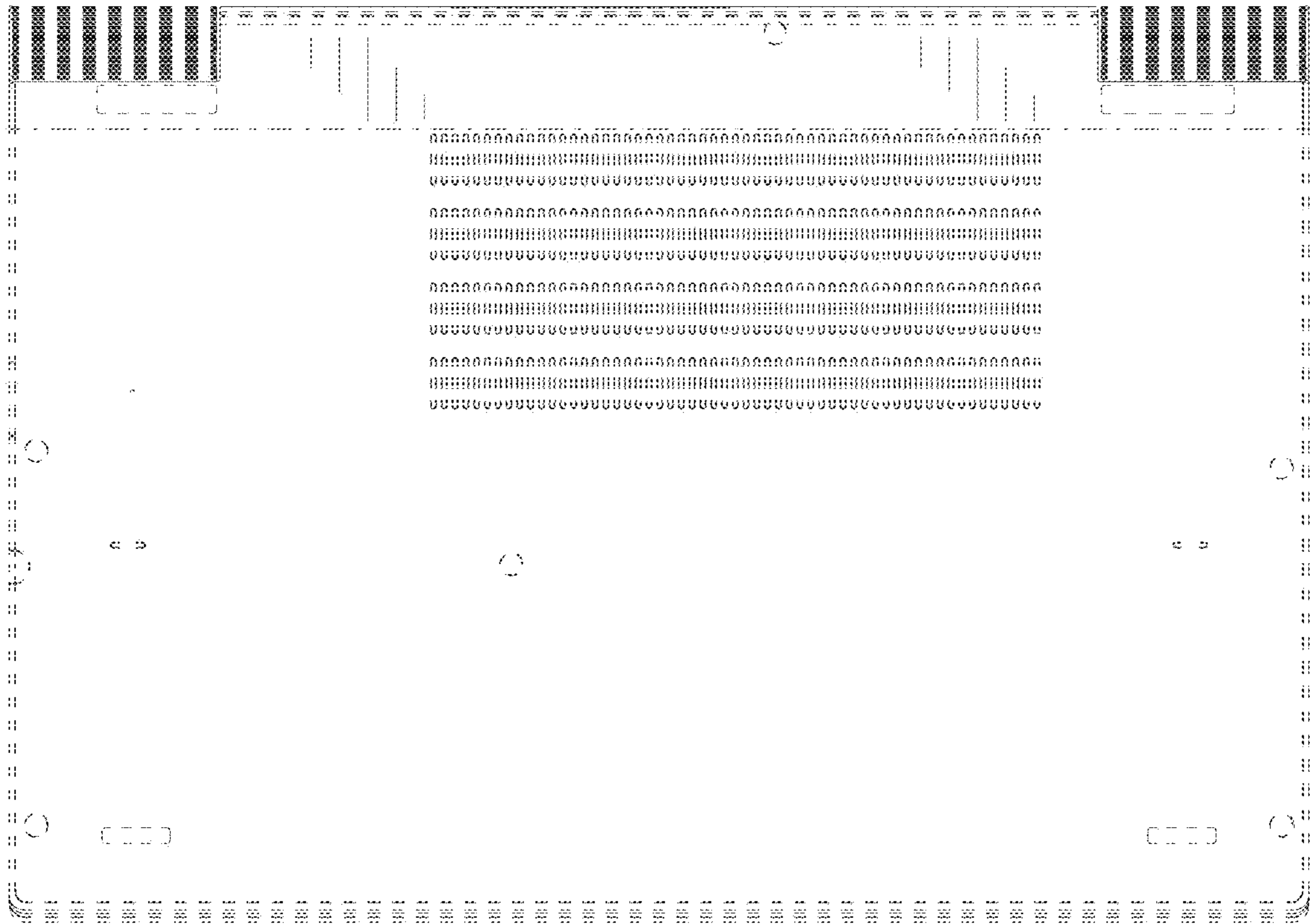

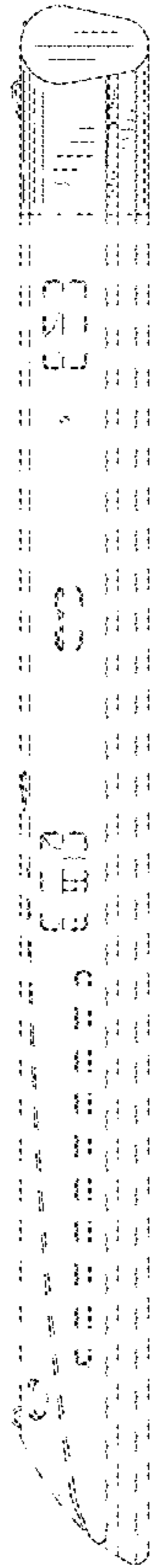

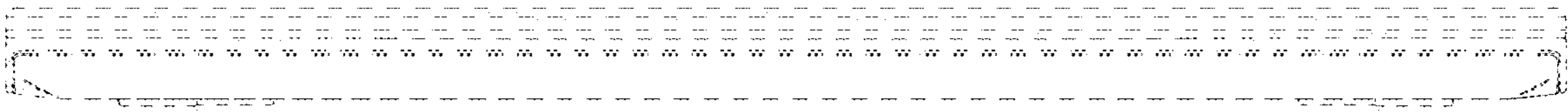
