FIG. 10 is a front view depicting a tenth image of the transitional graphical user interface.

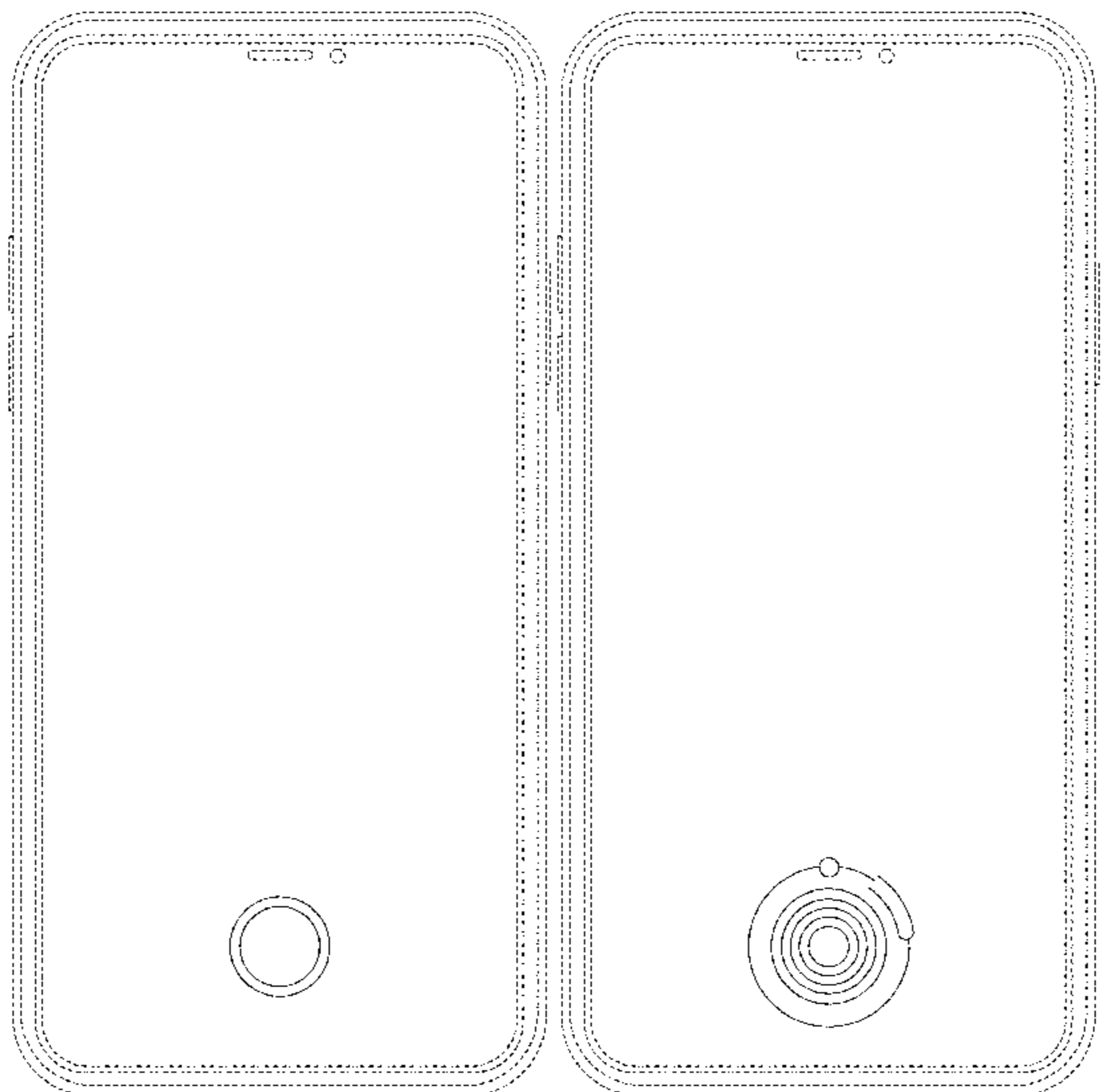

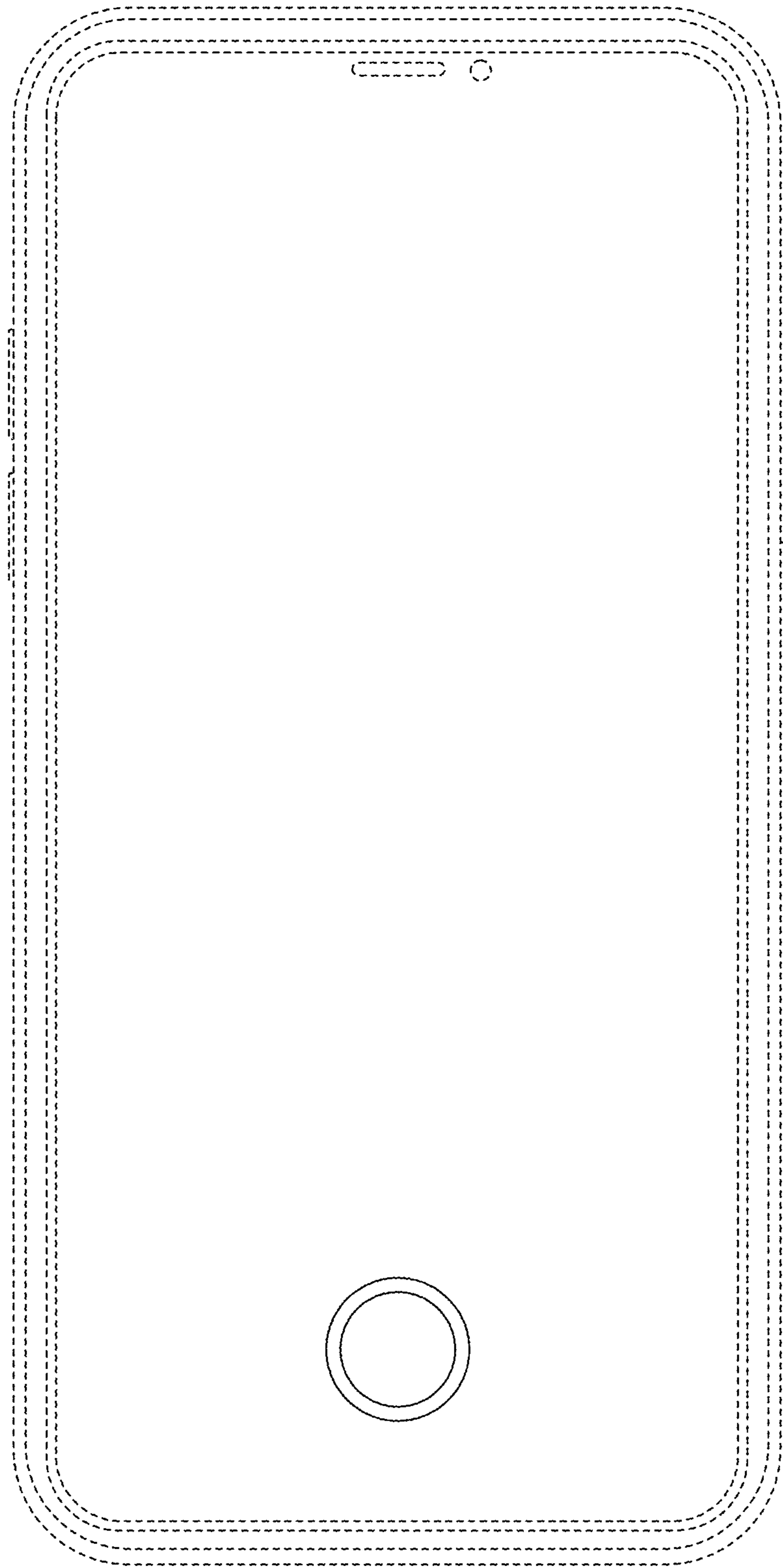

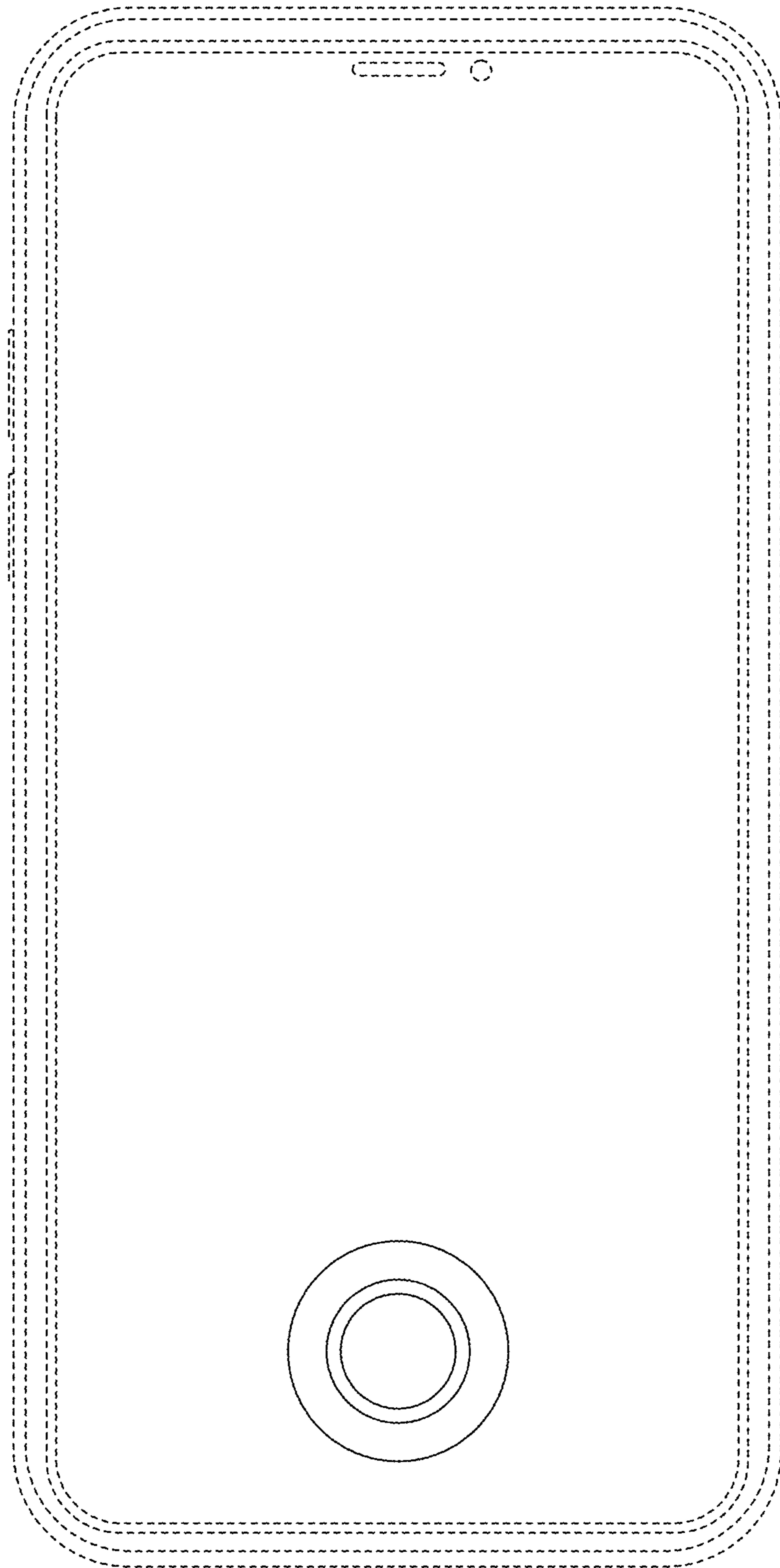

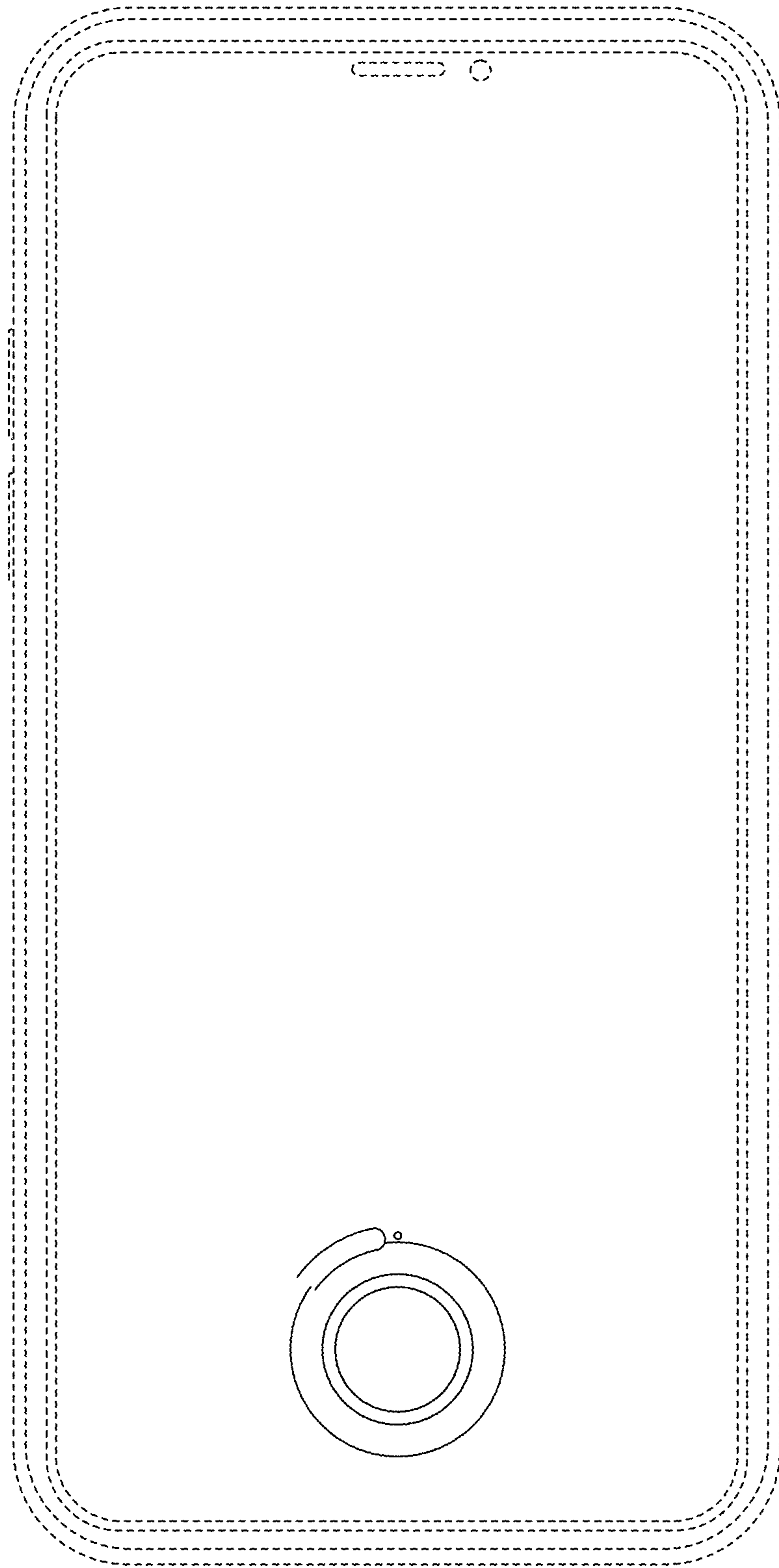

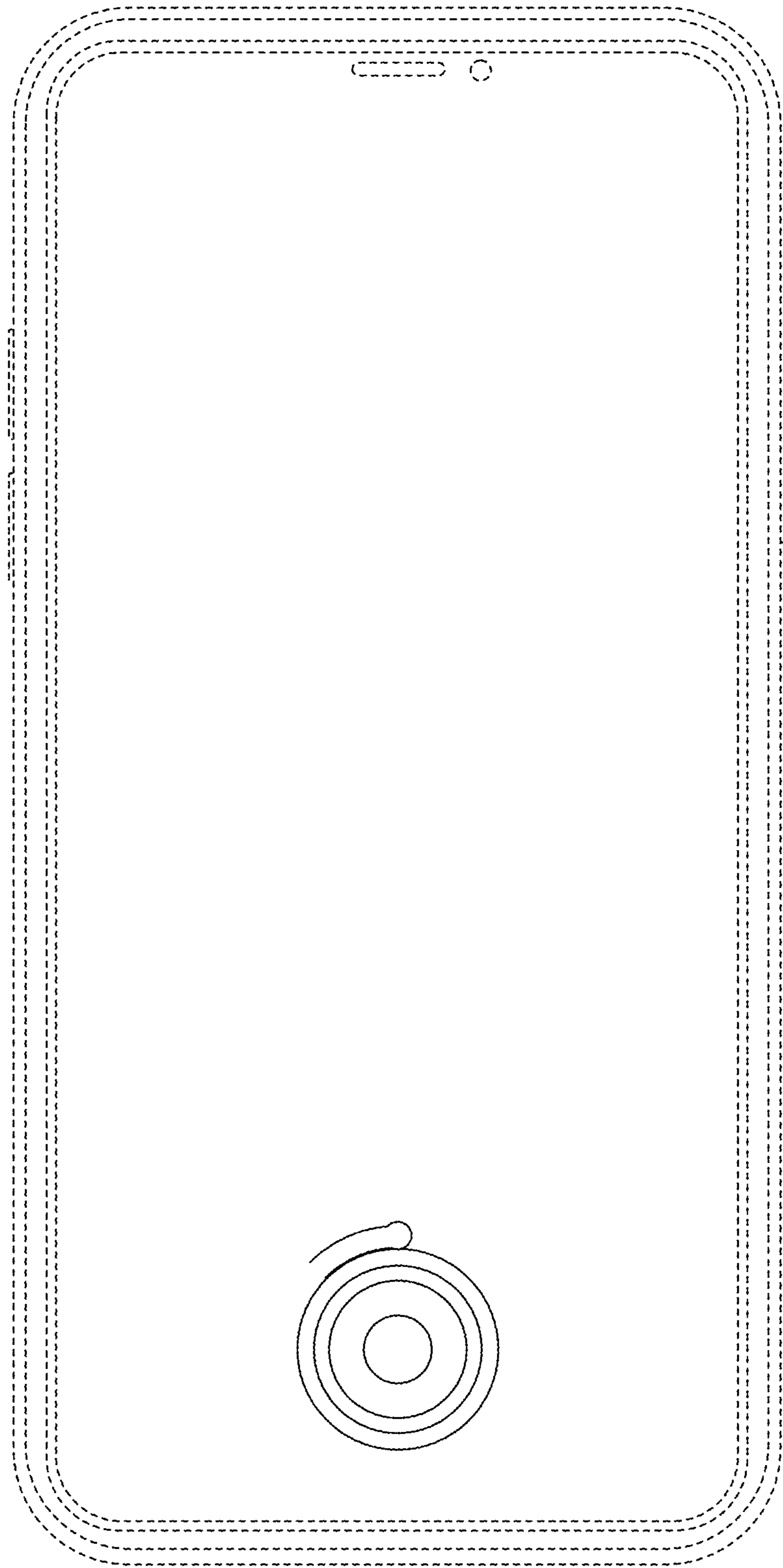

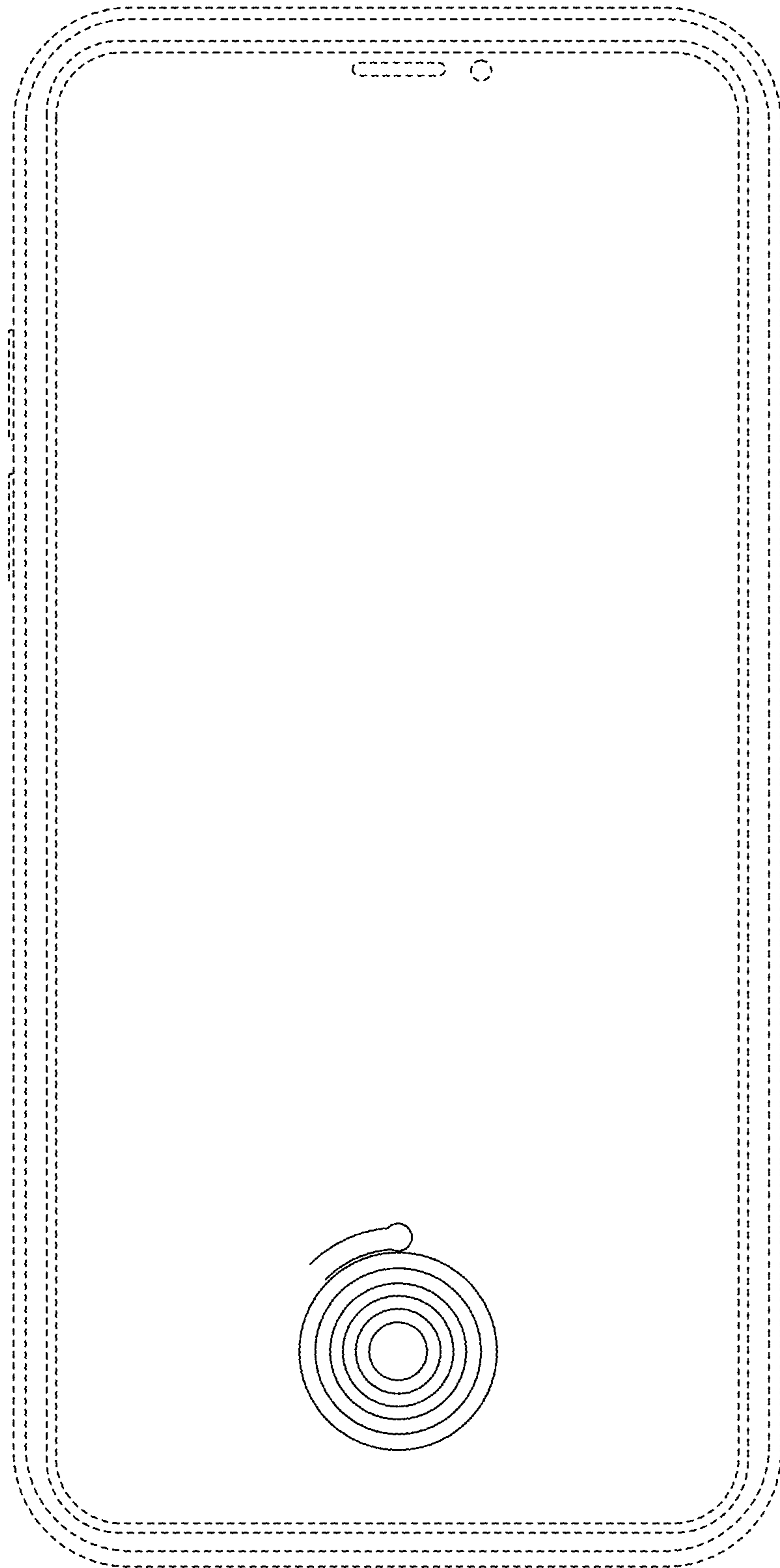

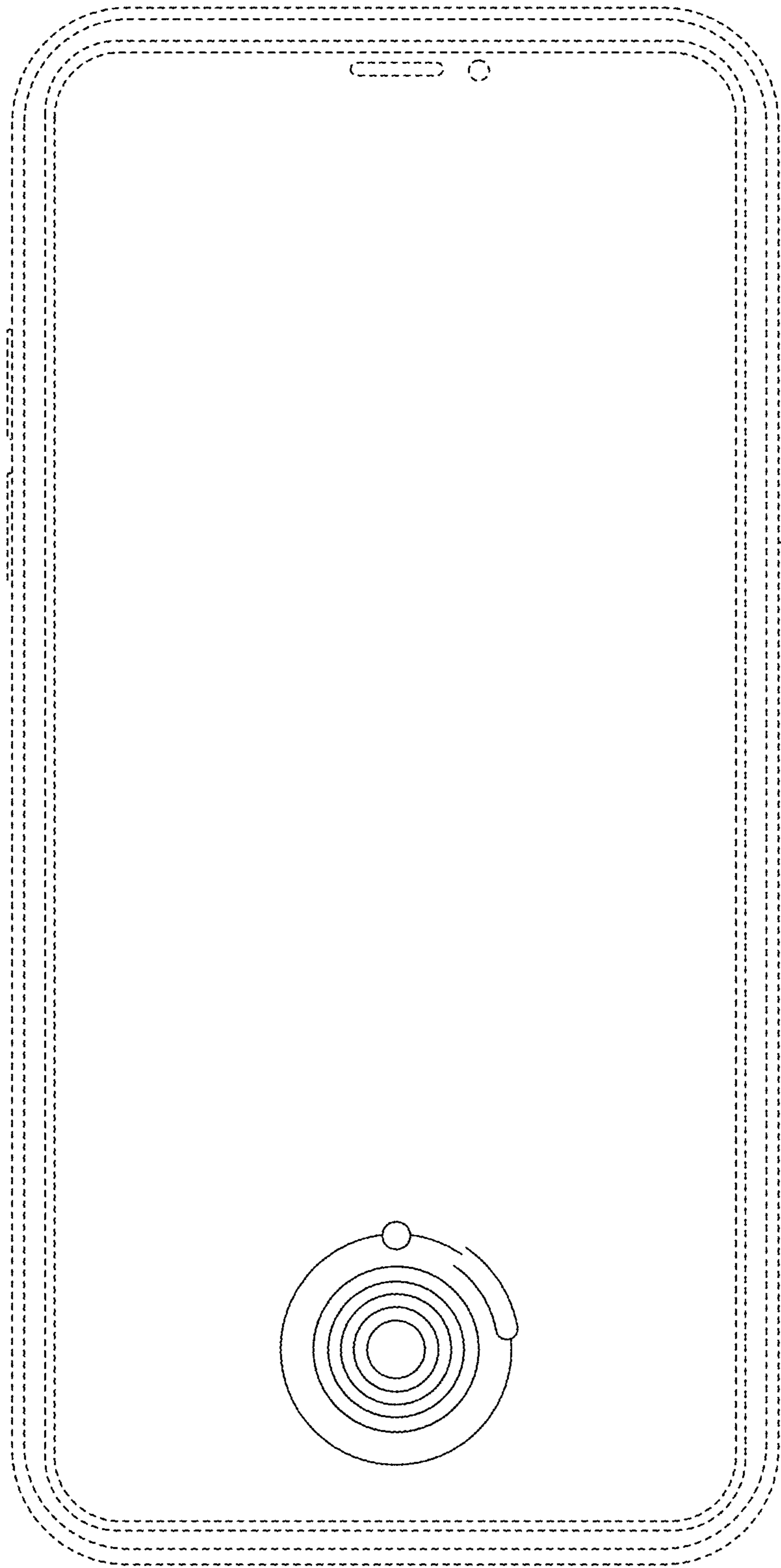

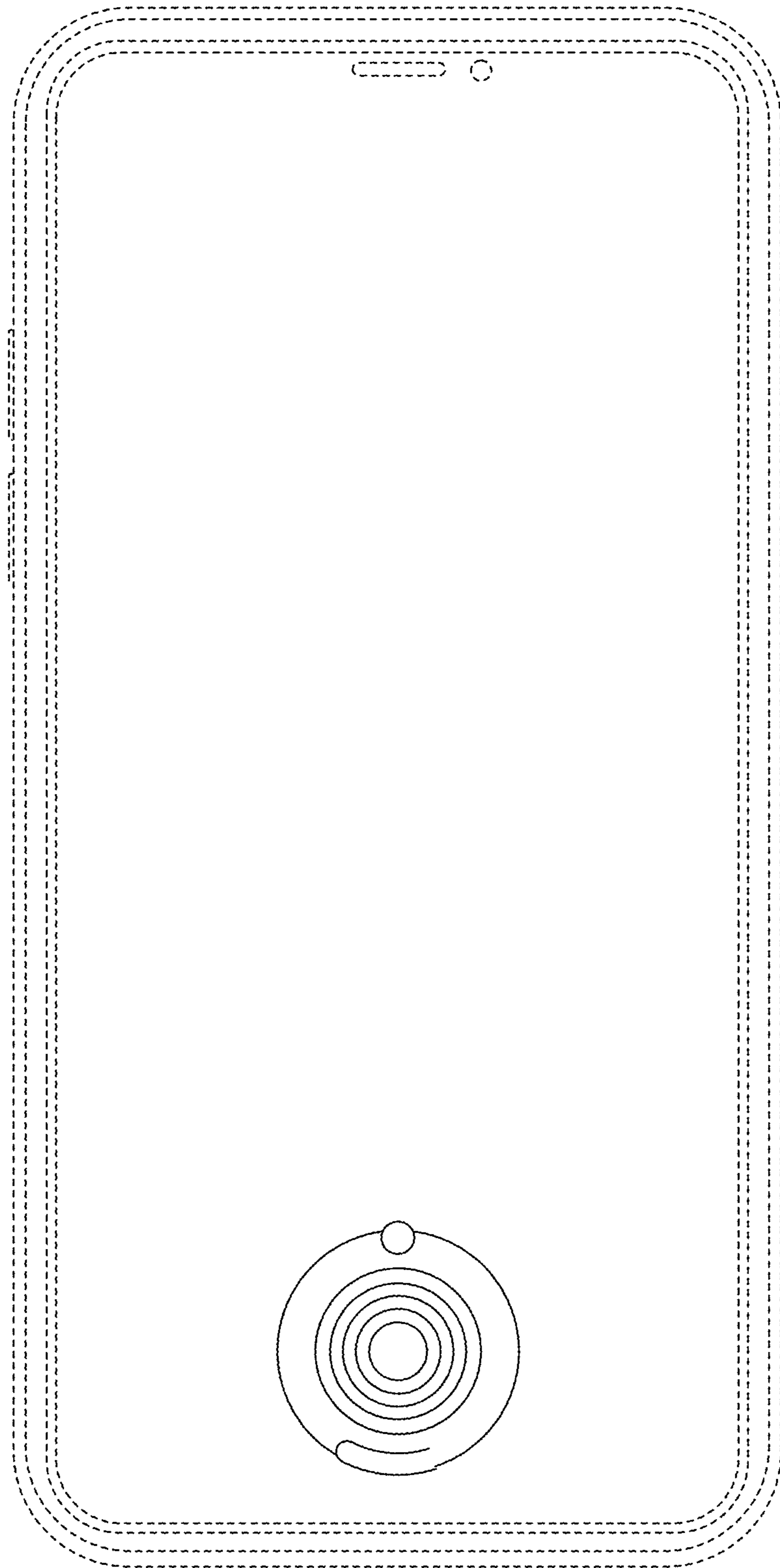

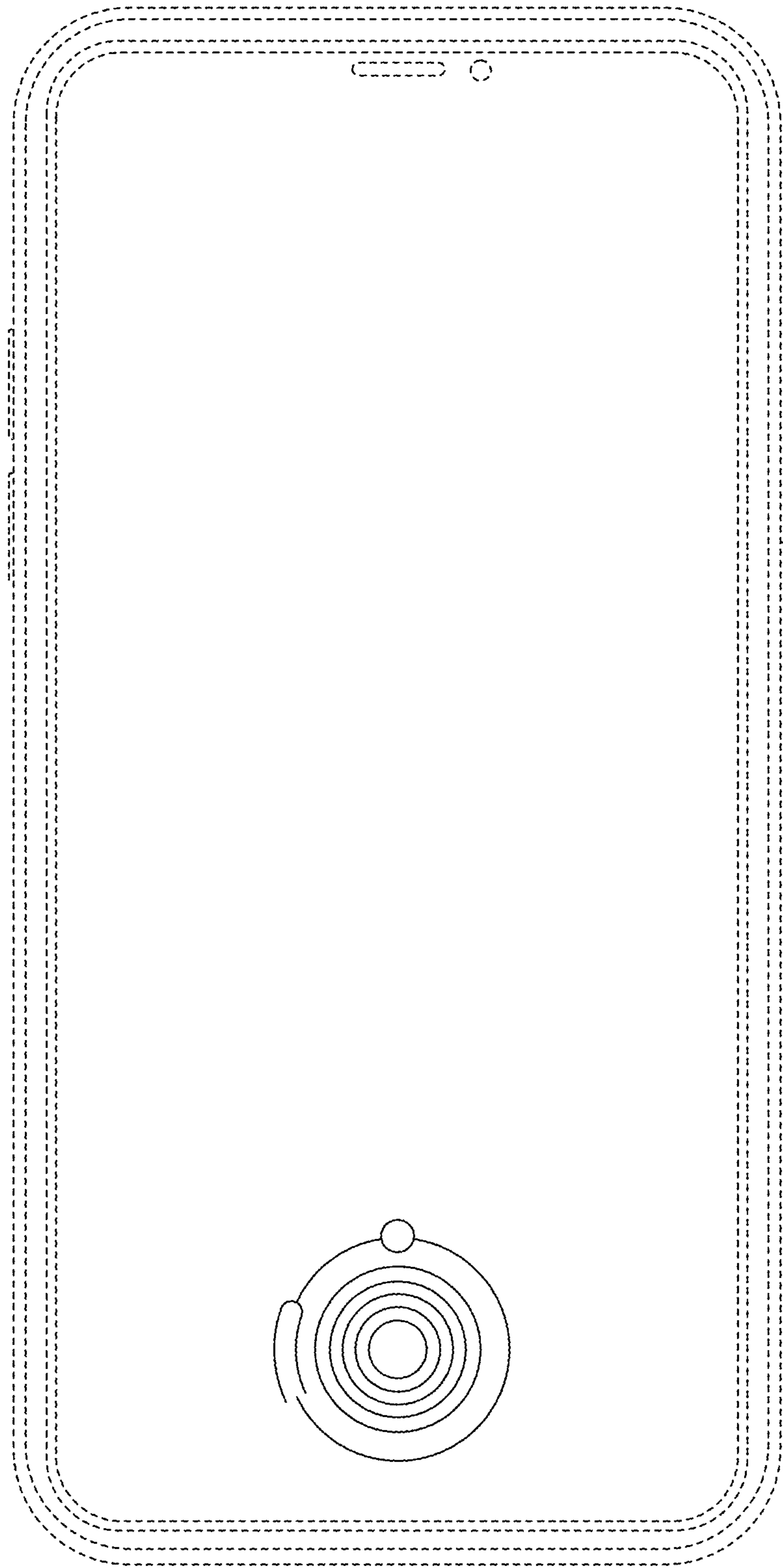

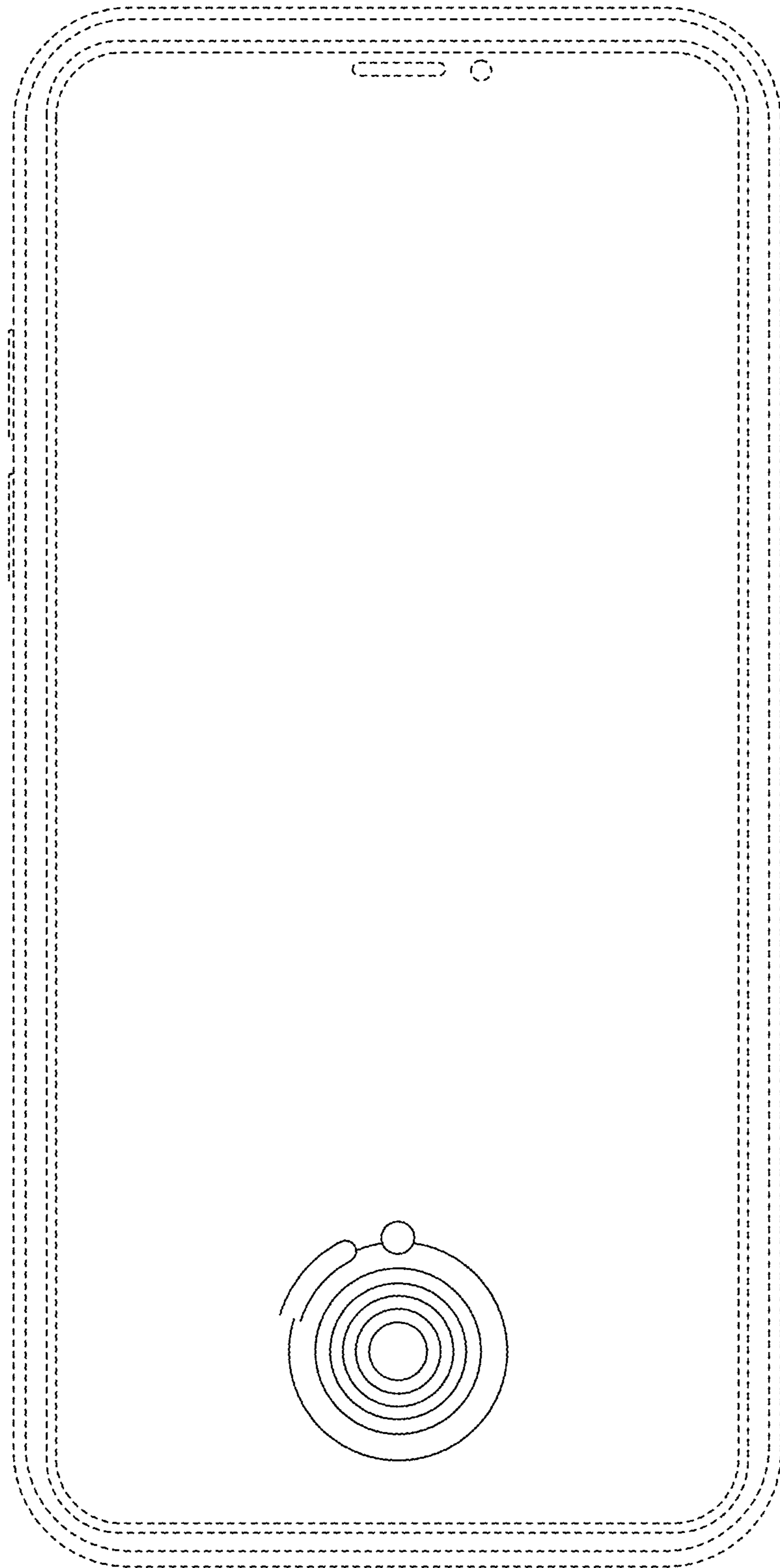

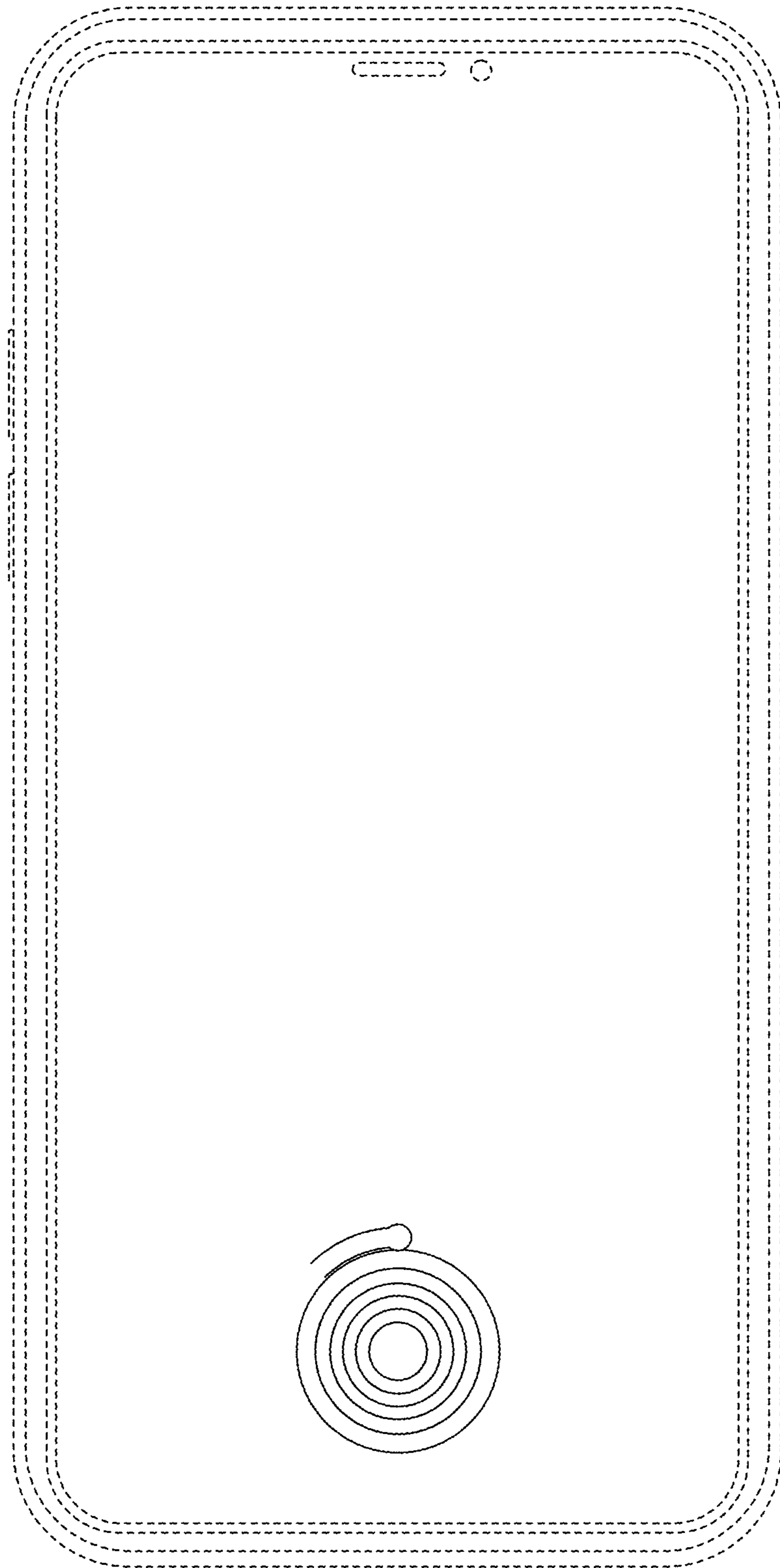
