The ornamental design for a digital camera display screen with transitional graphical user interface, as shown and described.

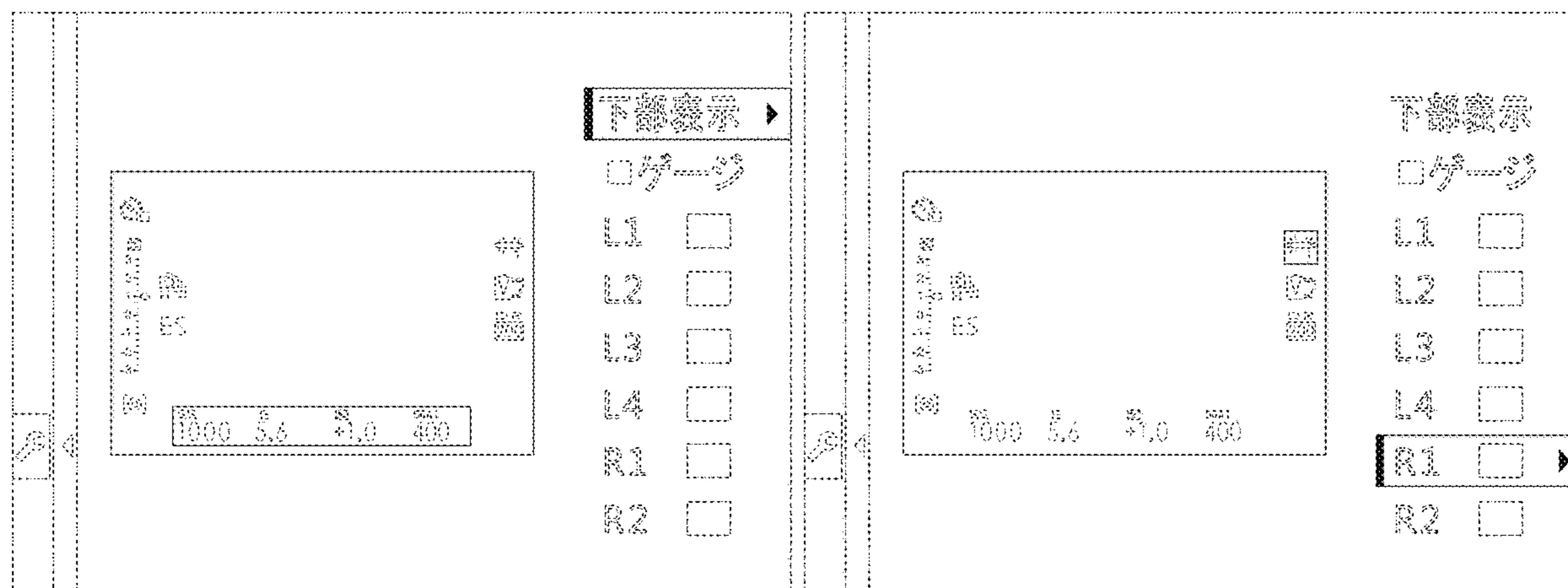
**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the digital camera, showing the new design;

FIG. 10 is an enlarged view of the display portion, showing a fifth image of the display screen of the first embodiment, shown separately for clarity;  
FIG. 11 is a perspective view of a second embodiment of the digital camera, showing the new design;  
FIG. 12 is a front view thereof;  
FIG. 13 is a rear view thereof;  
FIG. 14 is a top view thereof;  
FIG. 15 is a left view thereof;  
FIG. 16 is an enlarged view of the display portion, showing a first image of the display screen of the second embodiment, shown separately for clarity;  
FIG. 17 is an enlarged view of the display portion, showing a second image of the display screen of the second embodiment, shown separately for clarity;  
FIG. 18 is an enlarged view of the display portion, showing a third image of the display screen of the second embodiment, shown separately for clarity;  
FIG. 19 is an enlarged view of the display portion, showing a fourth image of the display screen of the second embodiment shown separately for clarity; and,  
FIG. 20 is an enlarged view of the display portion, showing a fifth image of the display screen of the second embodiment shown separately for clarity.

The broken lines showing the digital camera illustrate the environment of the claimed design and form no part thereof. The broken lines within the display screen in the drawings

The appearance of the transitional graphical user interface sequentially transitions between the images shown in FIGS. 6-10 and FIGS. 16-20. The process or period in which one image transitions to another image forms no part of the claimed design.

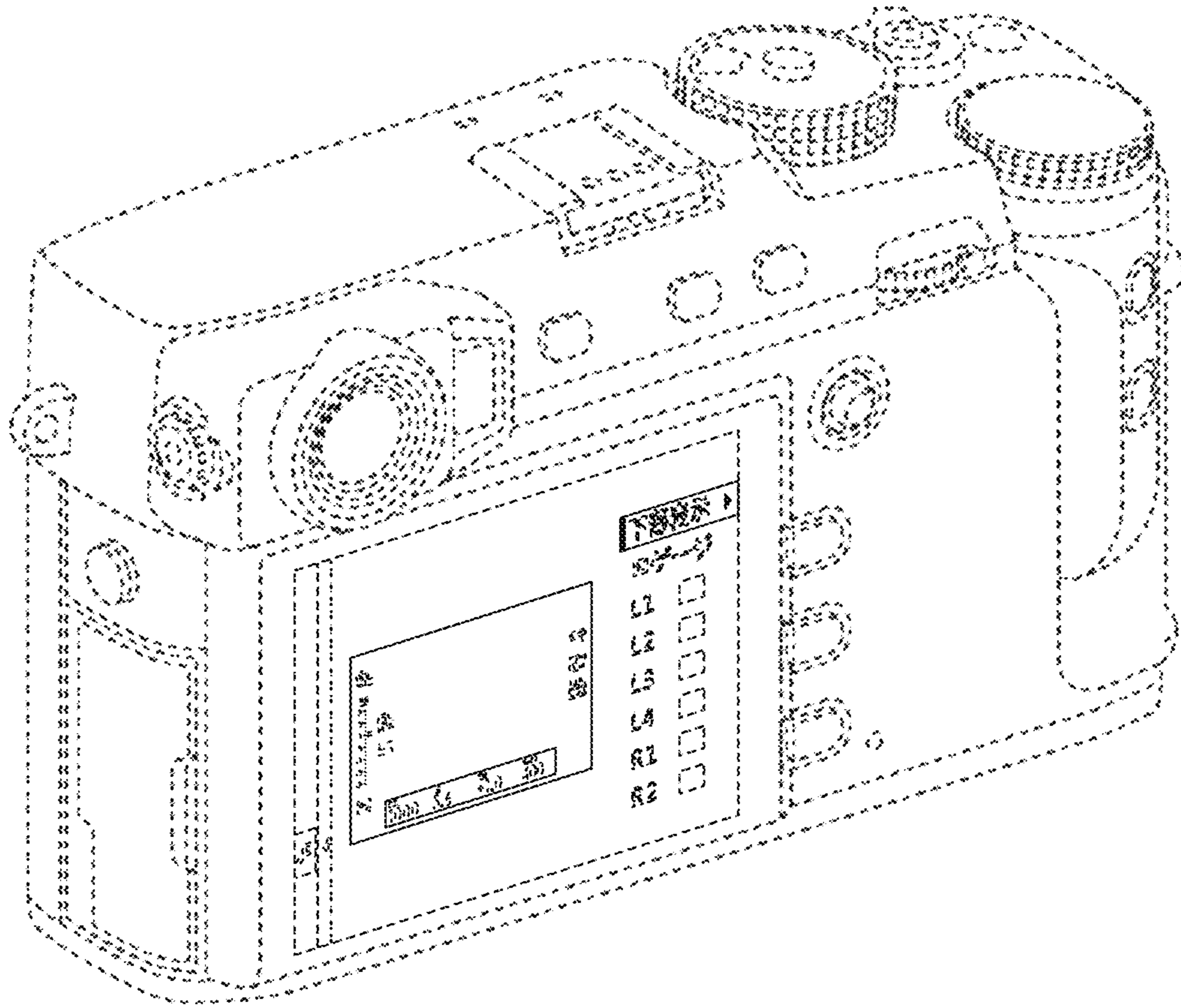

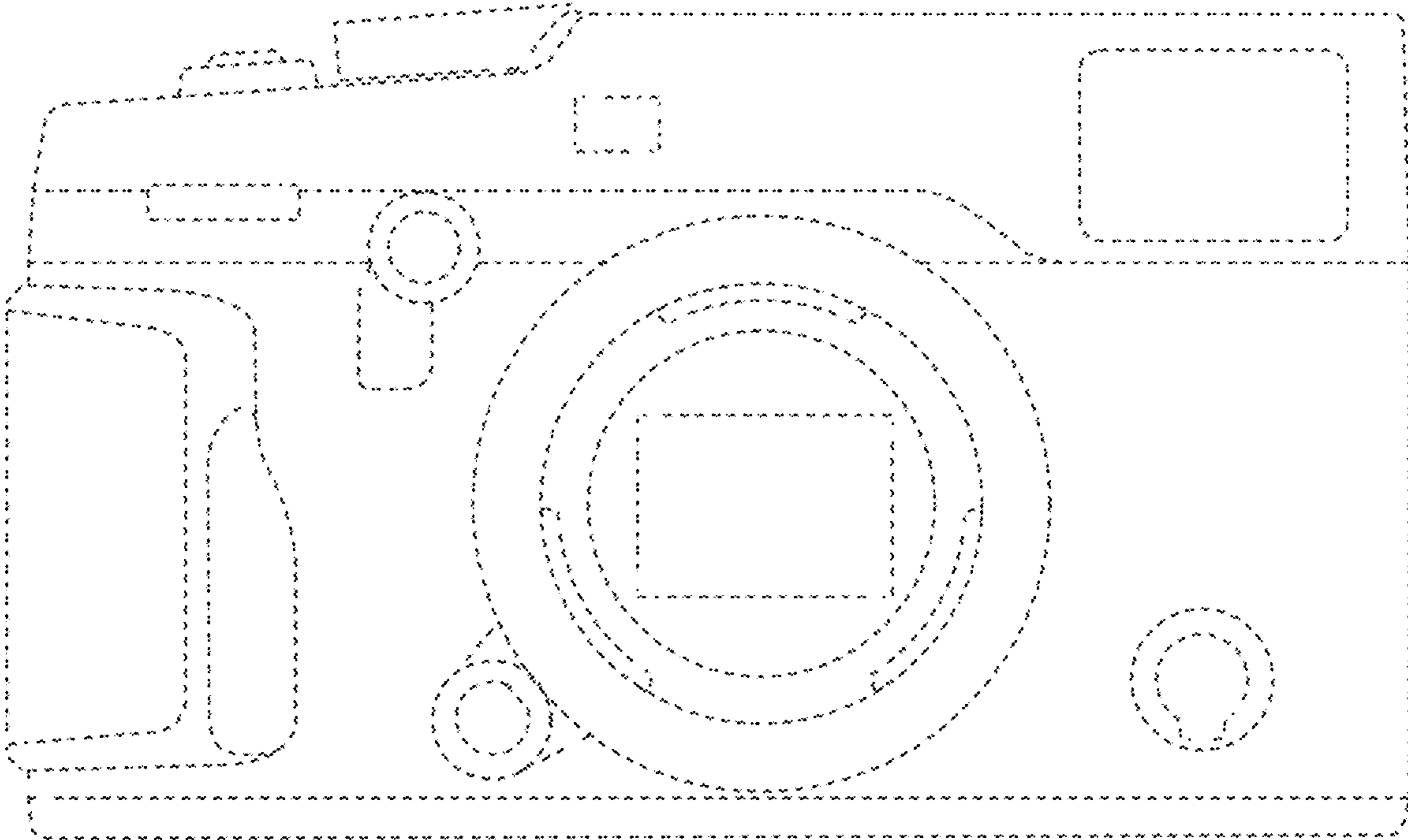

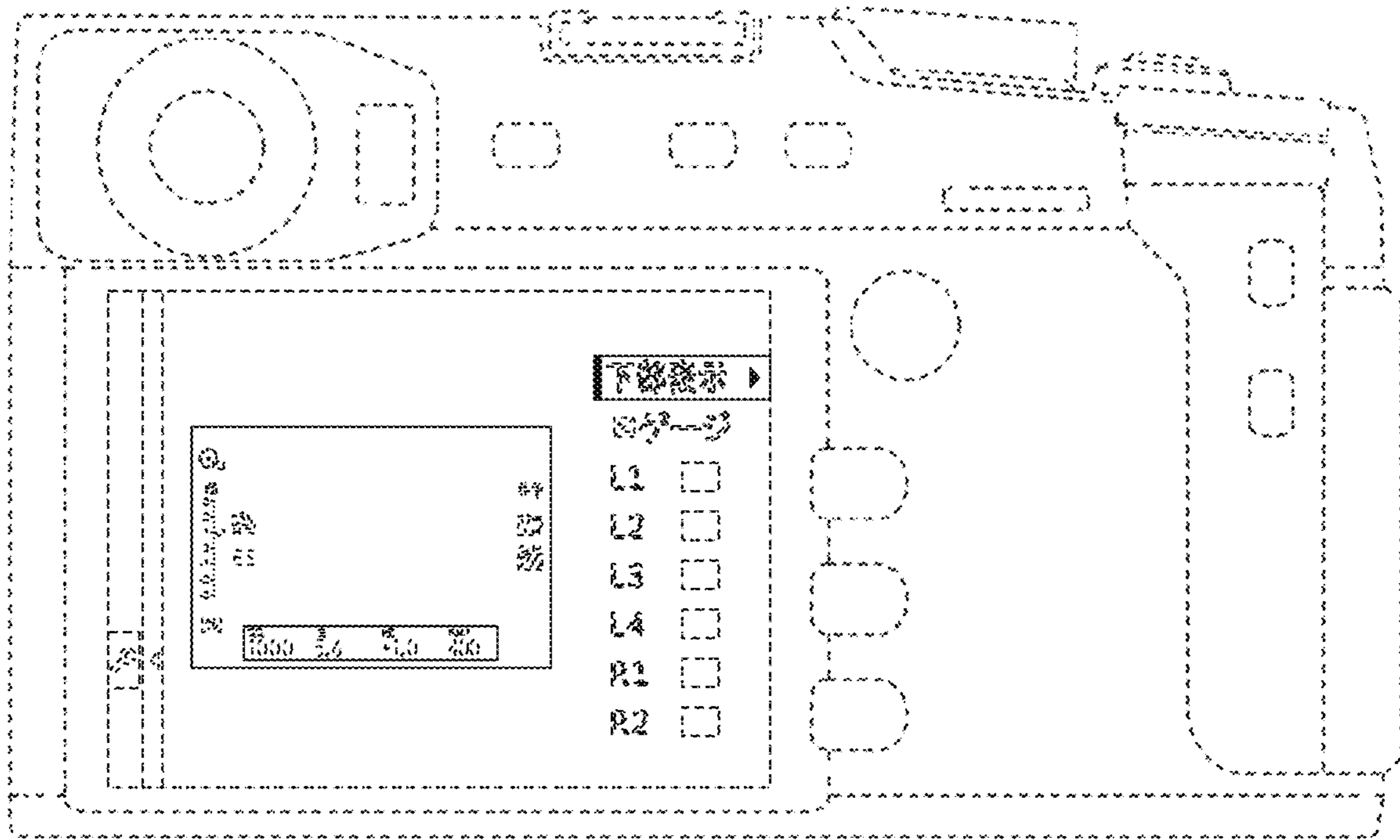

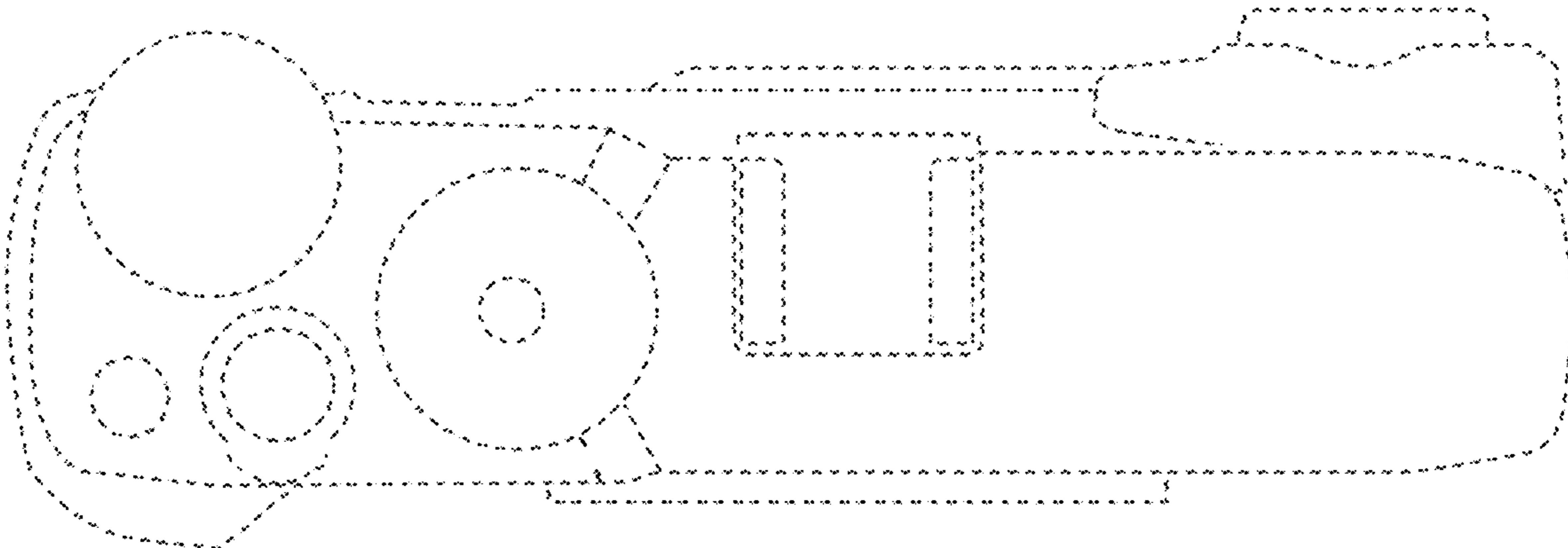

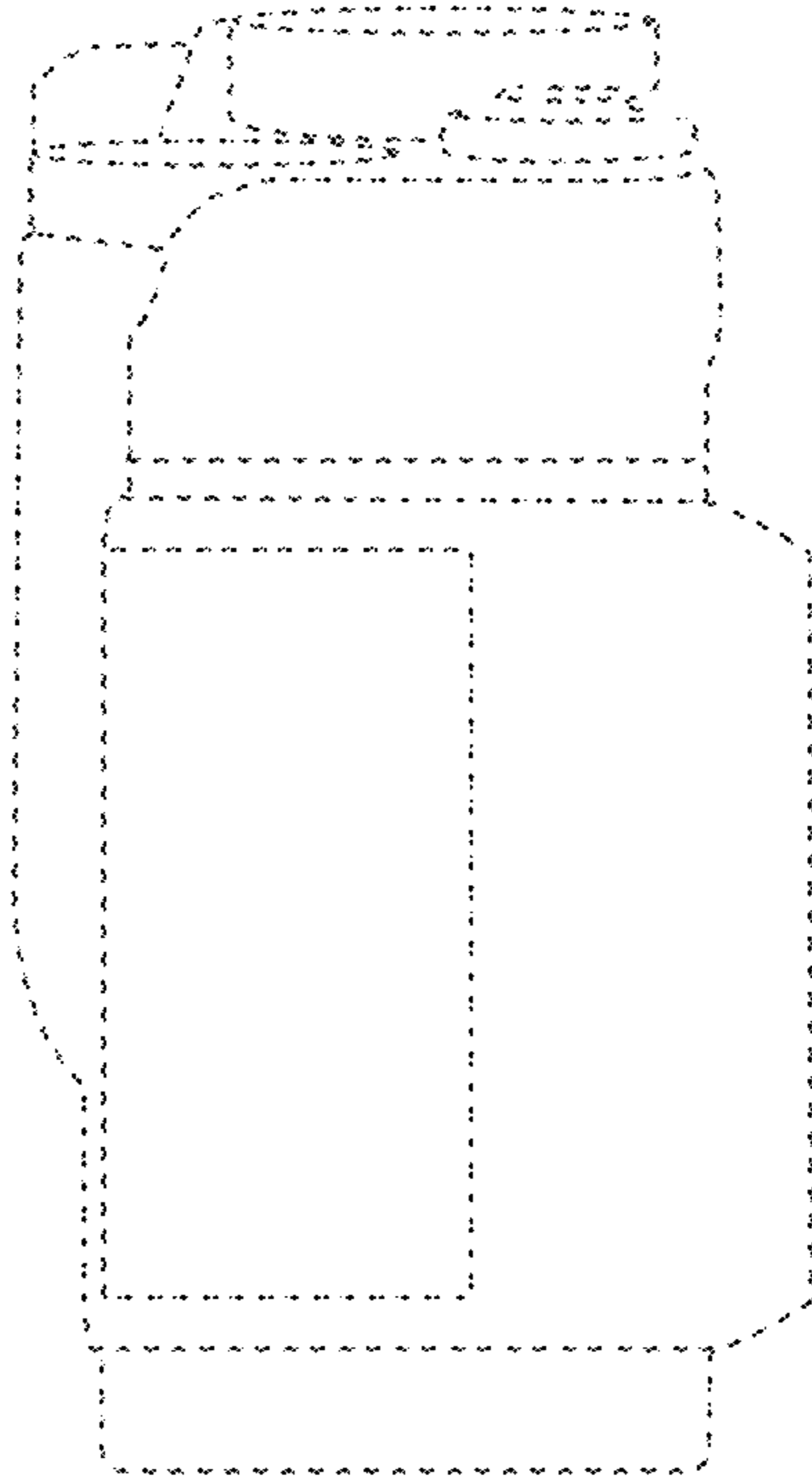

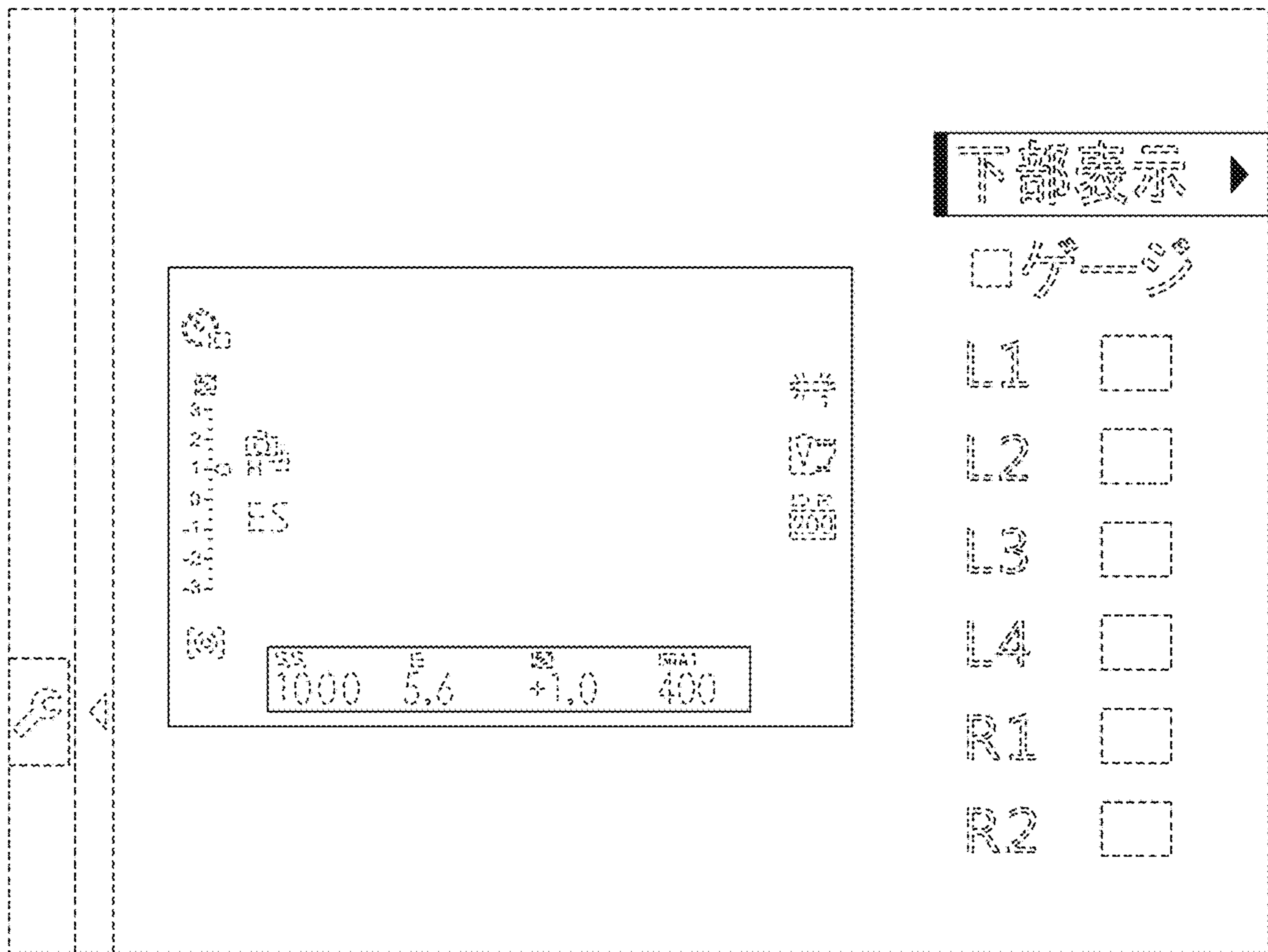

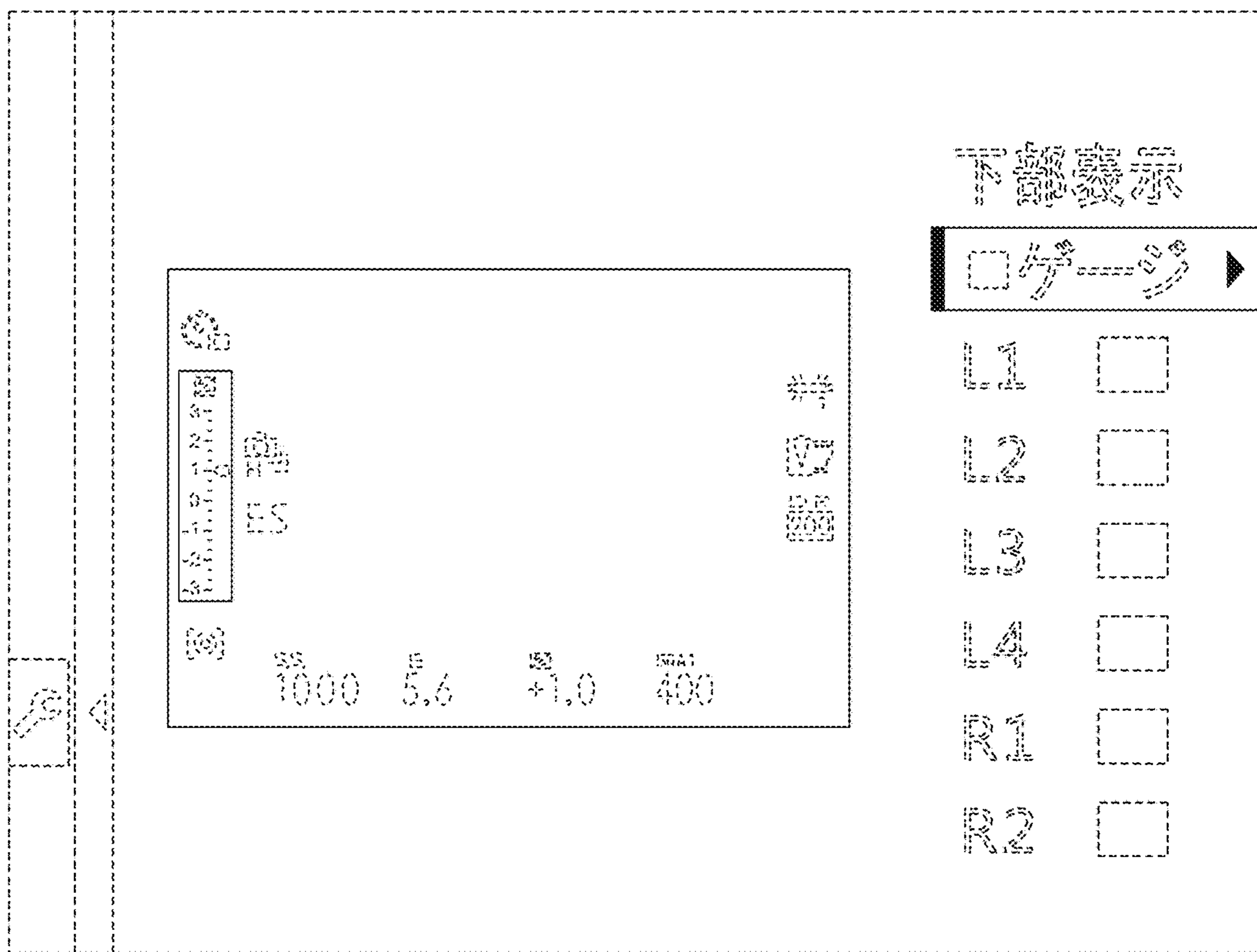

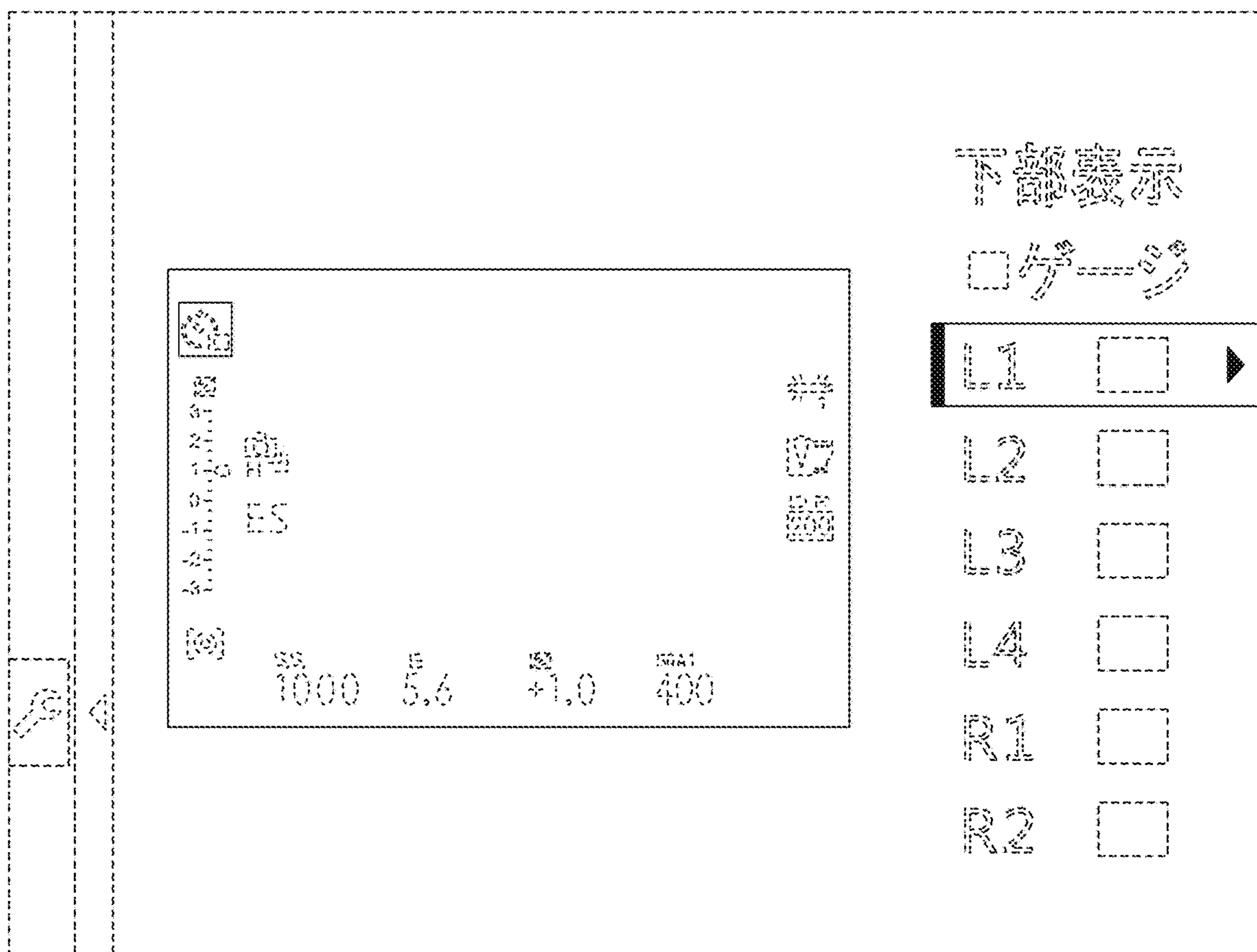

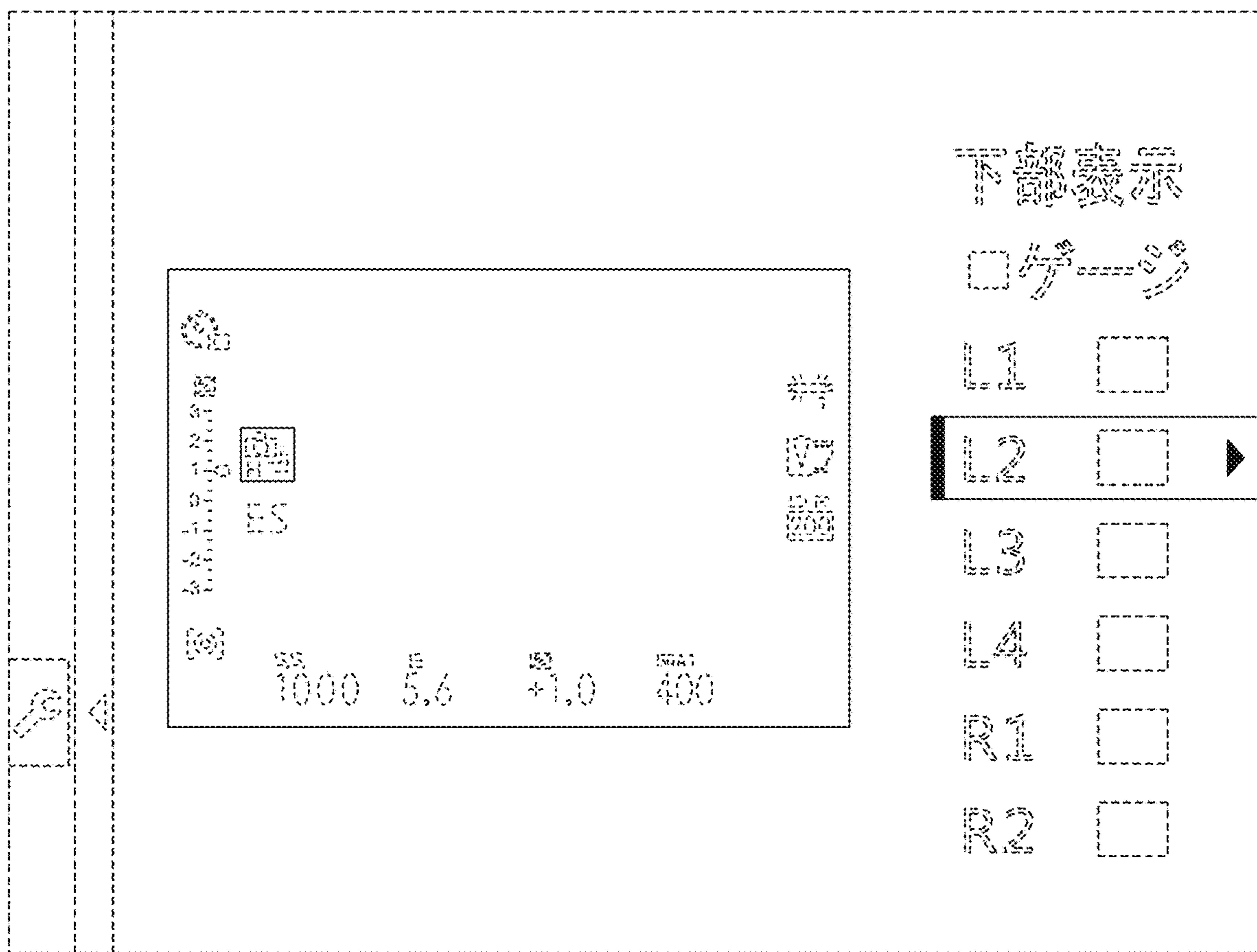

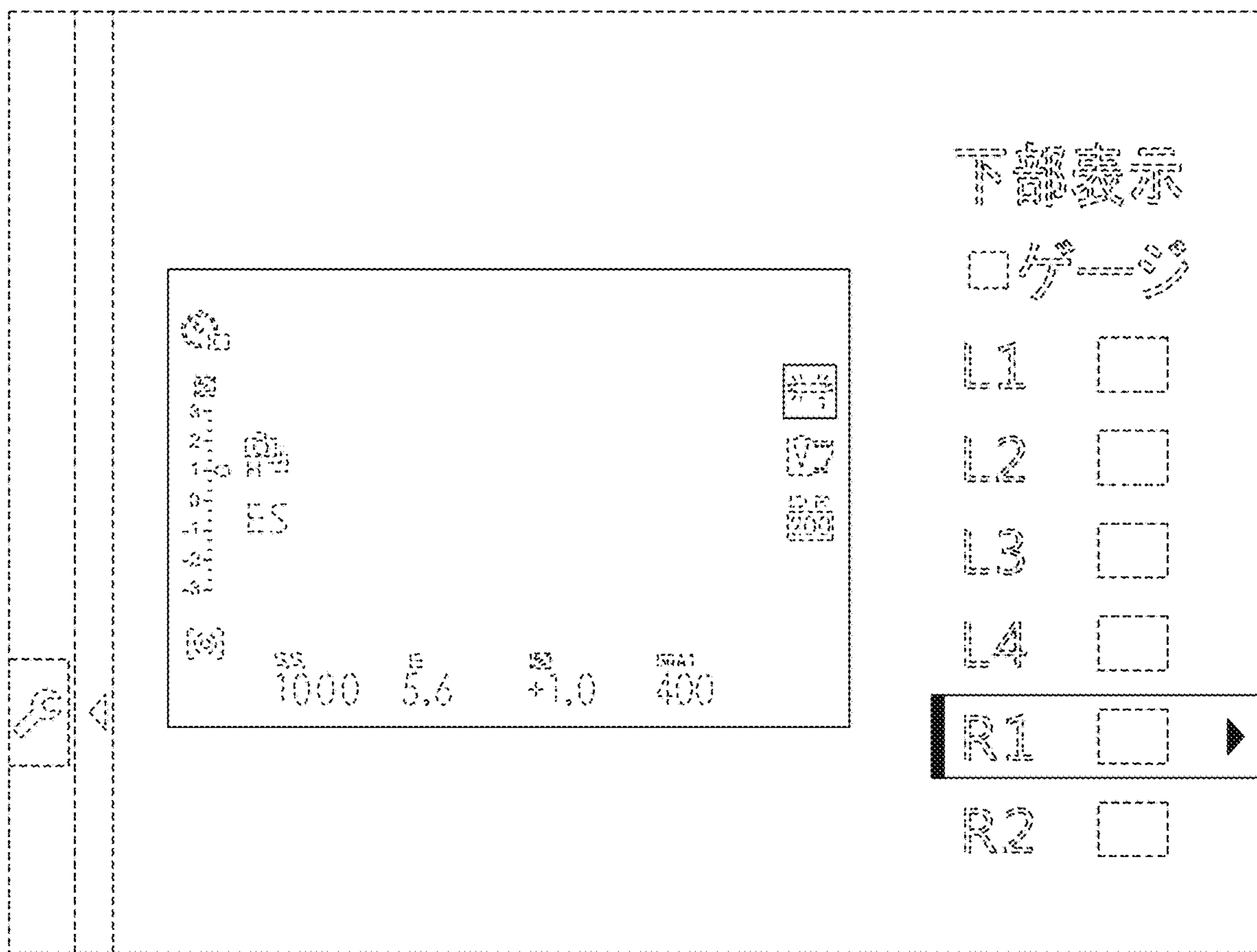

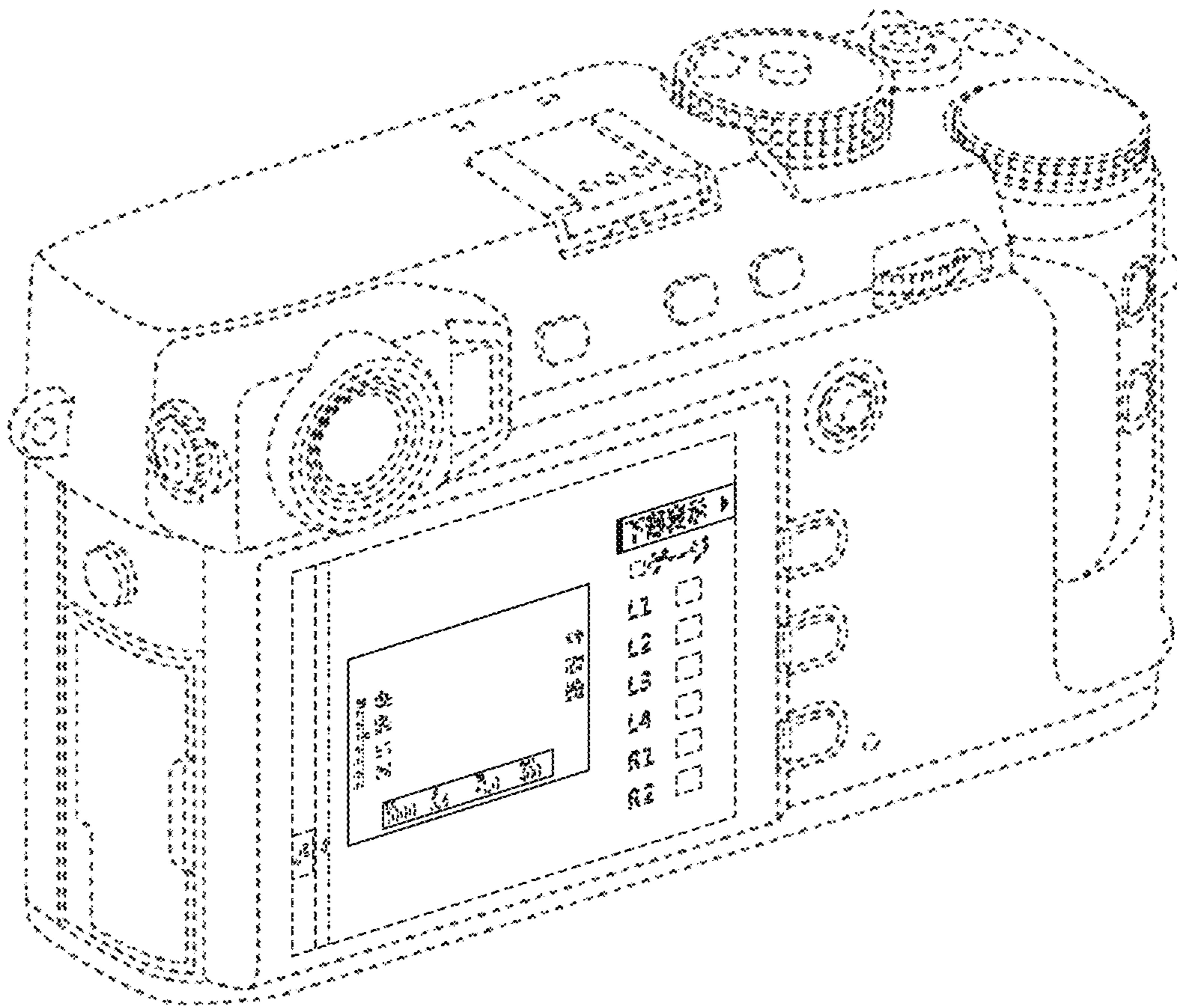

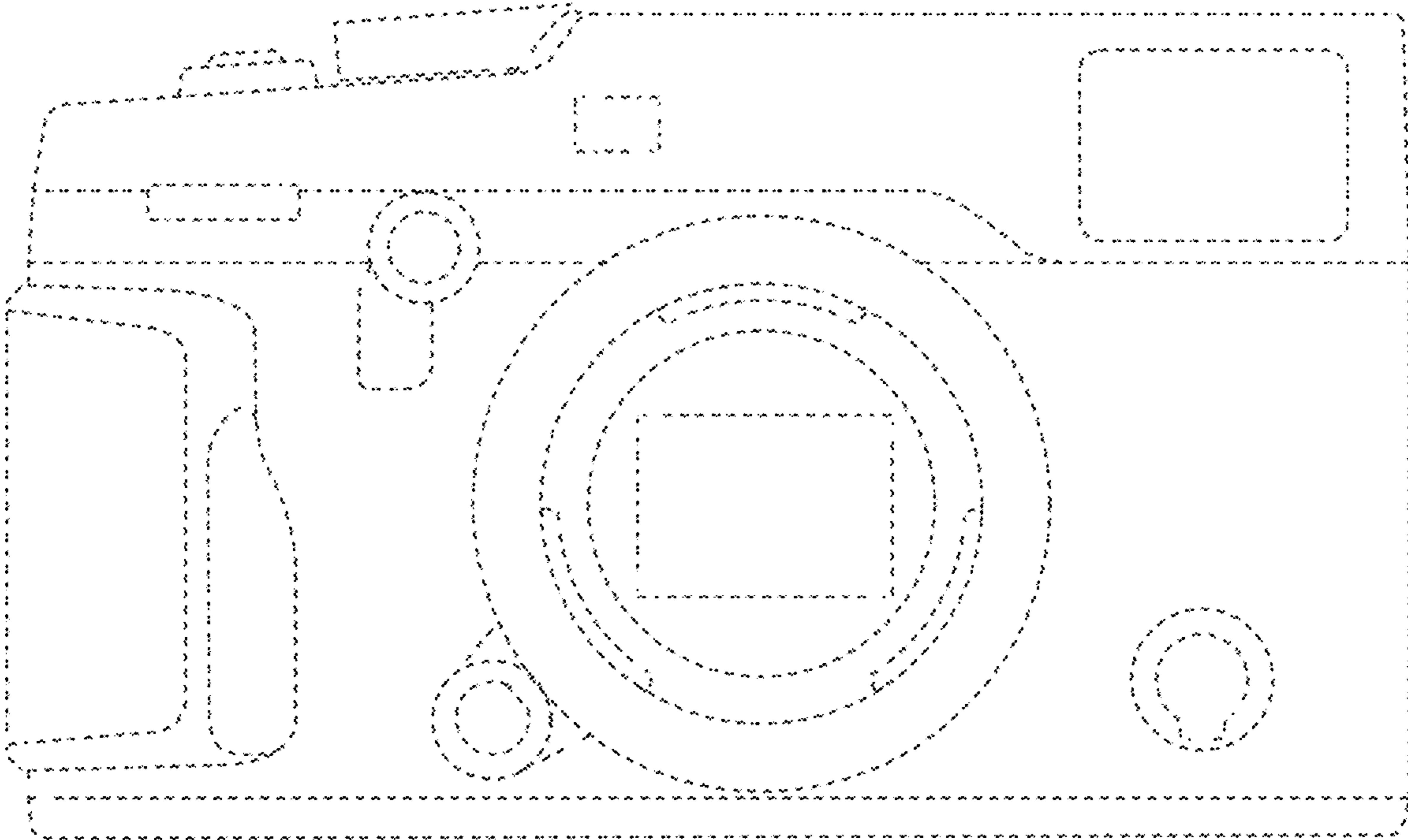

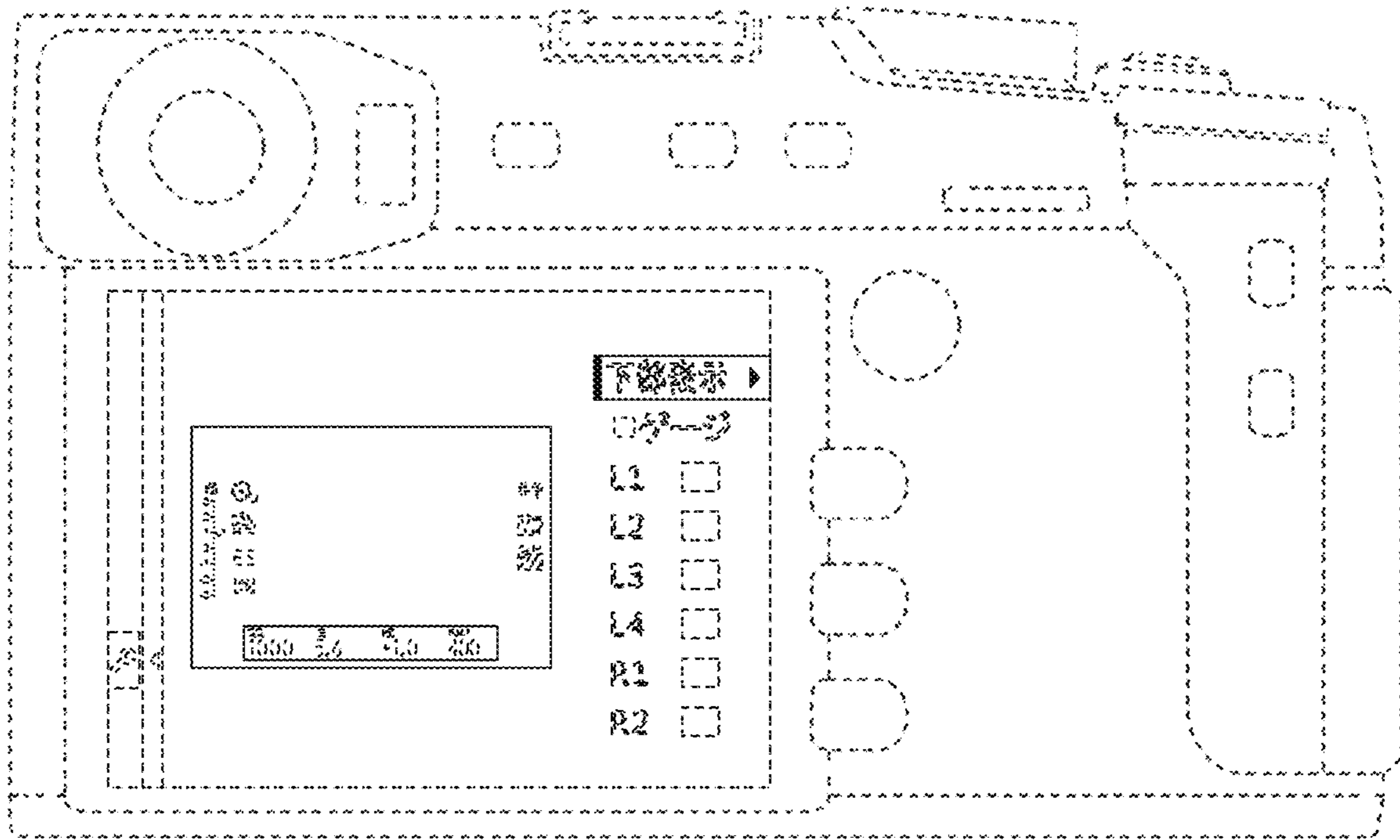

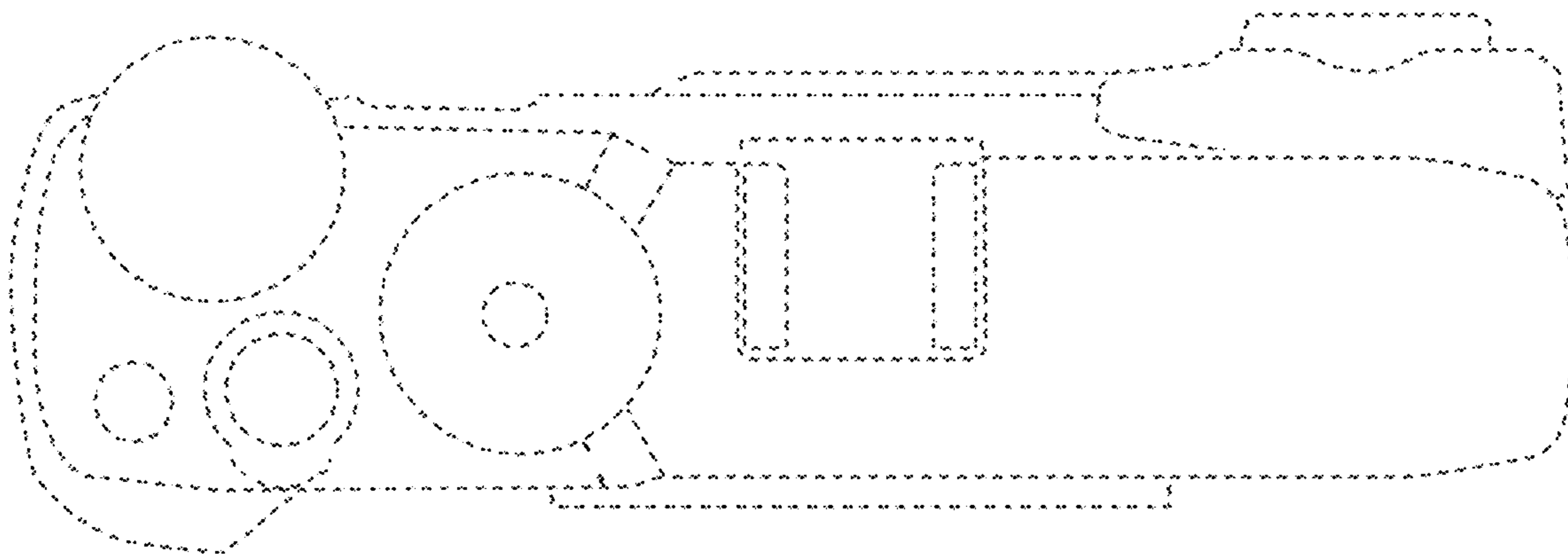

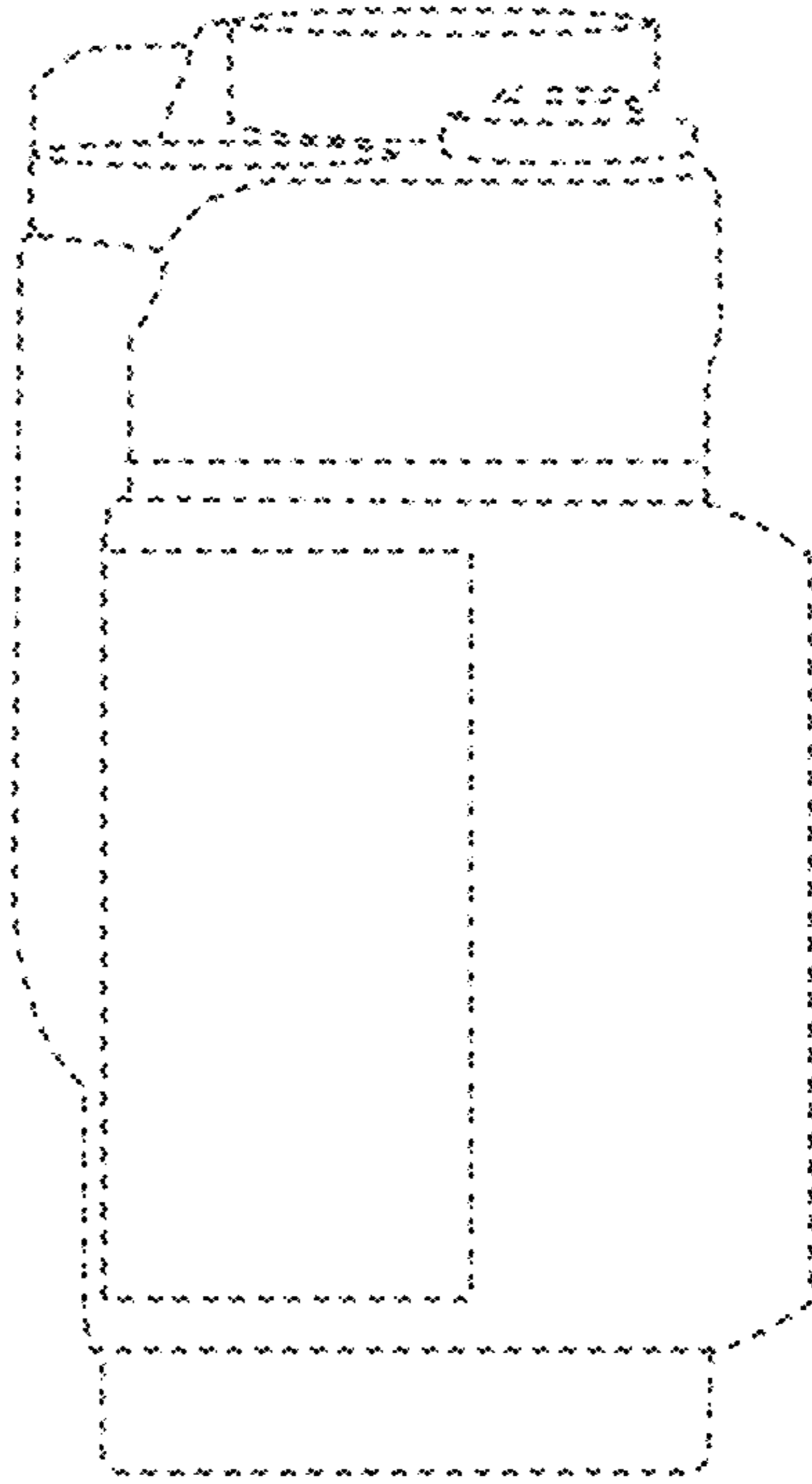

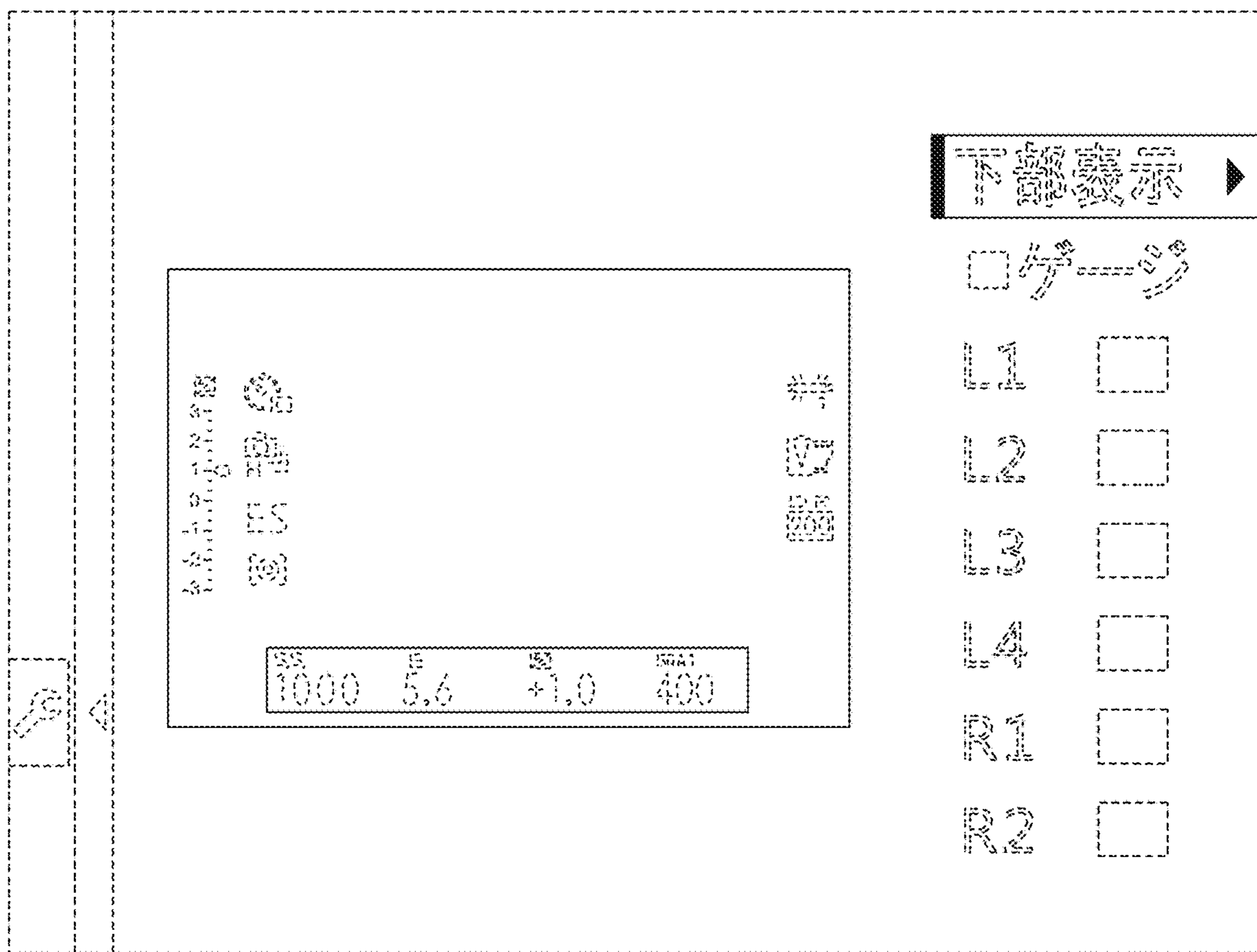

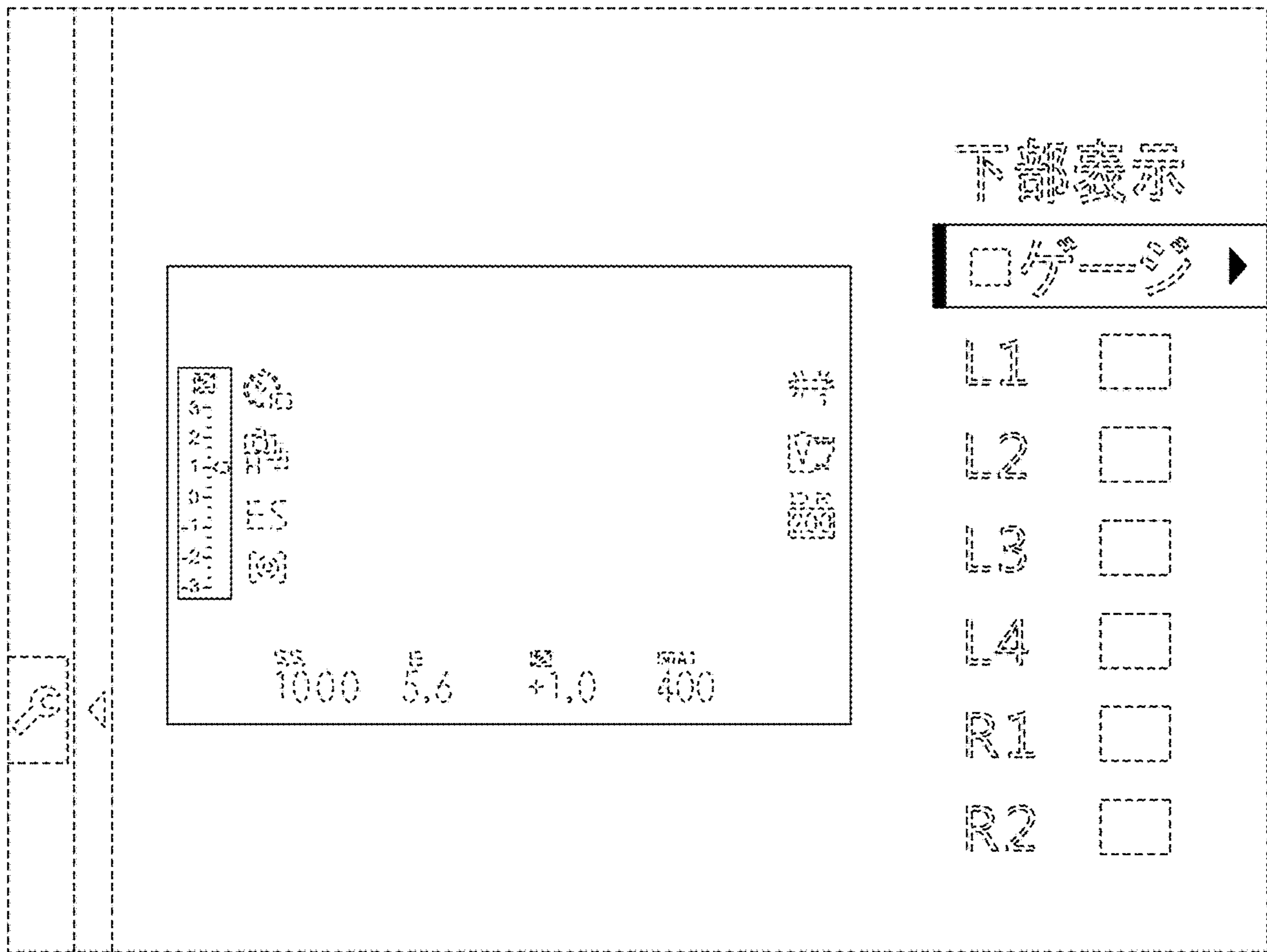

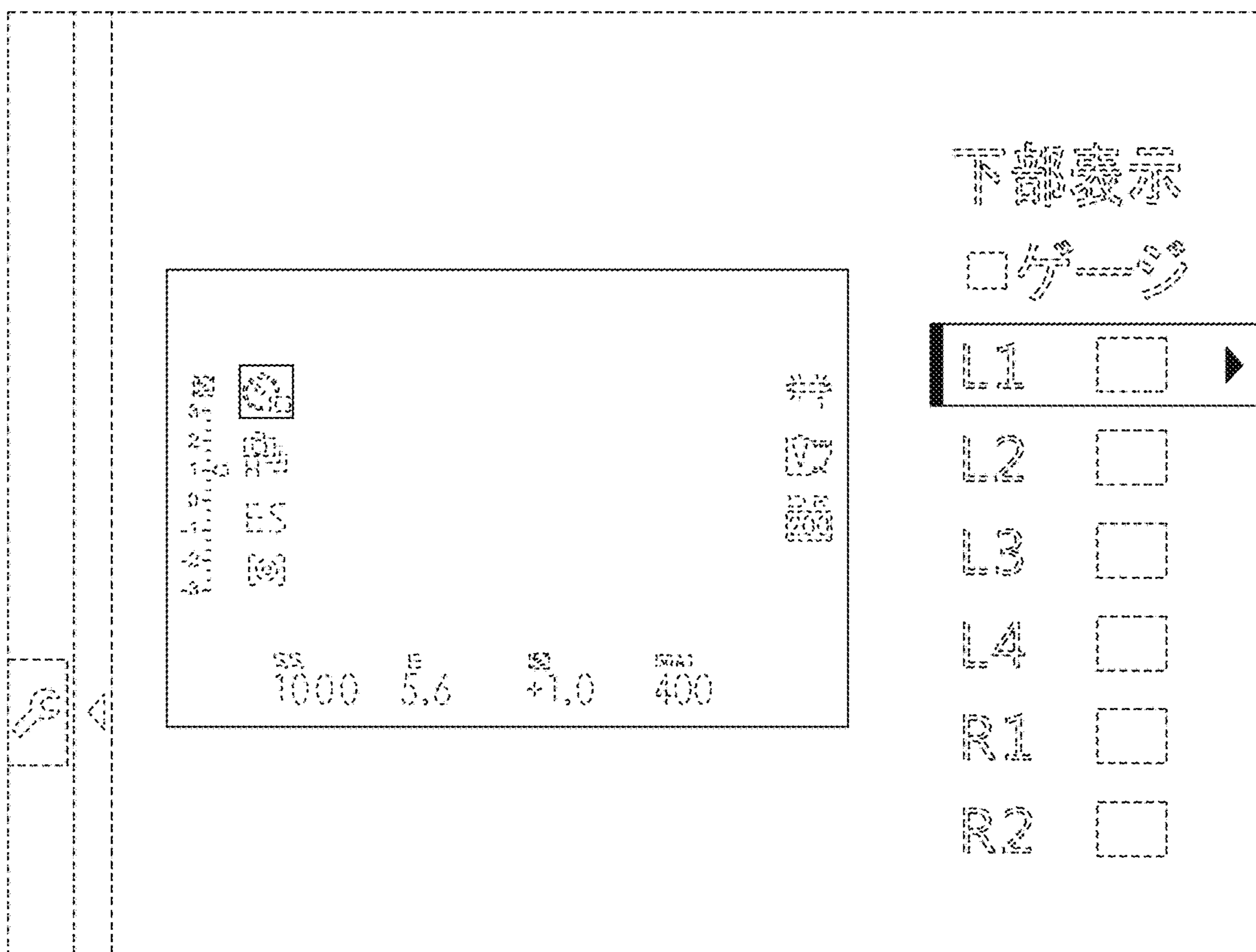

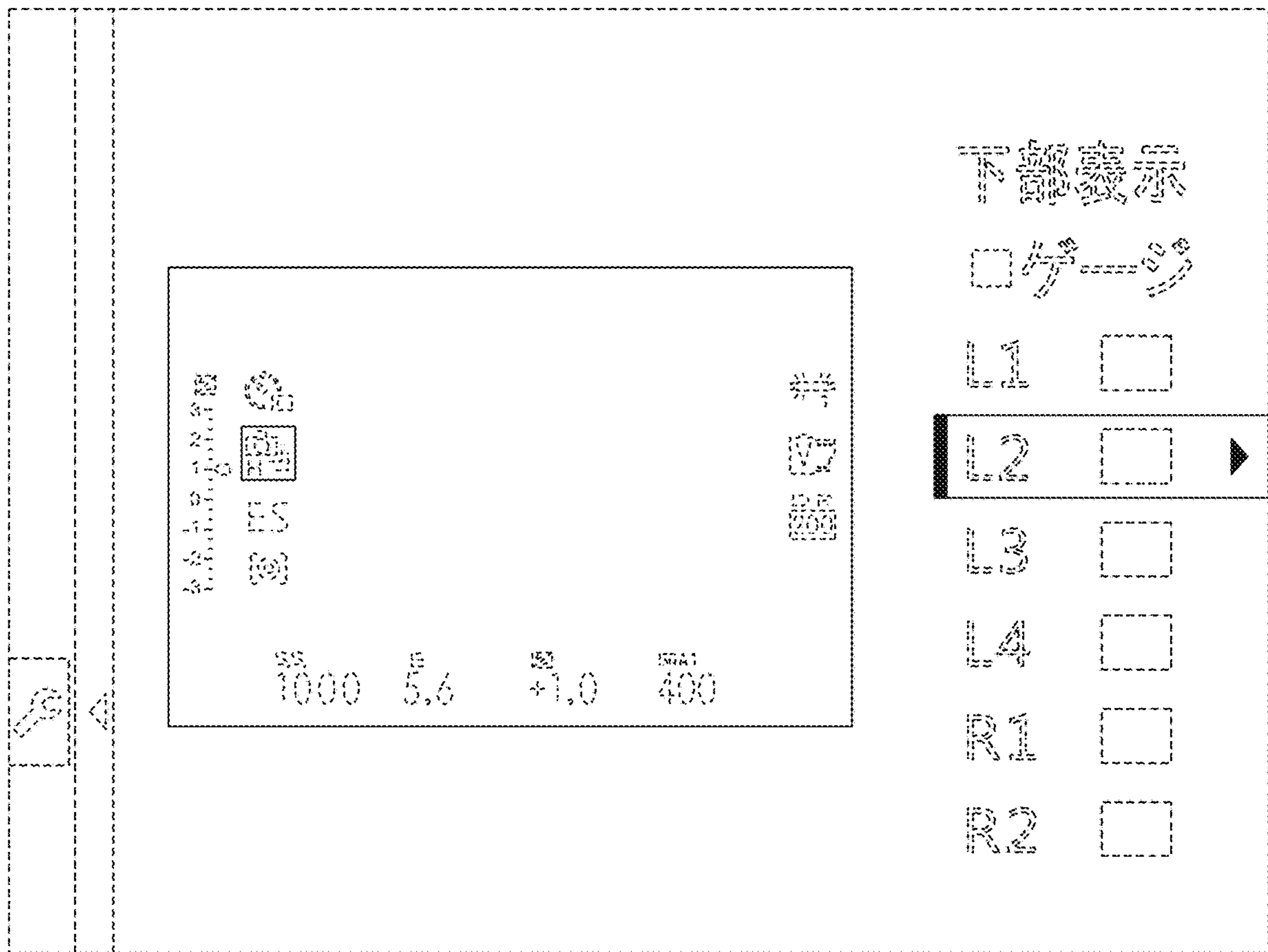

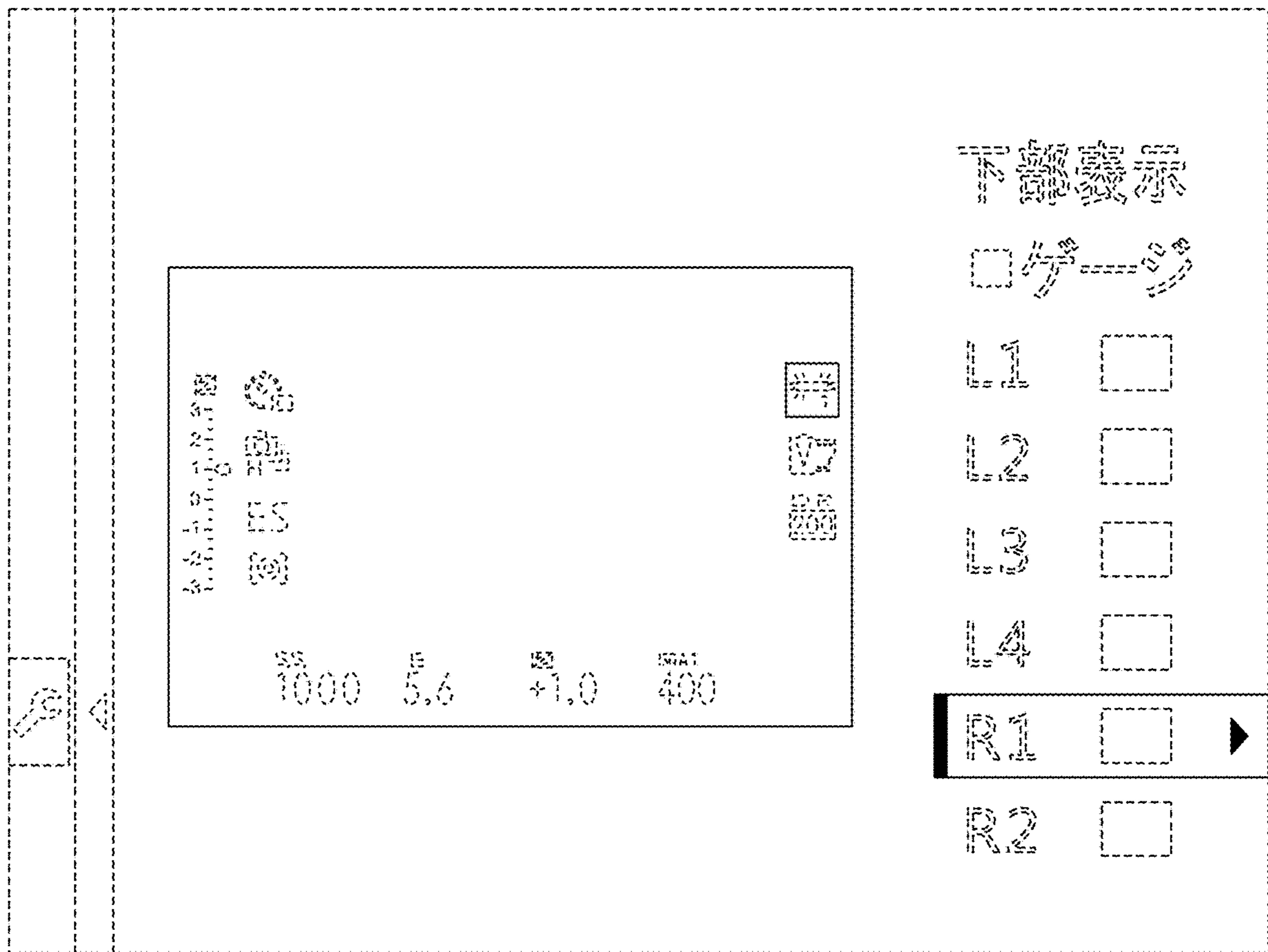
