The ornamental design for an electronic device with graphical user interface, as shown and described.

DESCRIPTION

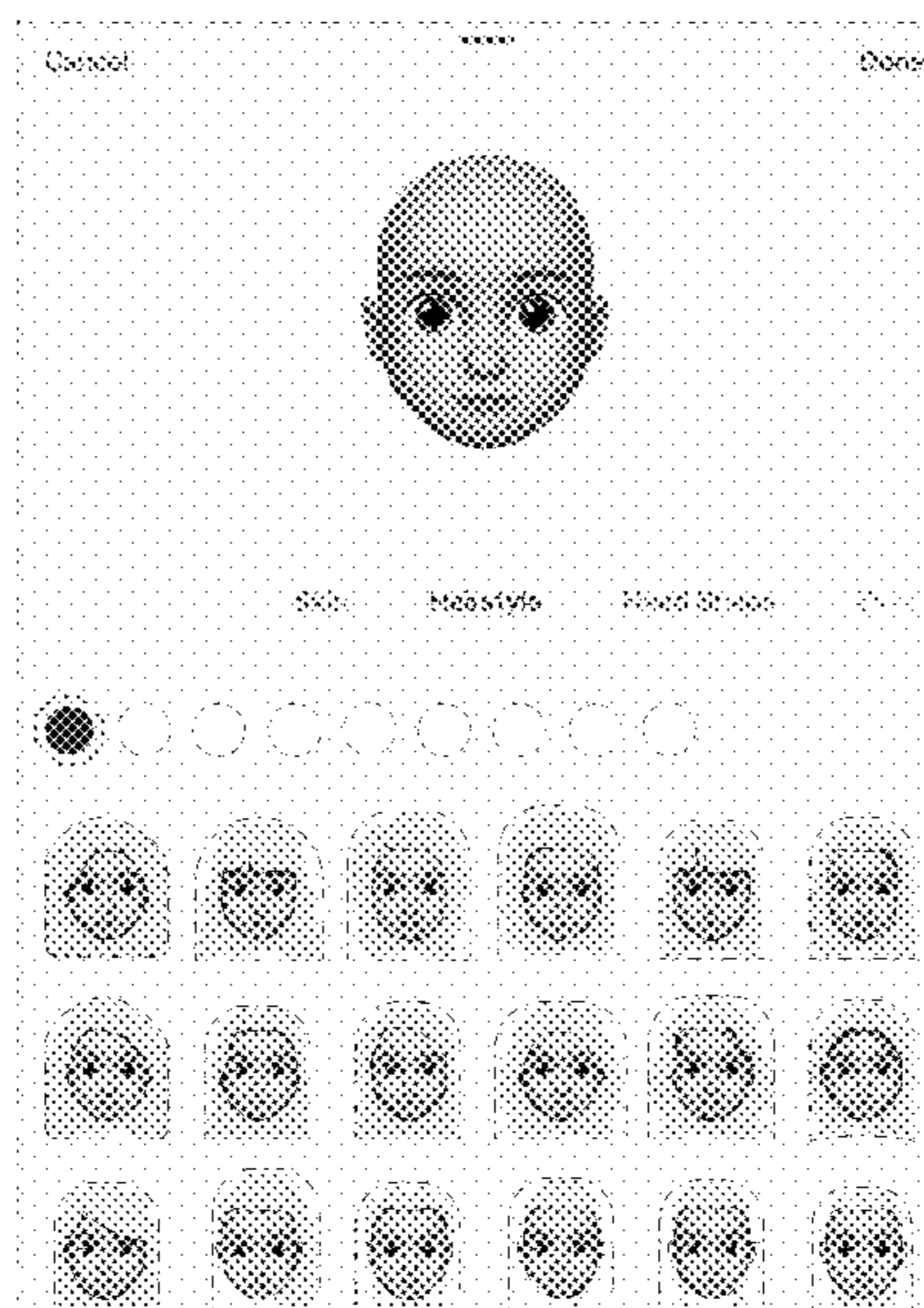

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing the claimed design; FIG. 2 is another embodiment thereof; and, FIG. 3 is a front view of an electronic device having a display screen with the graphical user interface of FIG. 1 applied thereto. The graphical user interface design of FIG. 2 may be similarly applied thereto.

The outer dashed broken lines in the figures show a display screen or portion thereof, or an electronic device having a display screen, and form no part of the claimed design. The other dashed broken lines in the figures show portions of the graphical user interface that form no part of the claimed design.

The dot-dash broken lines in the figures and the areas within the dot-dash broken lines show portions of the graphical user interface that form no part of the claimed design.

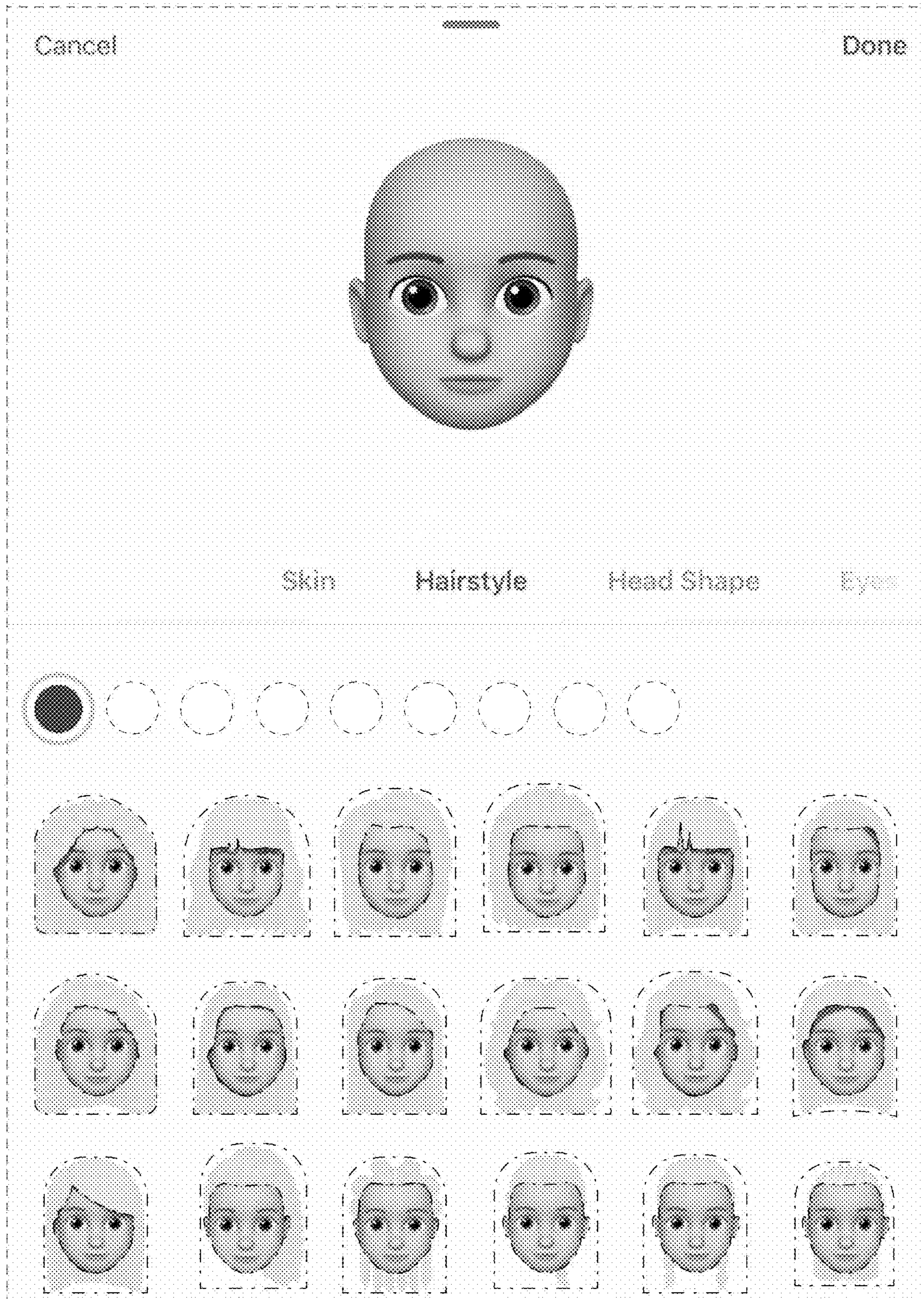

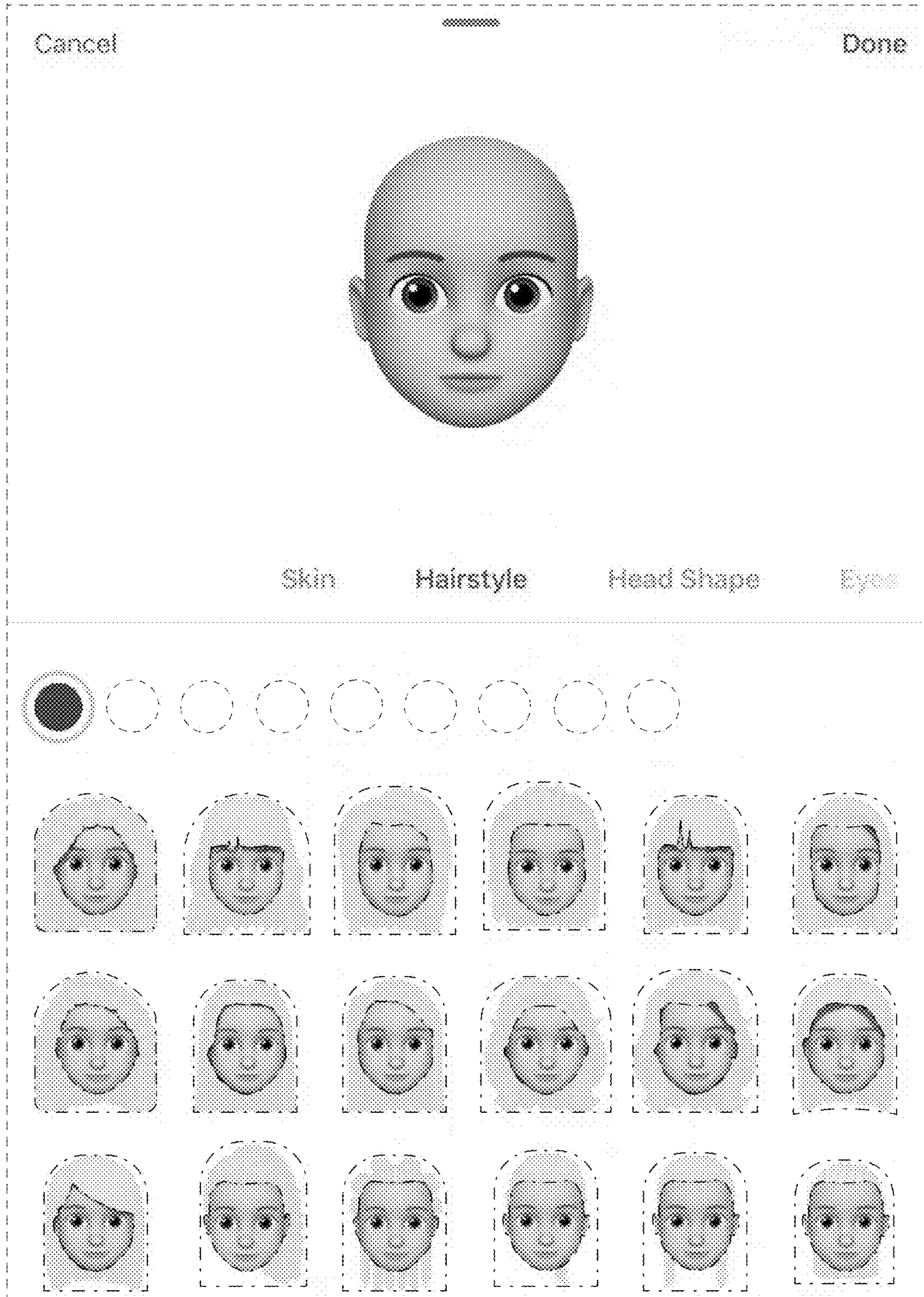

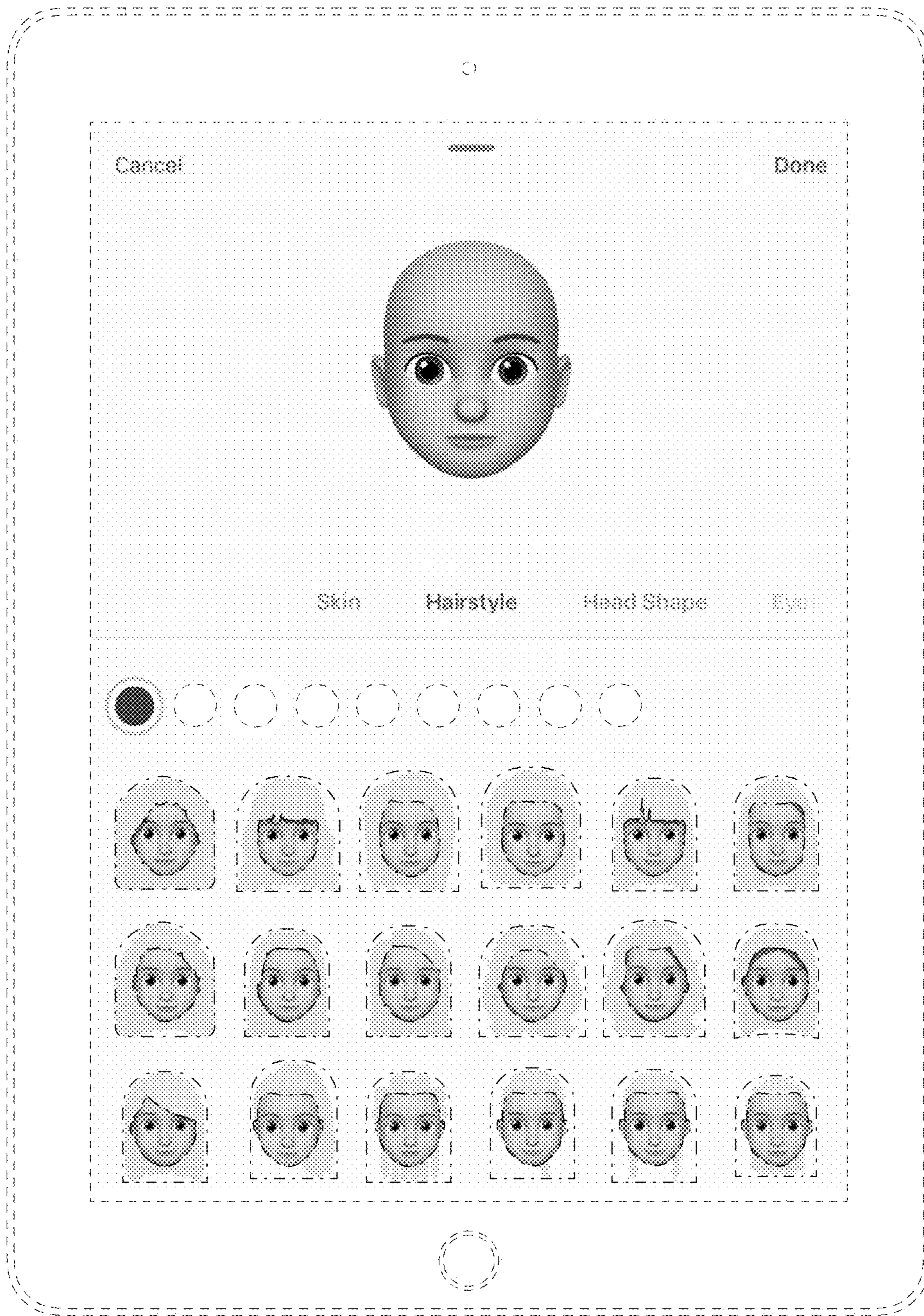
