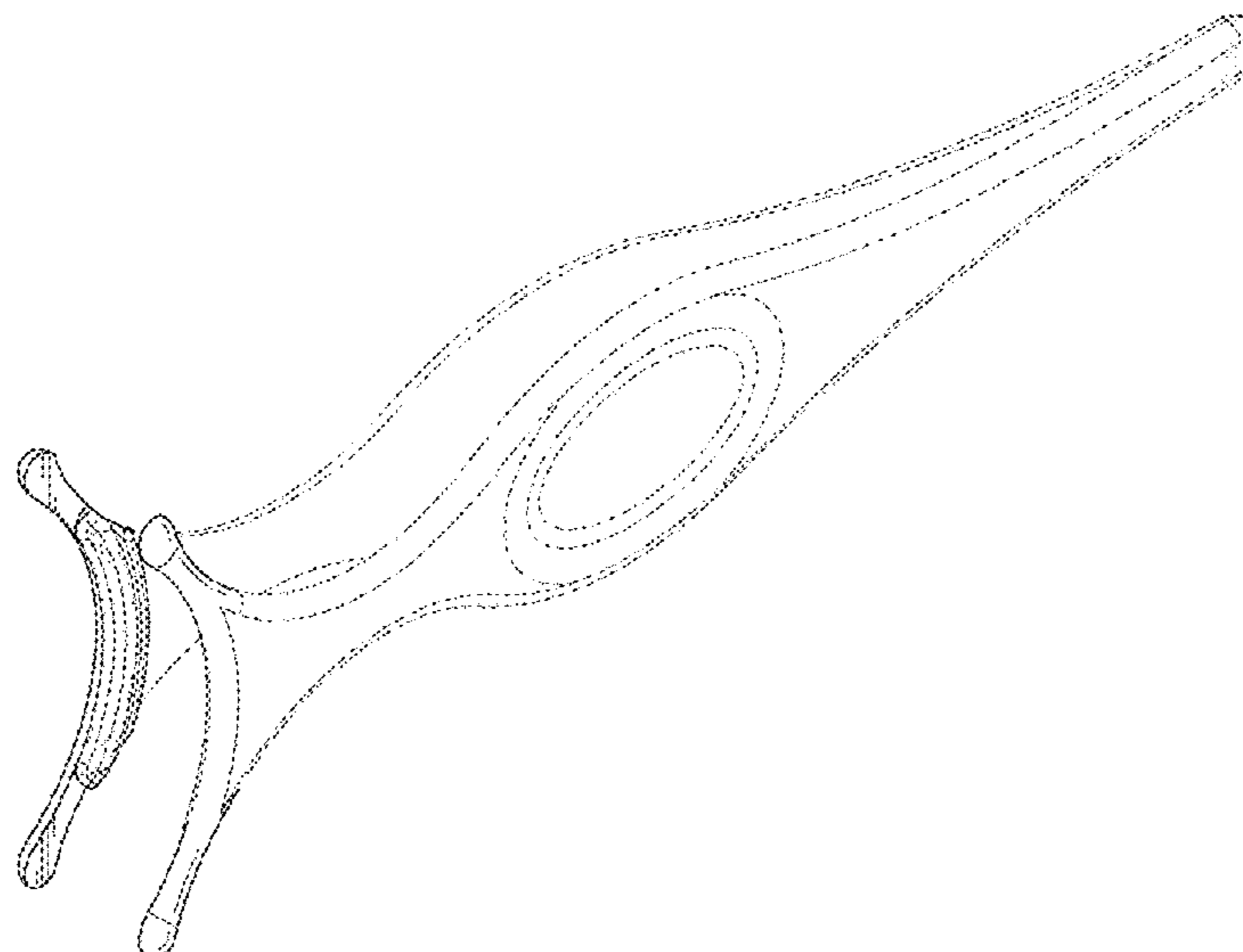
(57) **CLAIM**

An ornamental design for a false eyelash applicator, as shown and described.

DESCRIPTION

FIG. 1 is an illustration of a front perspective view of a false eyelash applicator;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right-side elevation view thereof;
FIG. 5 is a left-side elevation view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a bottom perspective view thereof.

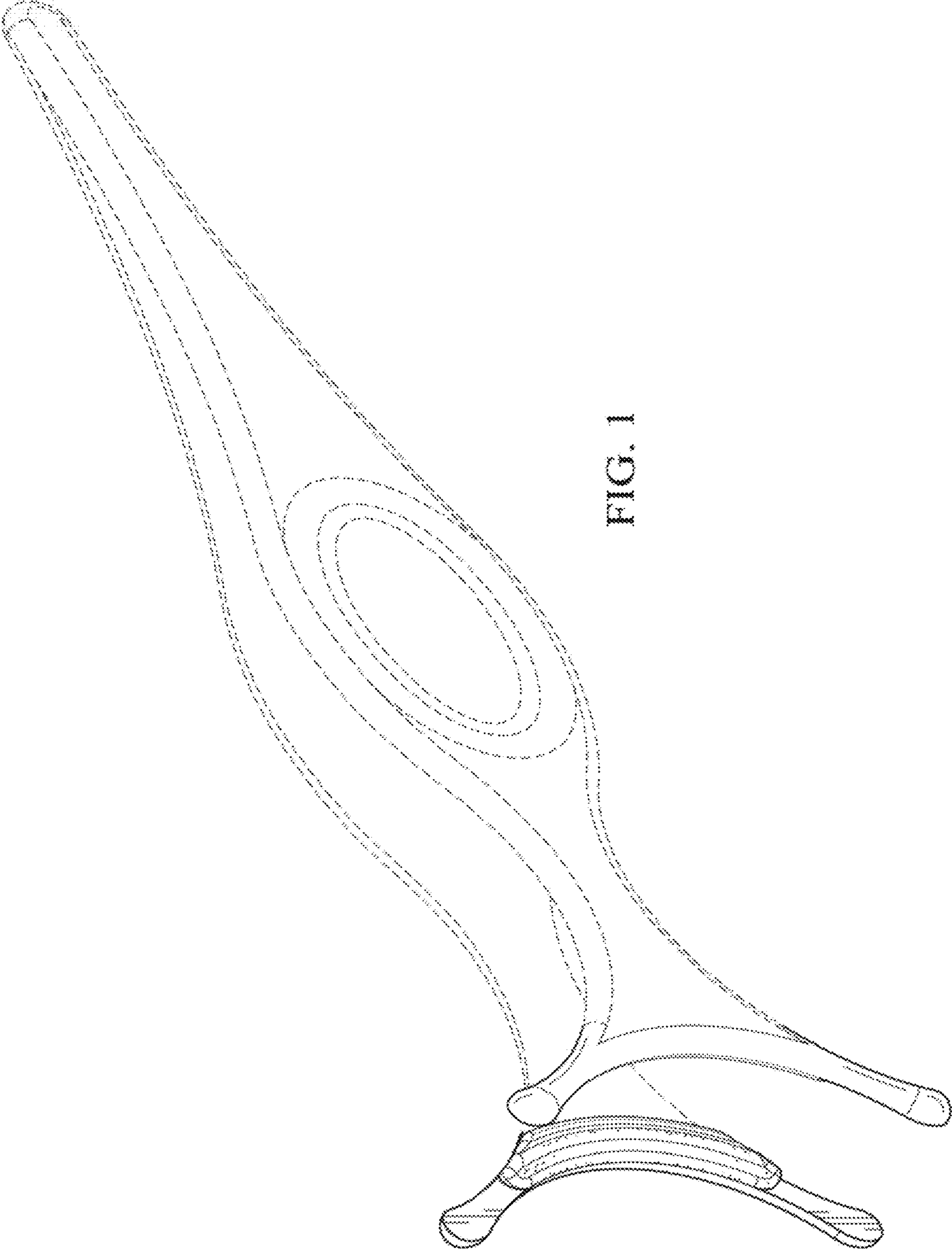

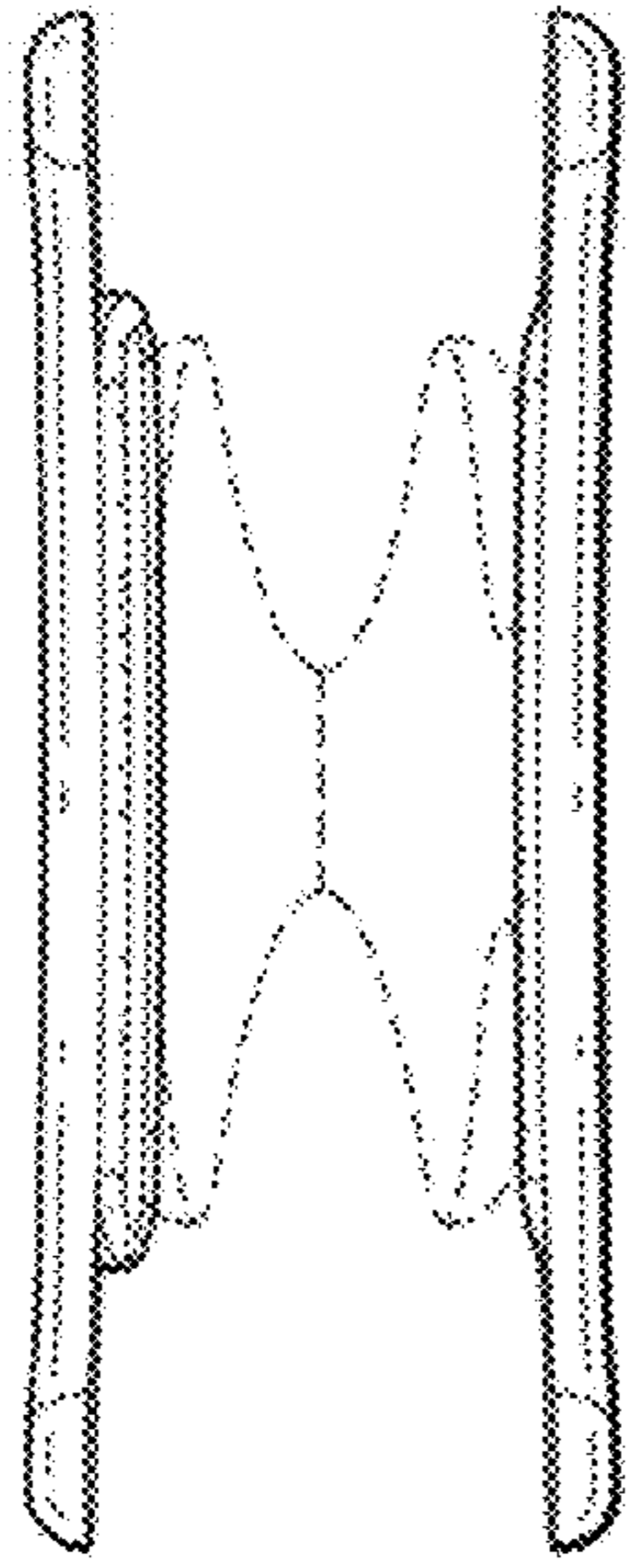

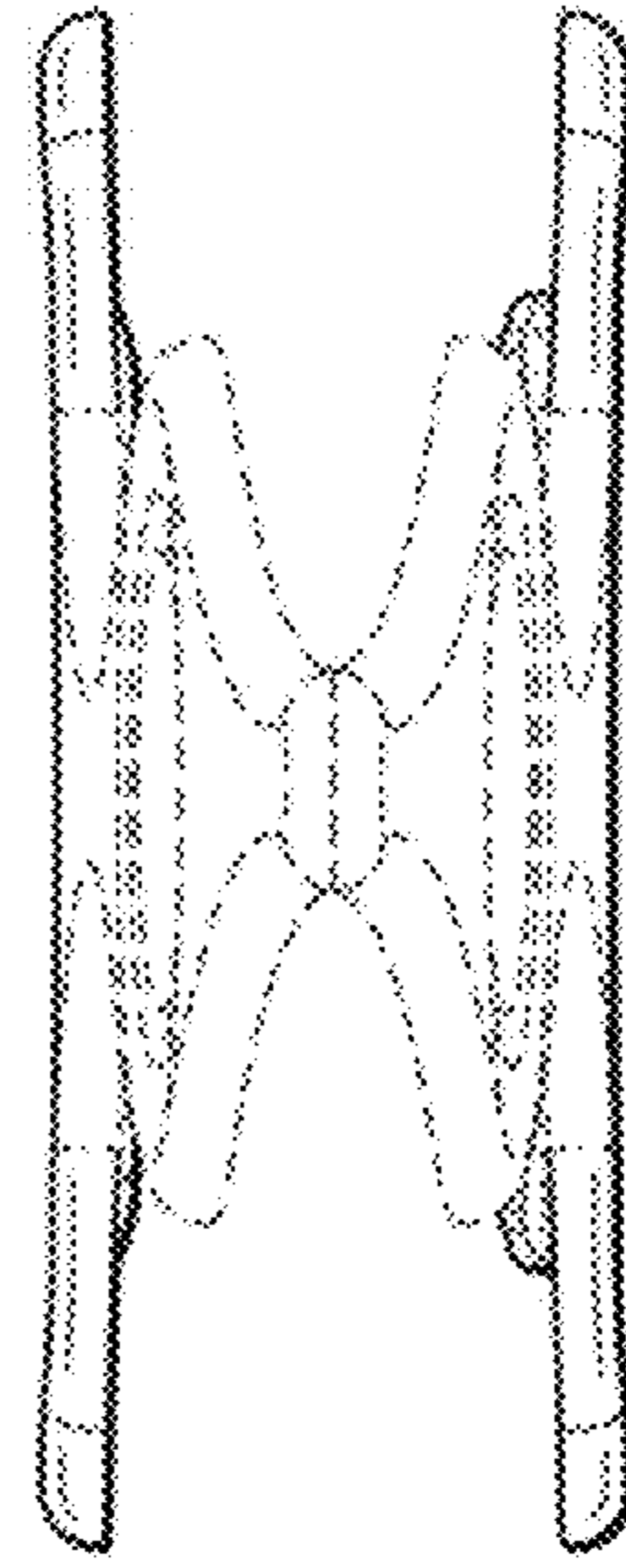

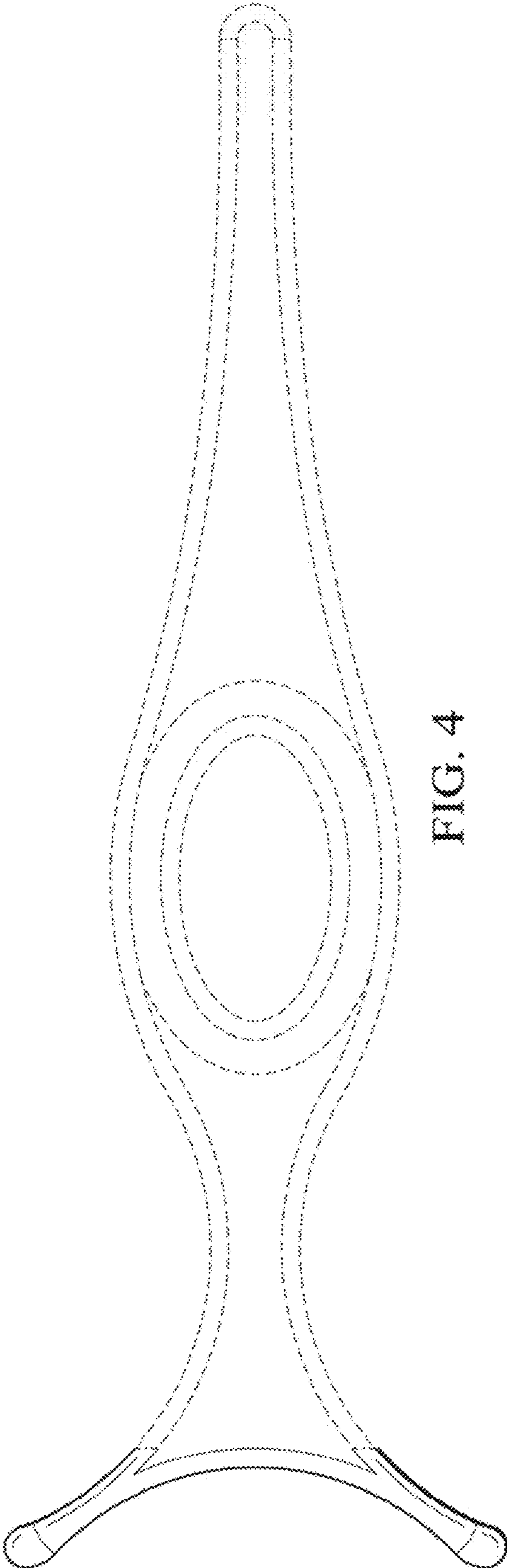

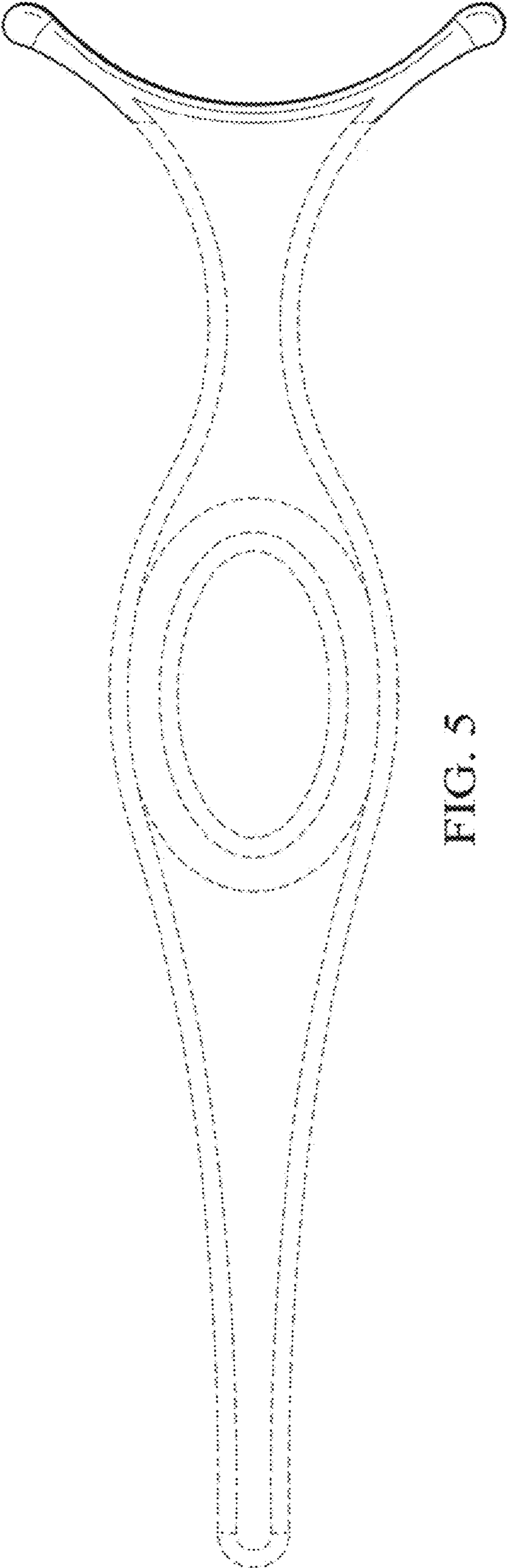

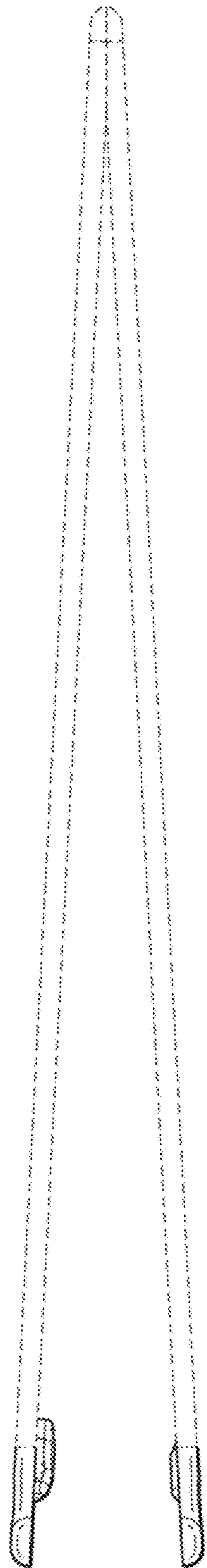

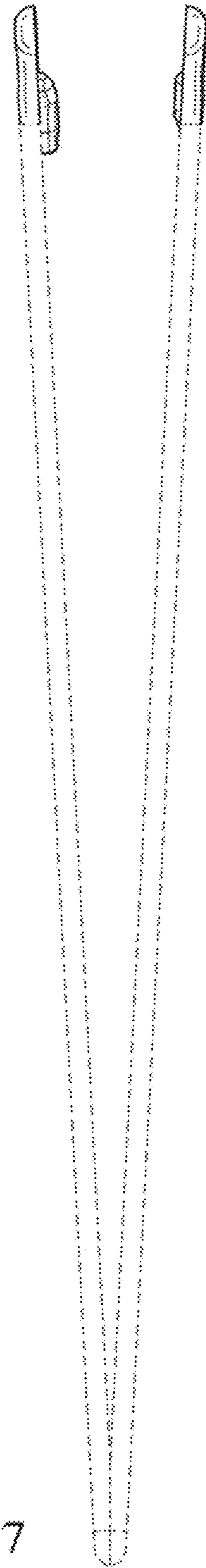

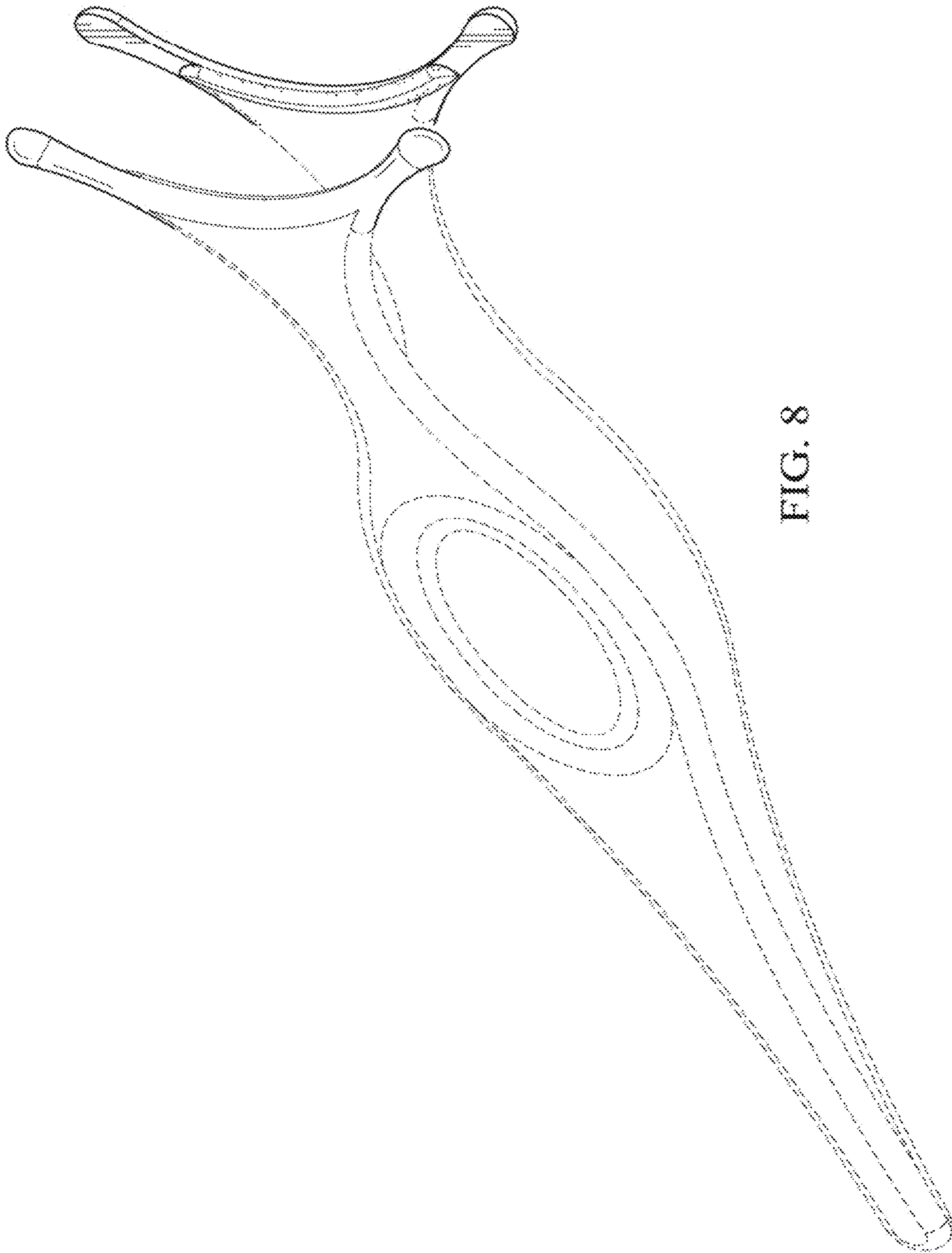
