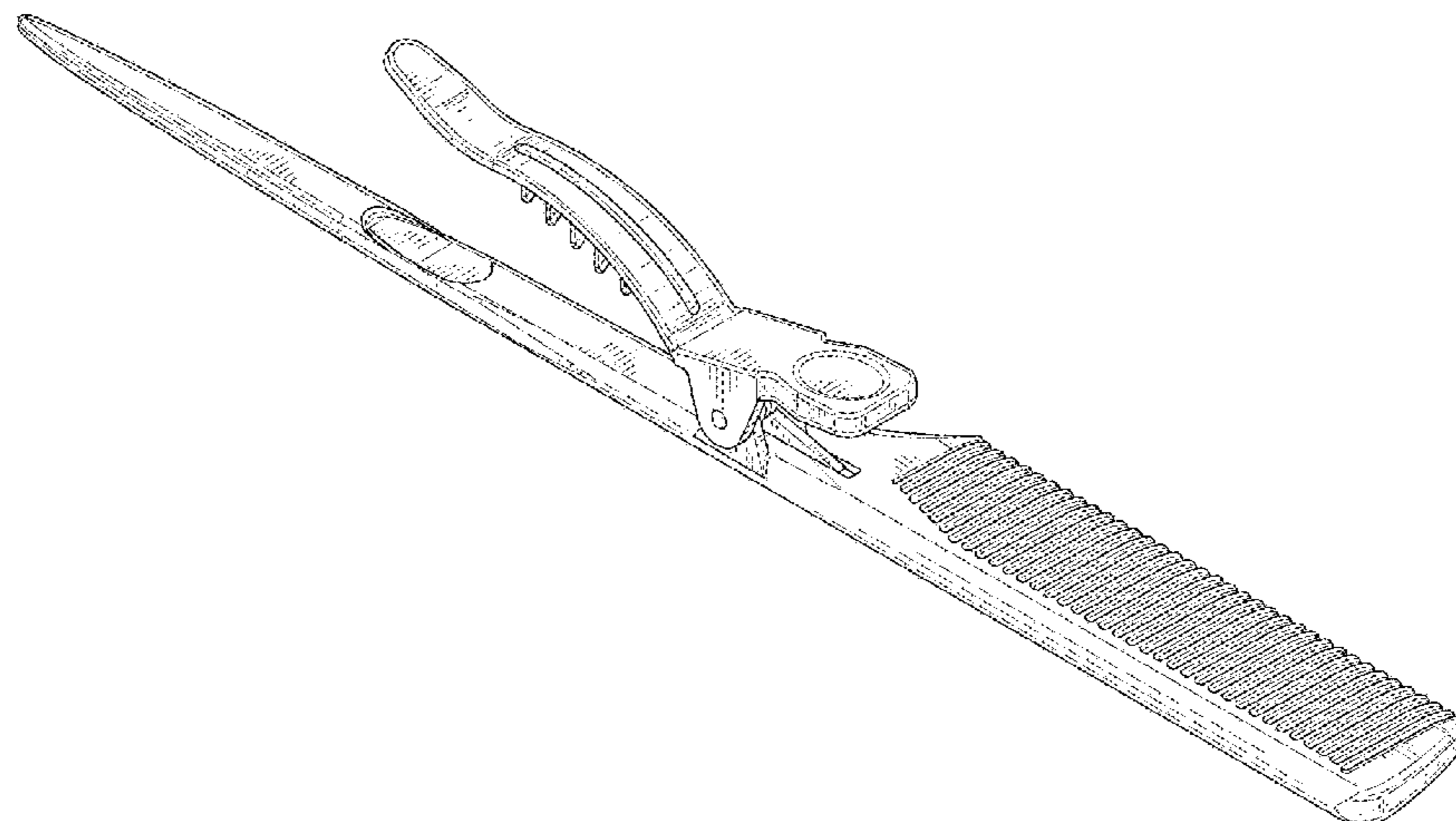


FIG. 7 is a bottom plan view of a rat tail comb with hair clip combination of the present invention.

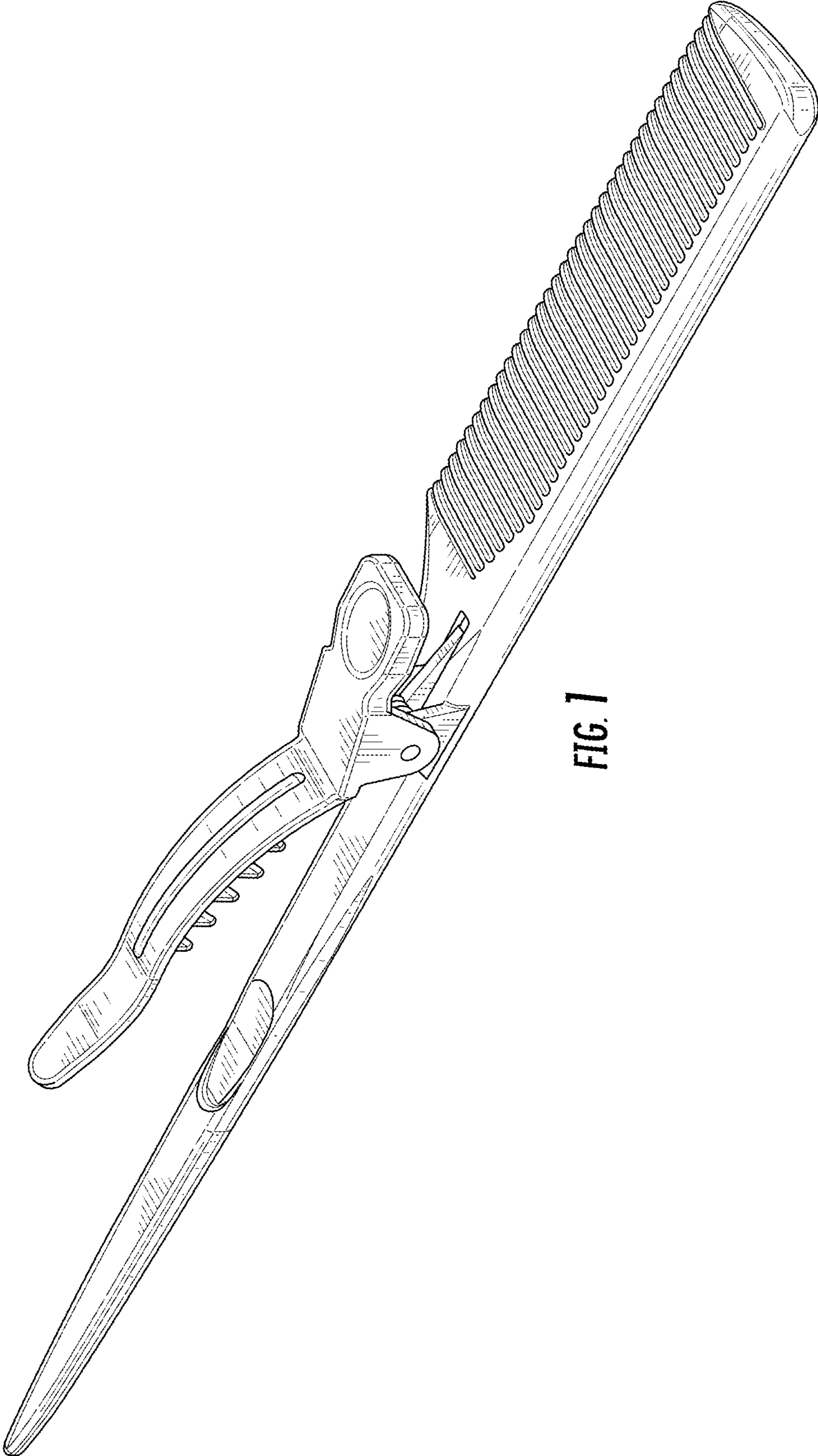

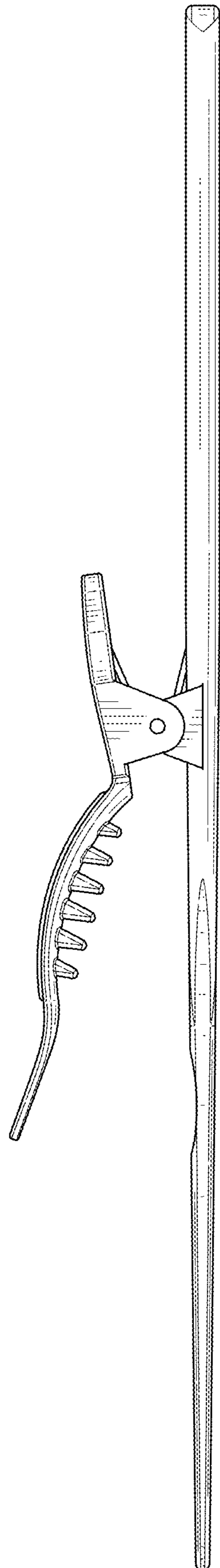

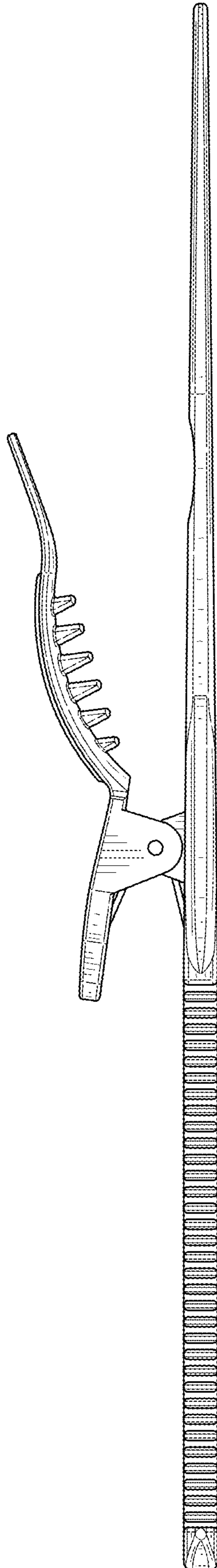

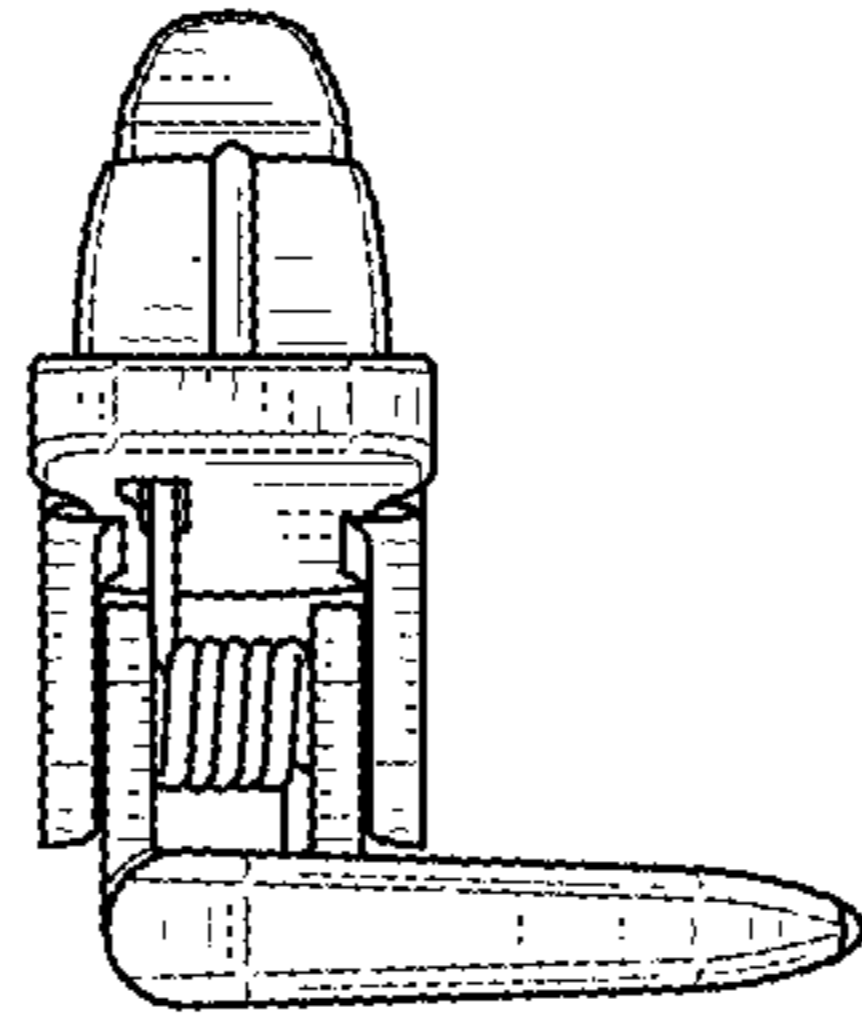

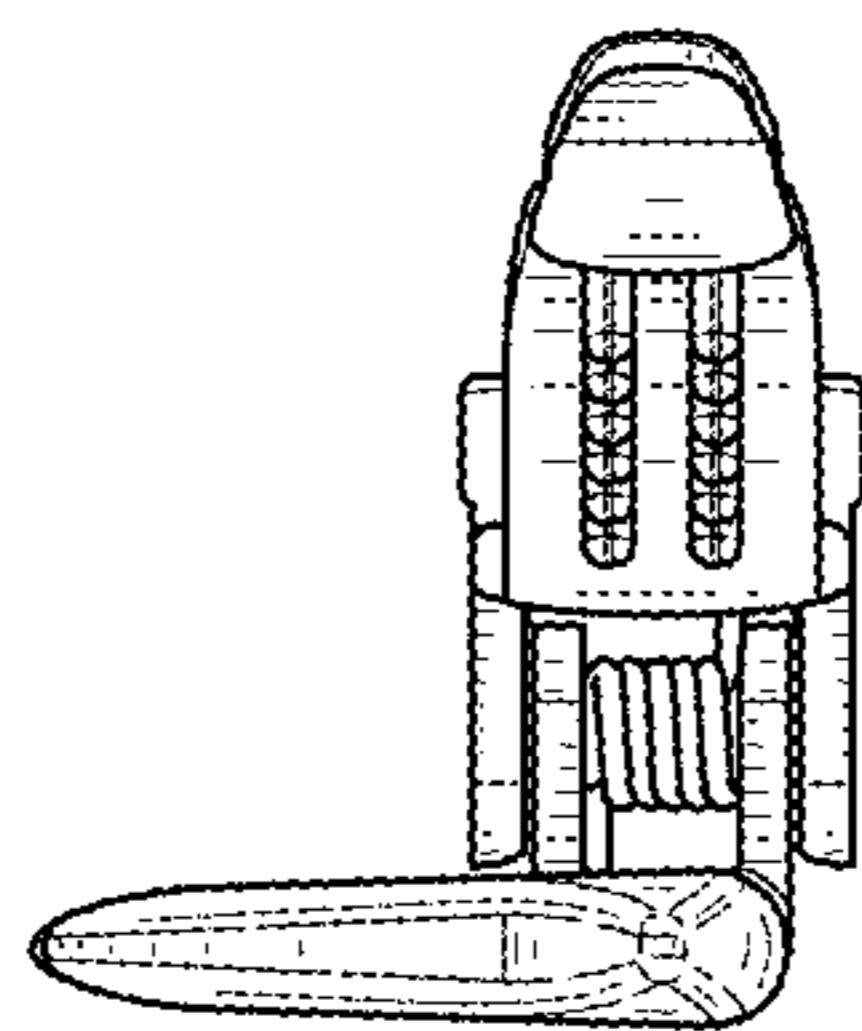

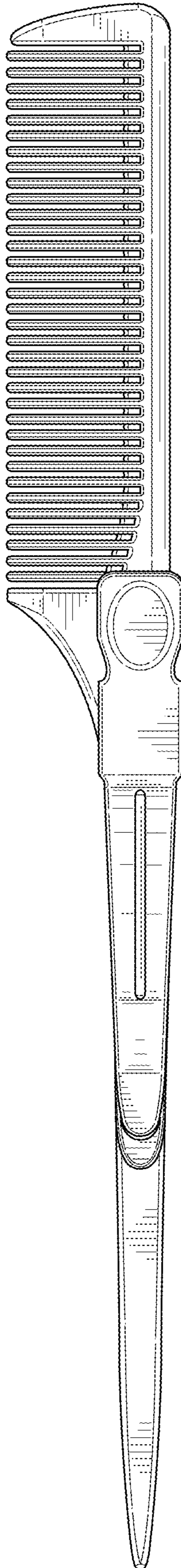

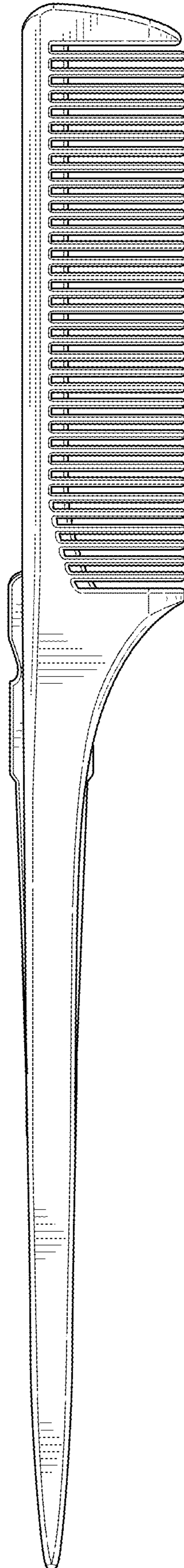
