(57) **CLAIM**

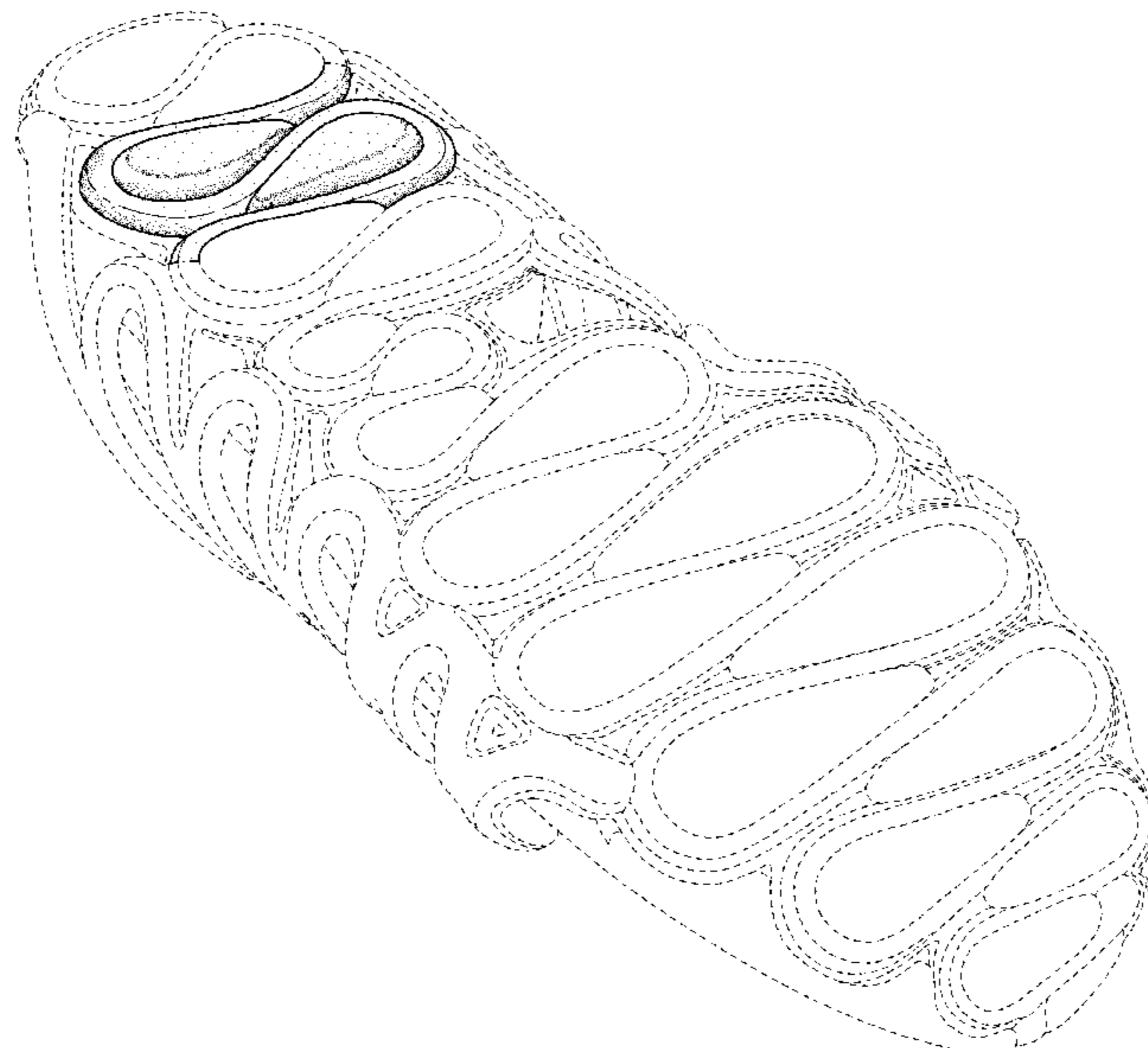
The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a shoe showing the claimed design, the front and top views thereof form no part of the claimed design;  
FIG. 2 is a rear view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof; and,  
FIG. 5 is a bottom view thereof.

The dashed broken lines in the figures show portions of the shoe that form no part of the claimed design.  
The dot-dash broken lines in the figures show boundaries that form no part of the claimed design.

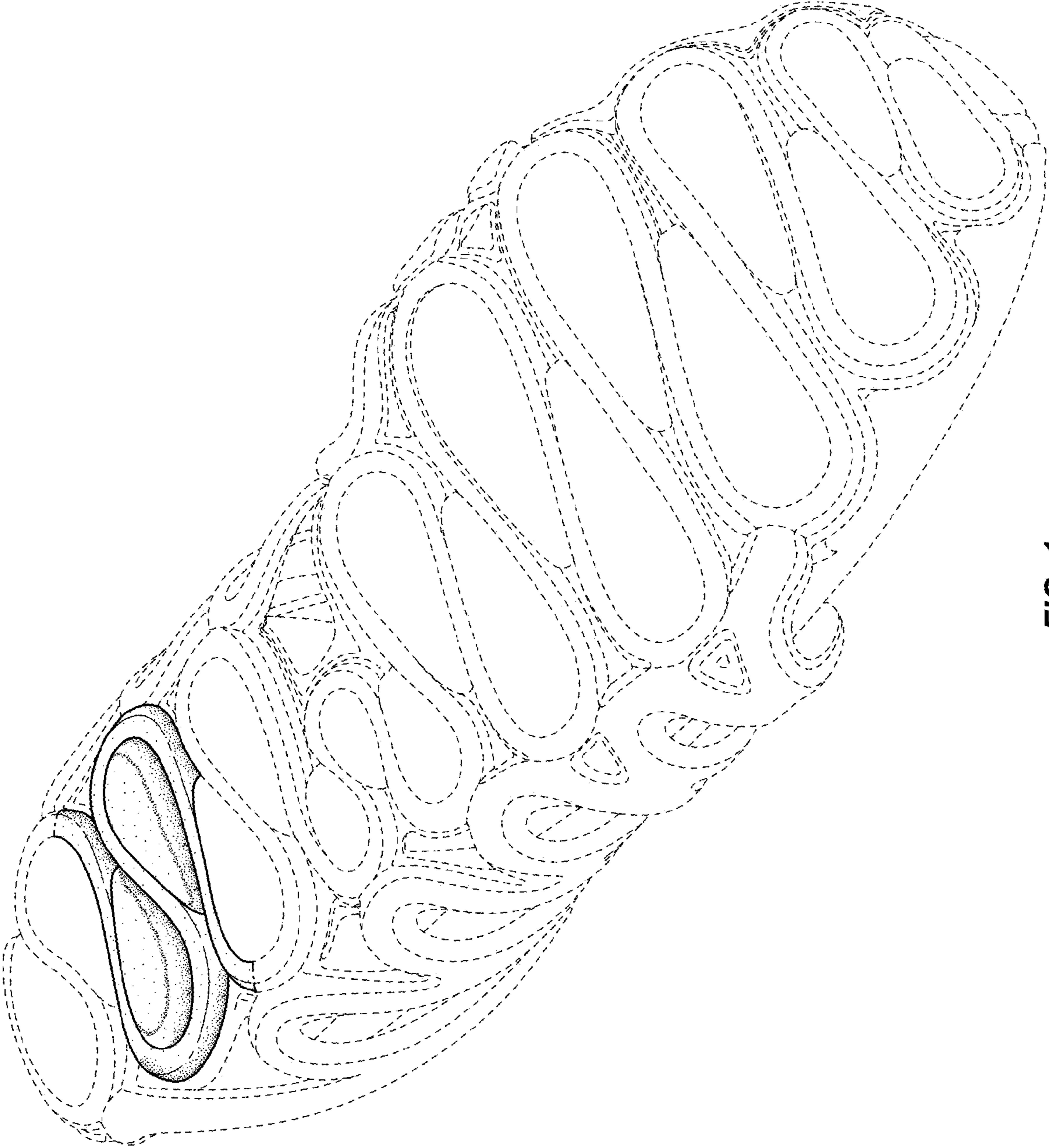
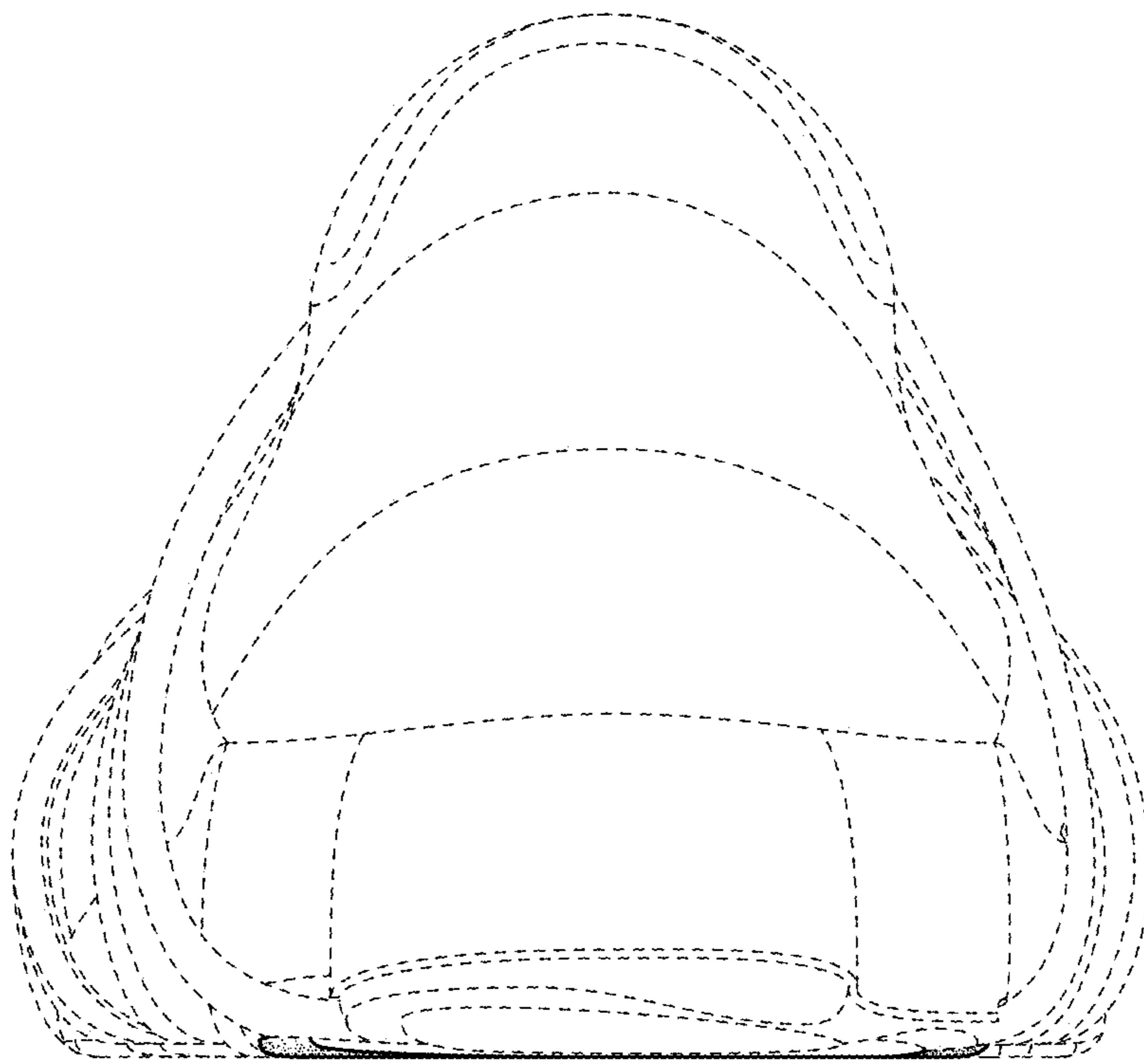

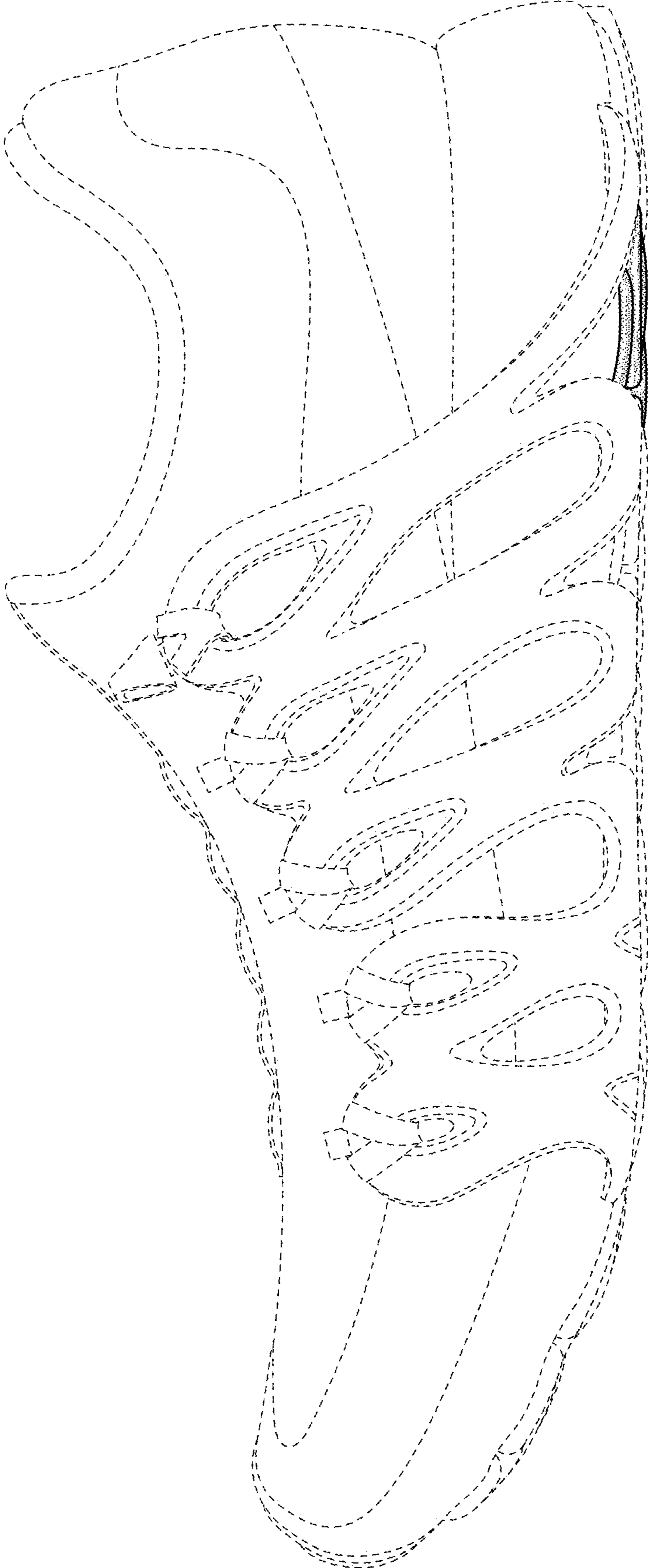

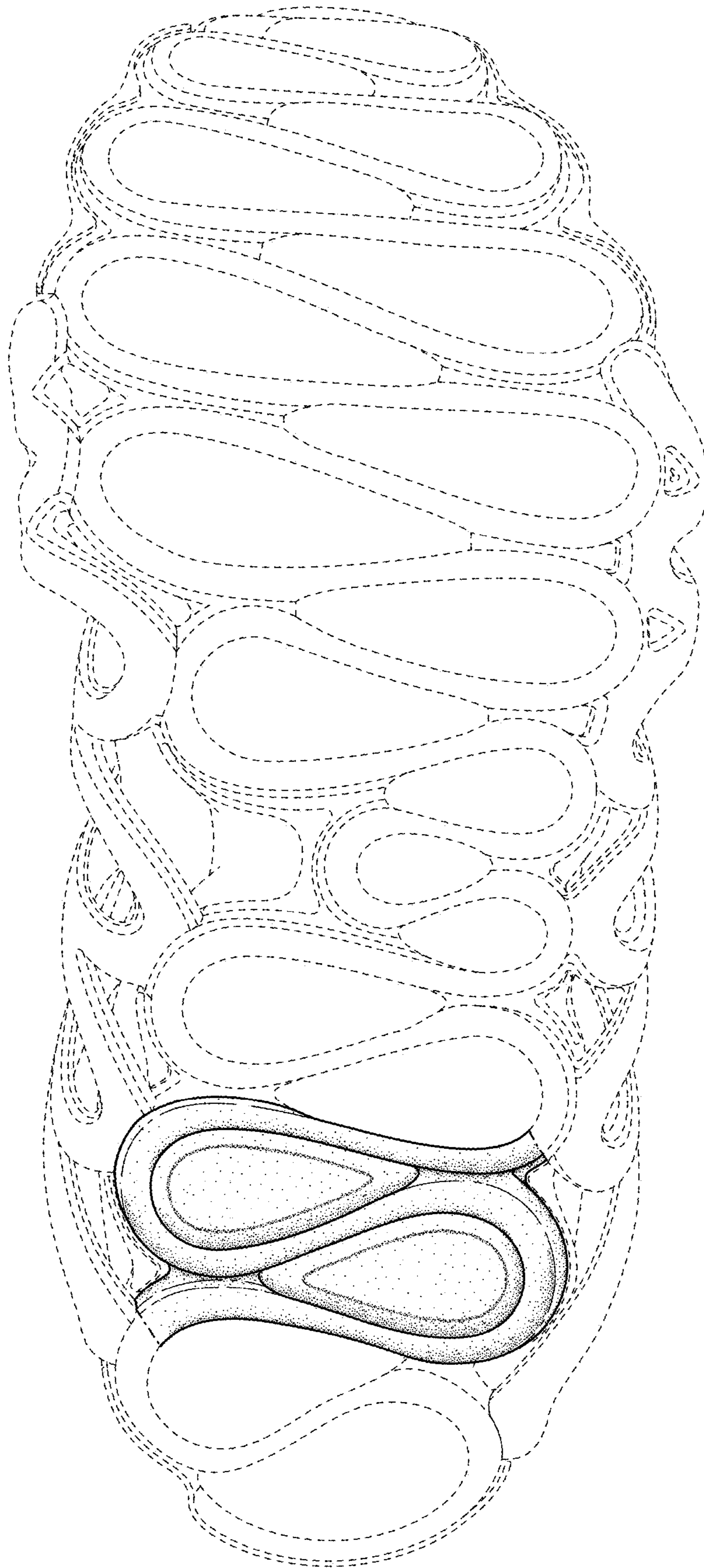
