(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear lateral top perspective view of a shoe. FIG. 2 is a lateral side view of the shoe of FIG. 1. FIG. 3 is a medial side view of the shoe of FIG. 1. FIG. 4 is a front view of the shoe of FIG. 1. FIG. 5 is a rear view of the shoe of FIG. 1. FIG. 6 is a top view of the shoe of FIG. 1; and, FIG. 7 is a bottom view of the shoe of FIG. 1. The broken lines show portions of the shoe that form no part of the claimed design.

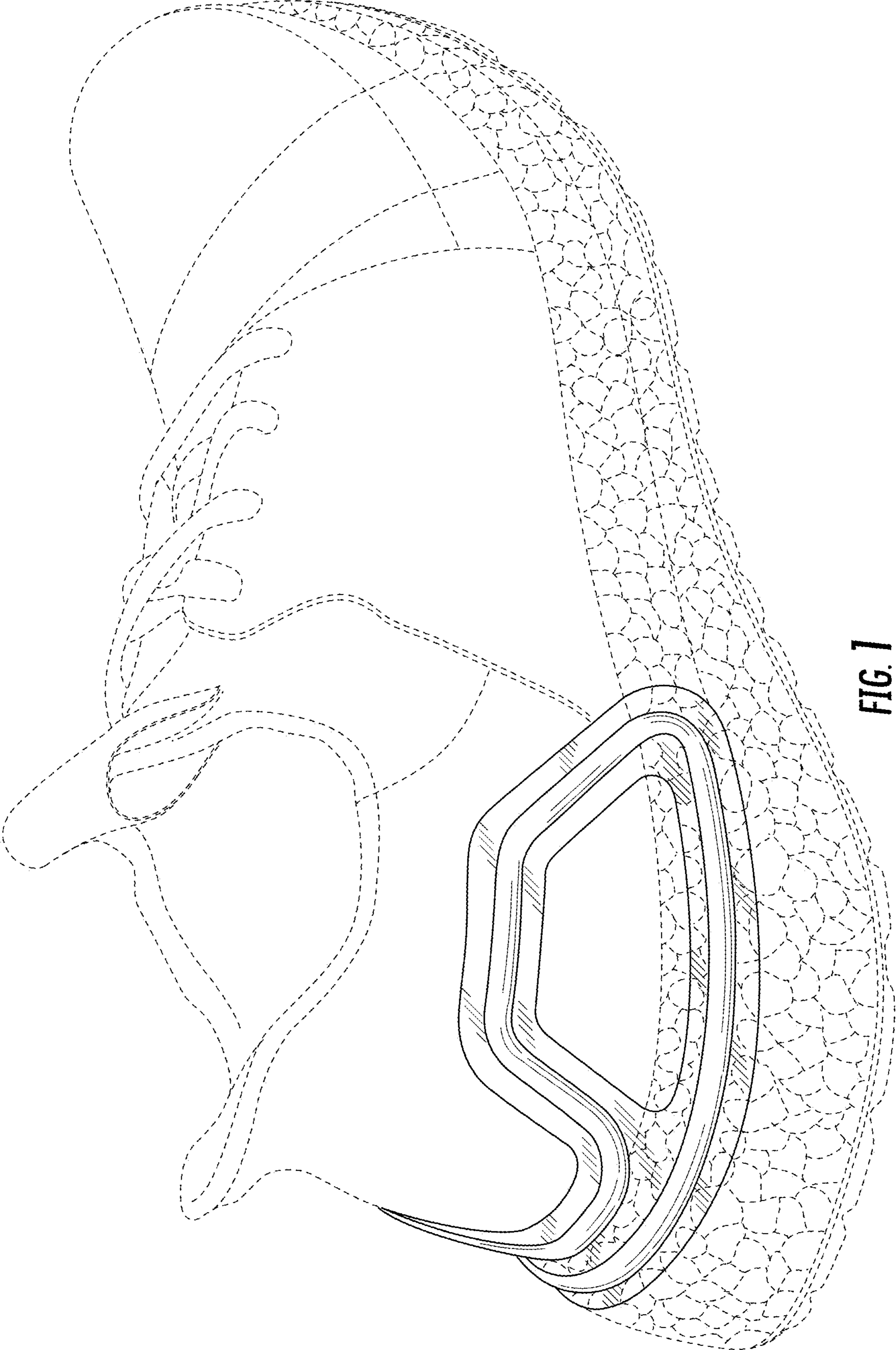

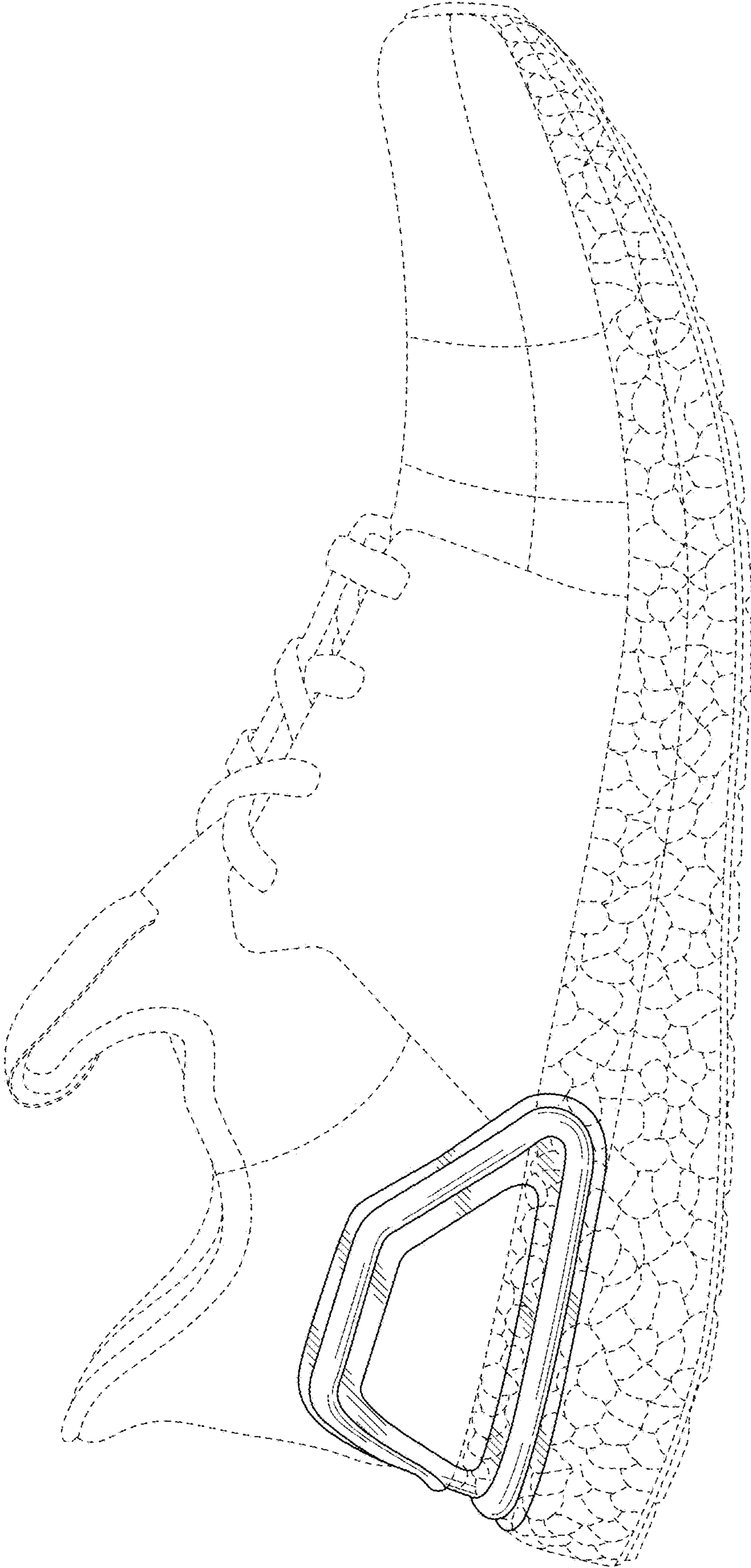

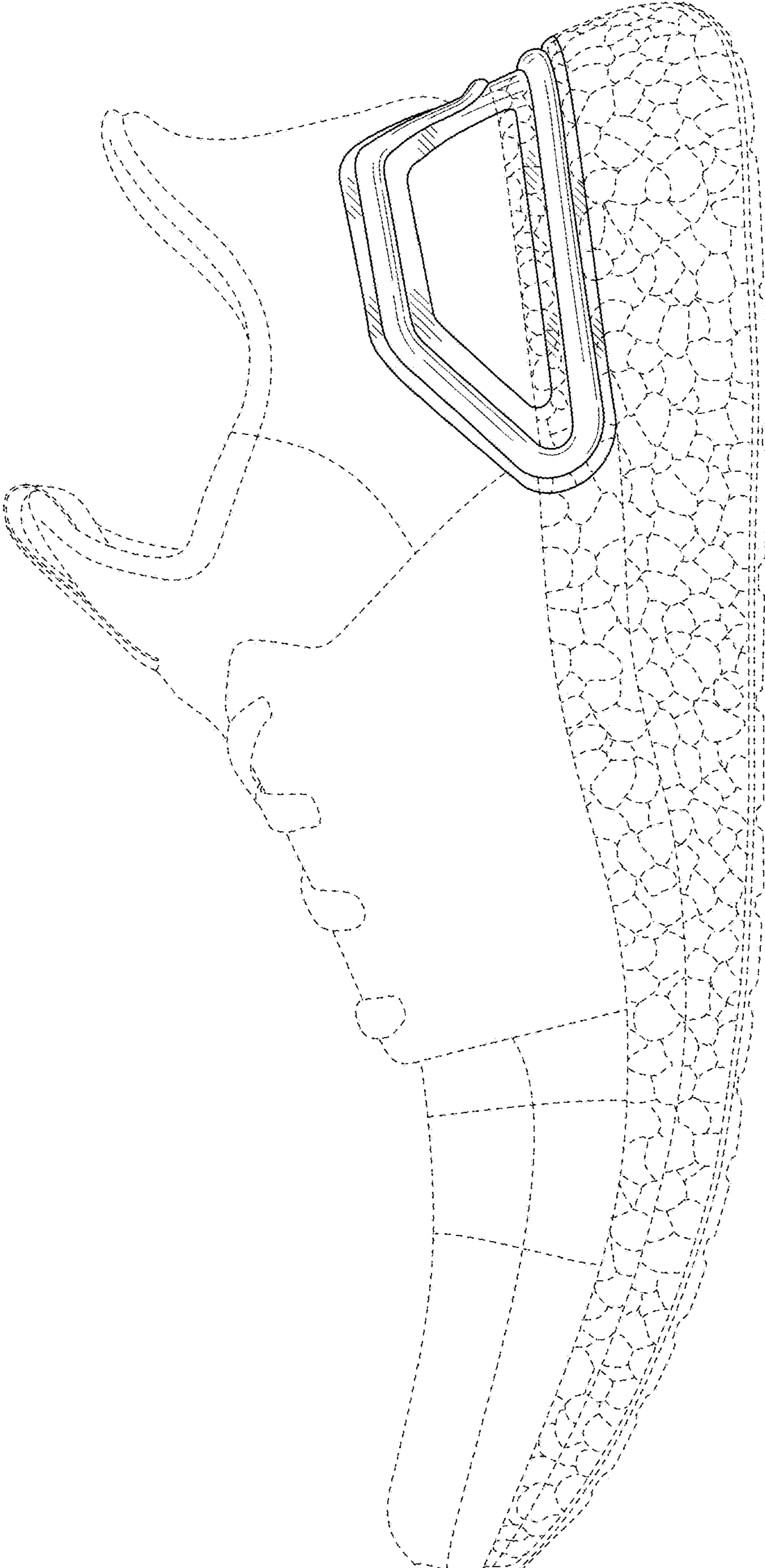
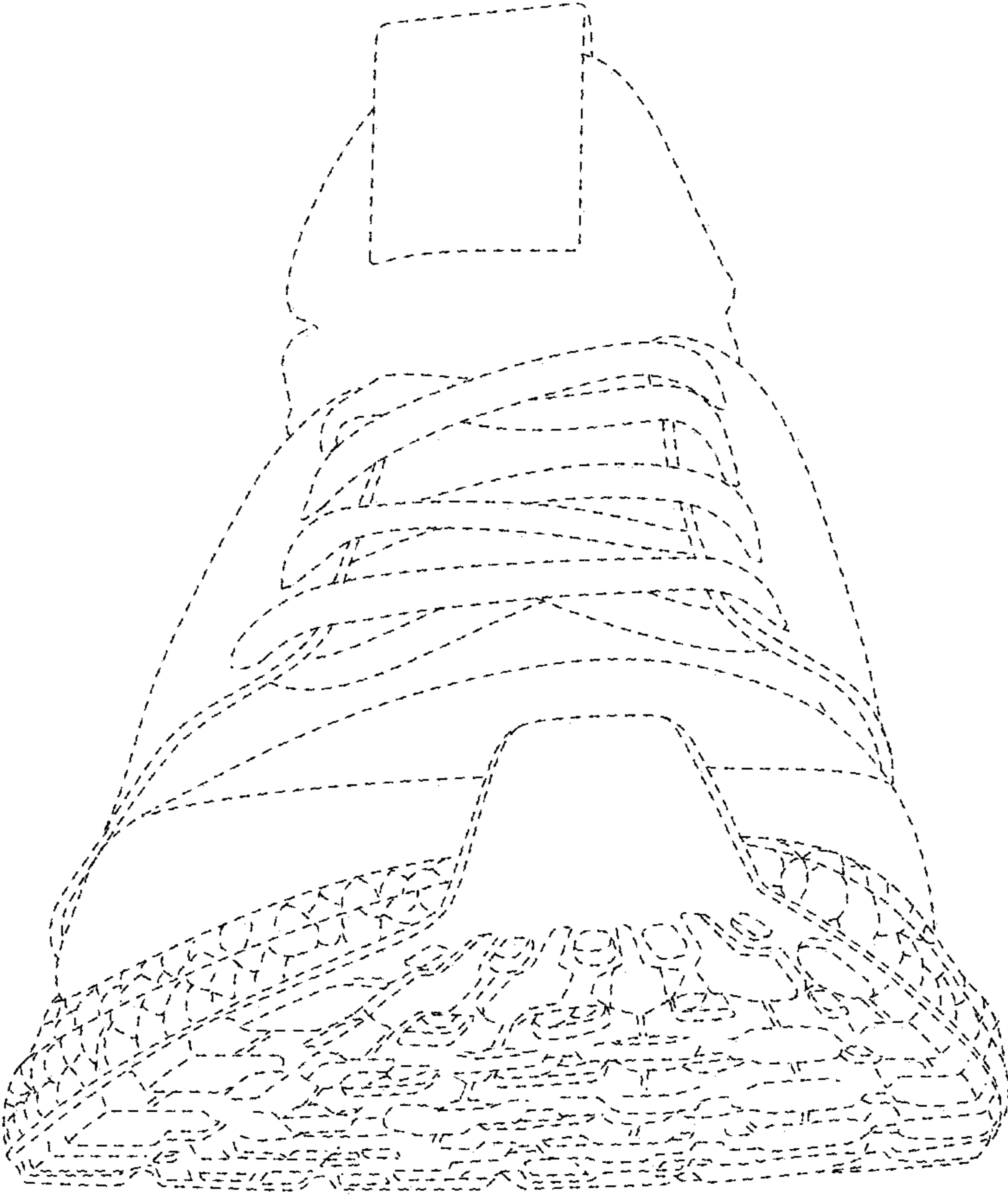

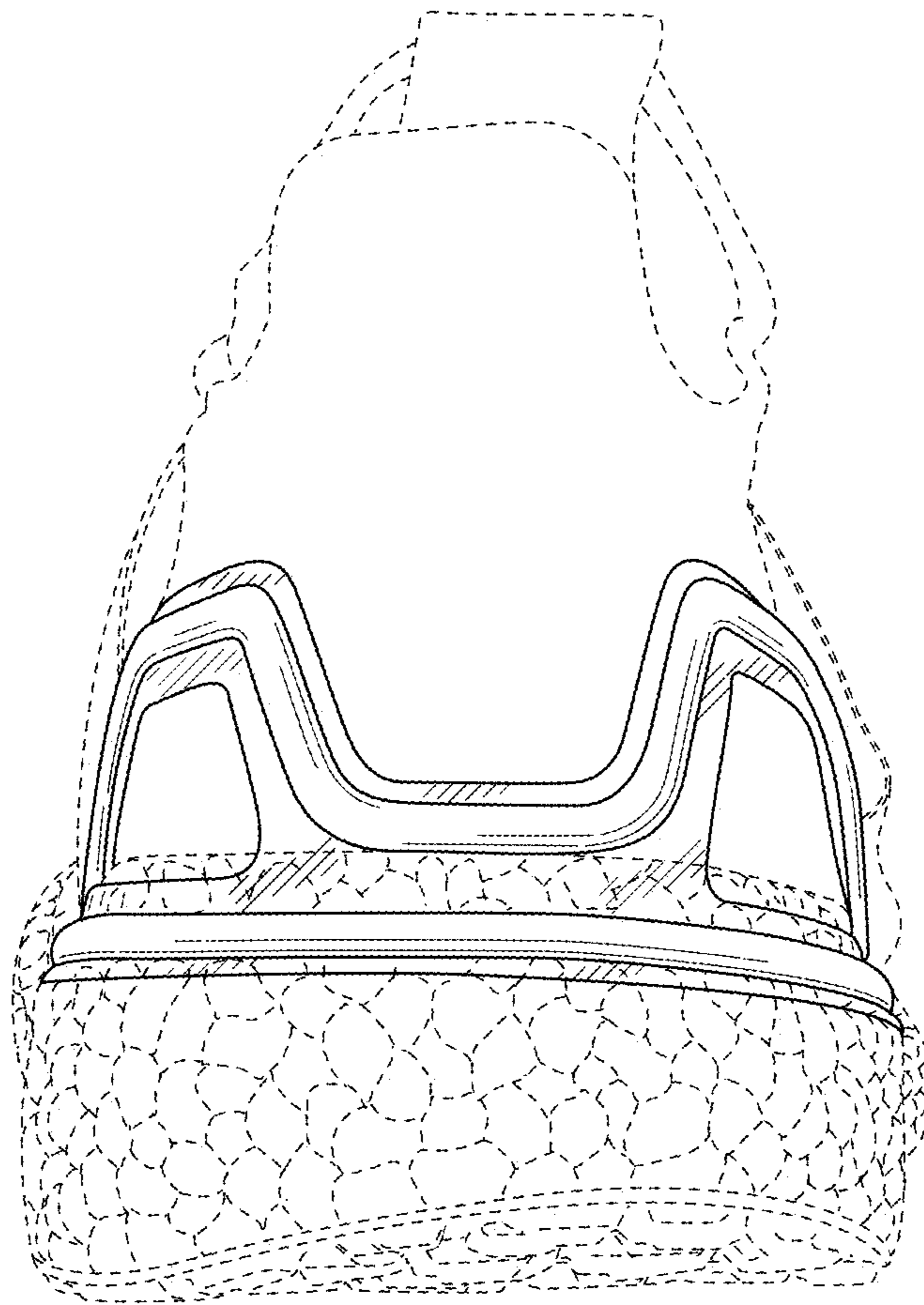

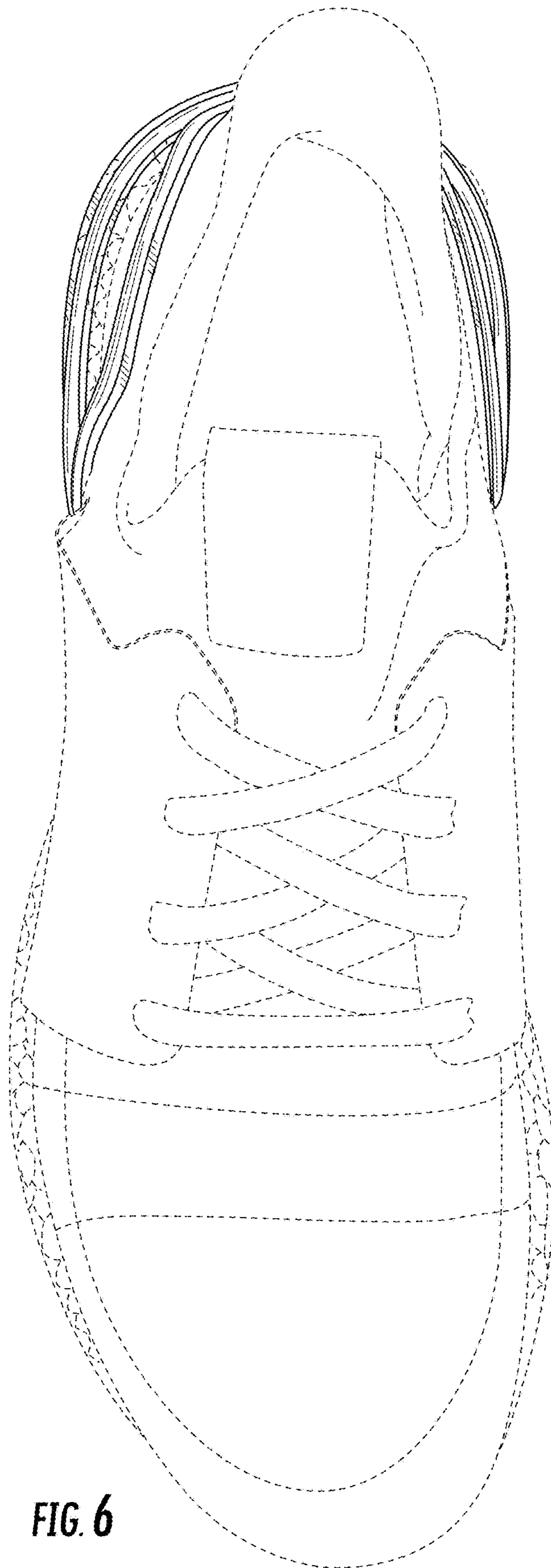

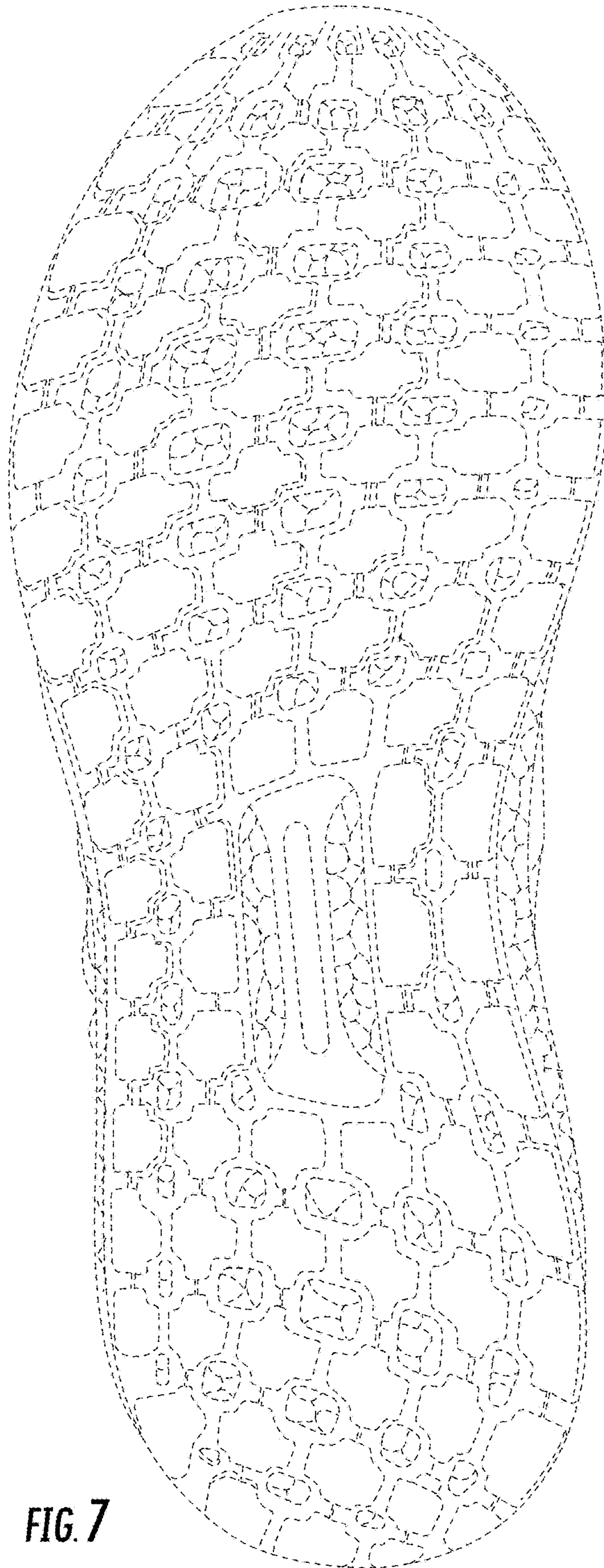
