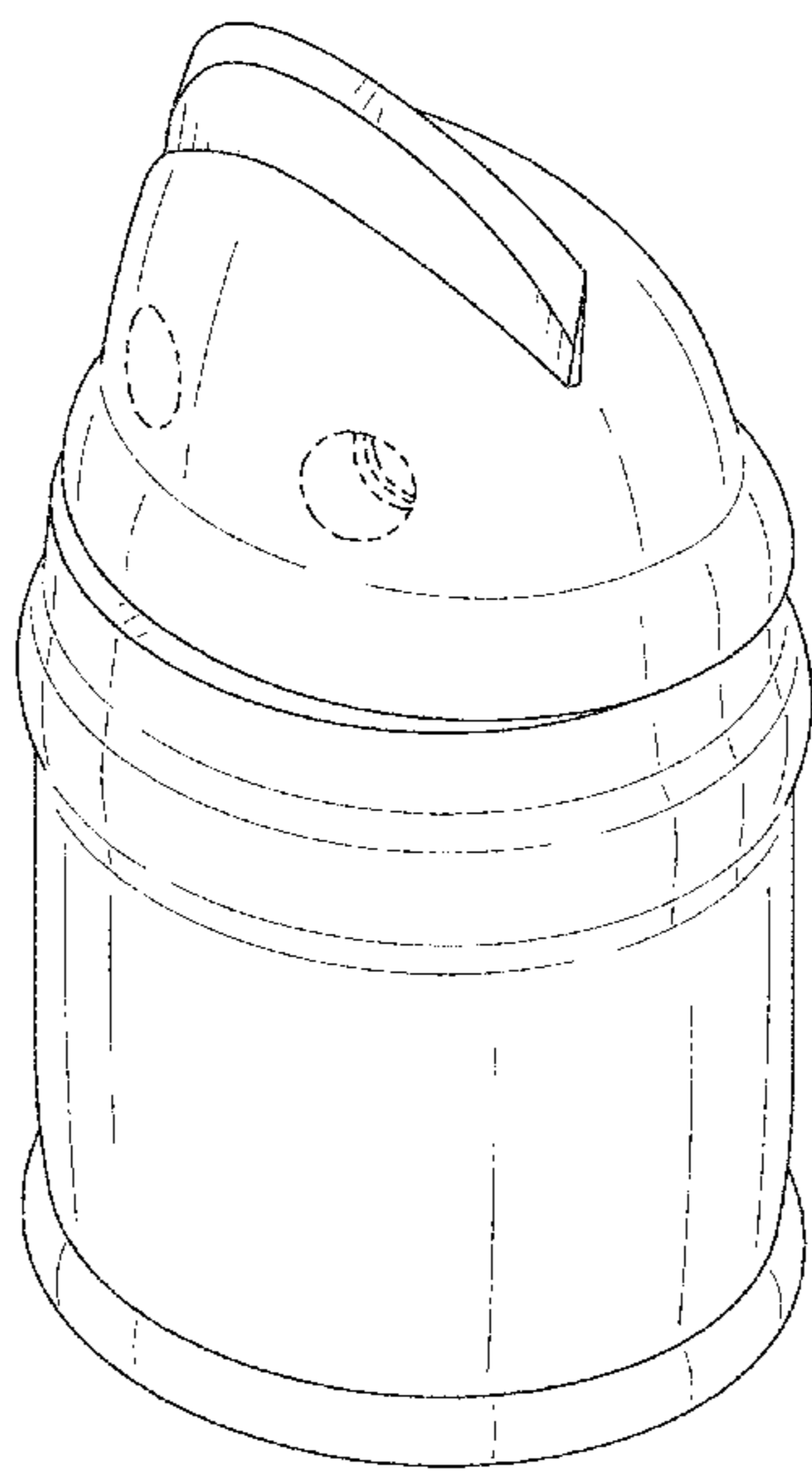

FIG. 1 is a front, right side, top perspective view of a silicone thumb knife showing my new design;  
FIG. 2 is a rear, left side, bottom perspective view thereof;

FIG. 5 is a left side elevational view thereof;

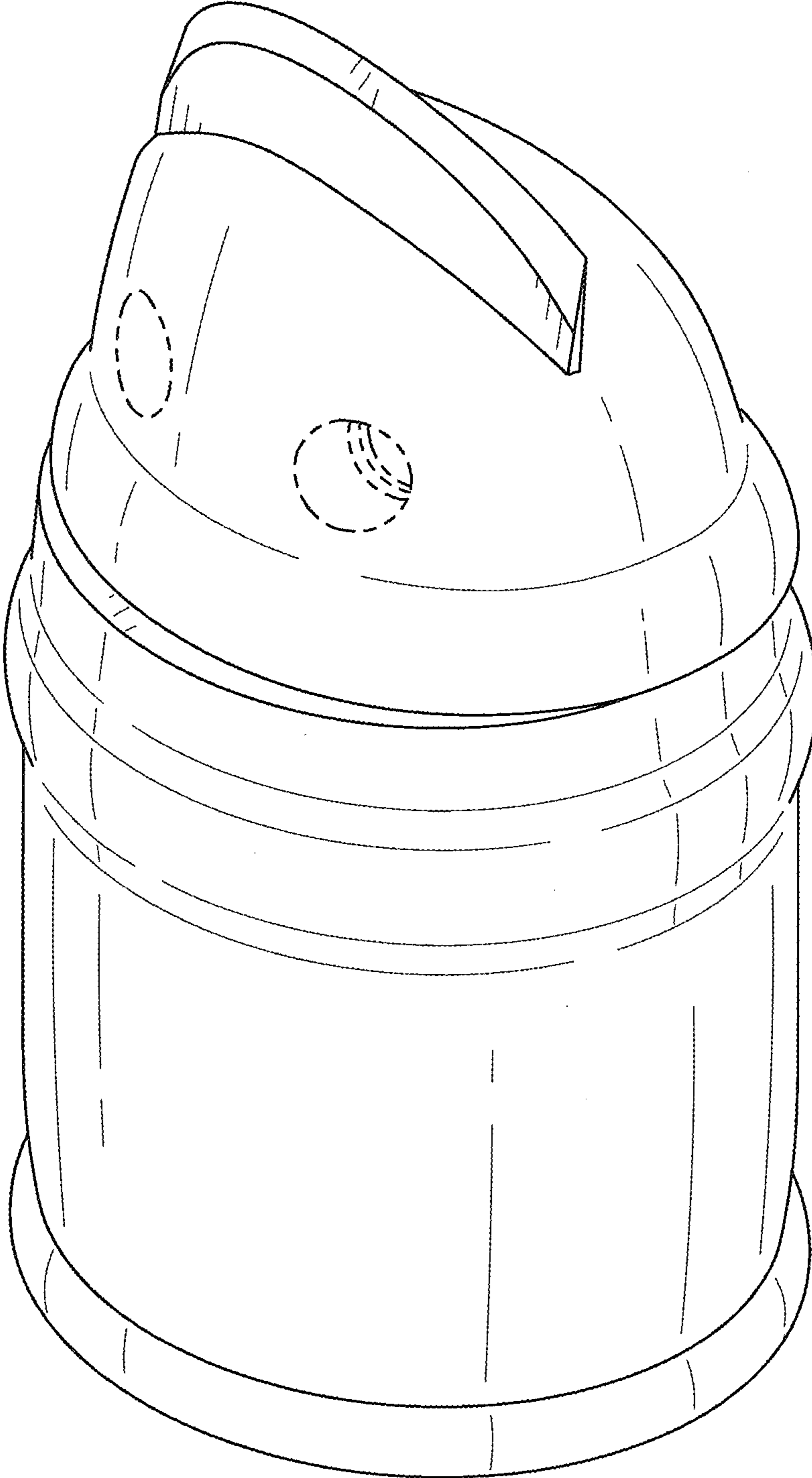

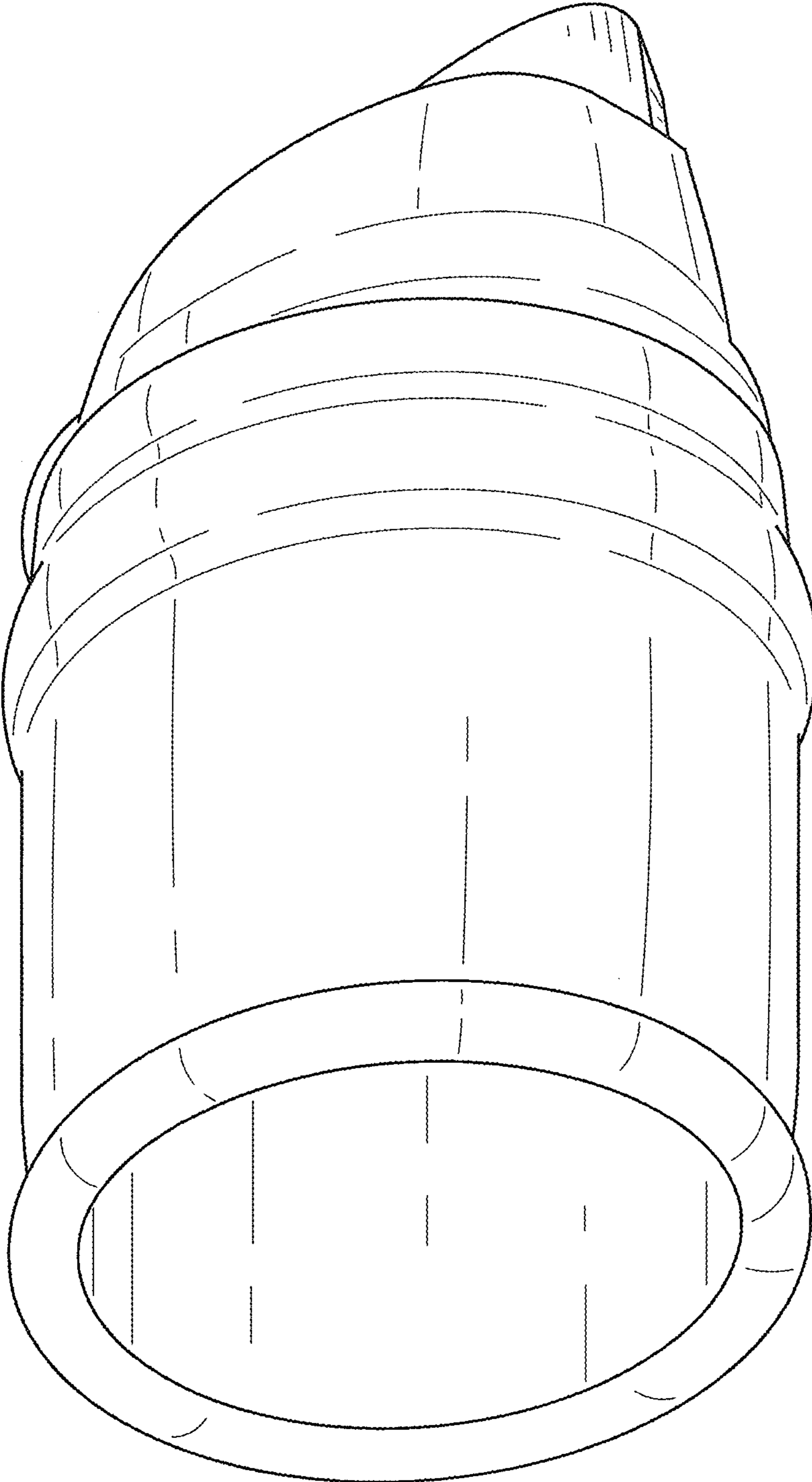

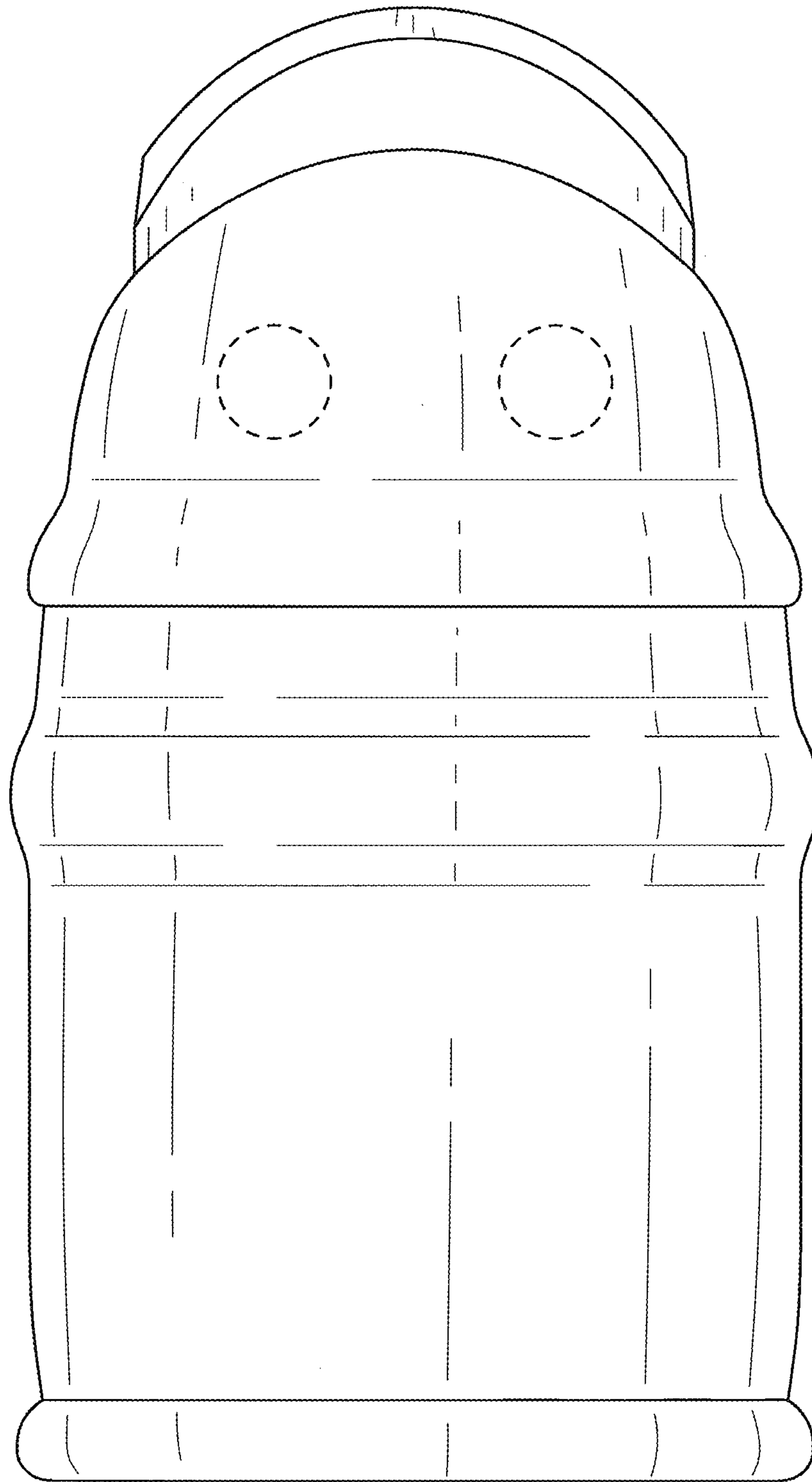

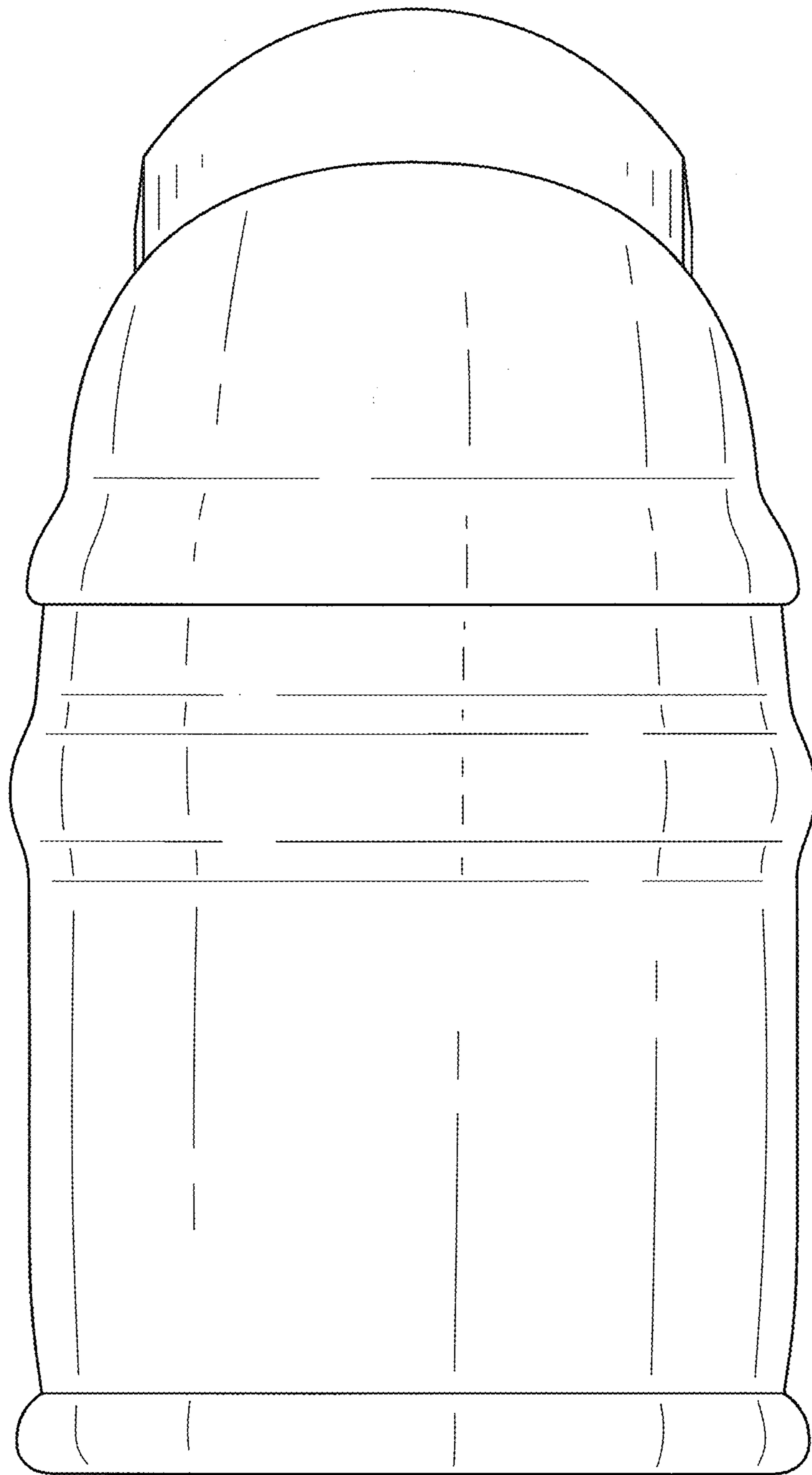

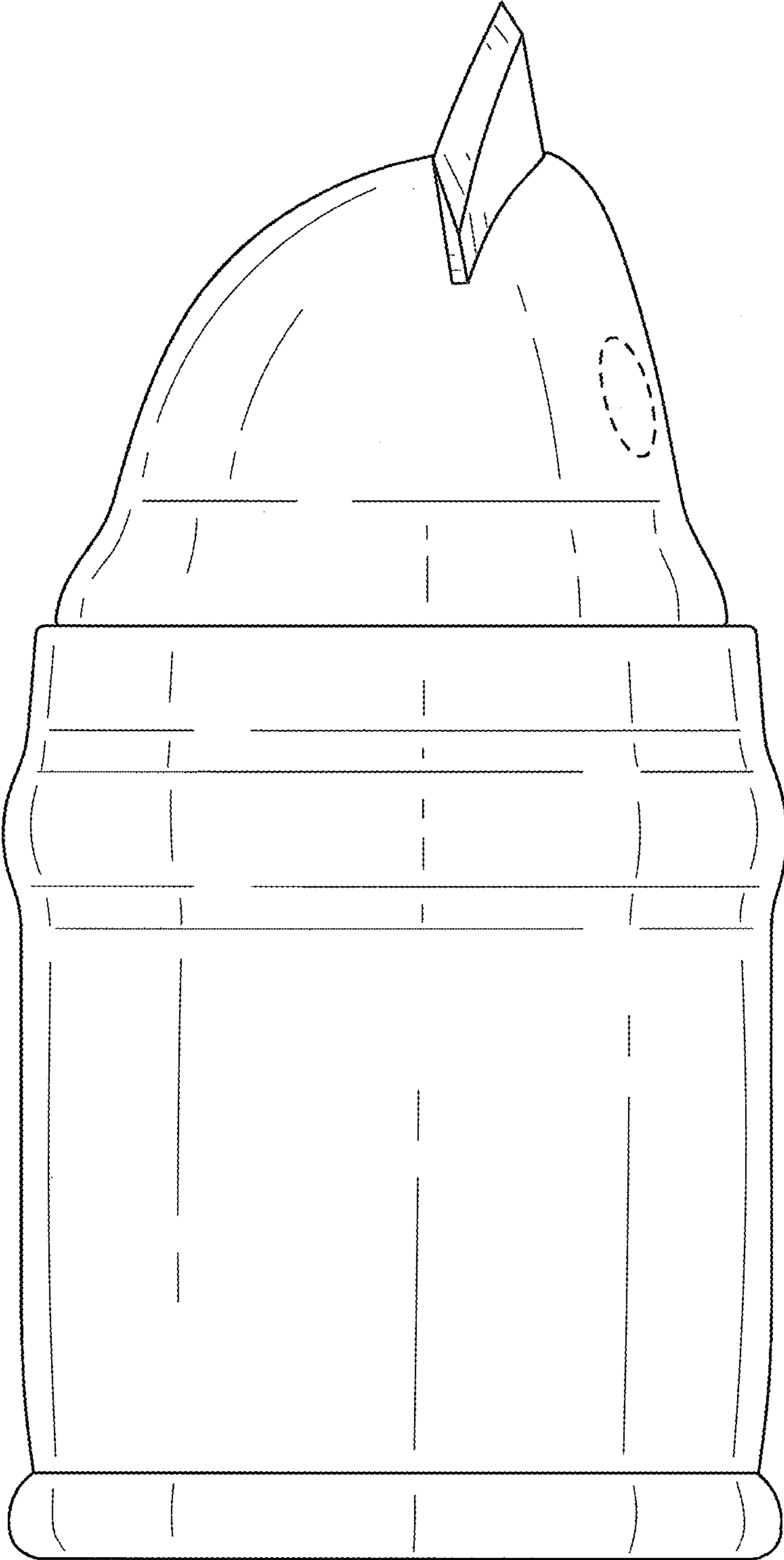

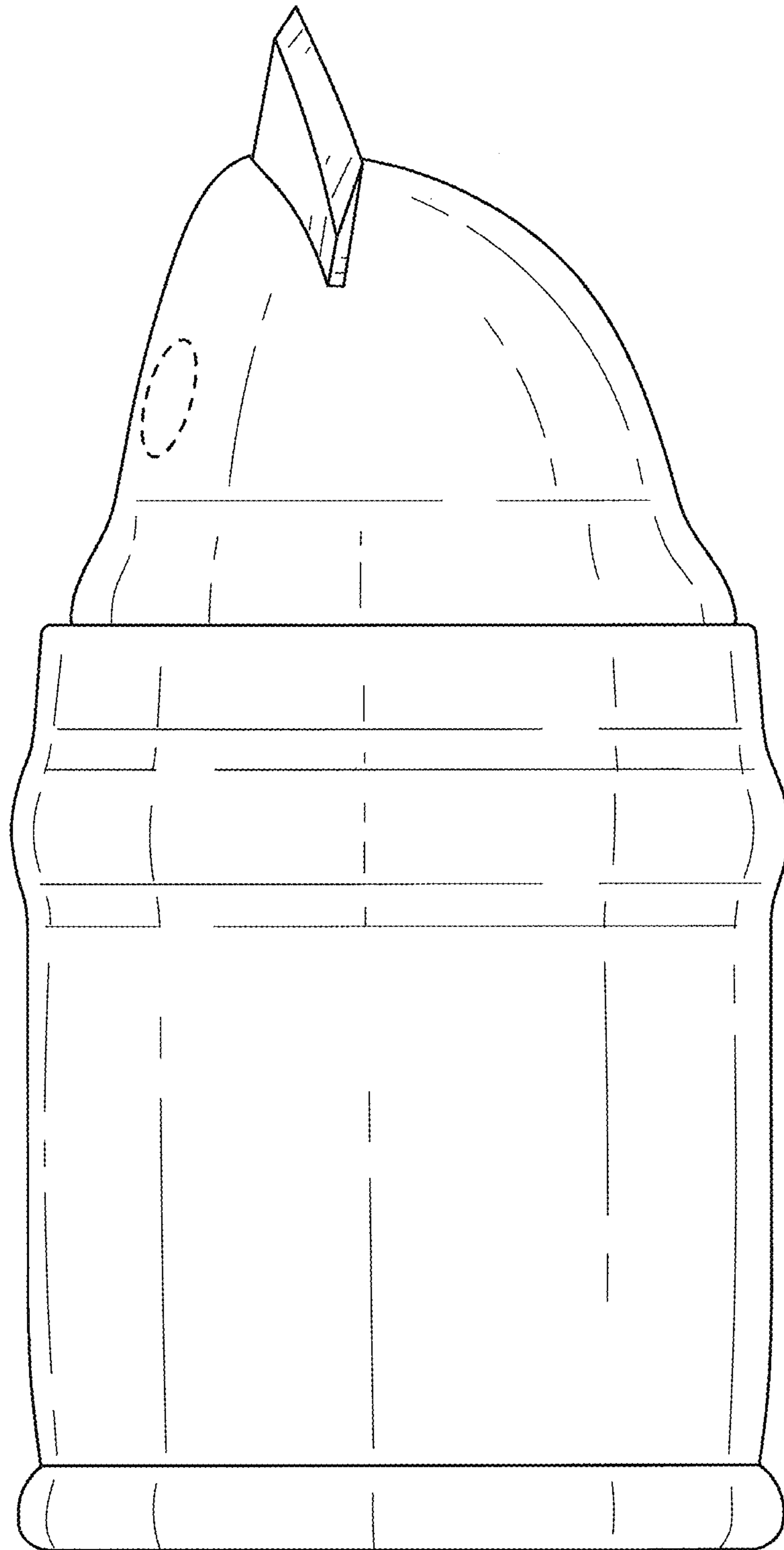

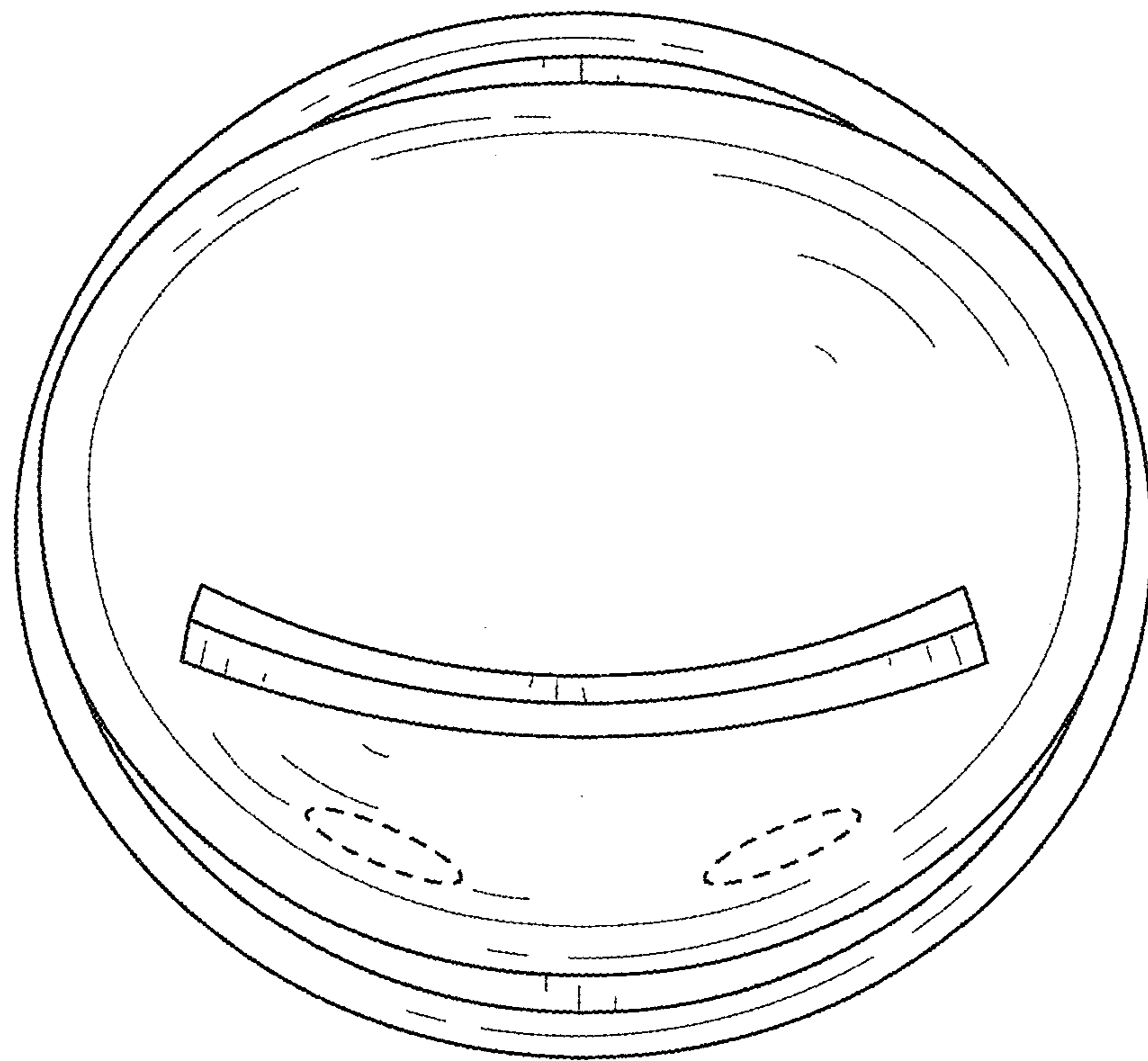

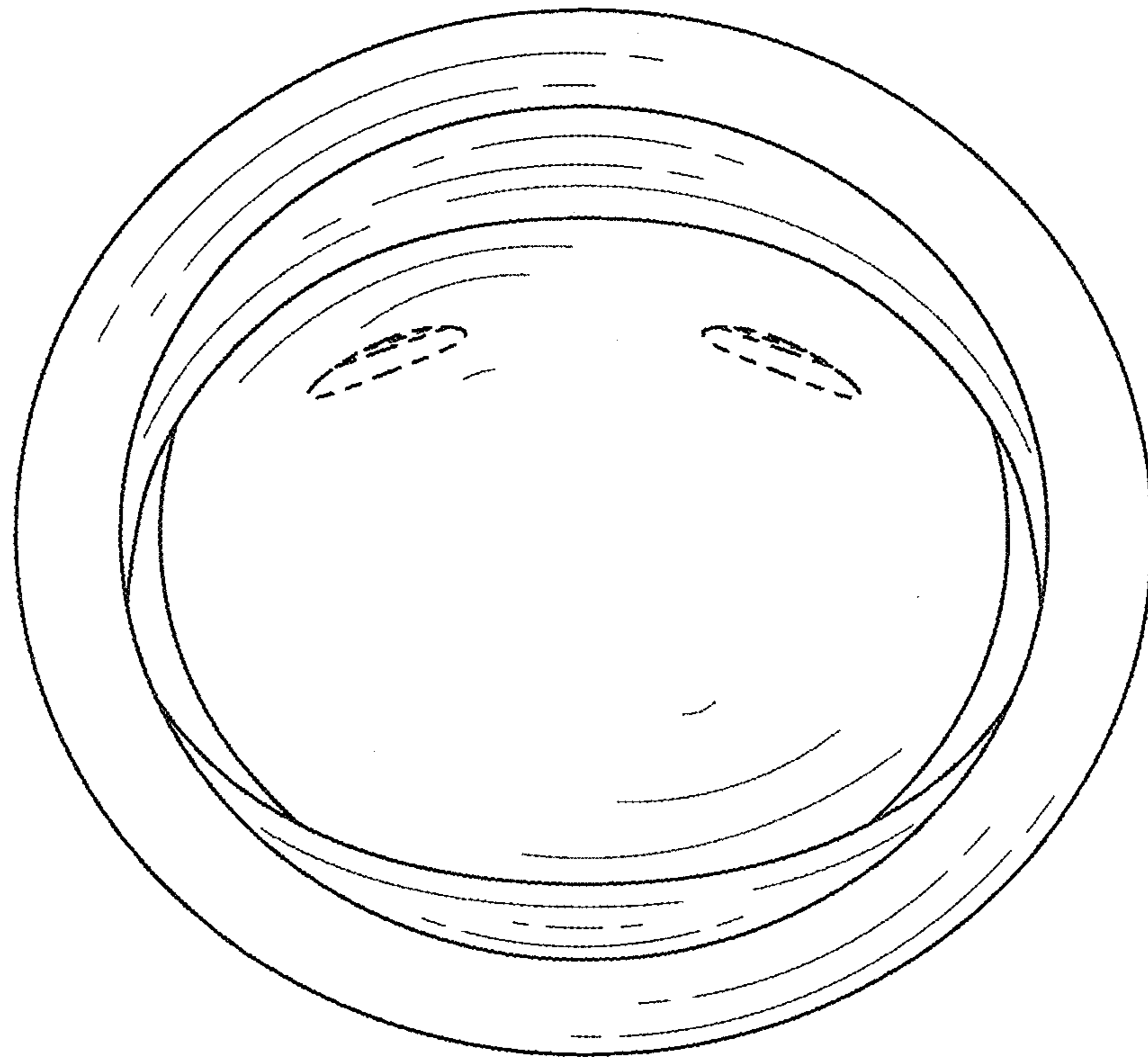
