FIG. 1 shows the top, back, right side perspective view of a track engaging cable hanger.

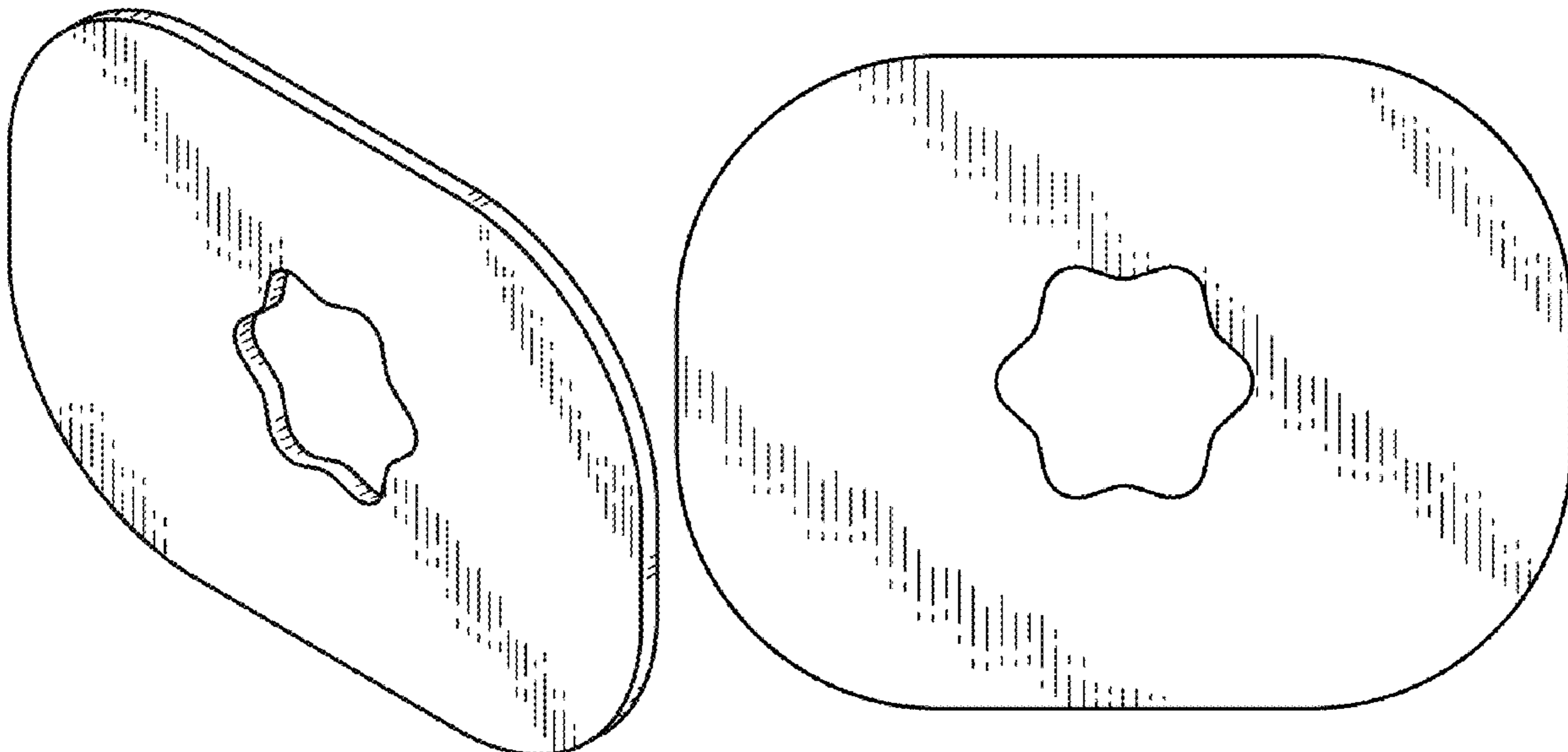
FIG. 2 shows the bottom, front, left side perspective view thereof.

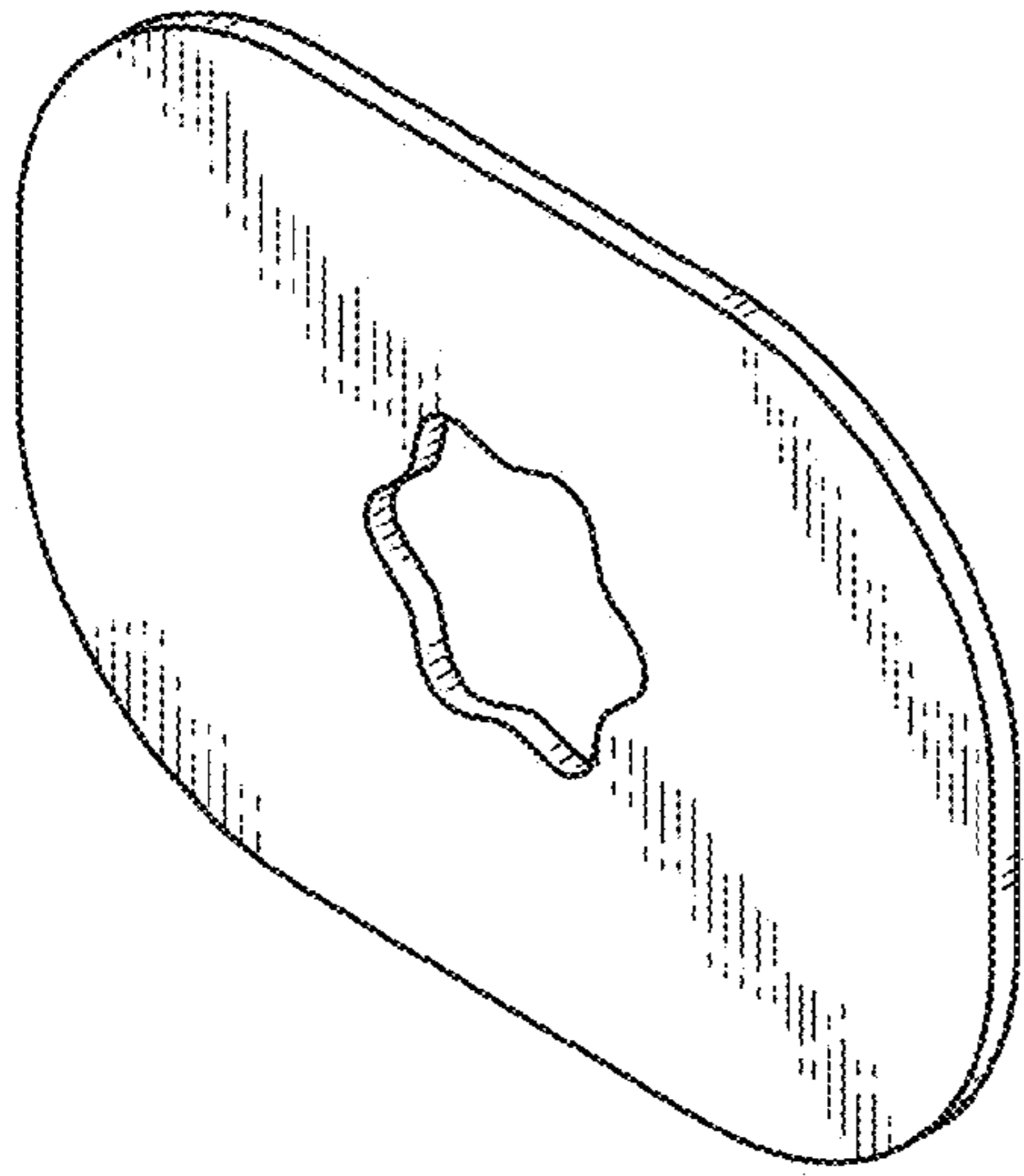

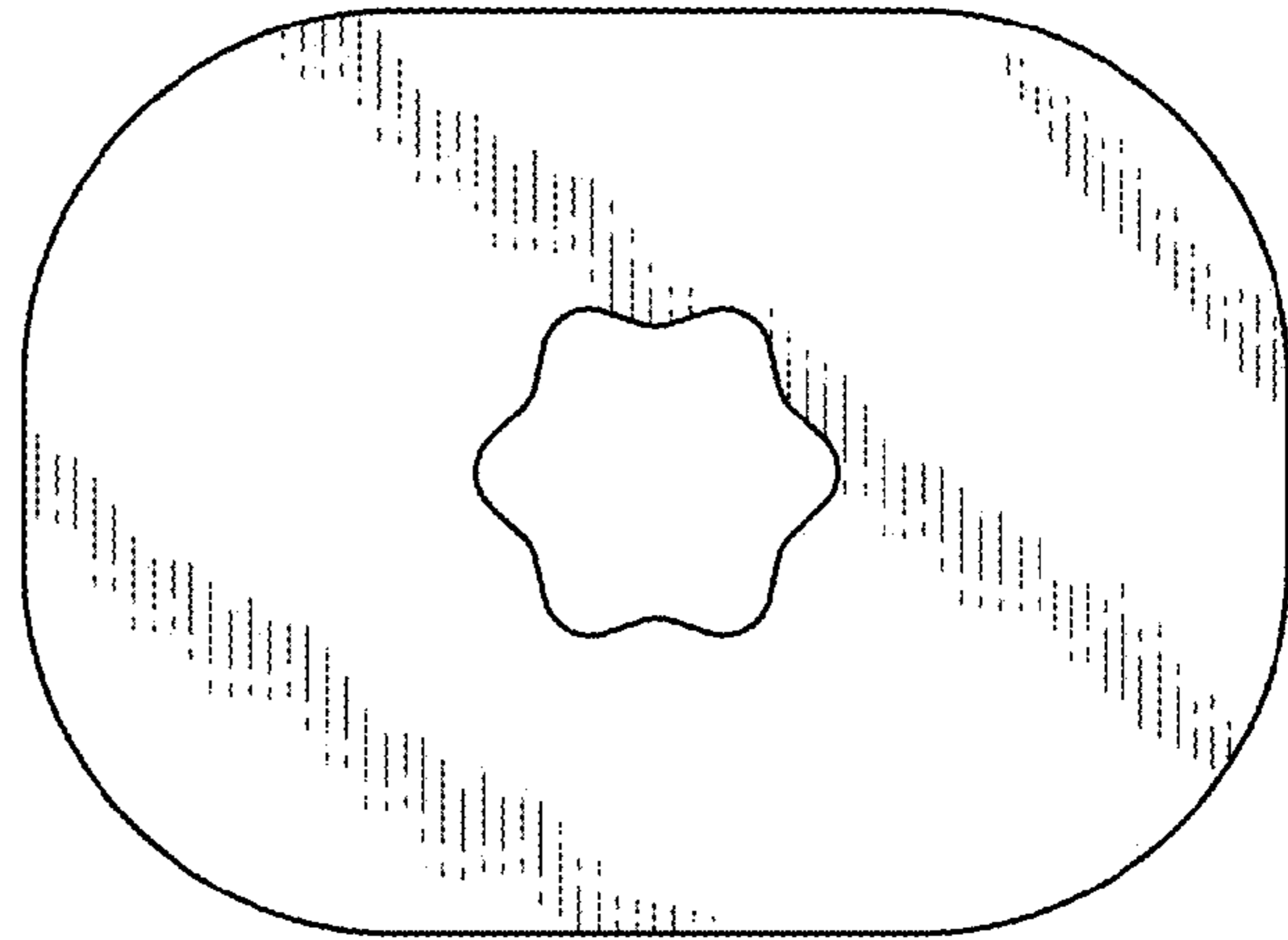

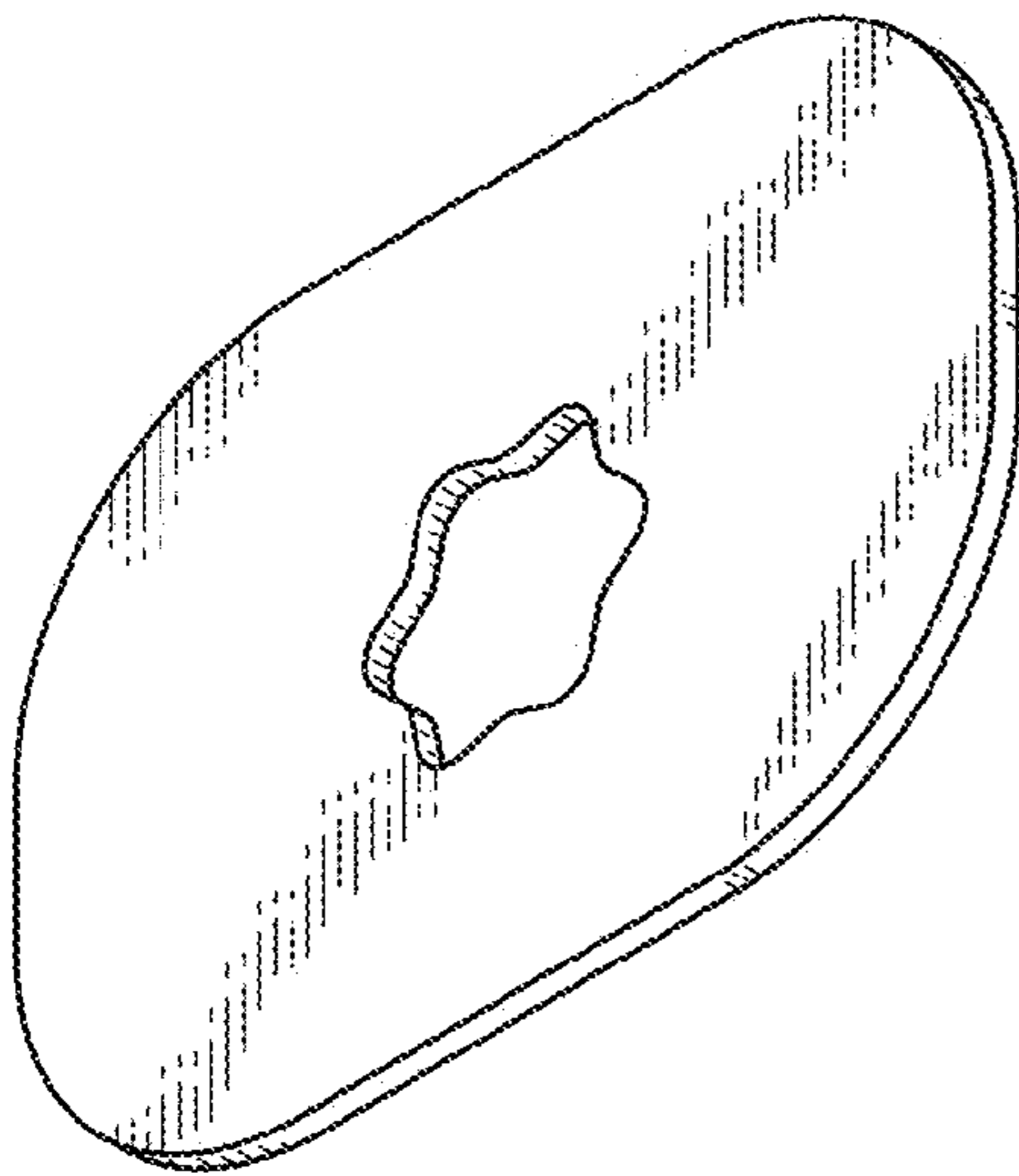

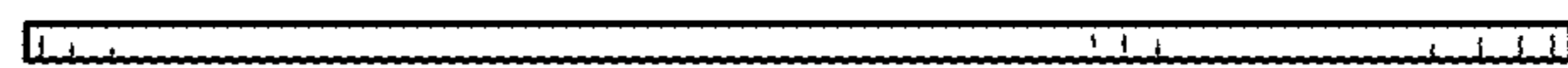
