FIG. 4 is an underside perspective view of the vehicle inspection lane floor insert;

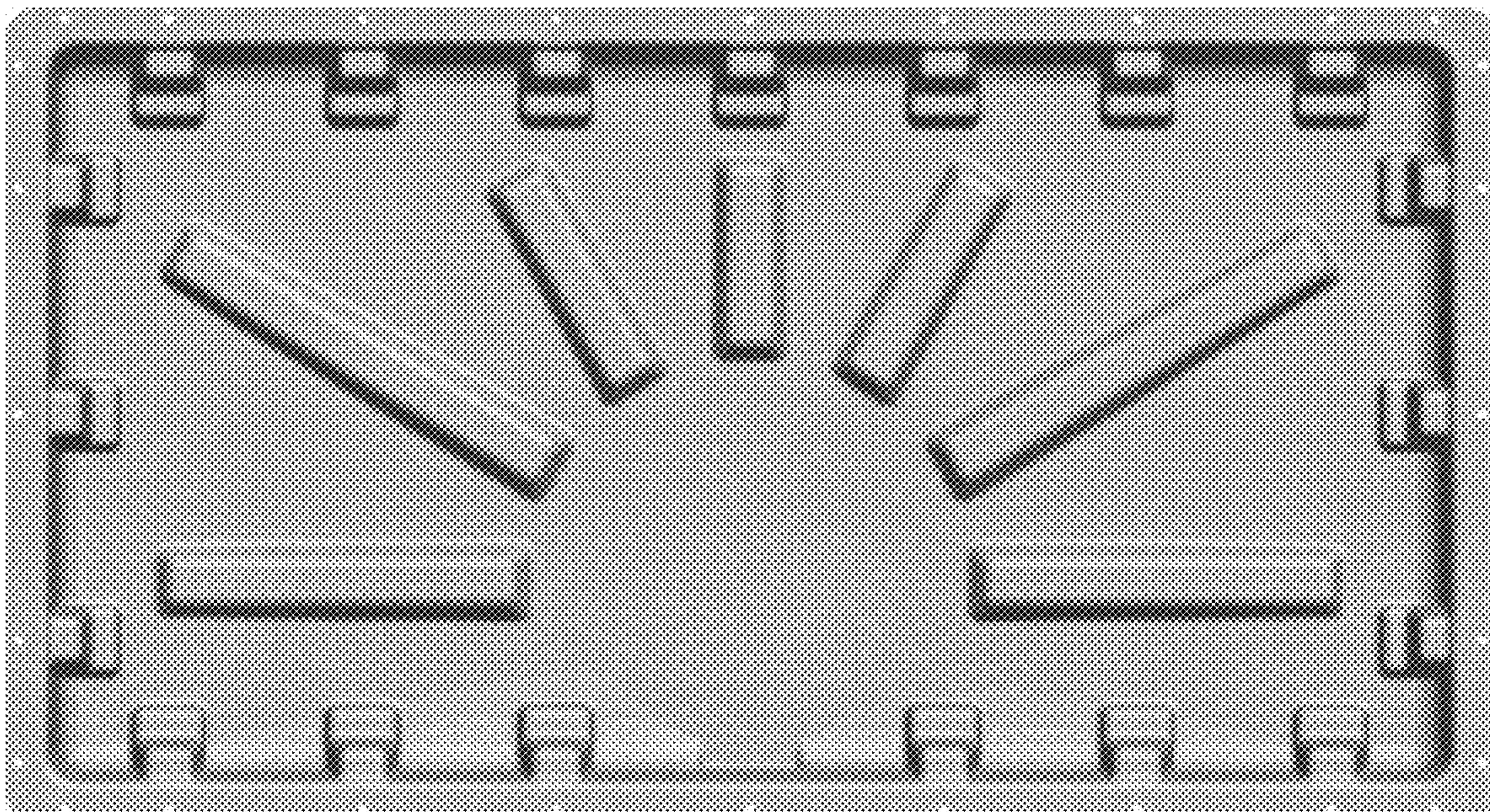
FIG. 5 is a front view of the vehicle inspection lane floor insert;

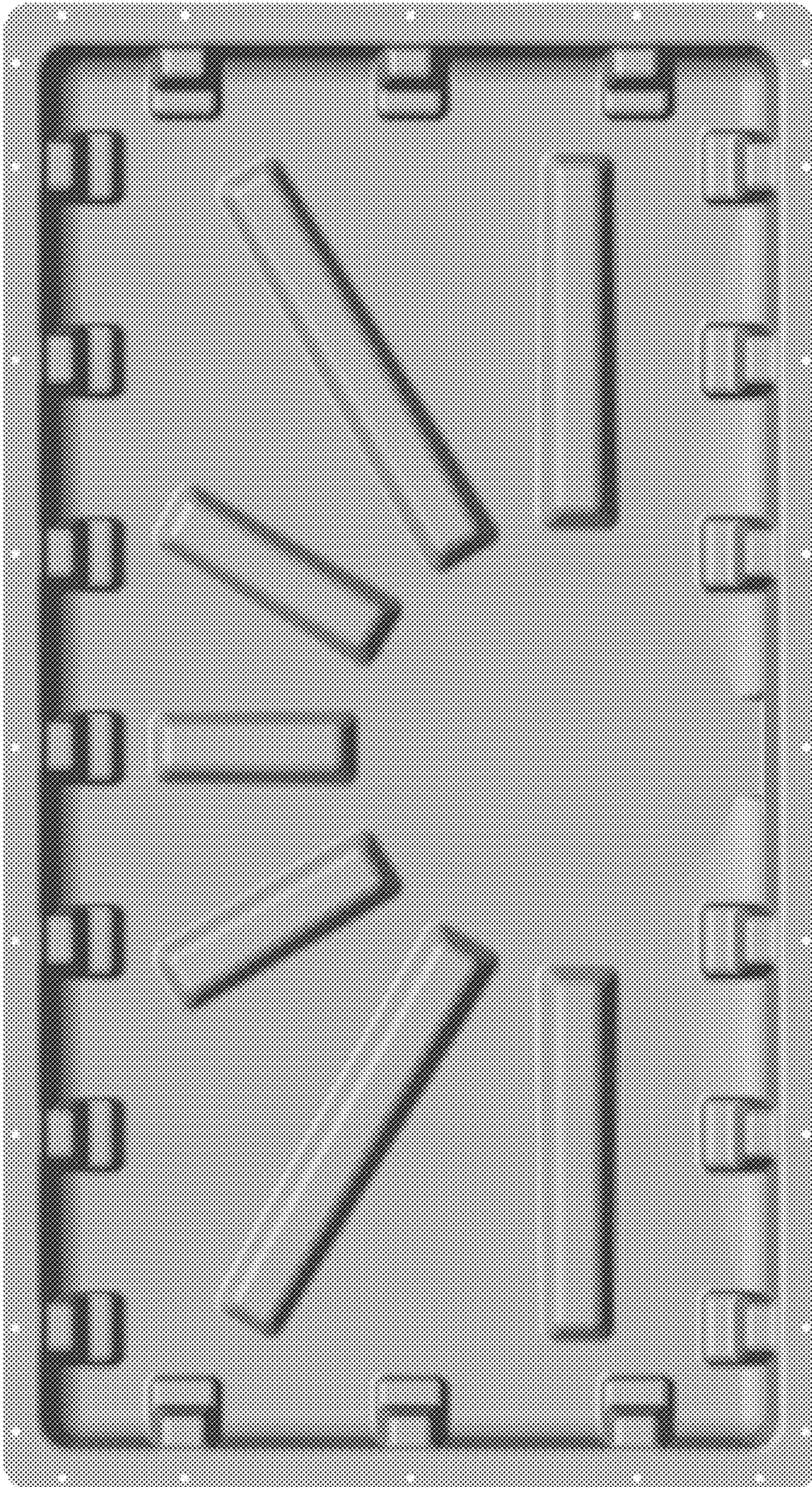

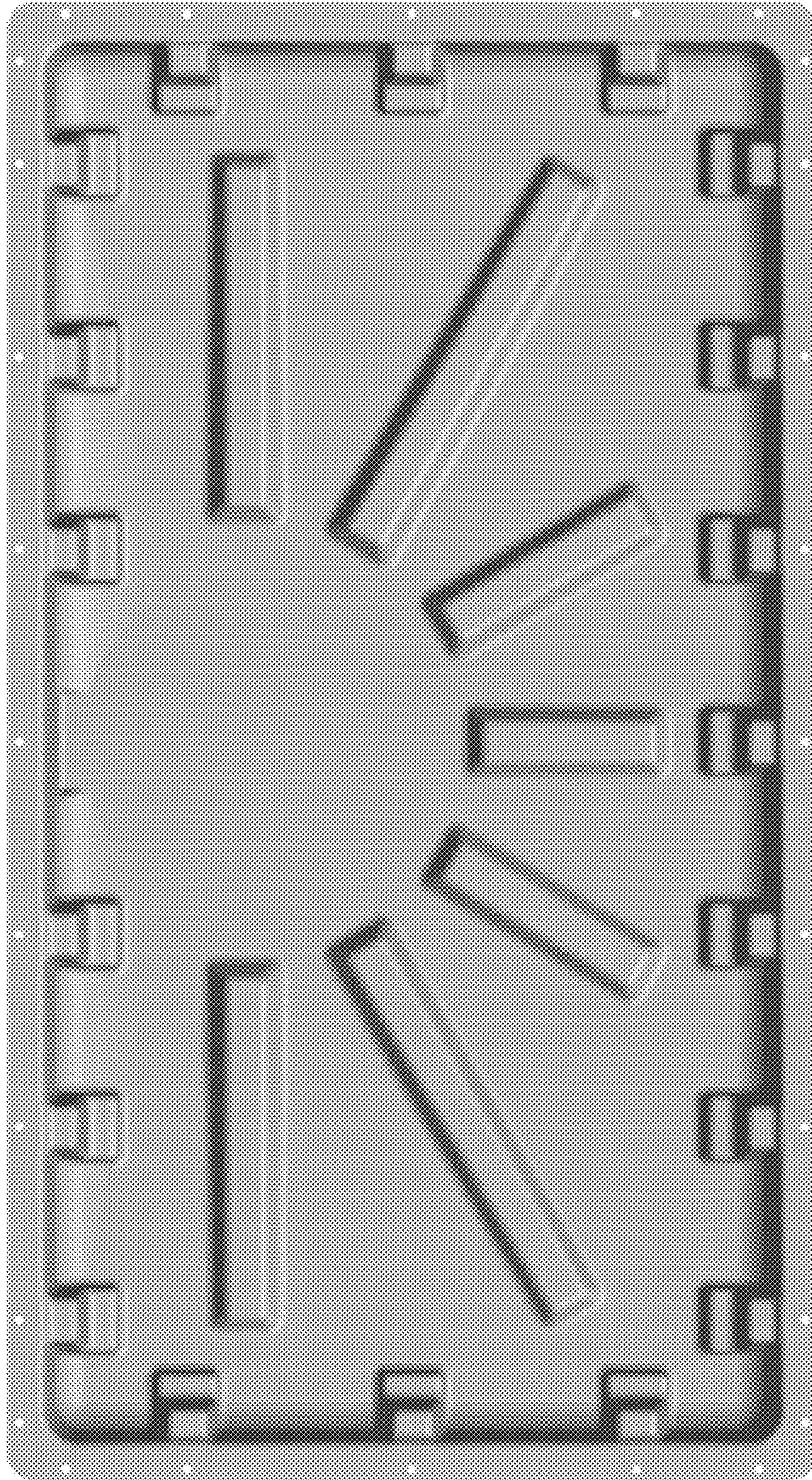

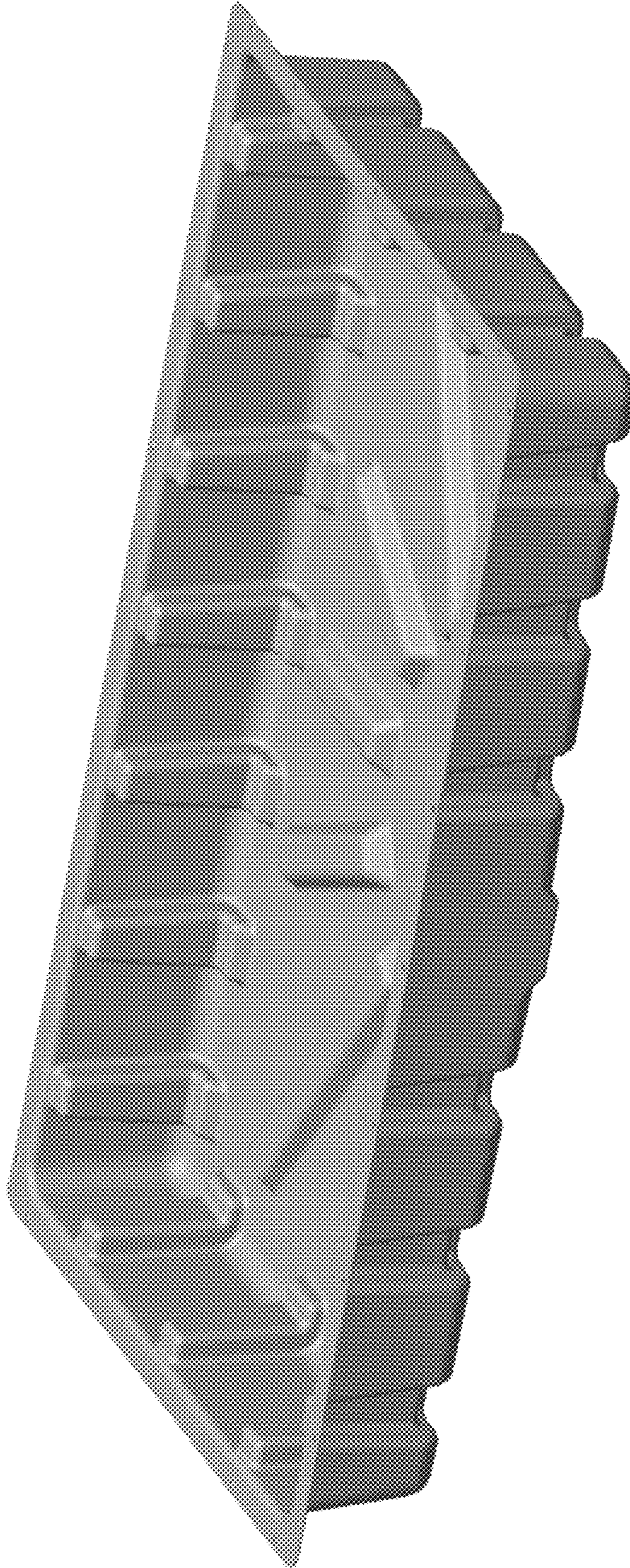

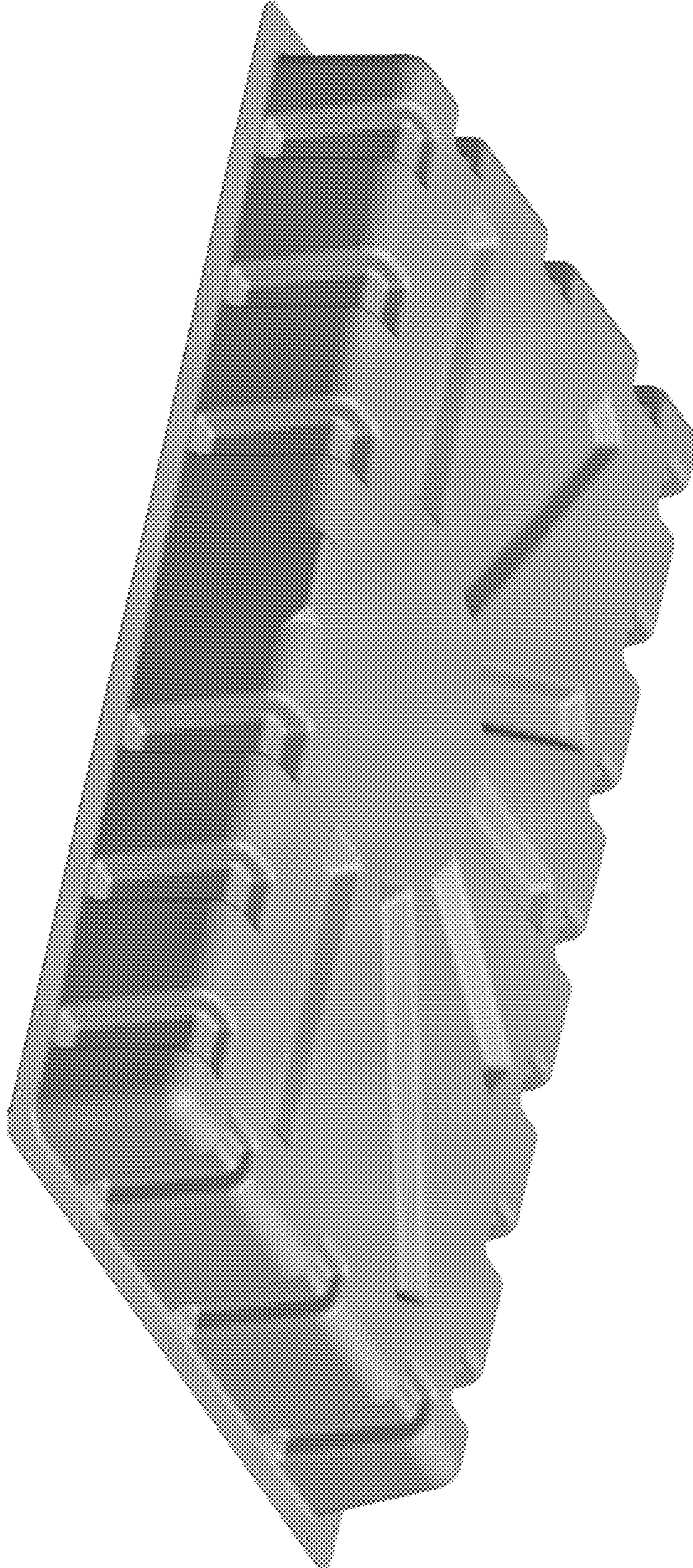

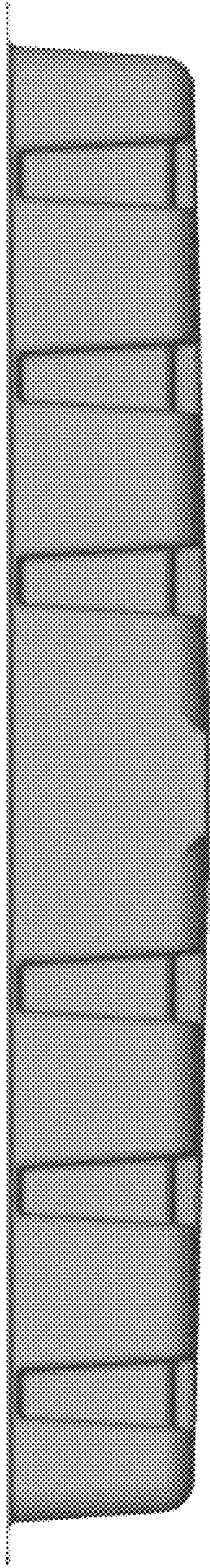

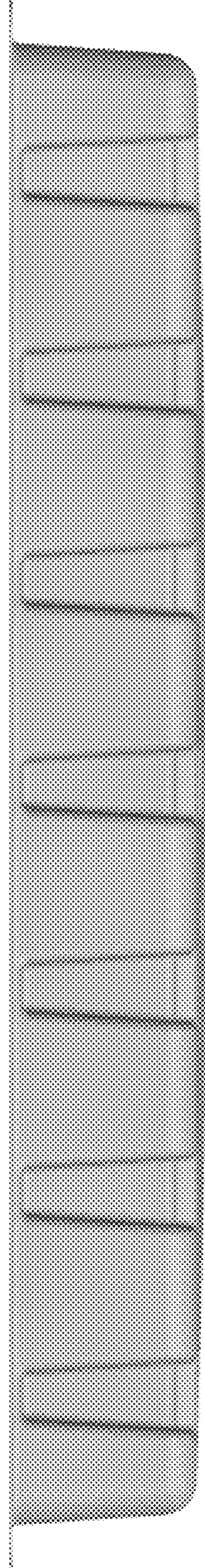

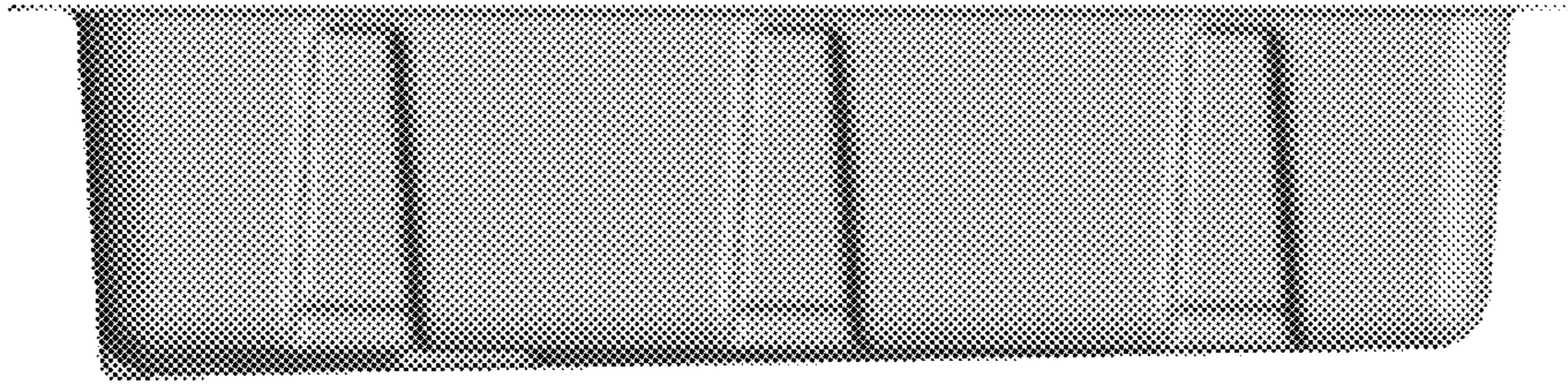

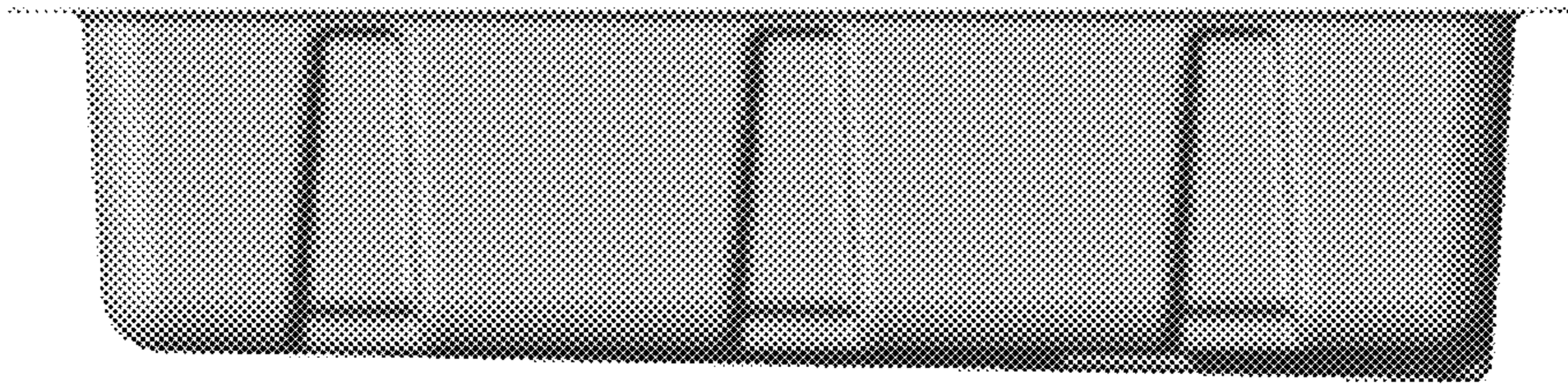
