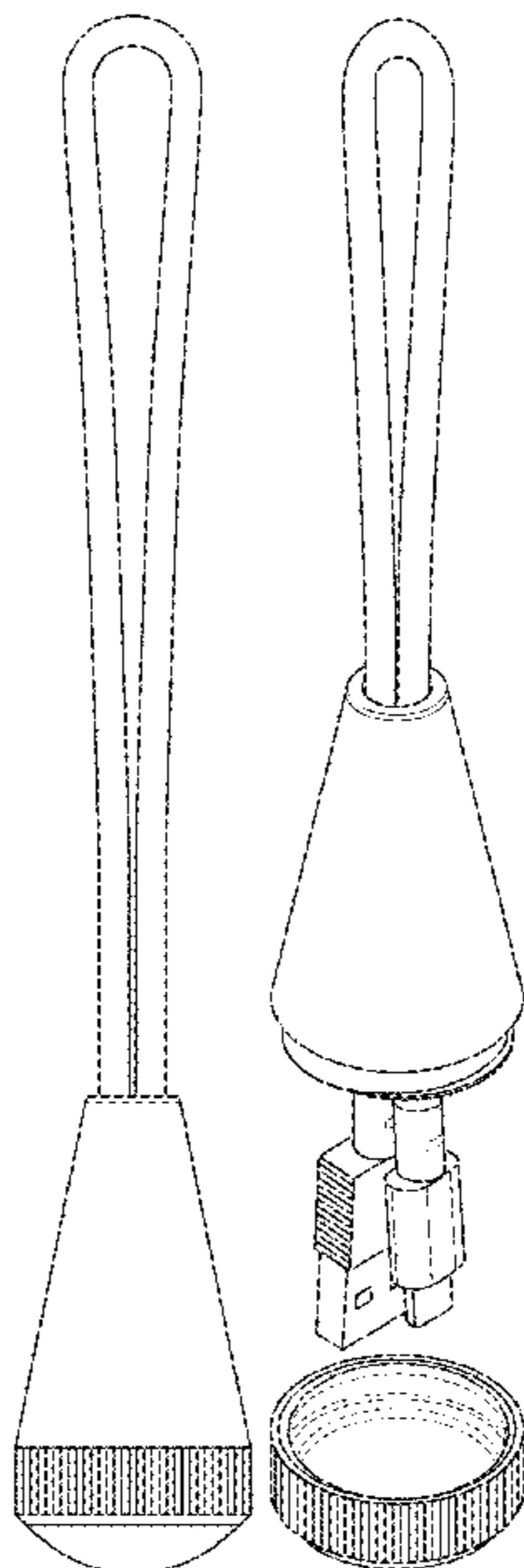
(57) **CLAIM**

The ornamental design for a charging cable, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a charging cable, showing my new design;  
FIG. 2 is a back elevation view thereof;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a front, top, left perspective view thereof; and,  
FIG. 8 is a front, top, left perspective view of the charging cable of FIG. 1, shown in an open configuration.  
The equal-length broken lines in the drawings depict portions of the charging cable that form no part of the claimed design.

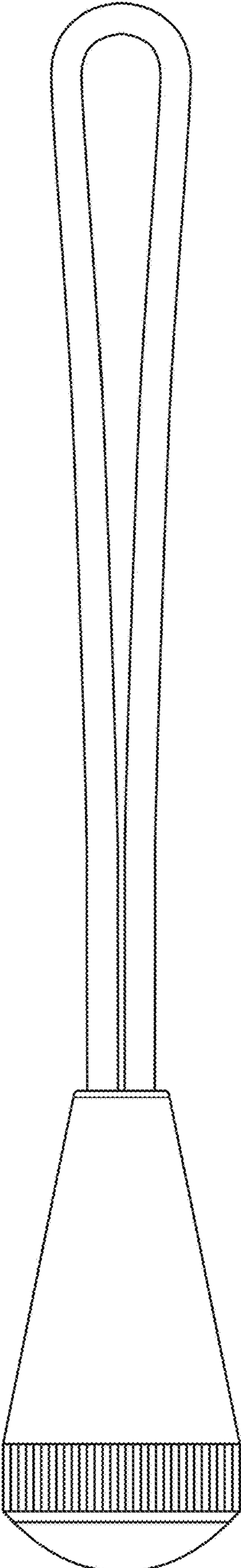

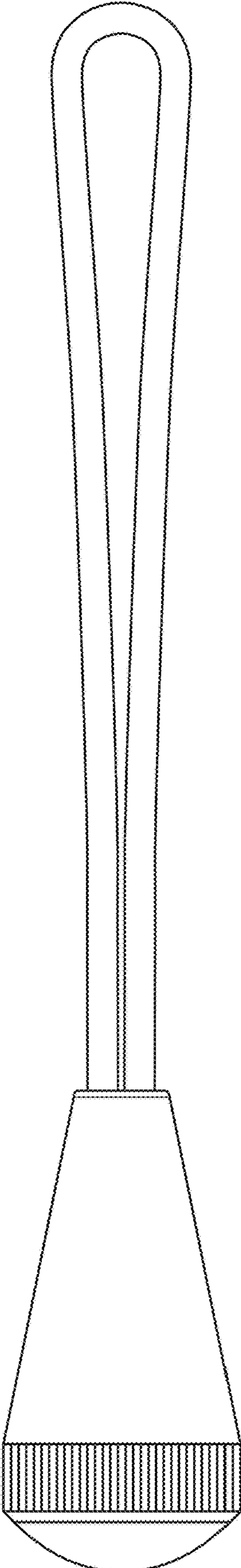

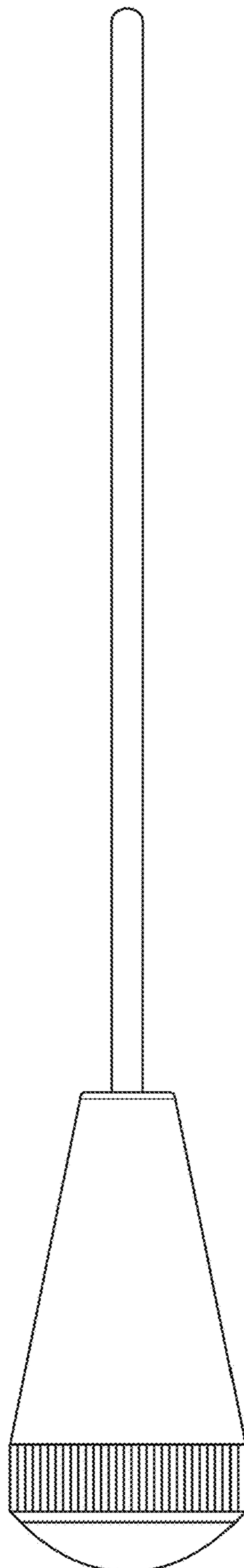

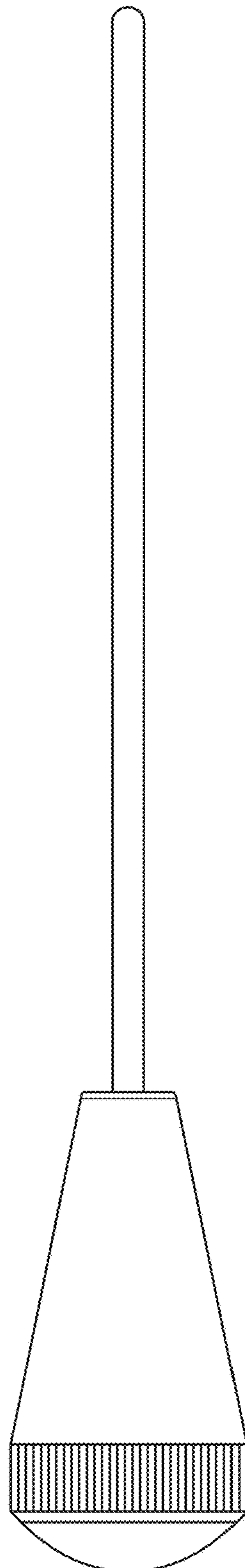

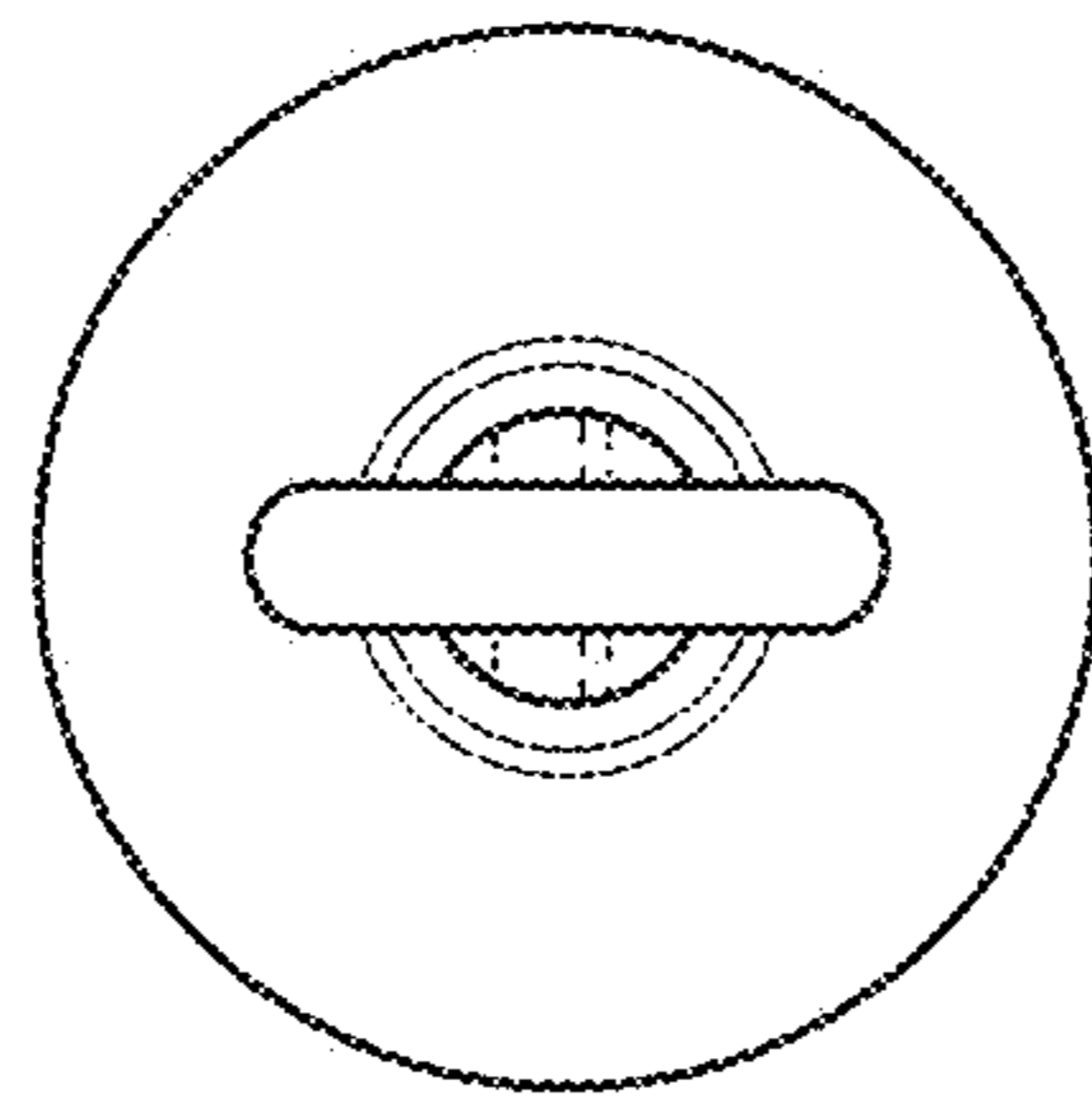

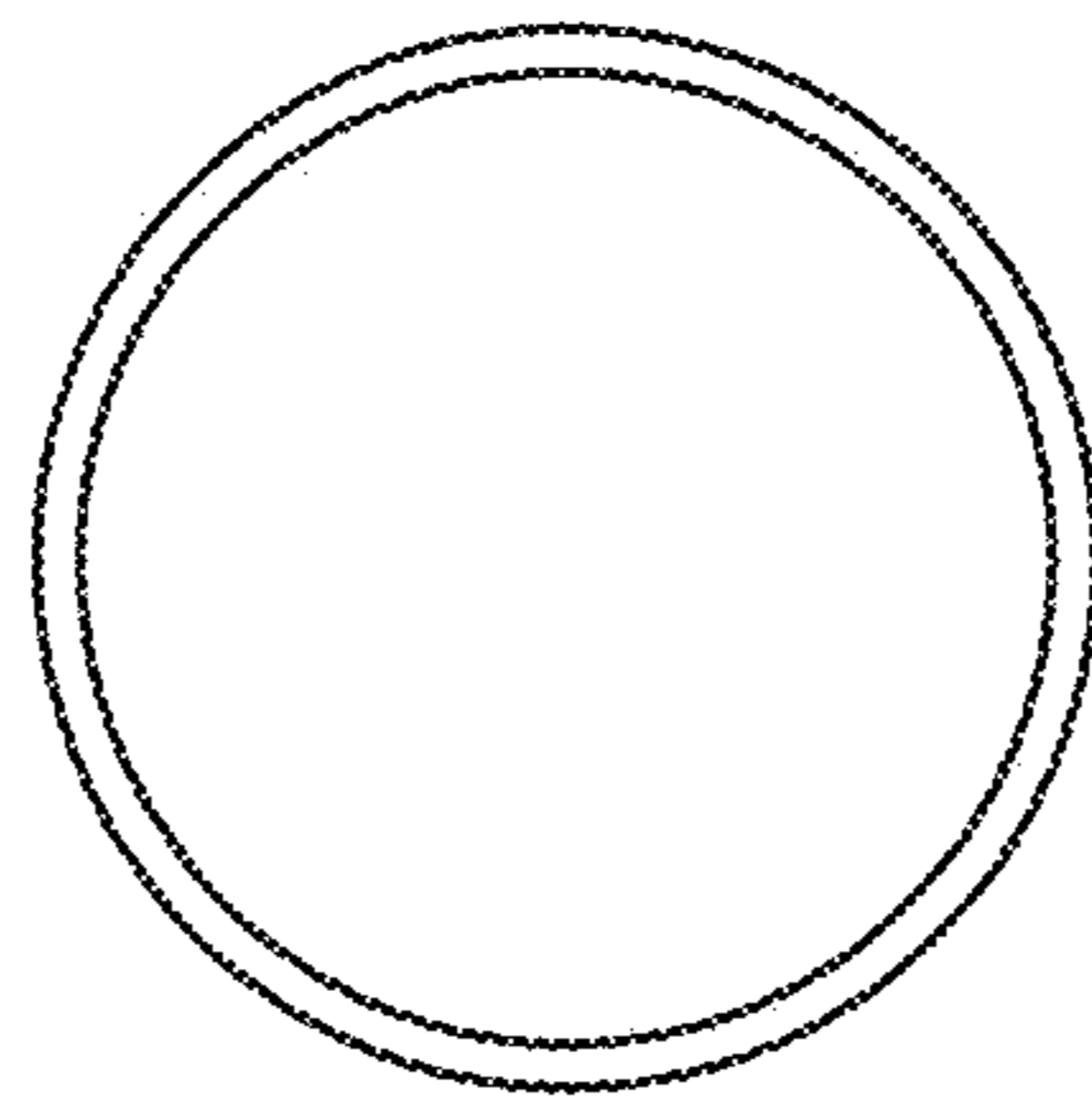

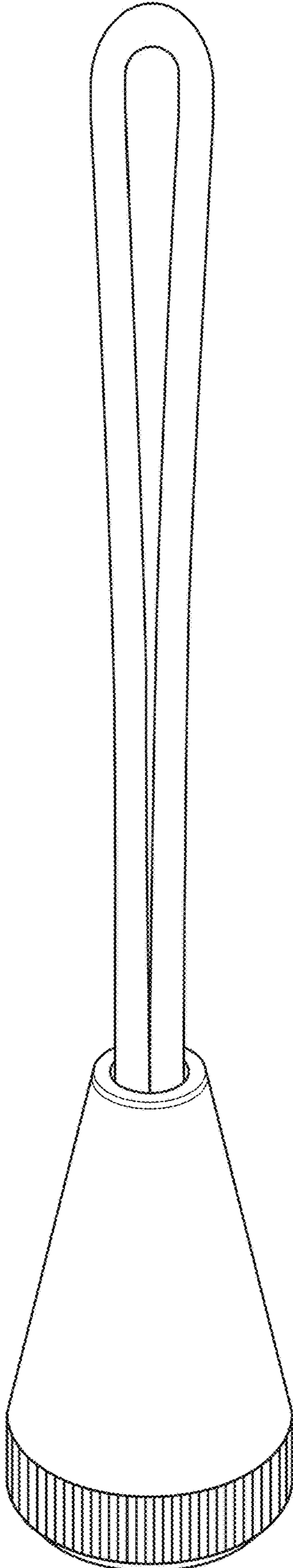
