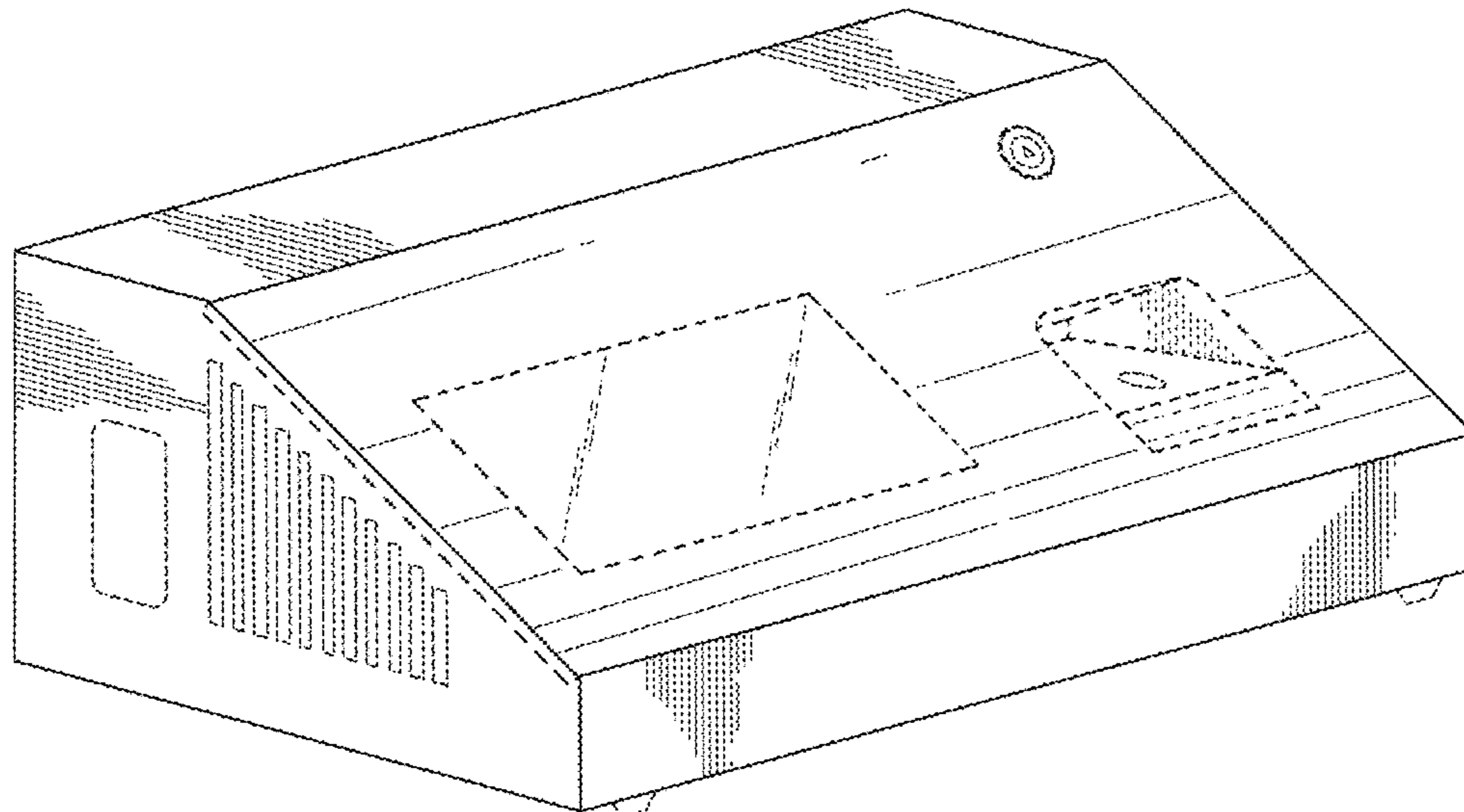
FIG. 1 is a perspective view of an electronic key control unit according to our new design, as viewed from the front, above and to the left of the device;

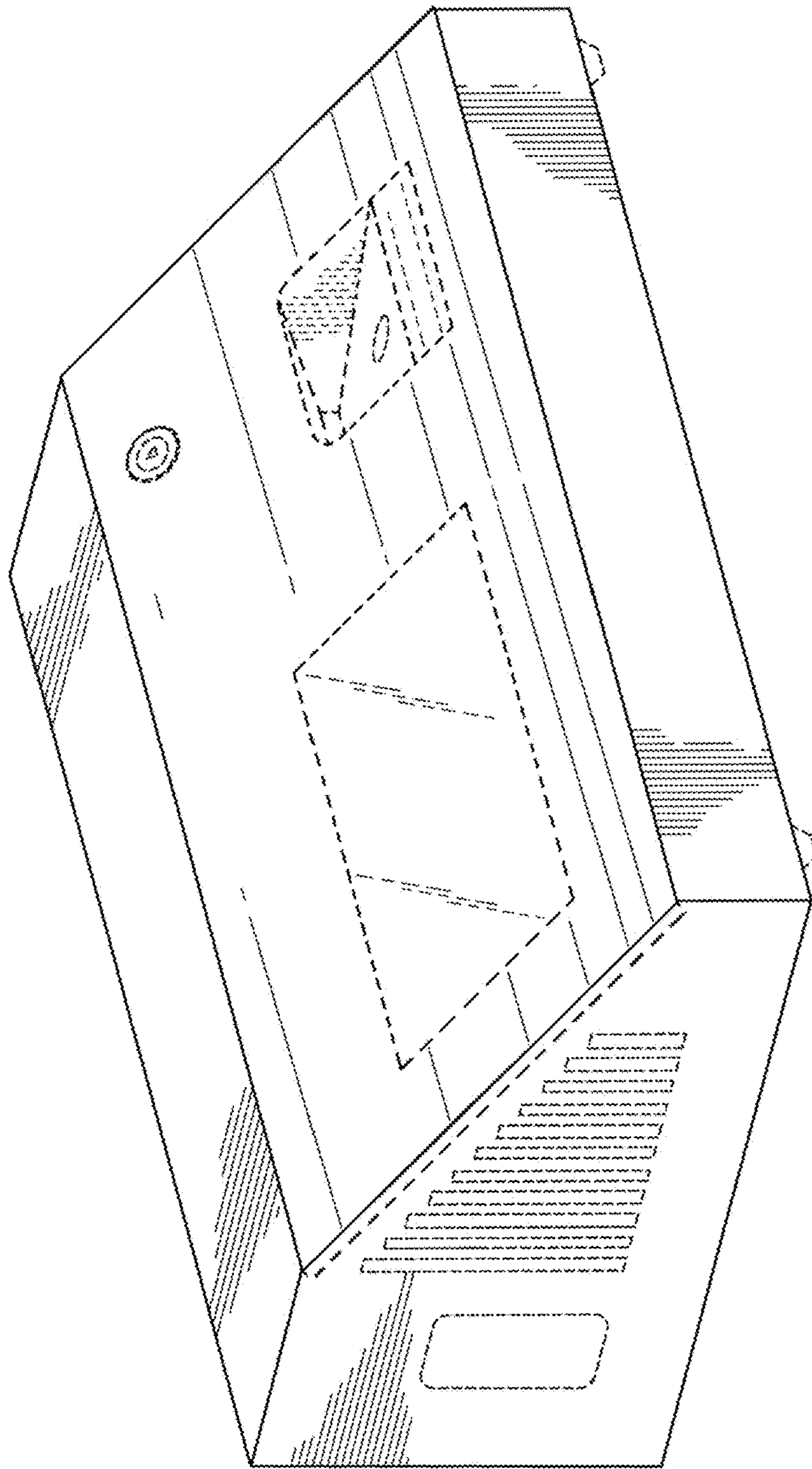

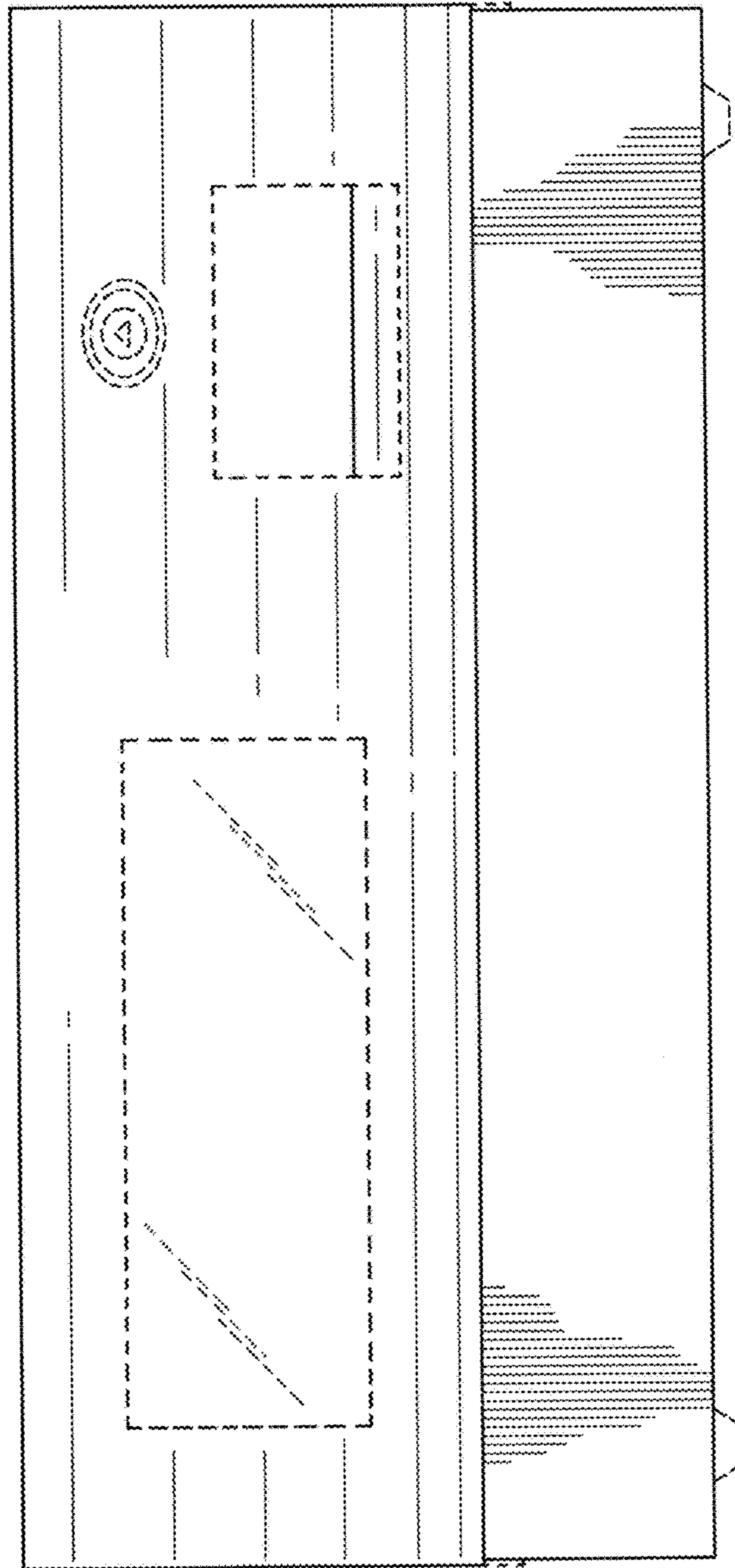

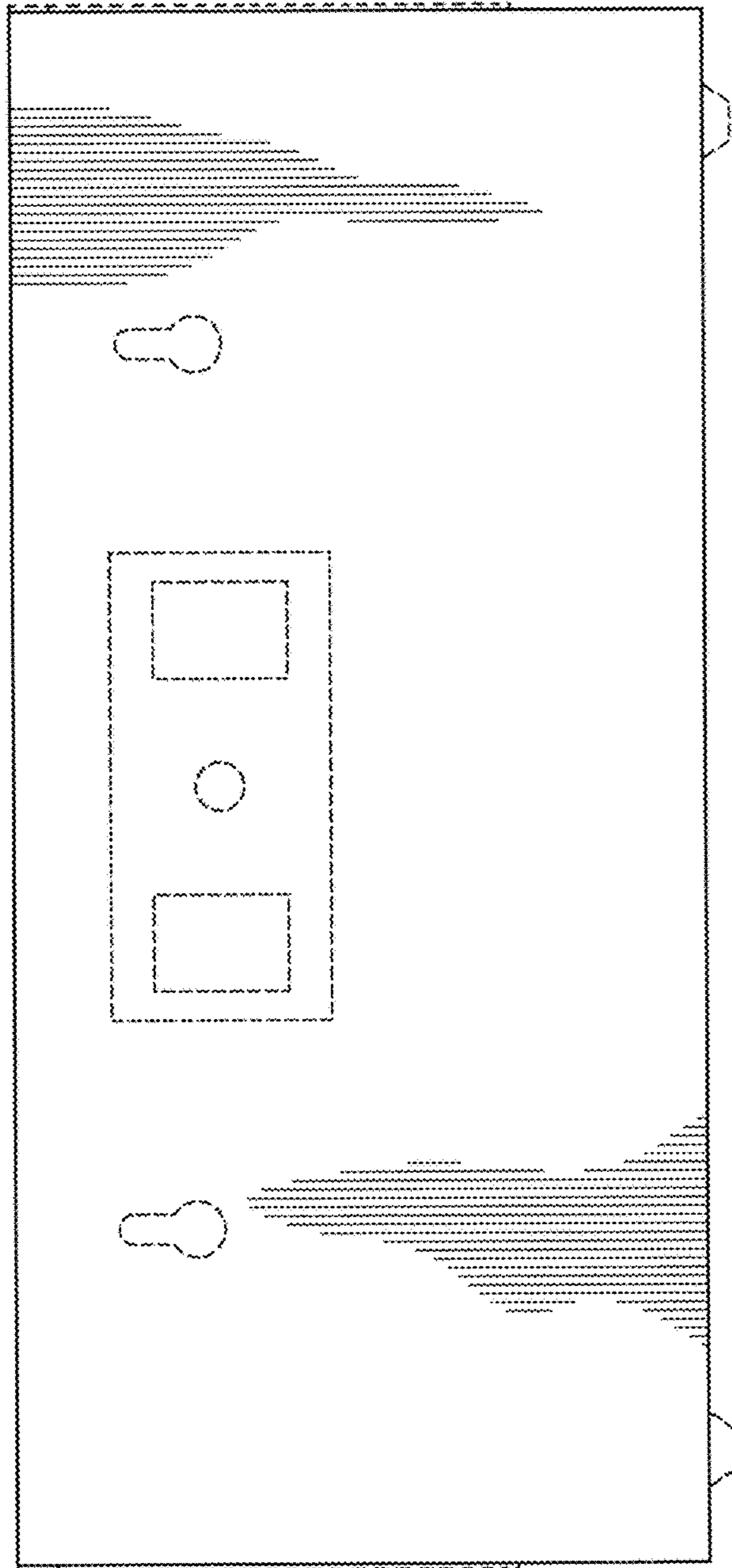

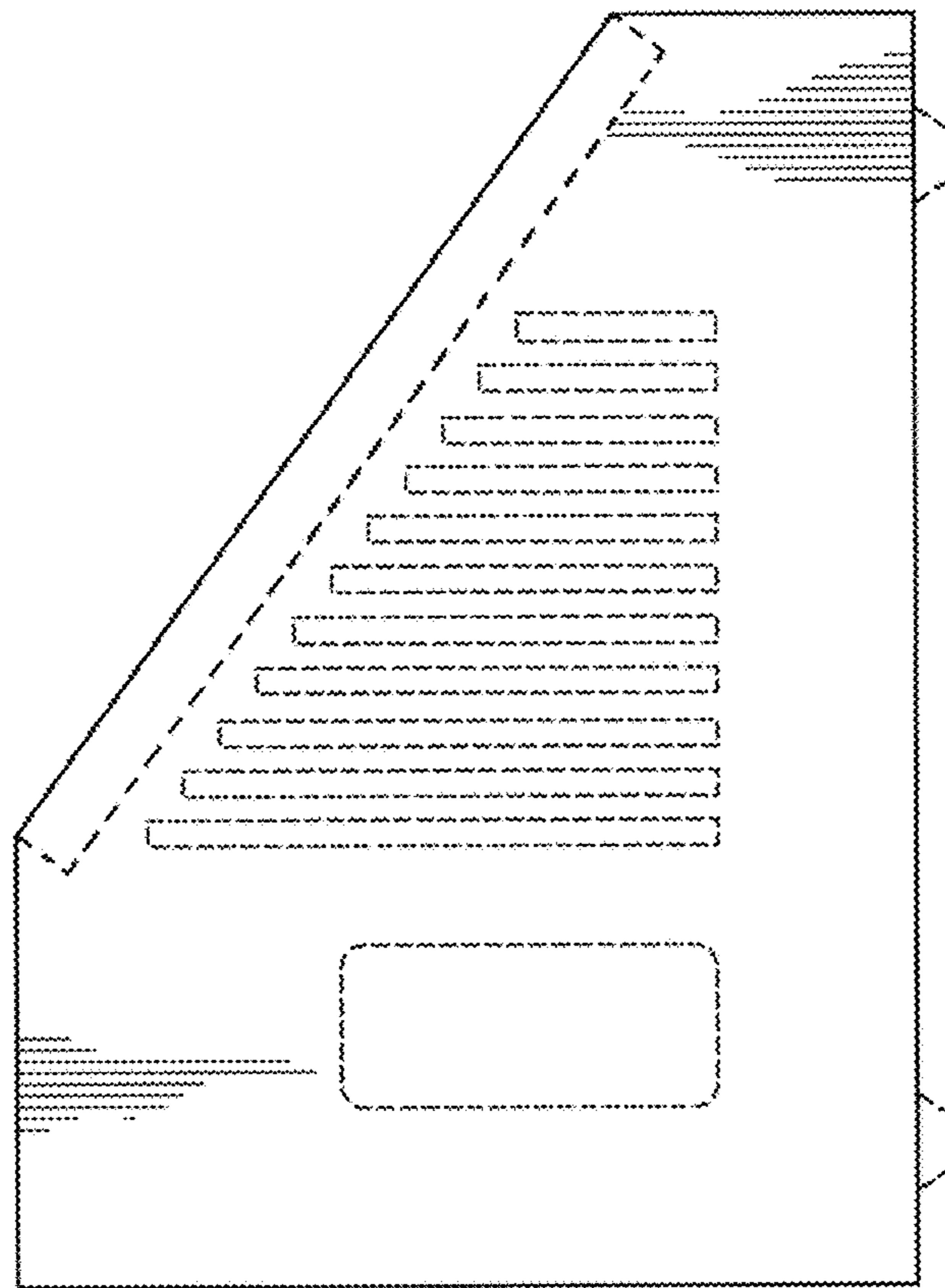

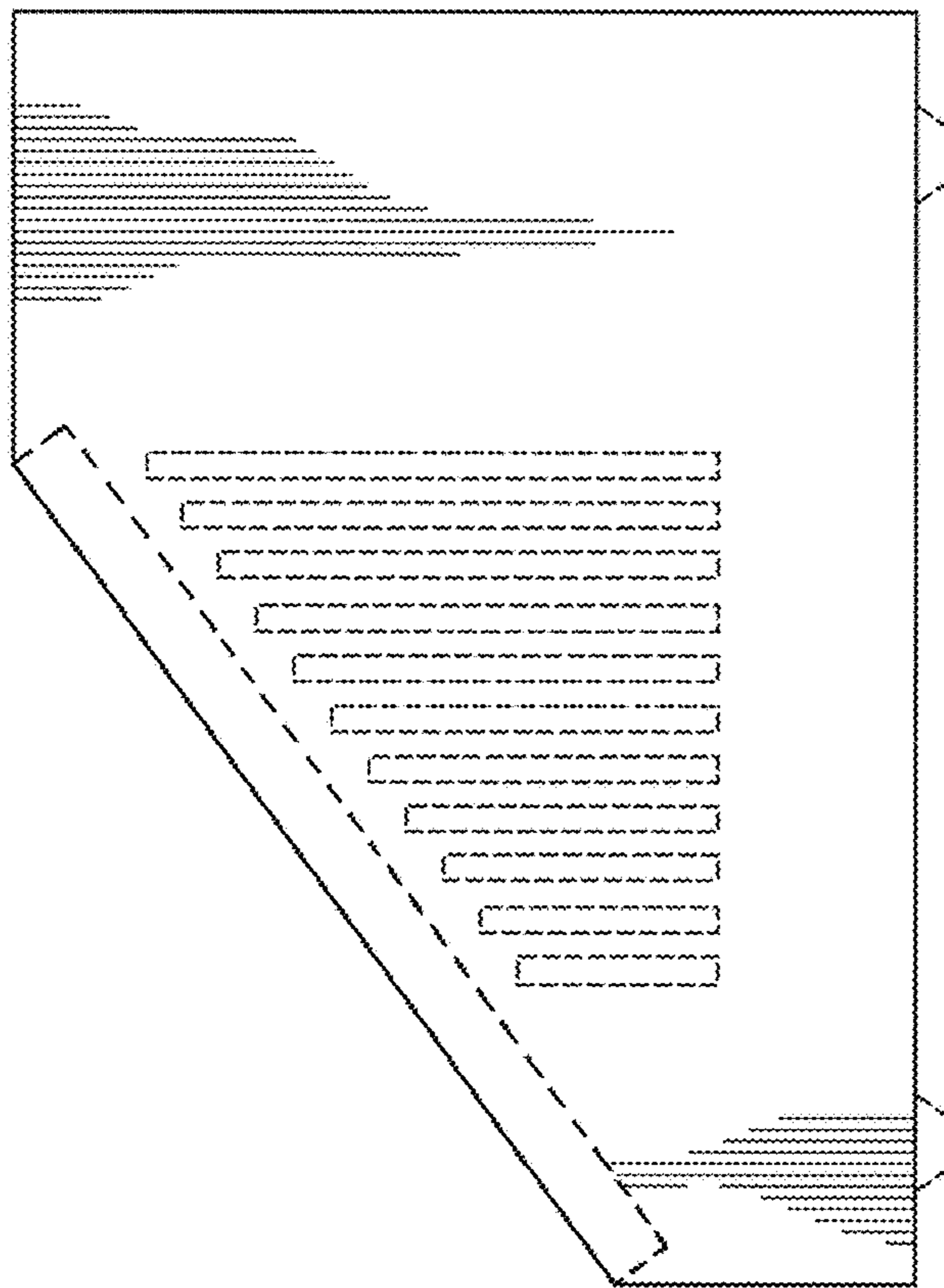

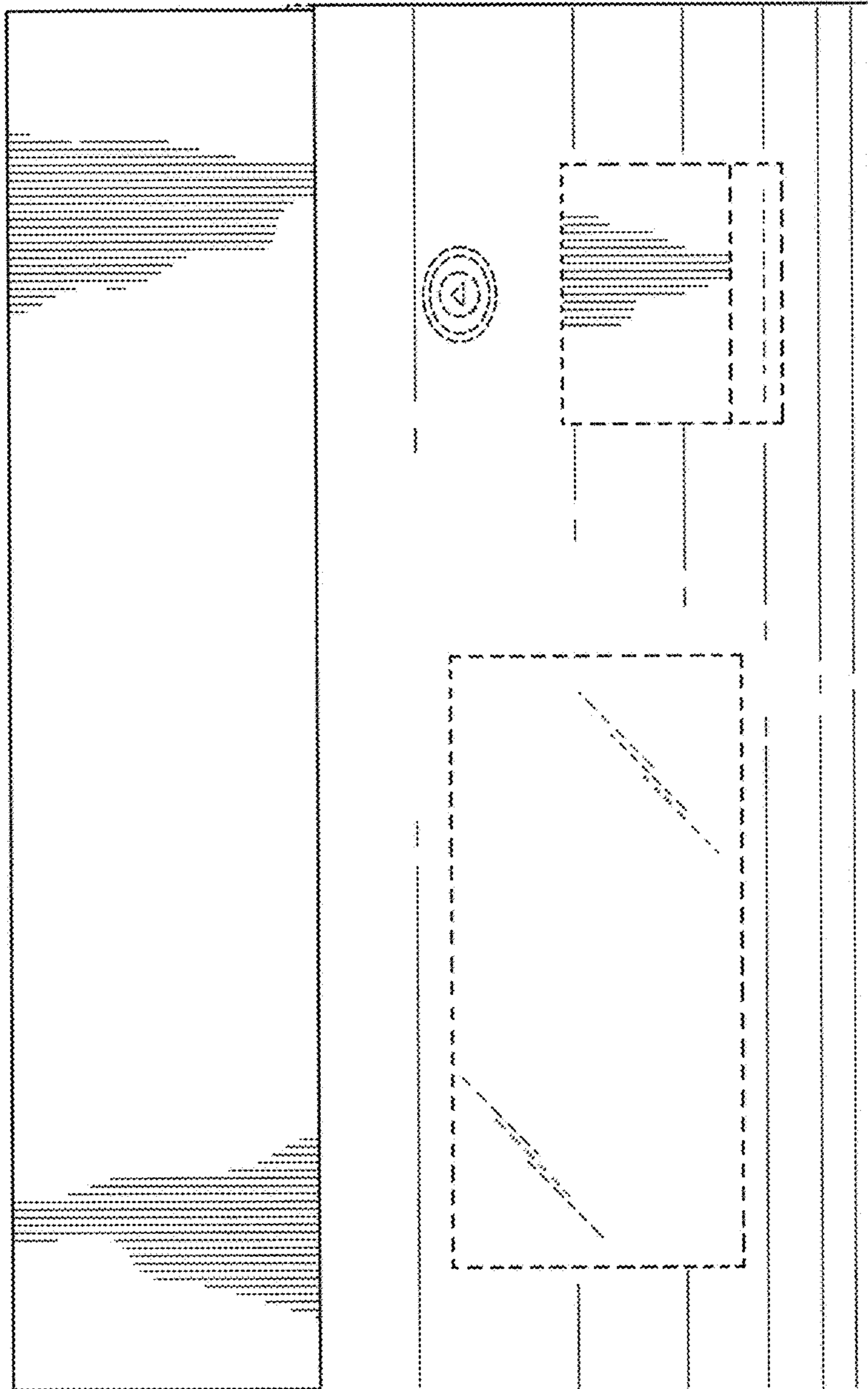
