(57) **CLAIM**

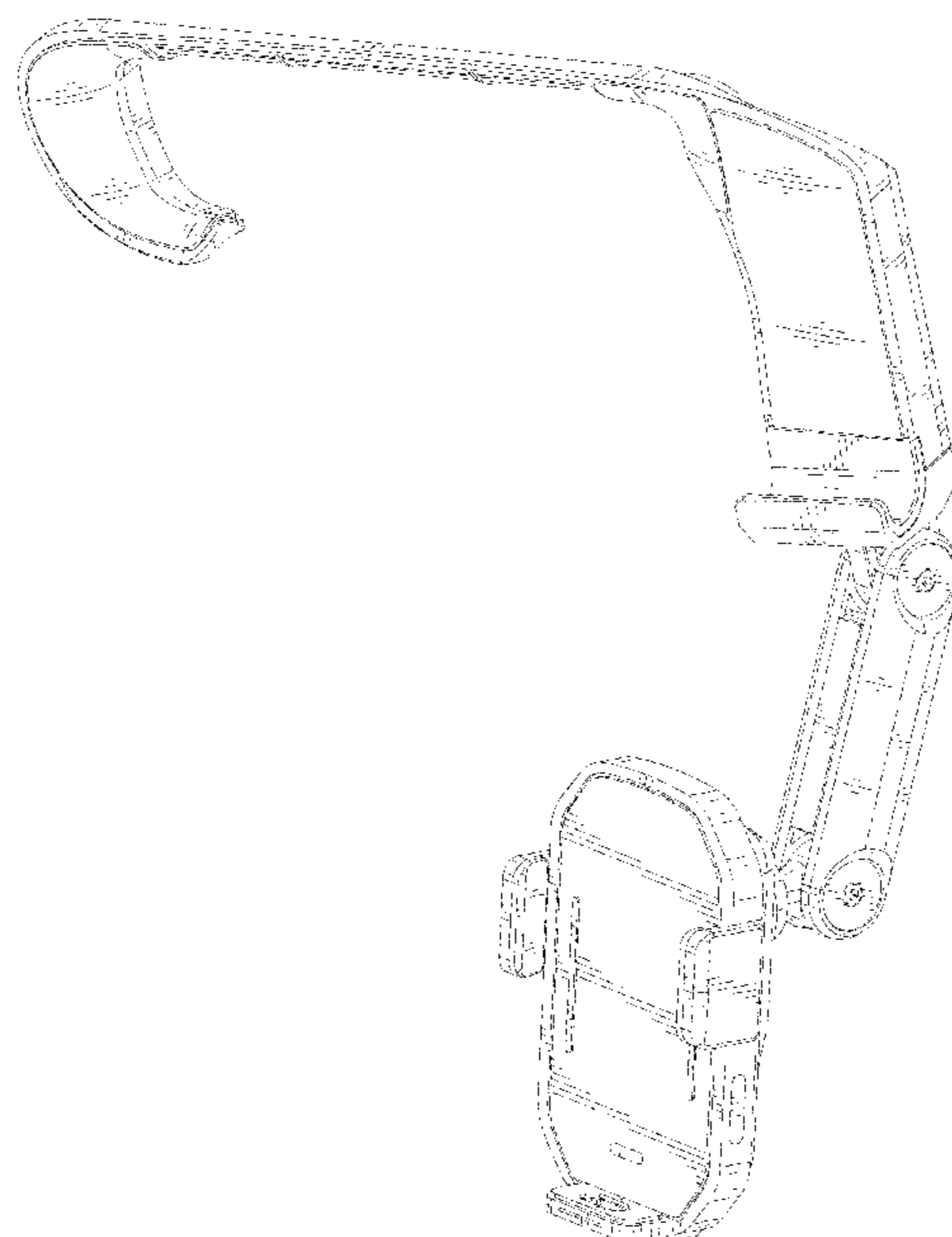
I claim the ornamental design for a support for mobile phone, as shown and described.

DESCRIPTION

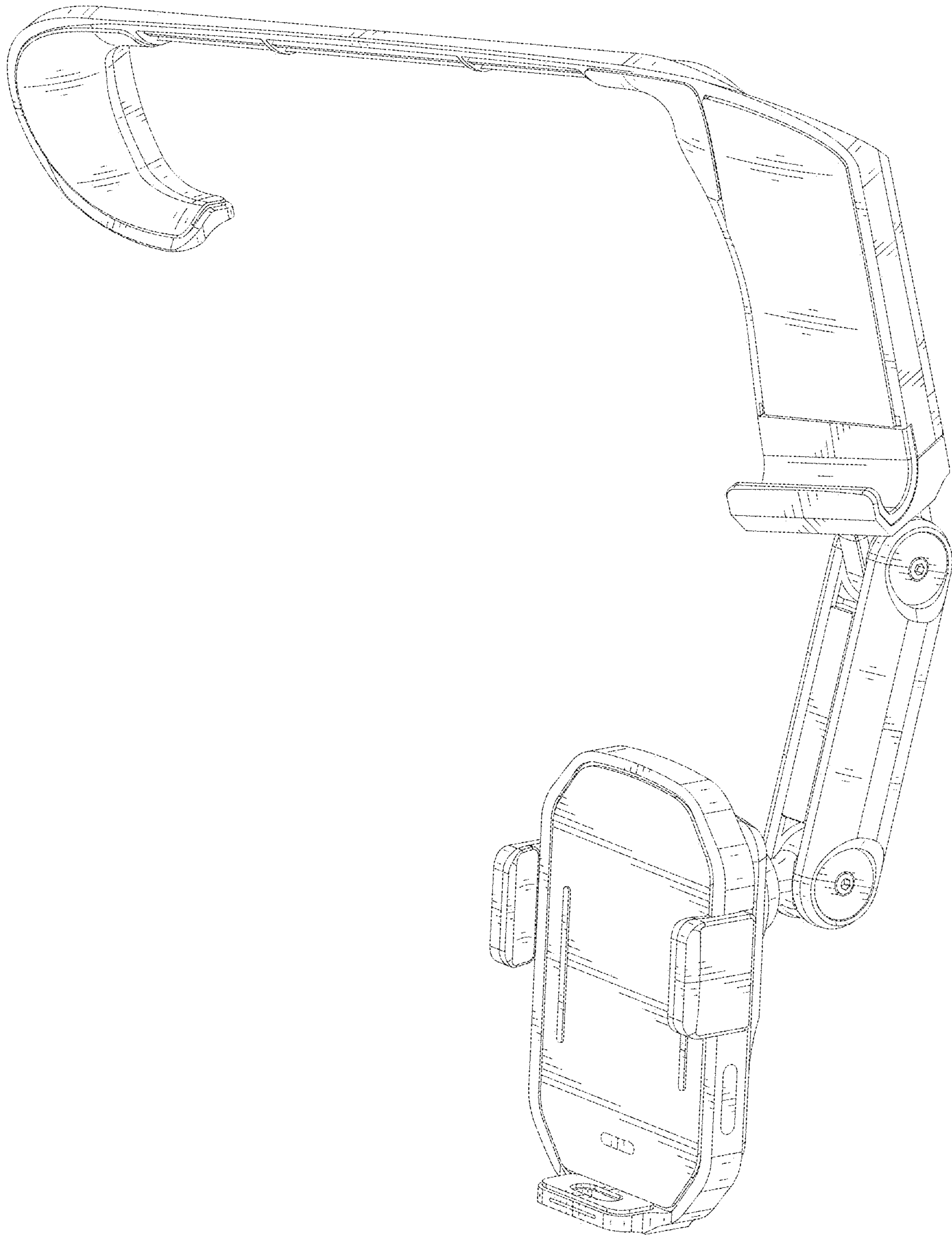

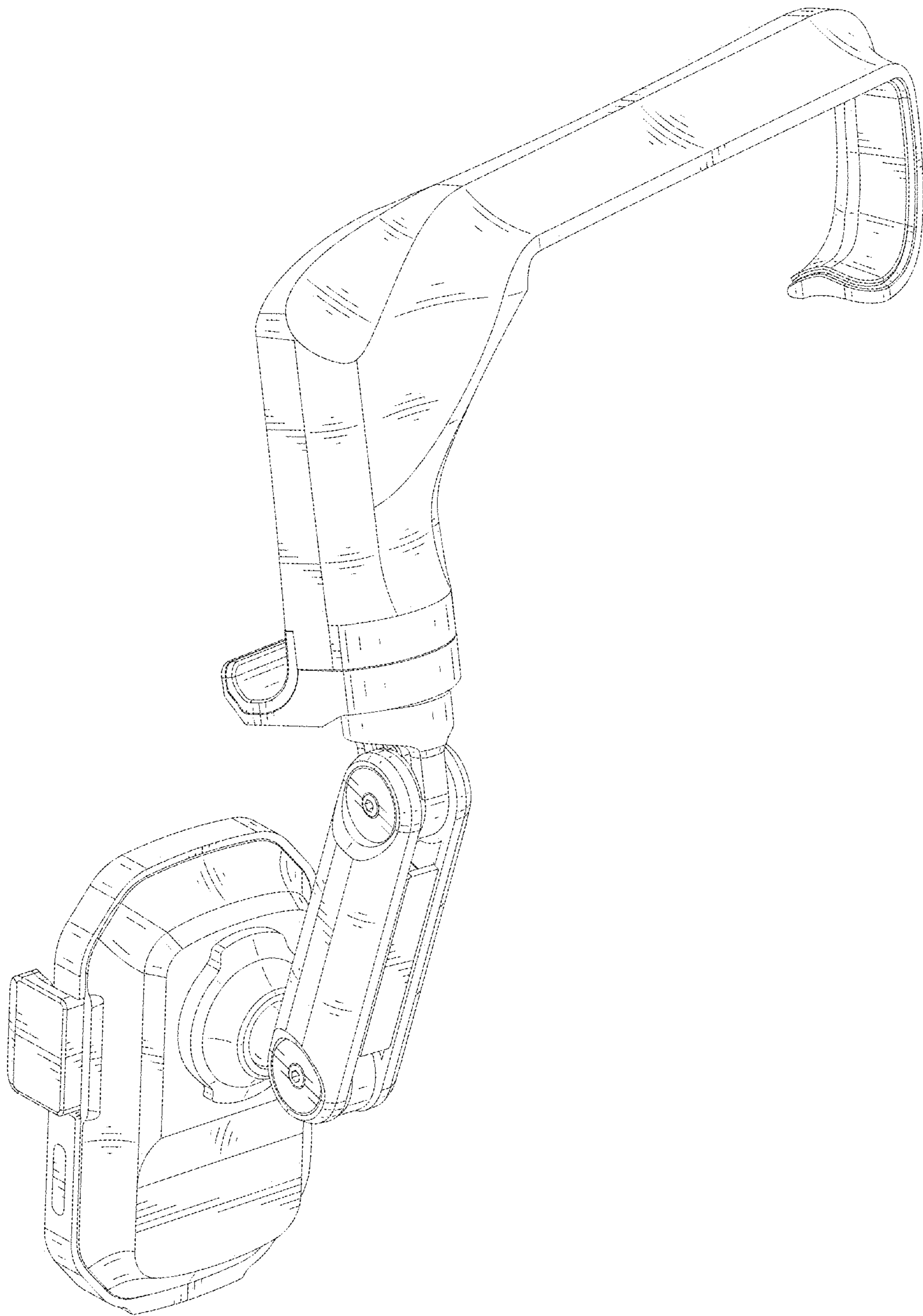

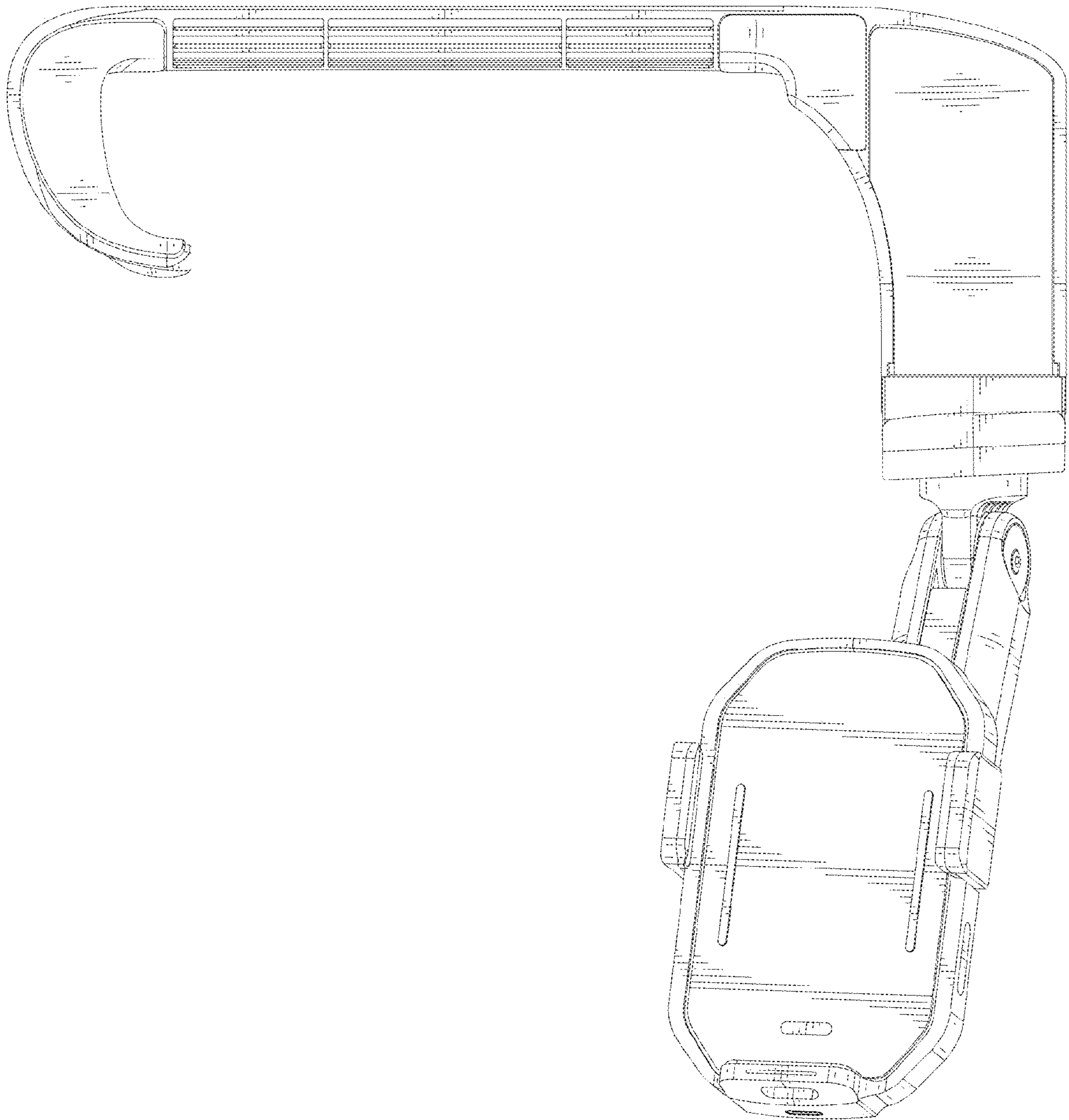

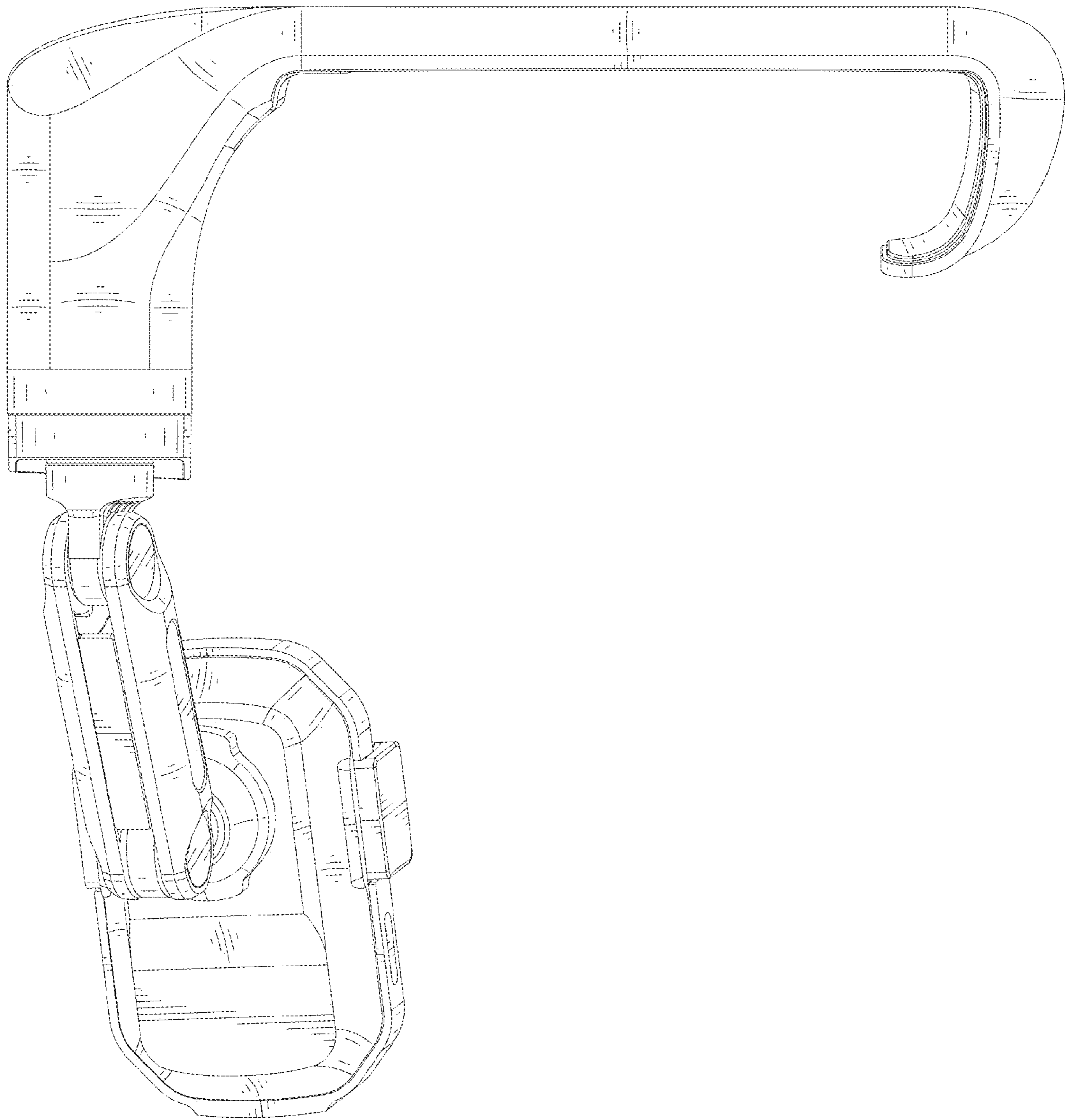

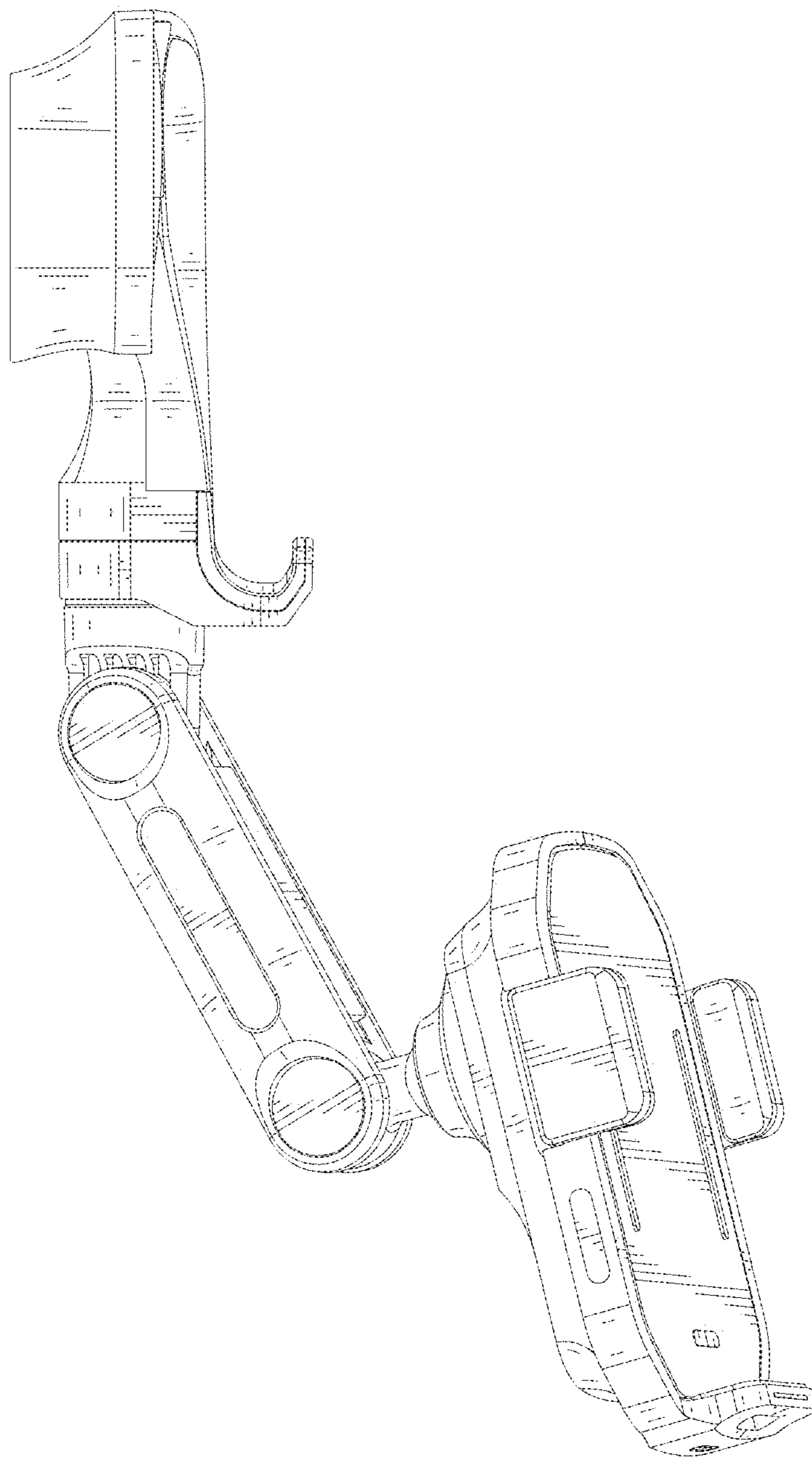

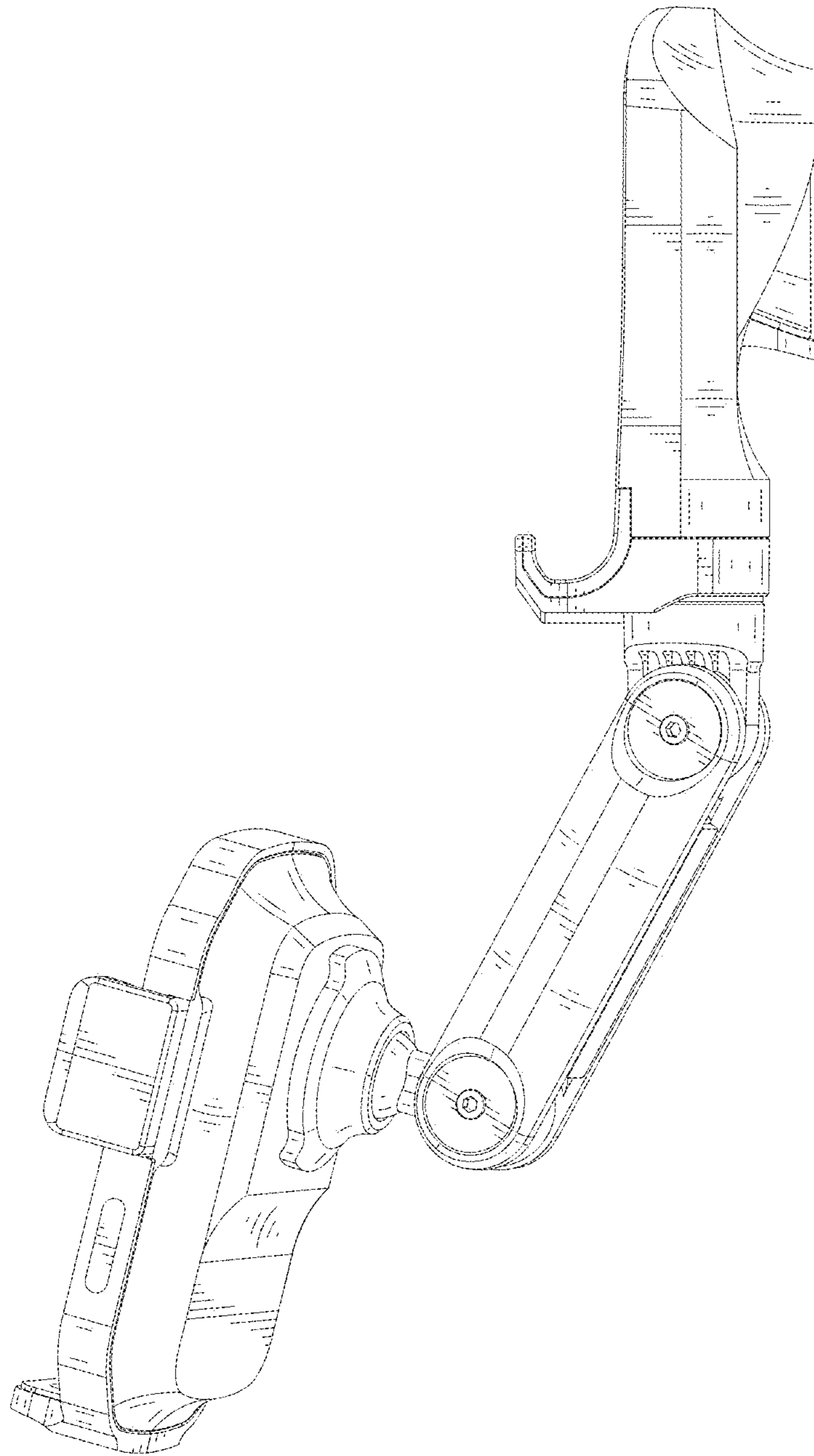

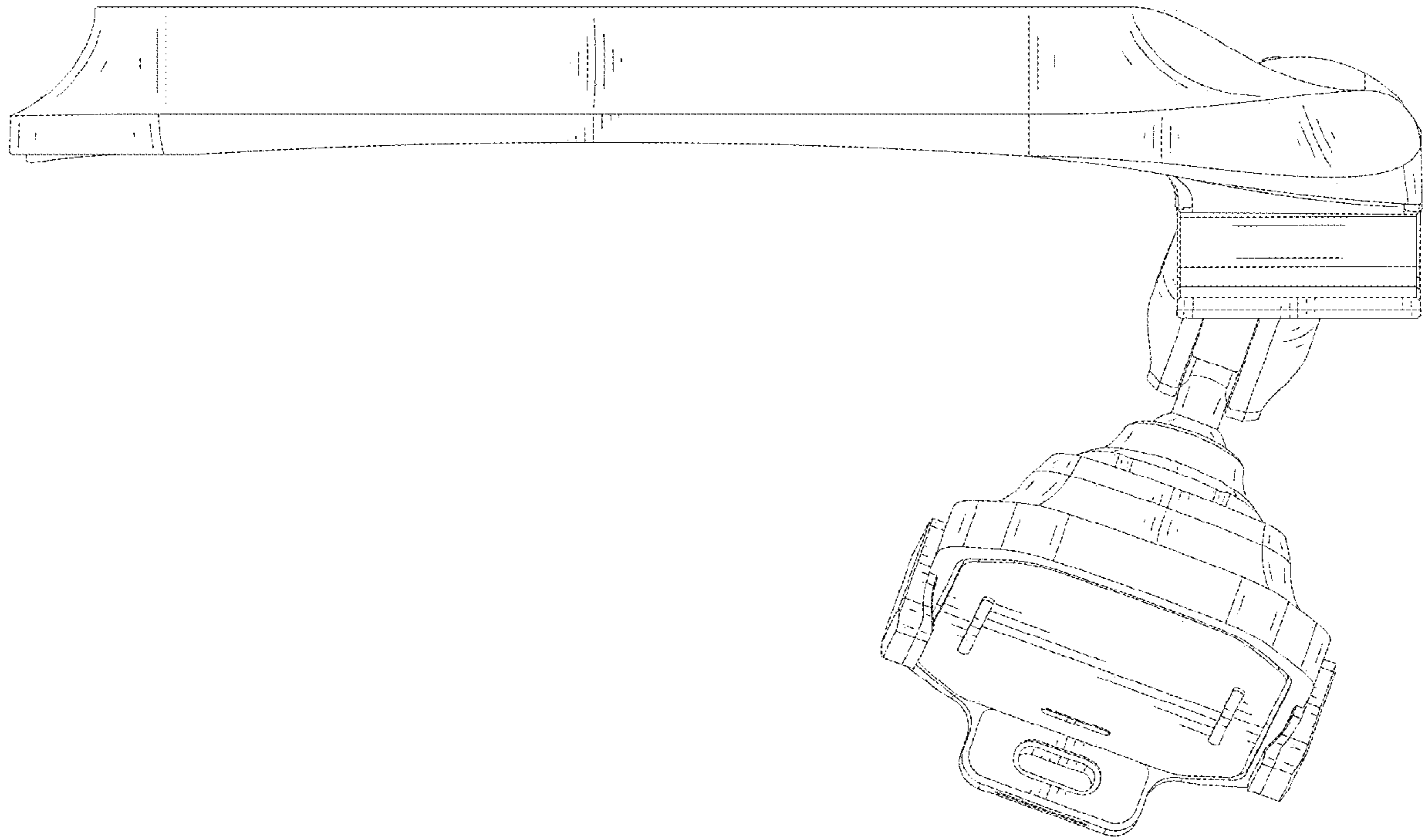

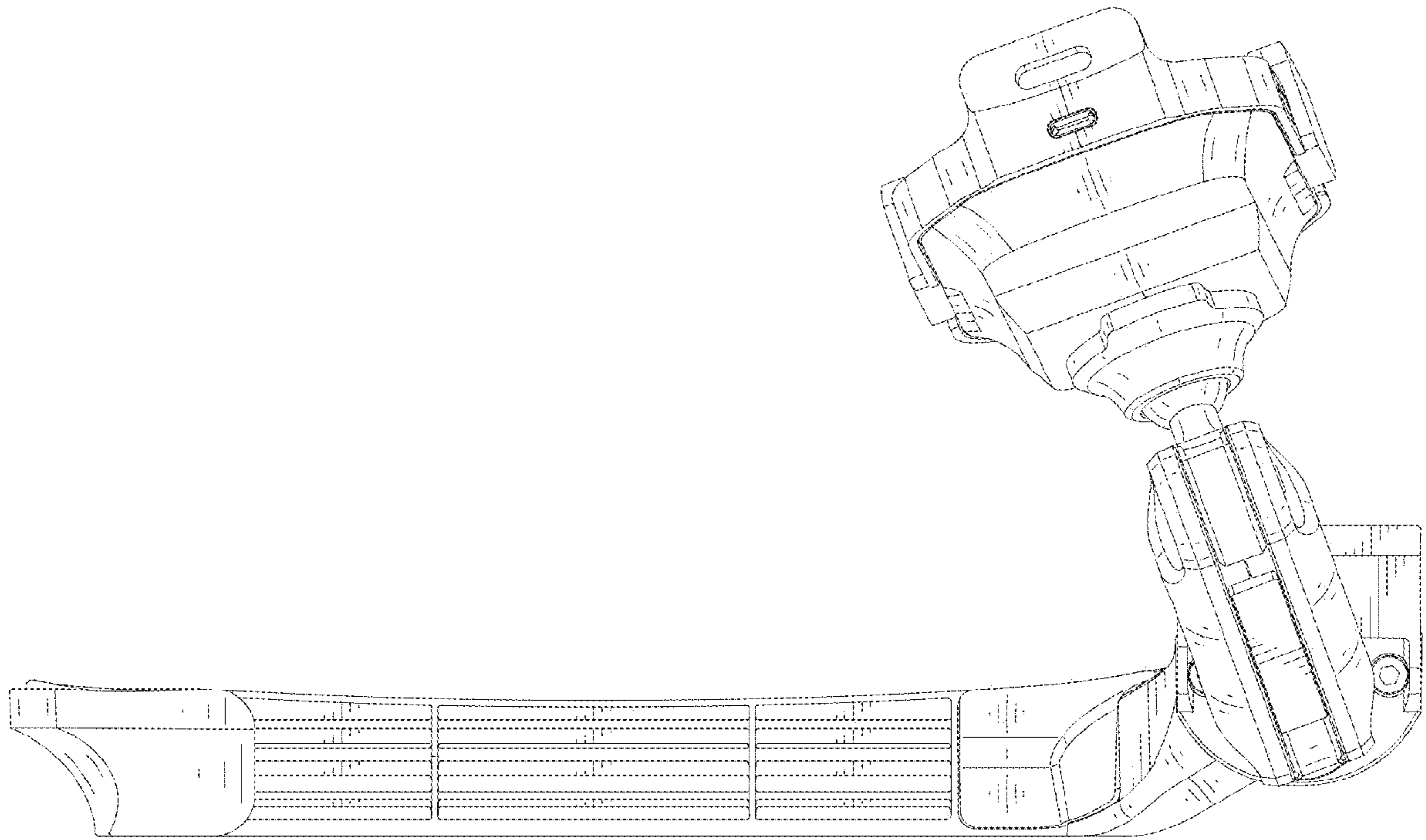
