FIG. 9 is a ninth image thereof;

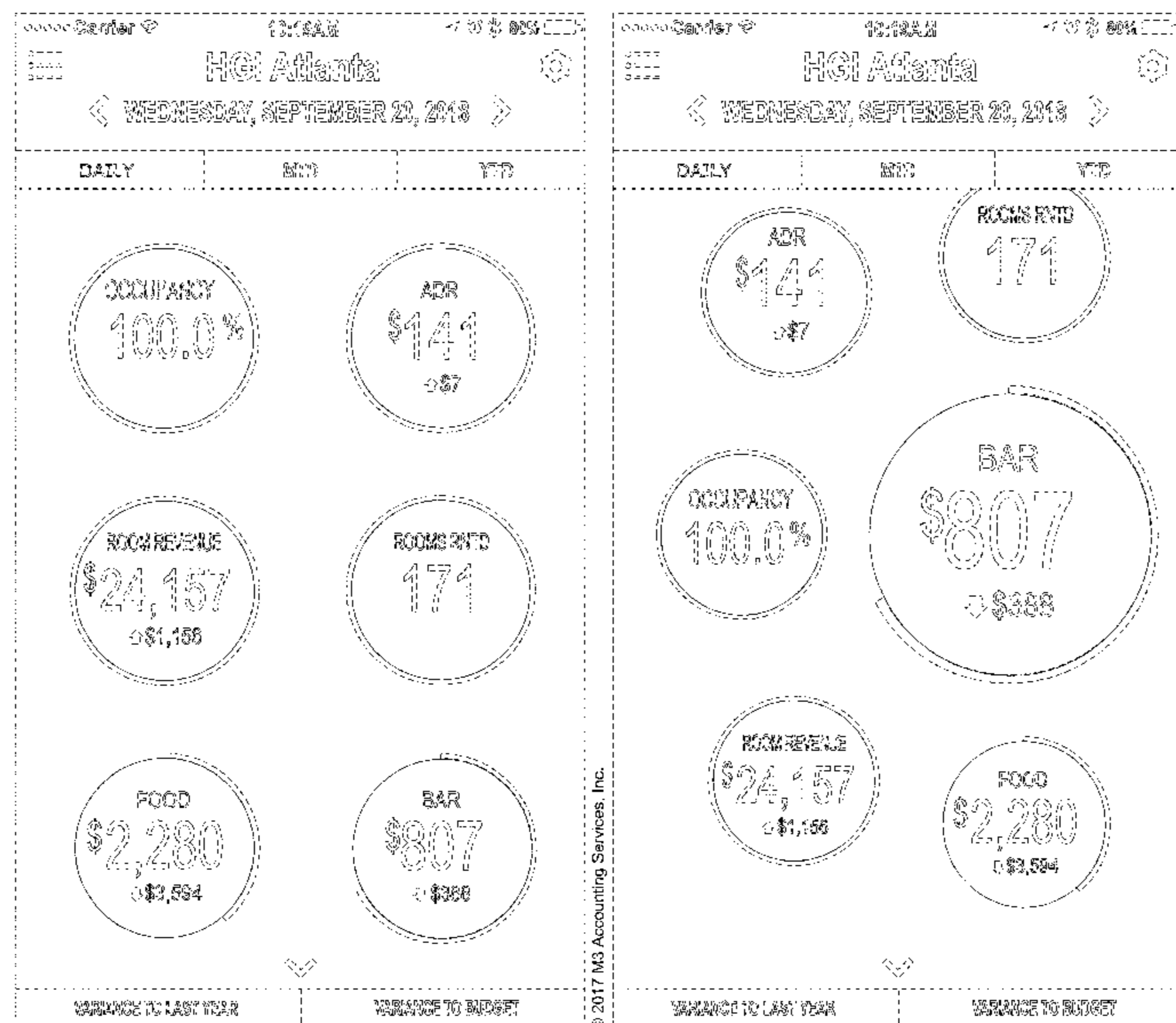
FIG. 10 is a tenth image thereof;

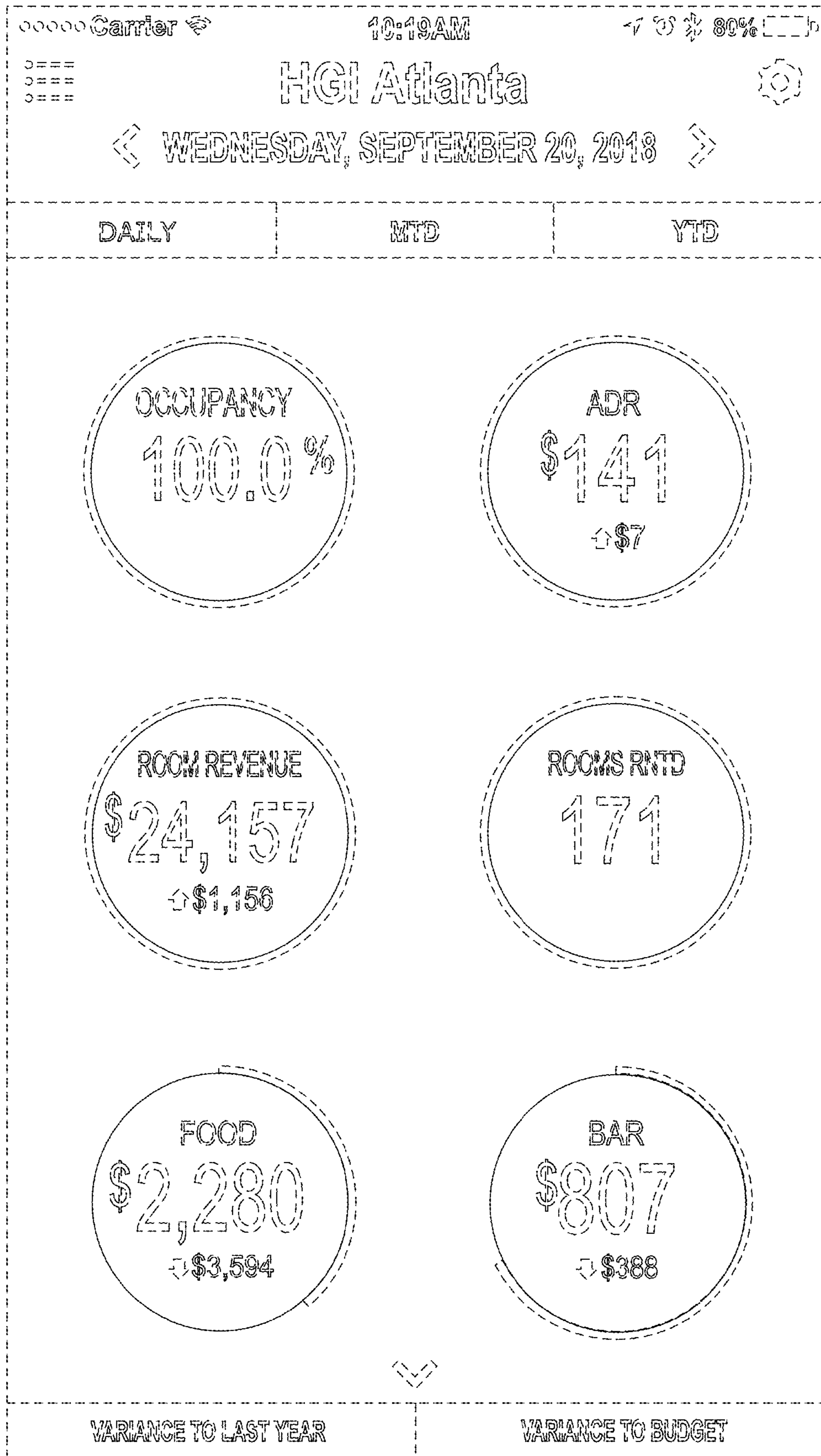
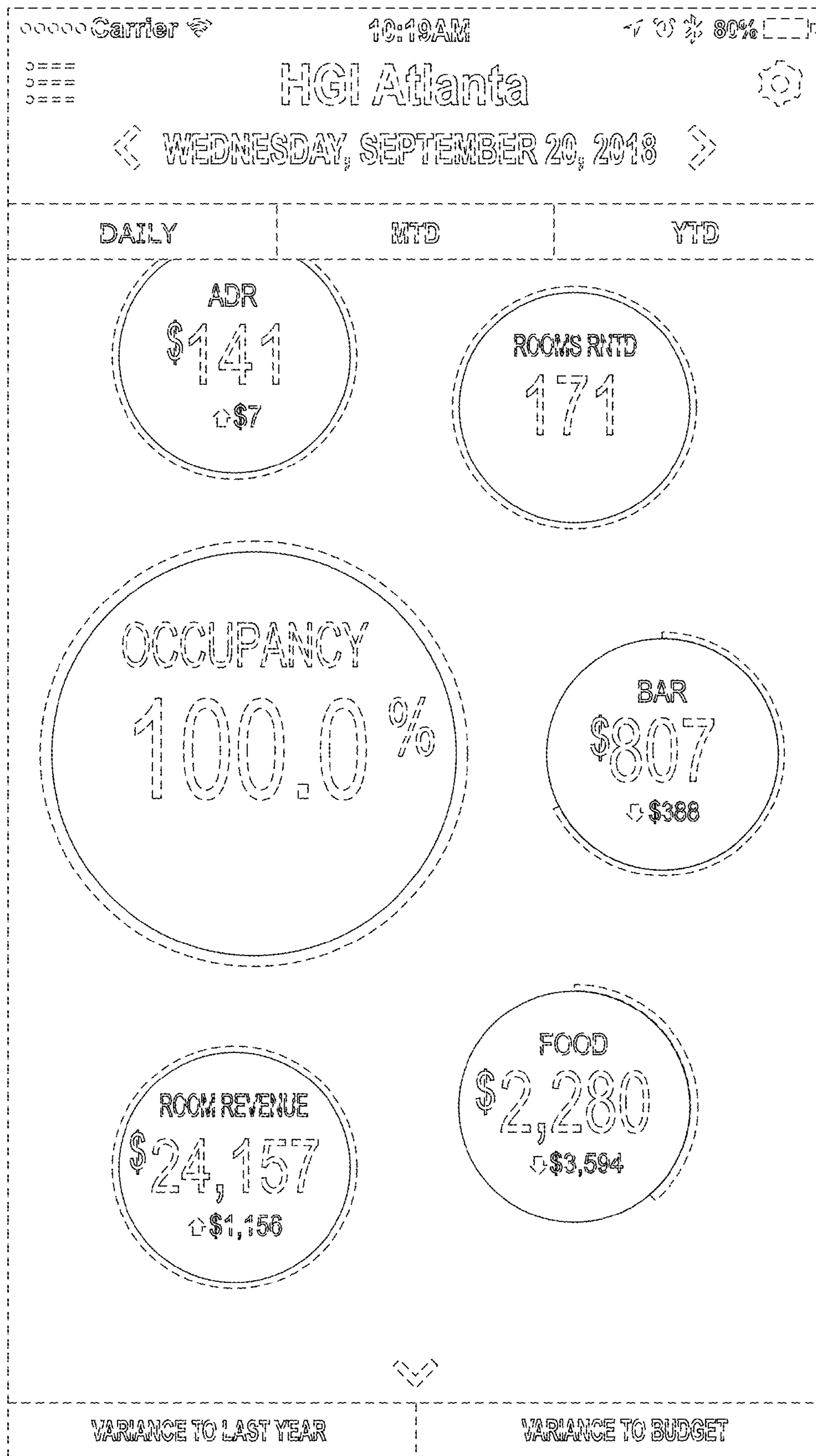
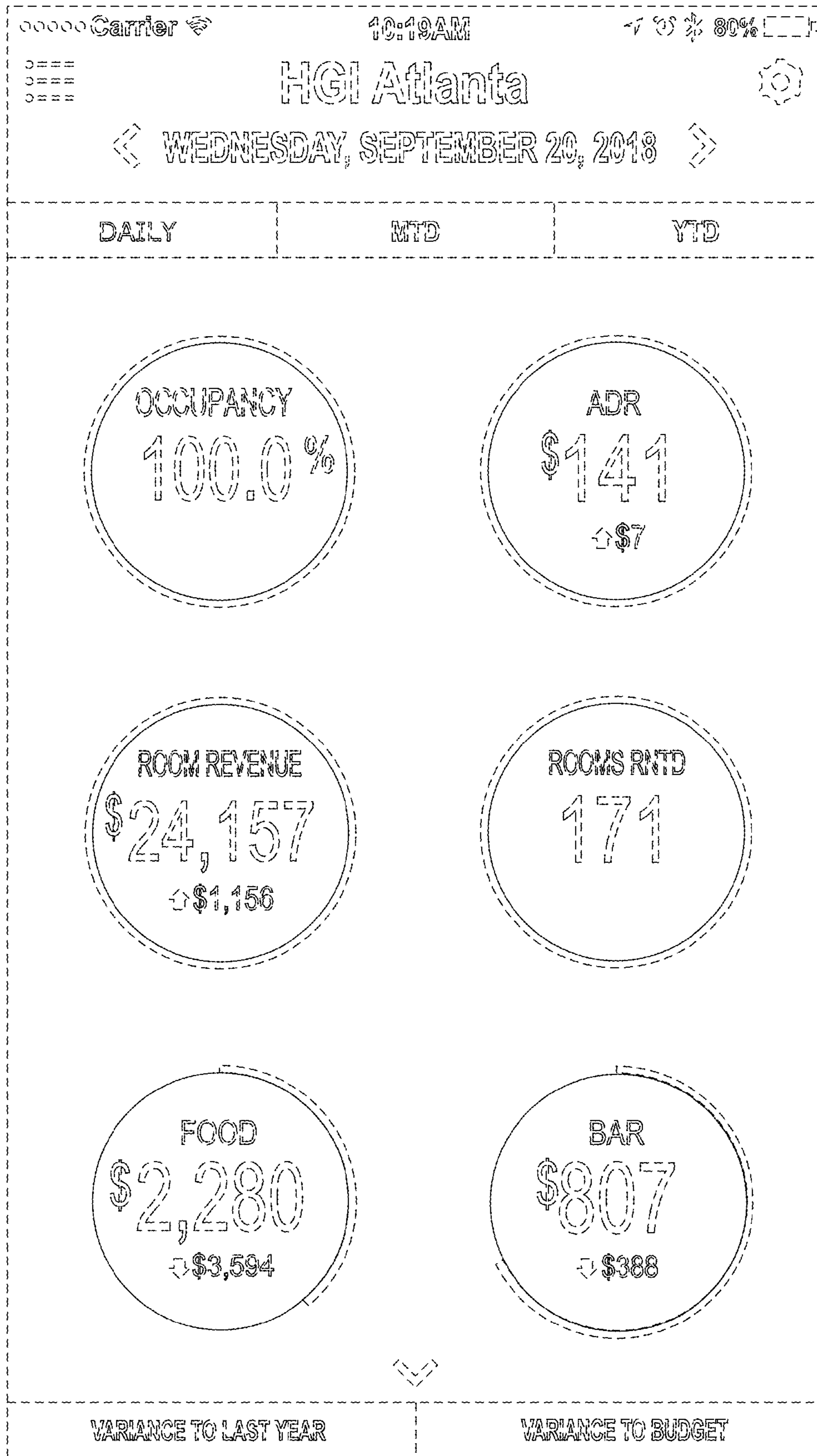

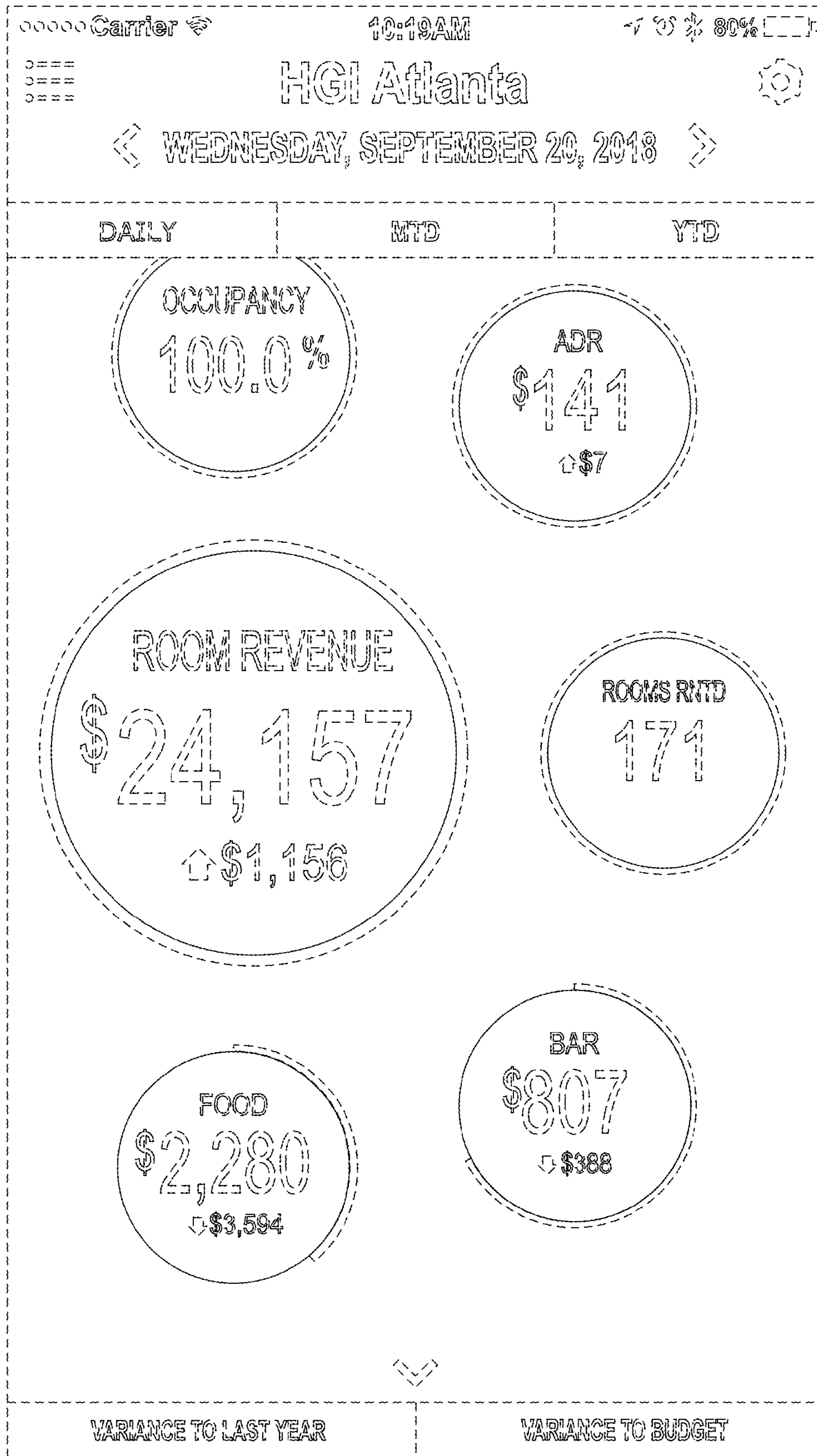

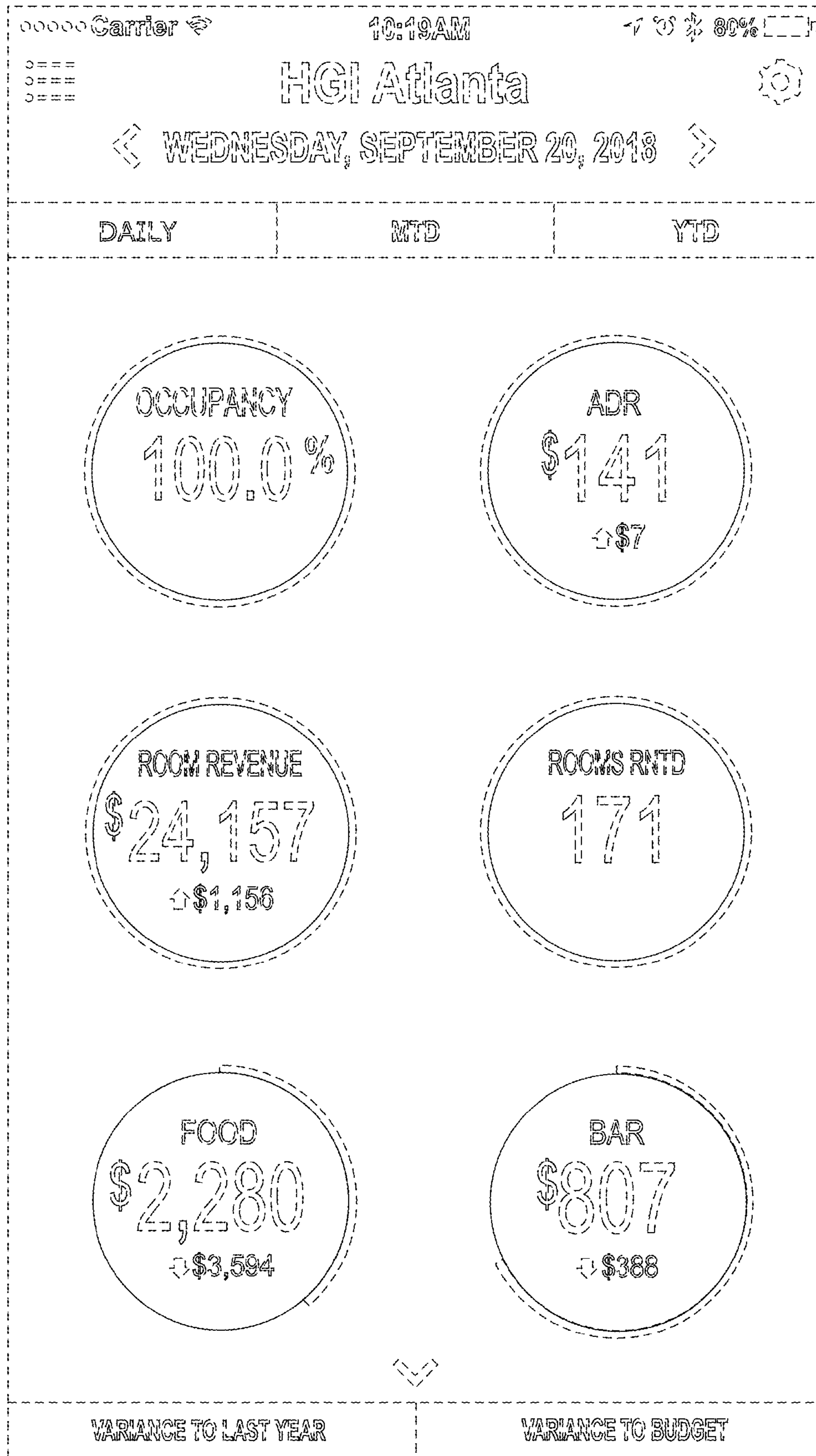

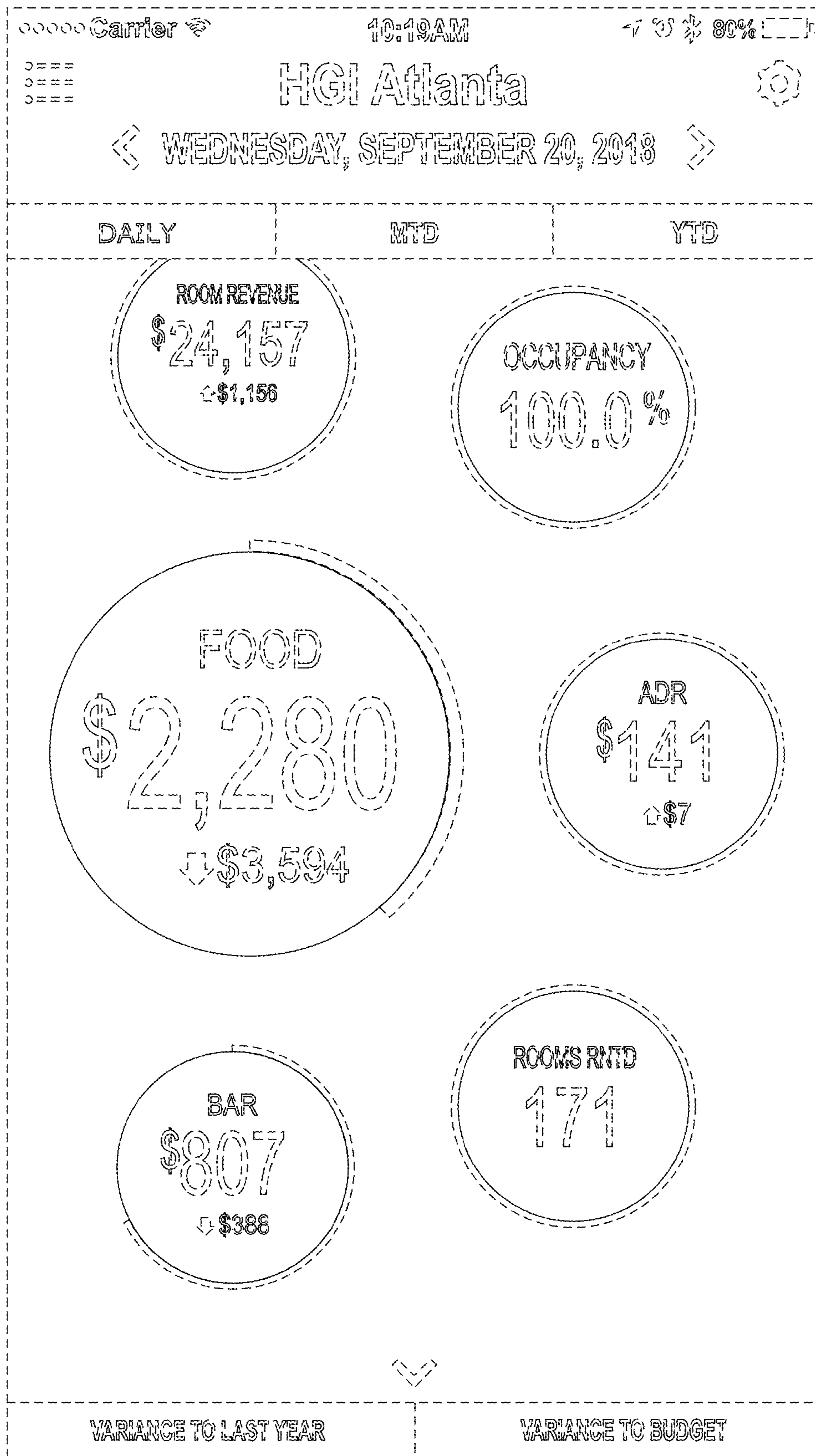

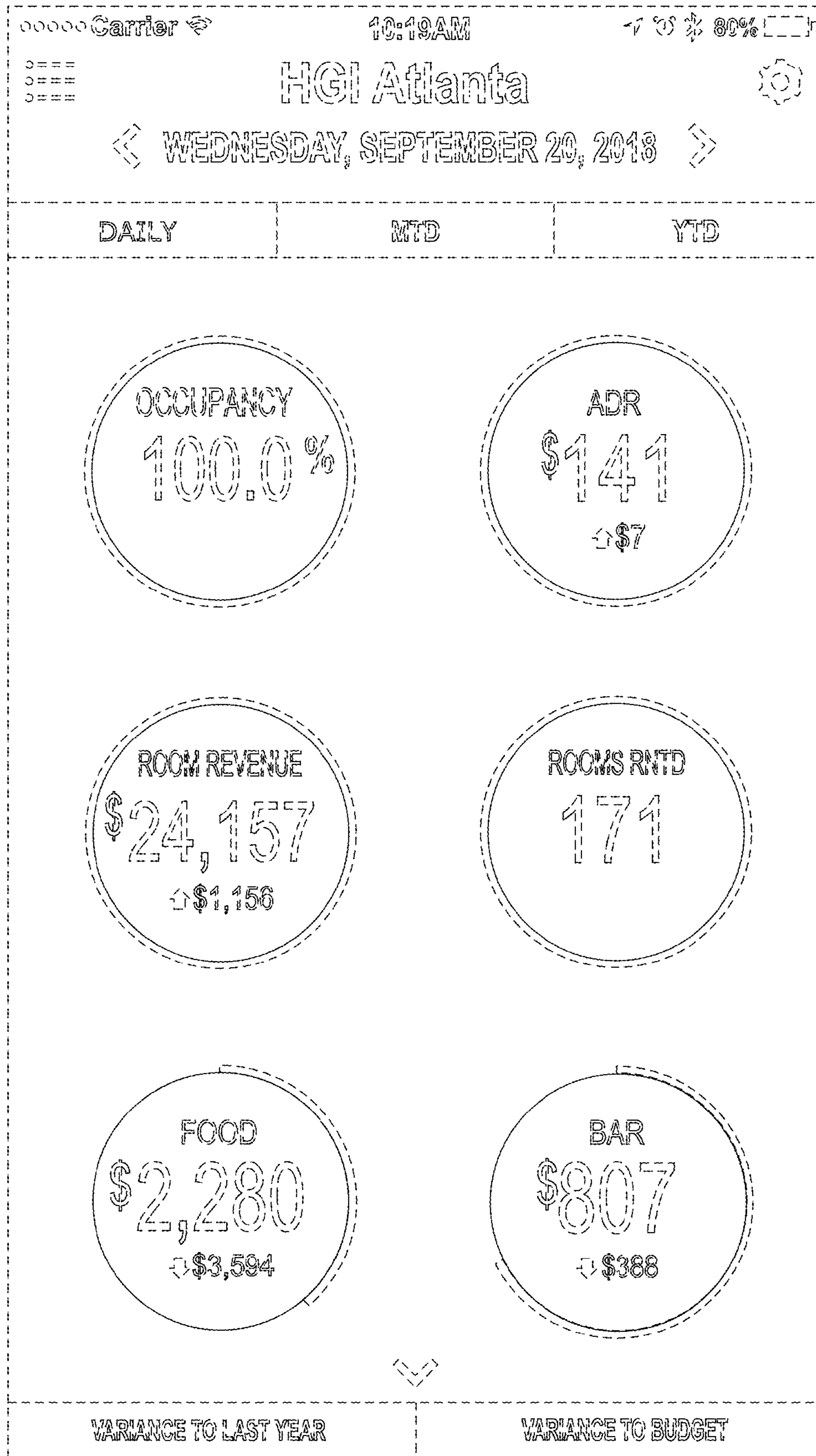

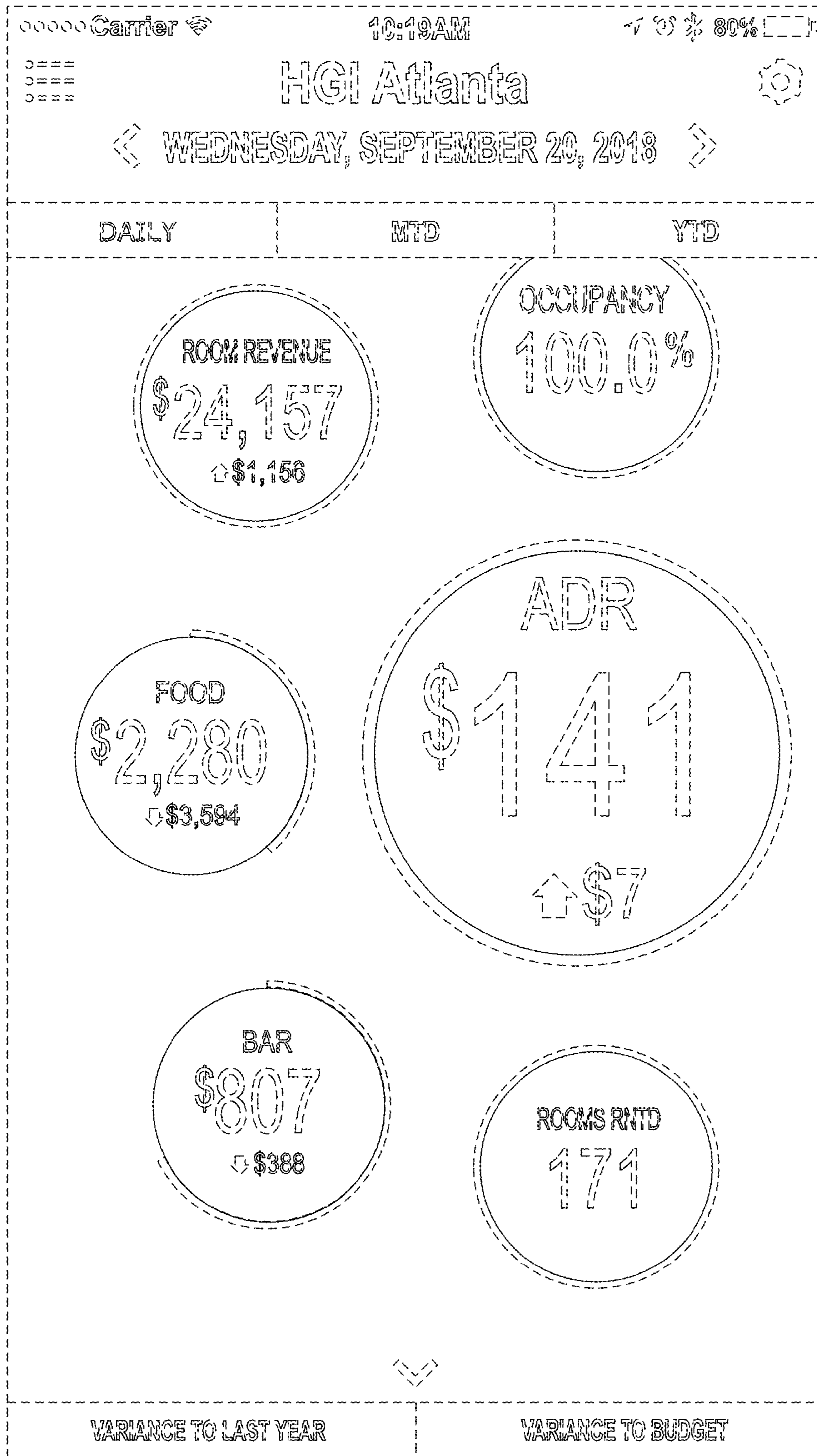

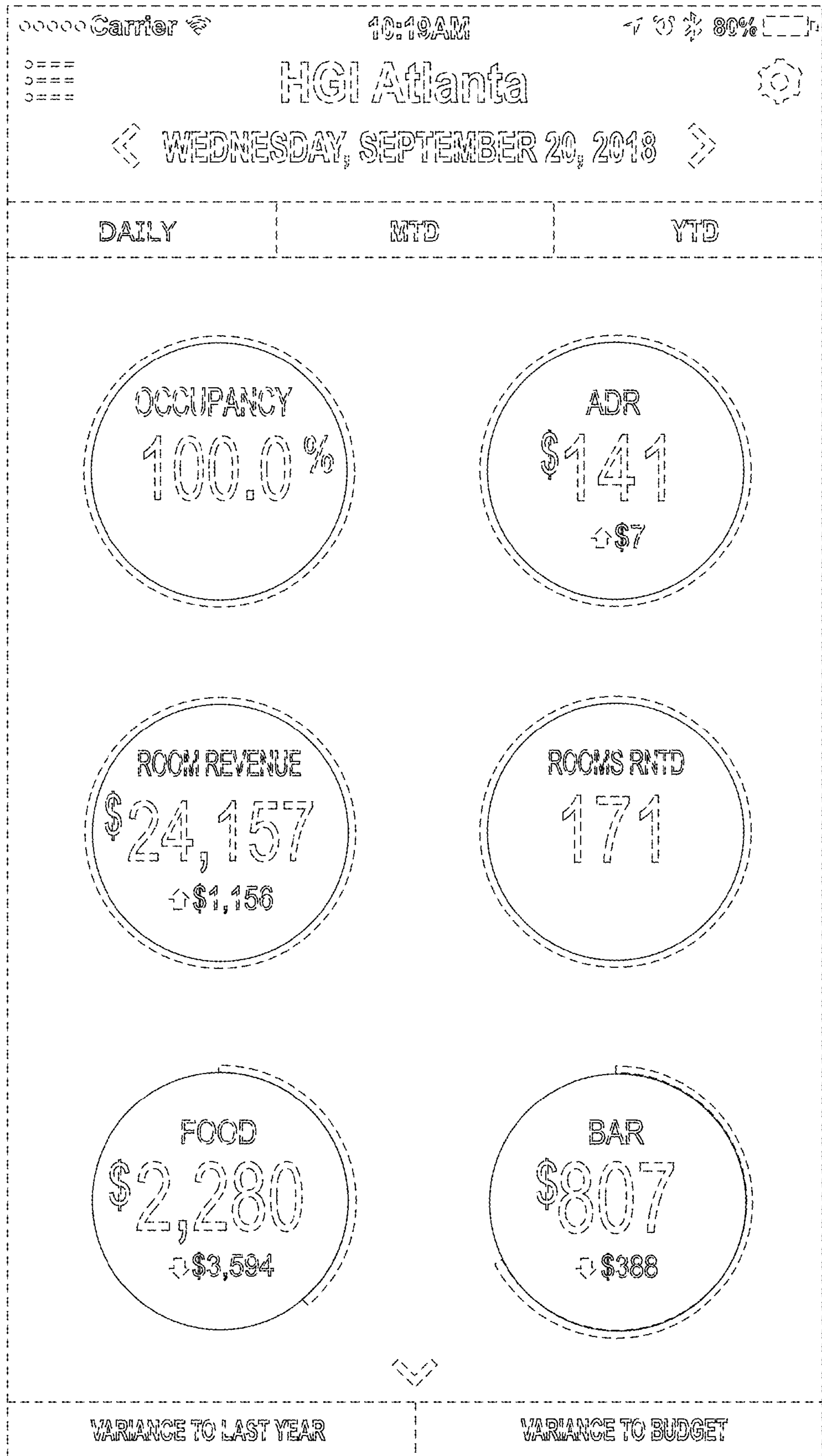

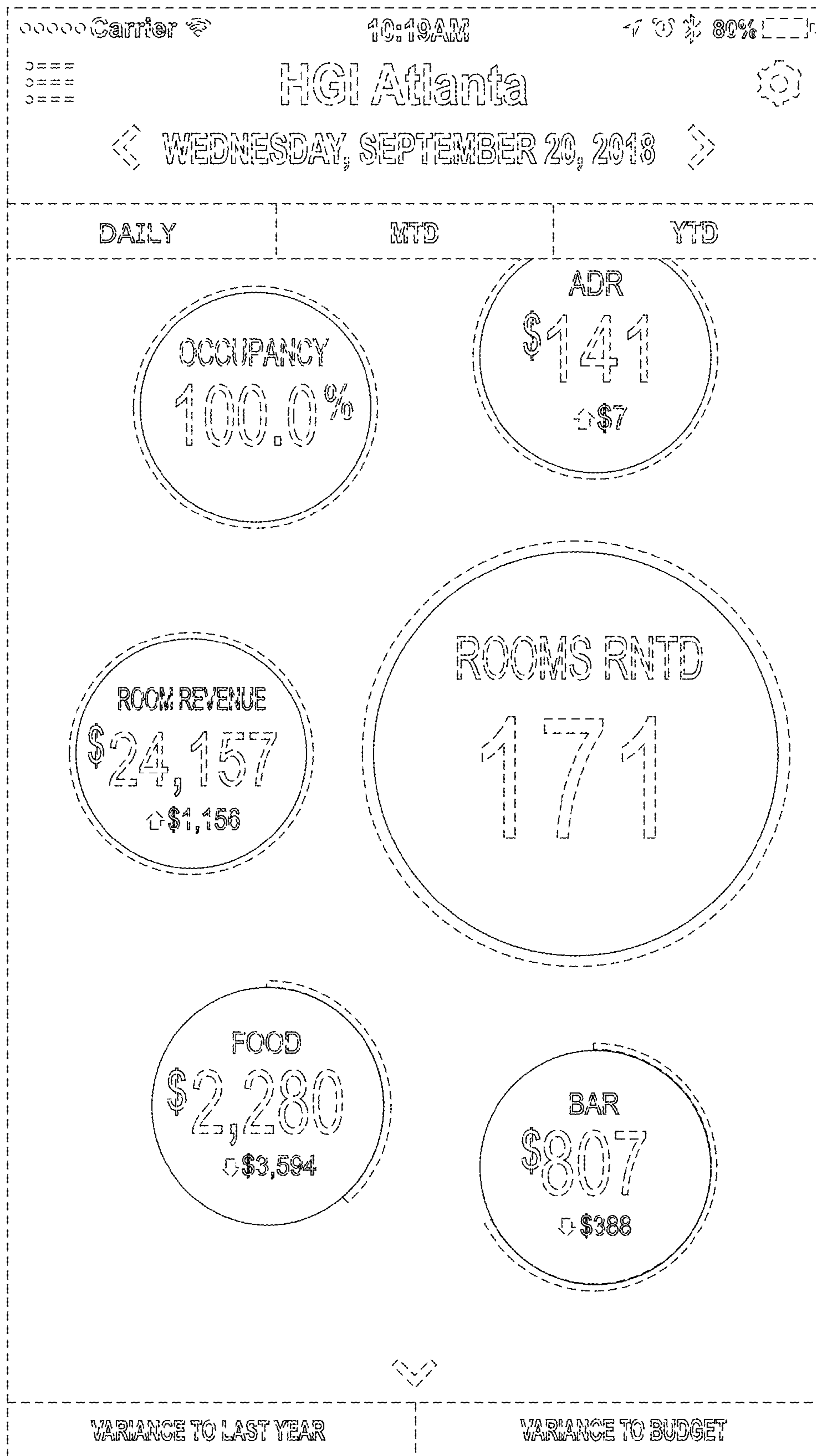

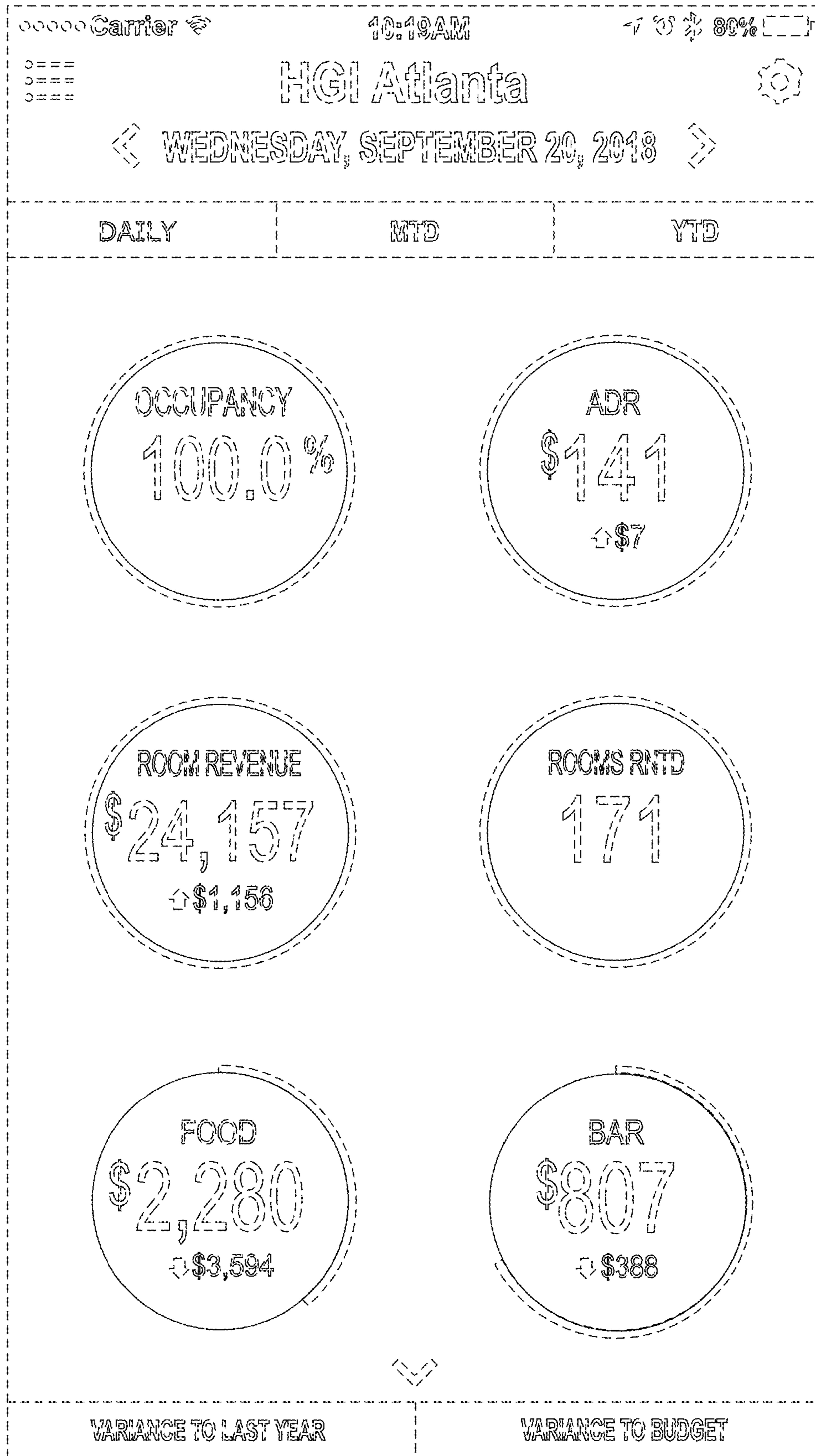

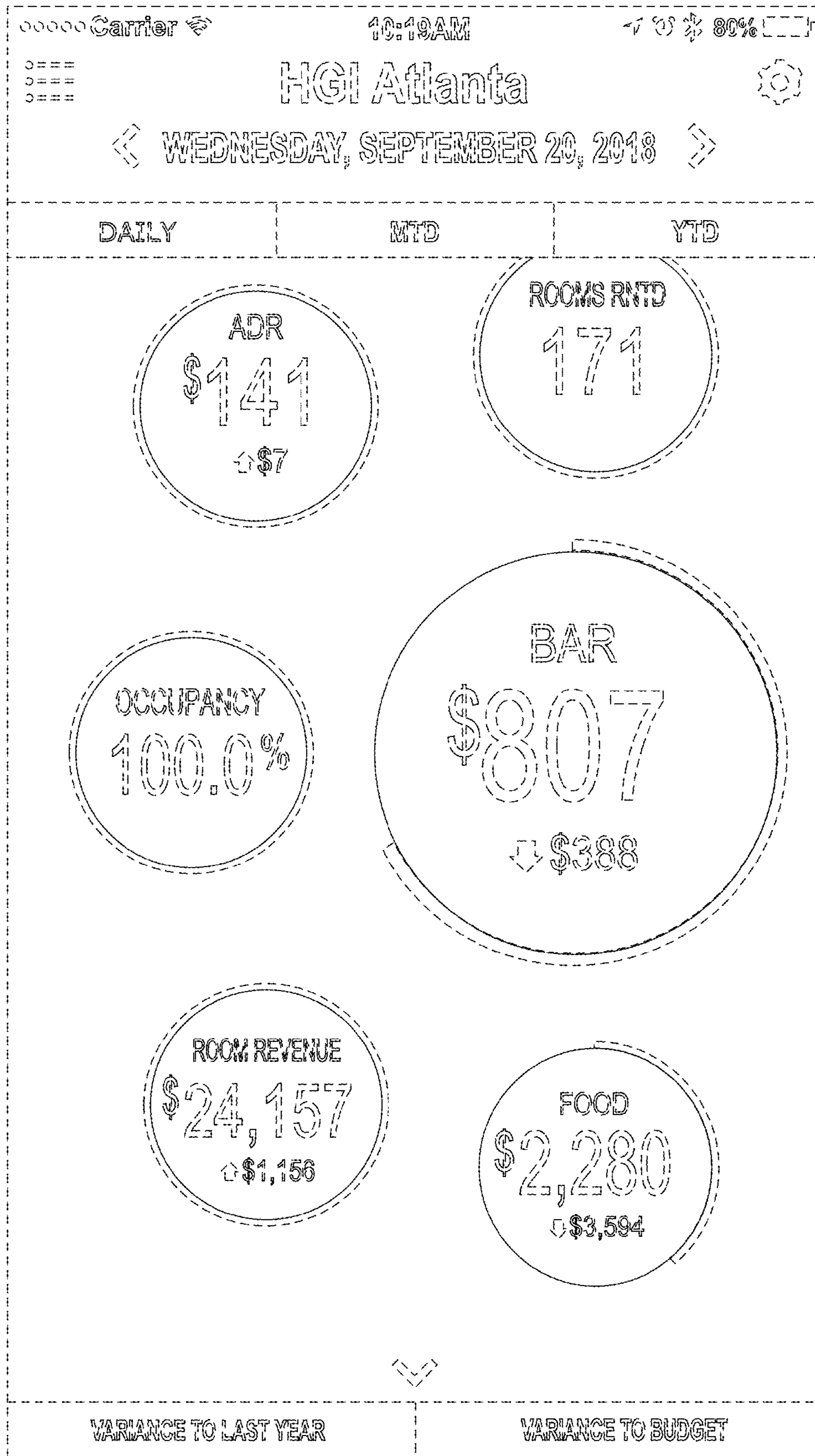
