DESCRIPTION

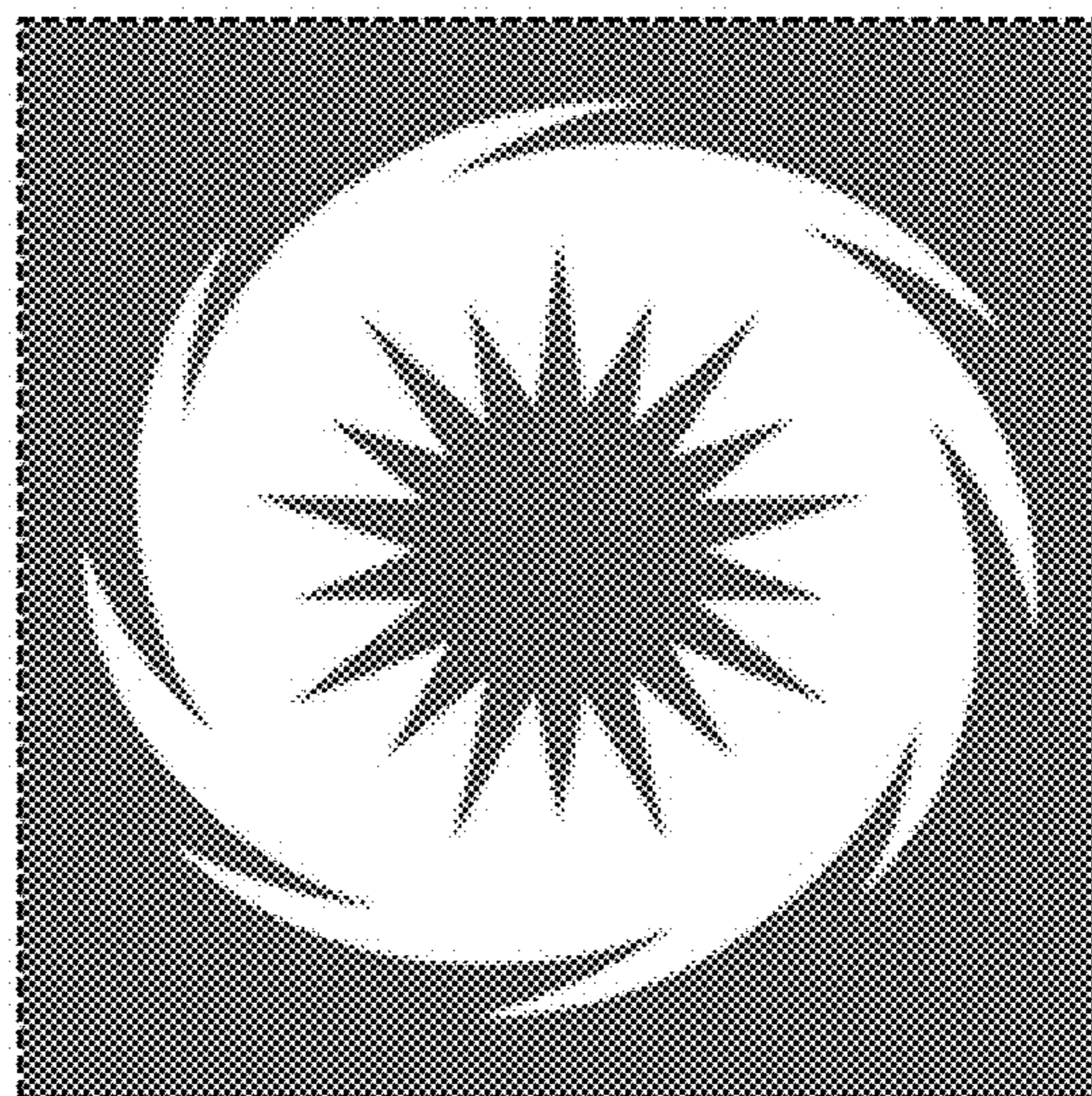
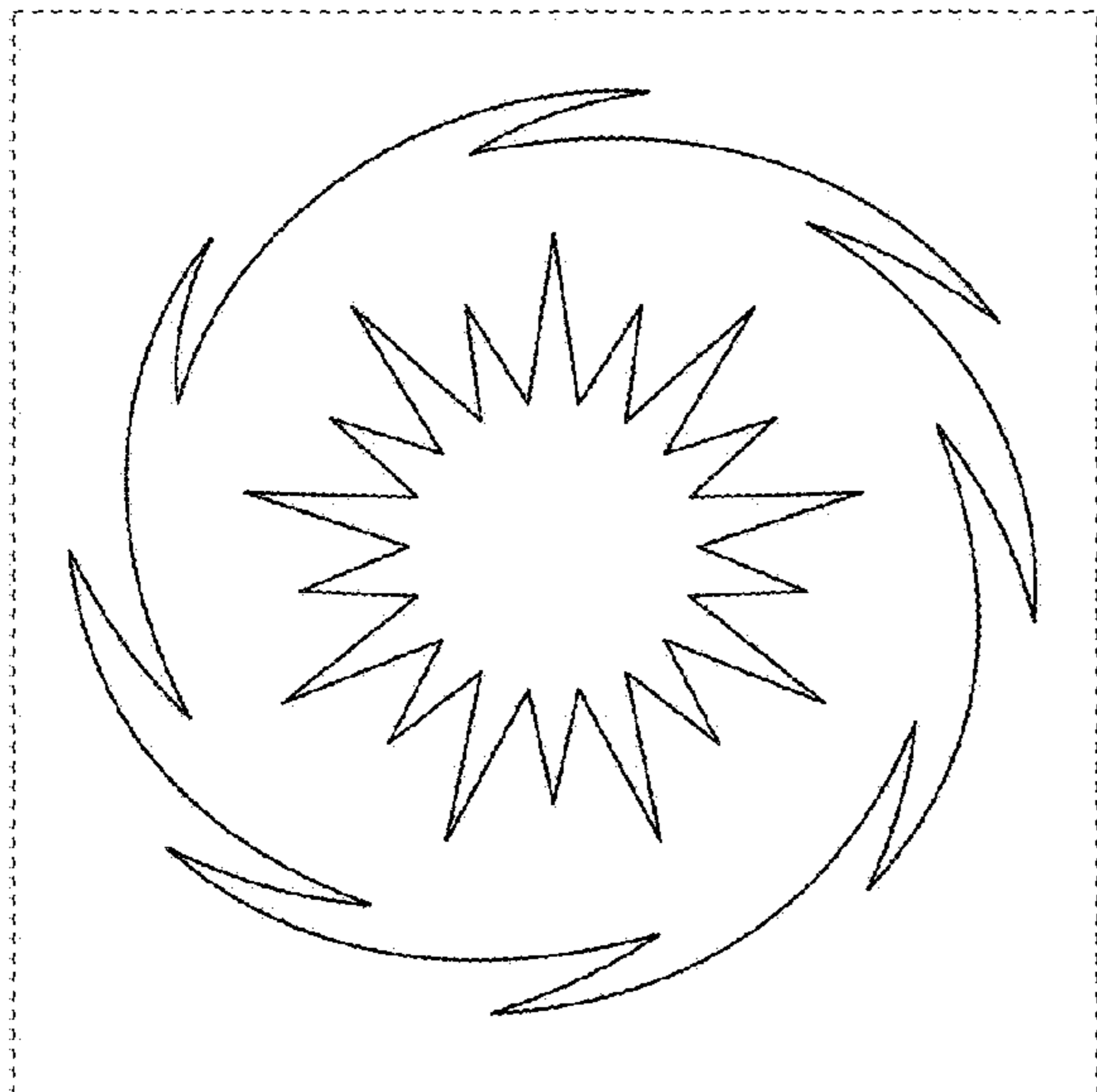

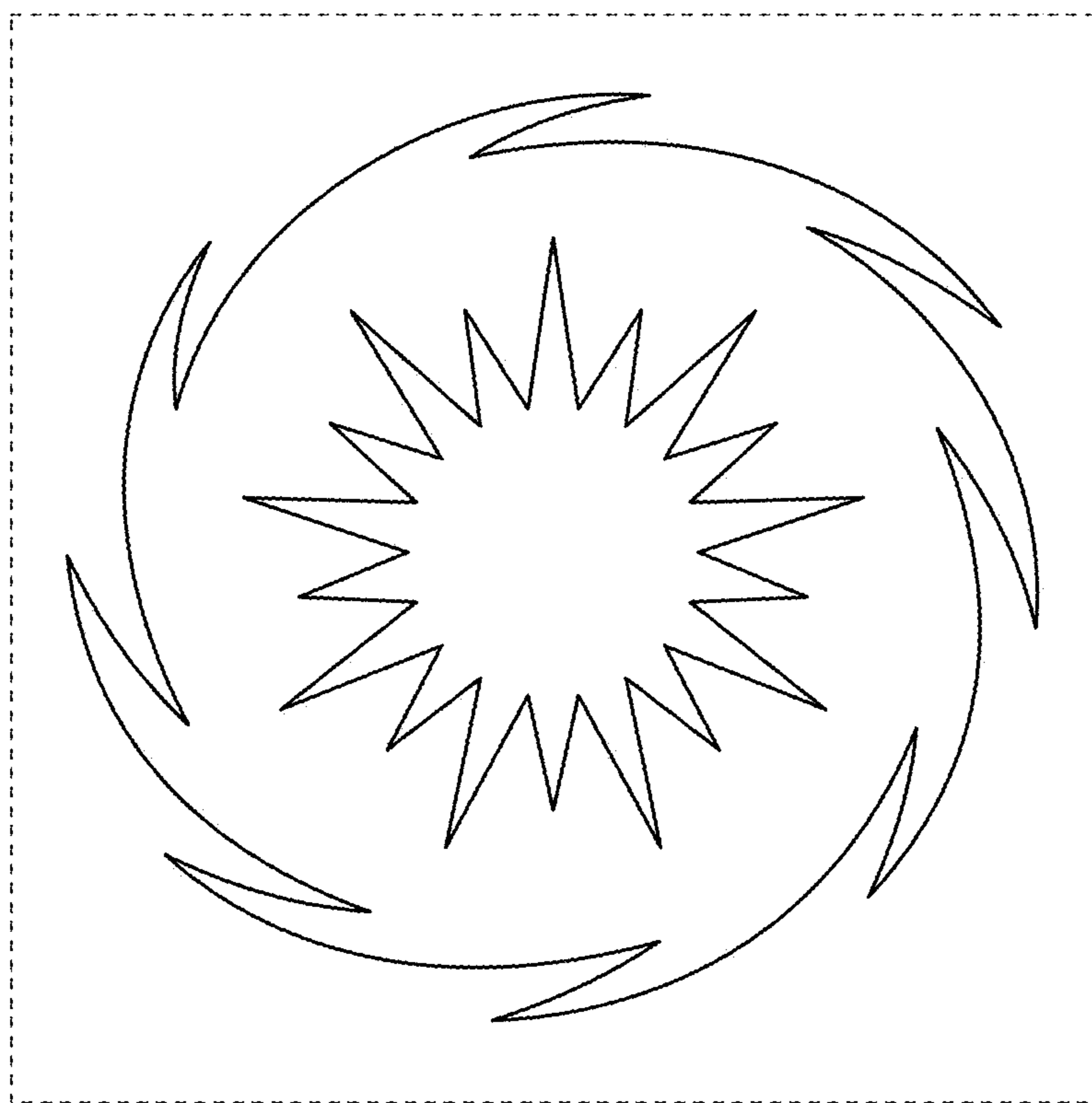

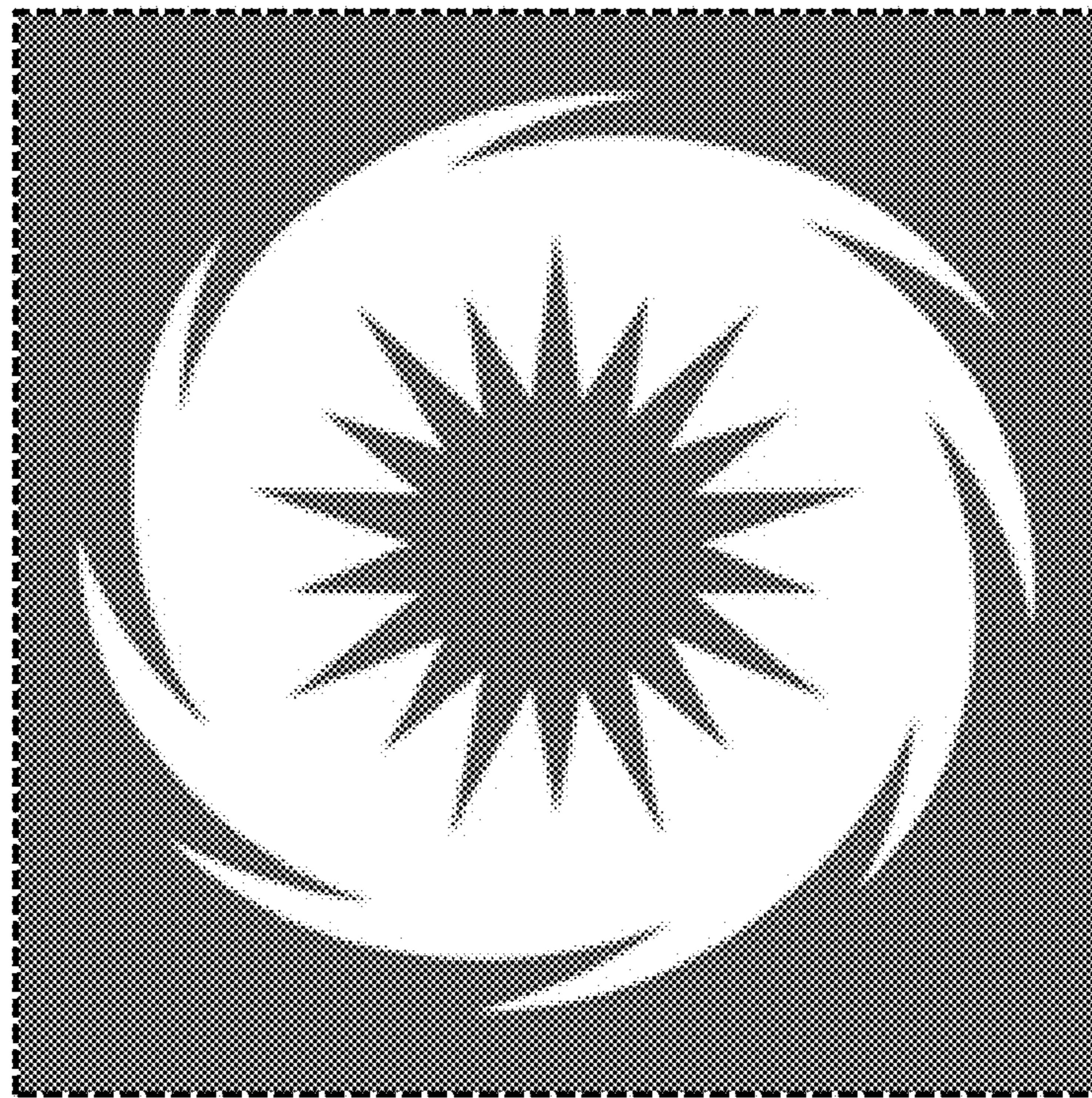
