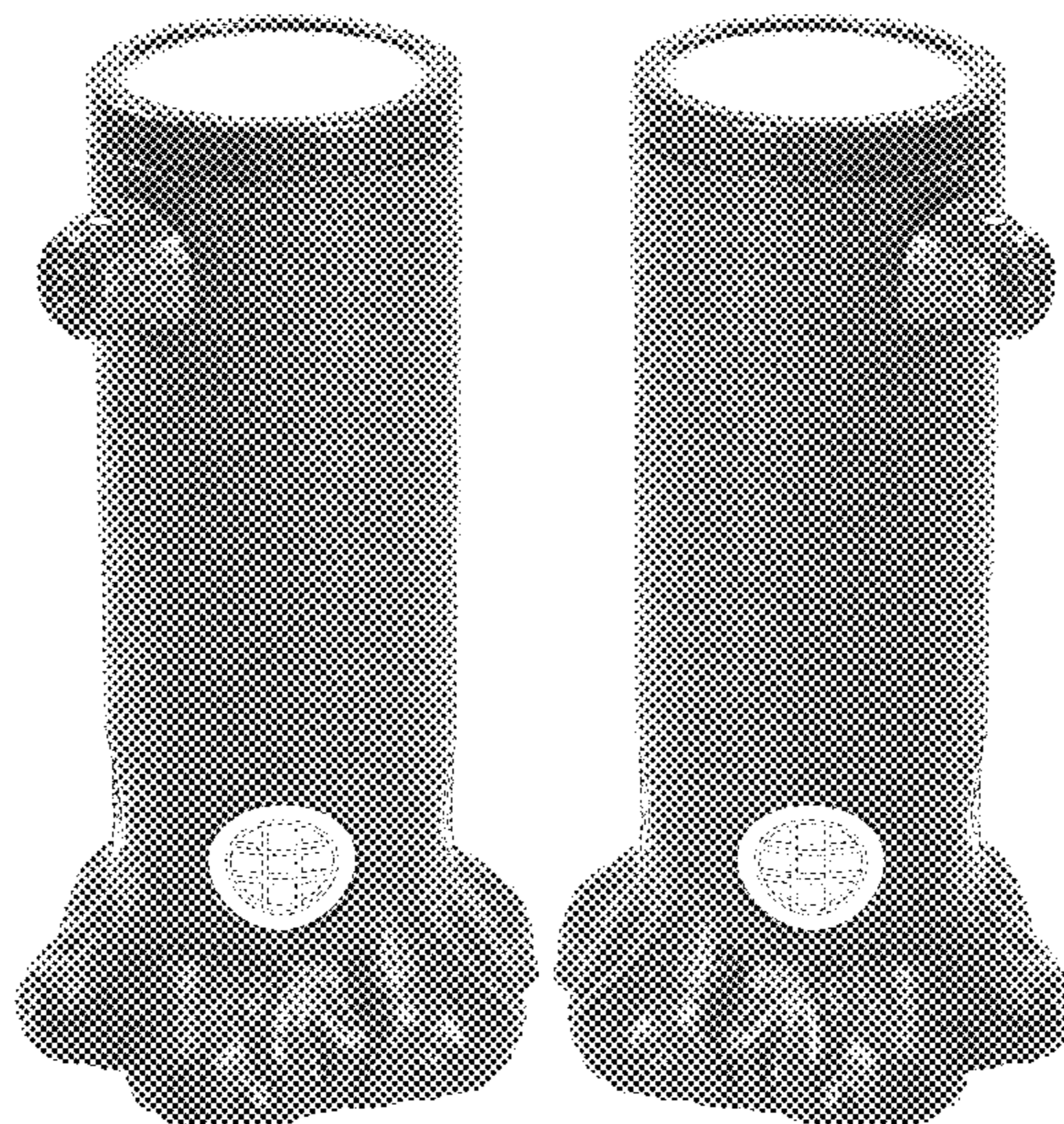
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front perspective view of a drum showing the first embodiment of my new design;

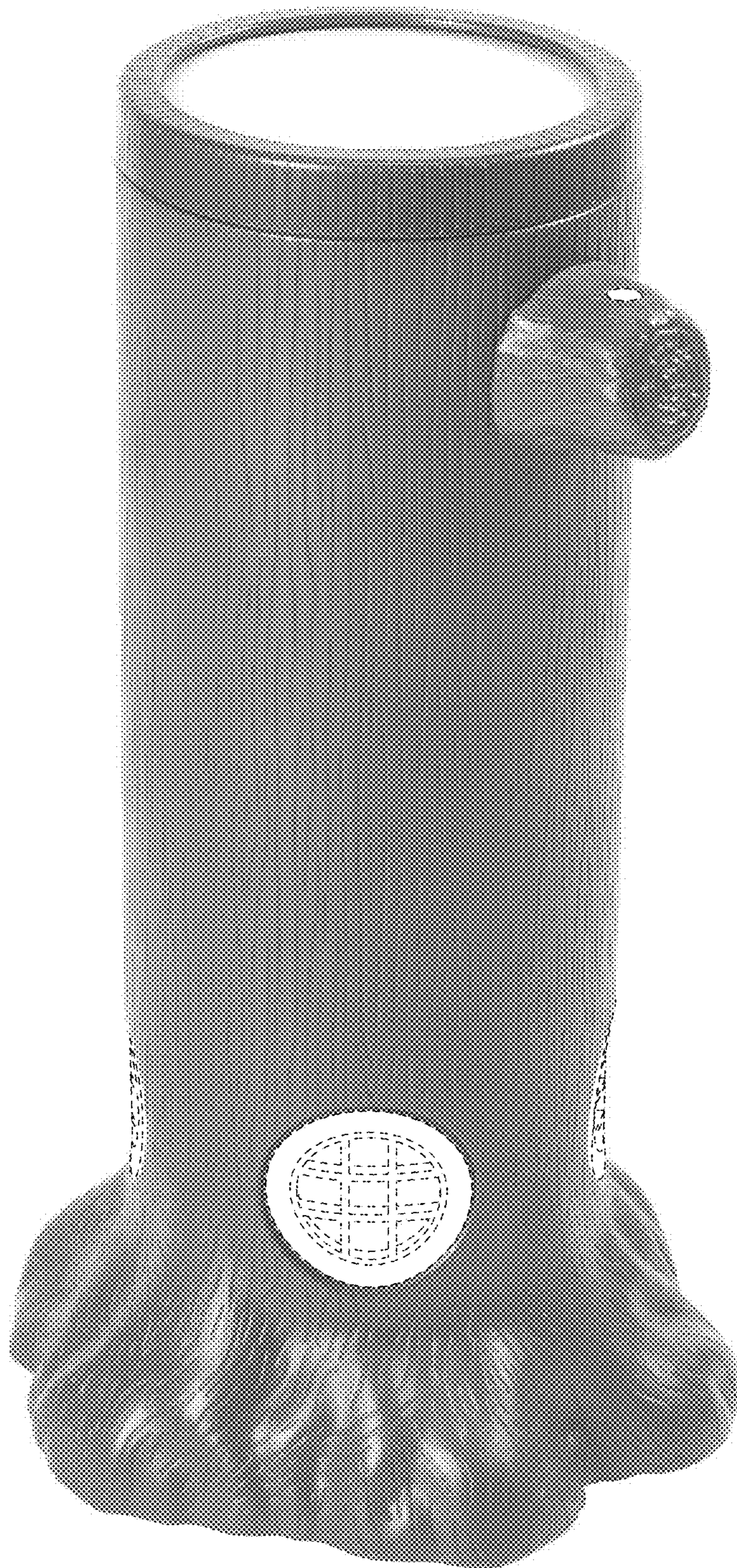

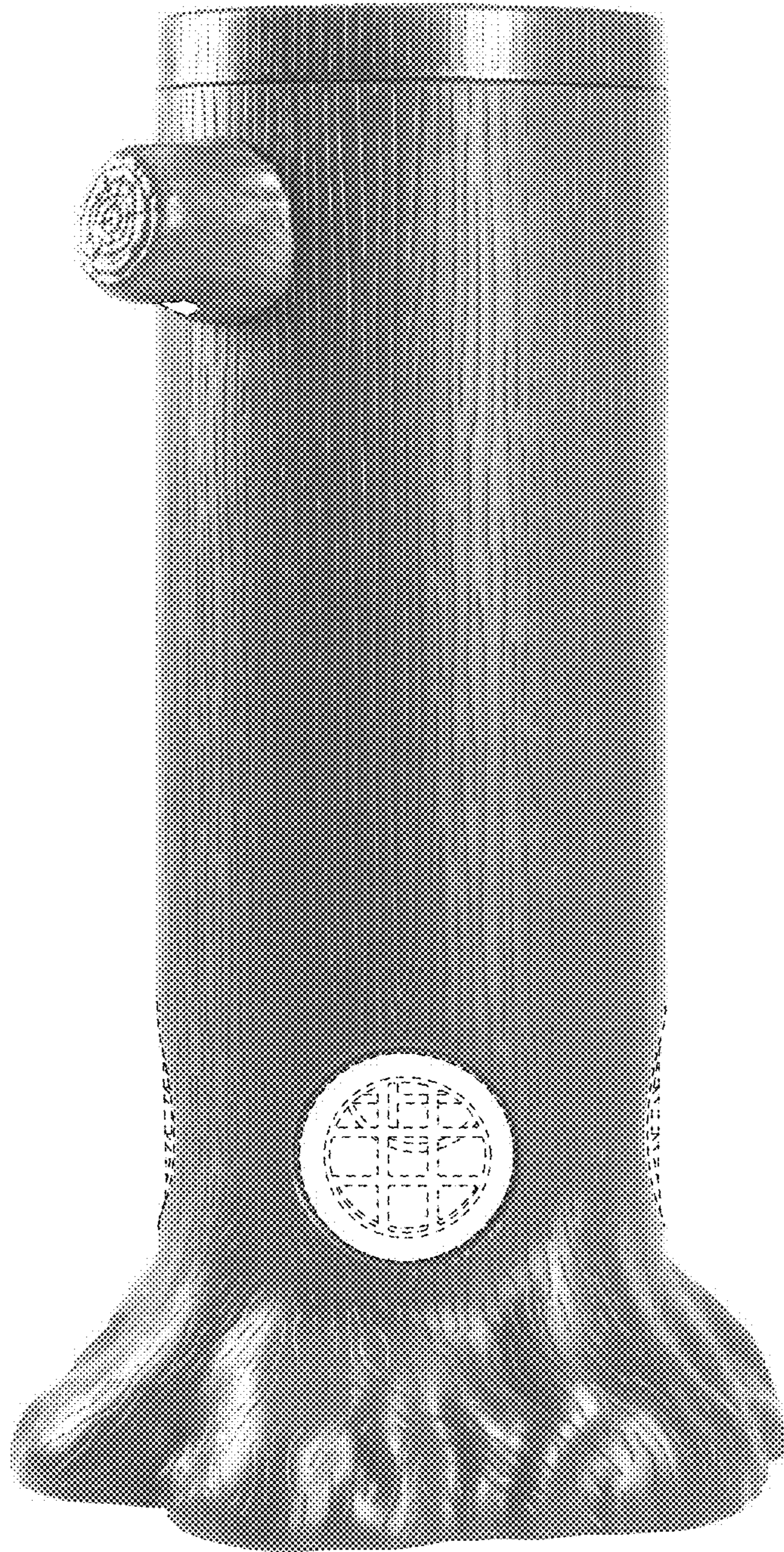

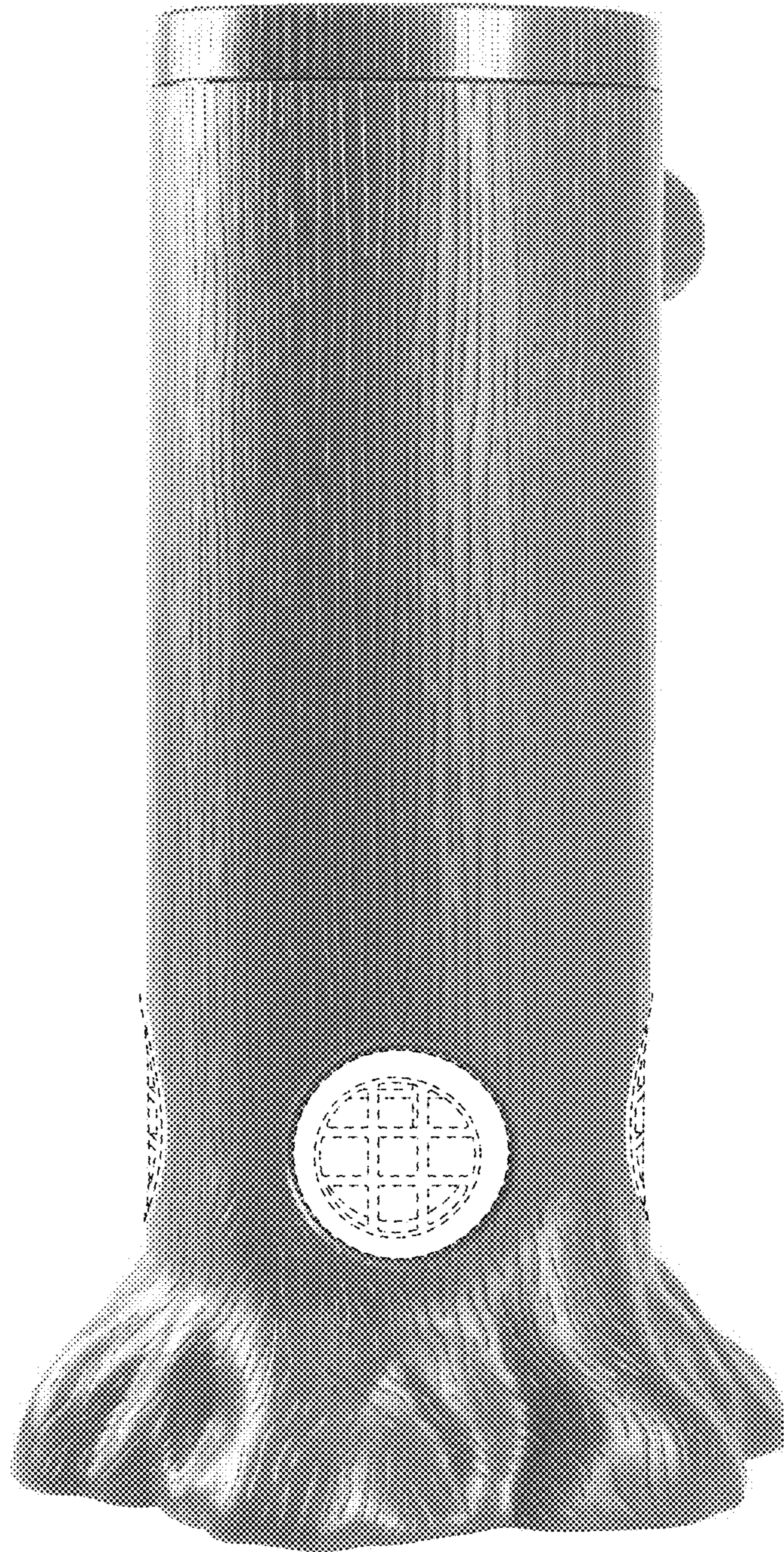

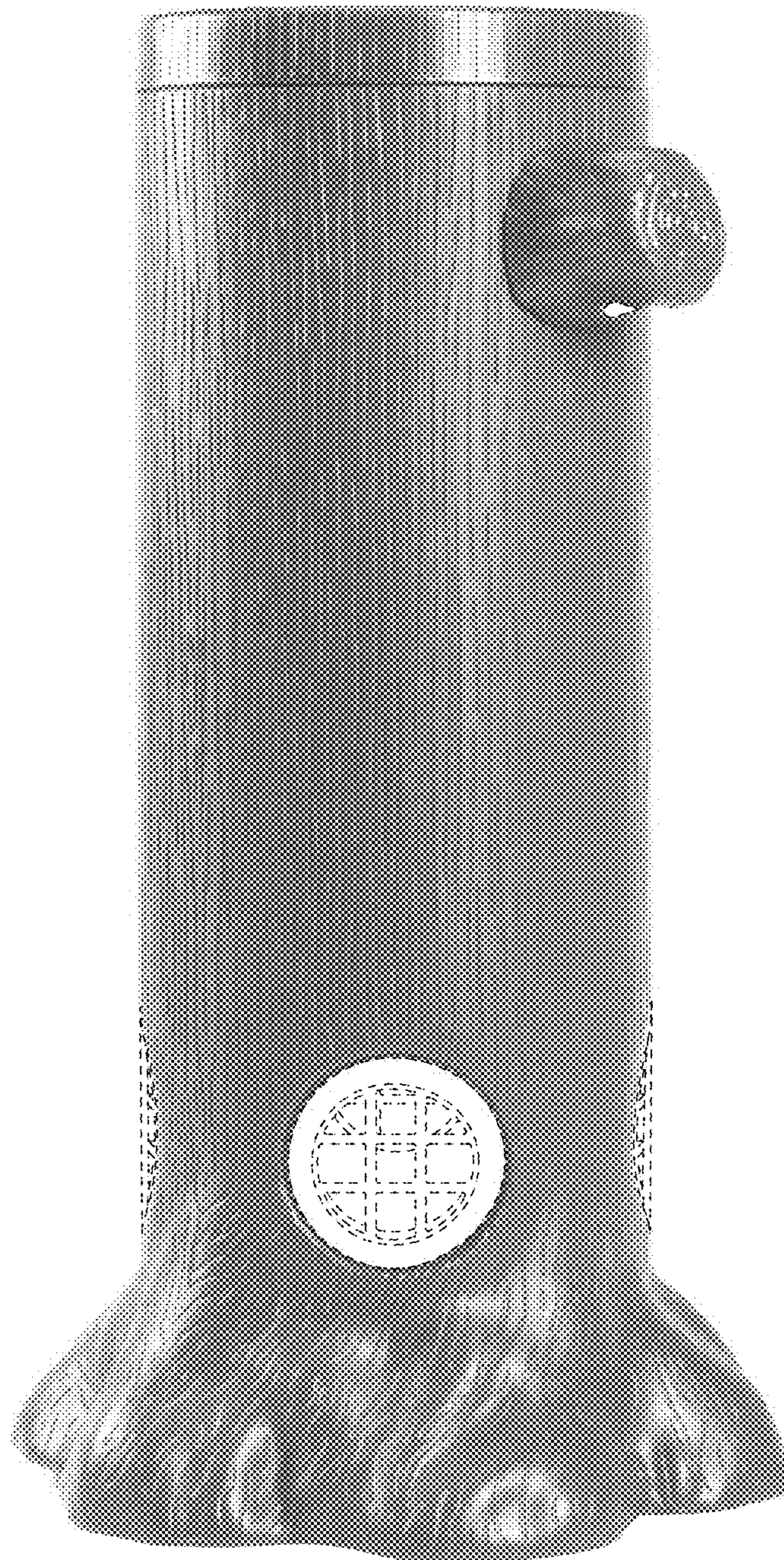

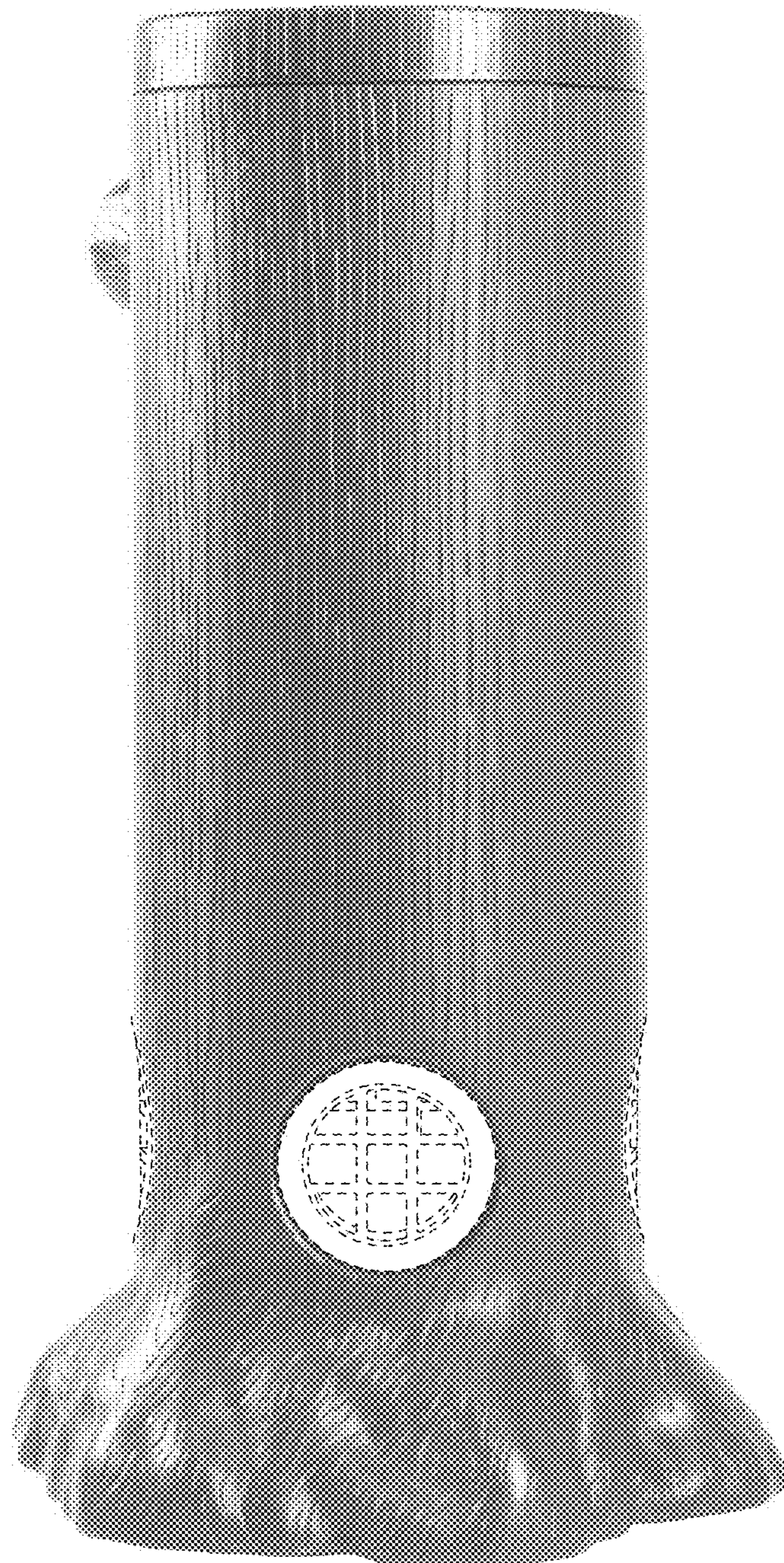

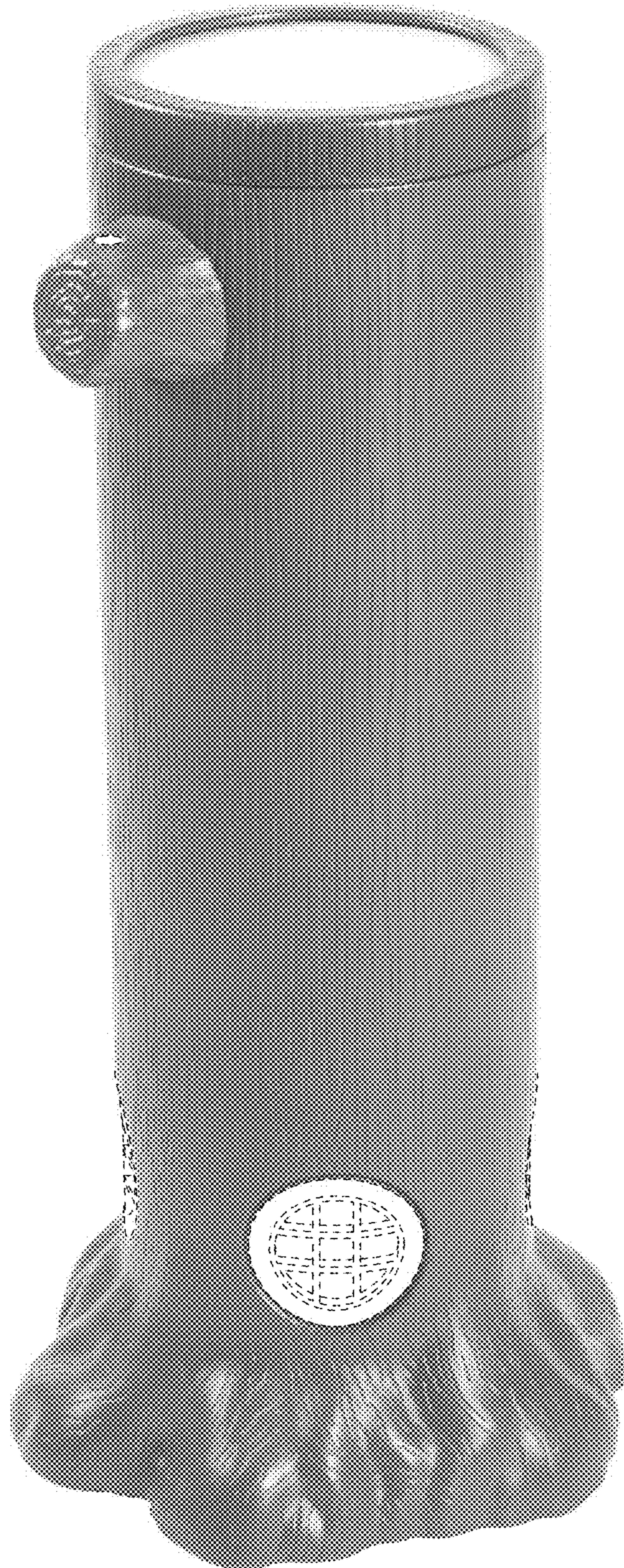

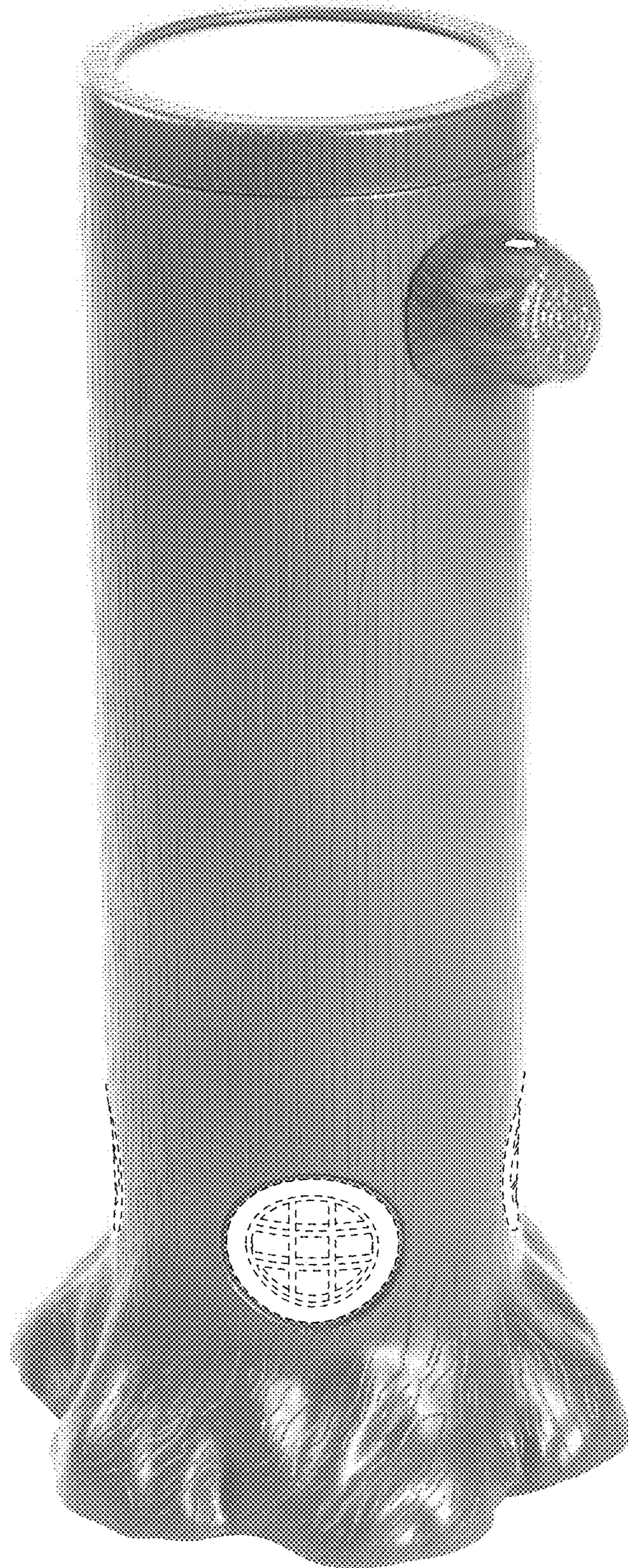

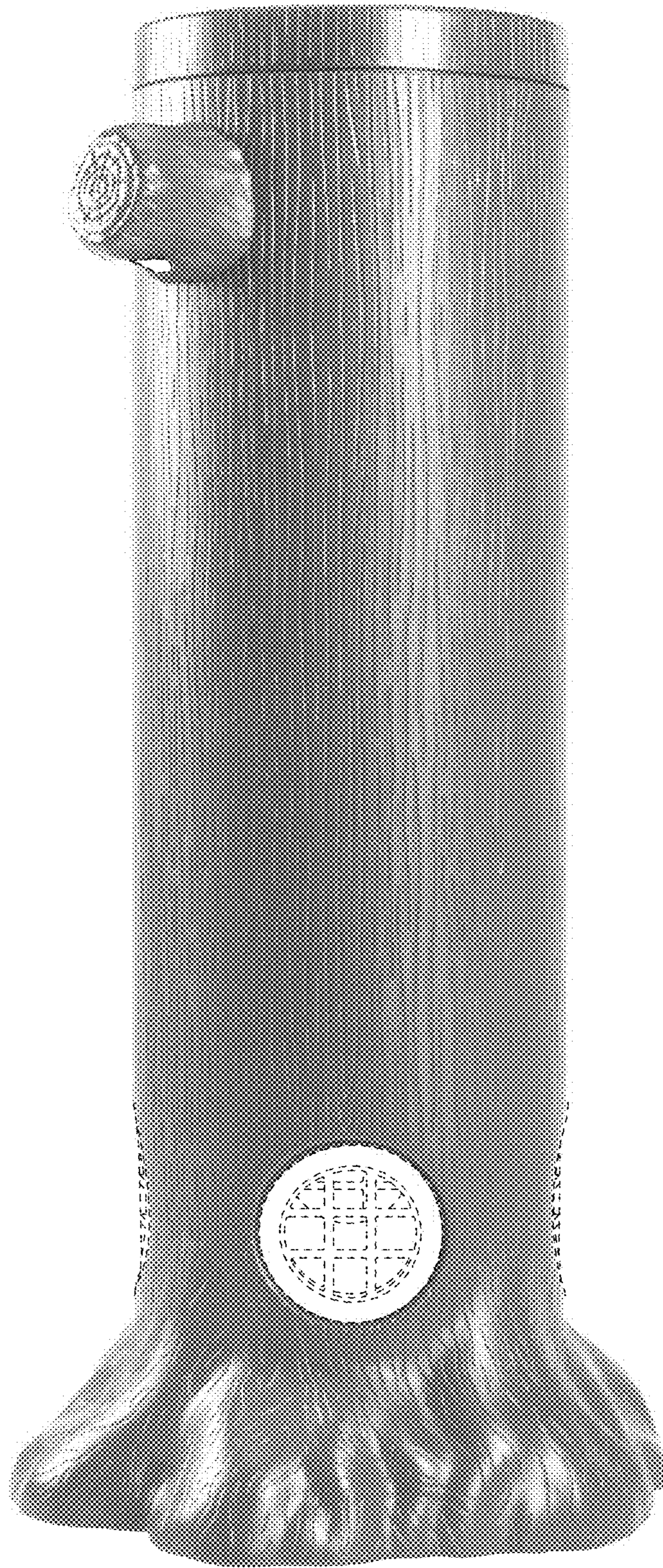

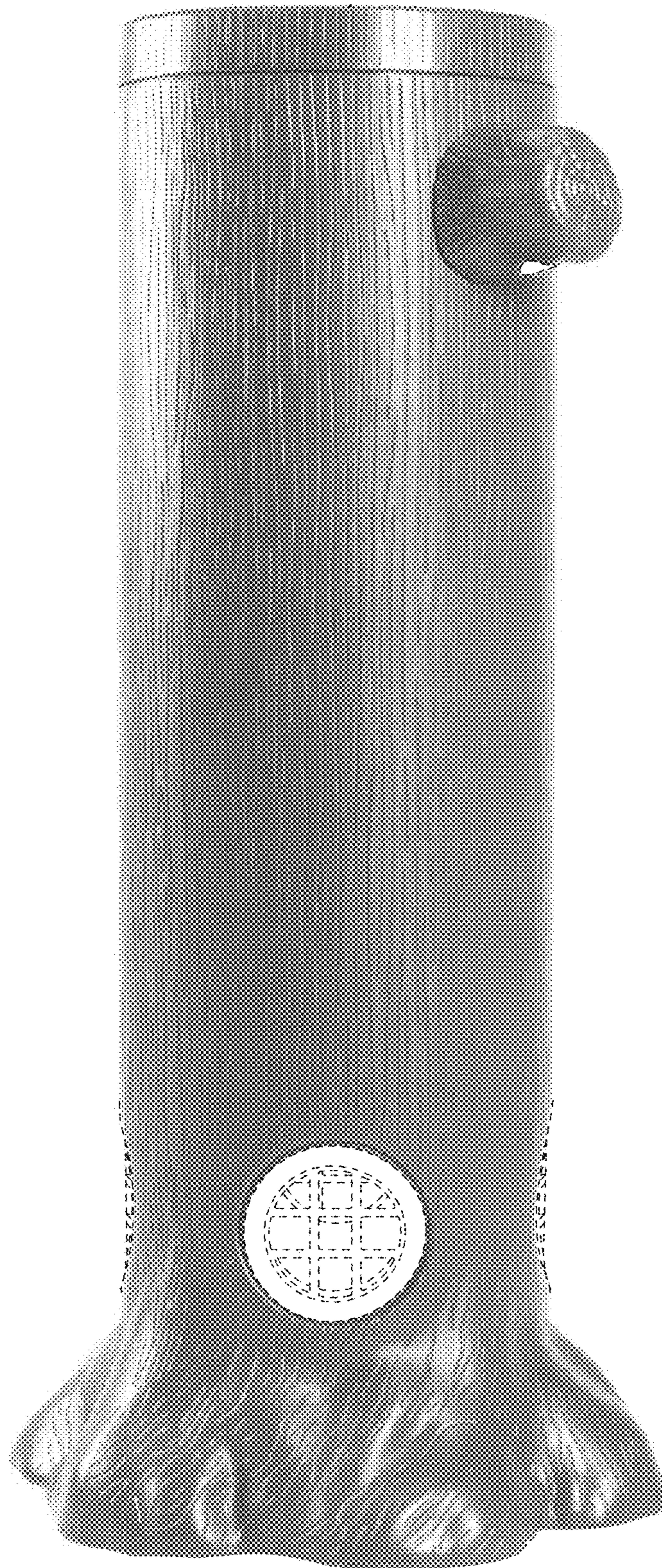

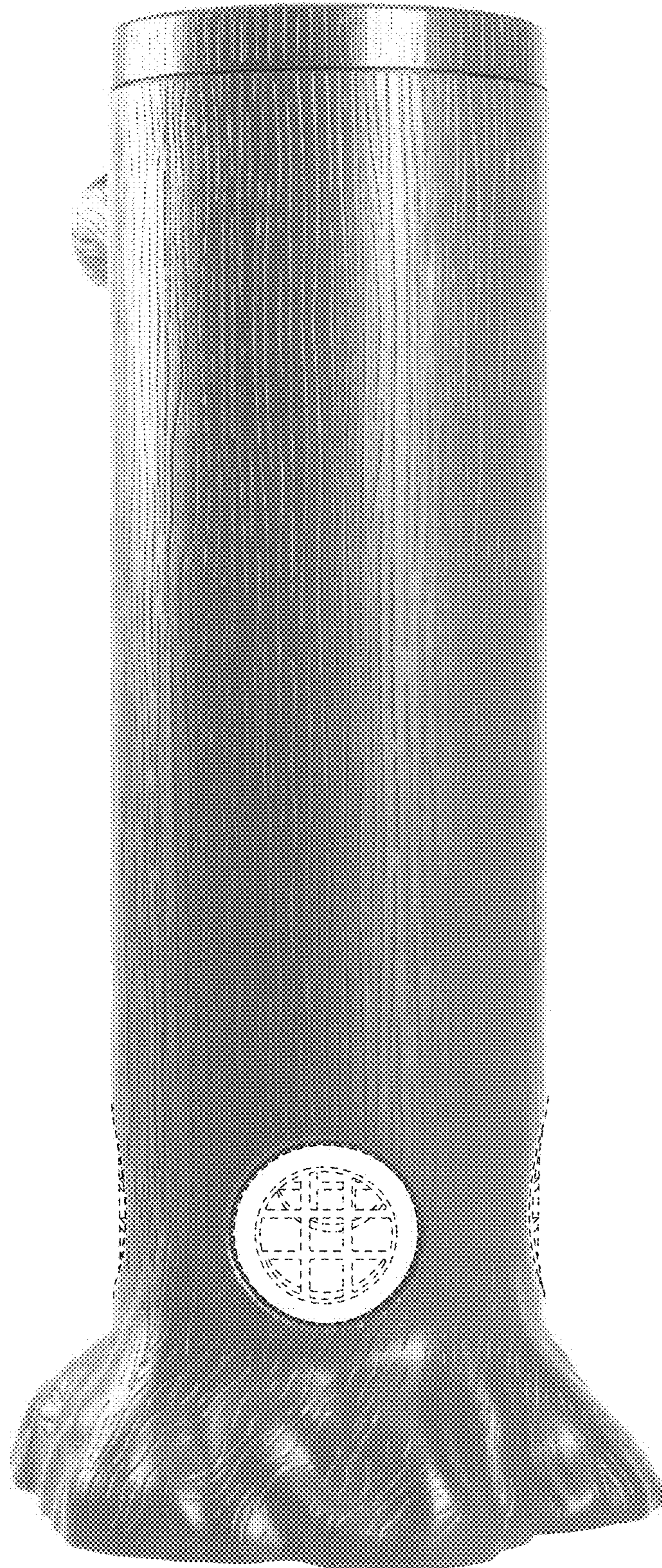

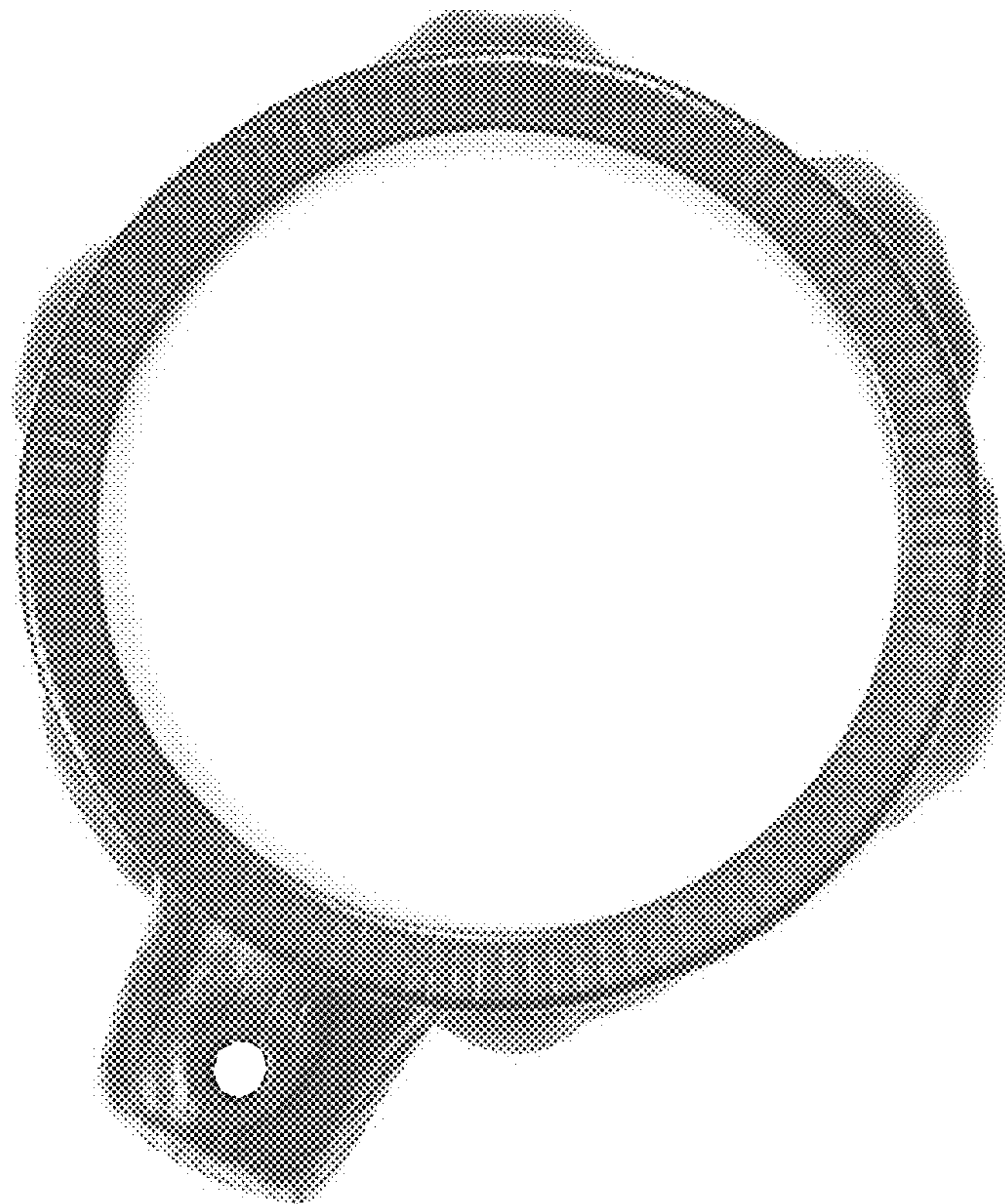
