FIG. 5 is a right side elevational view of FIG. 1;

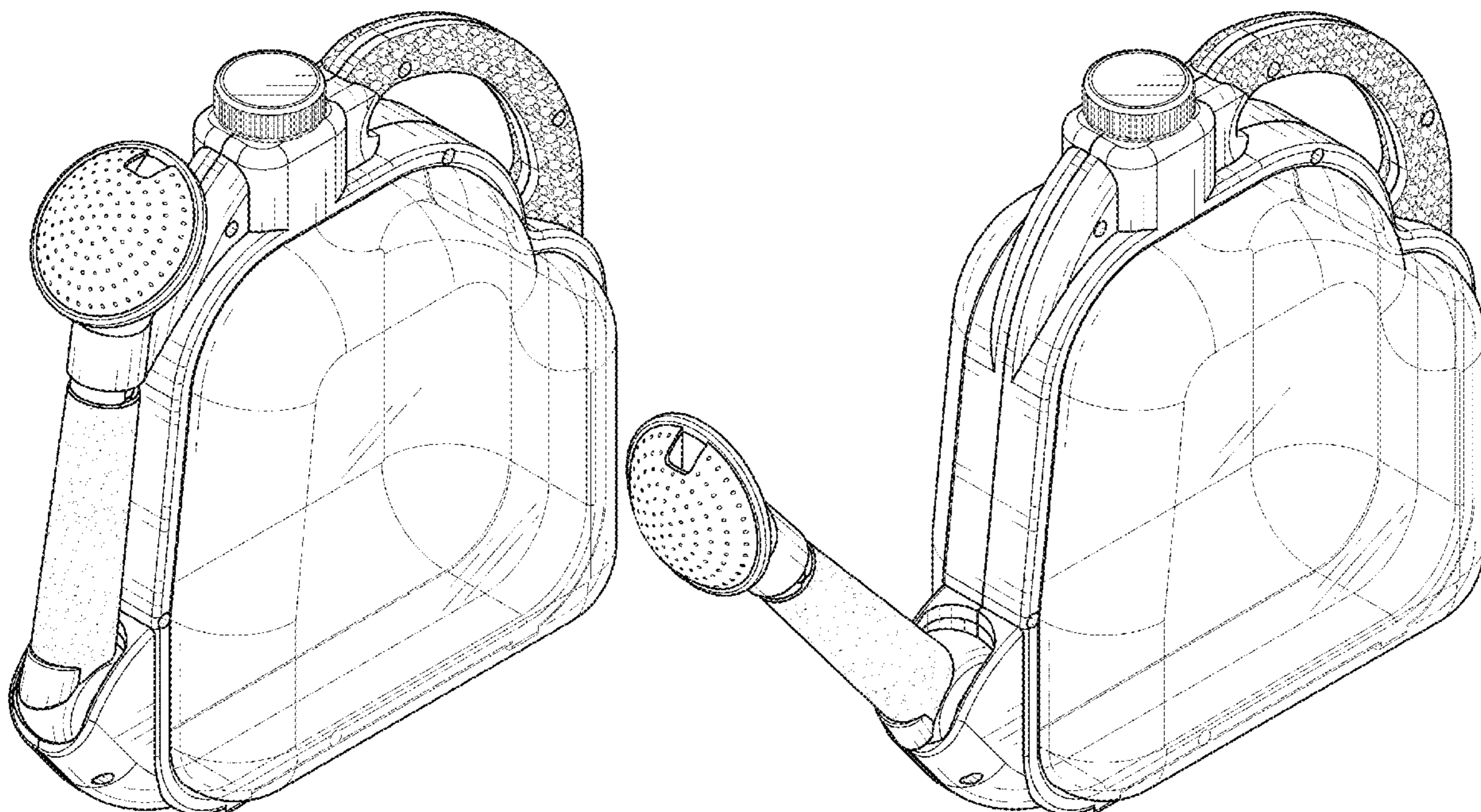
FIG. 6 is a top plan view of FIG. 1;

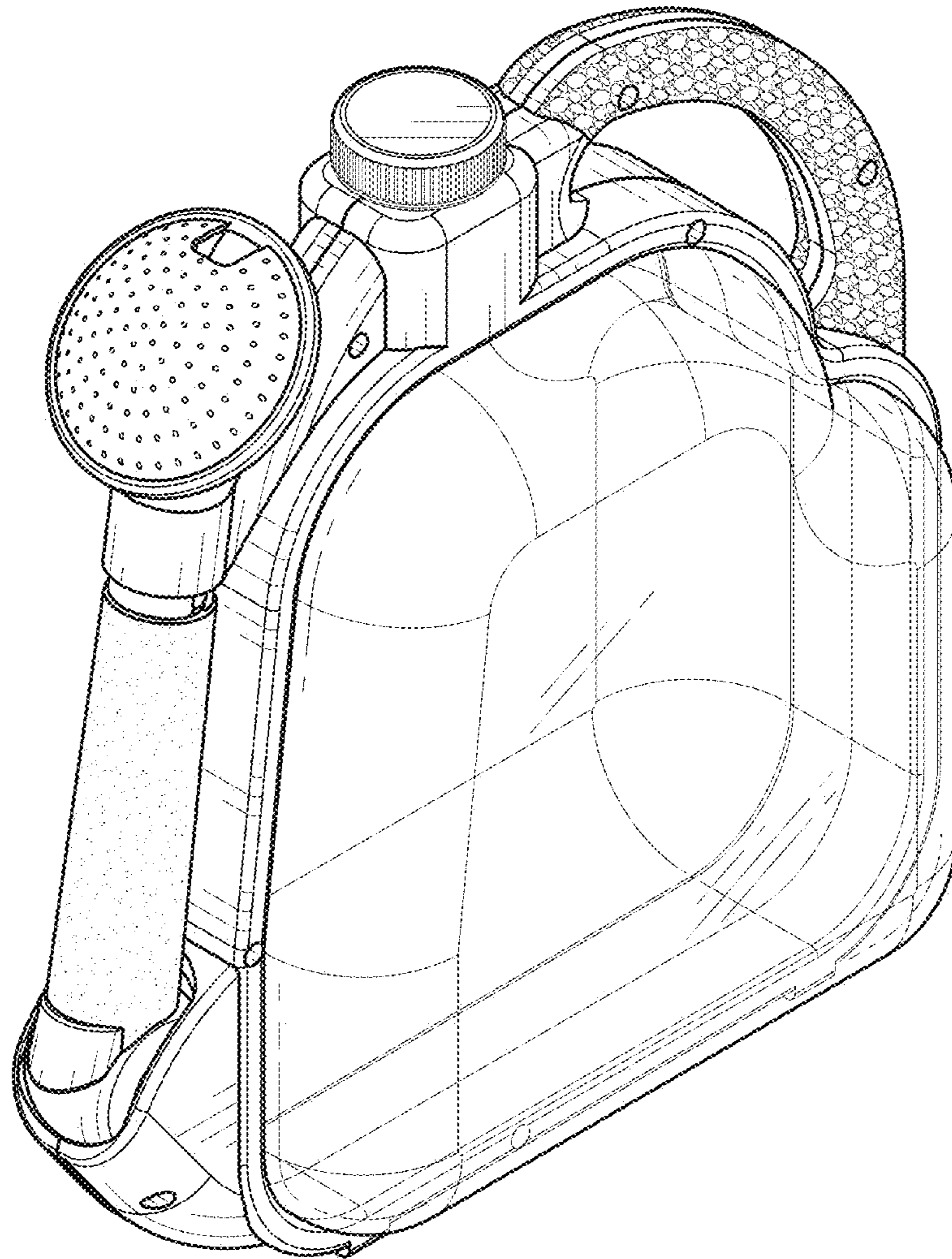

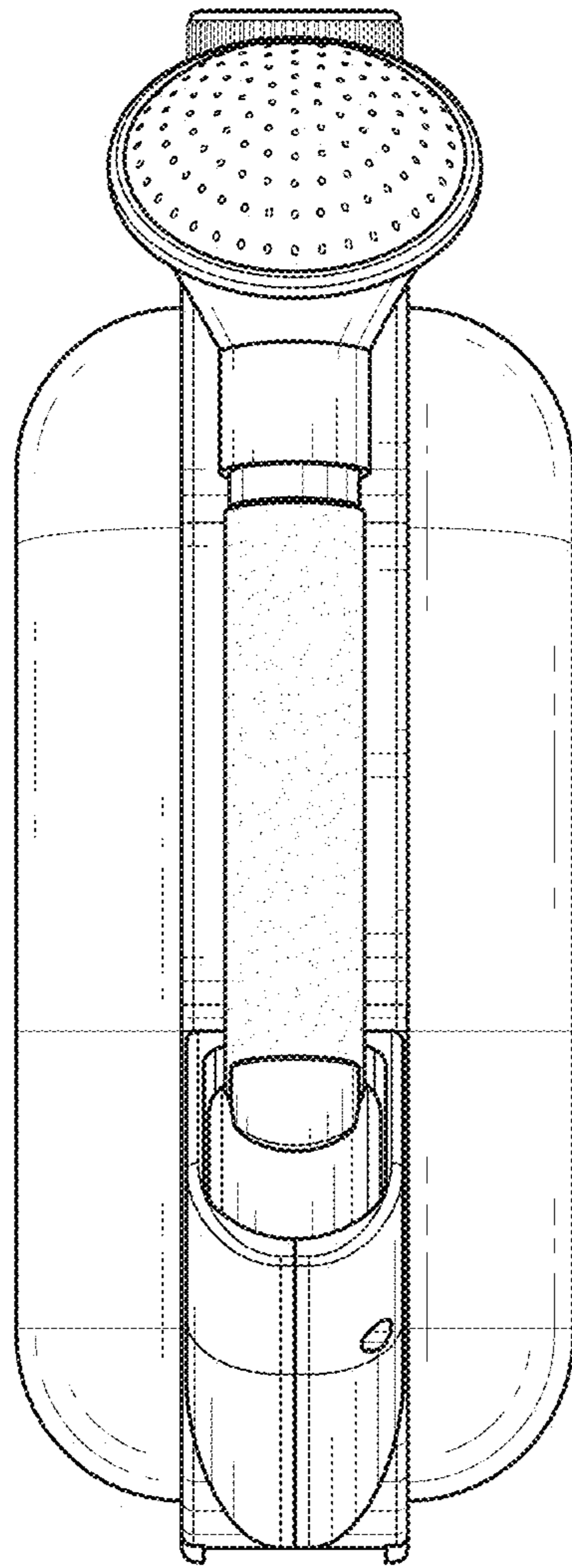

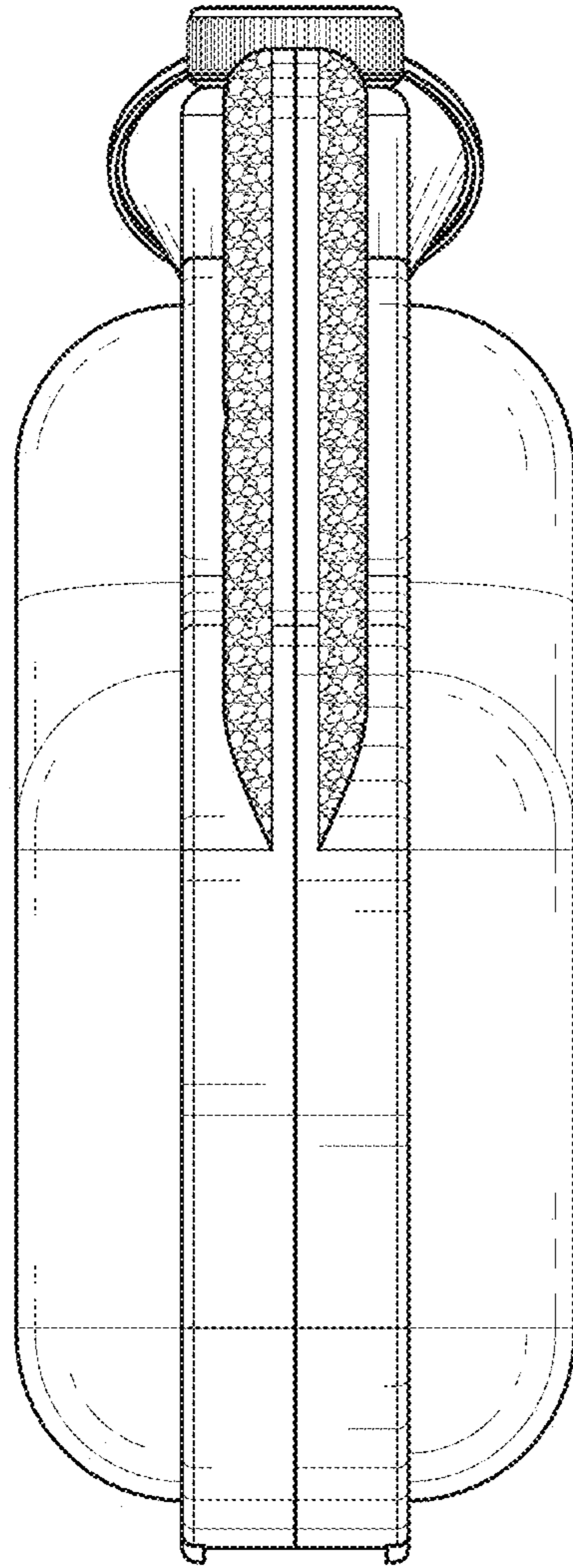

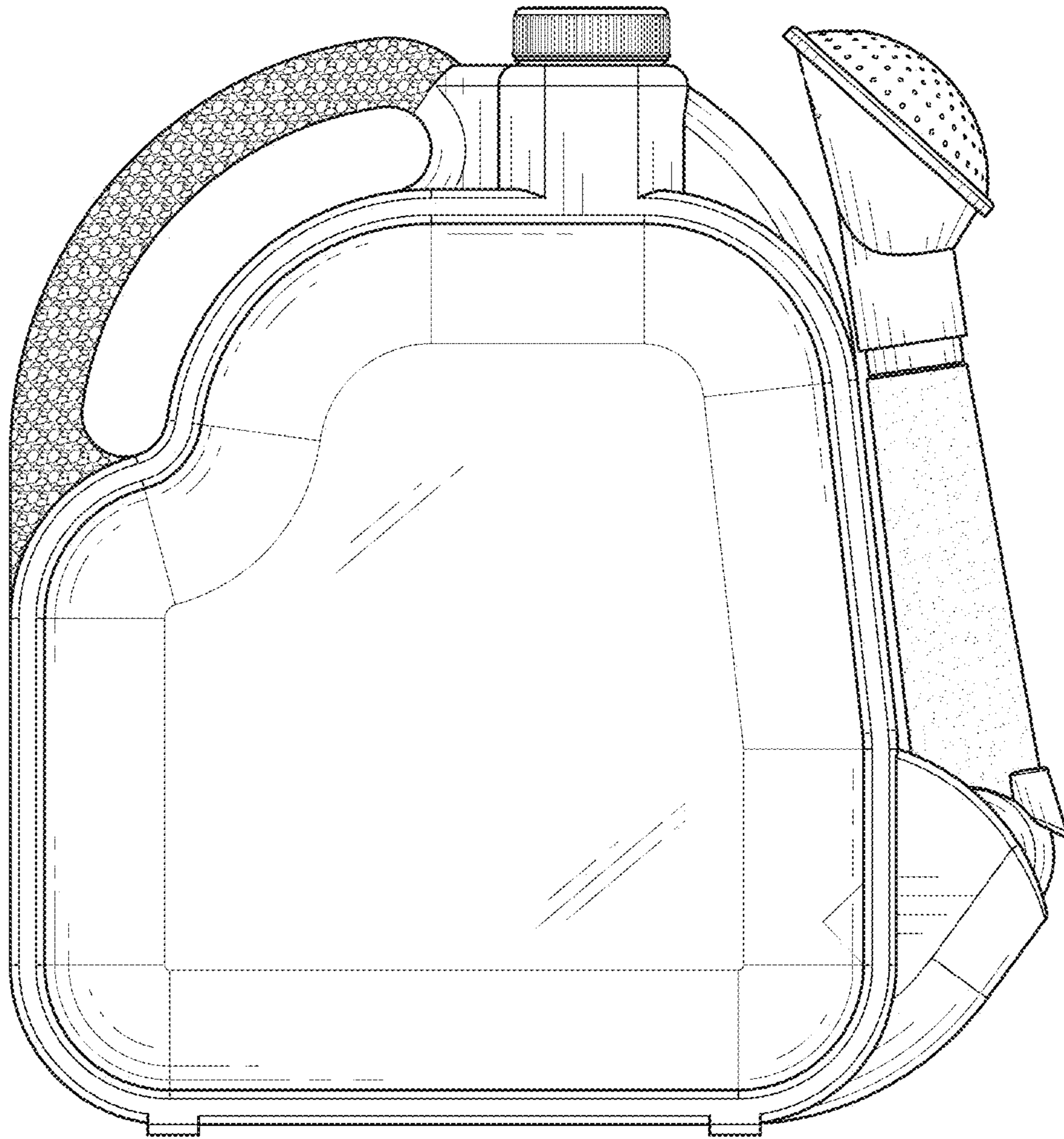

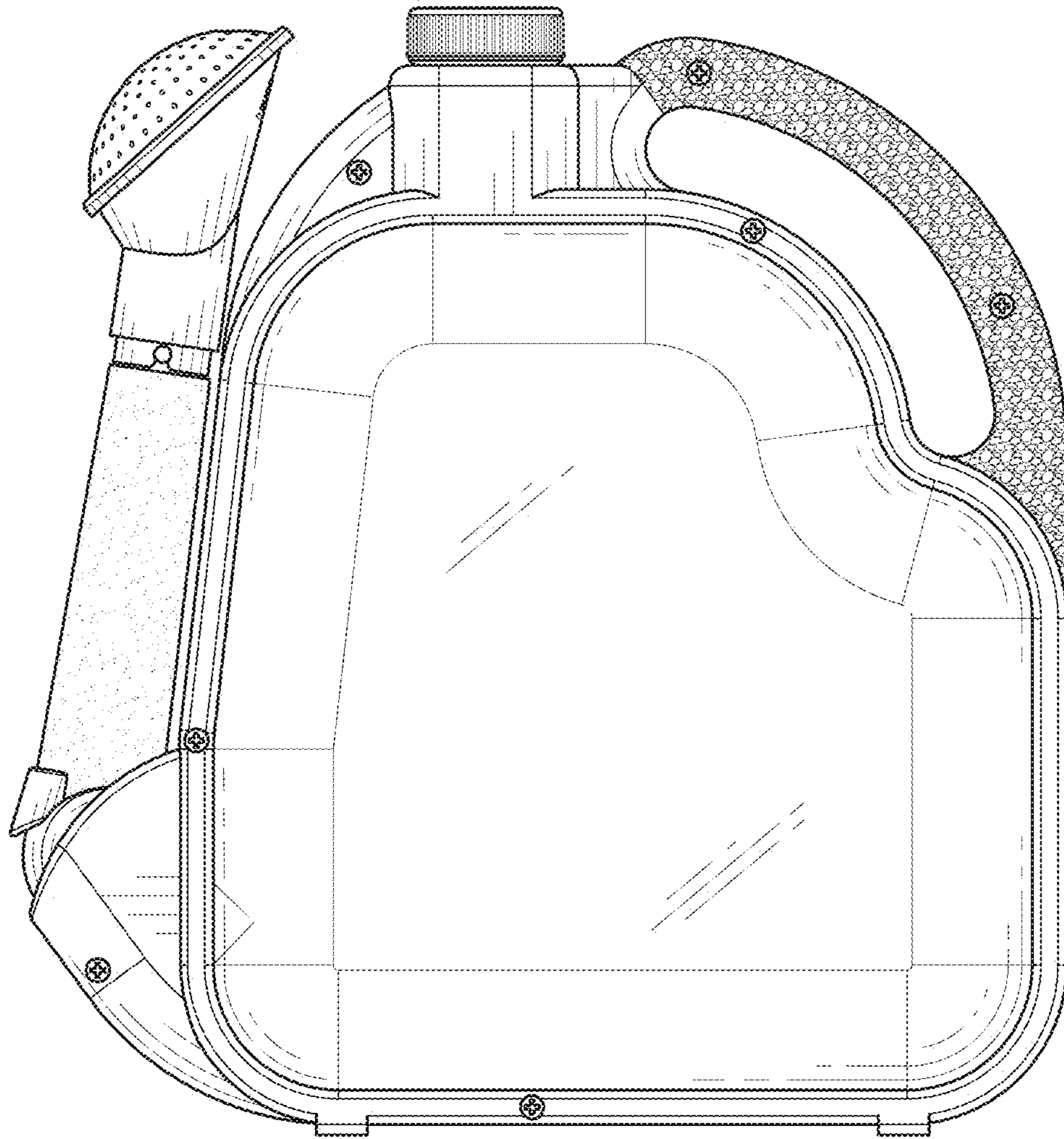

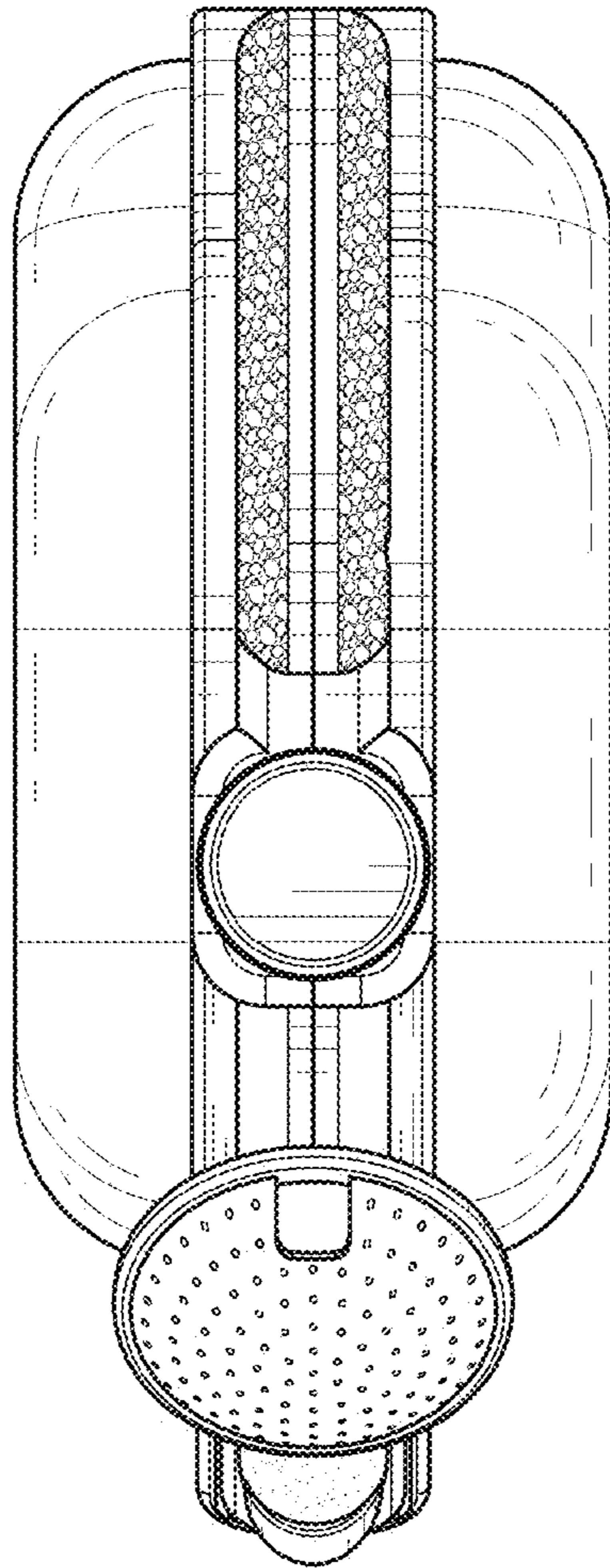

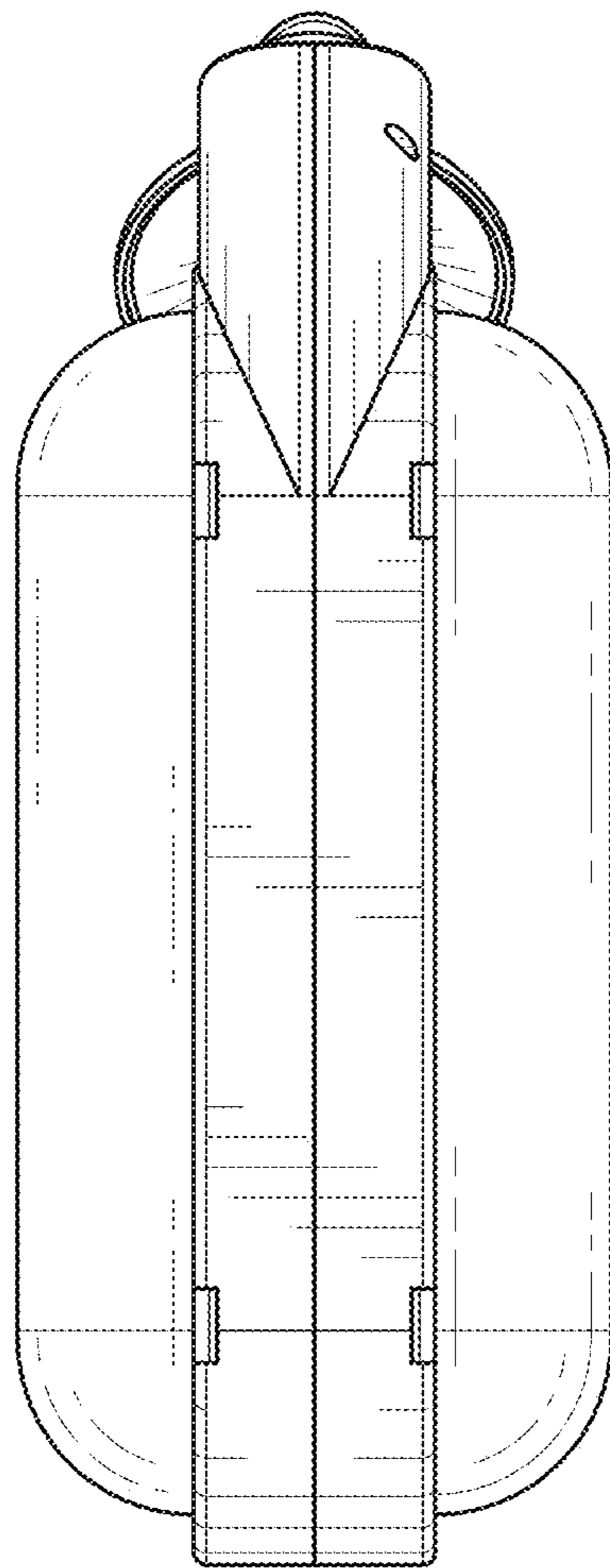

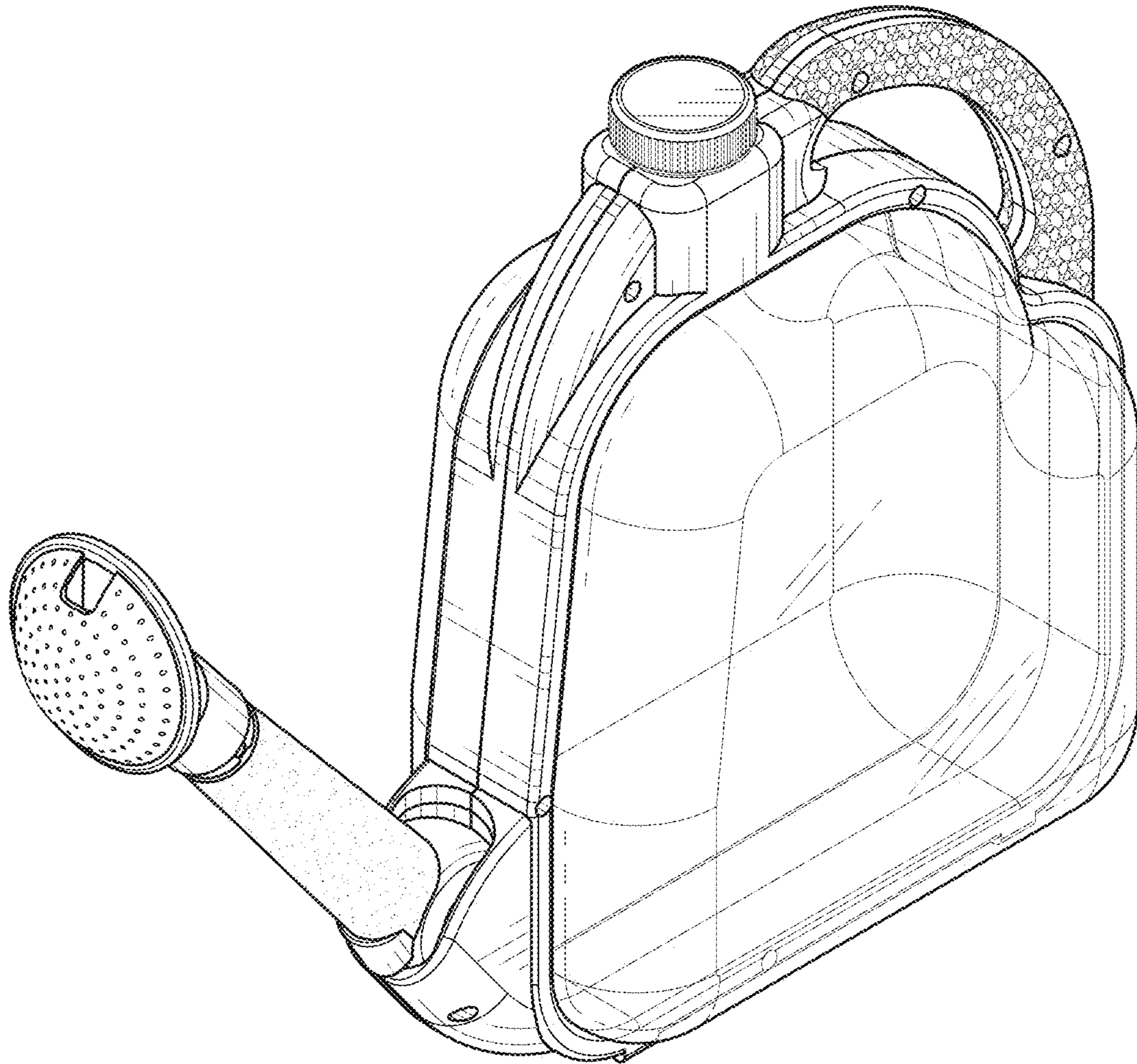
