(57) **CLAIM**

The ornamental design for an end cap seal, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of an end cap seal in accordance with the claimed design;

FIG. 2 is a rear right perspective view of the design of FIG. 1;

FIG. 3 is a front elevation view of the design of FIG. 1;

FIG. 4 is a right side elevation view of the design of FIG. 1, the left side elevation view is a mirror image thereof;

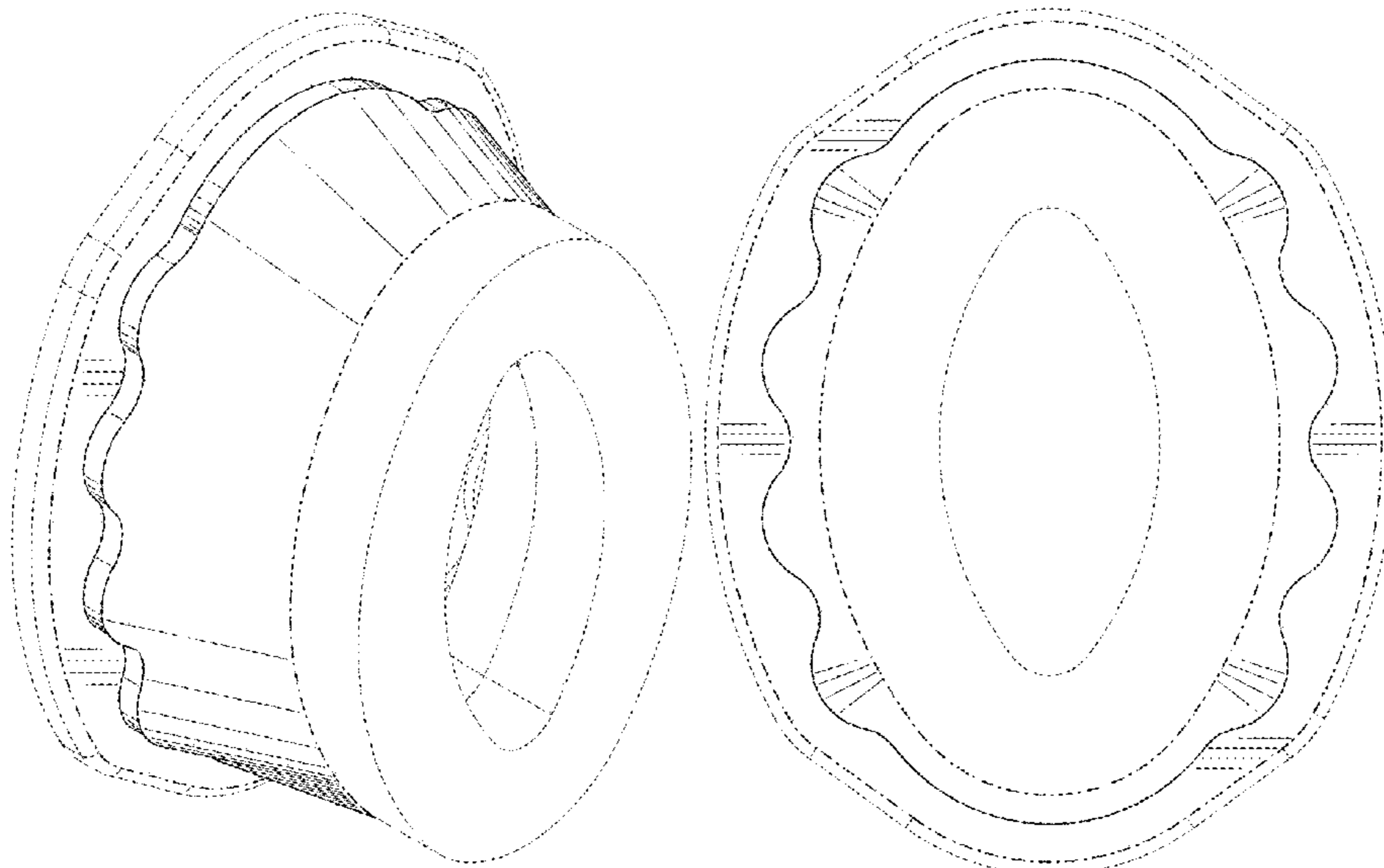
FIG. 5 is a top plan view of the design of FIG. 1, the bottom plan view is a mirror image thereof; and,

FIG. 6 is a rear elevation view of the design of FIG. 1.

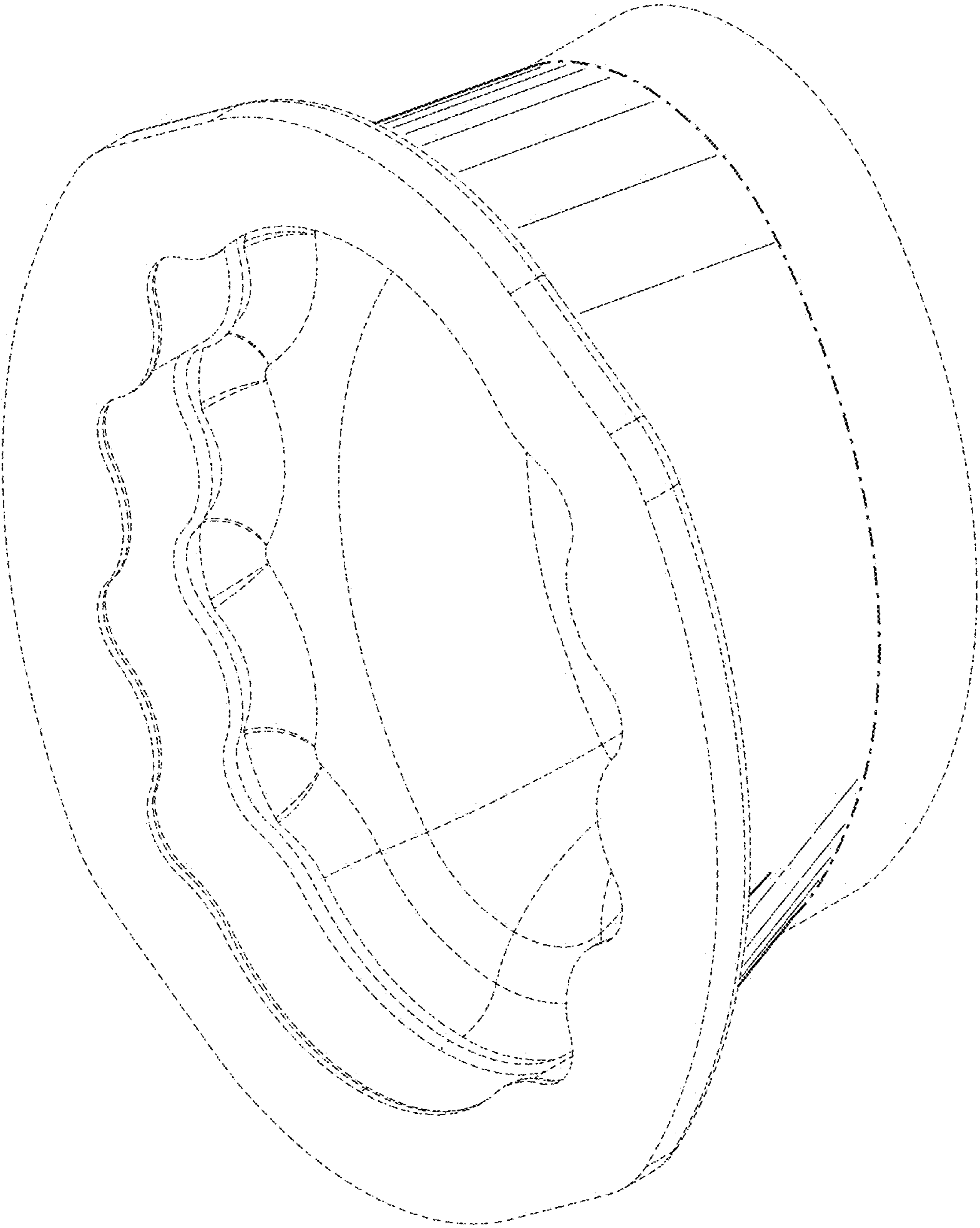

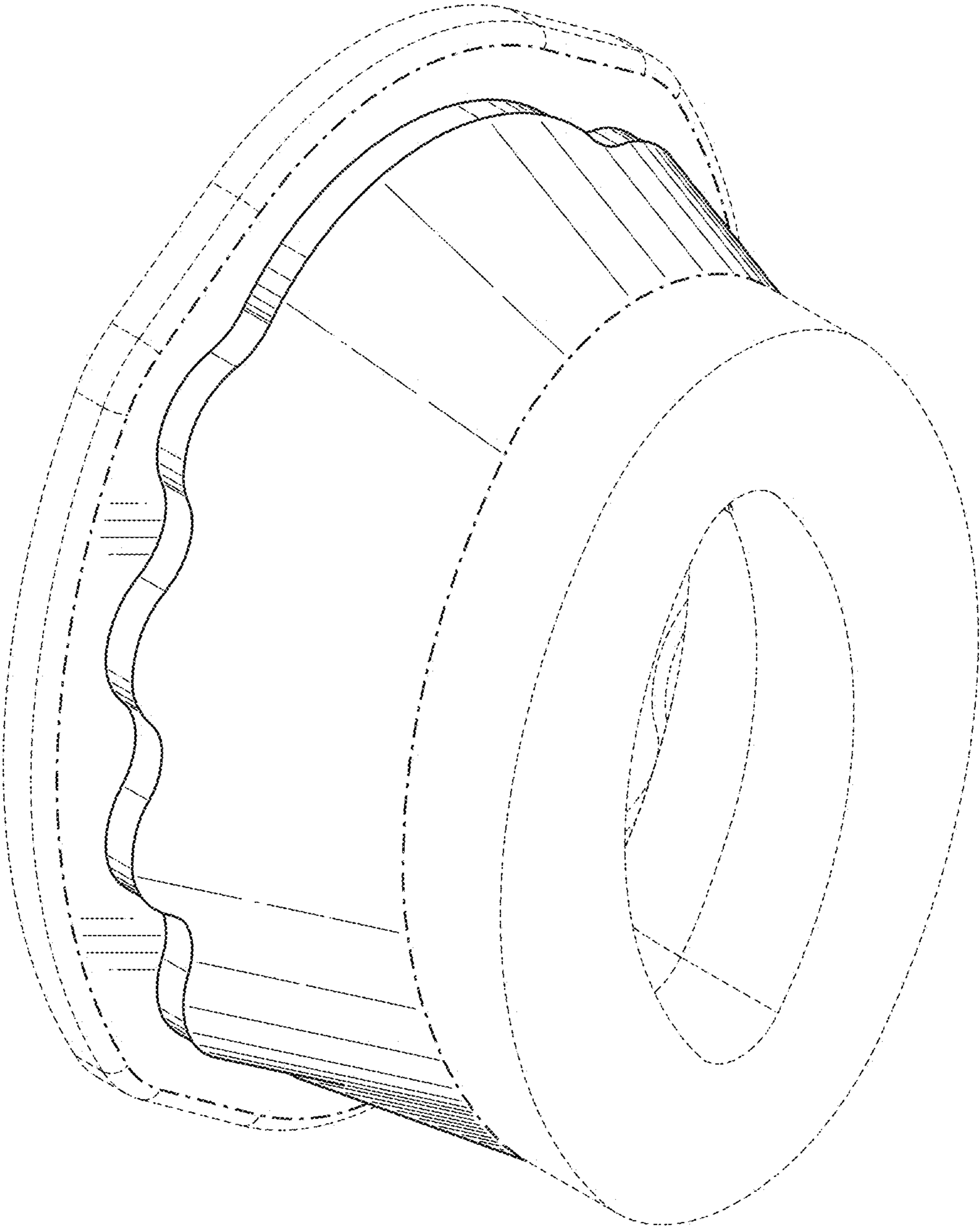

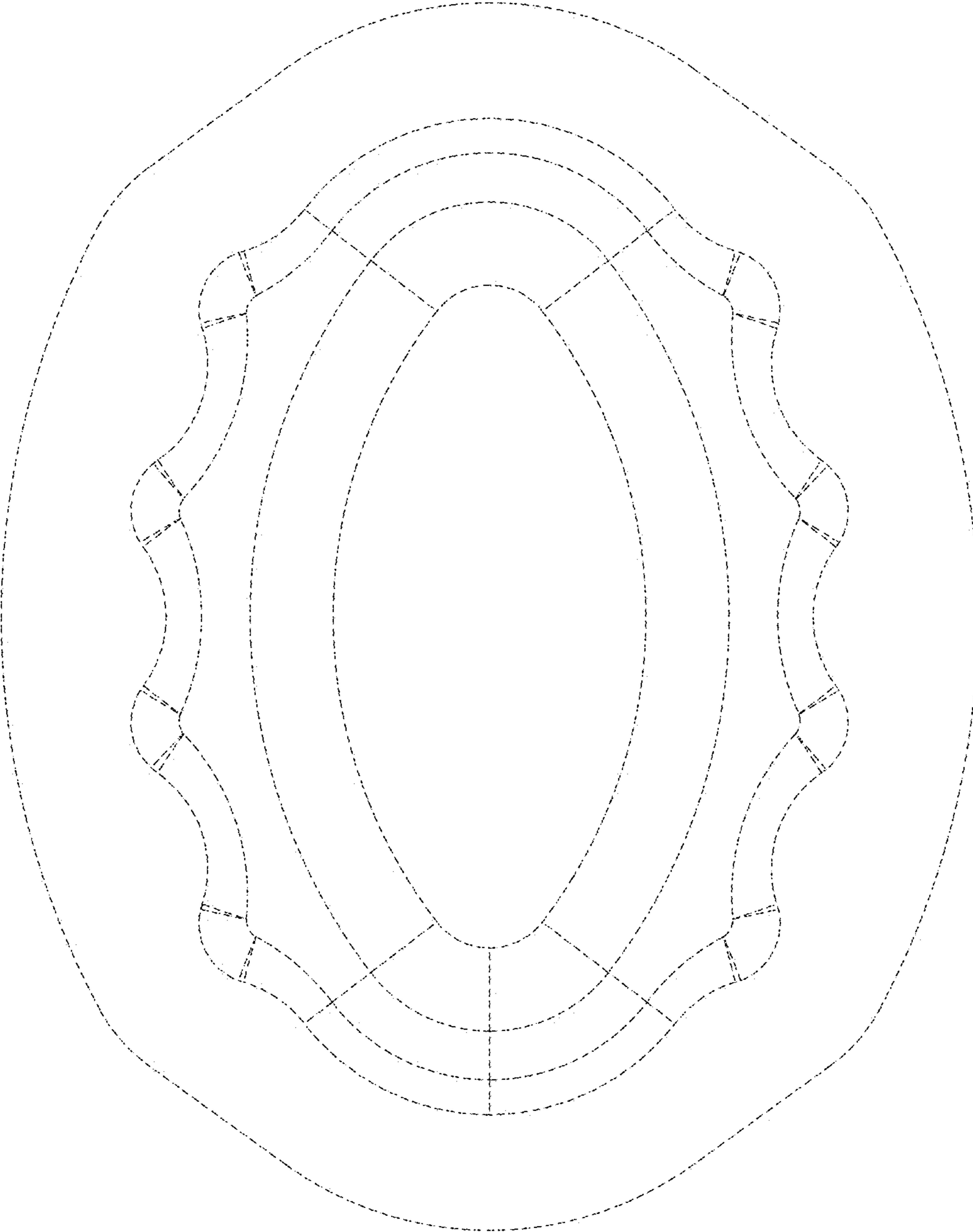

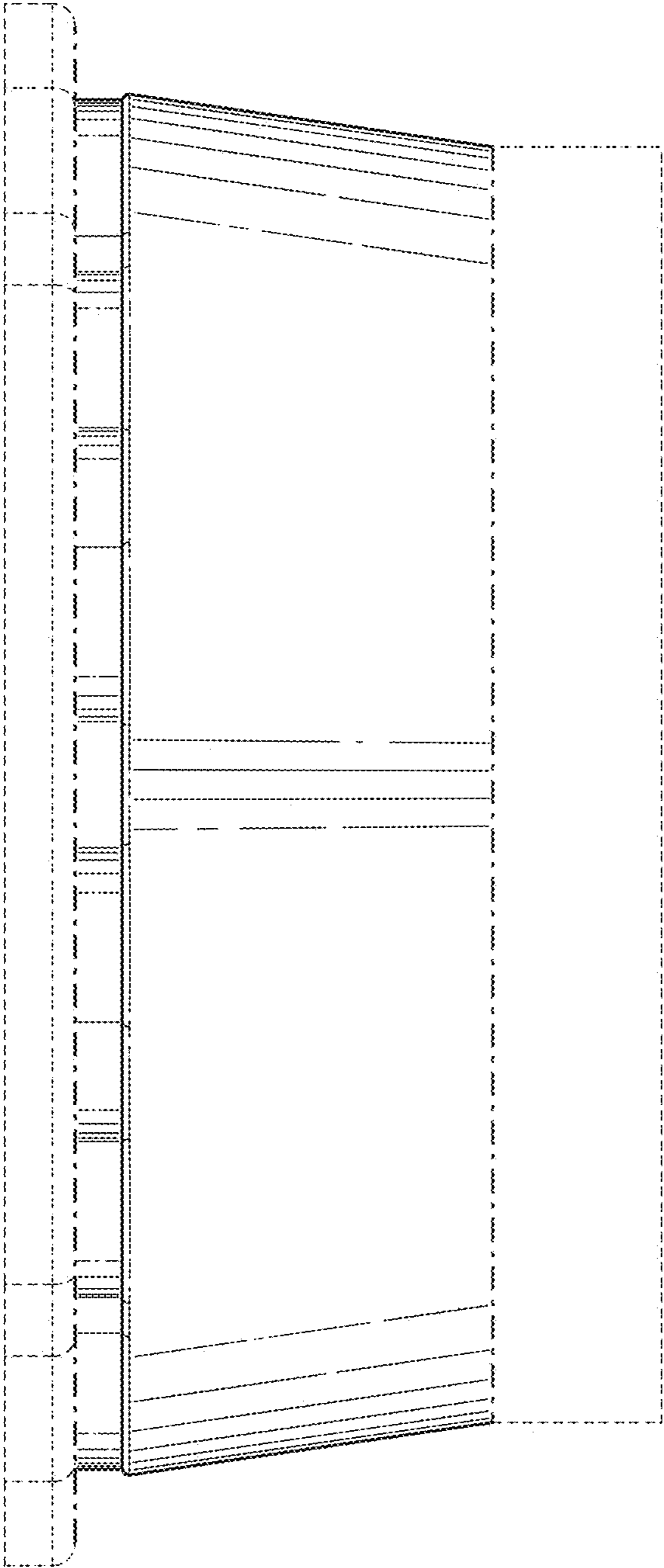

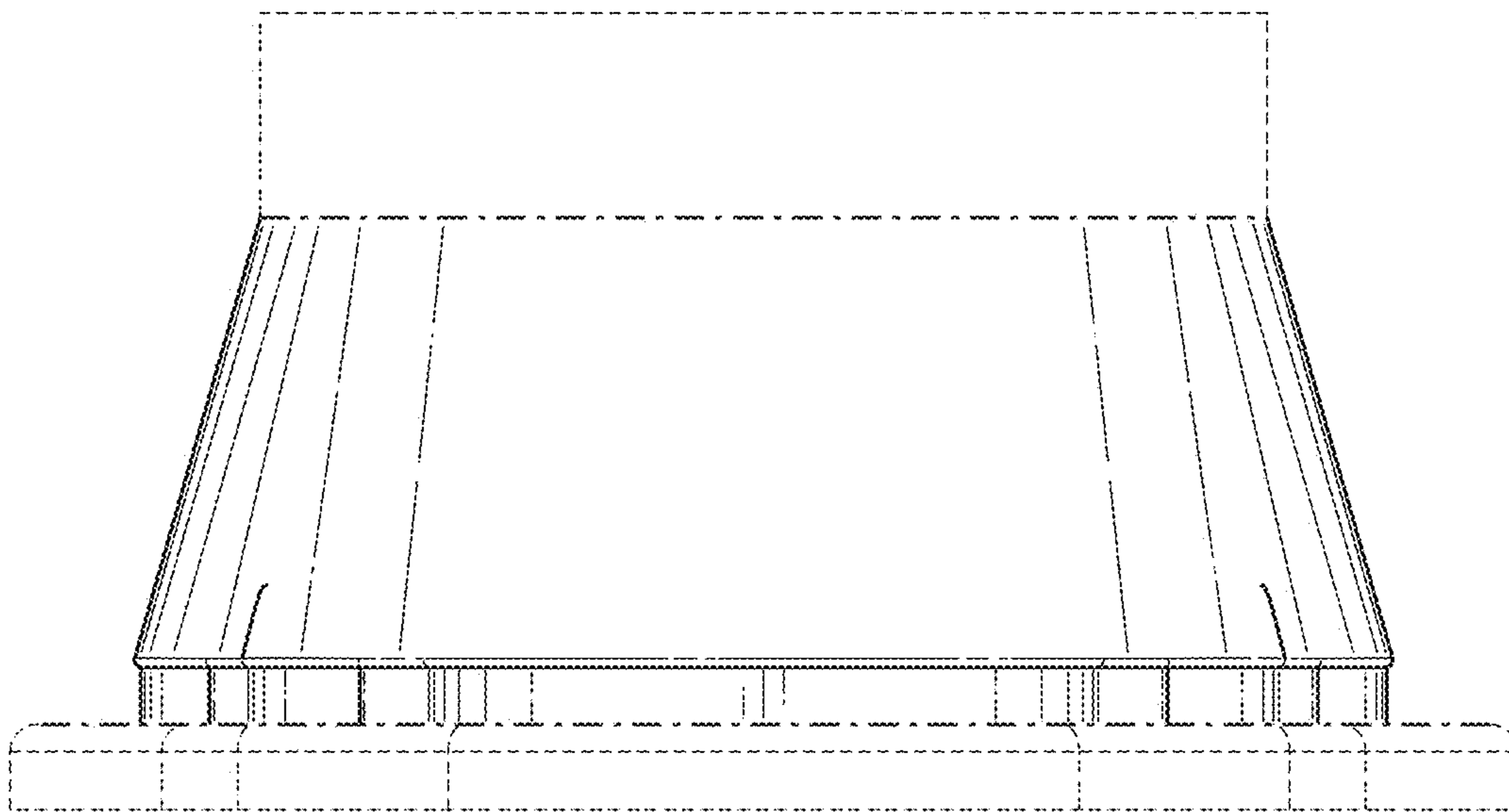

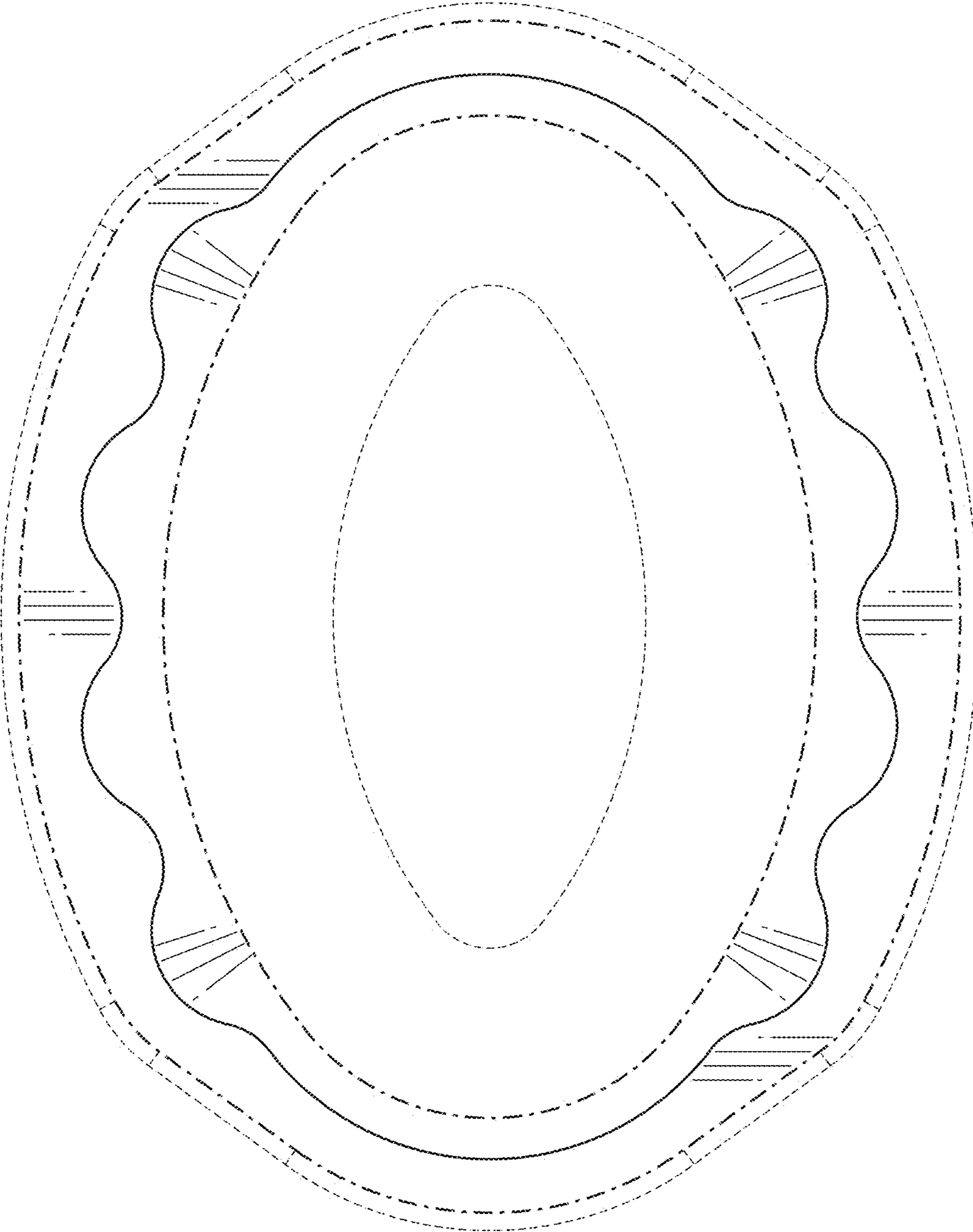
