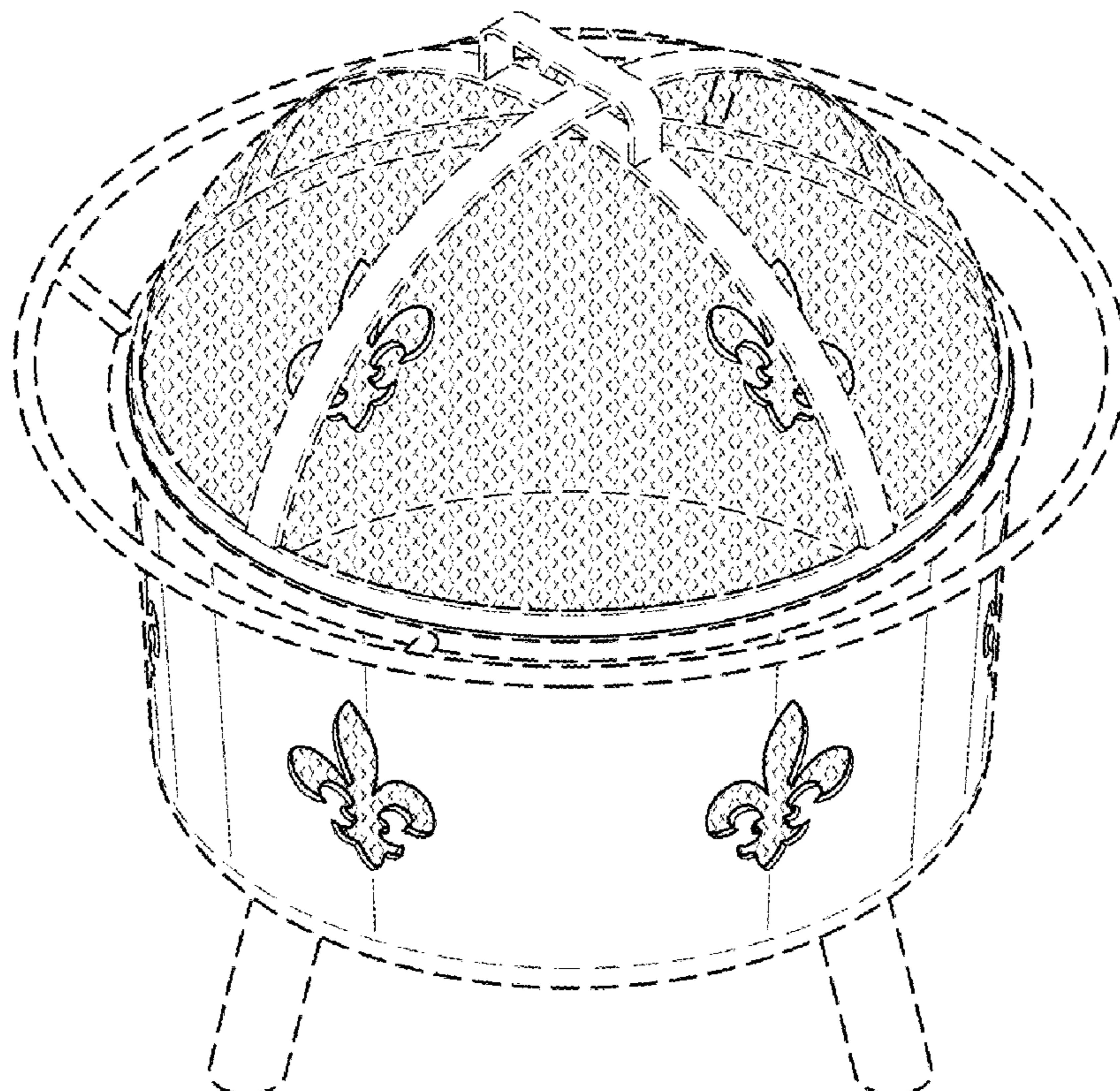
FIG. 1 is an upper perspective view of a fire pit showing my new design.

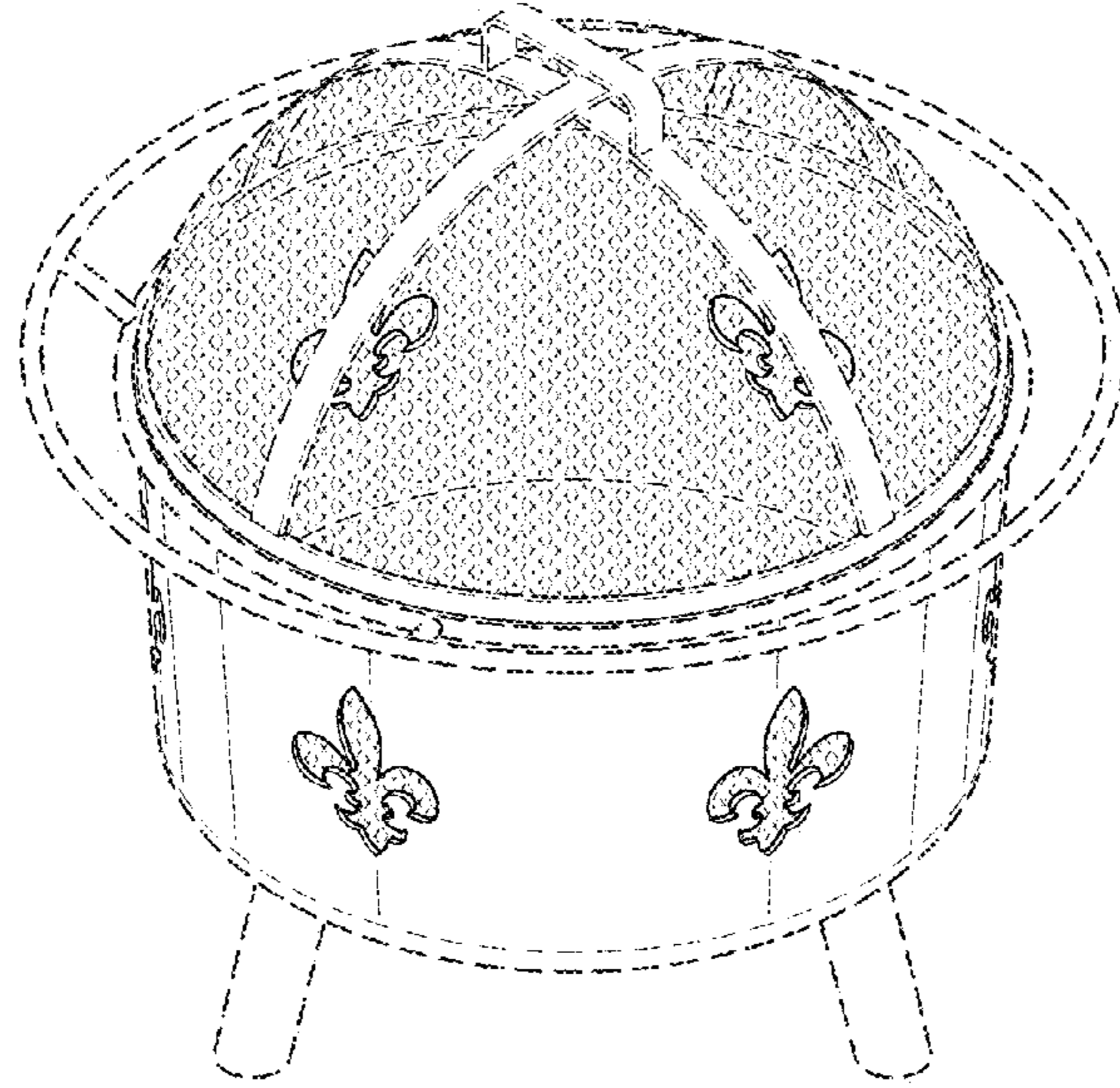

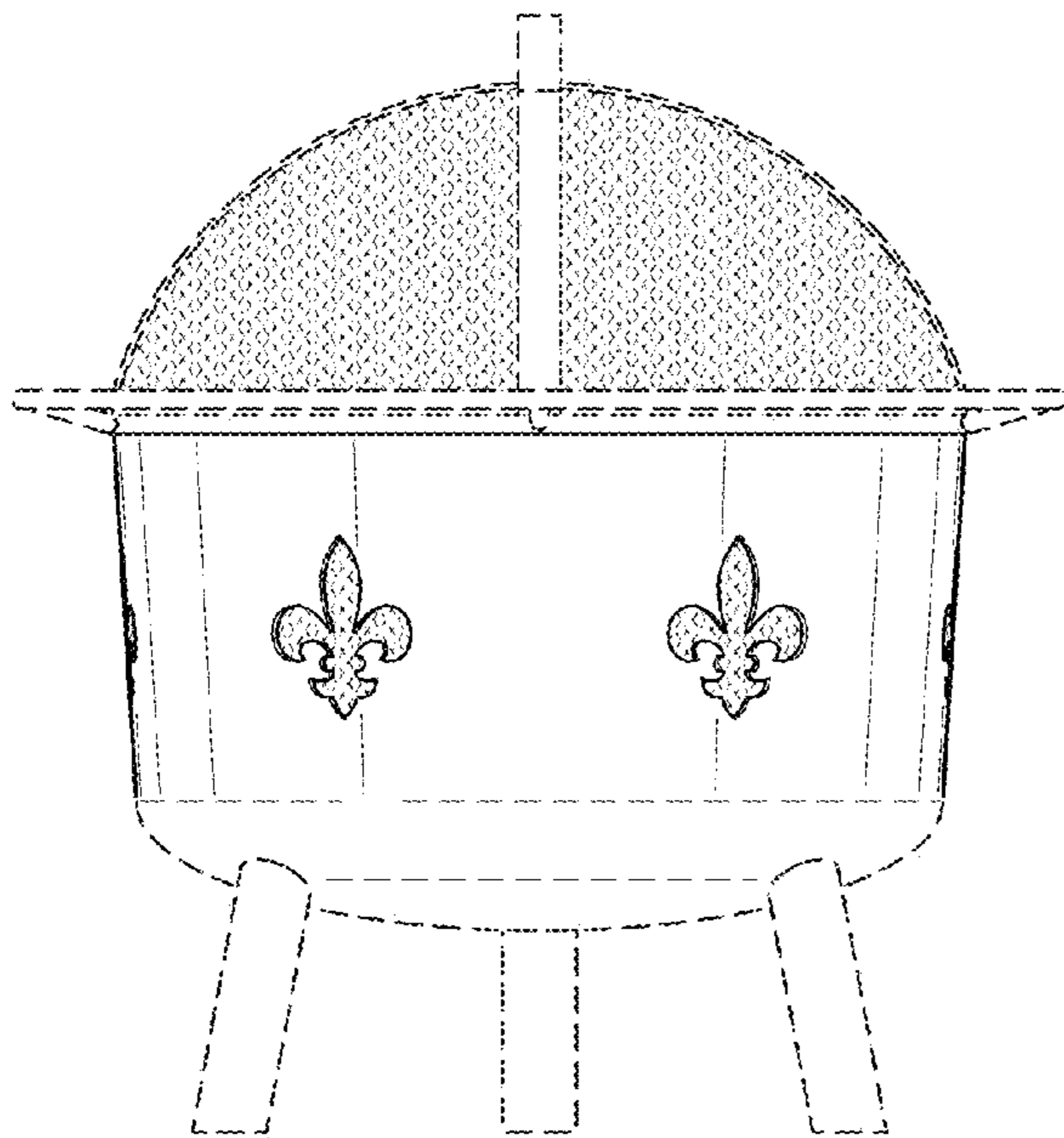

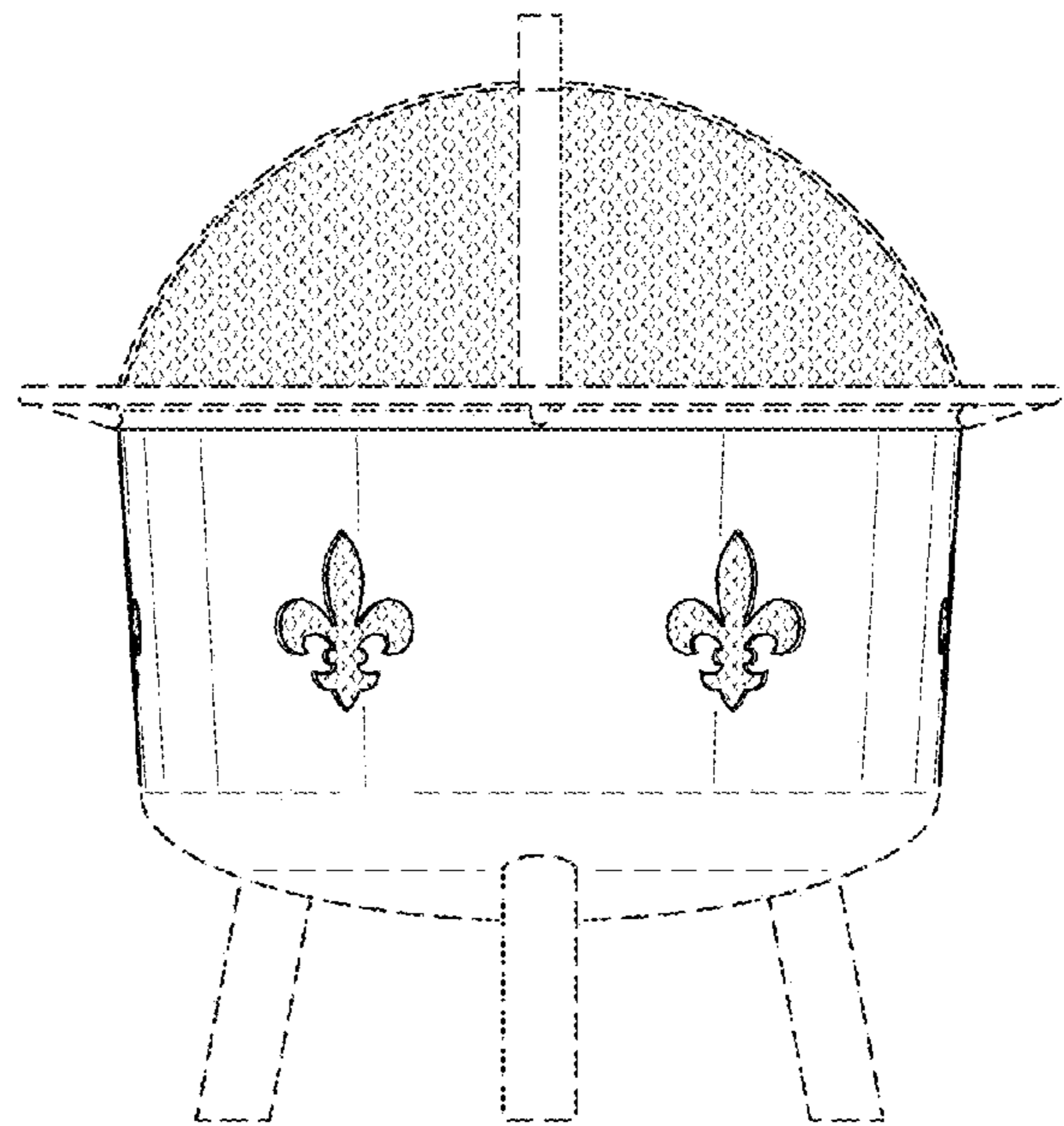

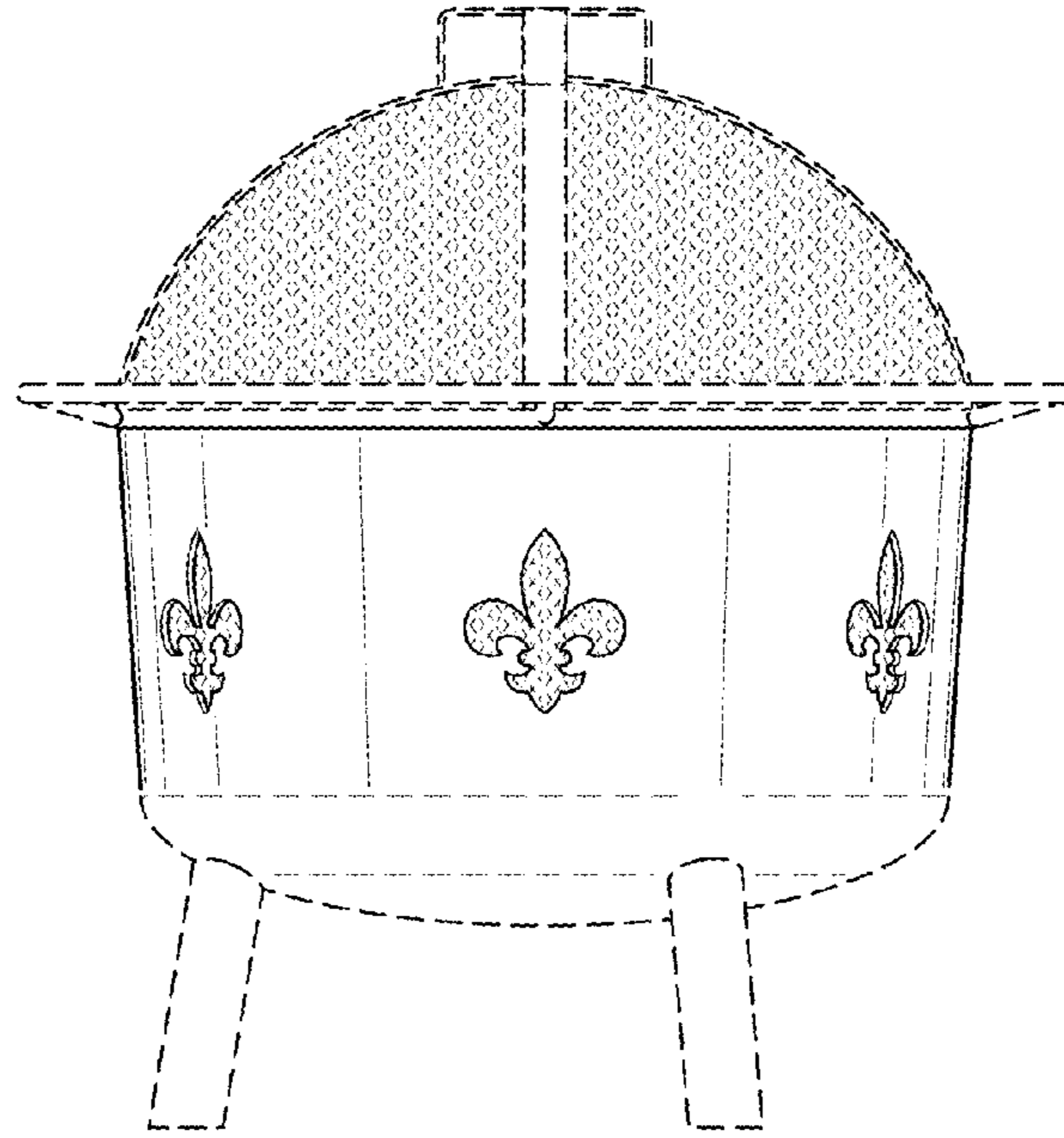

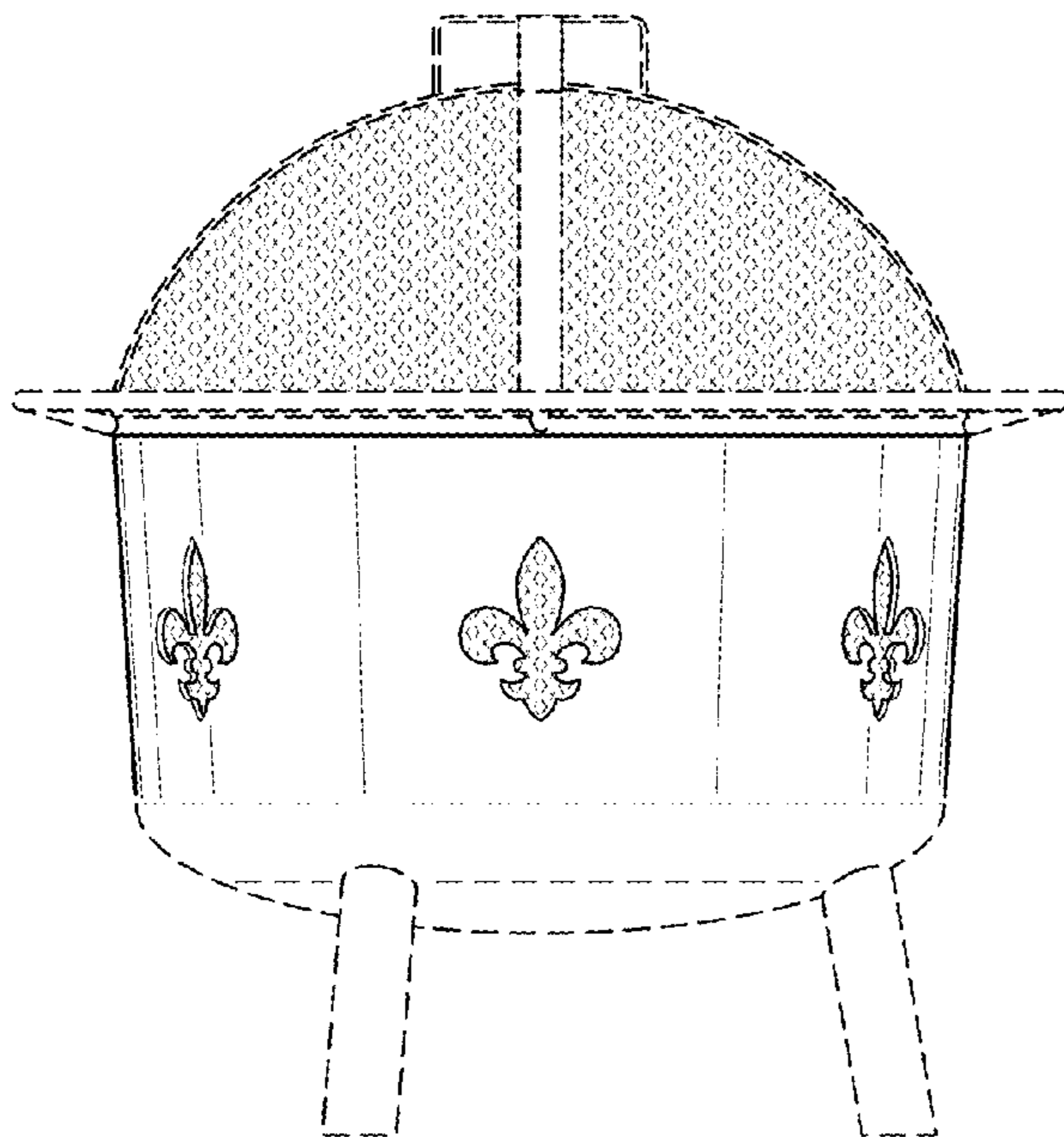

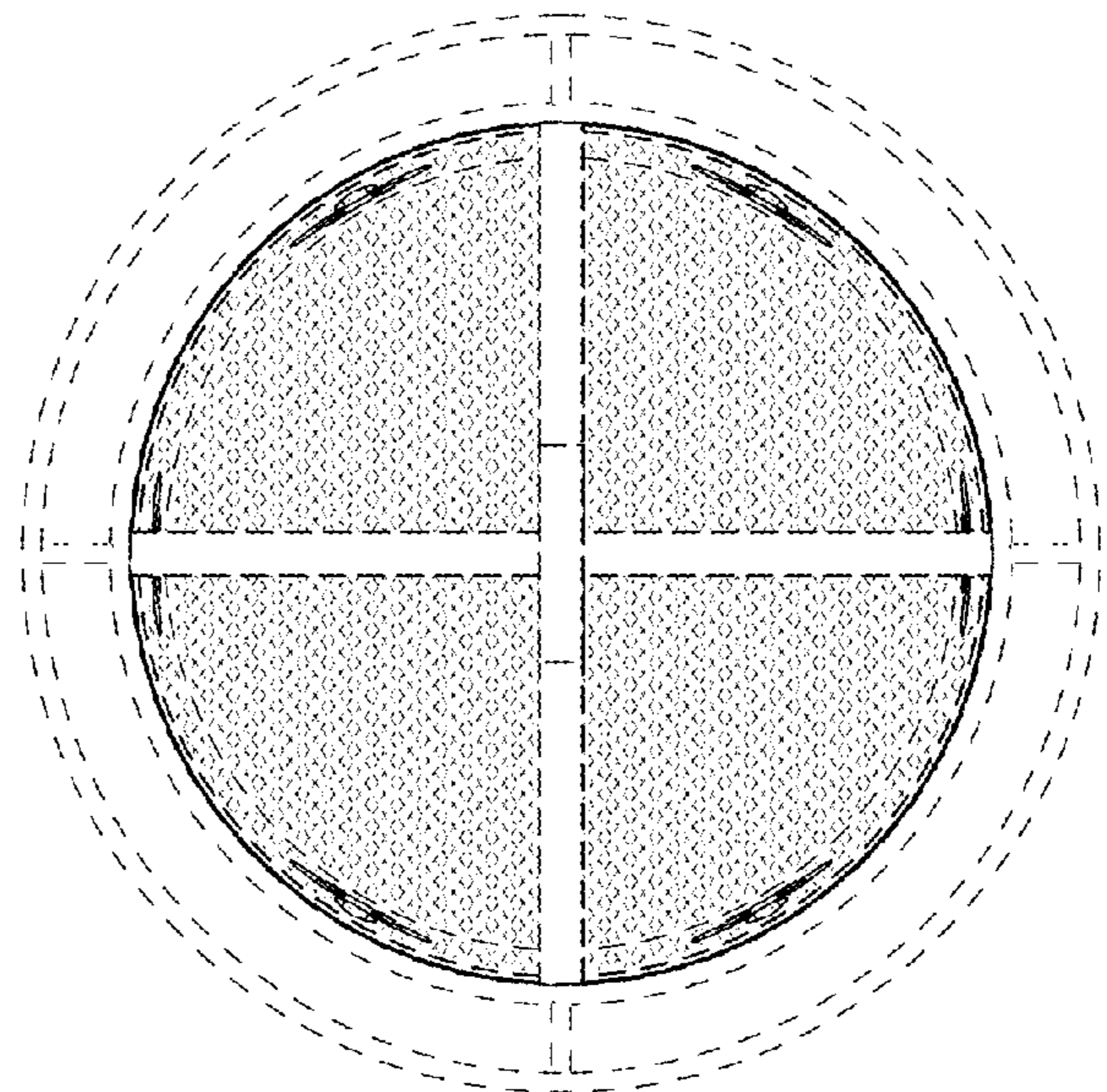

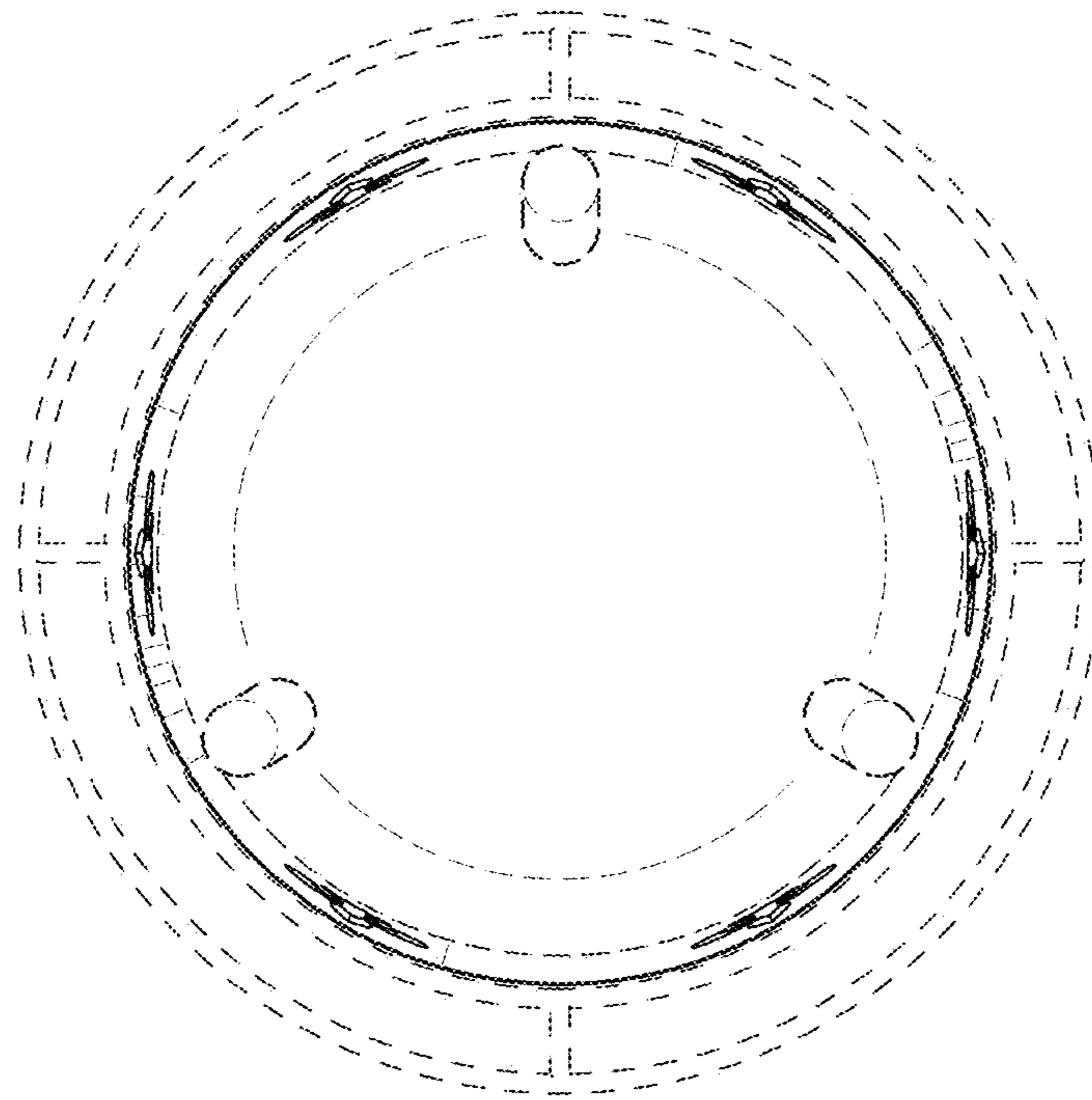

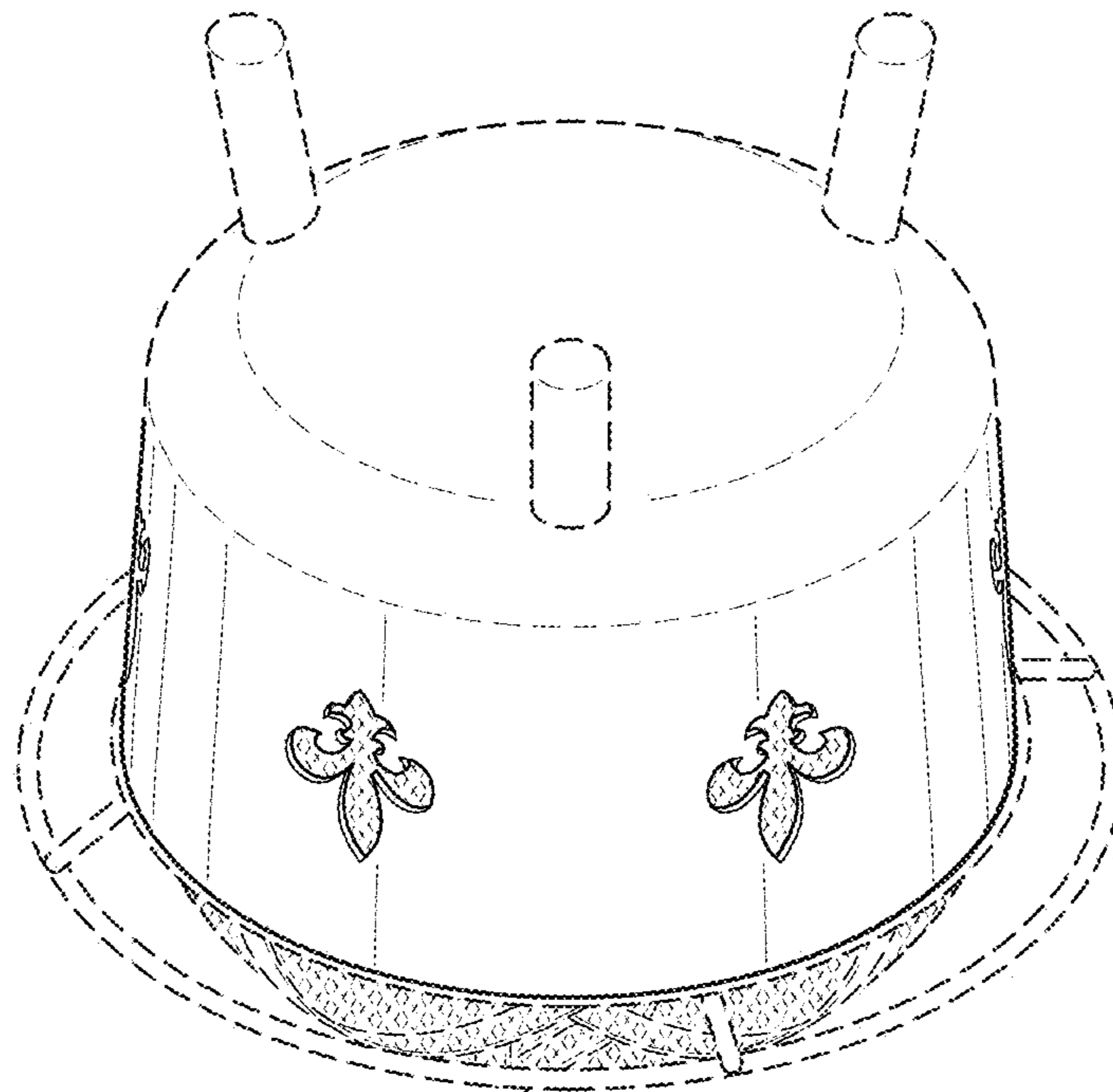
