FIG. 20 is a left side view thereof;

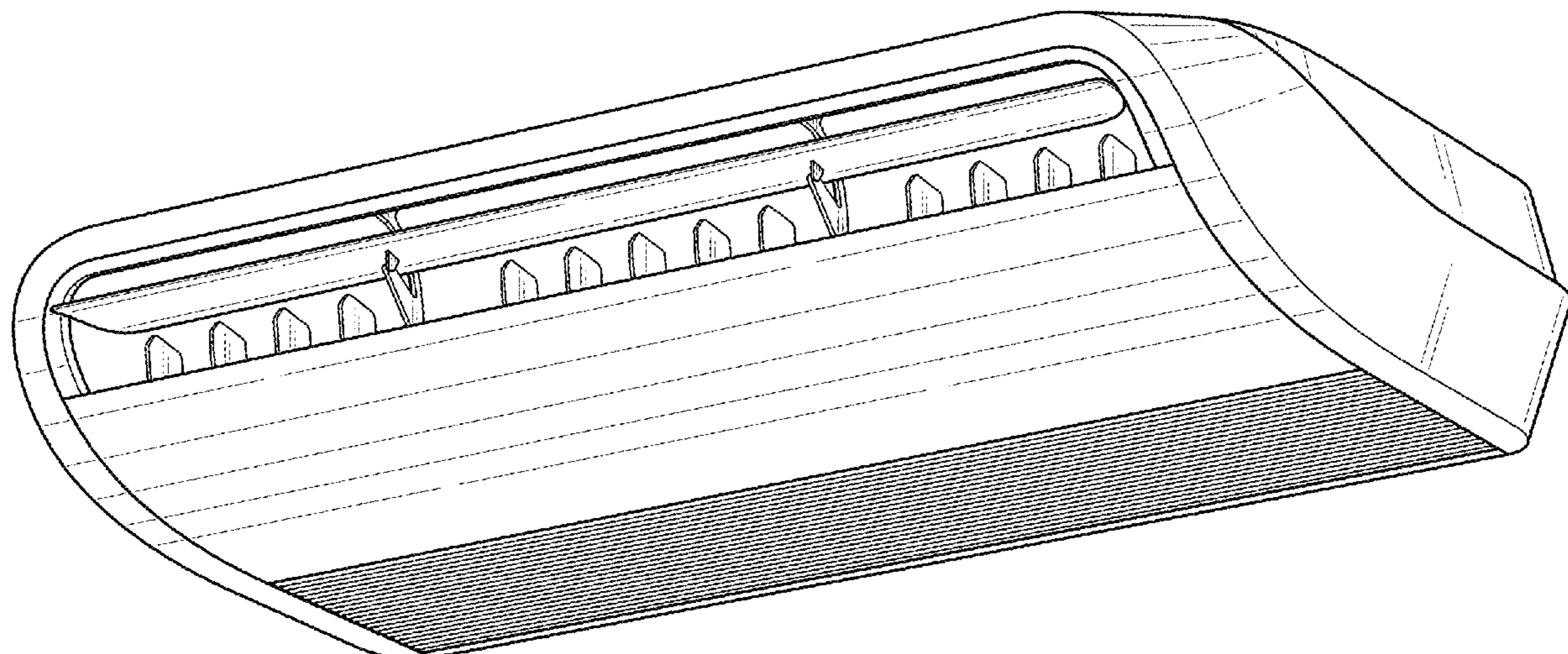
FIG. 21 is a right side view thereof;

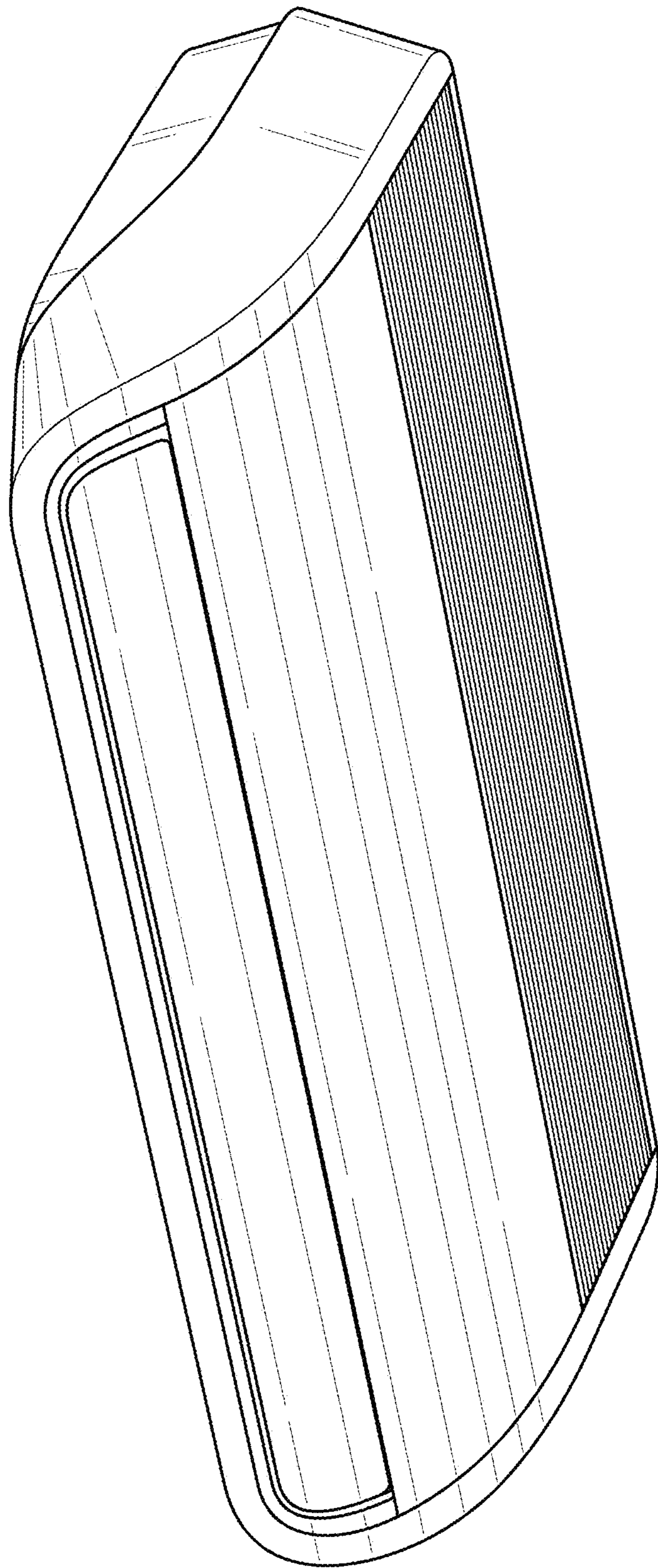

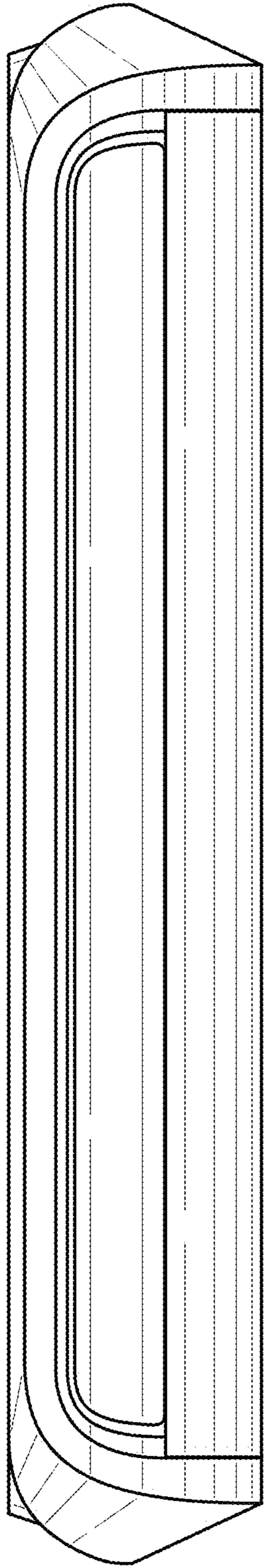

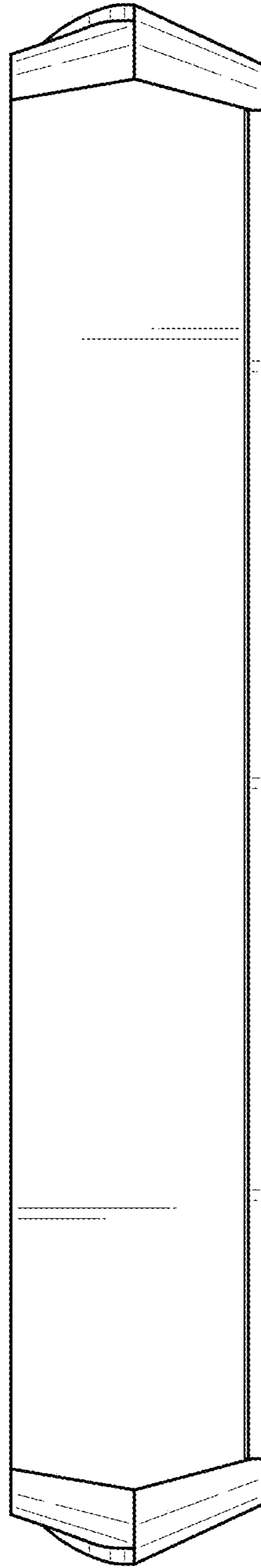

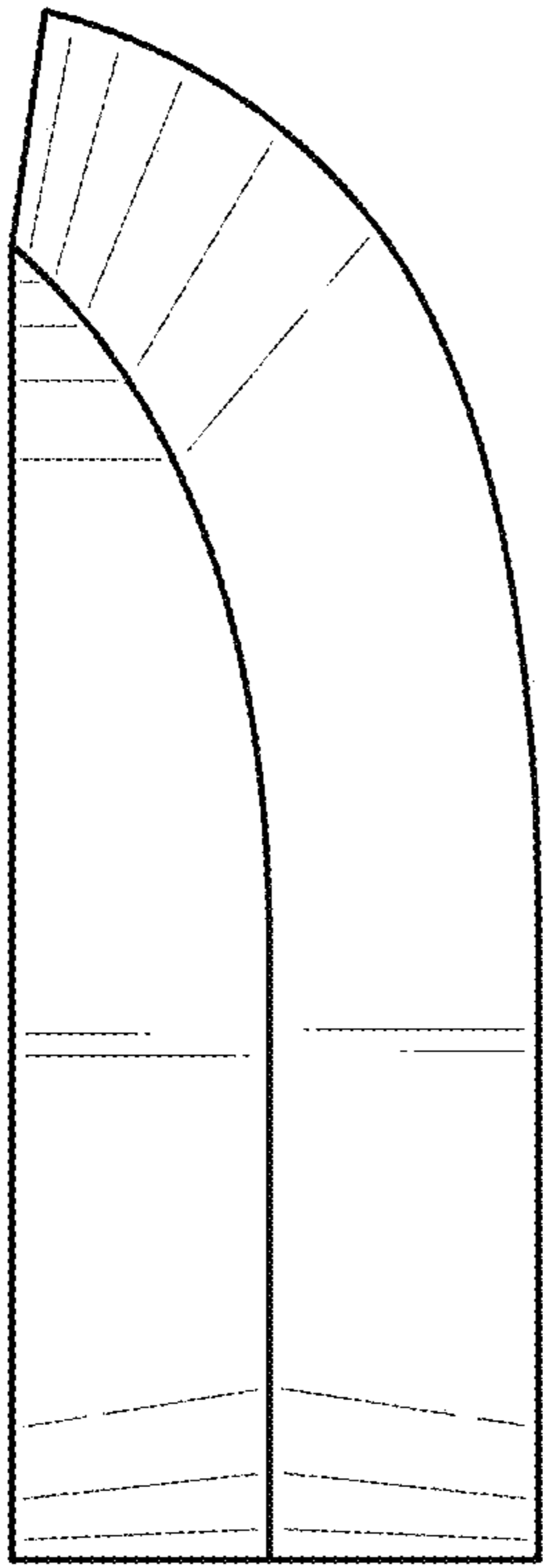

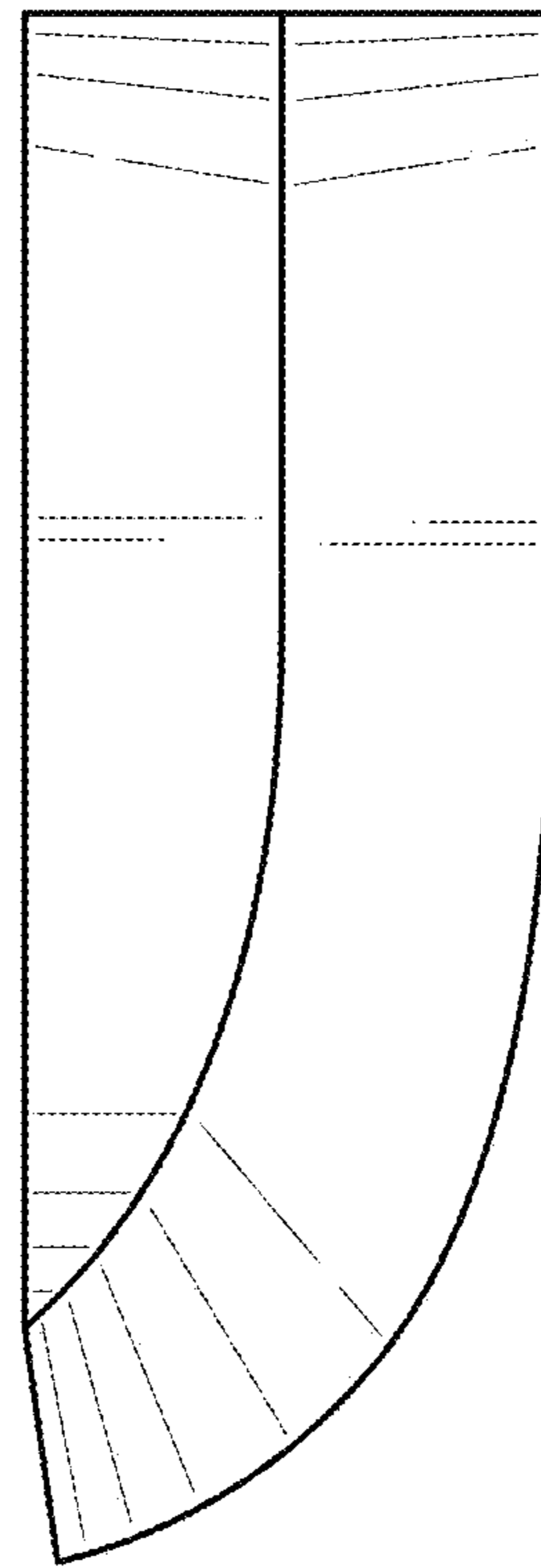

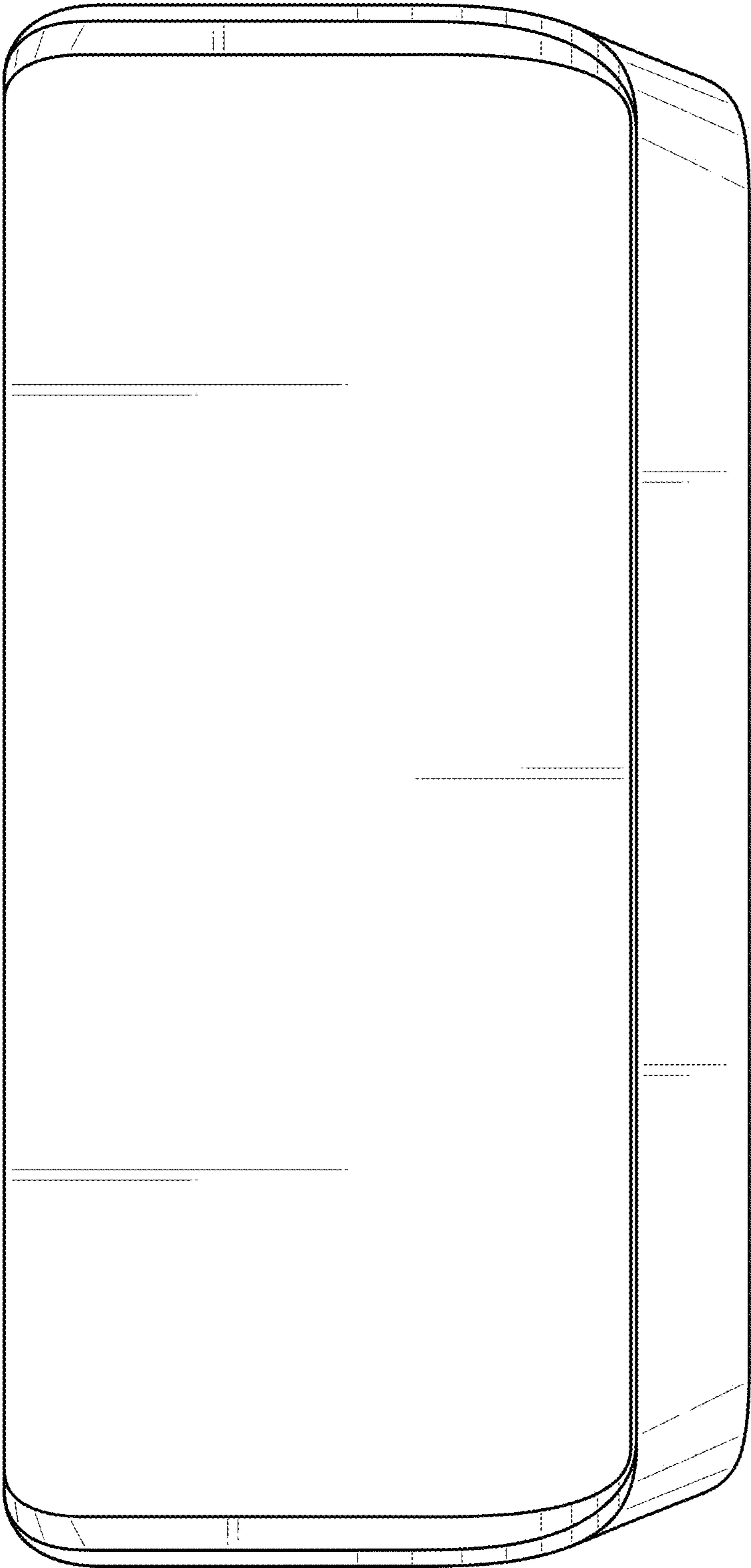

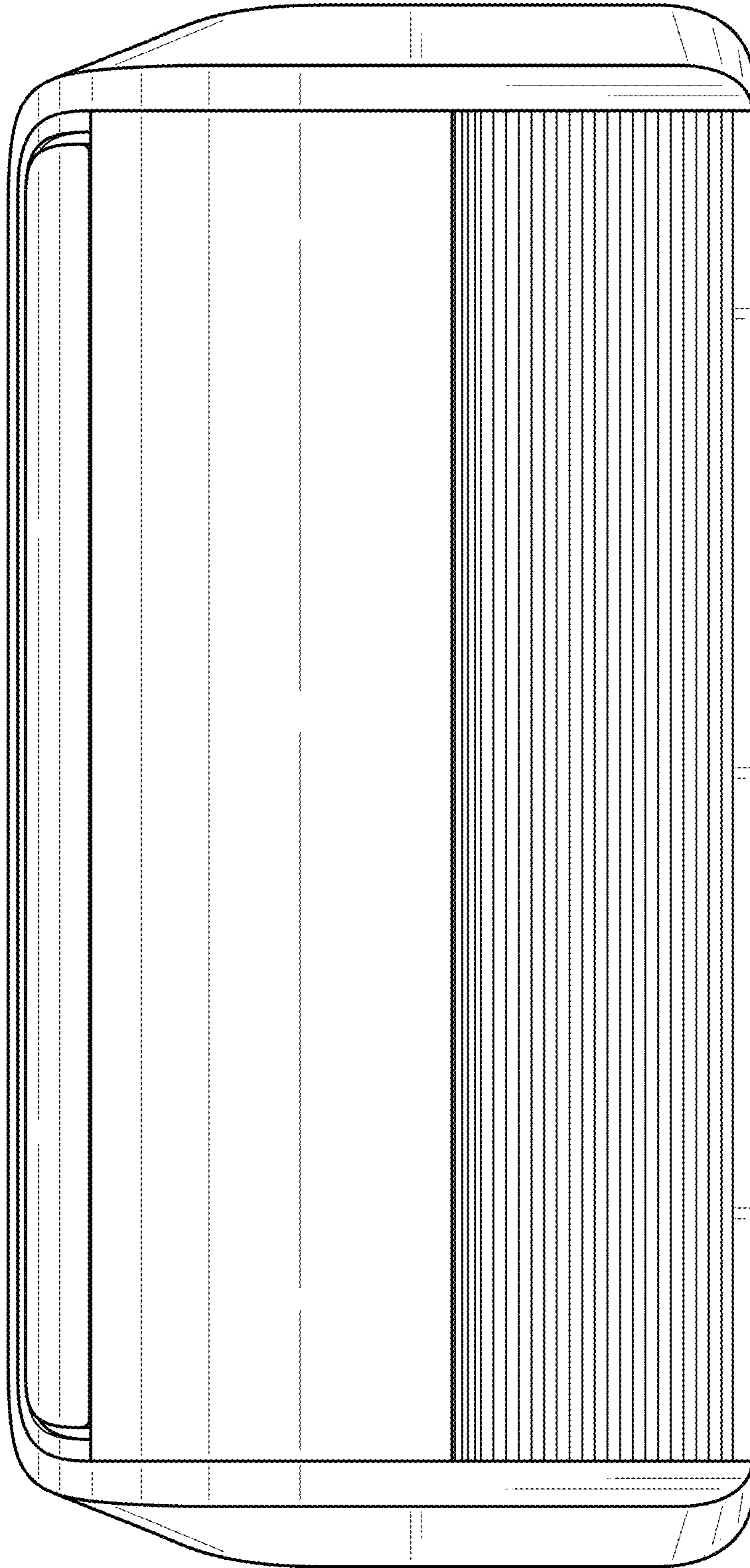

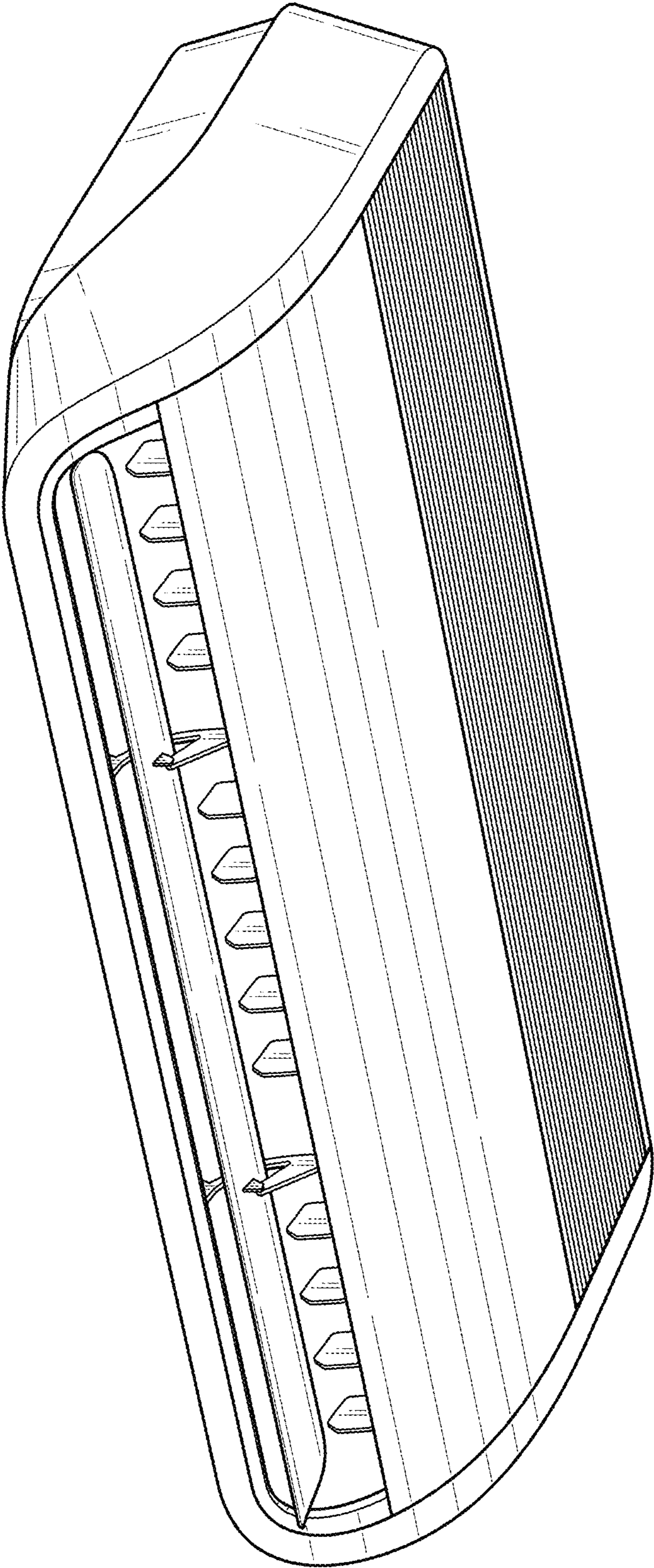

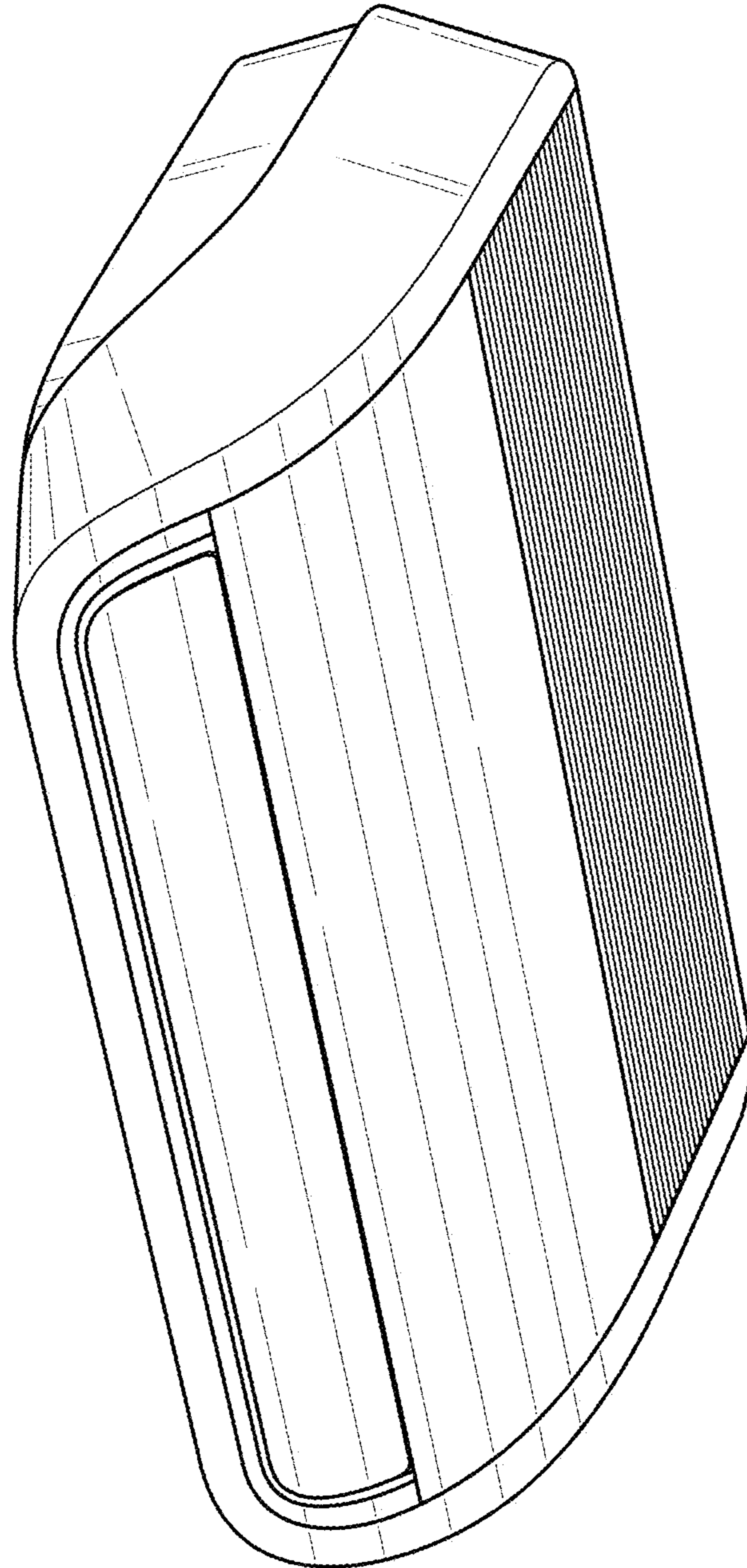

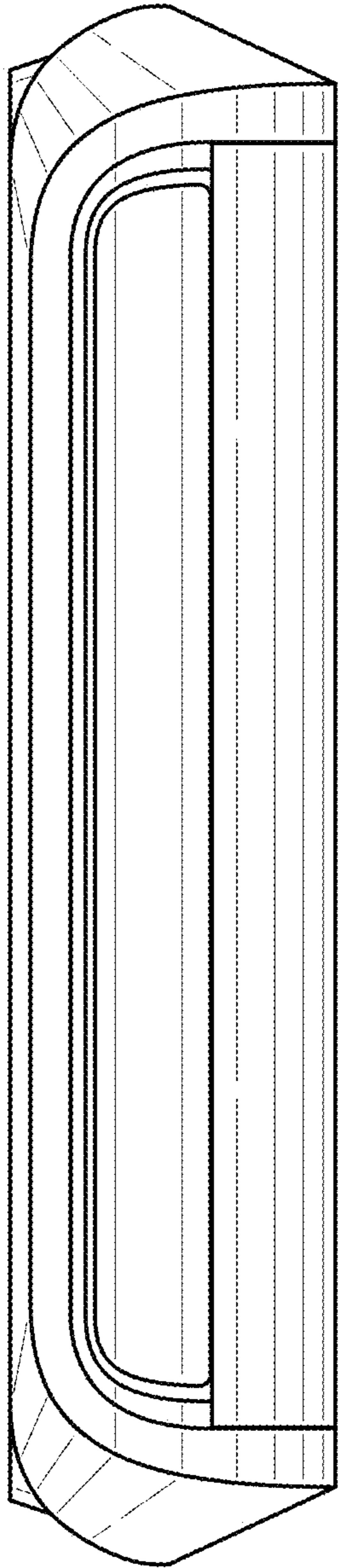

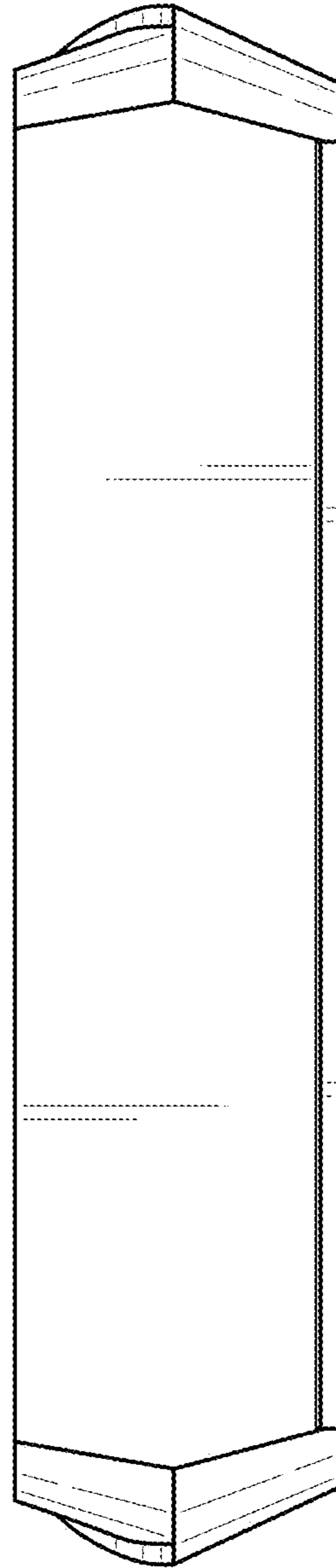

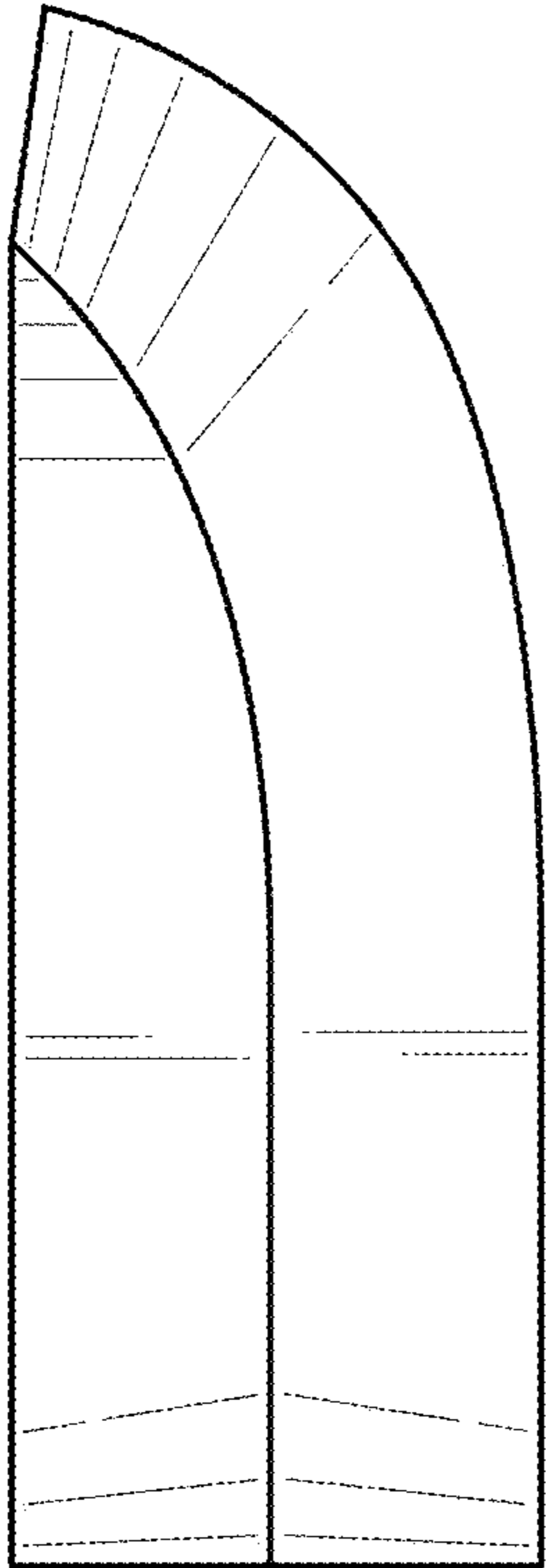

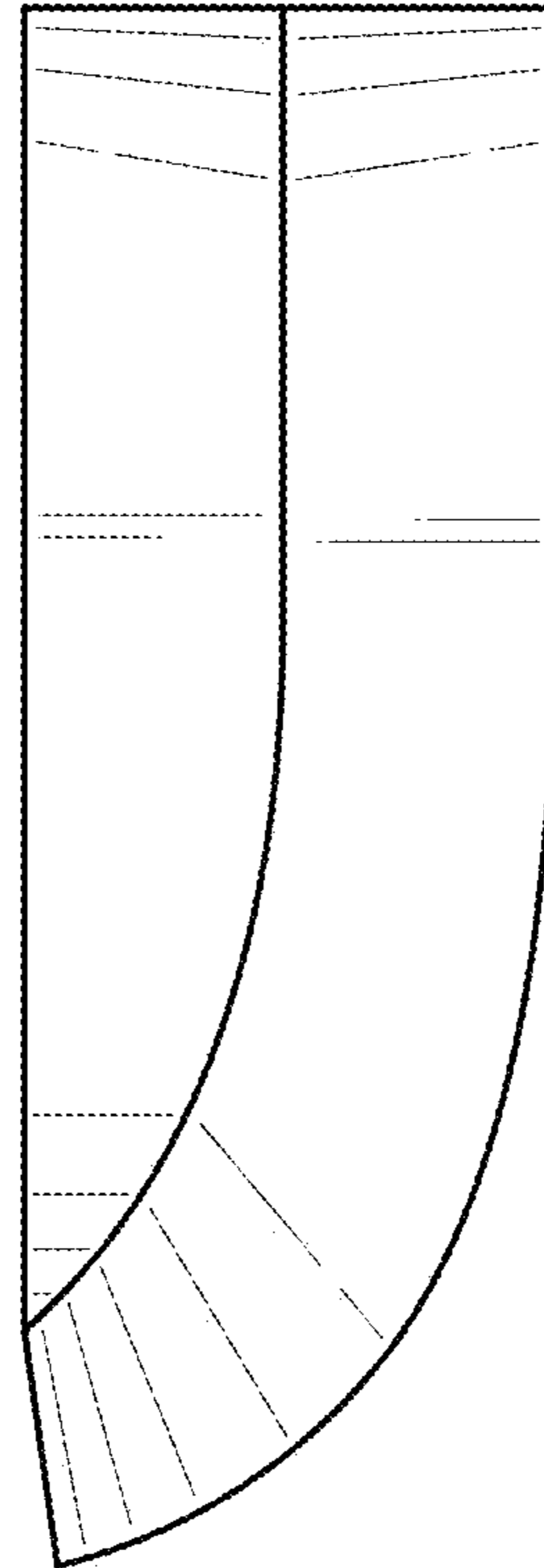

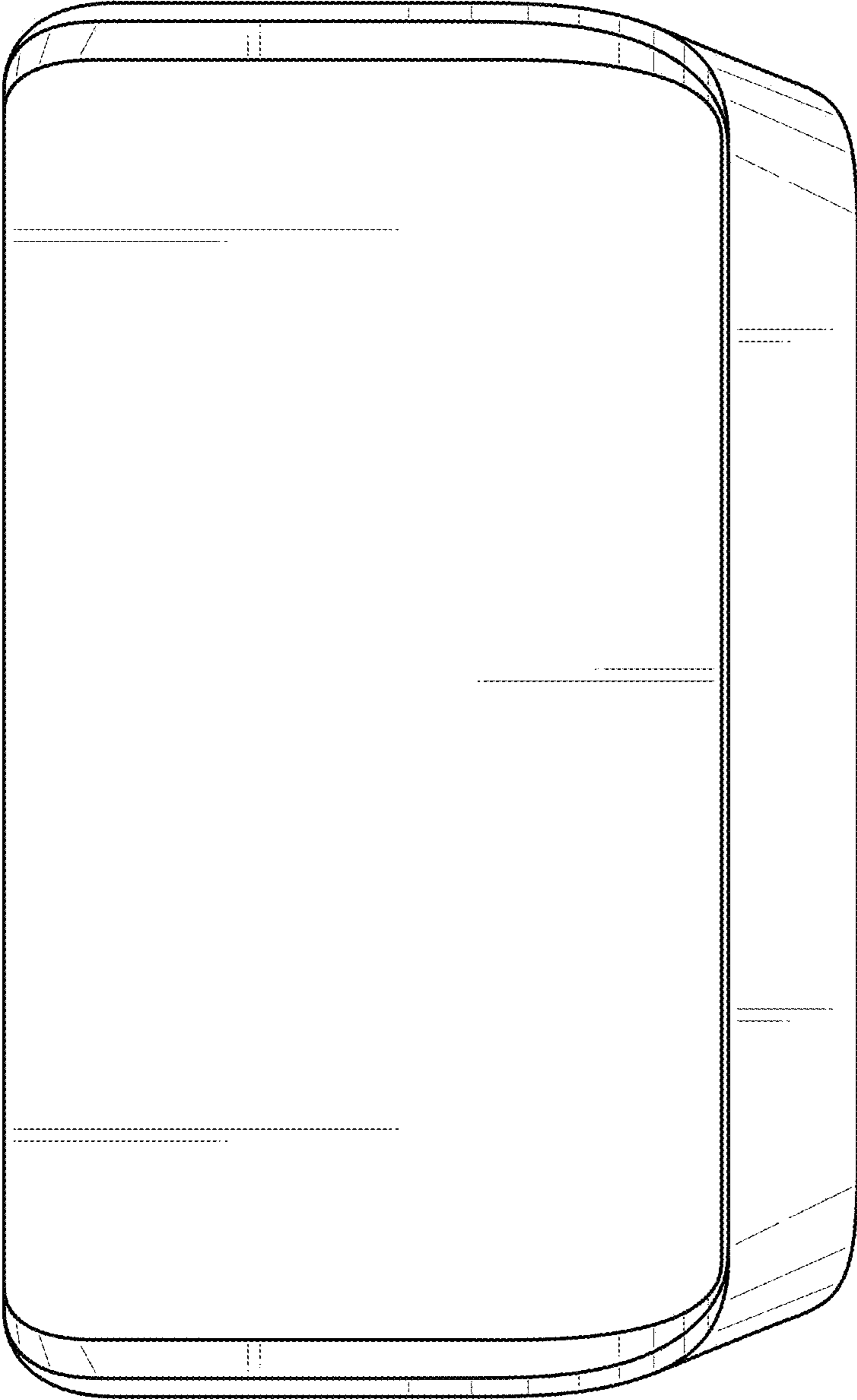

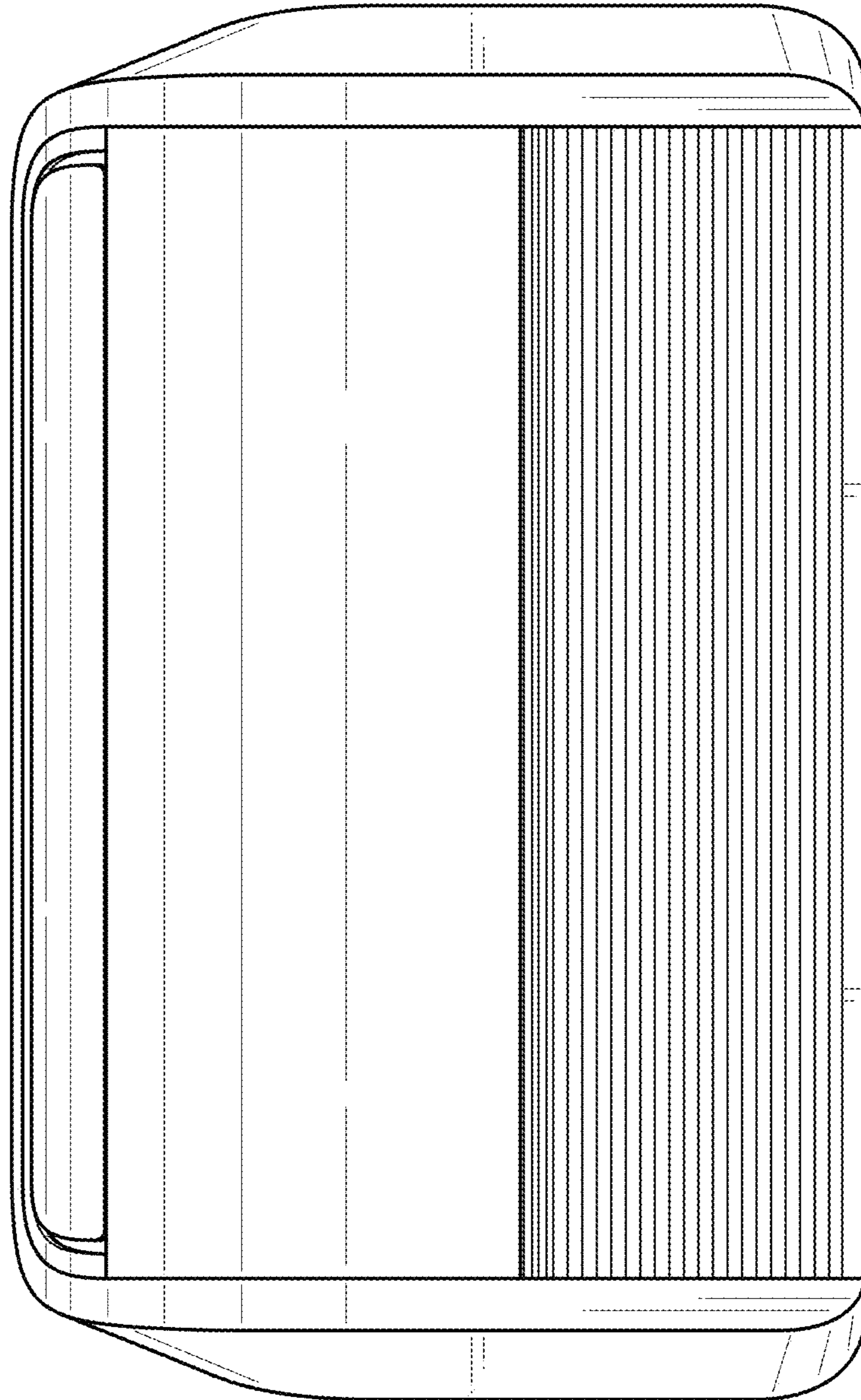

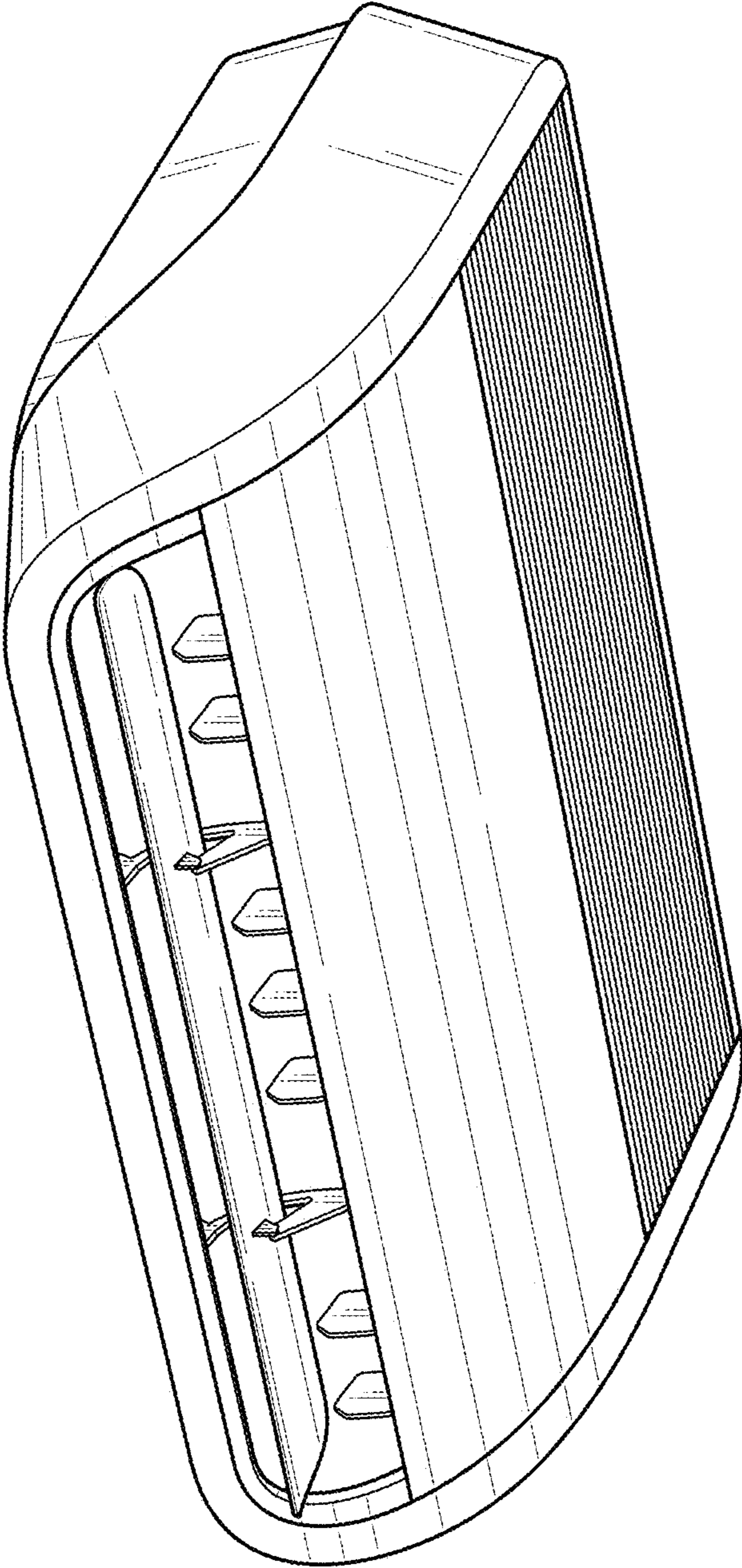

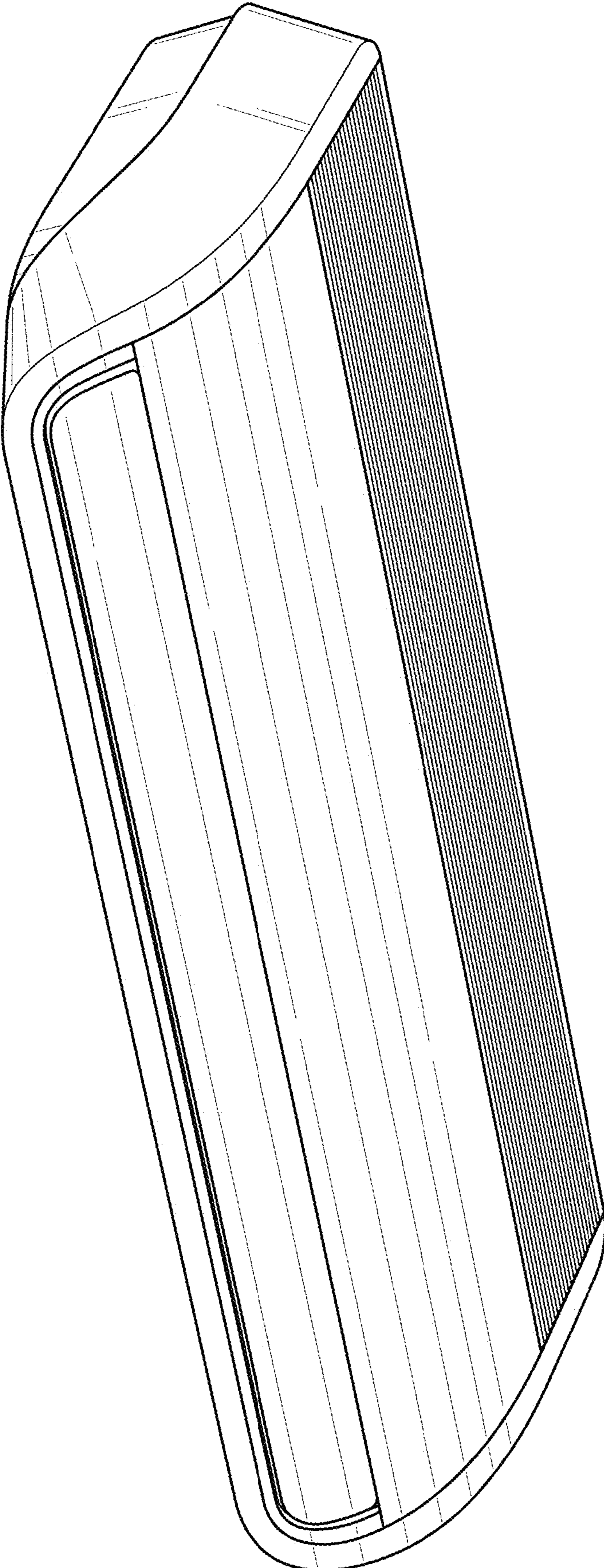

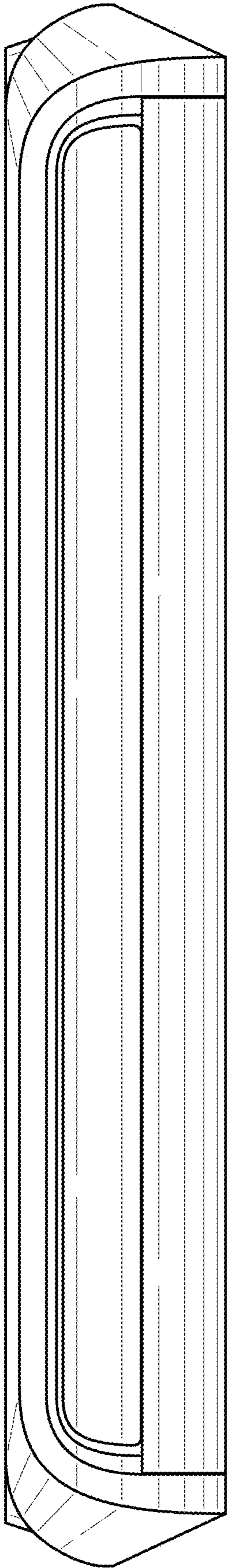

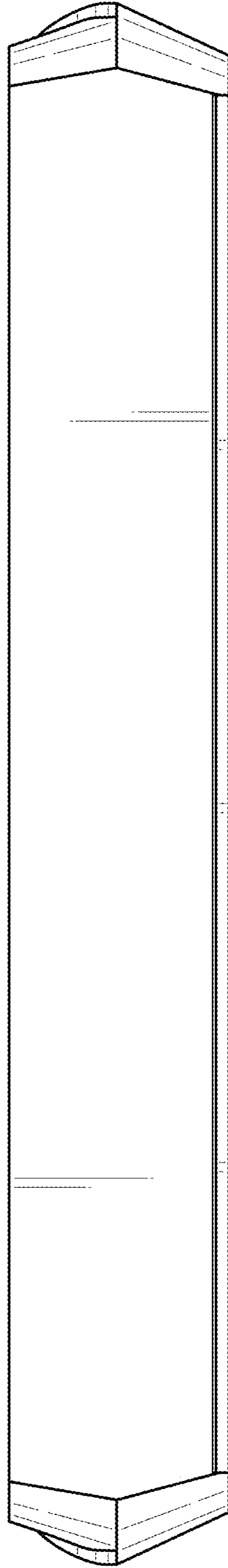

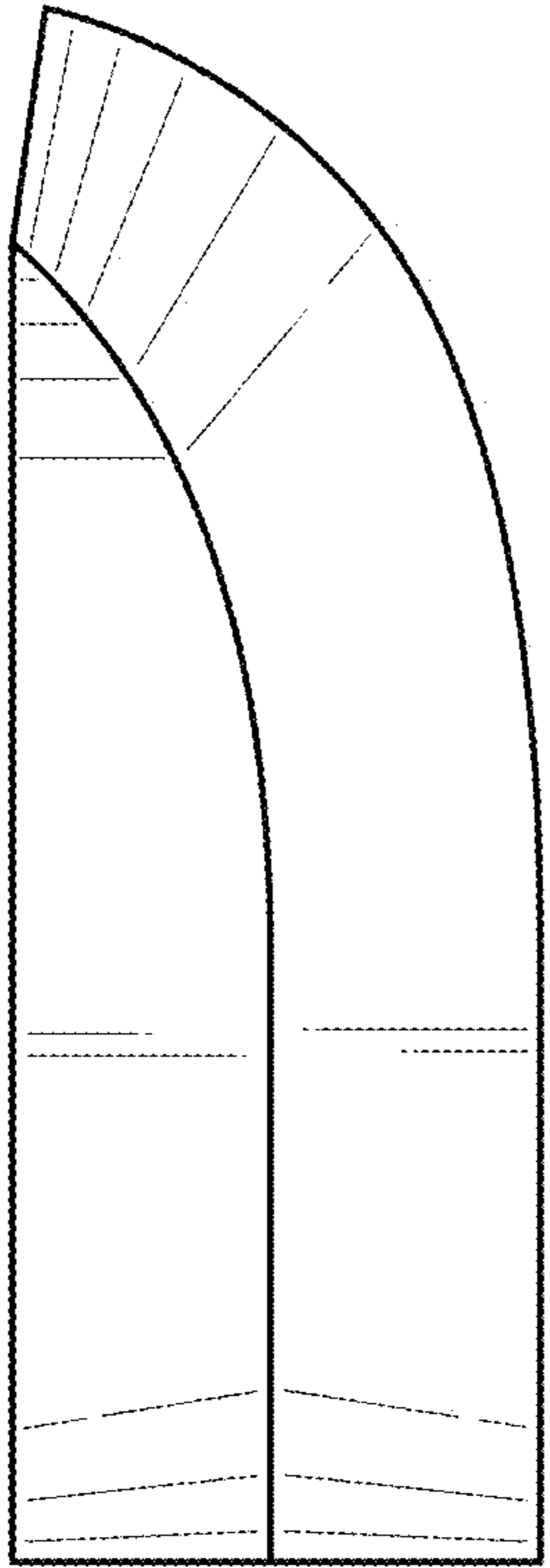

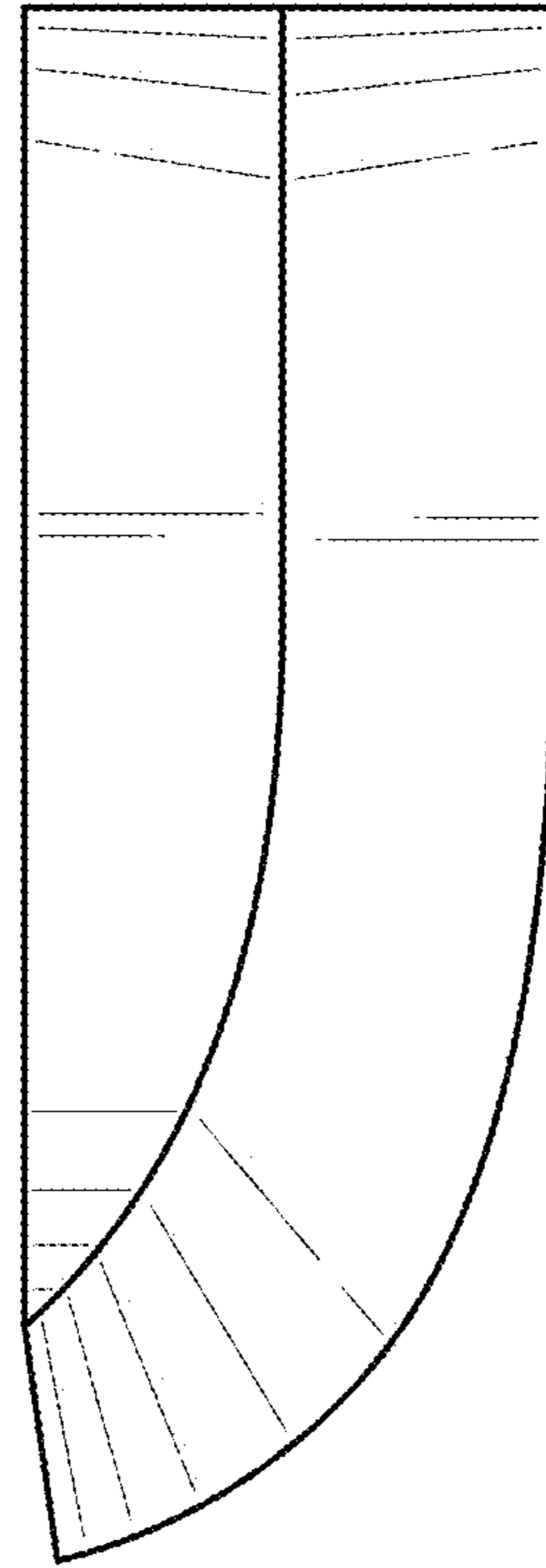

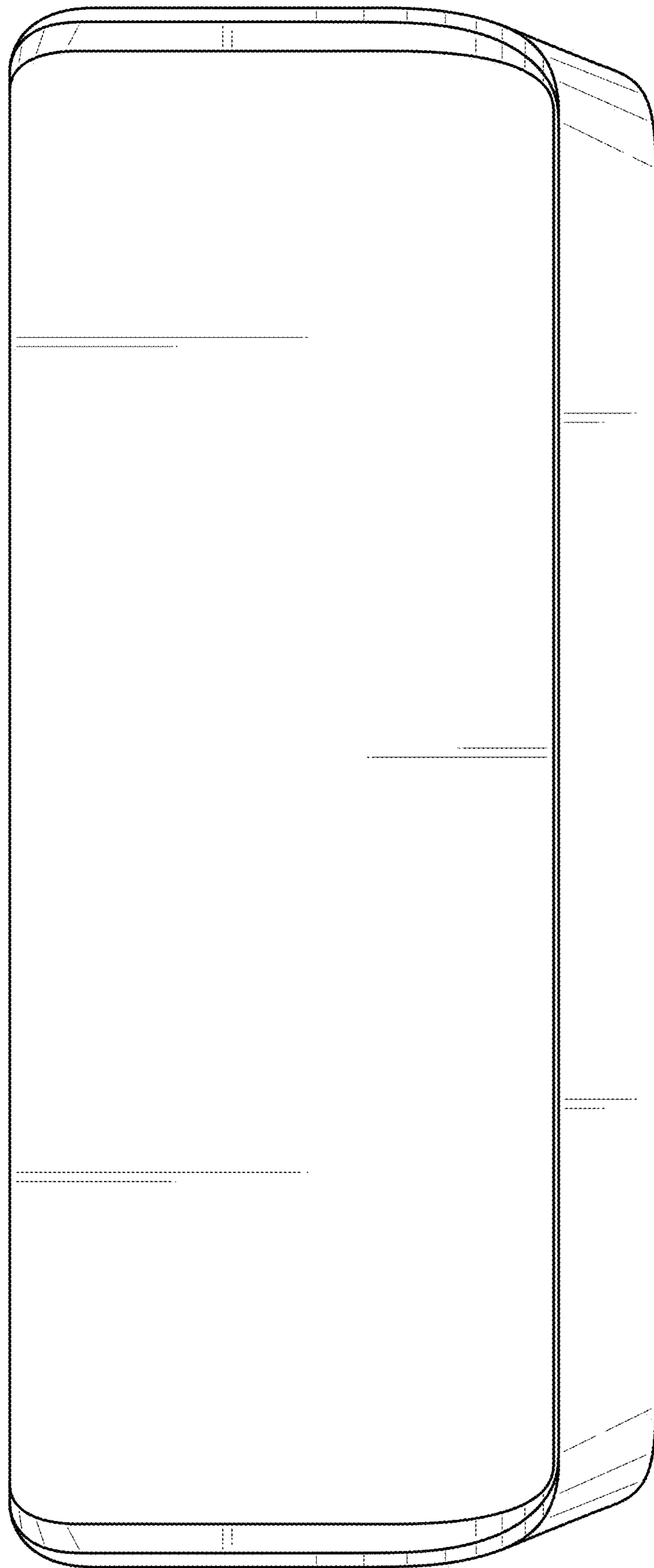

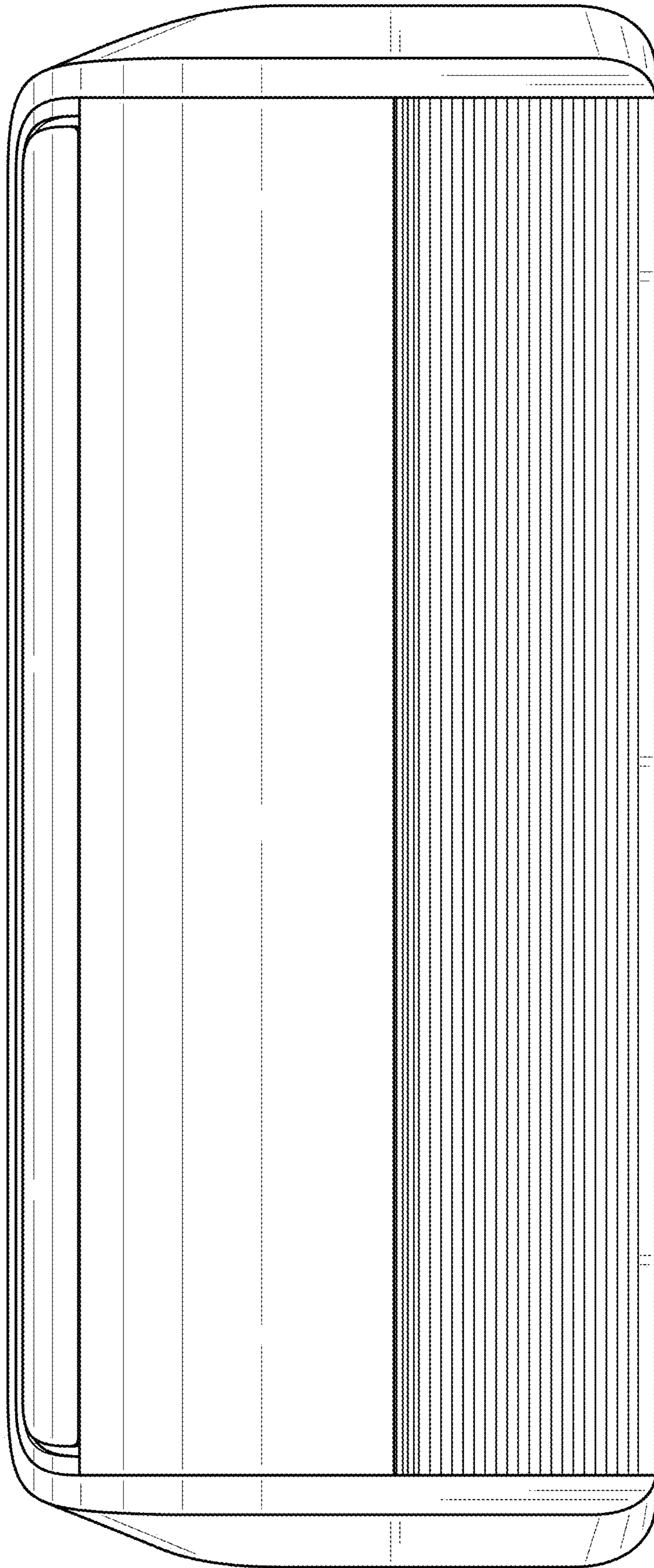

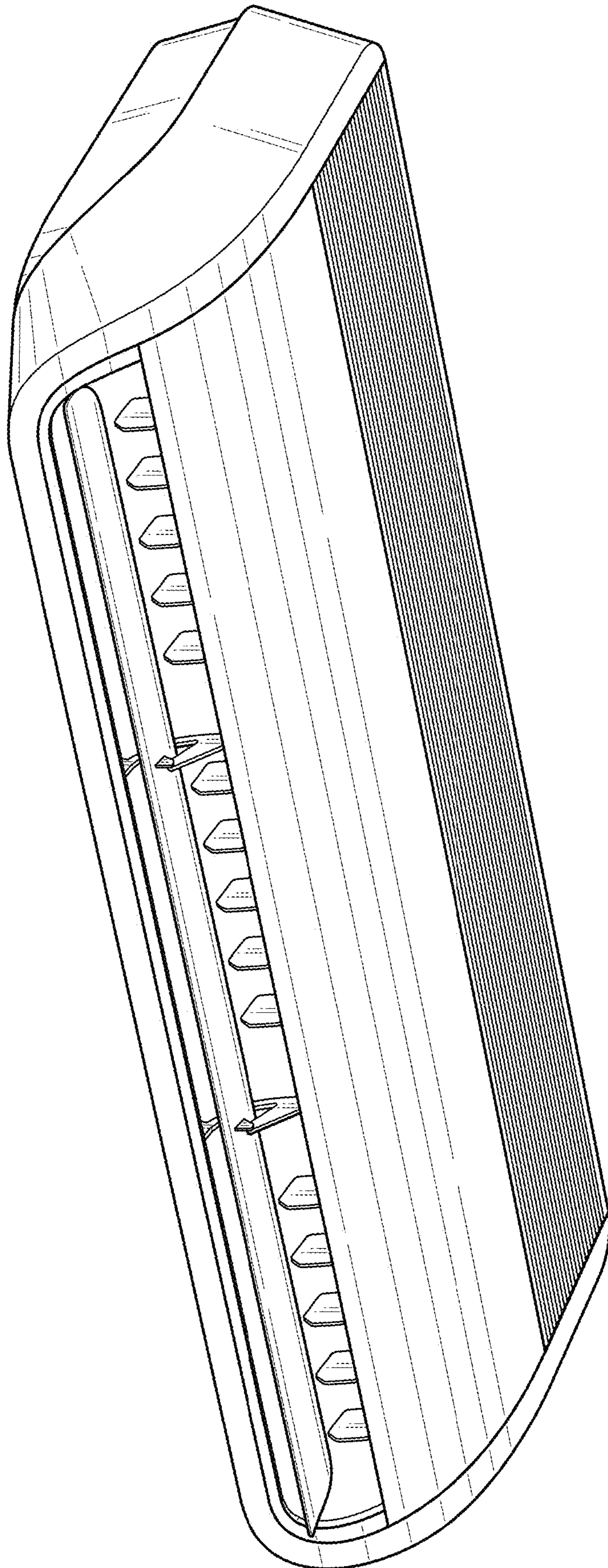
