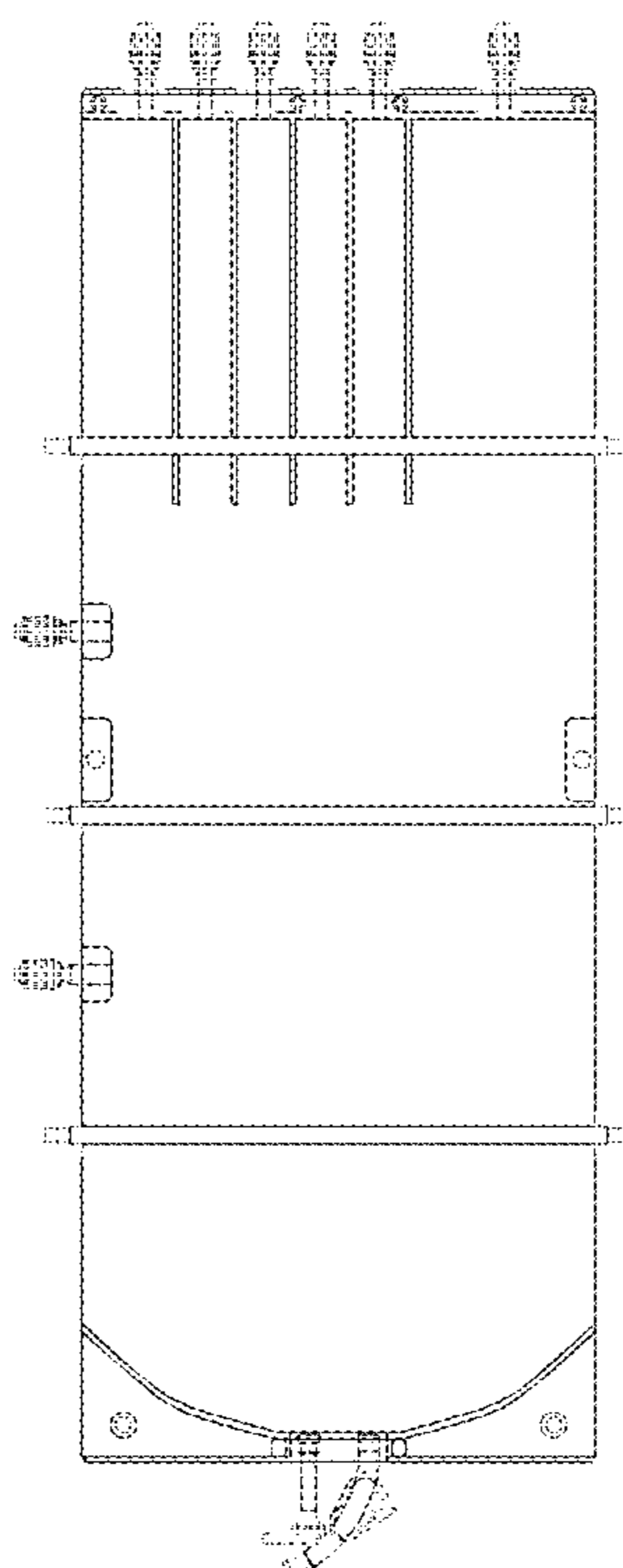

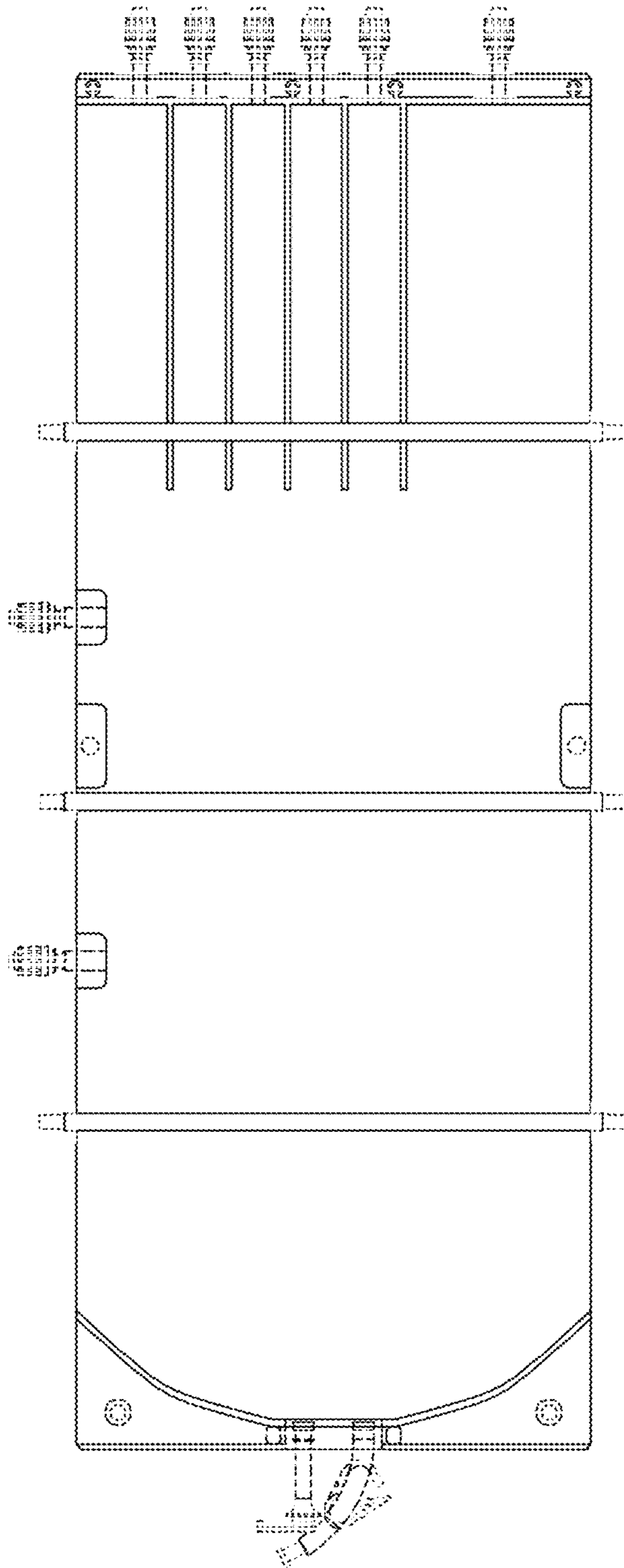
FIG. 2.0 is a front view of the first embodiment for an infusion bag;

FIG. 3.0 is a front view of the second embodiment for an infusion bag.

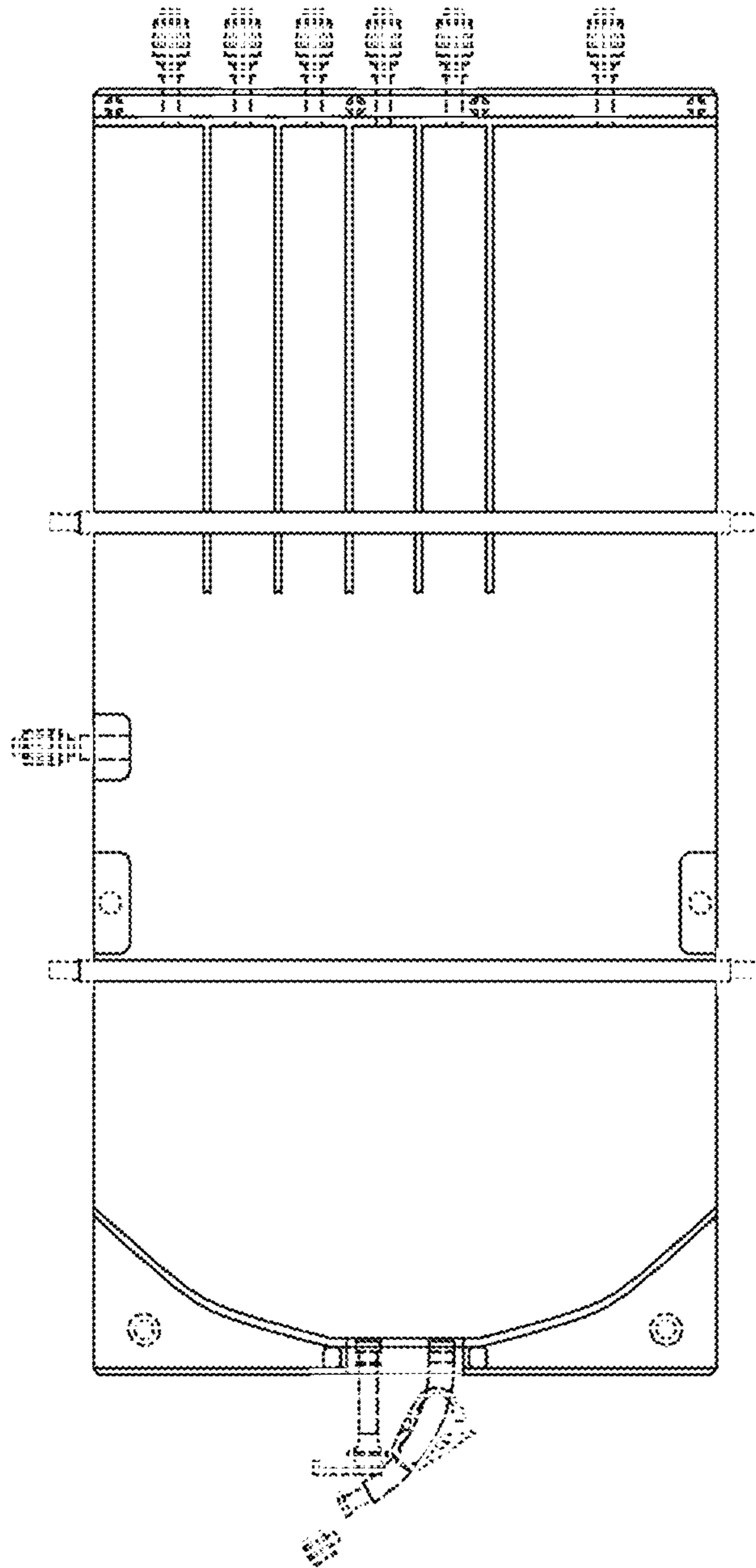
The portions of the infusion bag shown in broken lines form no part of the claimed design.
