The ornamental design for a decorative light system, as shown and described.

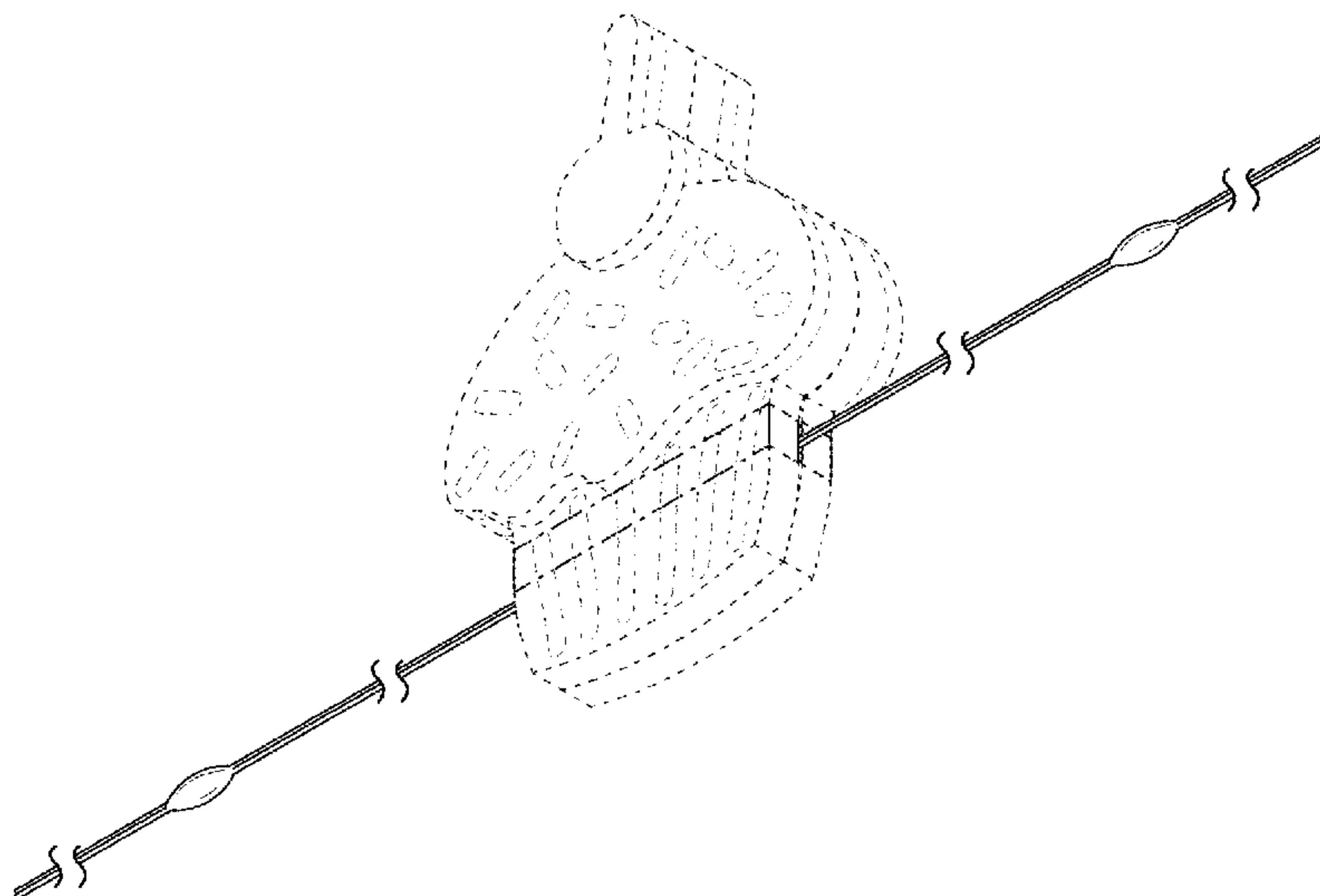
**DESCRIPTION**

FIG. 7 is a bottom view thereof.

The dashed lines in the drawings depict portions of the decorative lighting system and form no part of the claimed design. The dash-dot lines in the drawings depict an internal channel of the decorative lighting system and form no part of the claimed design.

The decorative light system is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

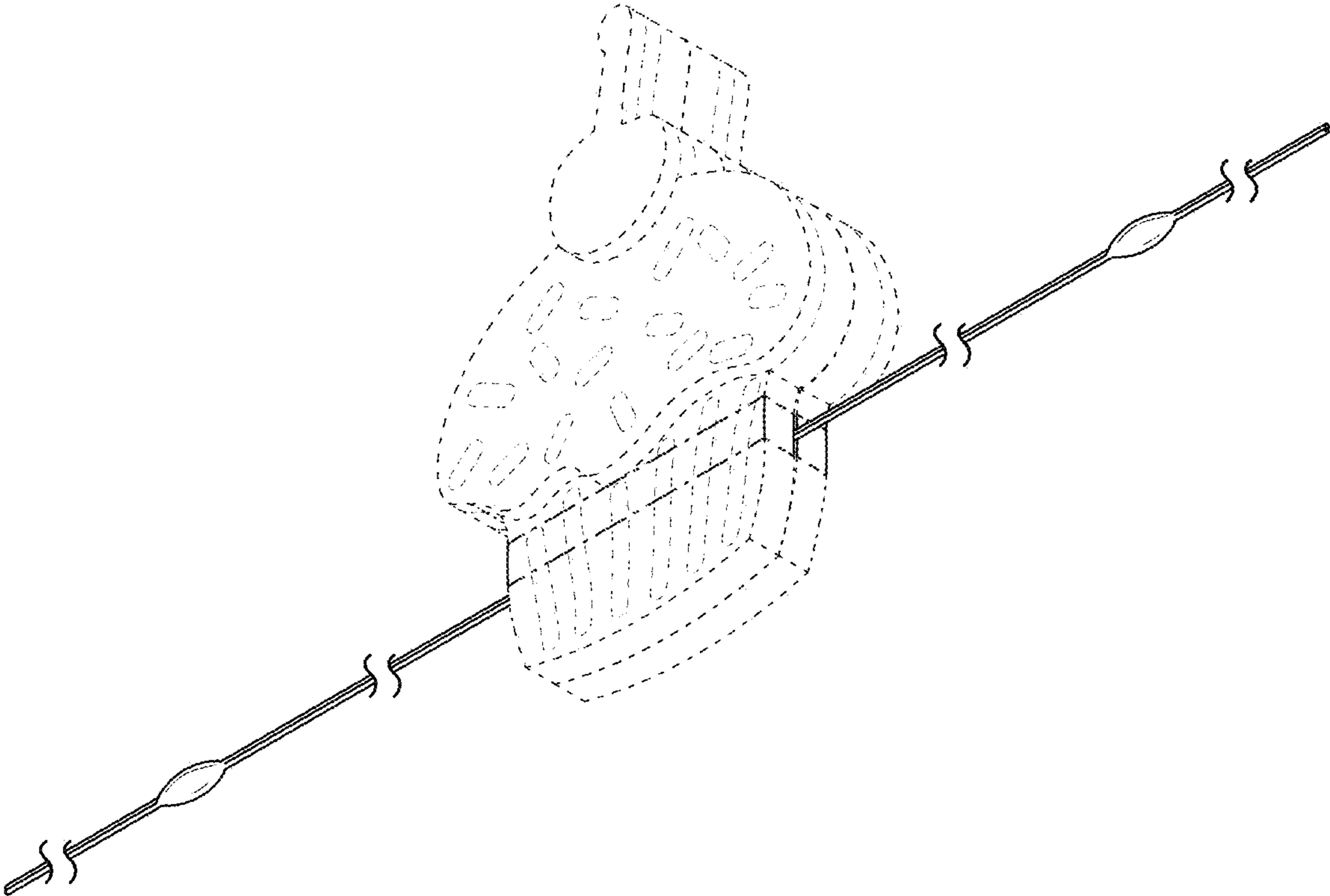

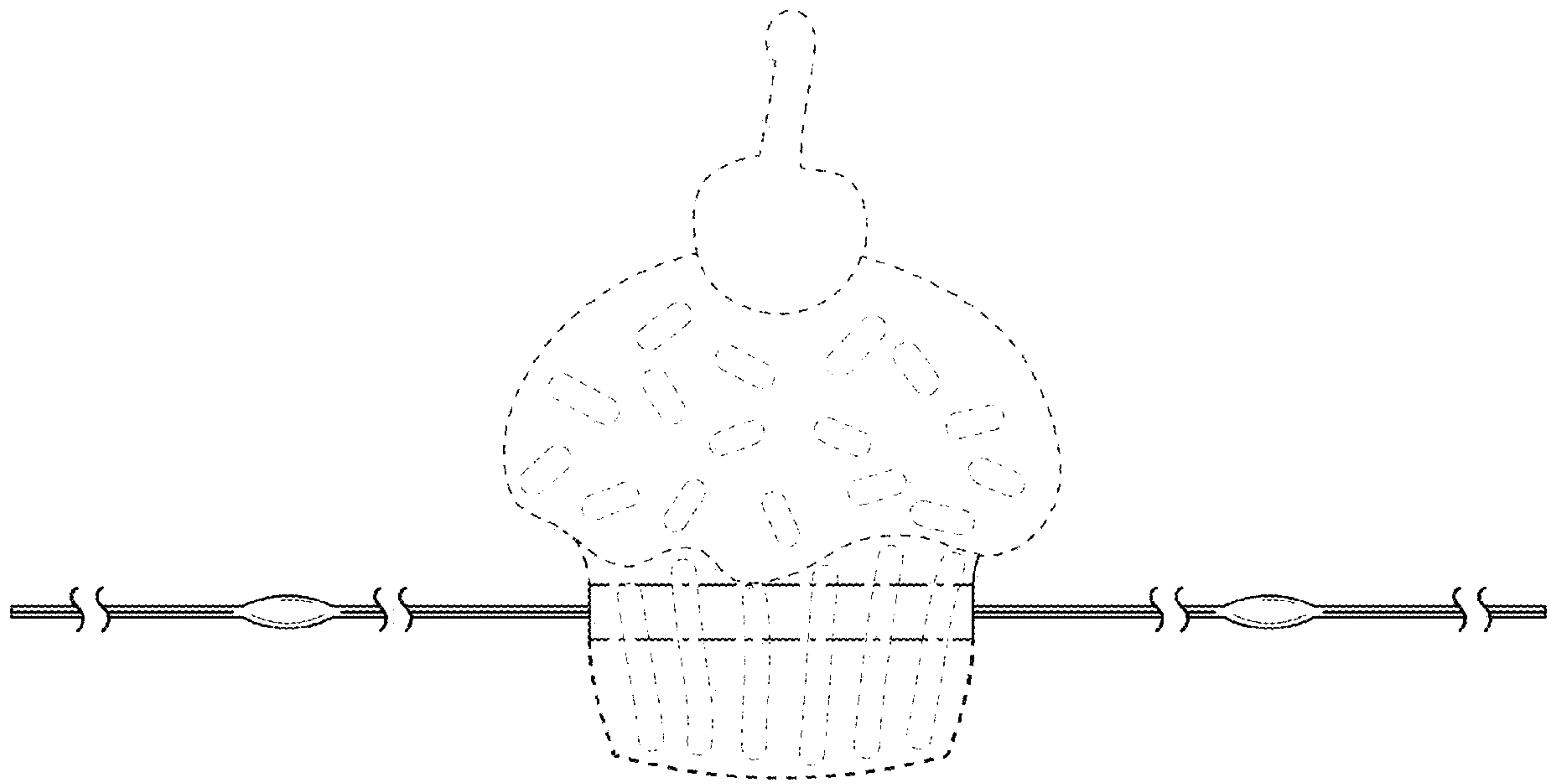

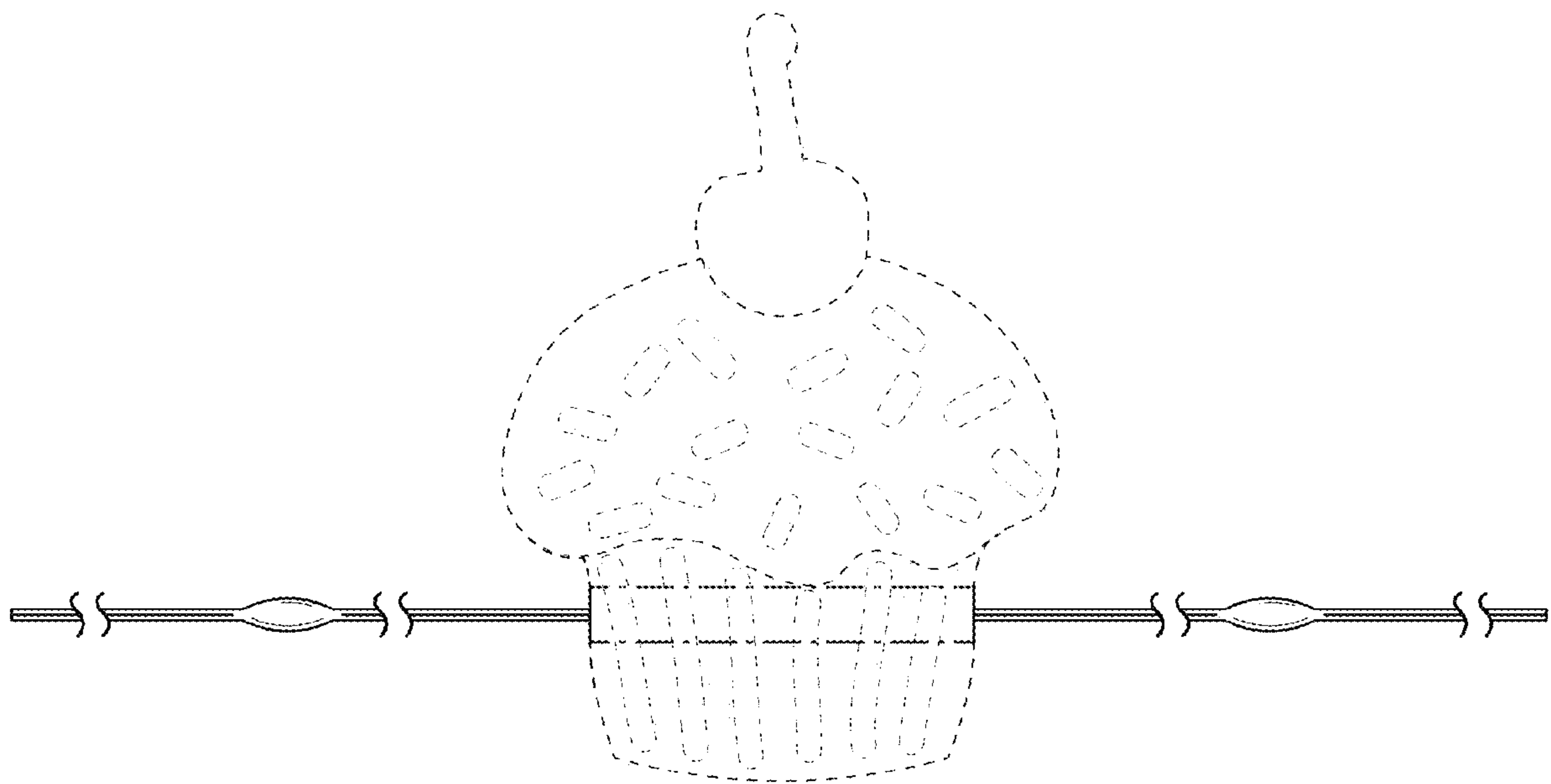

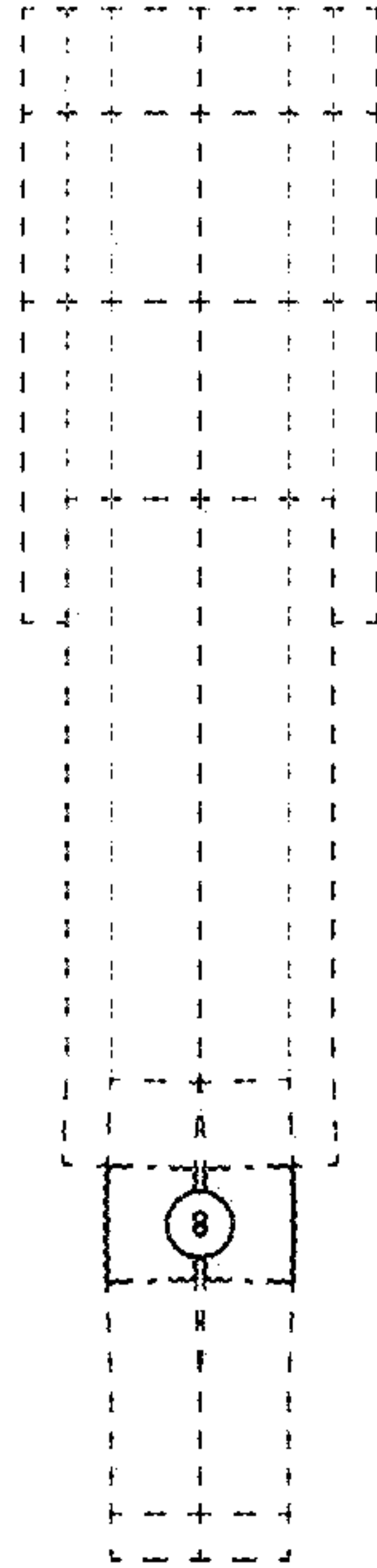

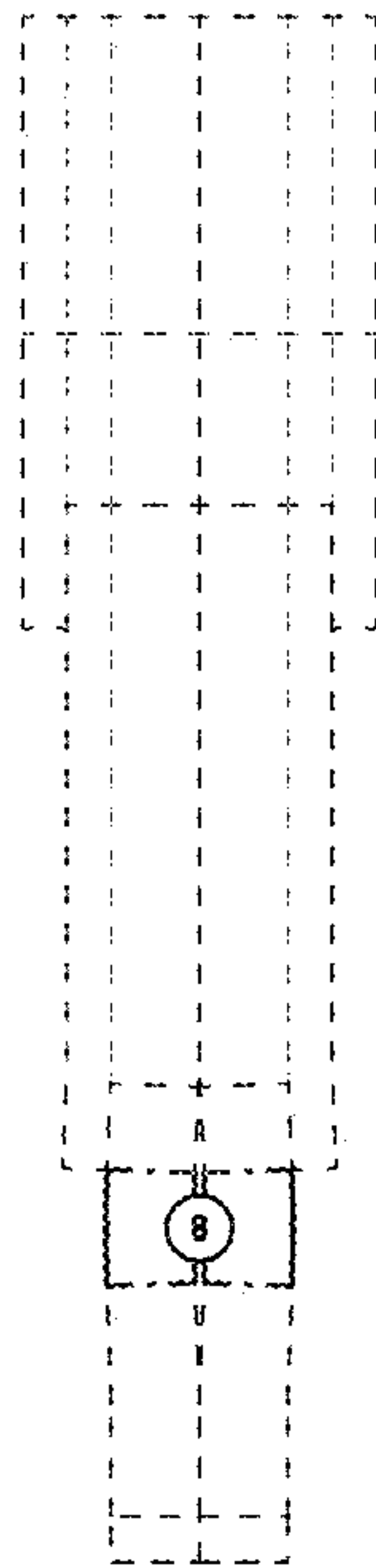

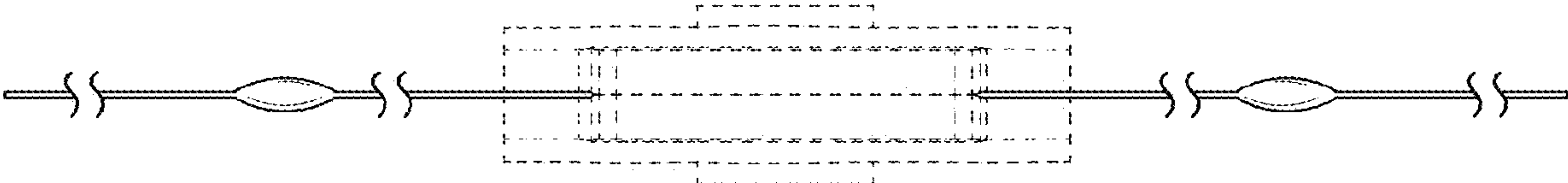
