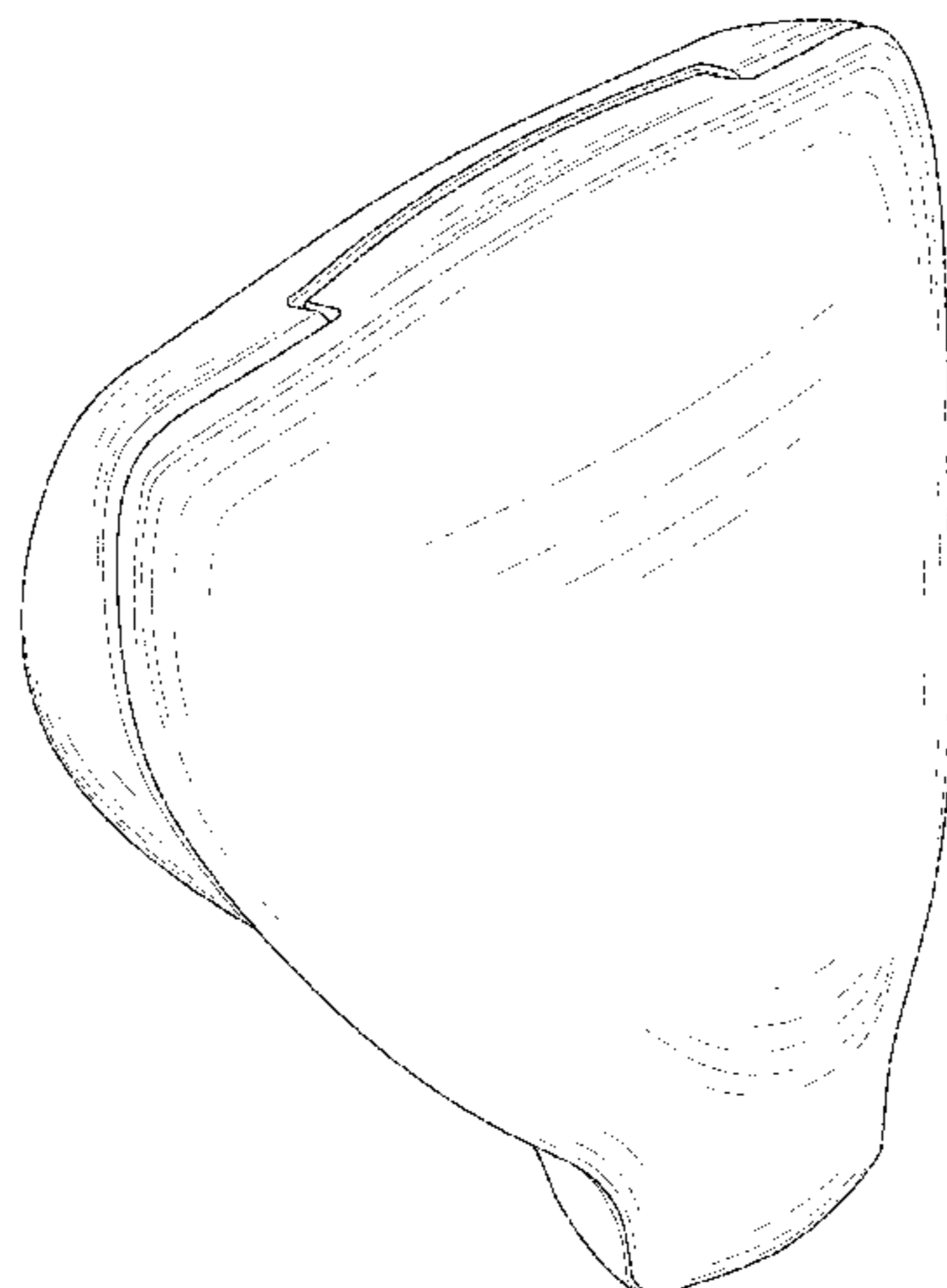
The ornamental design for a razor cover, as substantially shown and described.

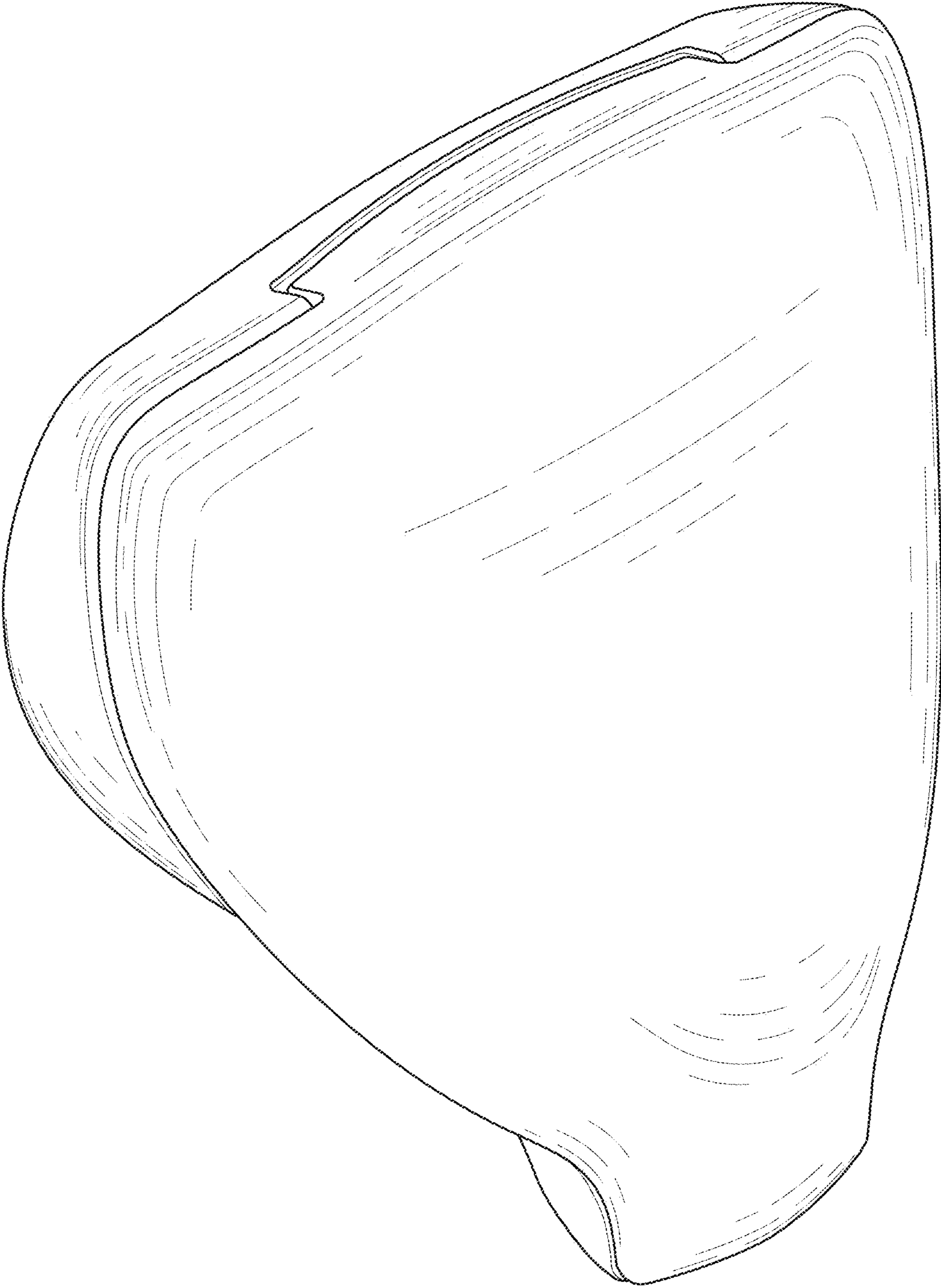

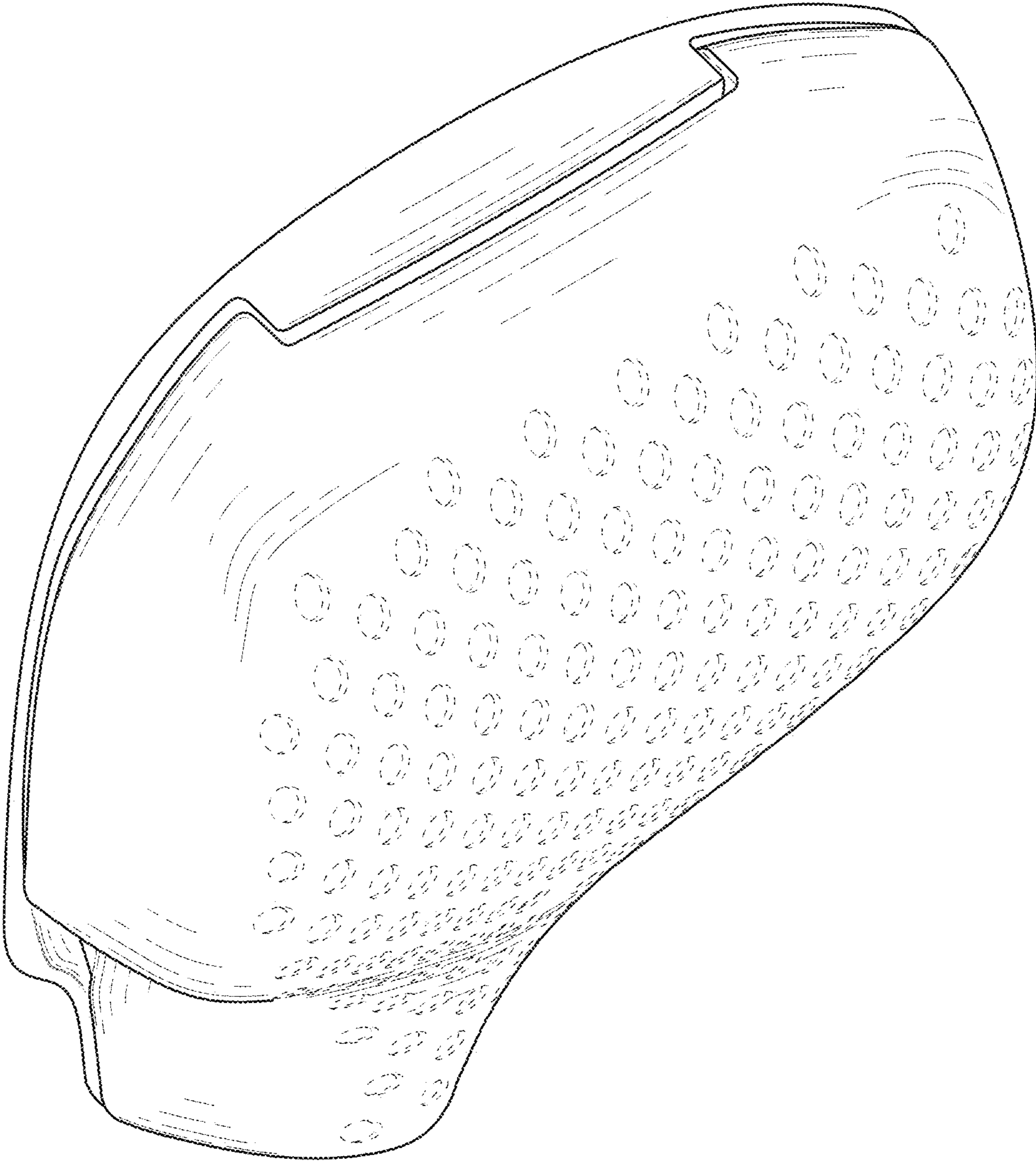
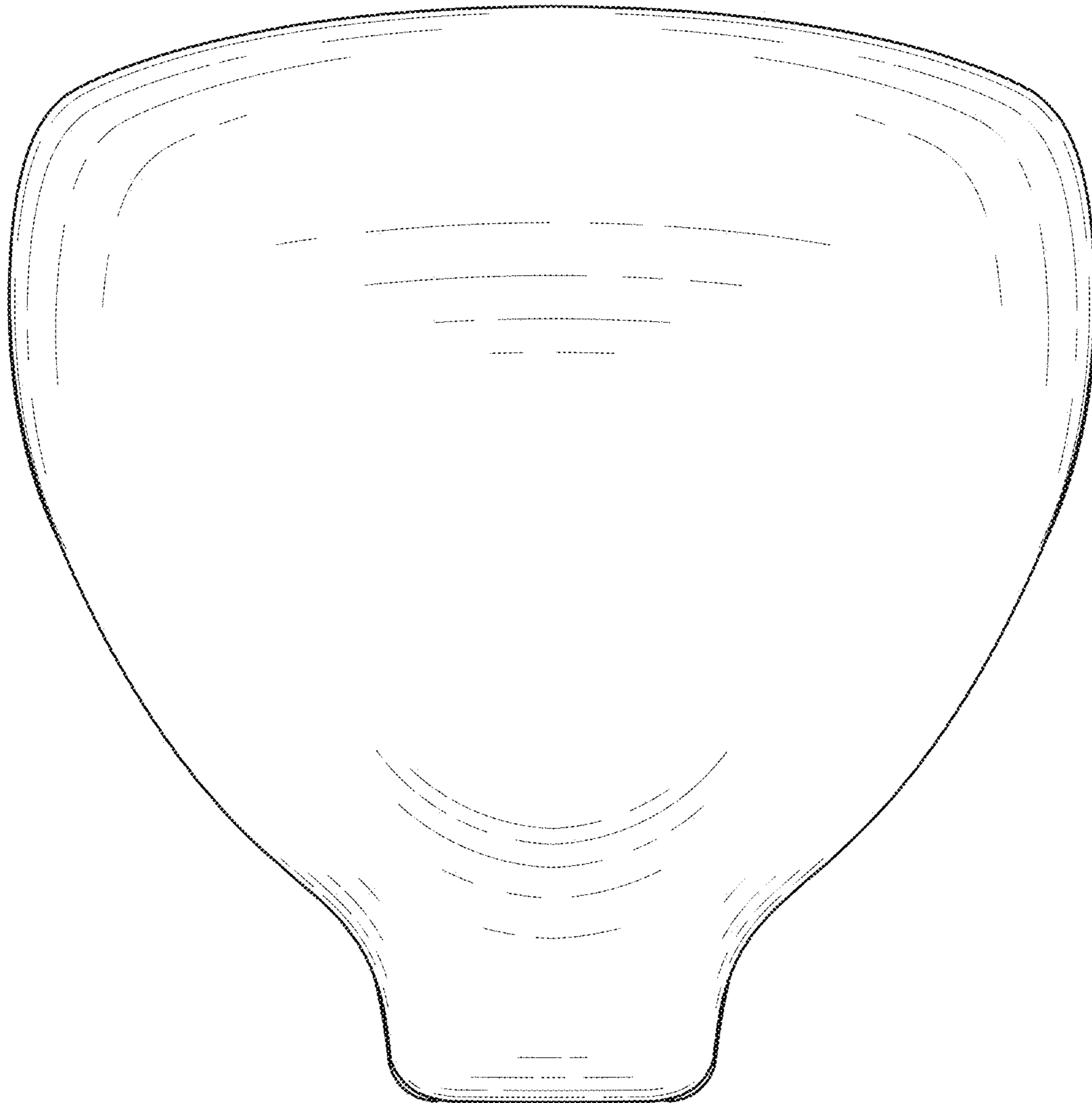
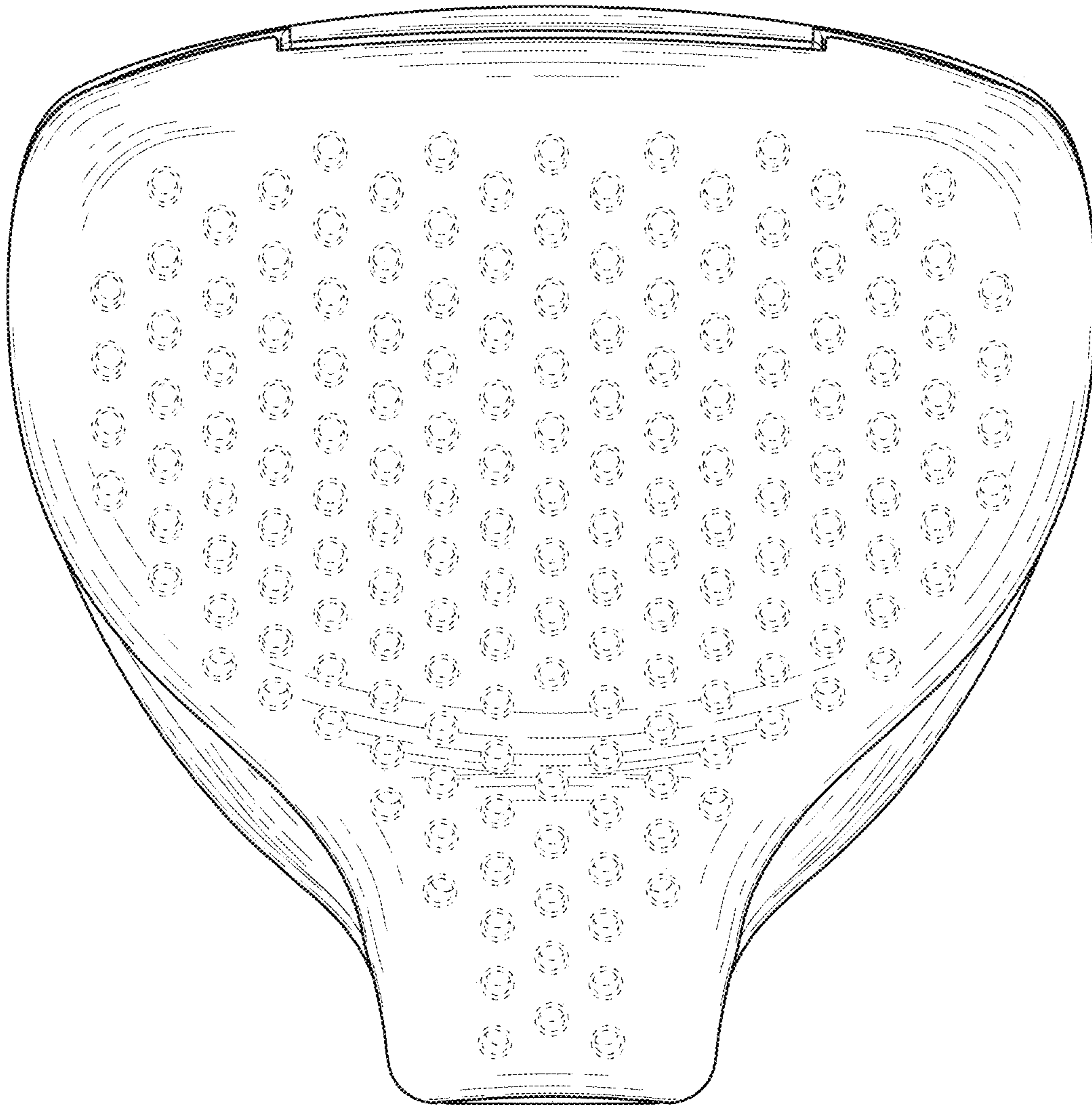


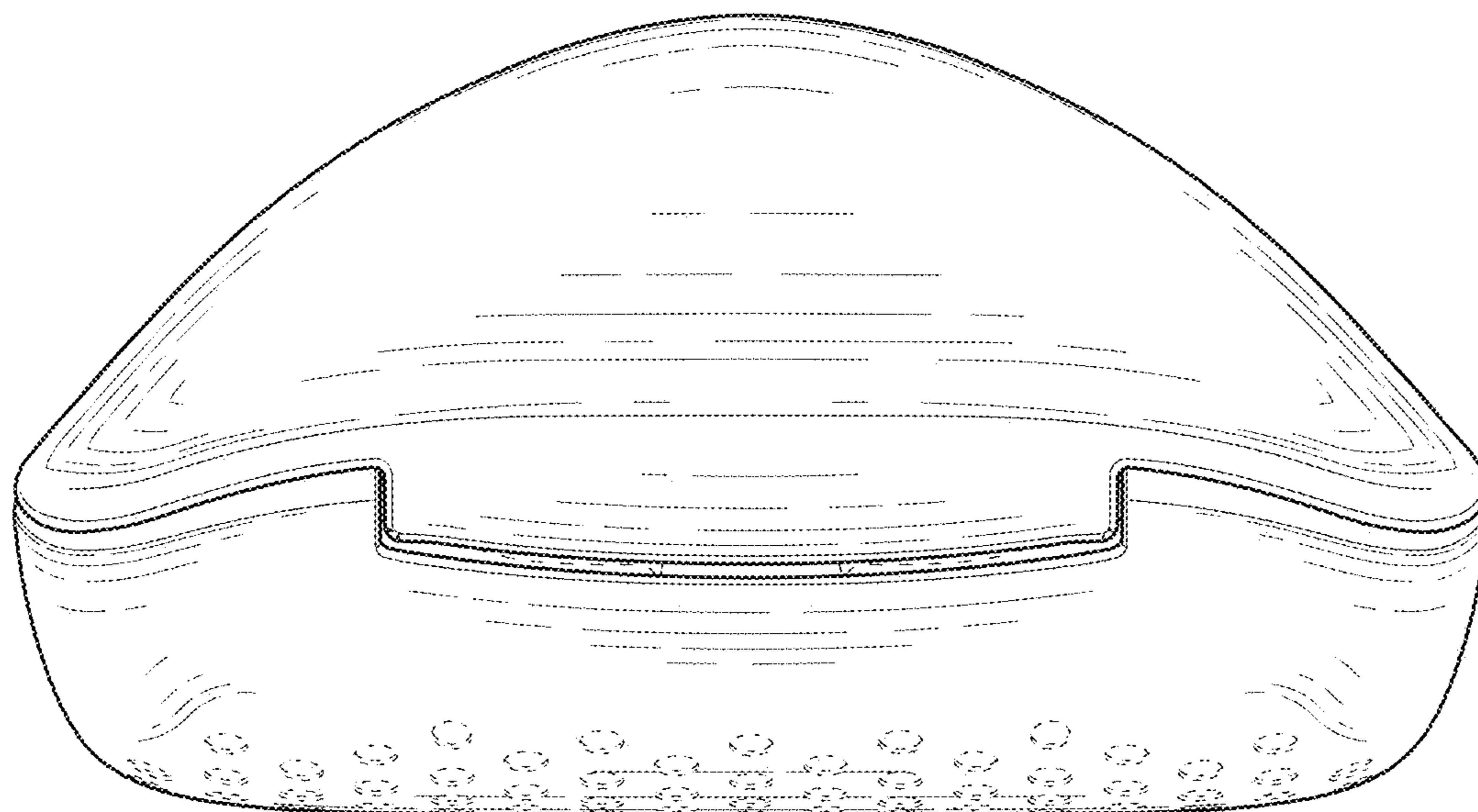

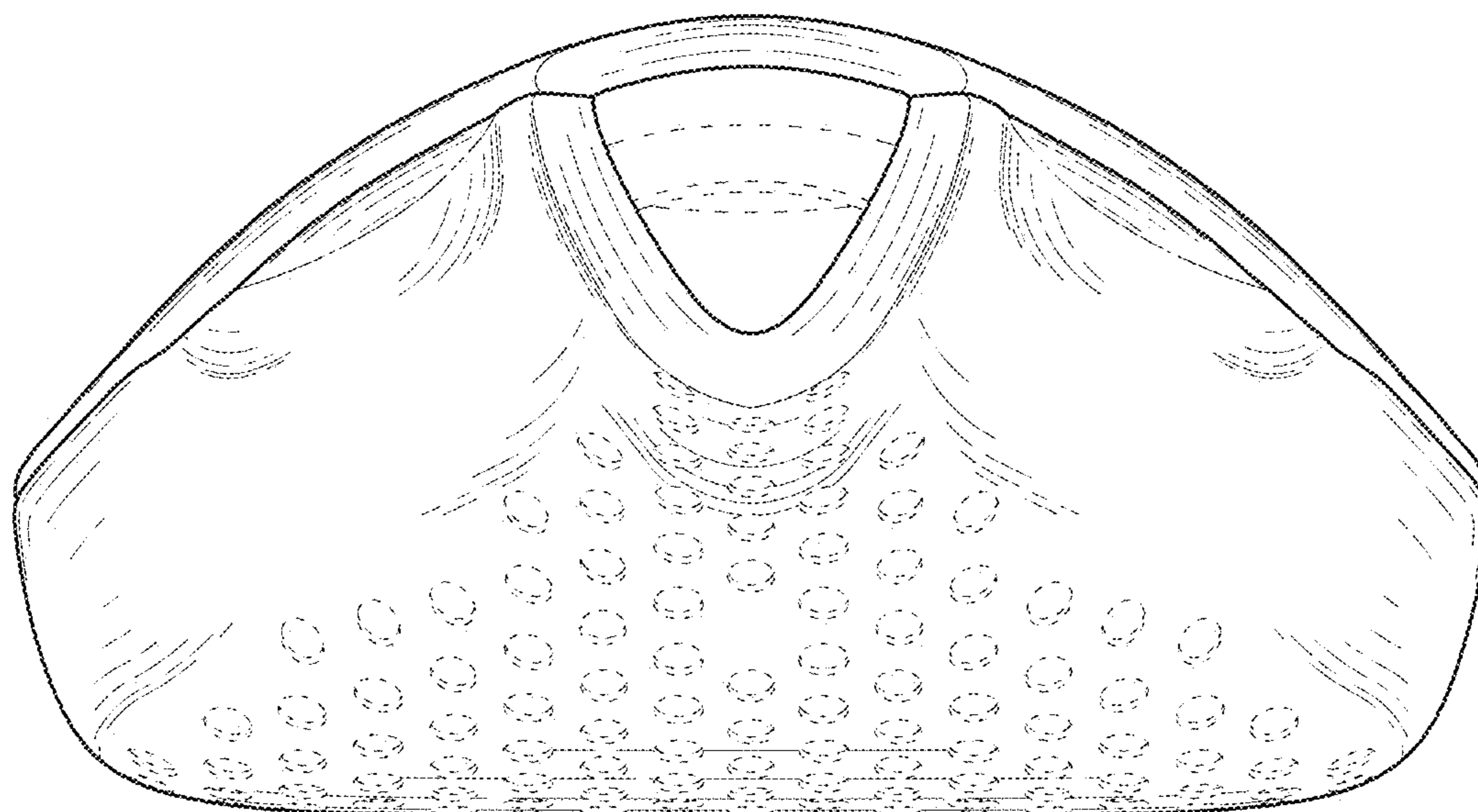

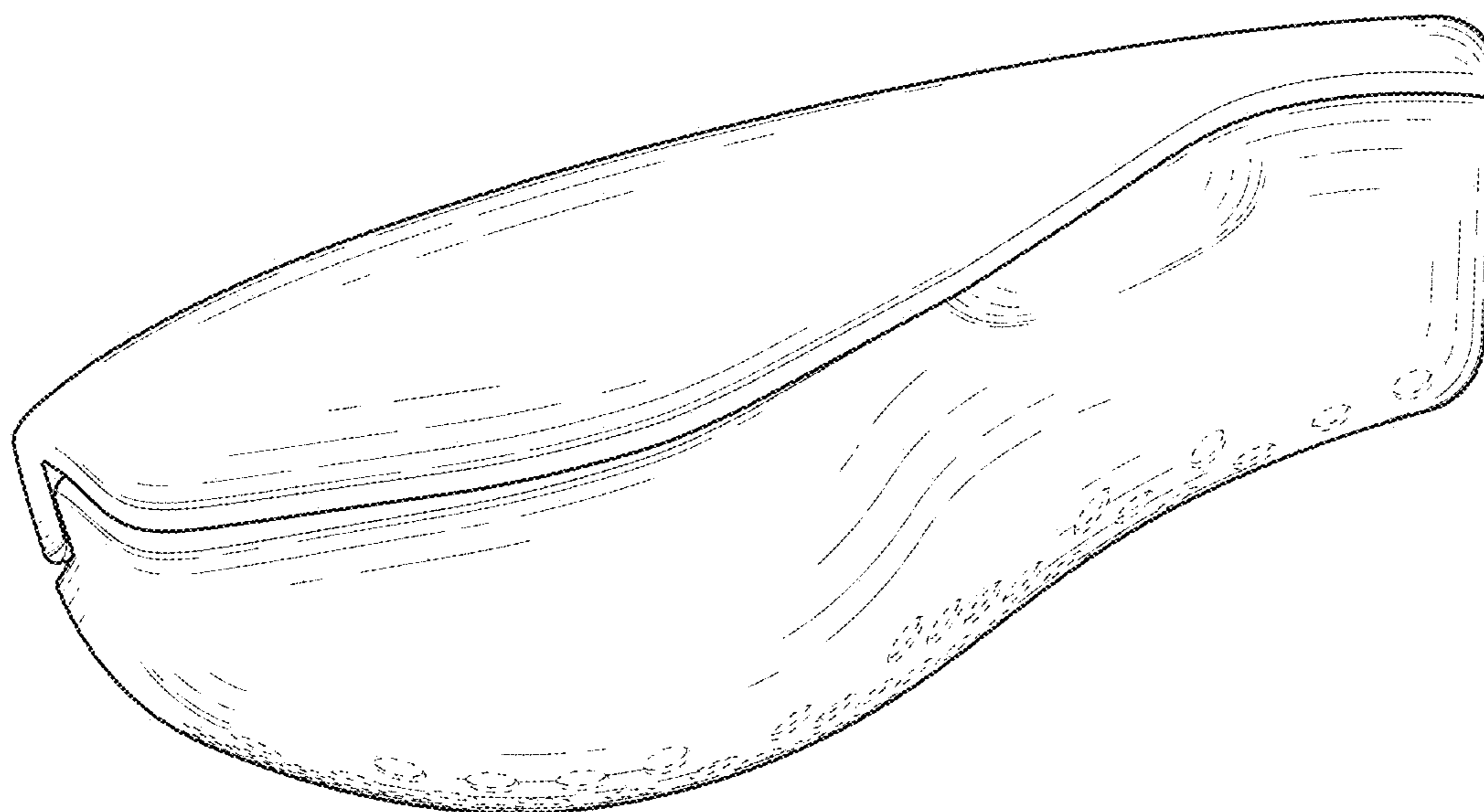

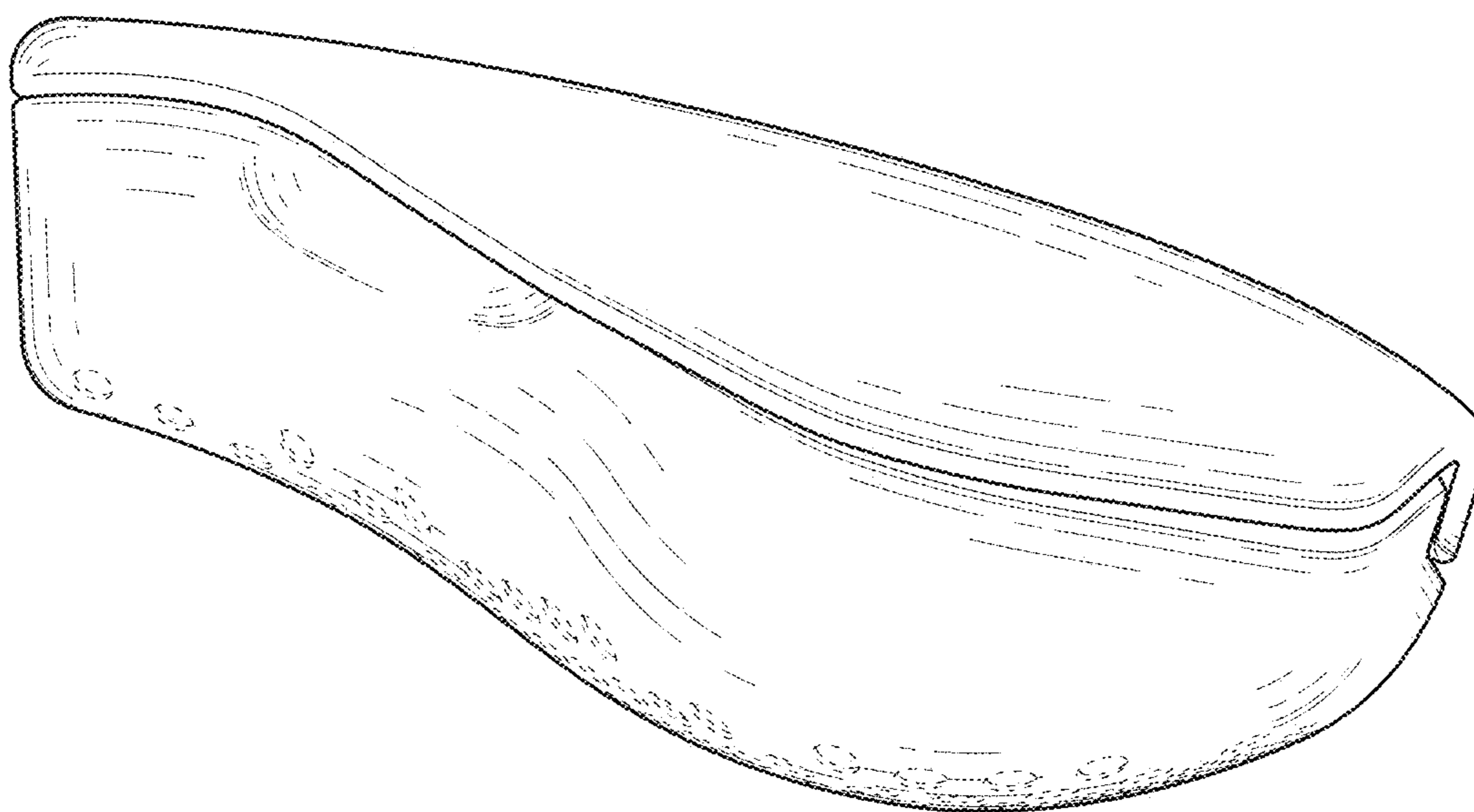

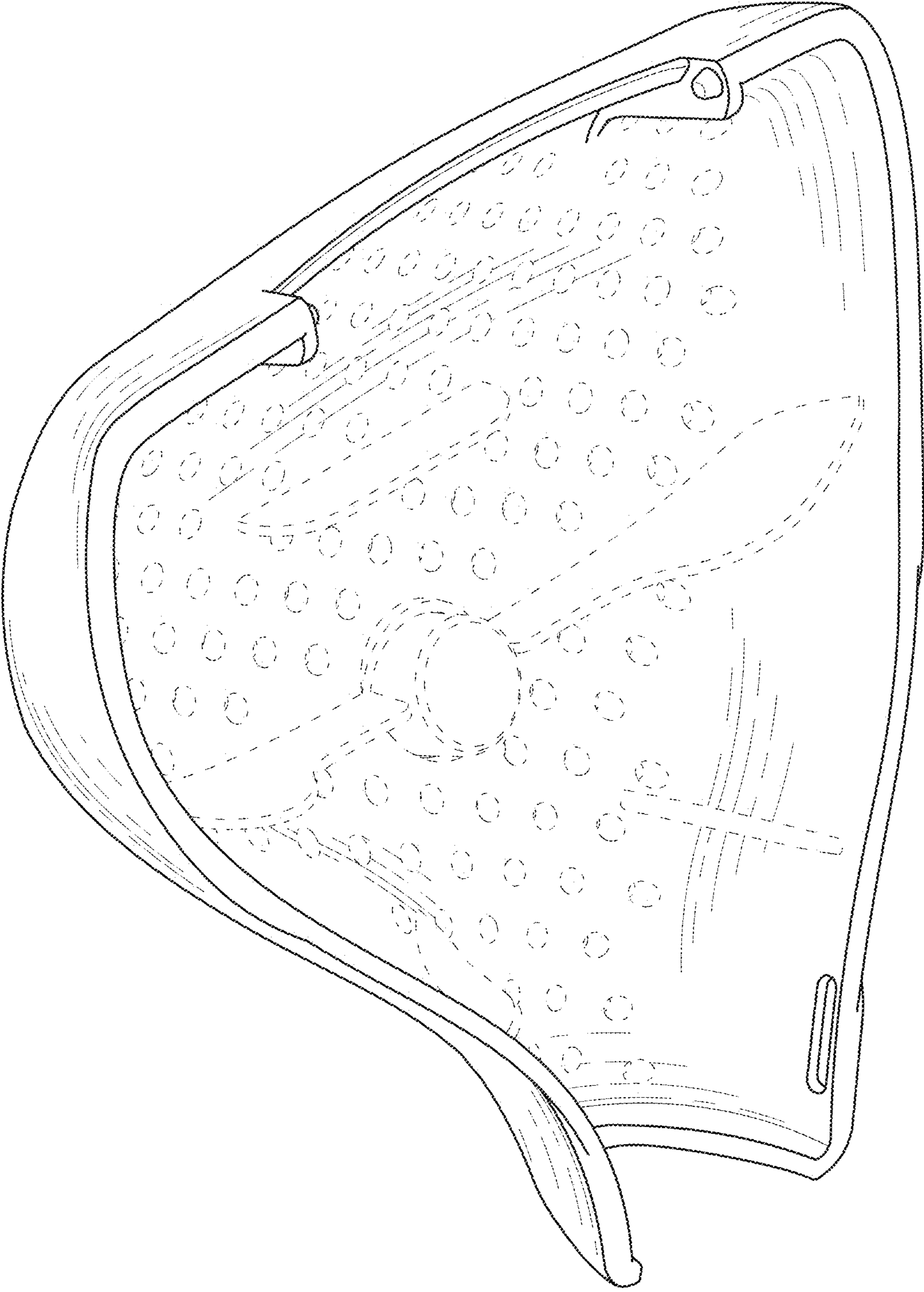
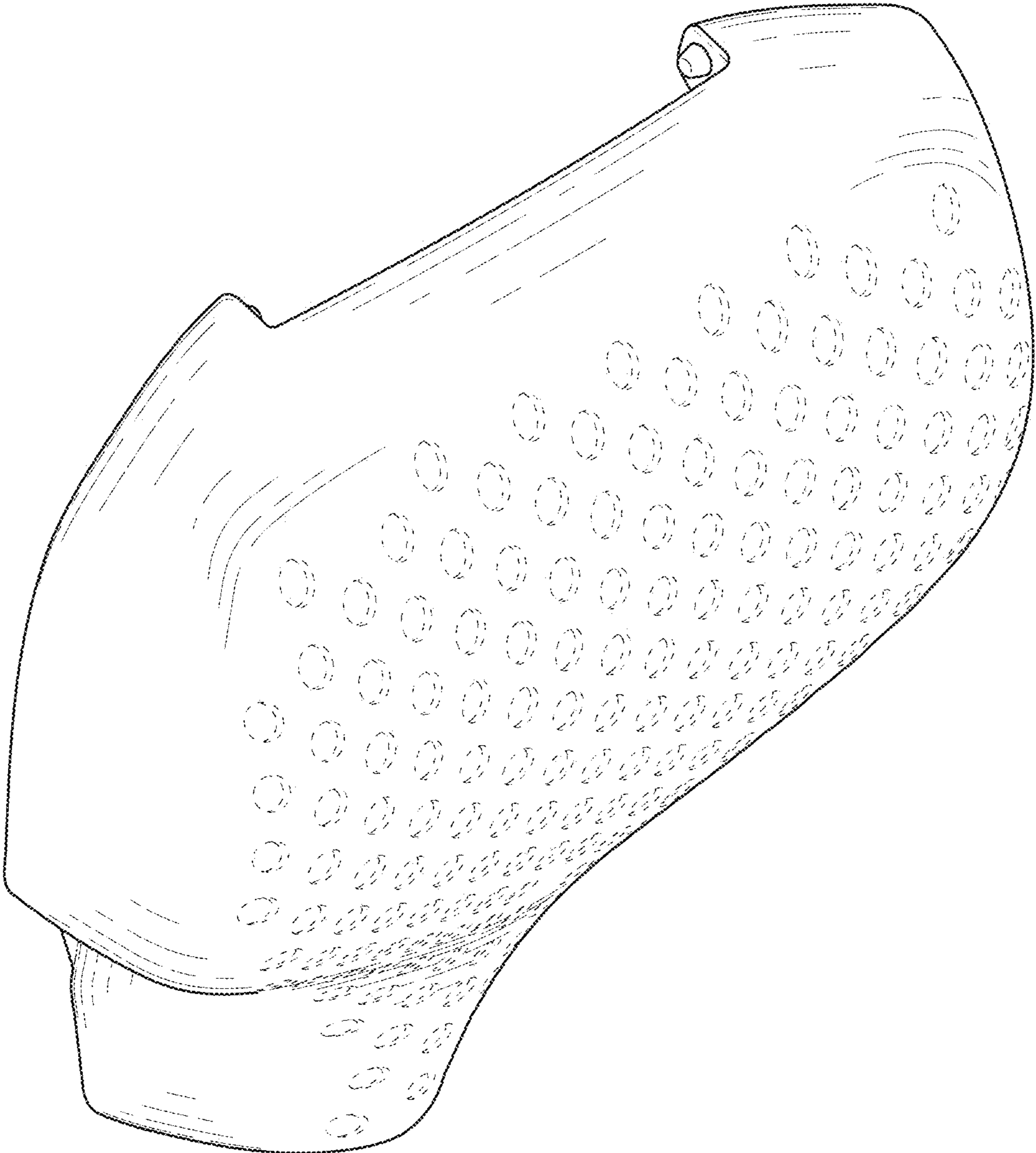
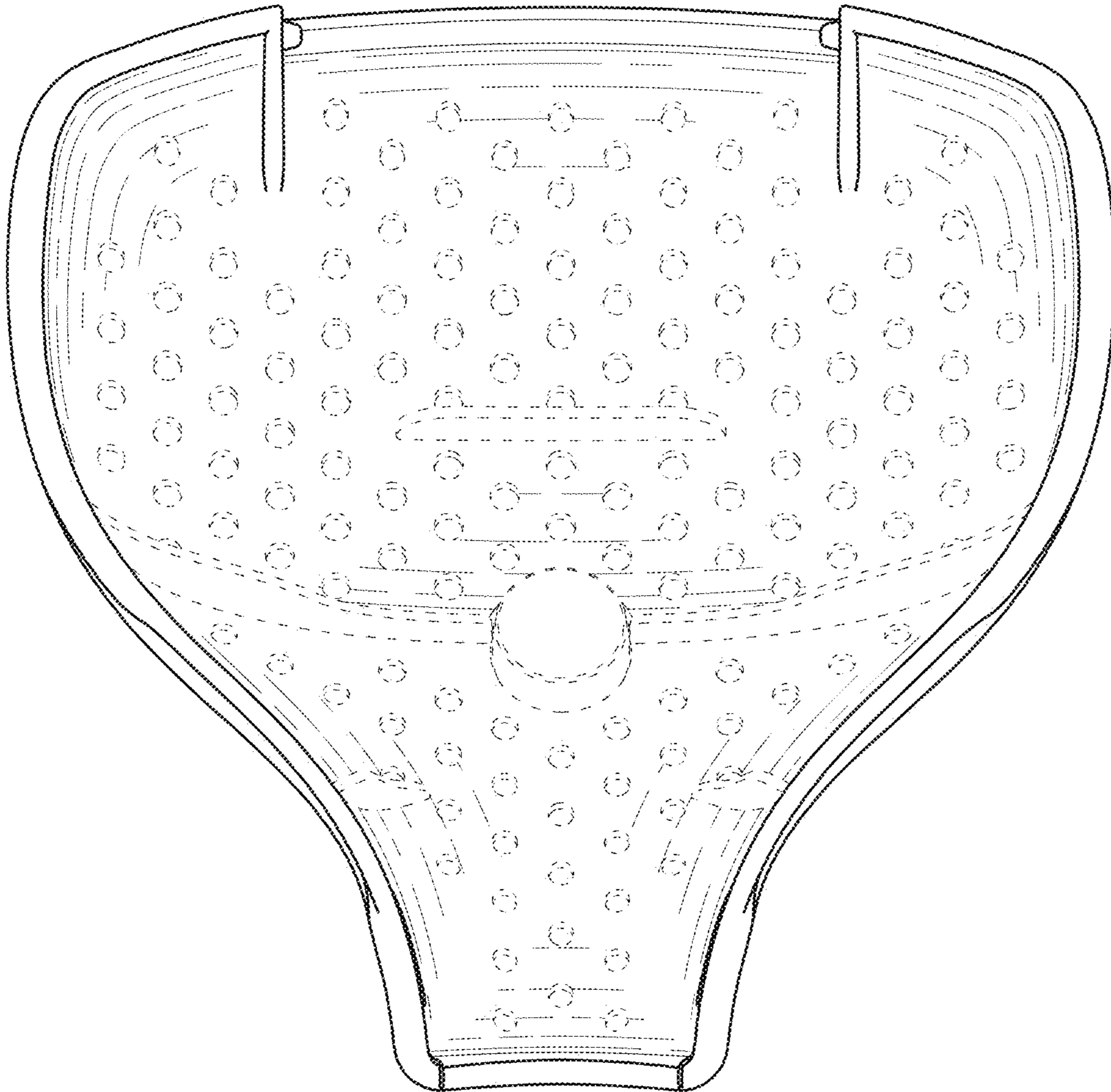

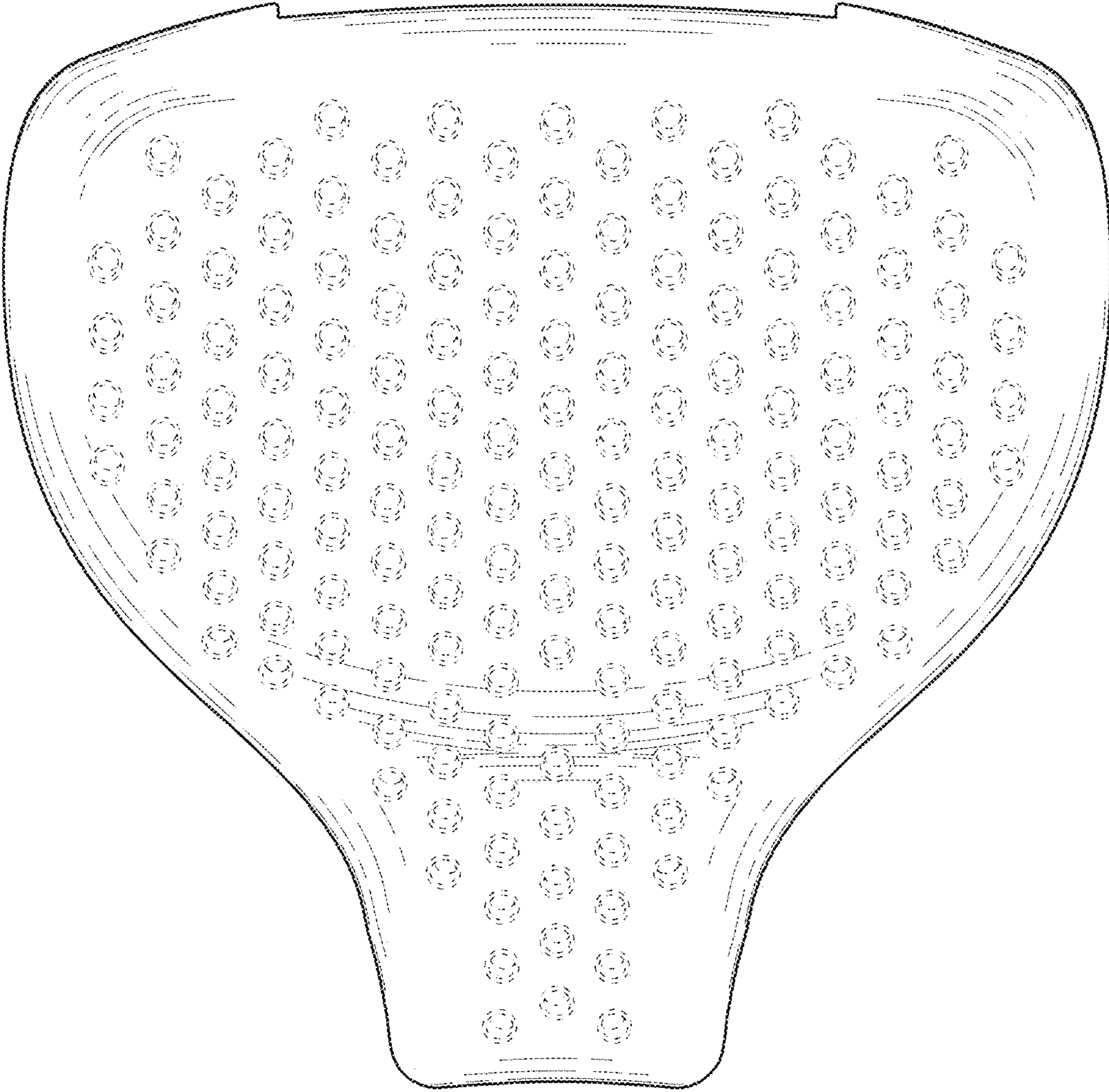

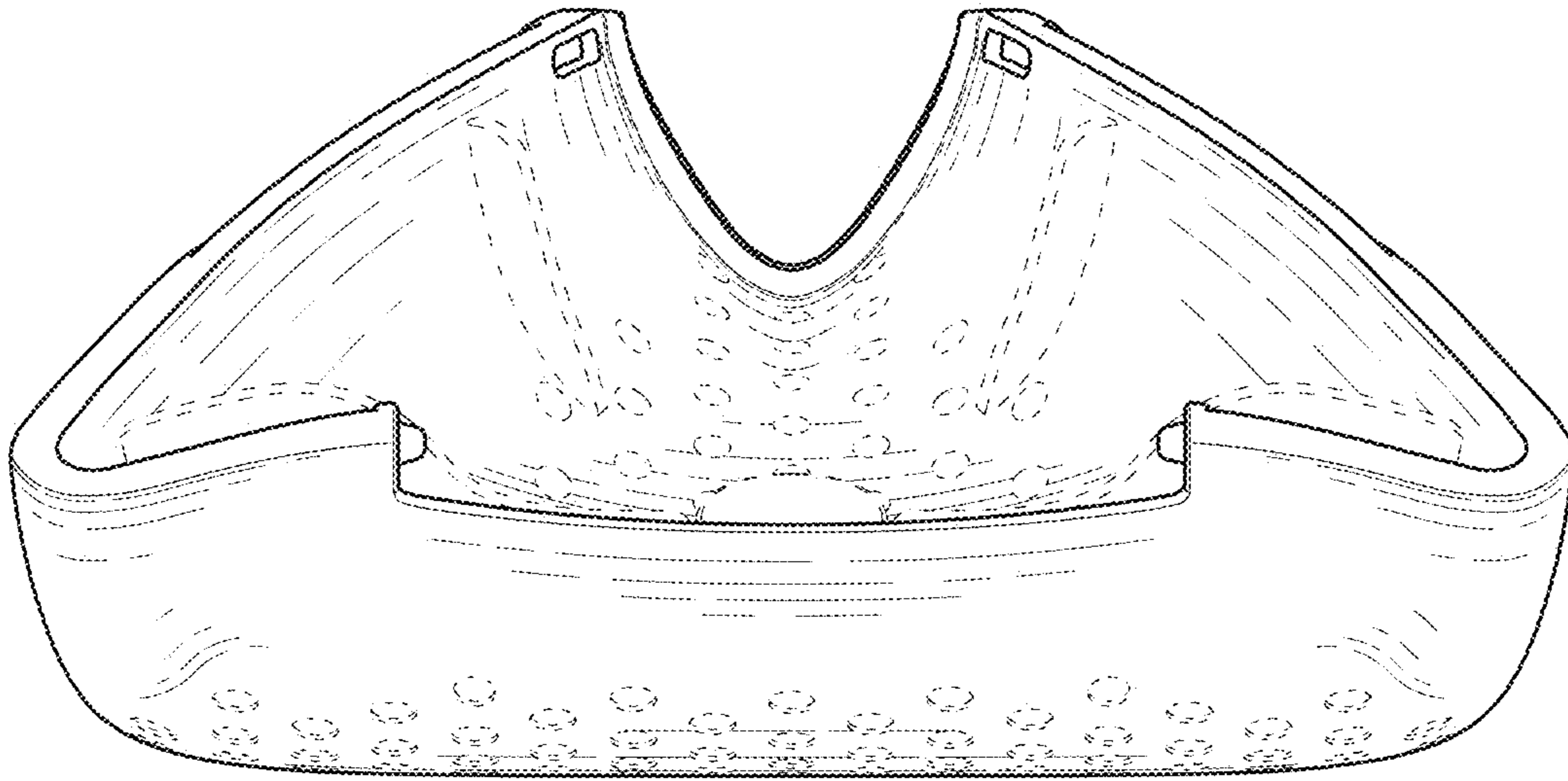

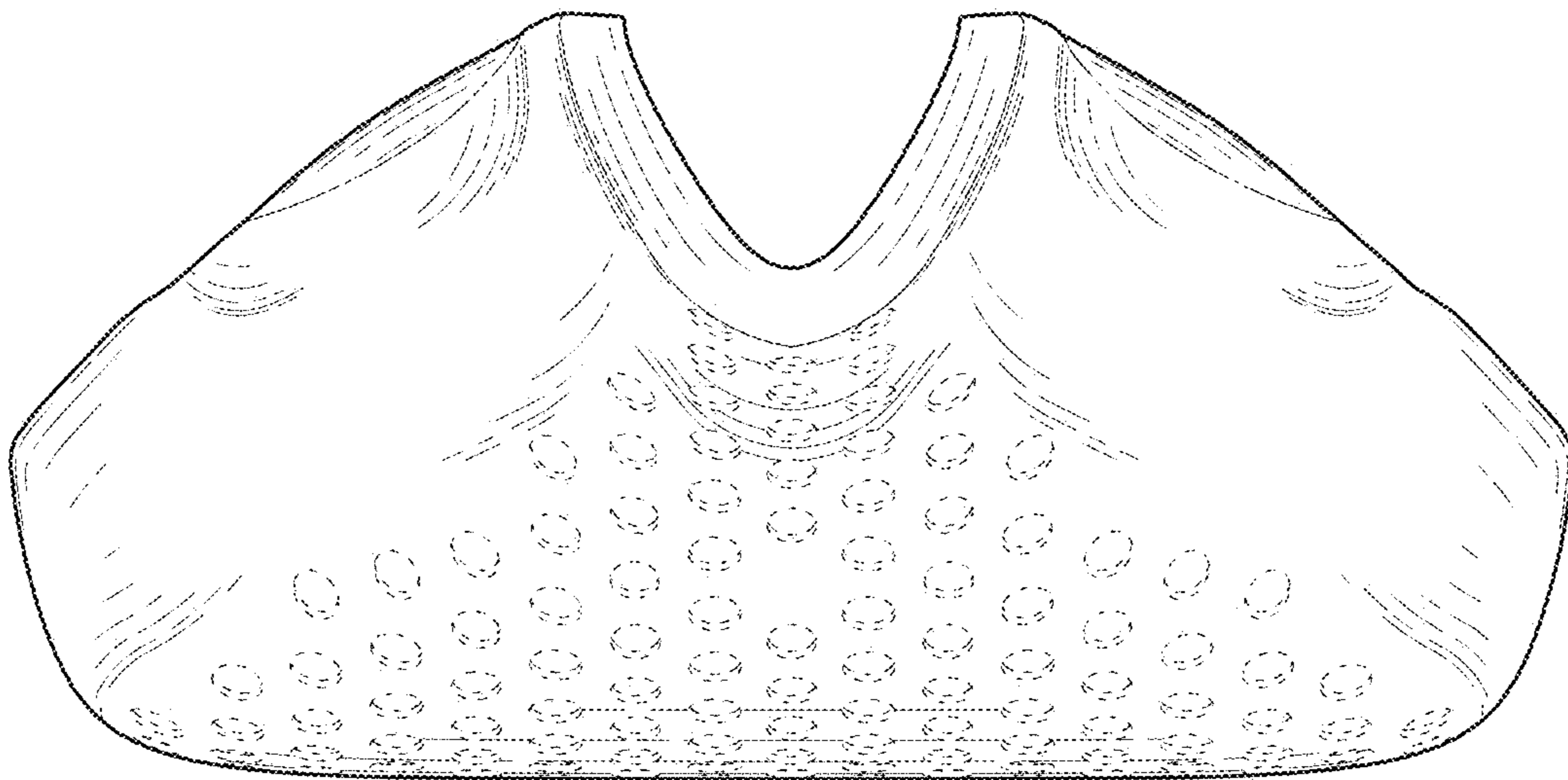
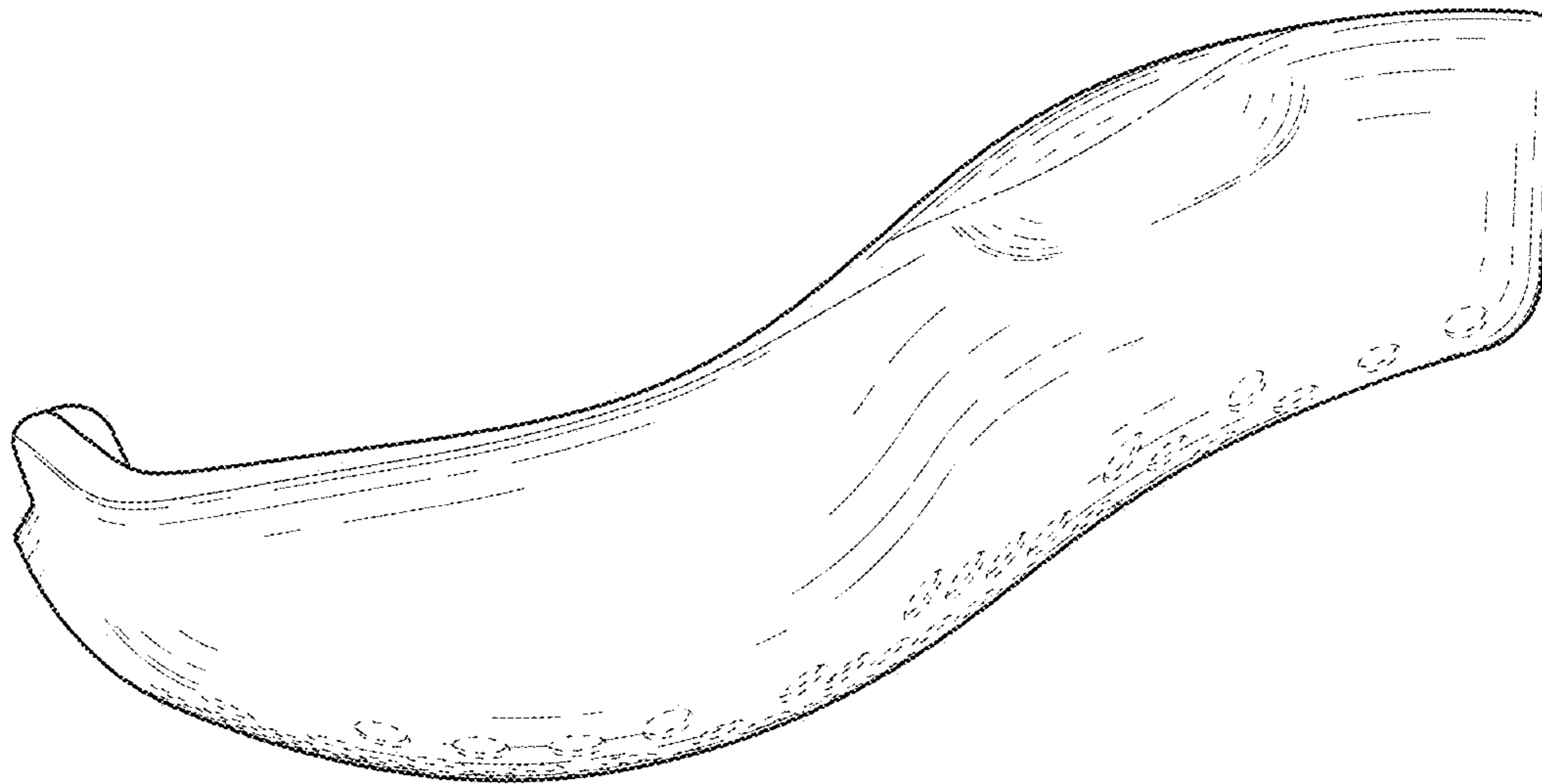
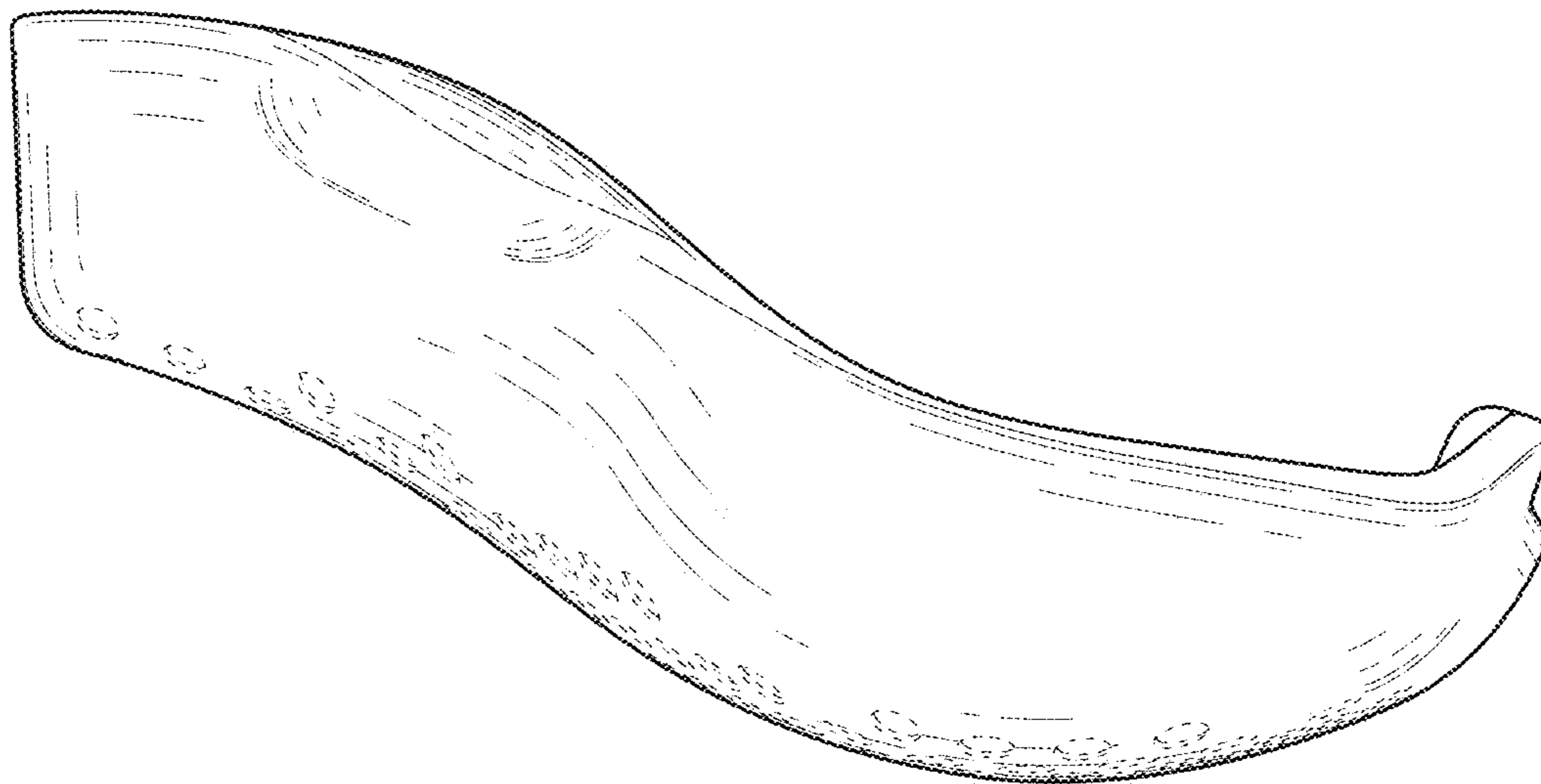


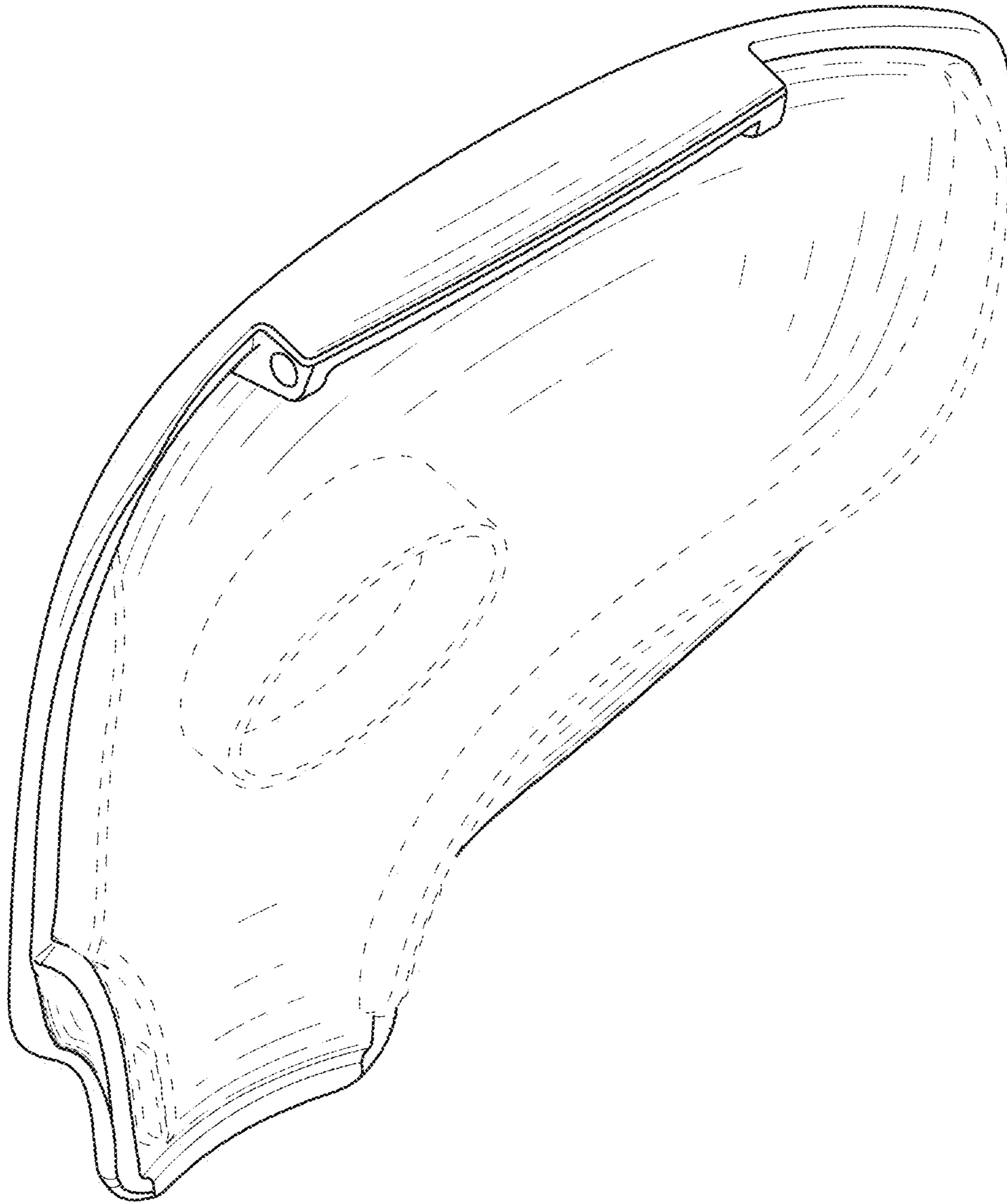

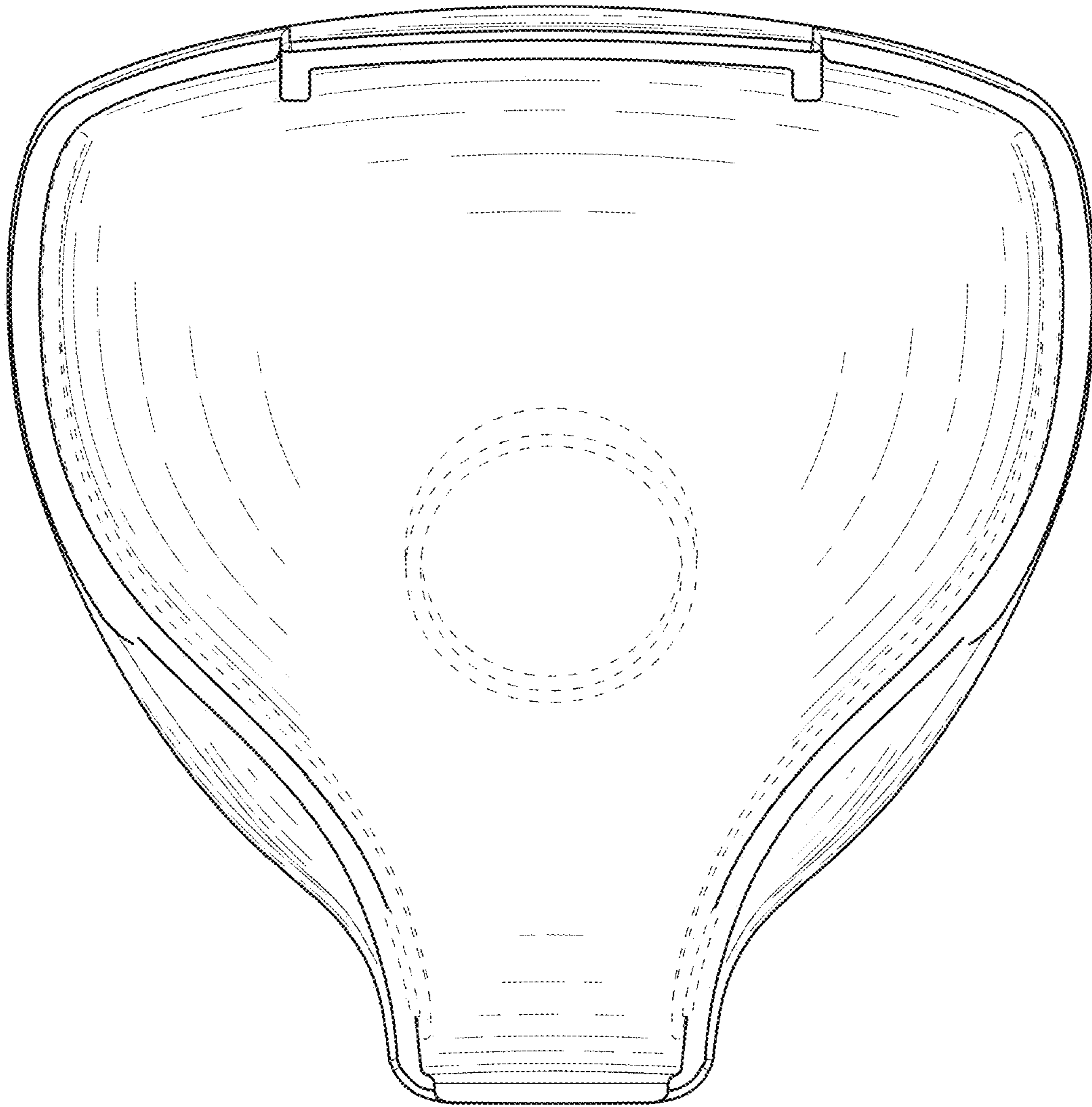

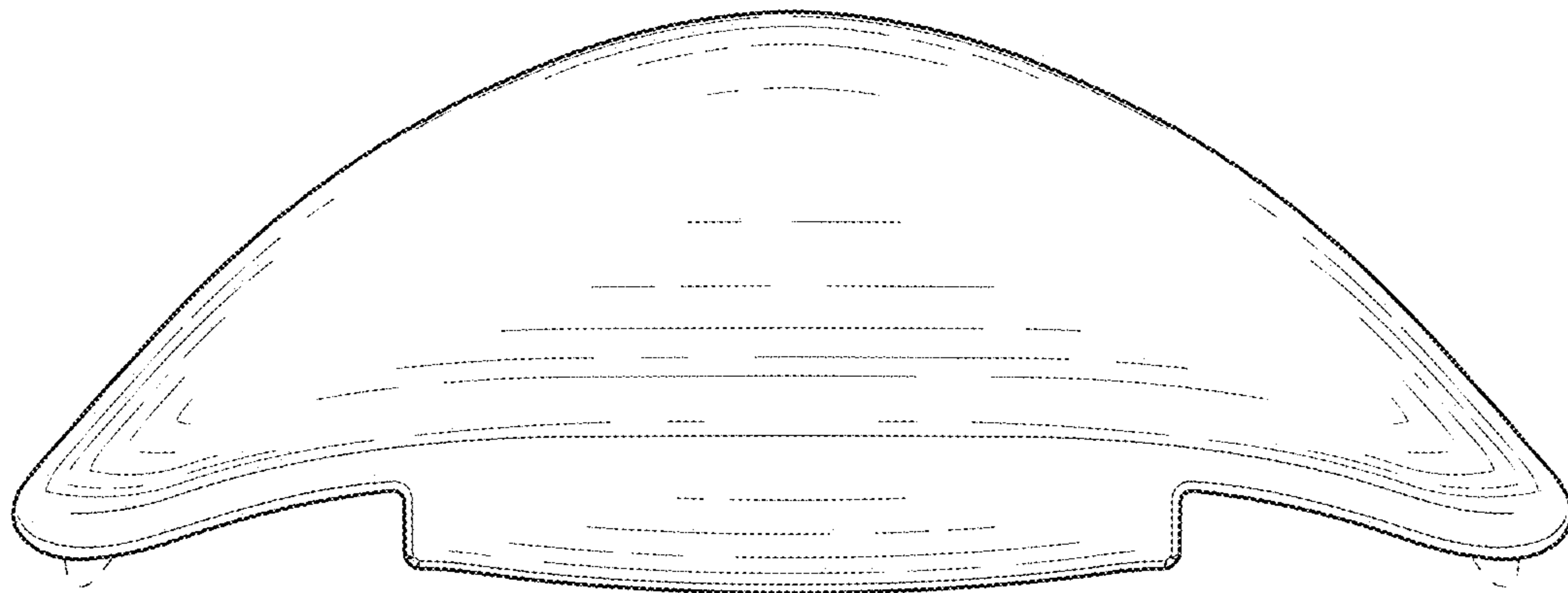

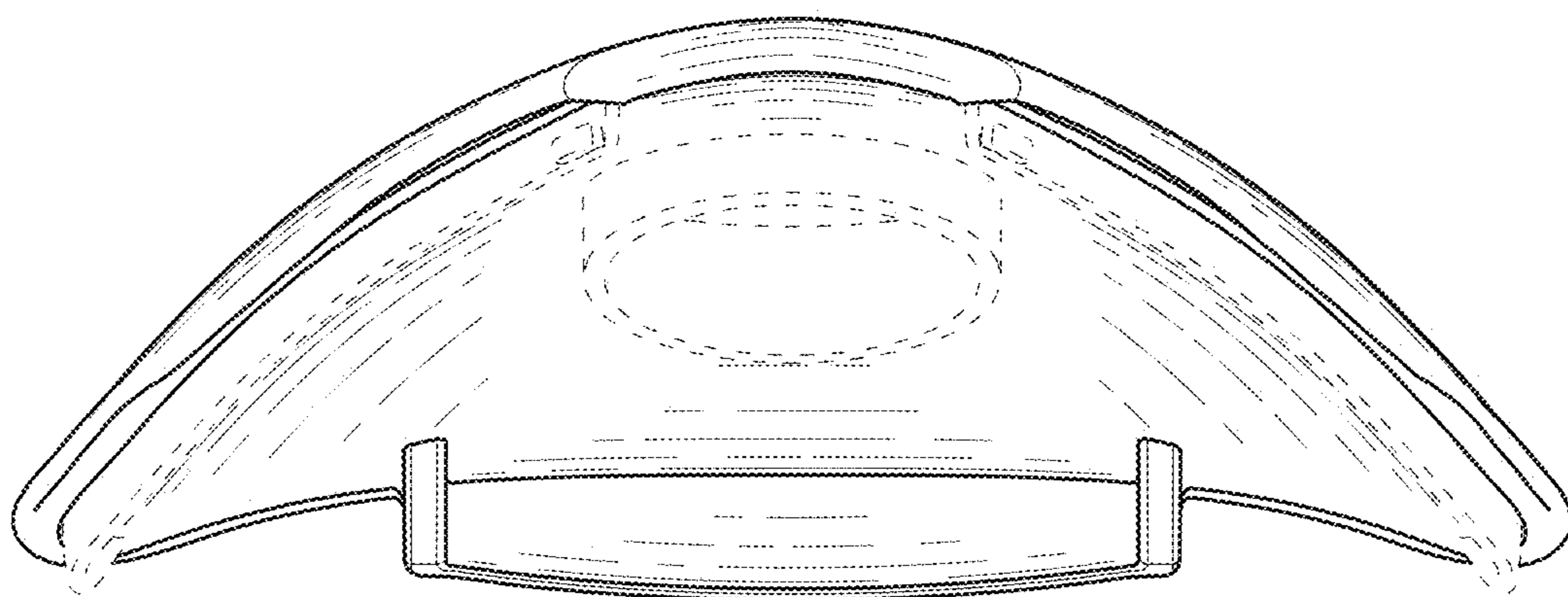

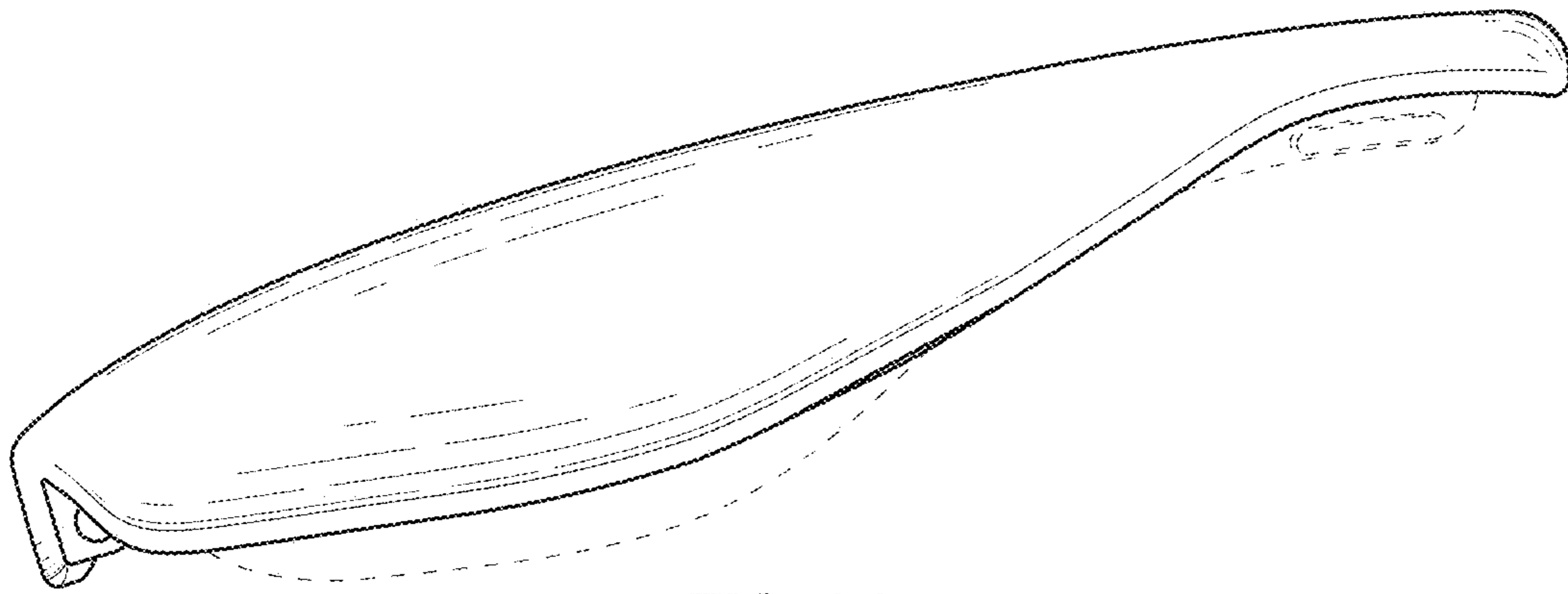

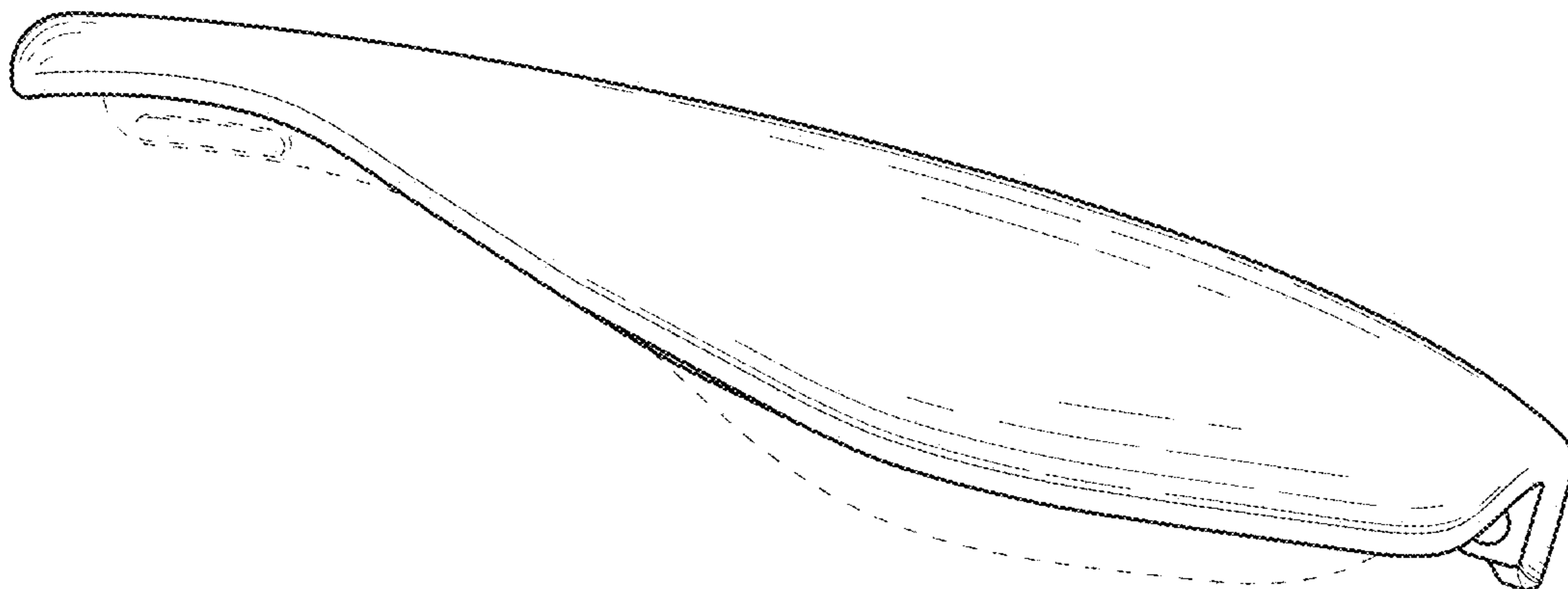
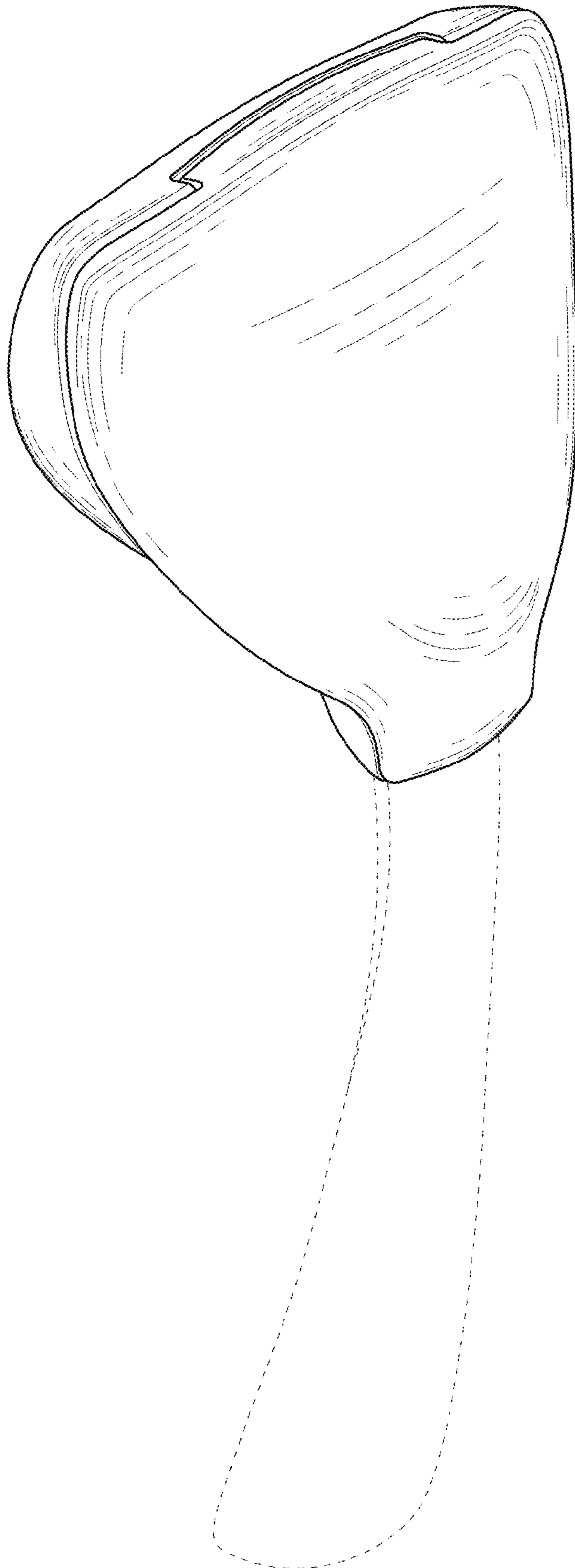
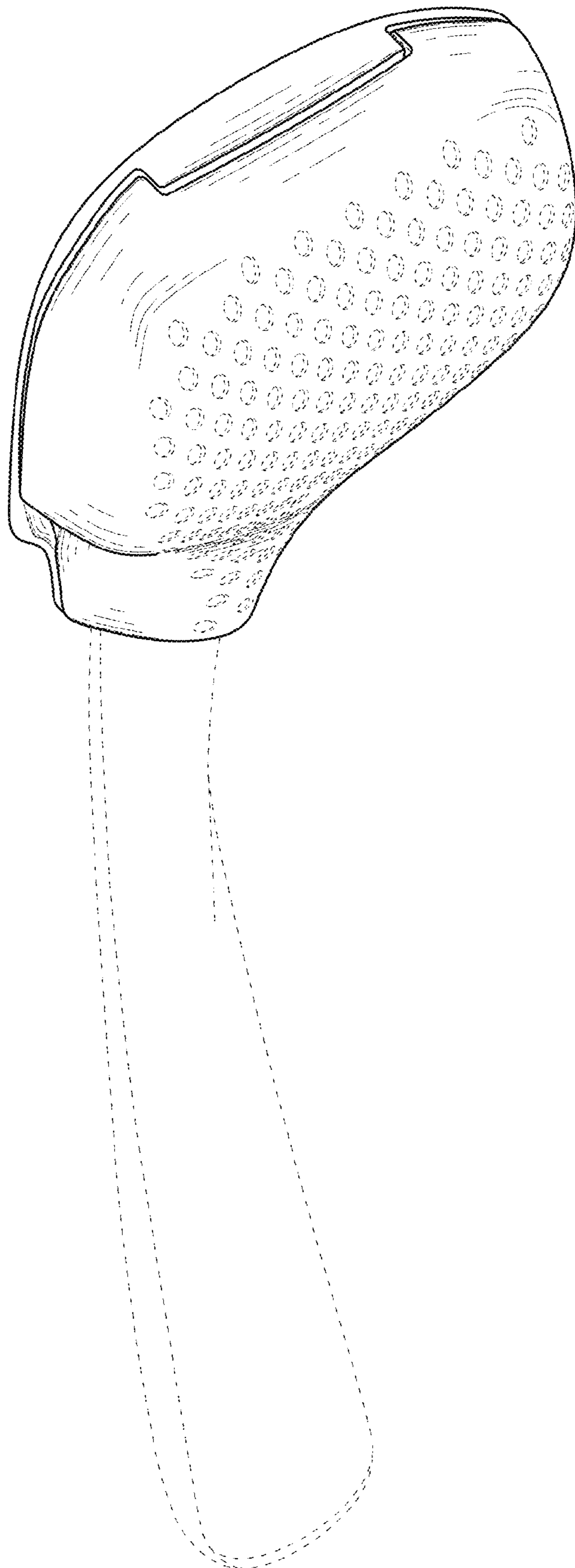

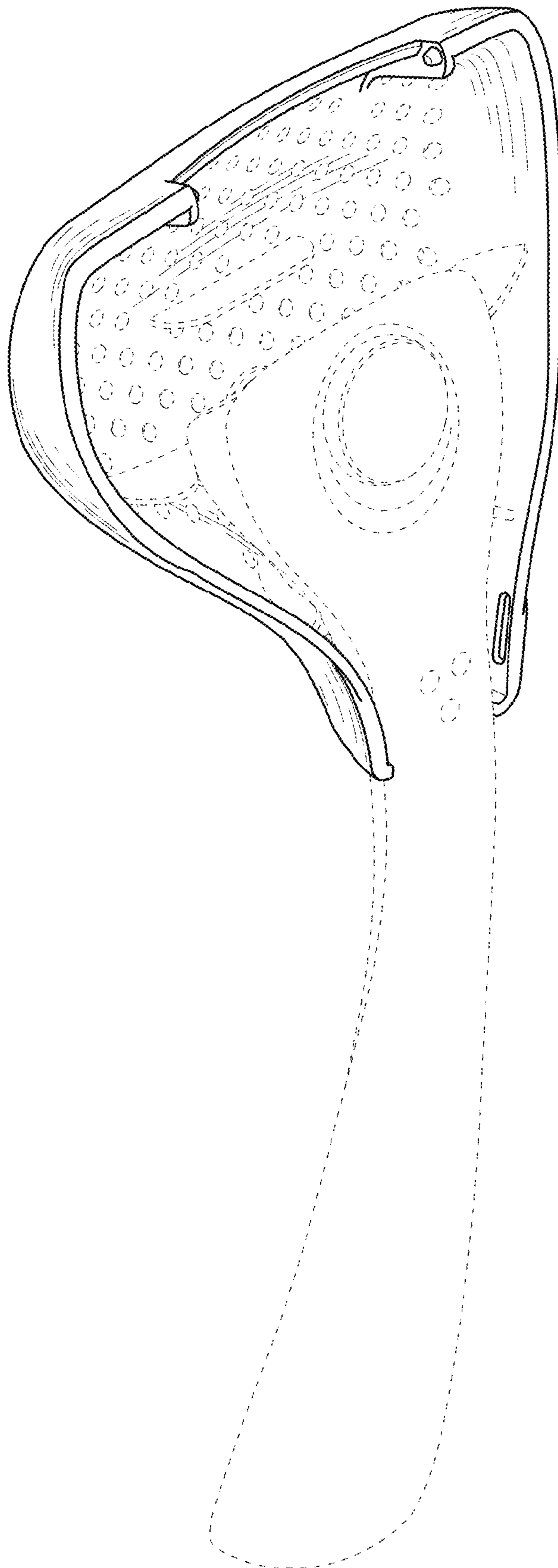

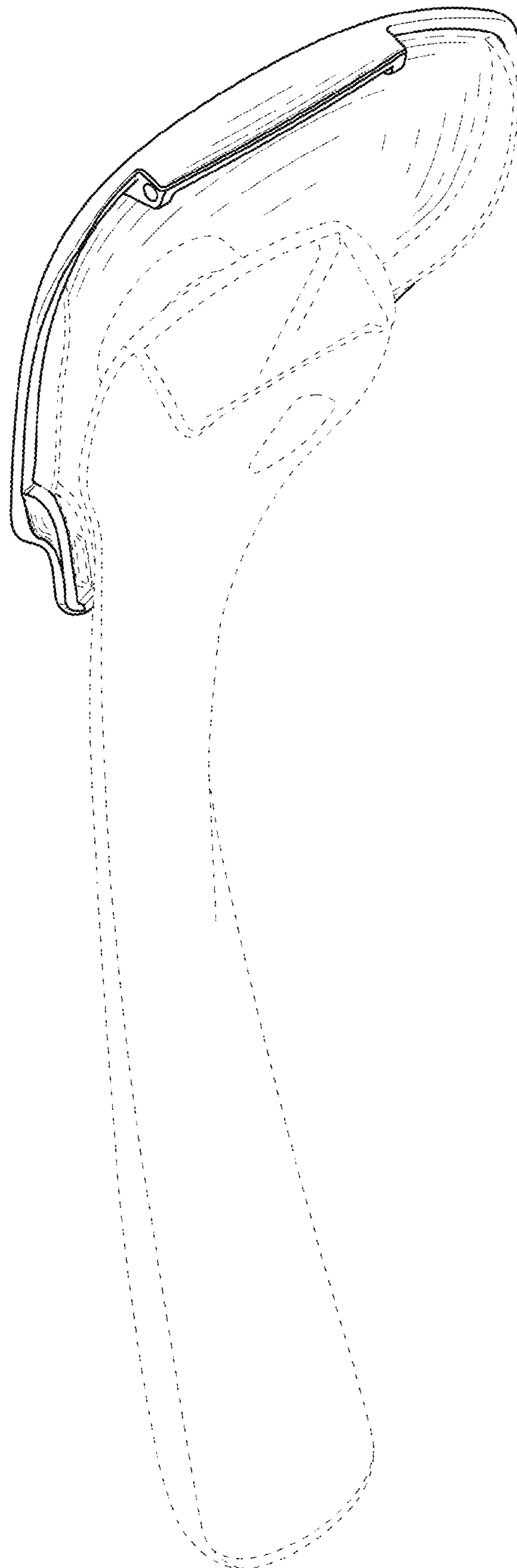
