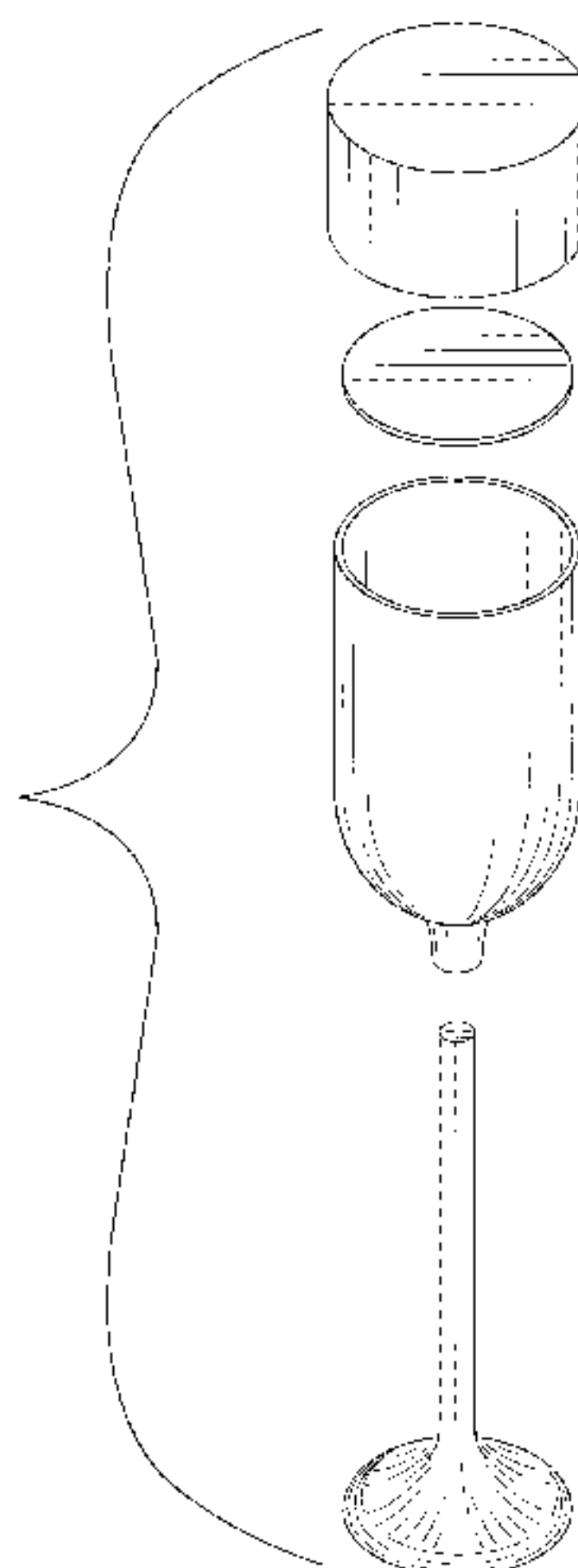
(57) **CLAIM**

The ornamental design for a lip balm container, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded top front perspective view of a lip balm container showing my new design;  
FIG. 2 is an exploded bottom front perspective view thereof;  
FIG. 3 is an enlarged, top front perspective view thereof;  
FIG. 4 is an enlarged, bottom front perspective view thereof;  
FIG. 5 is an enlarged, top view thereof;

FIG. 8 is an enlarged, back view thereof;

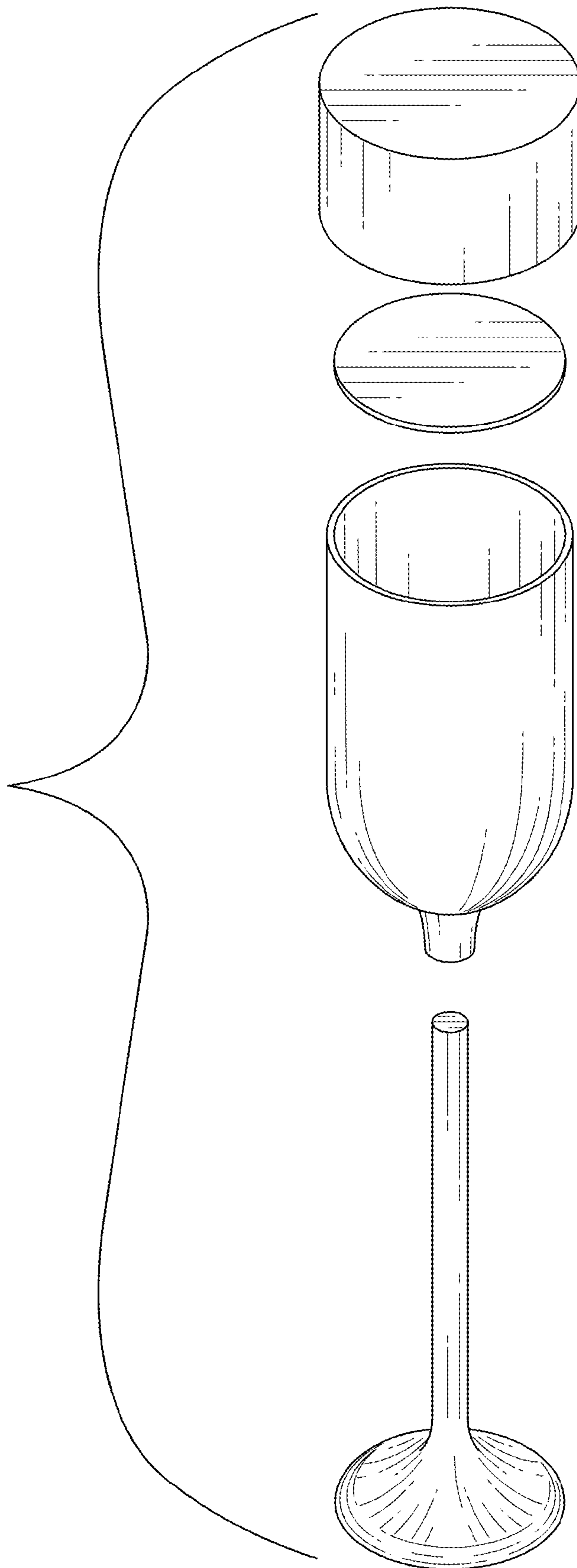

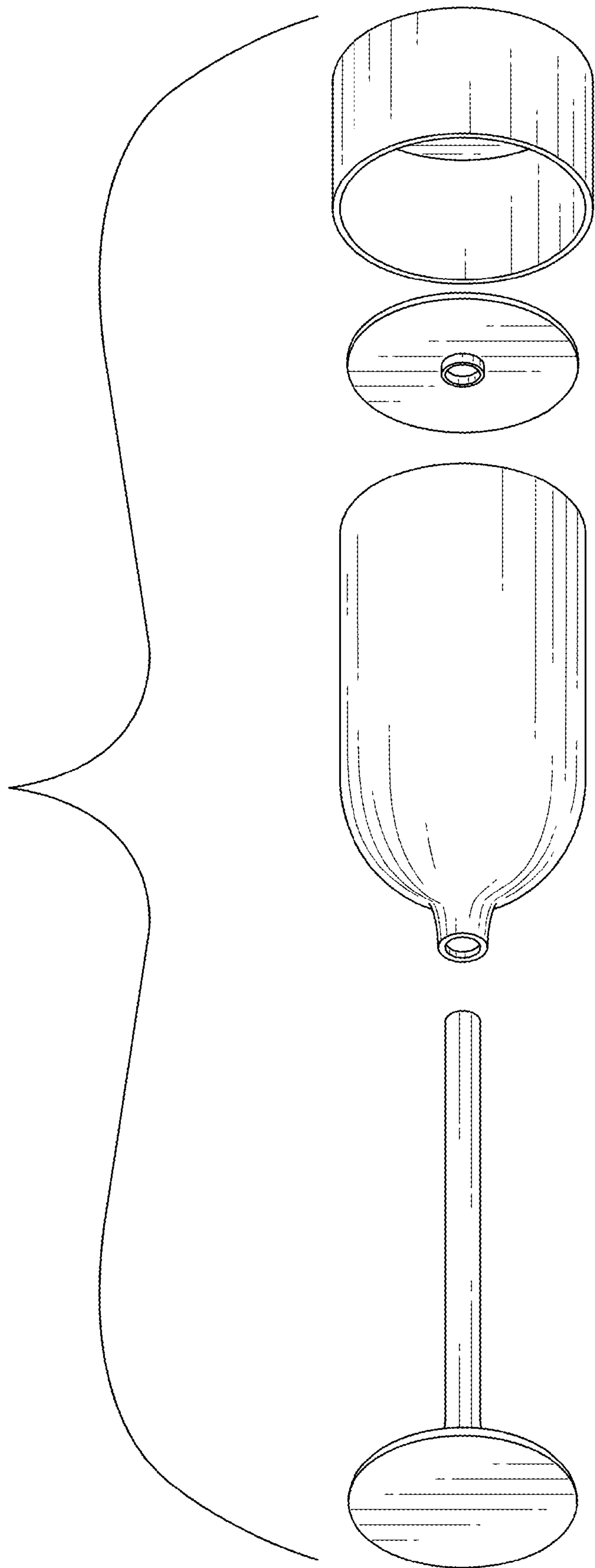

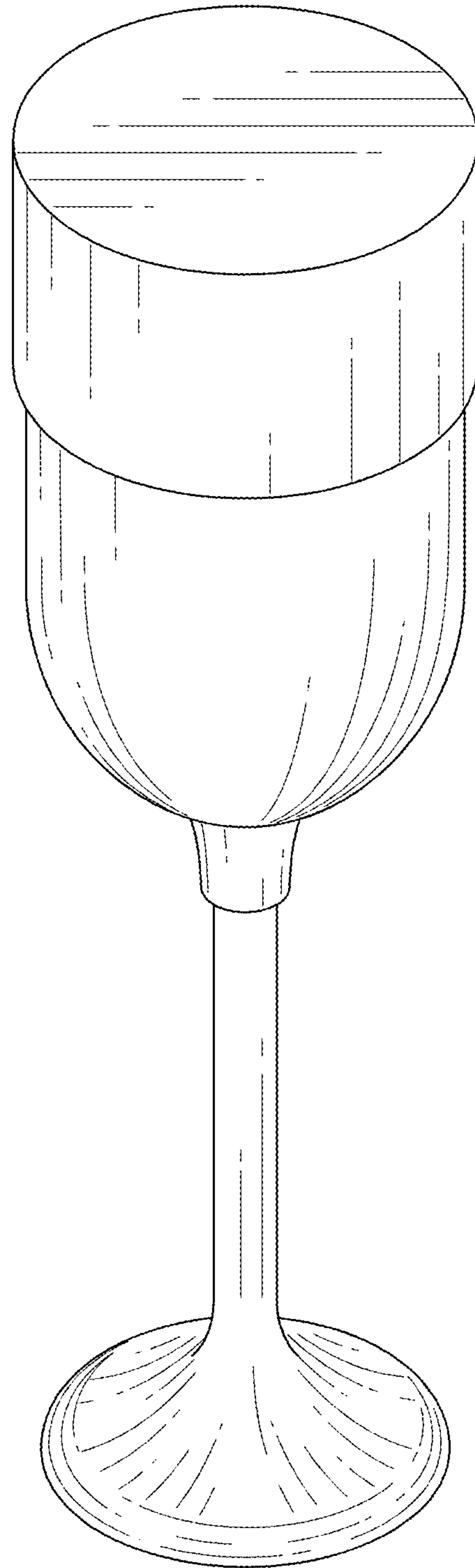

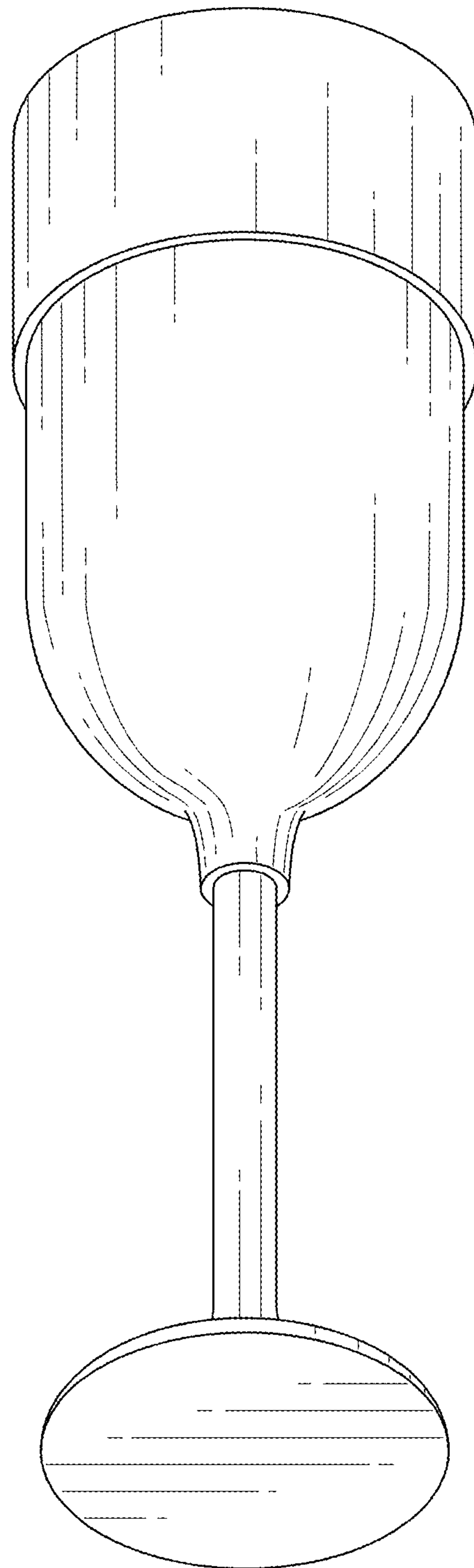

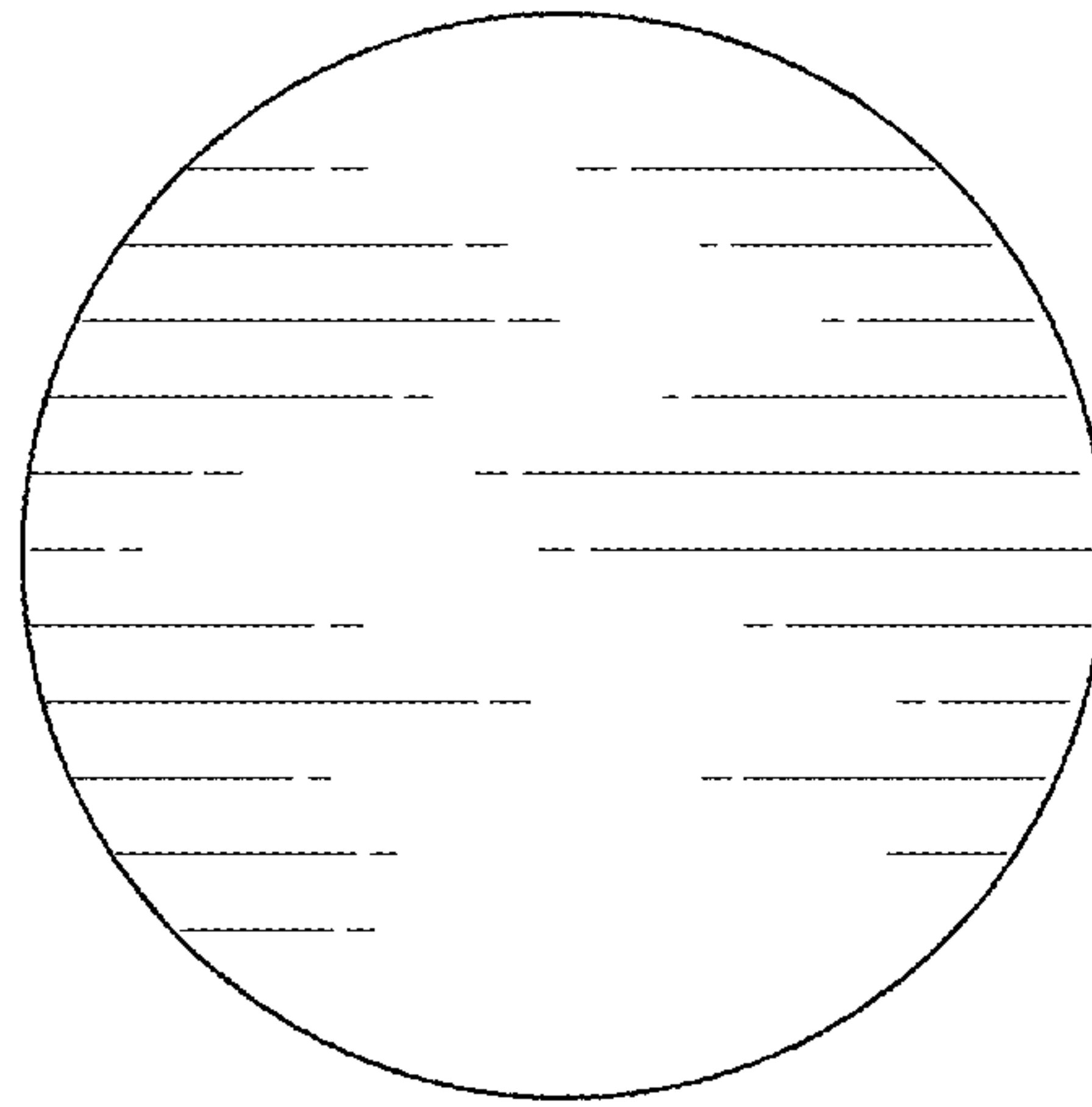

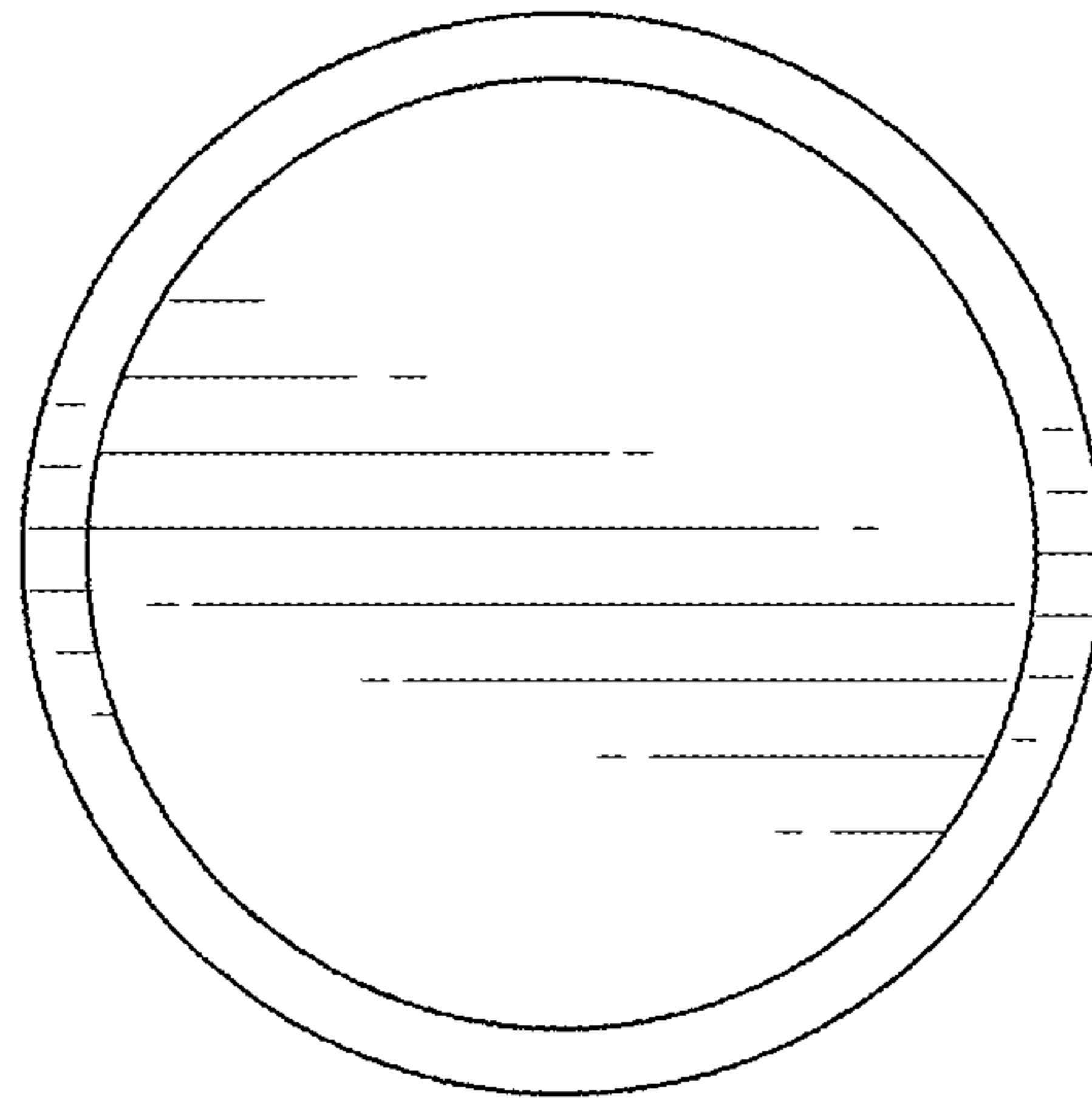

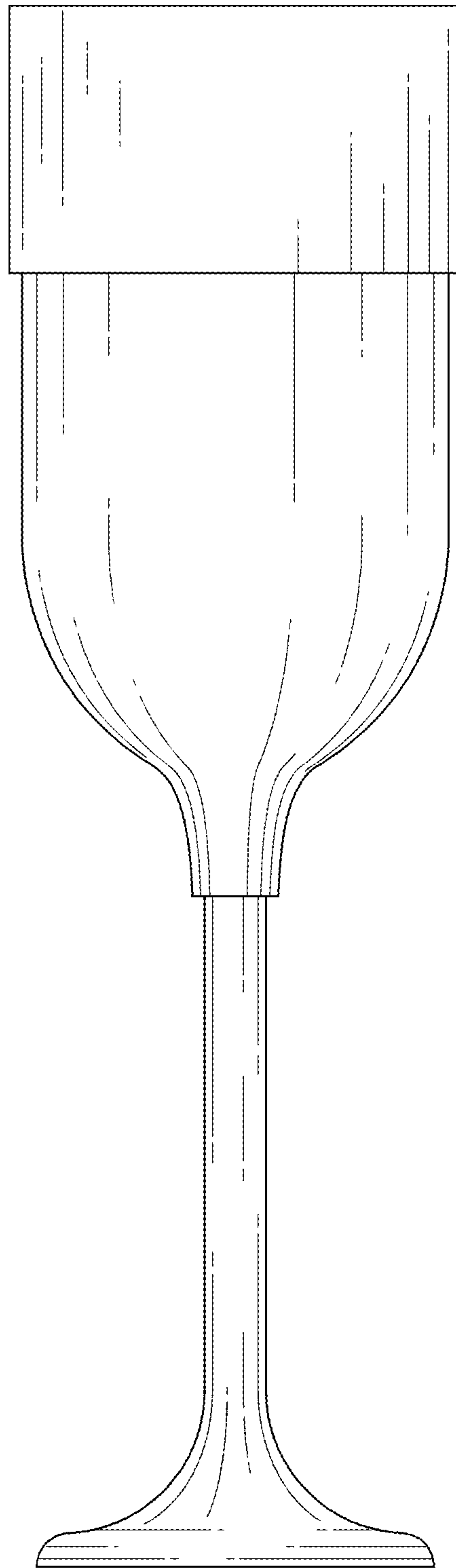

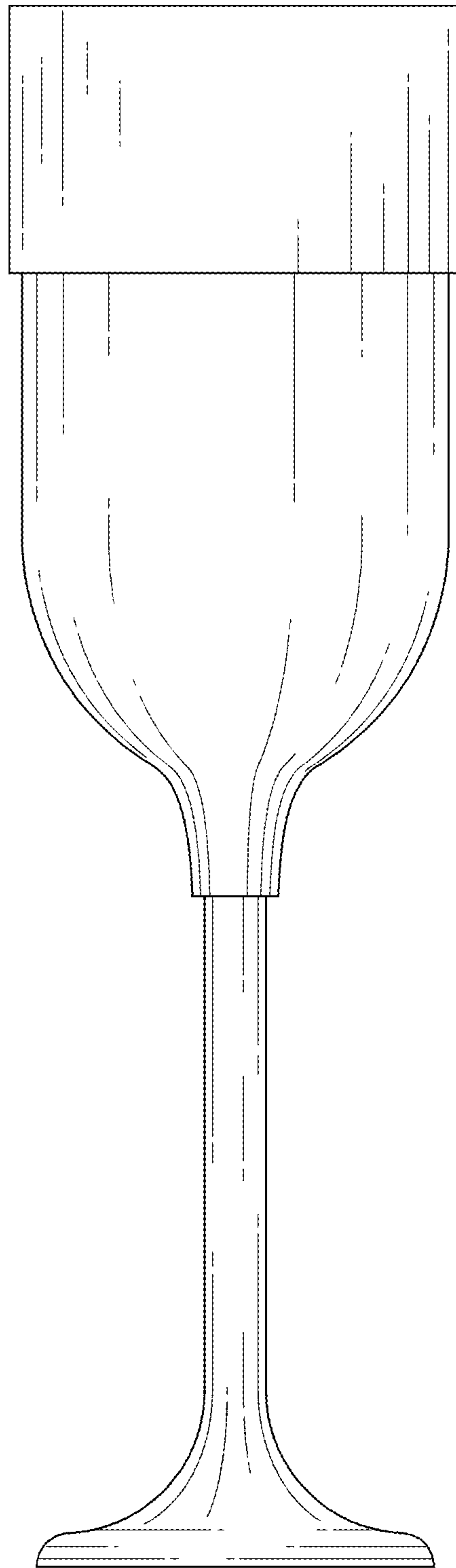

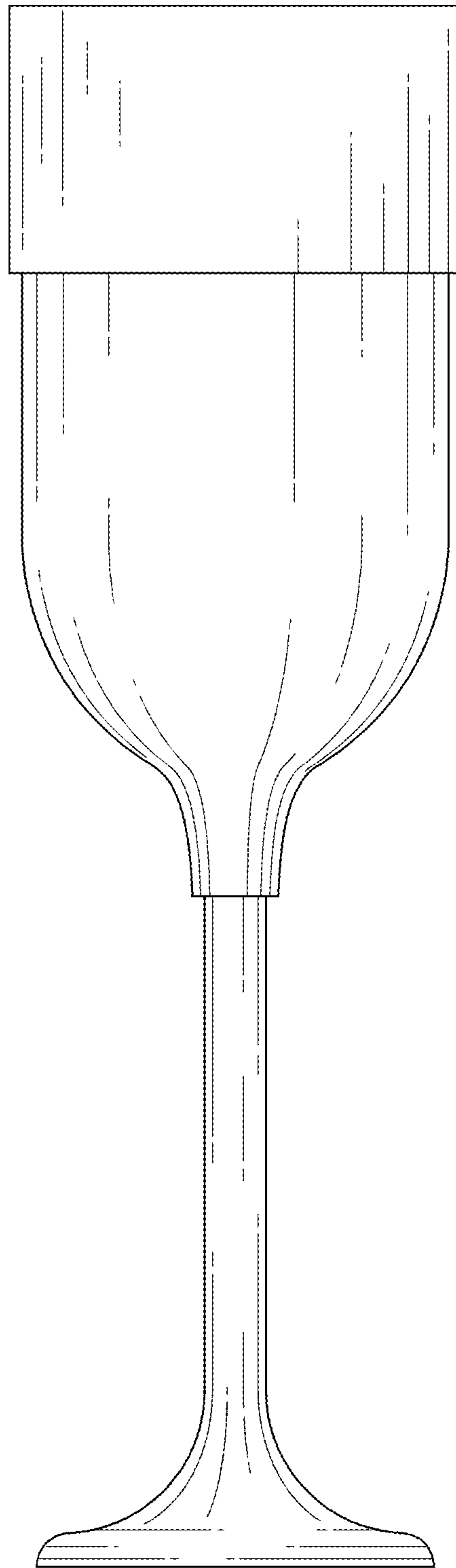

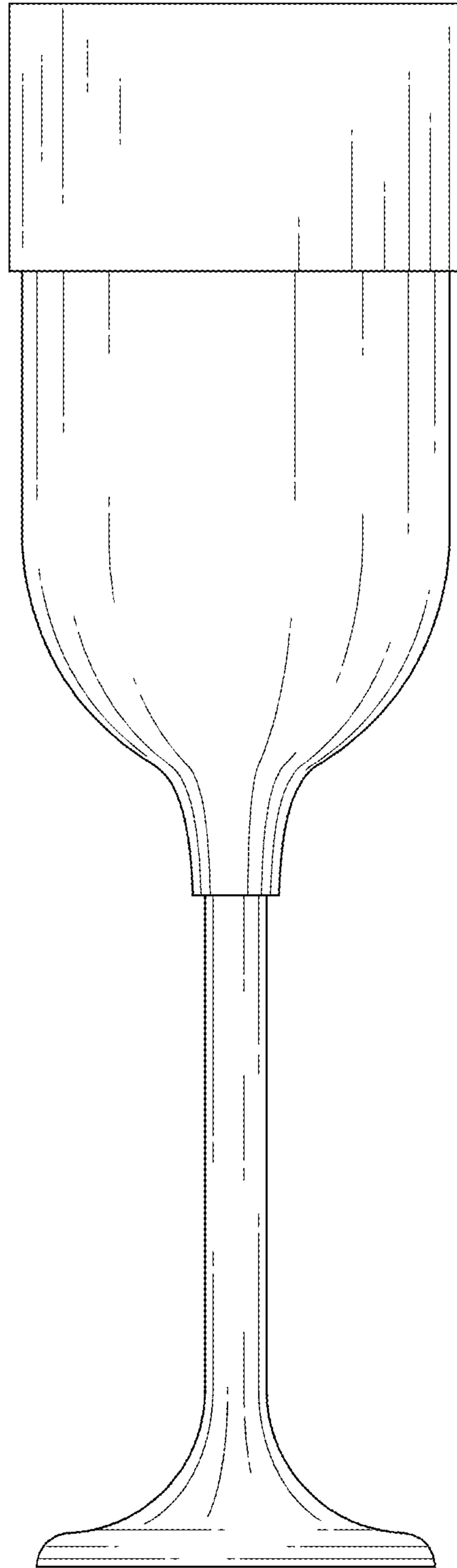

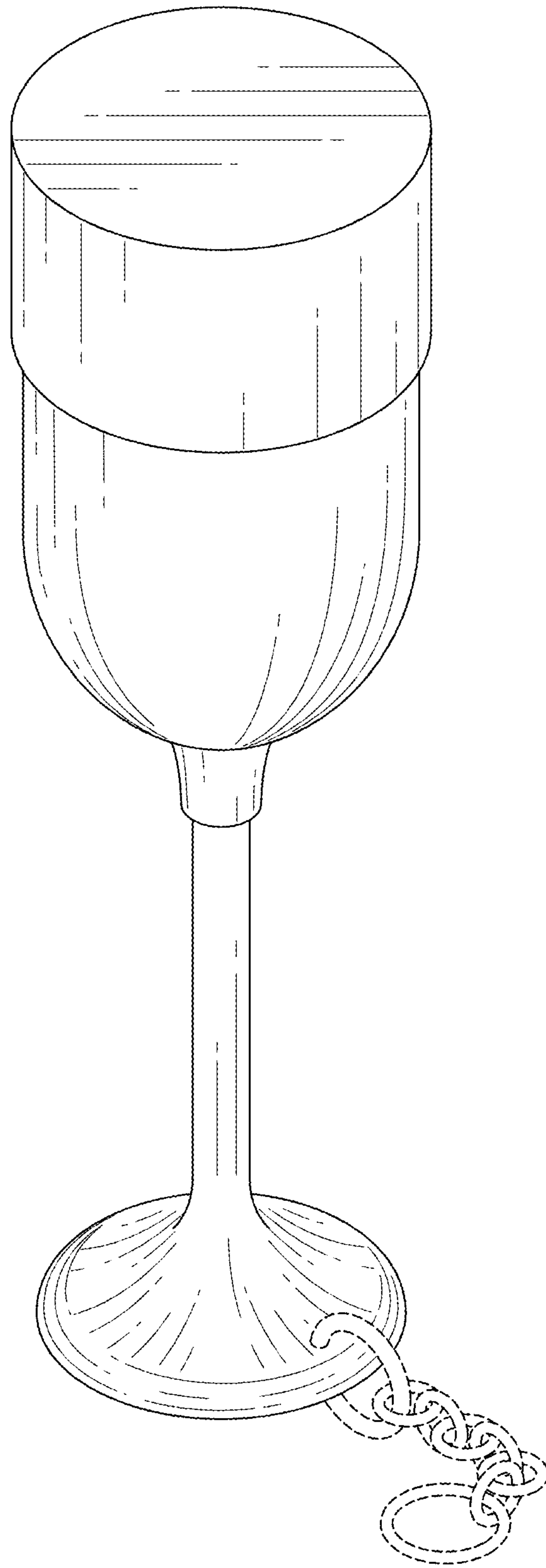
