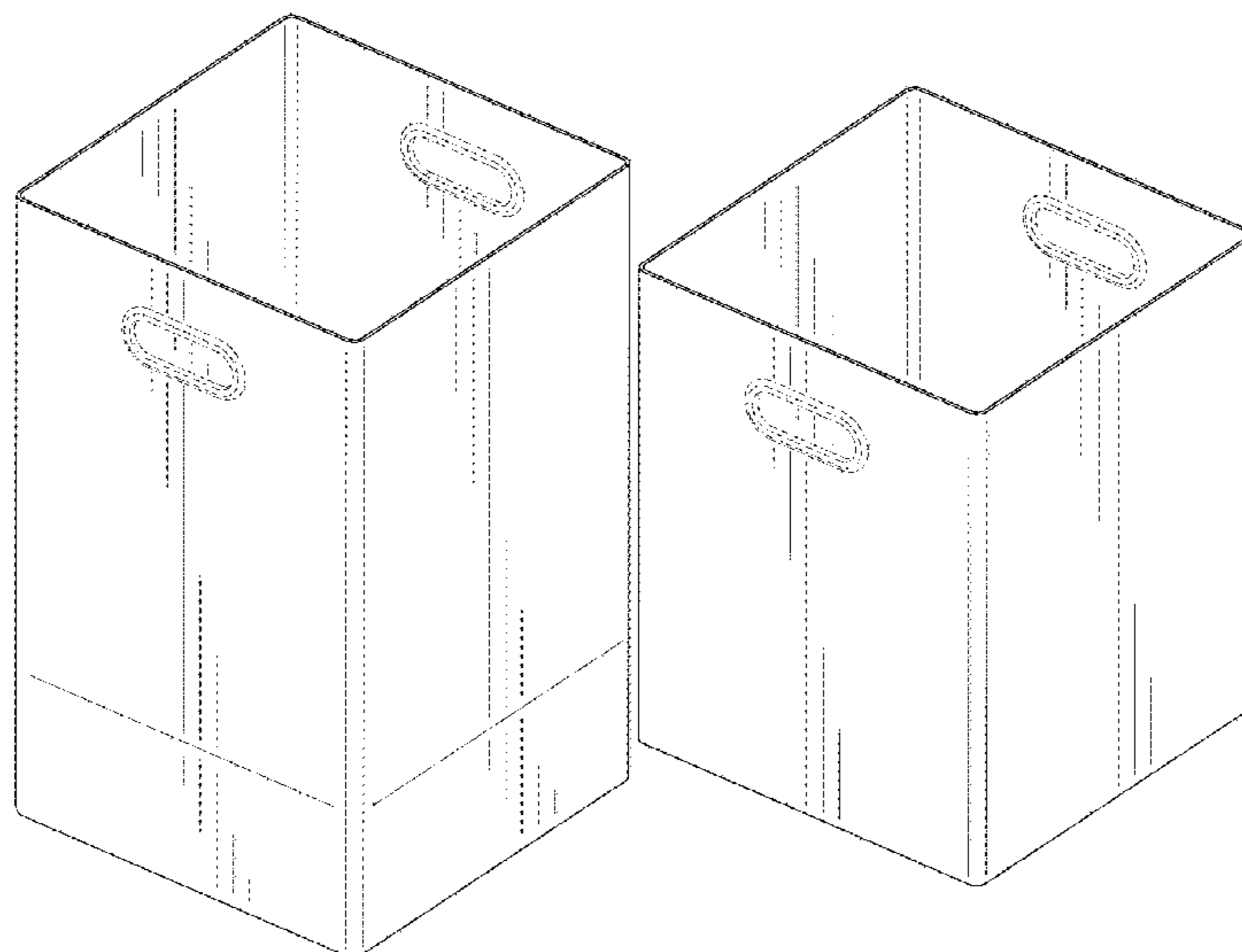
(57) **CLAIM**

The ornamental design for a foldable hamper, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a perspective view of a foldable hamper showing  
my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof;  
FIG. 8 is a perspective view of a side wall of the foldable  
hamper;  
FIG. 9 is another perspective view of the side wall of the  
foldable hamper, wherein a lower portion of the side wall is  
folded;  
FIG. 10 is a perspective view thereof with side walls of the  
foldable hamper being folded;  
FIG. 11 is a front view thereof with the side walls of the  
foldable hamper being folded;  
FIG. 12 is a rear view thereof with the side walls of the  
foldable hamper being folded;  
FIG. 13 is a left side view thereof with the side walls of the  
foldable hamper being folded;  
FIG. 14 is a right side view thereof with the side walls of the  
foldable hamper being folded;  
FIG. 15 is a top view thereof with two of the side walls of  
the foldable hamper being folded;  
FIG. 16 is another top view thereof with the side walls of the  
foldable hamper being folded; and,  
FIG. 17 is a perspective view thereof with the side walls of  
the foldable hamper being folded and flattened.  
The broken lines in FIGS. 1-7 and 10-17 depict portions of  
the foldable hamper that form no part of the claimed design.

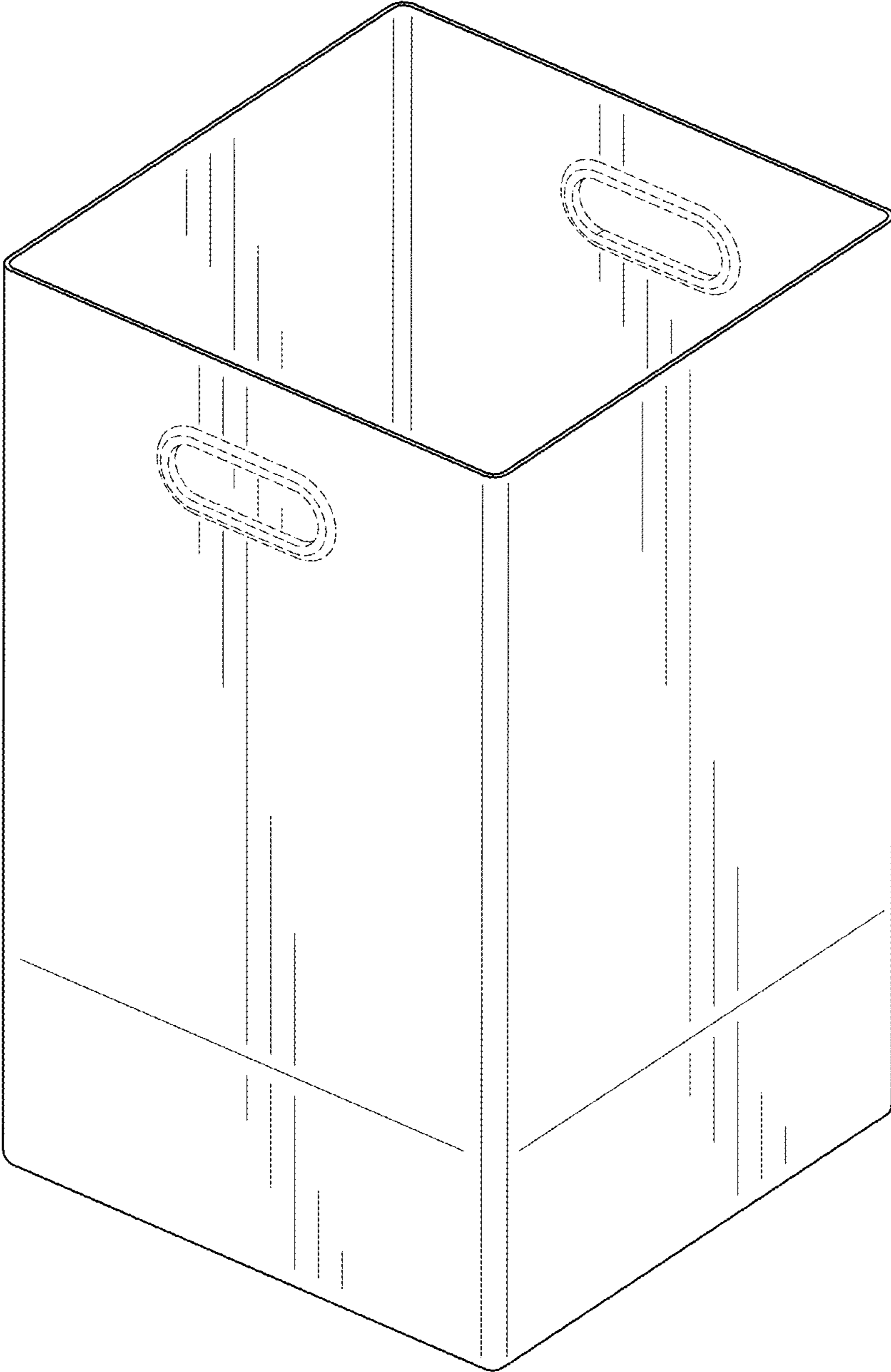

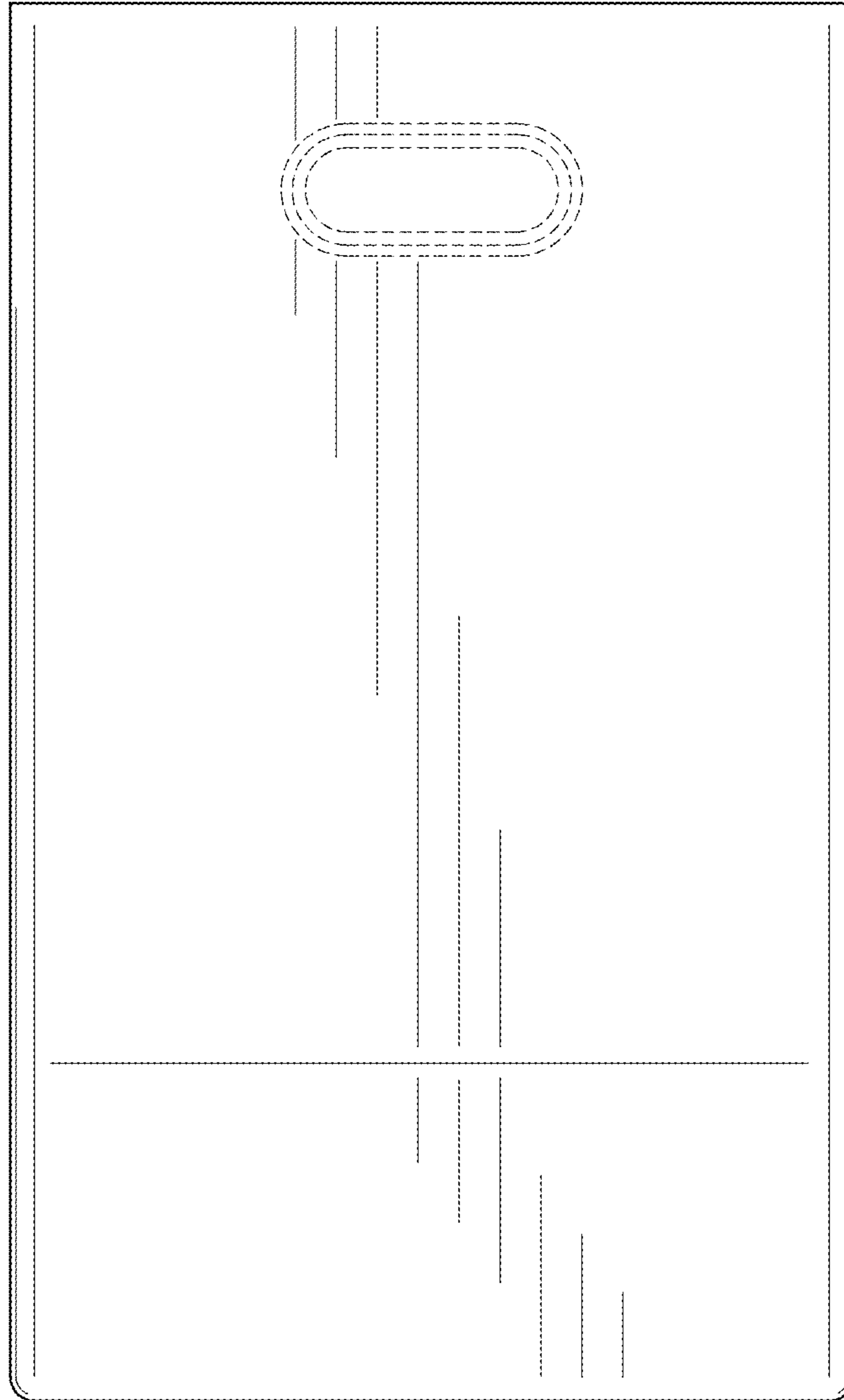

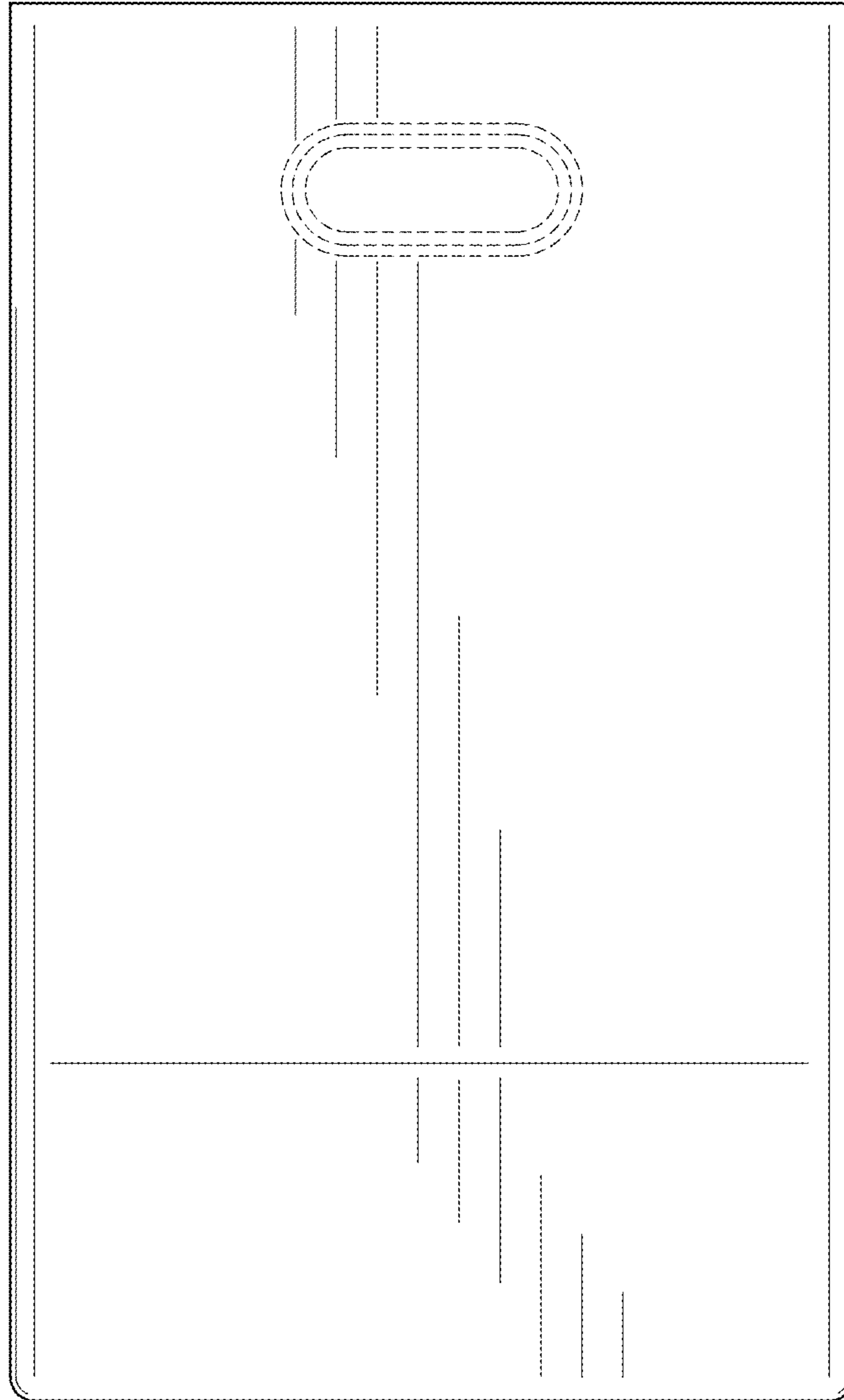

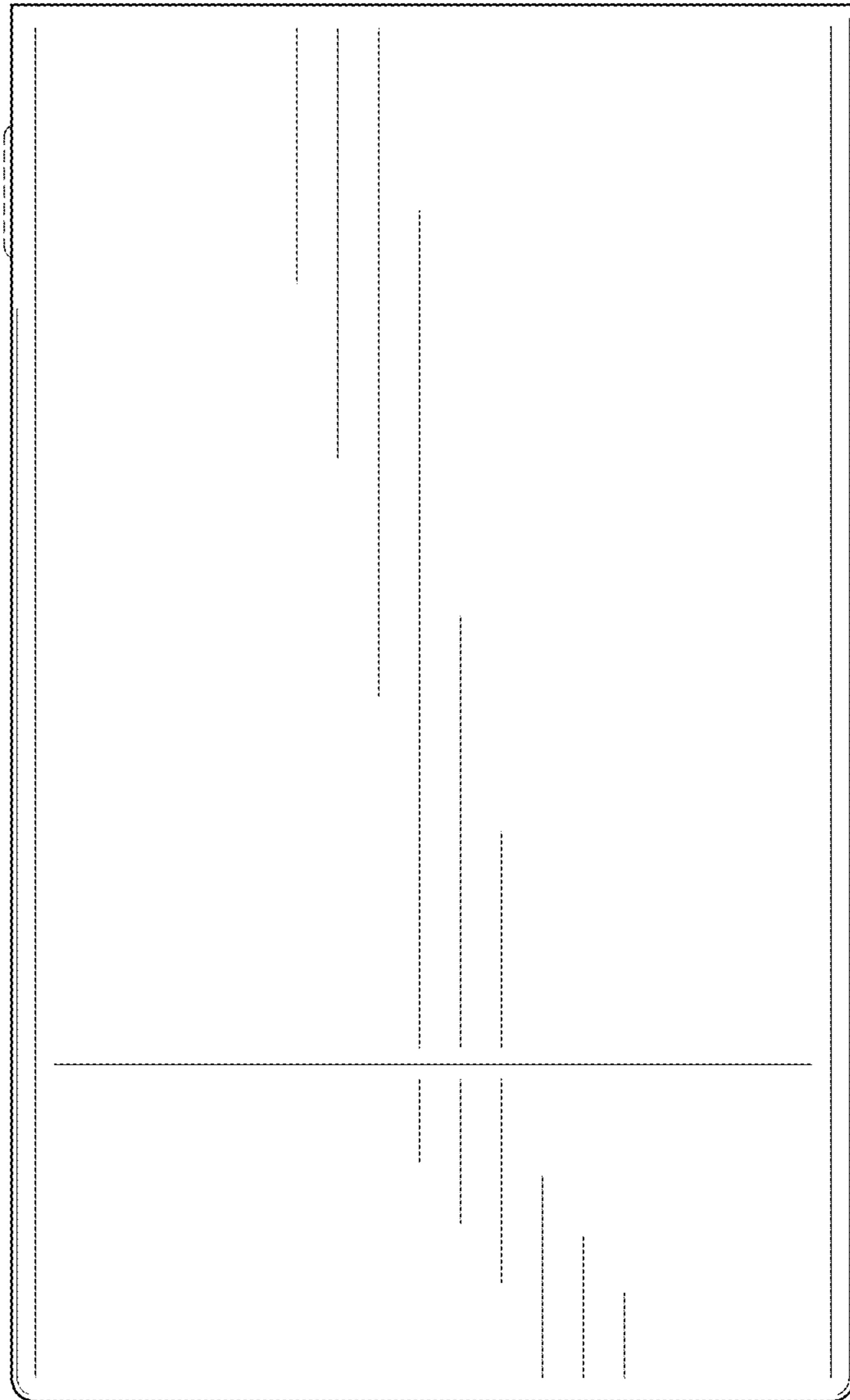

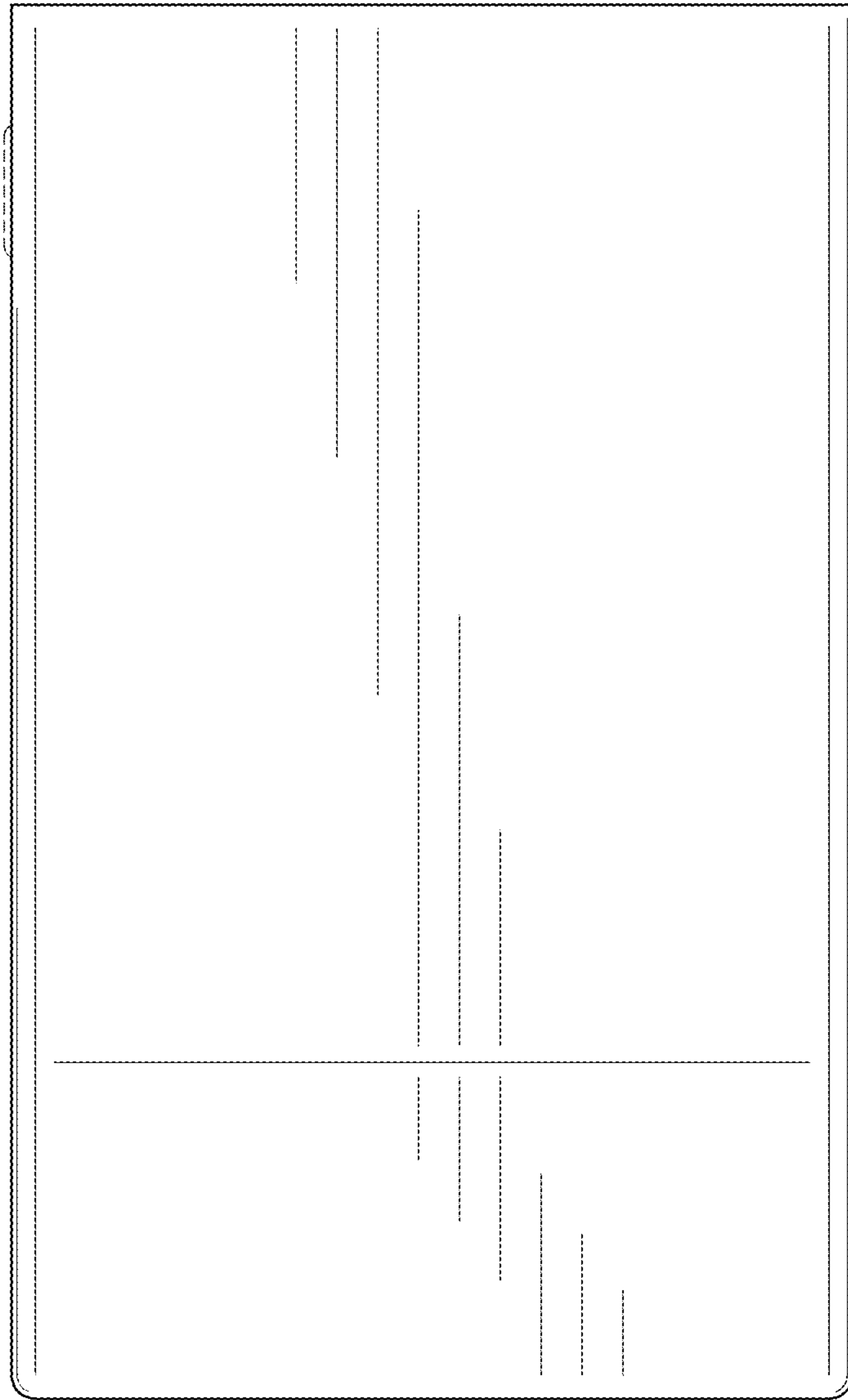

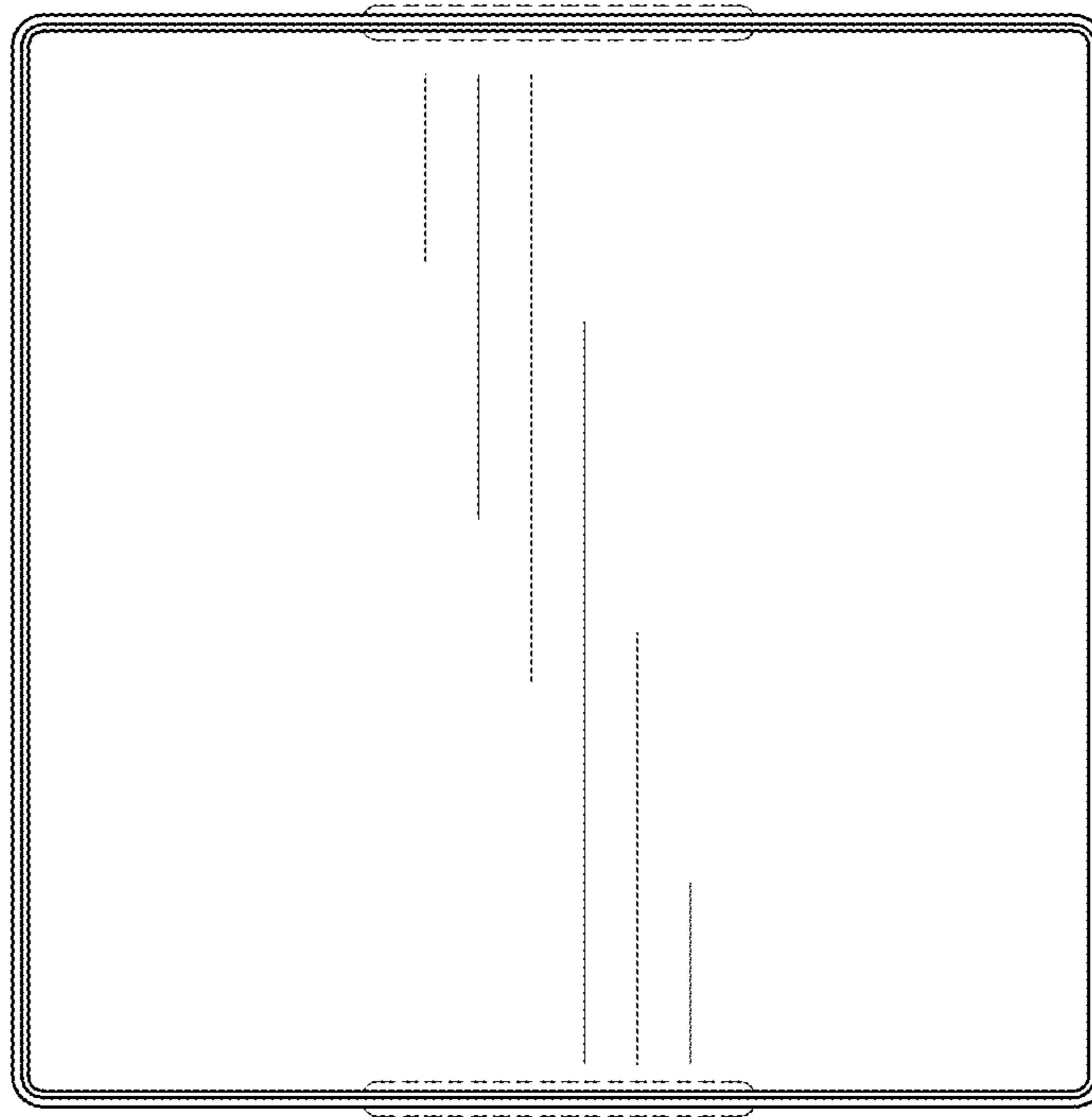

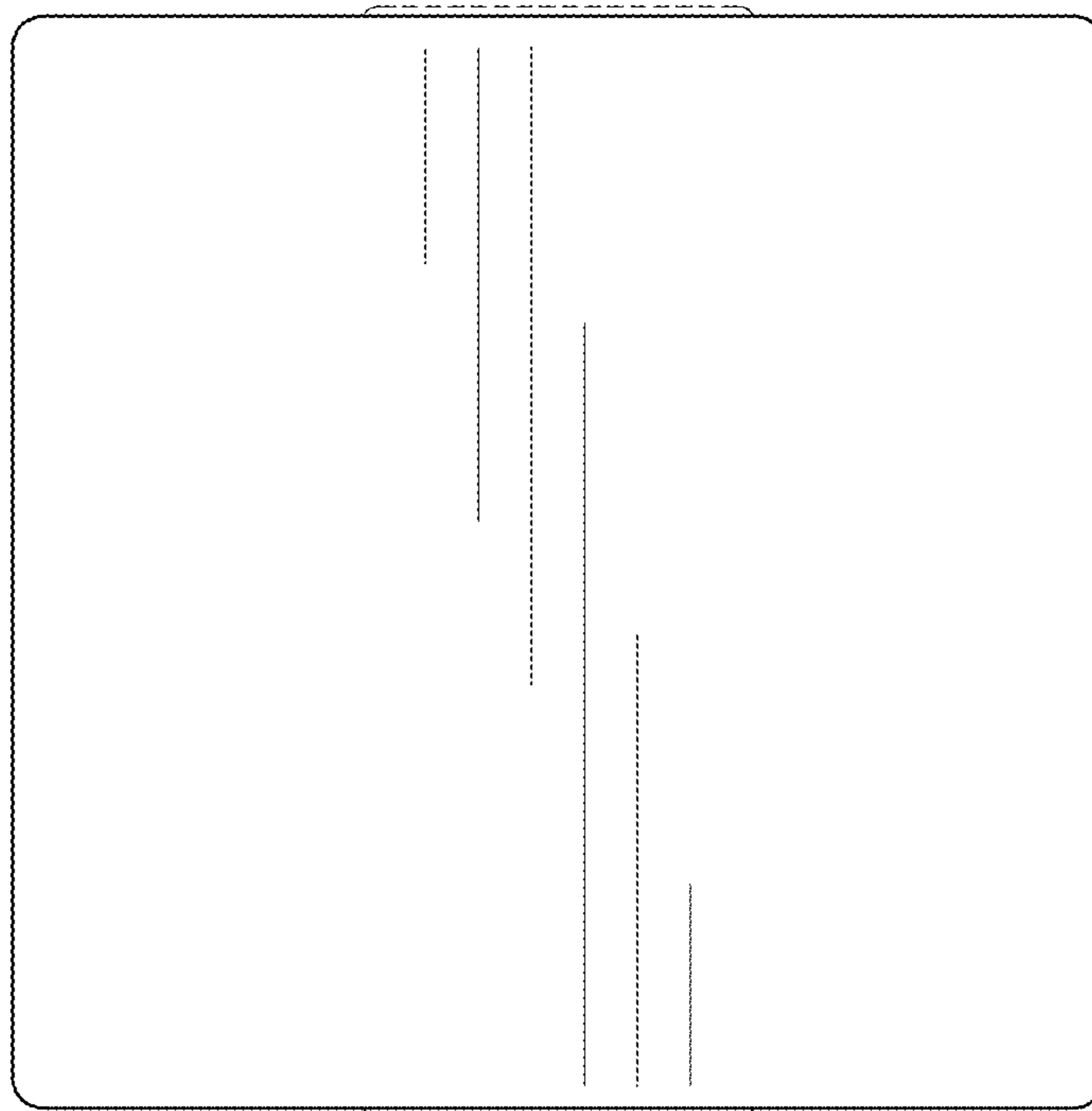

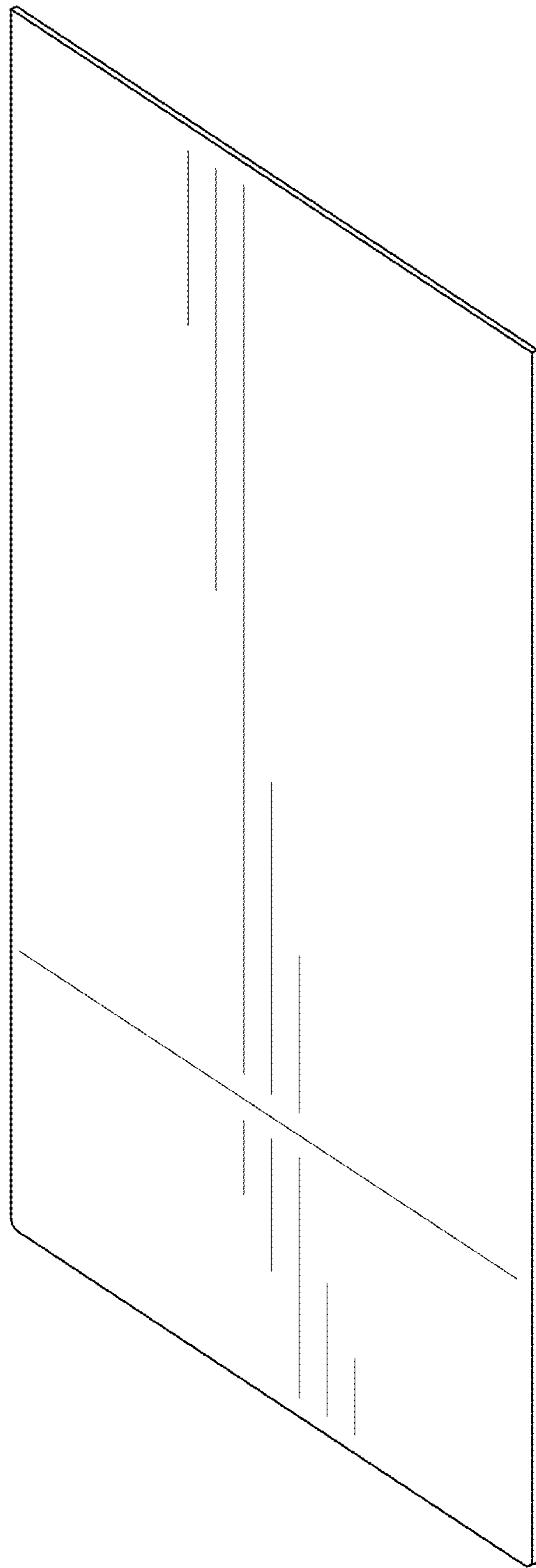

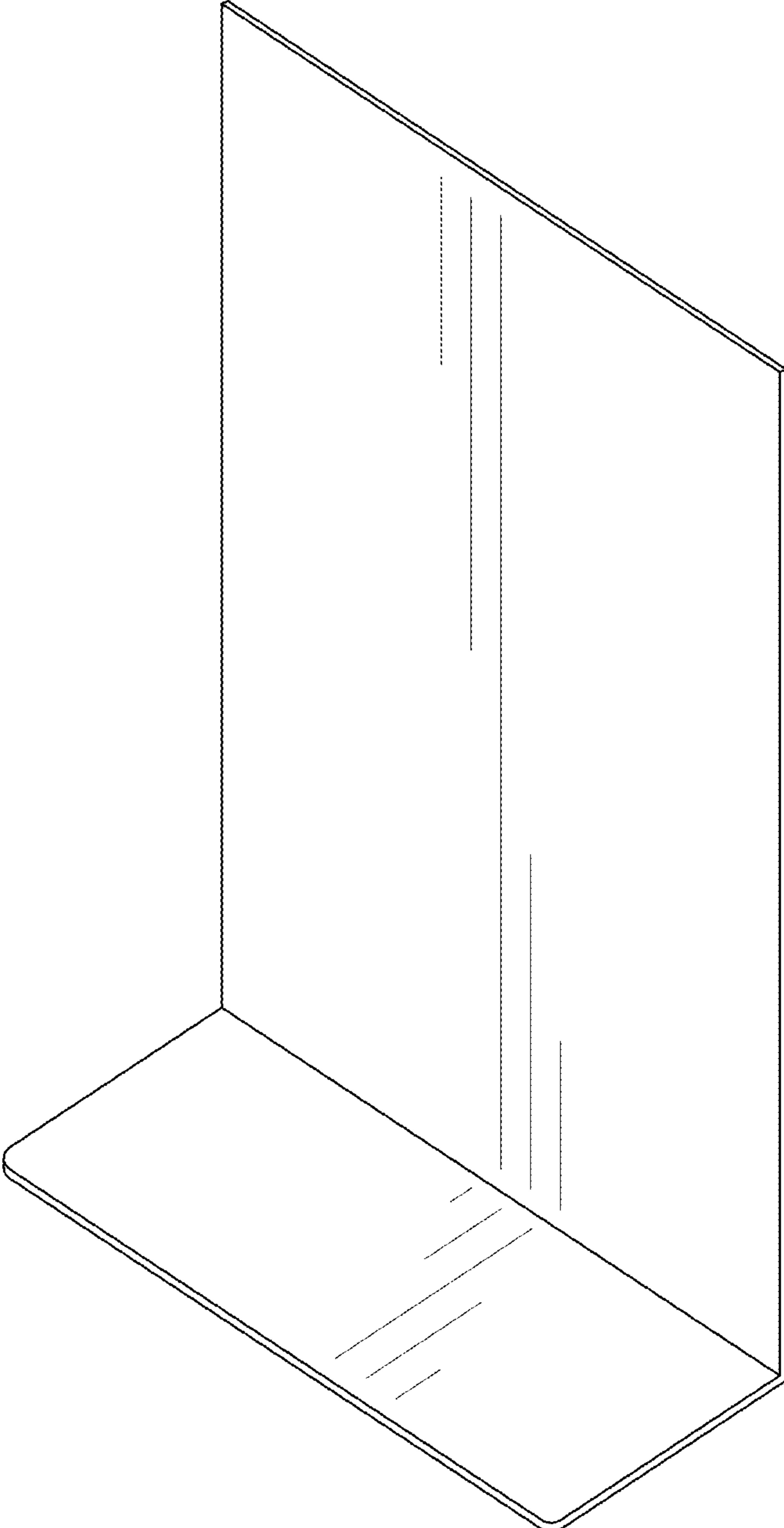

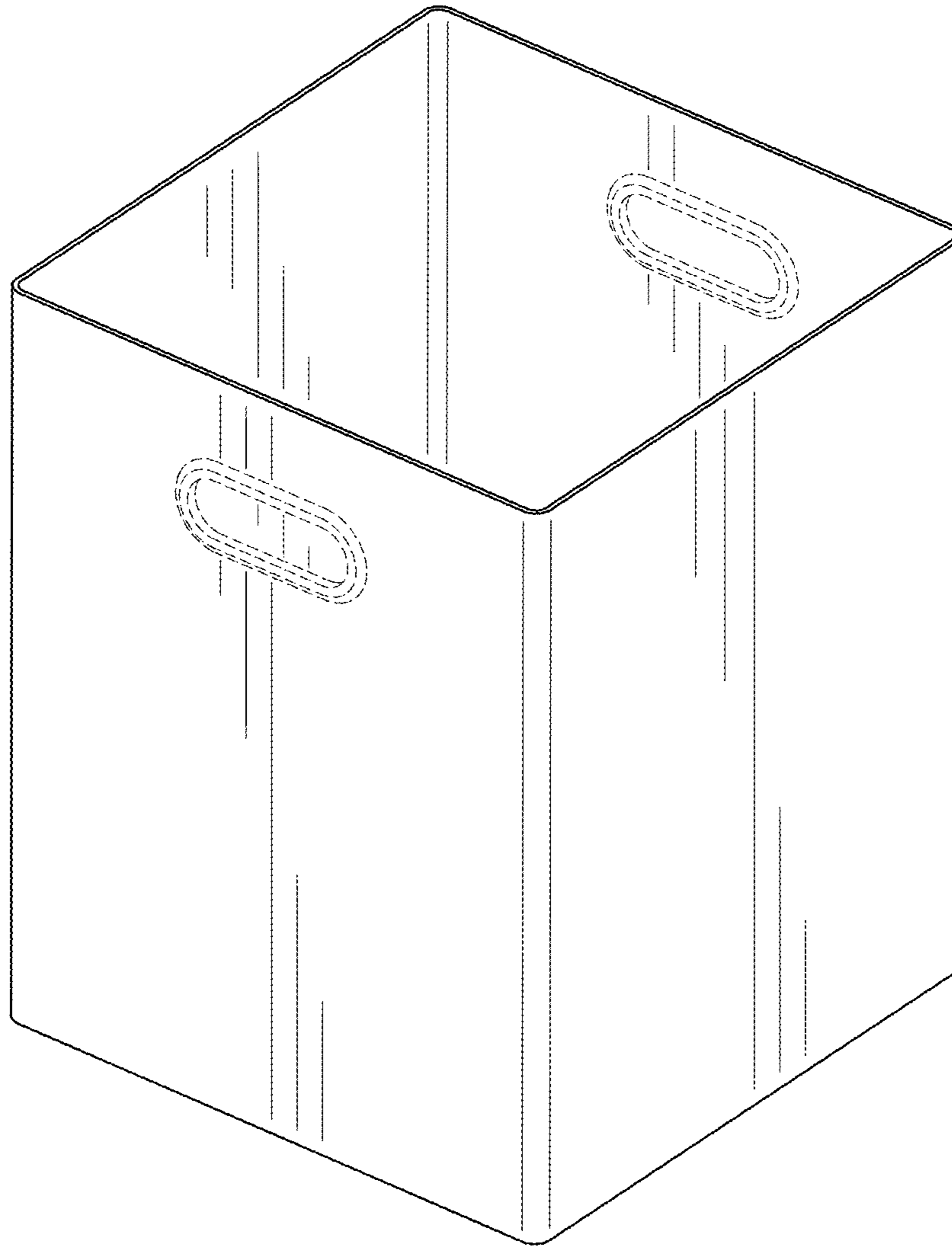

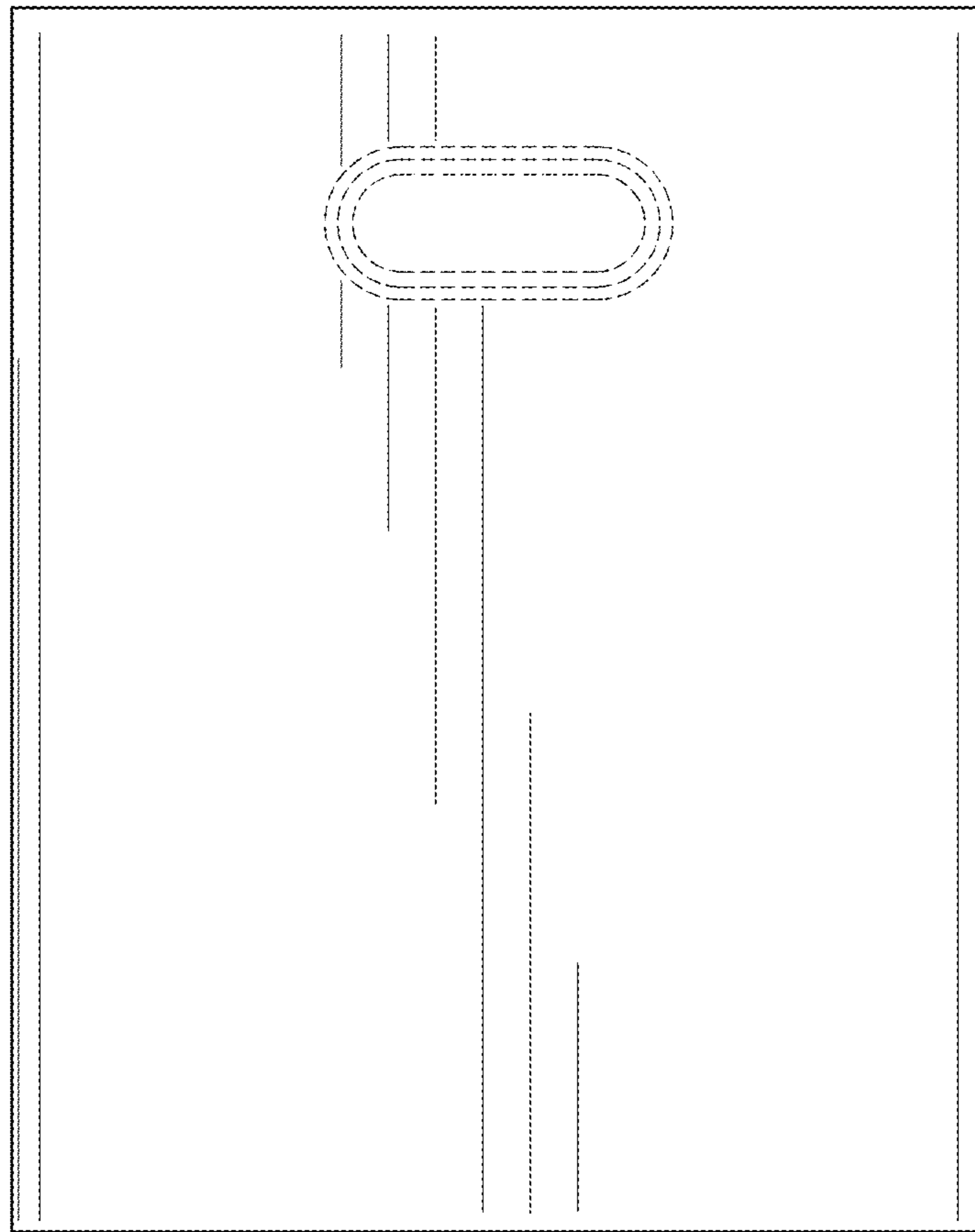

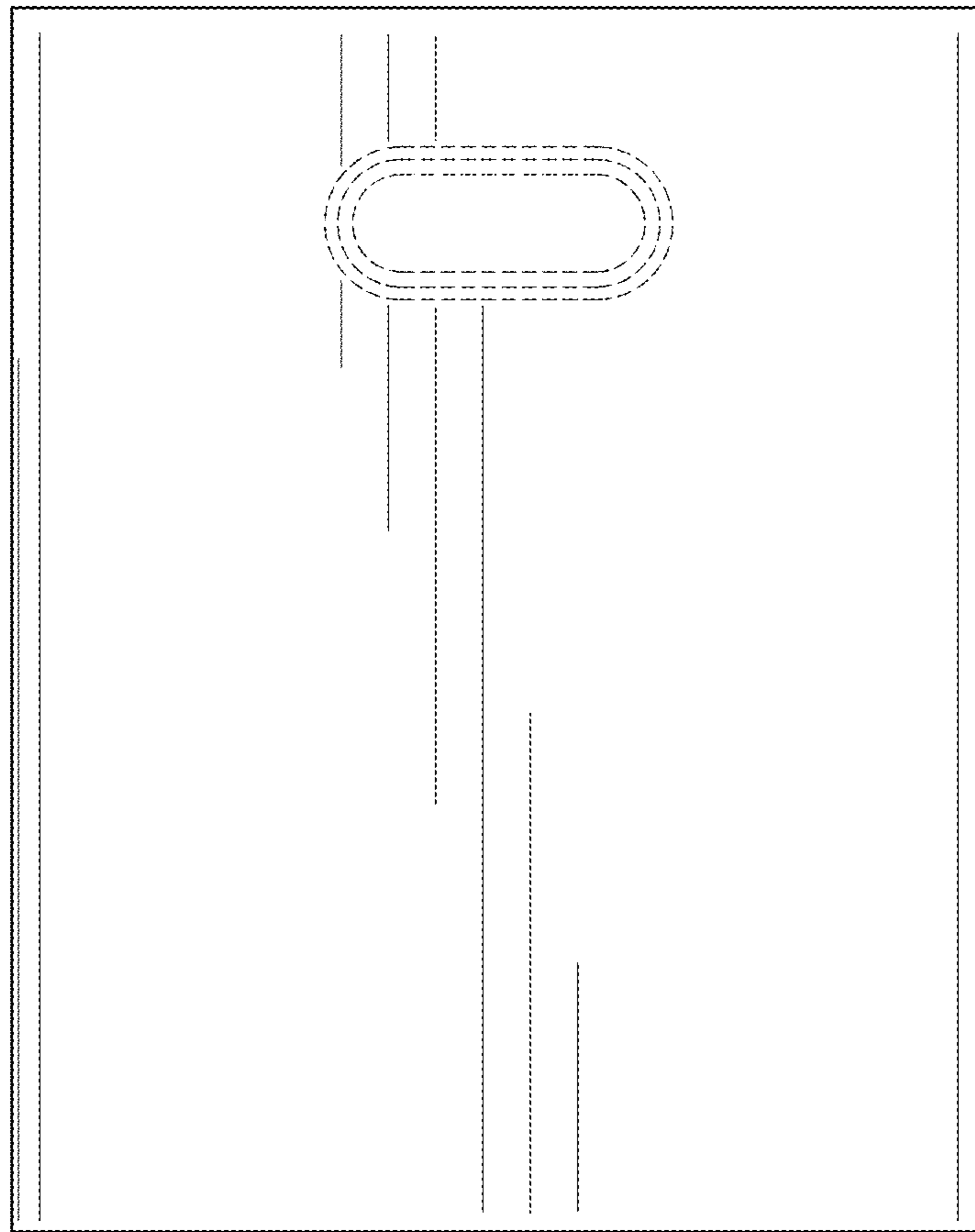

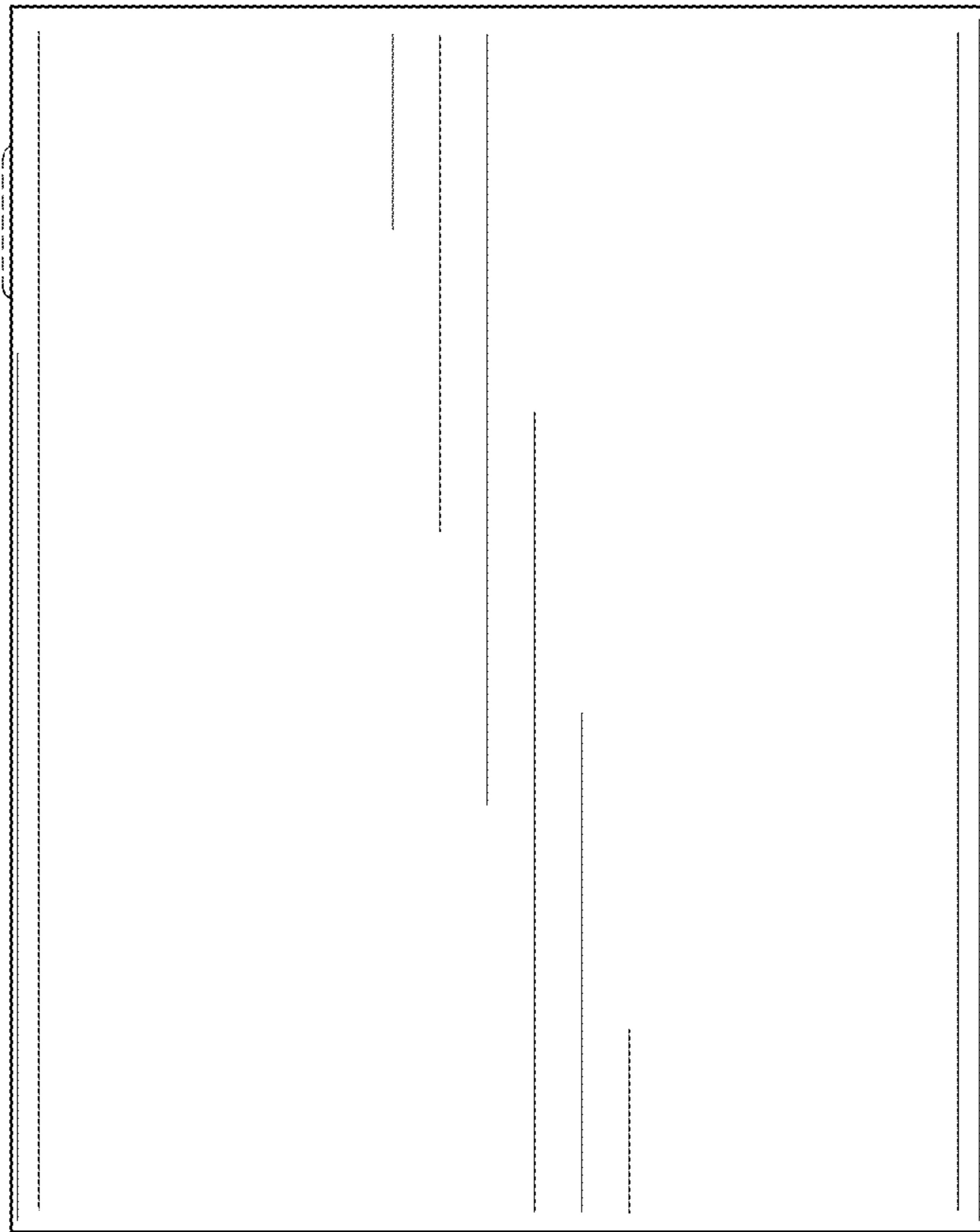

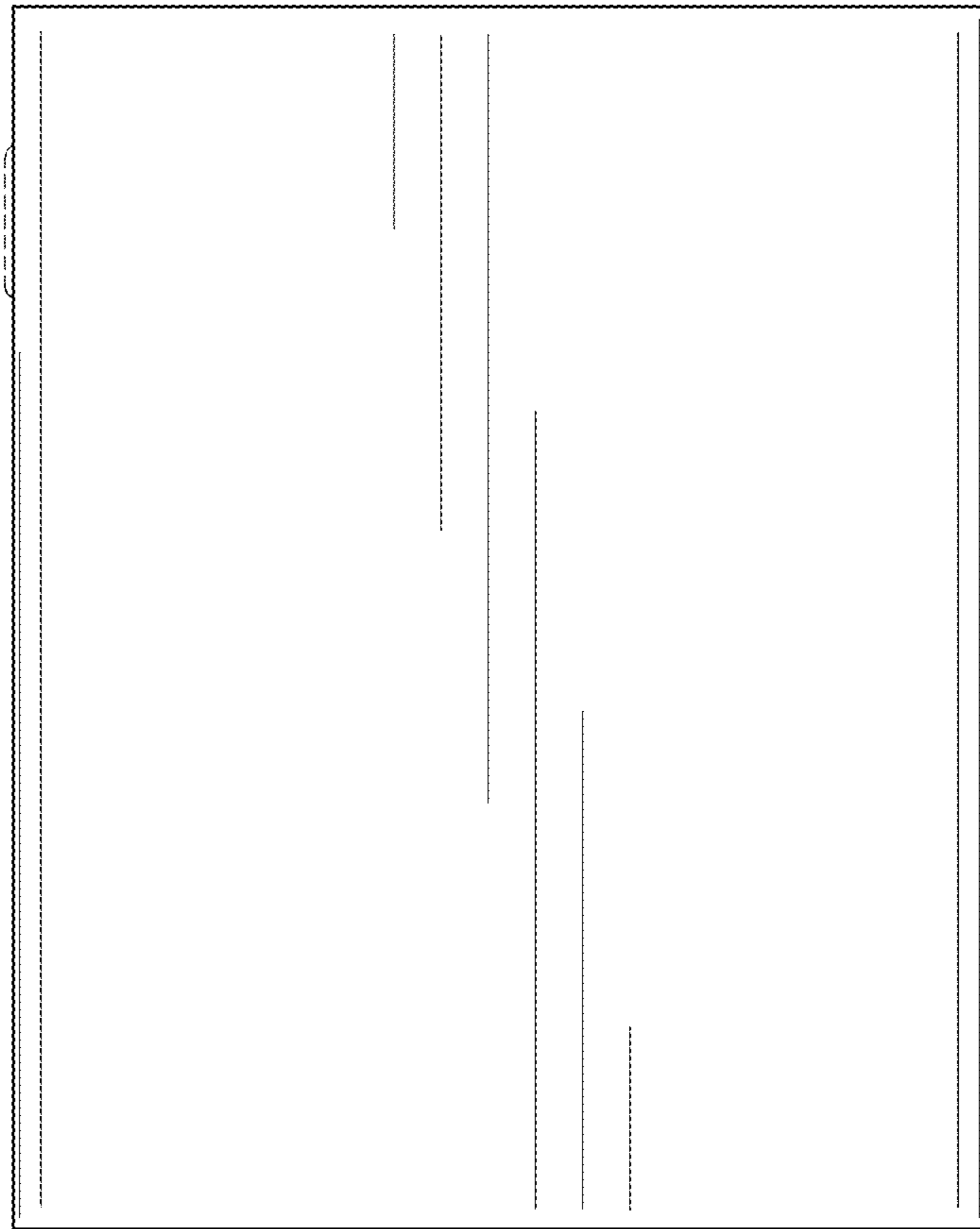

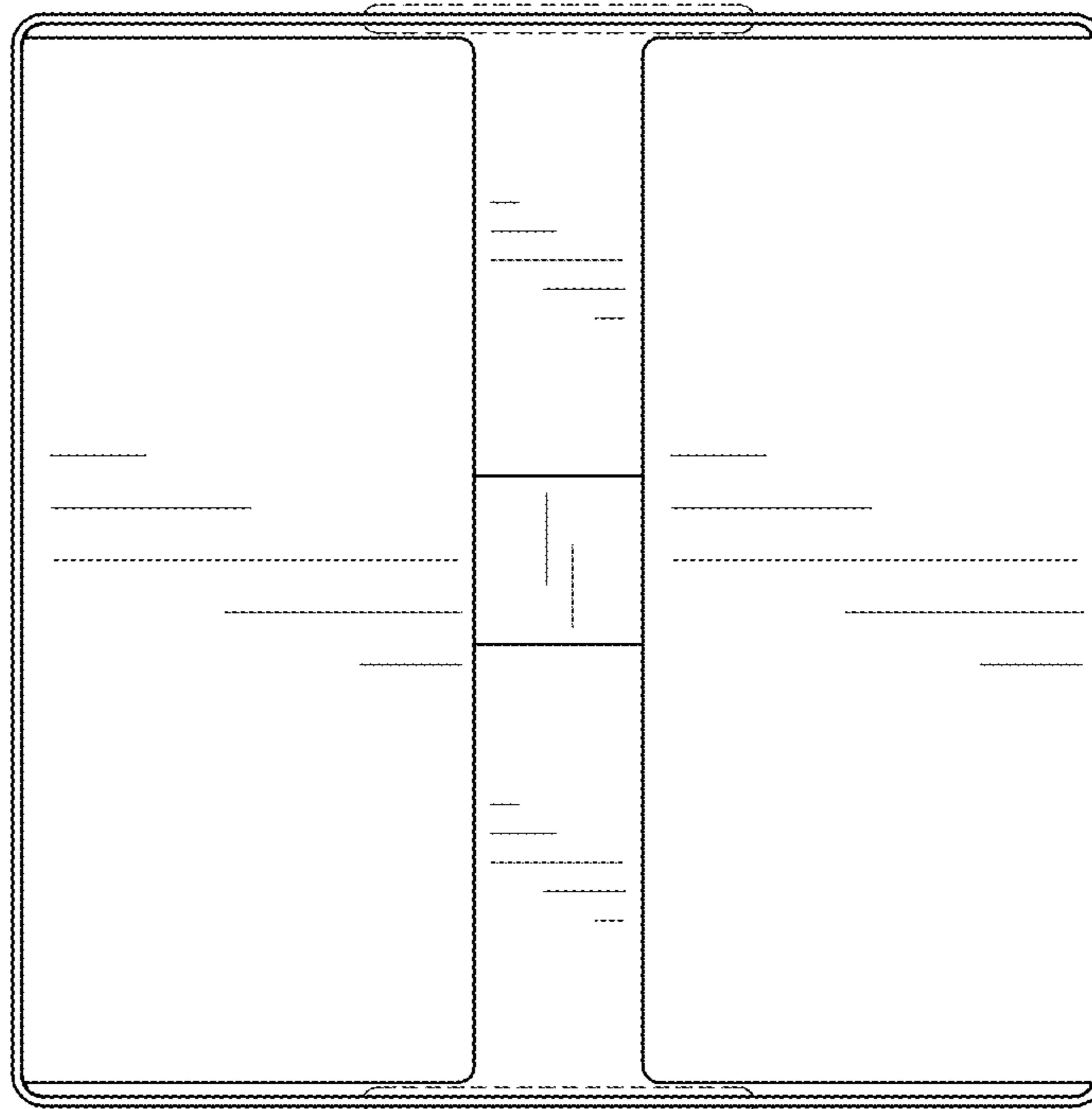

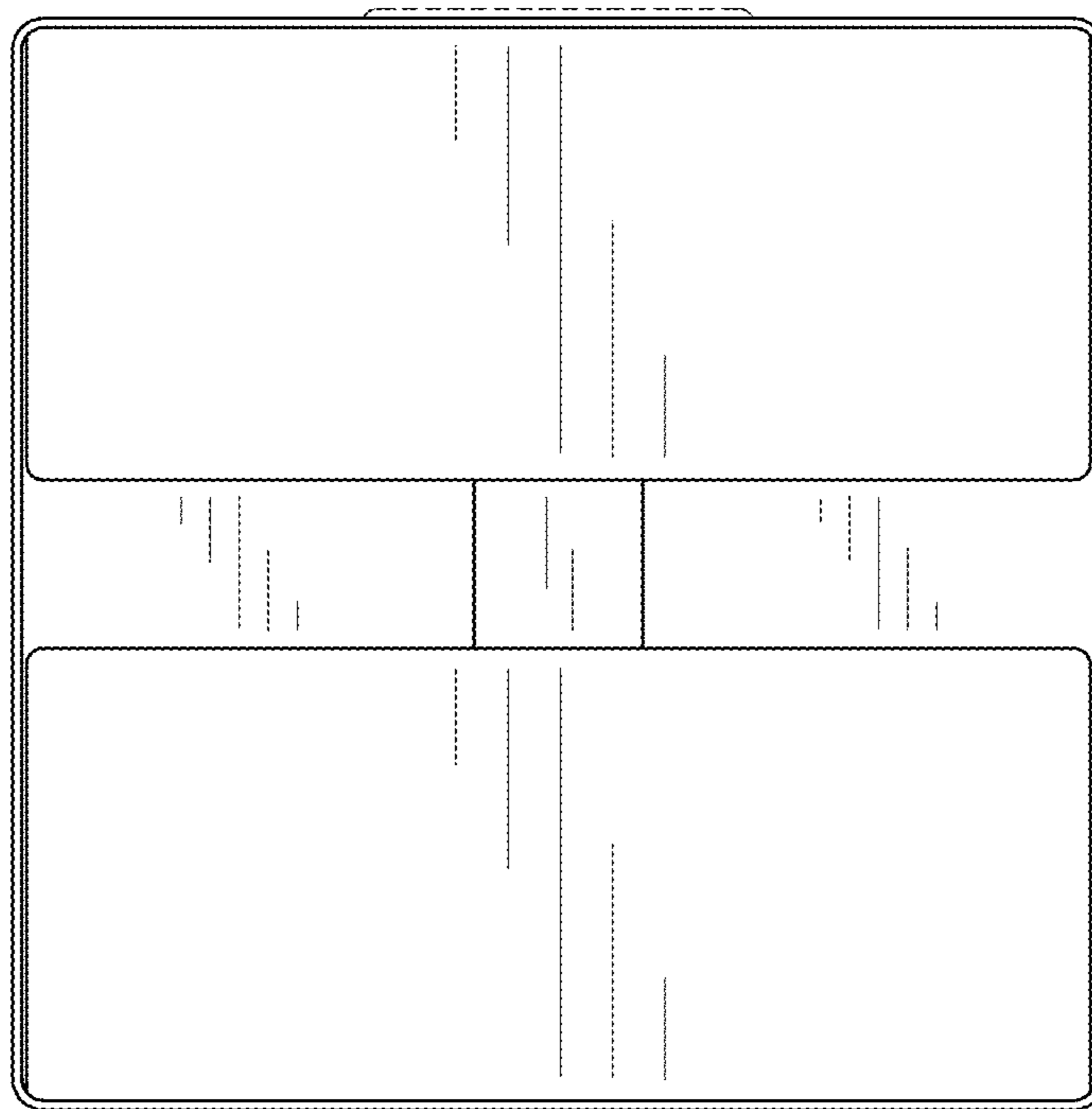

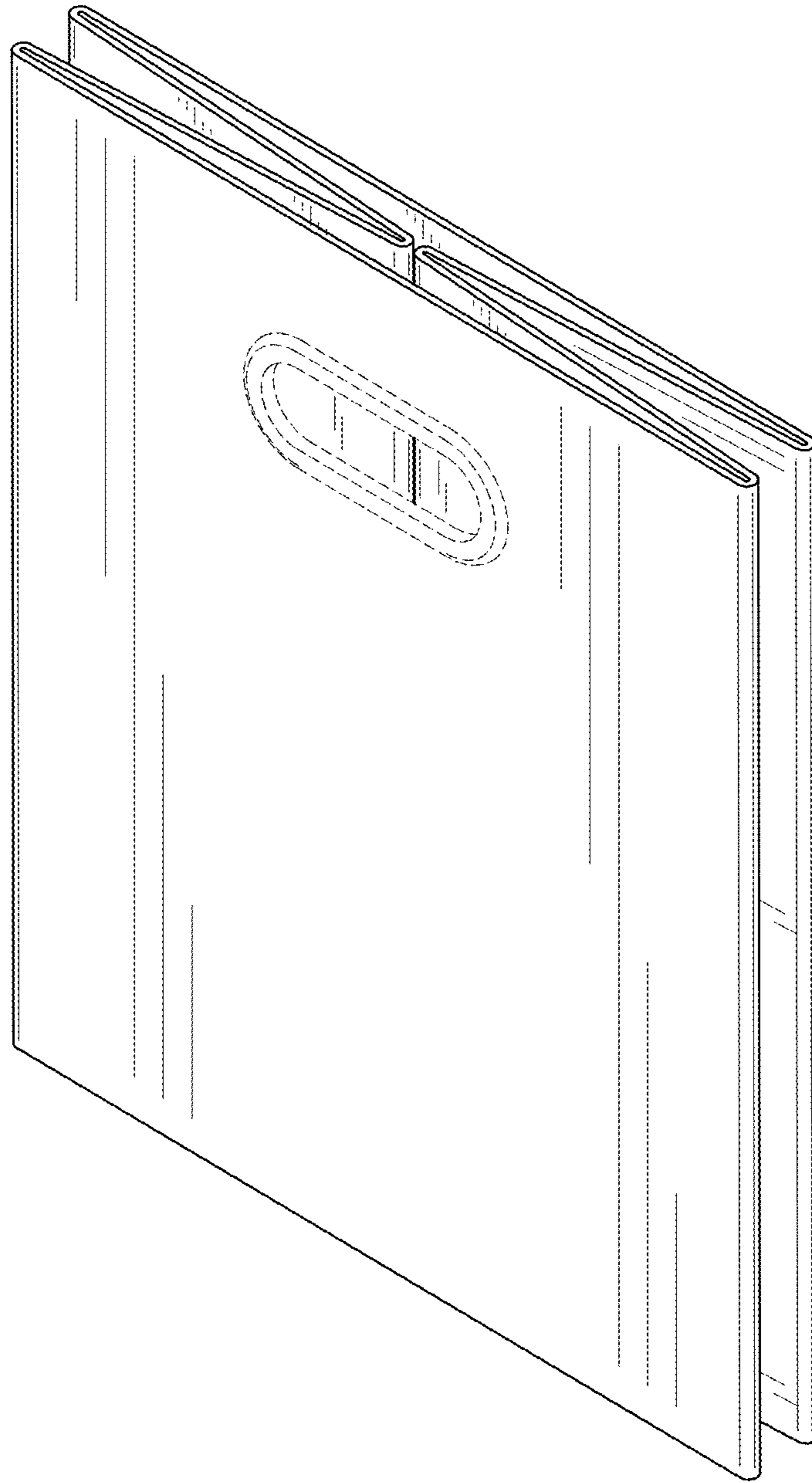
