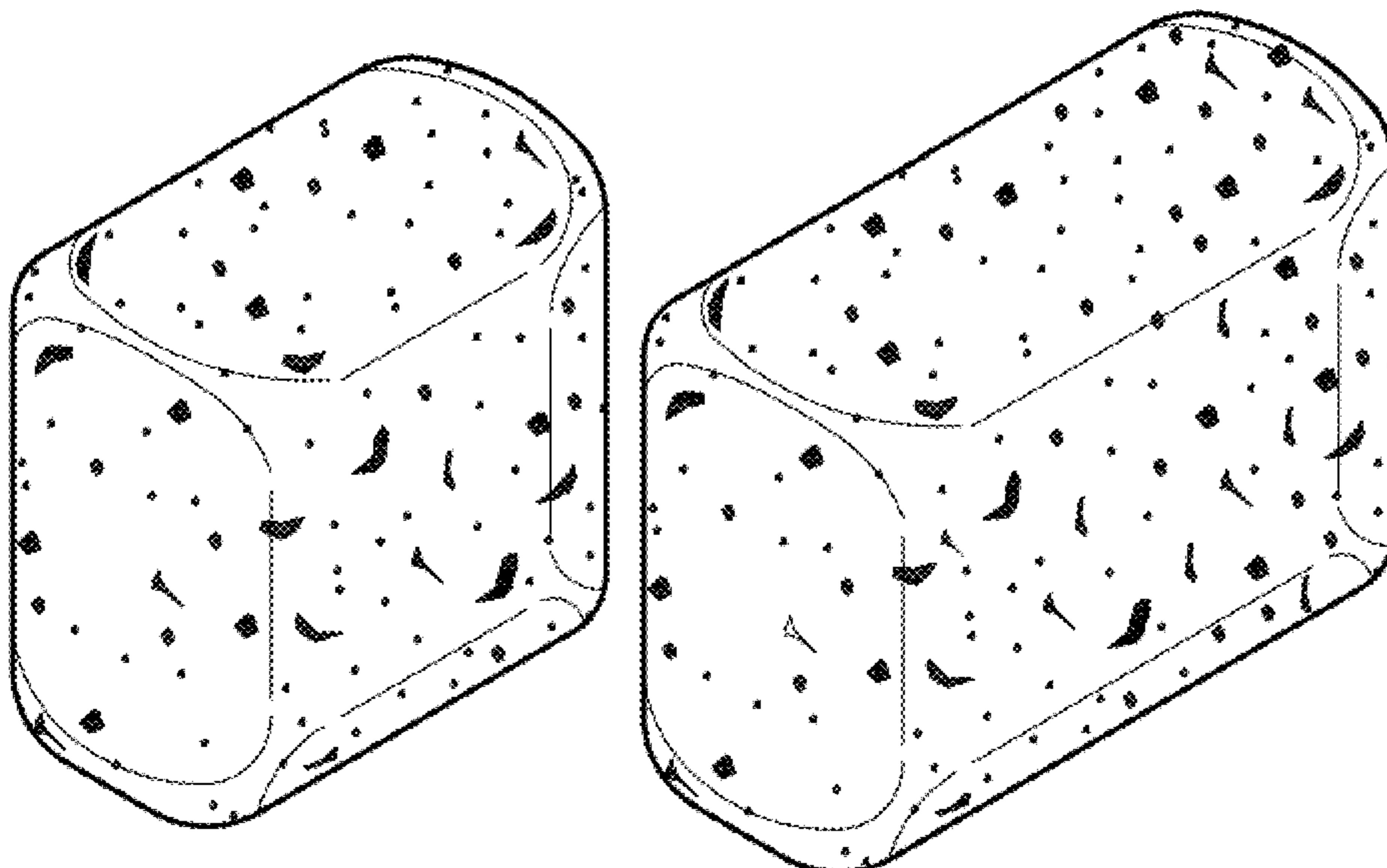
(57) **CLAIM**

We claim the ornamental design for a textured confectionary, as substantially shown and described.

**DESCRIPTION**

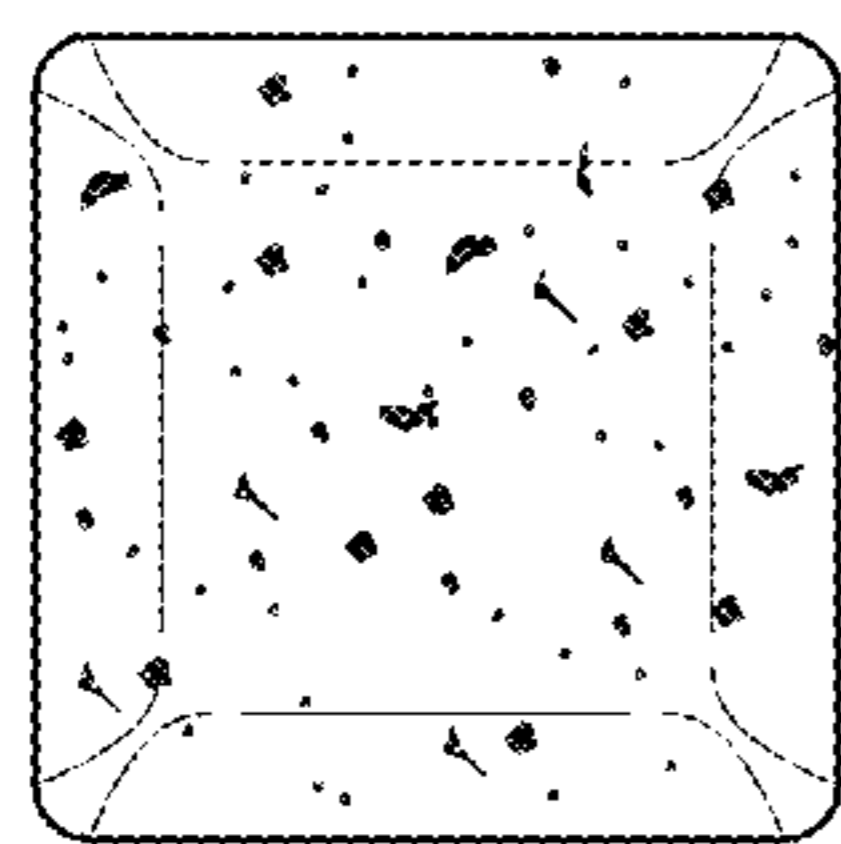

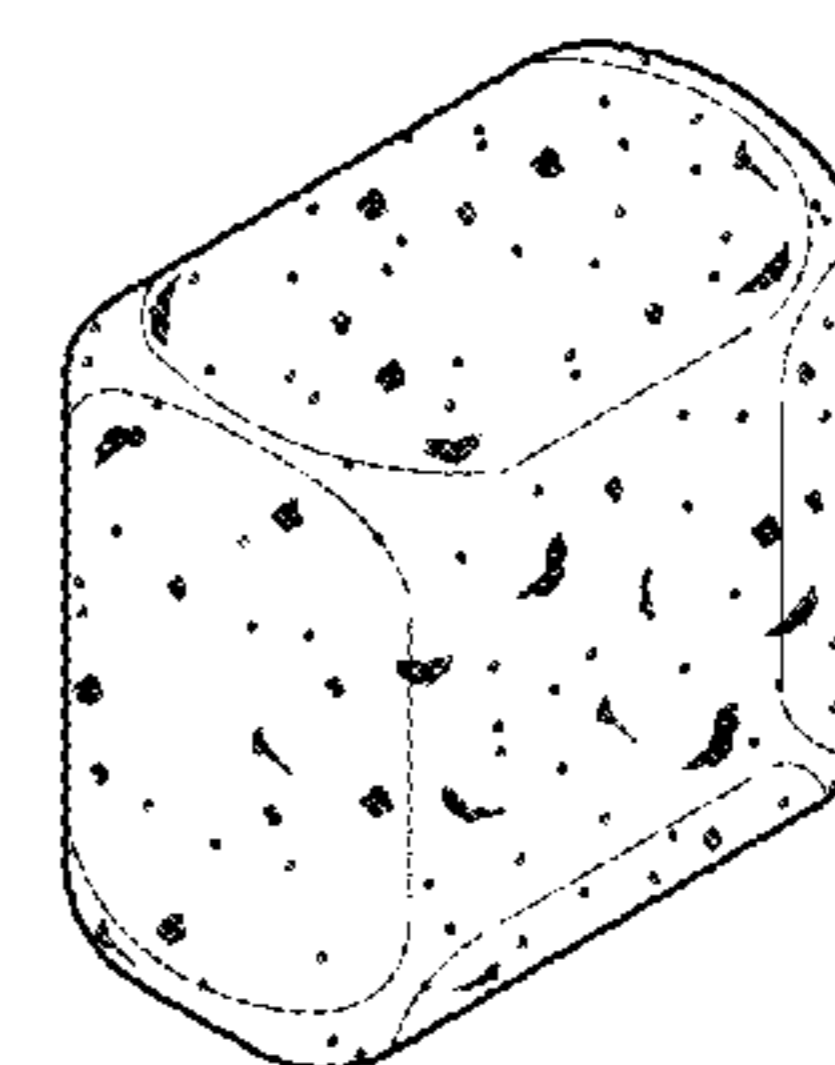

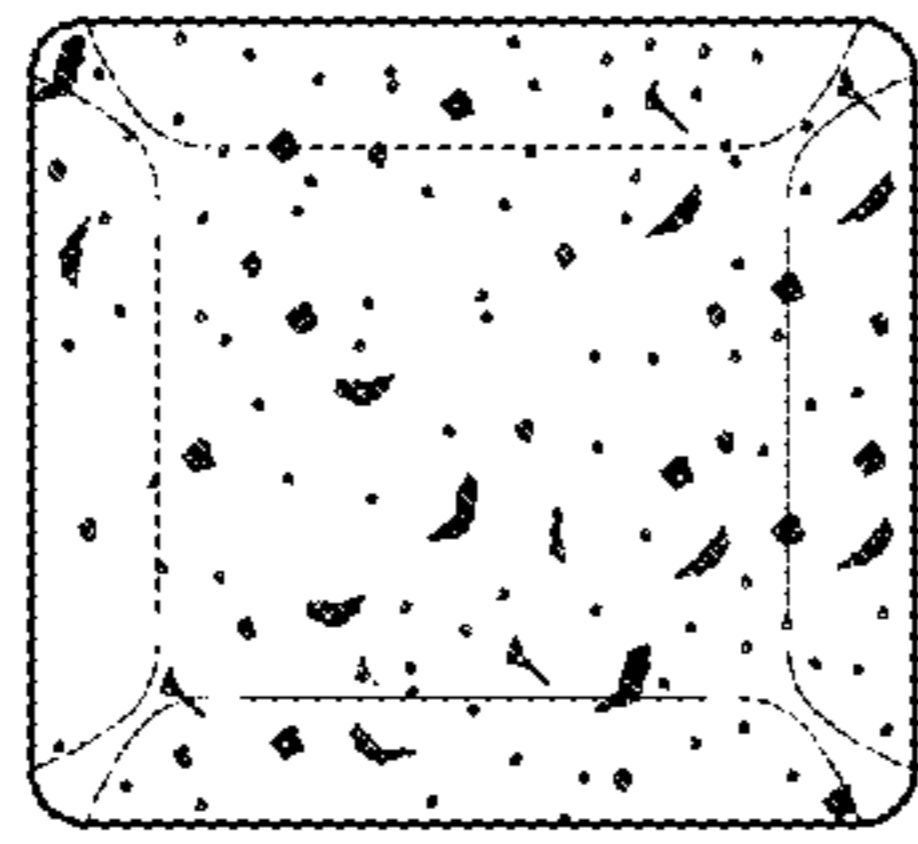

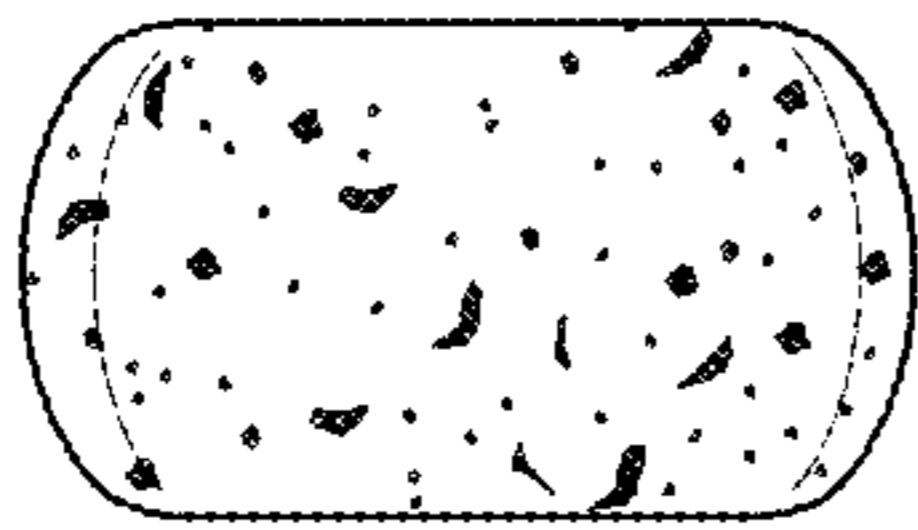

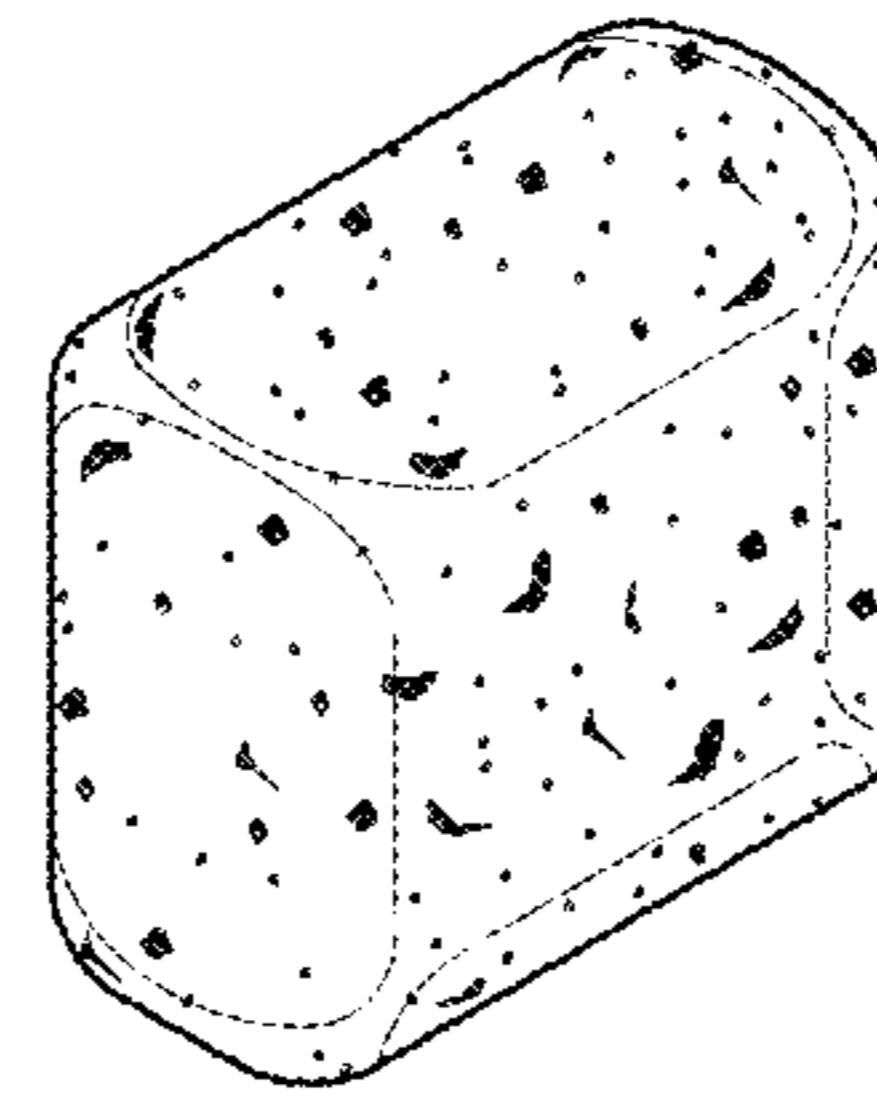

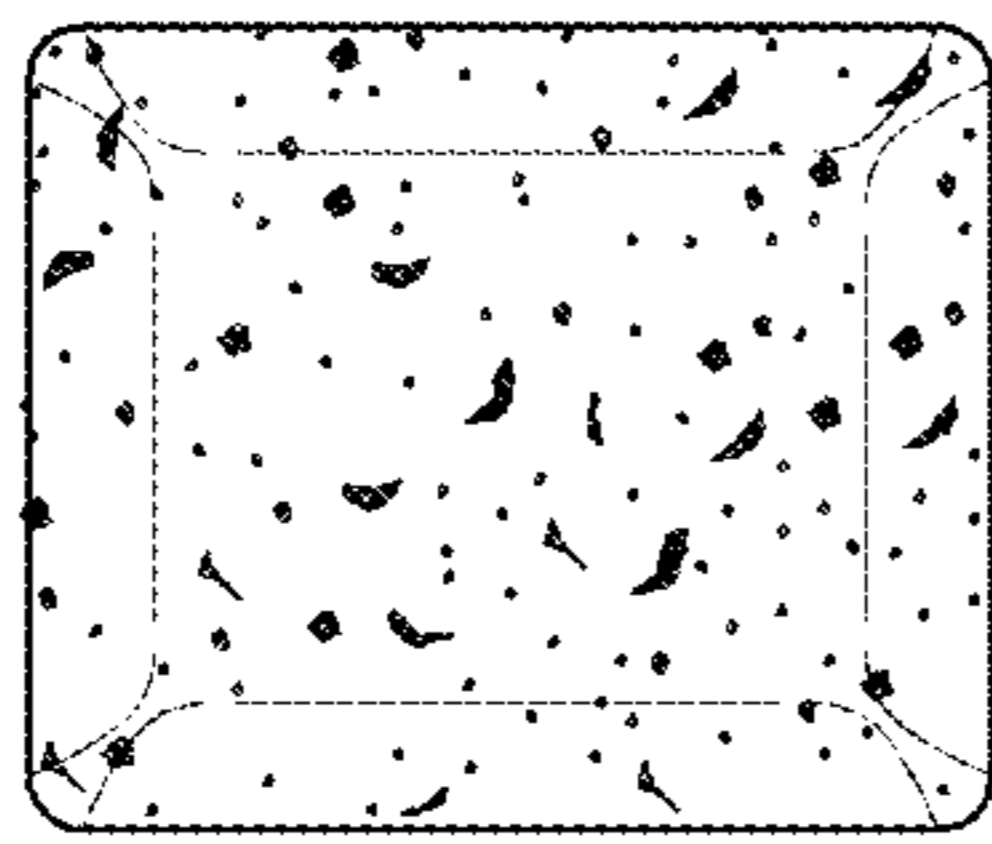

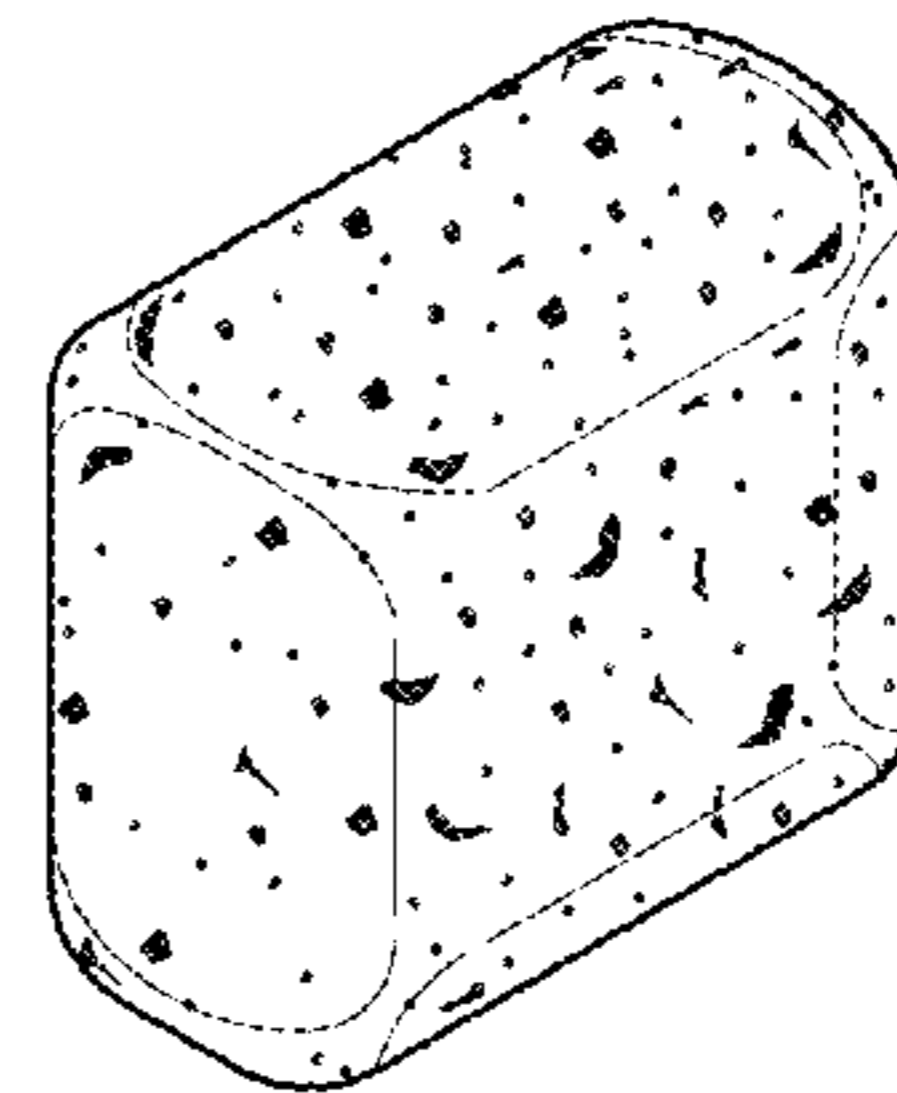

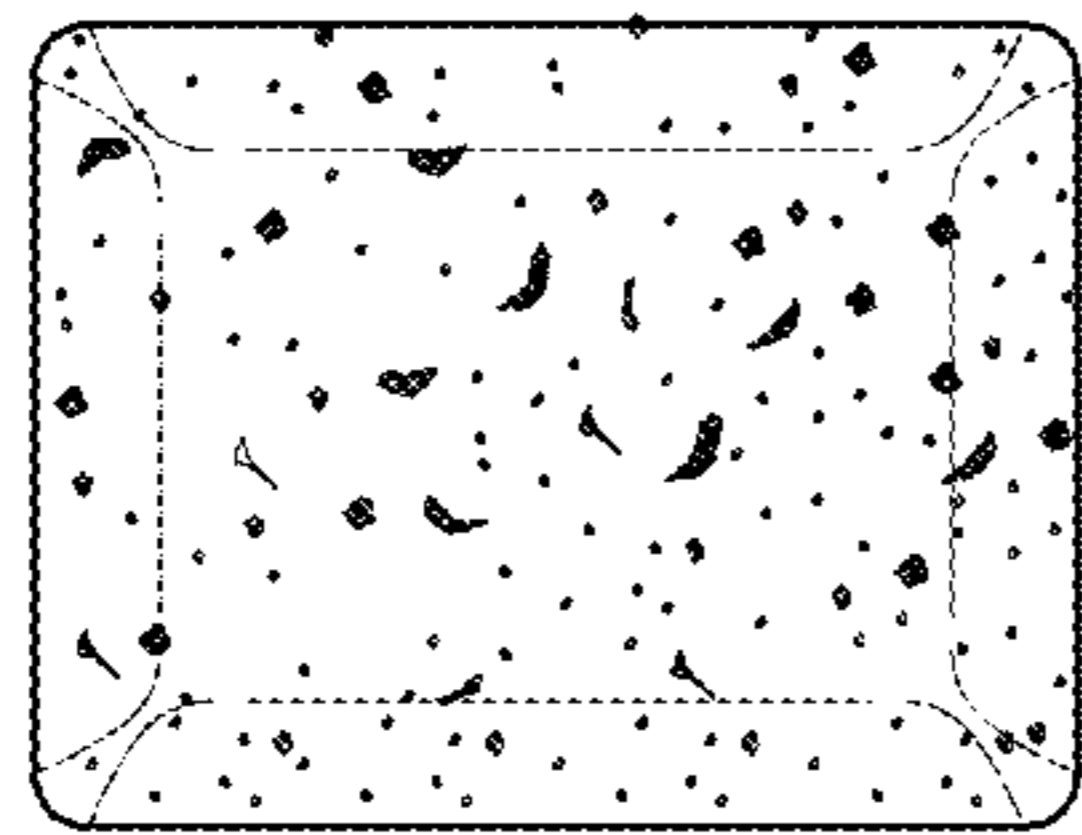

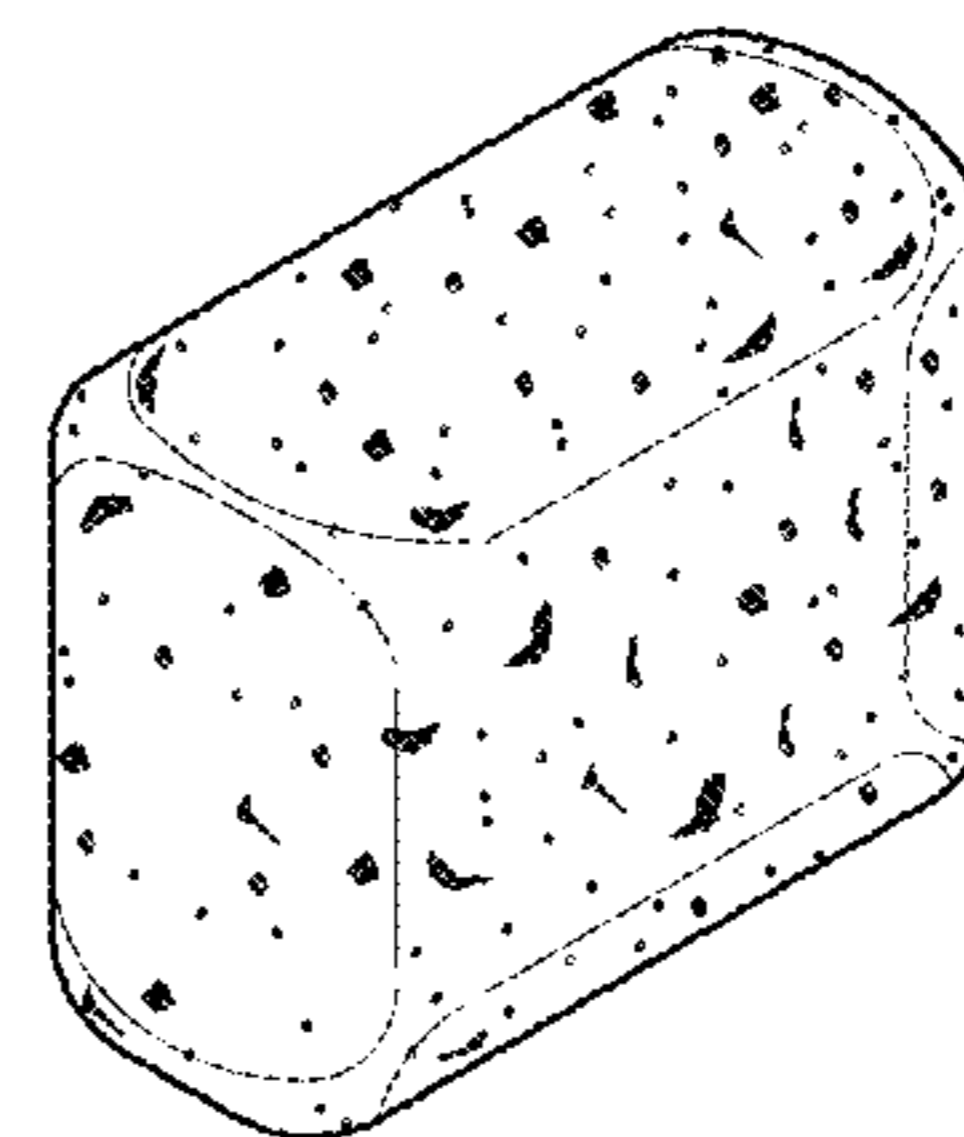

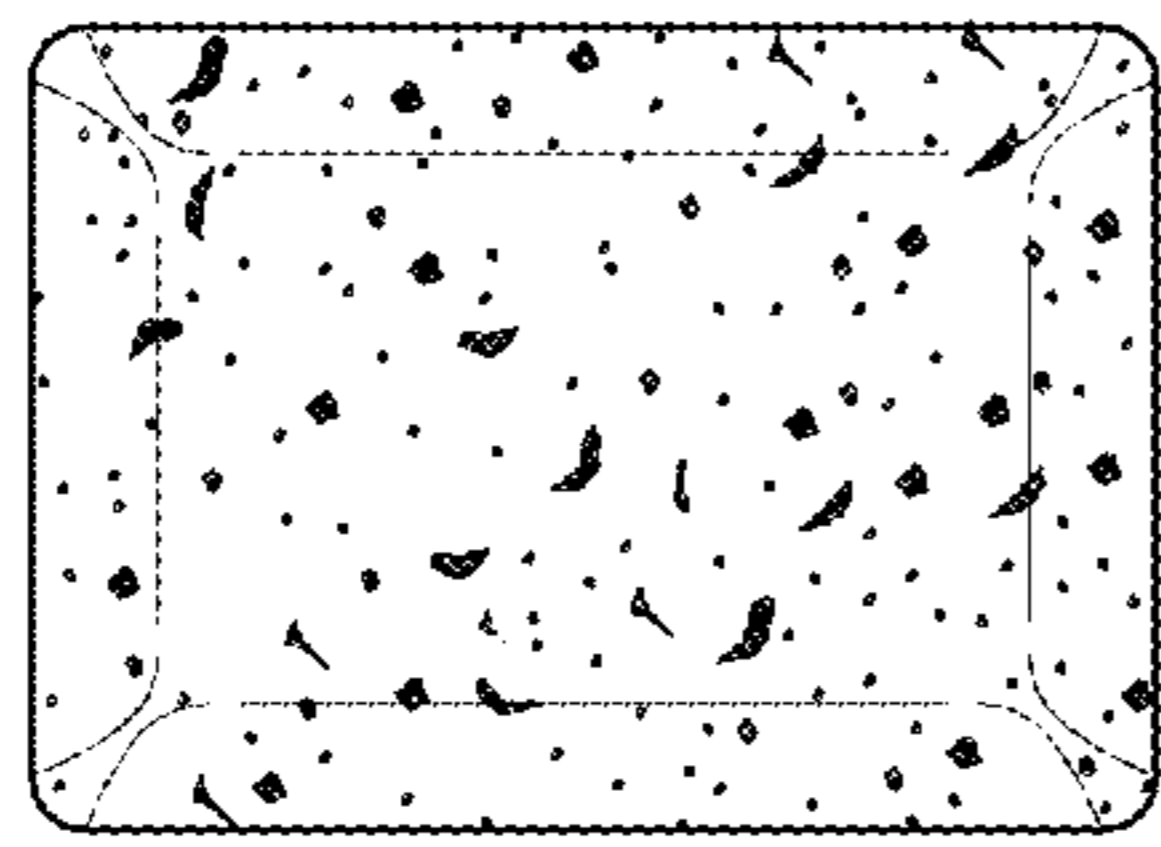

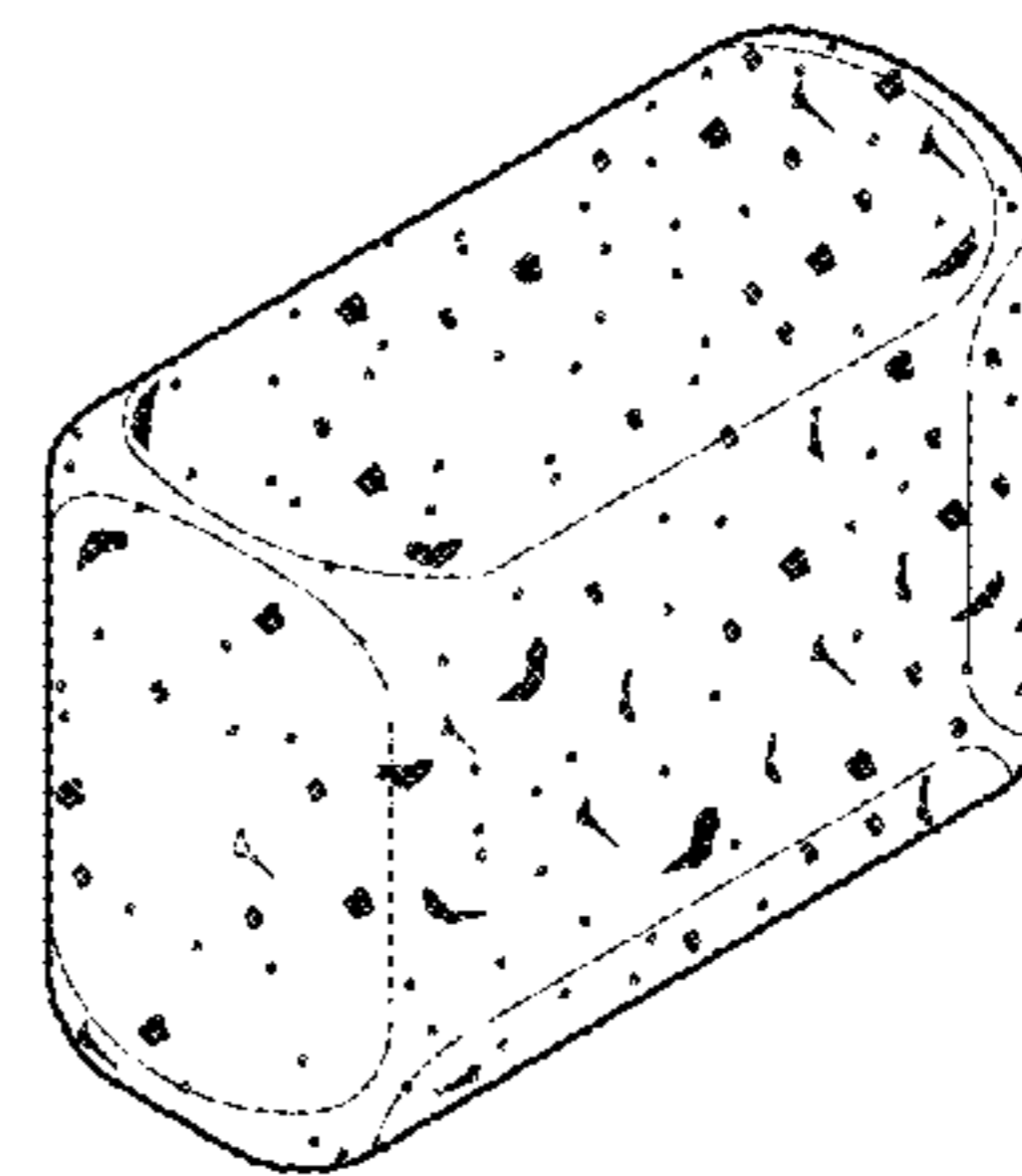
