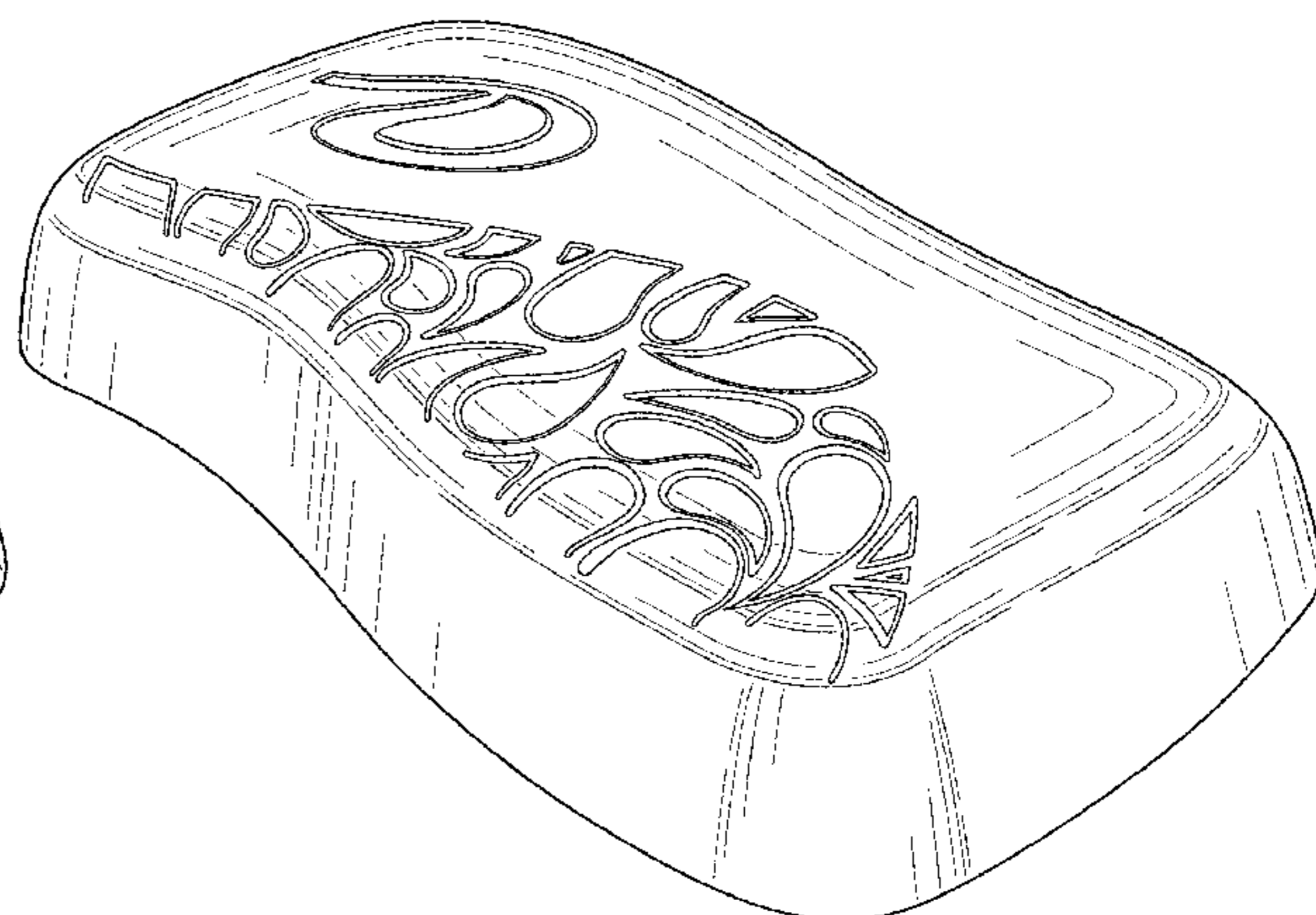
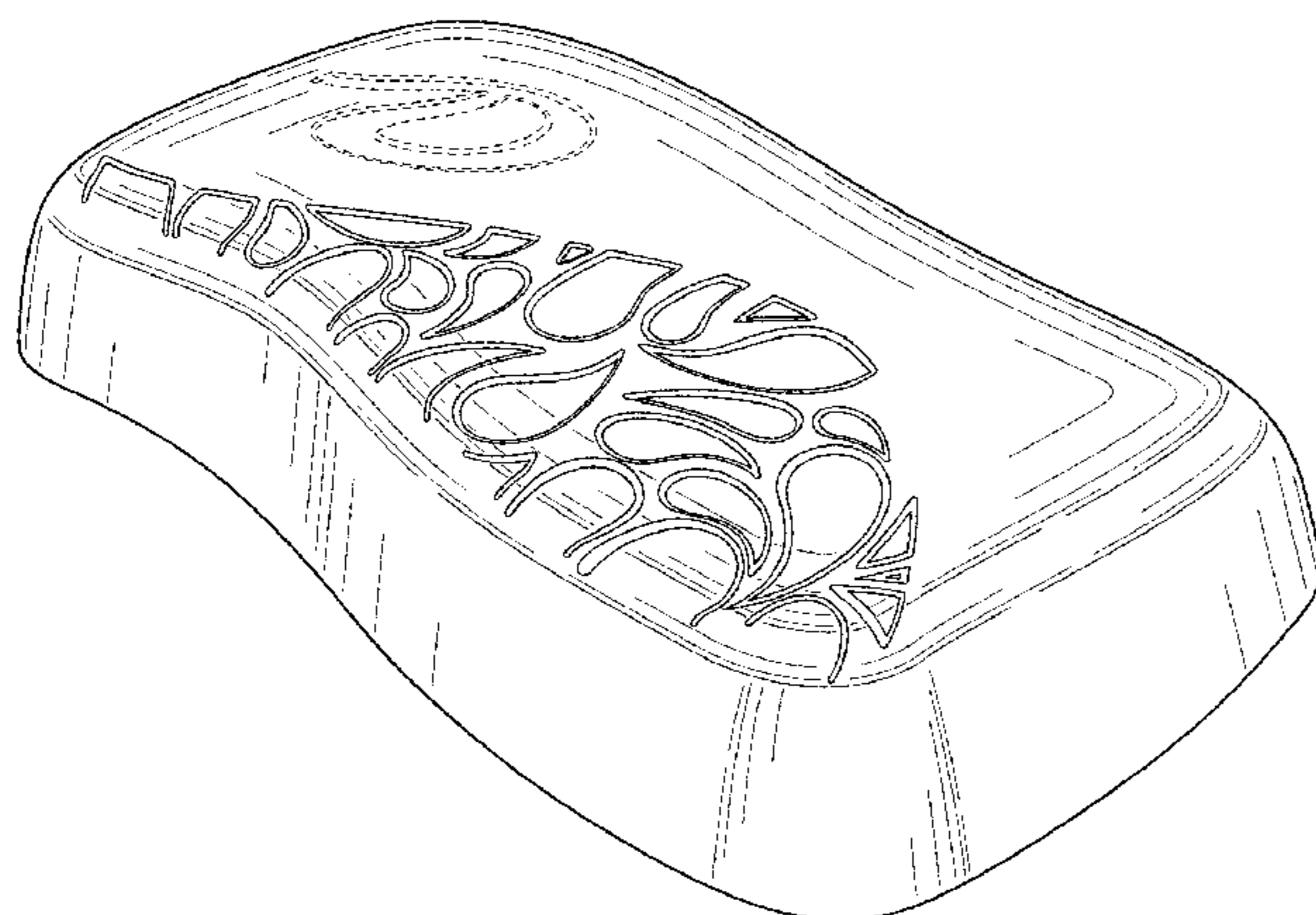
The ornamental design for a confection, as shown and described.

DESCRIPTION

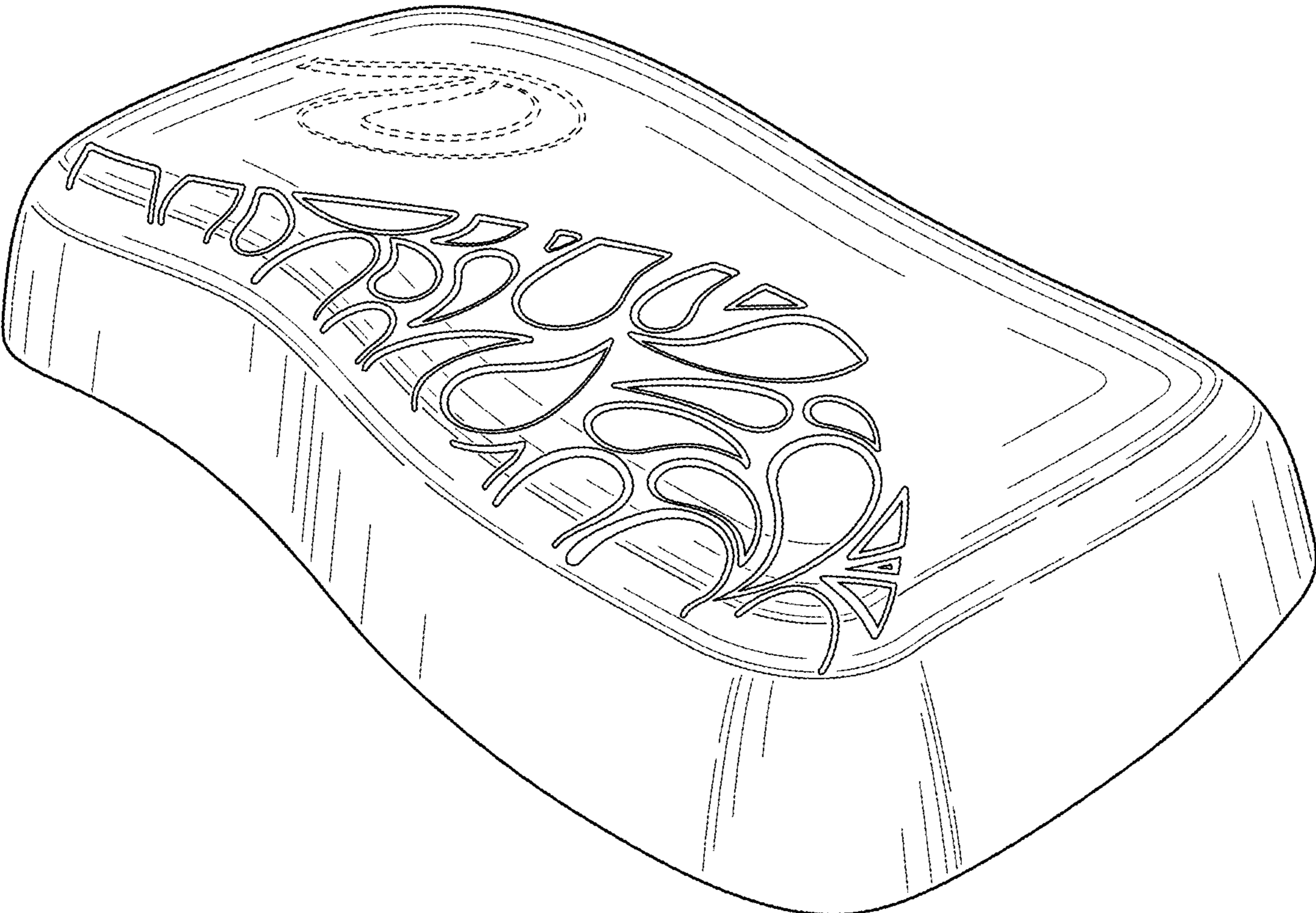

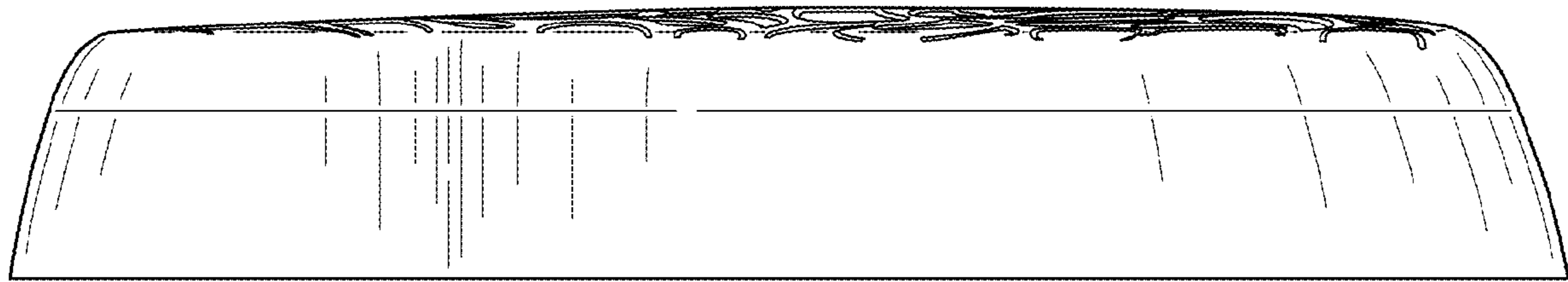

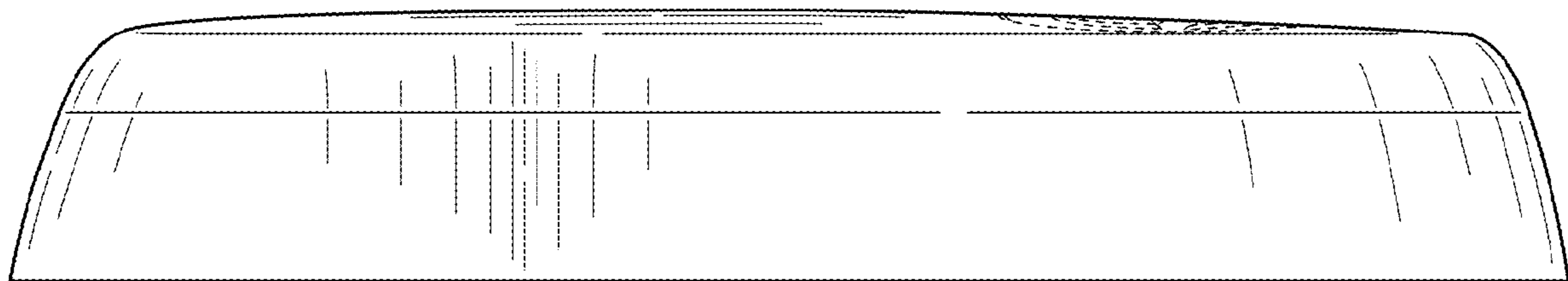

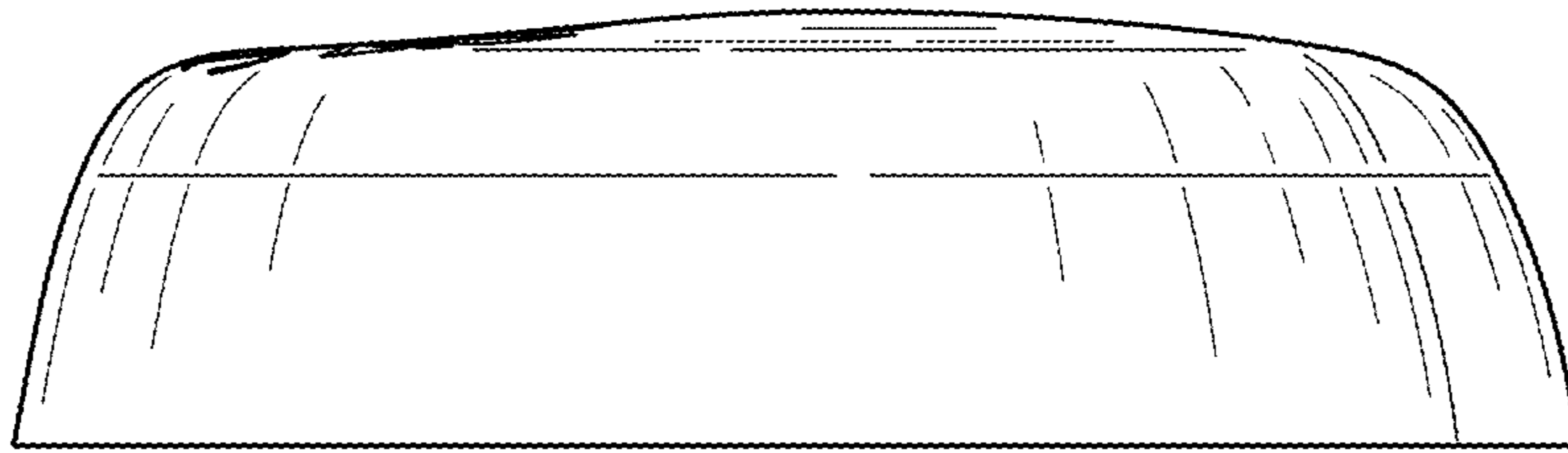

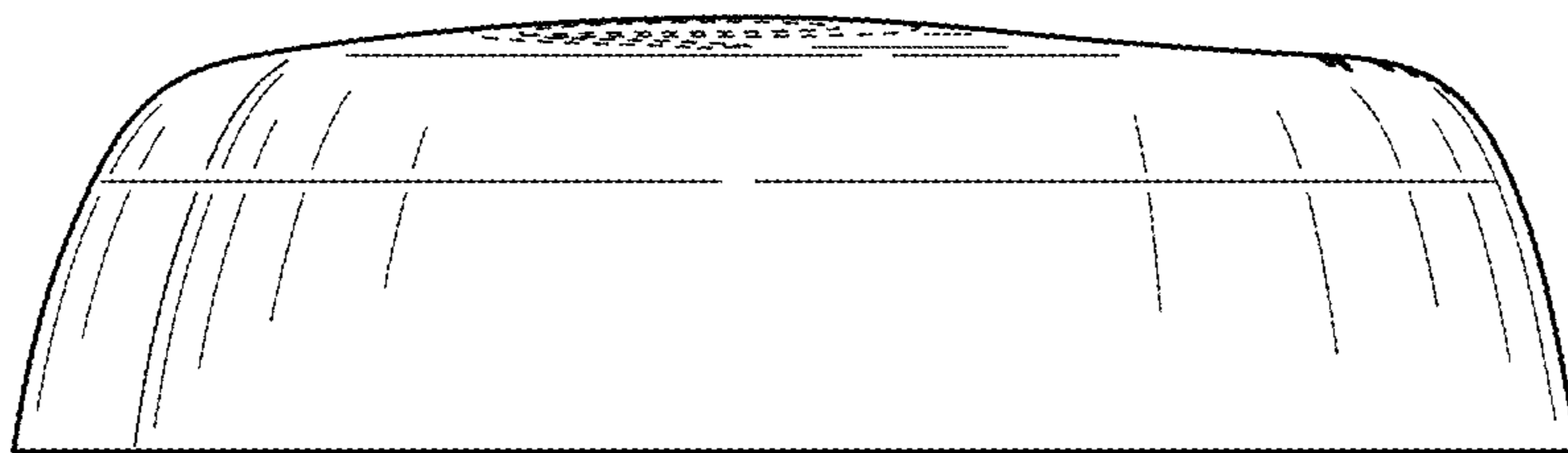

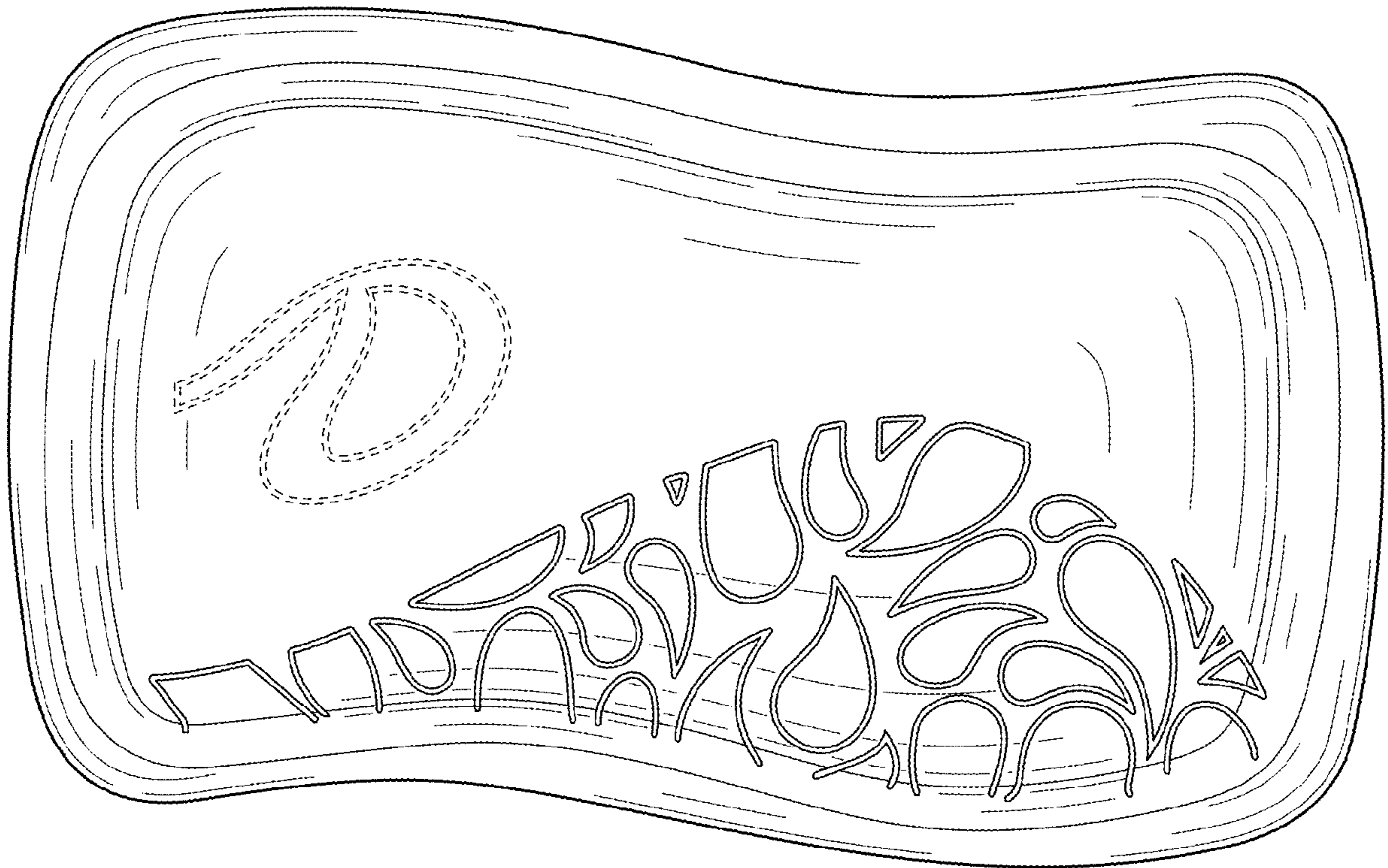

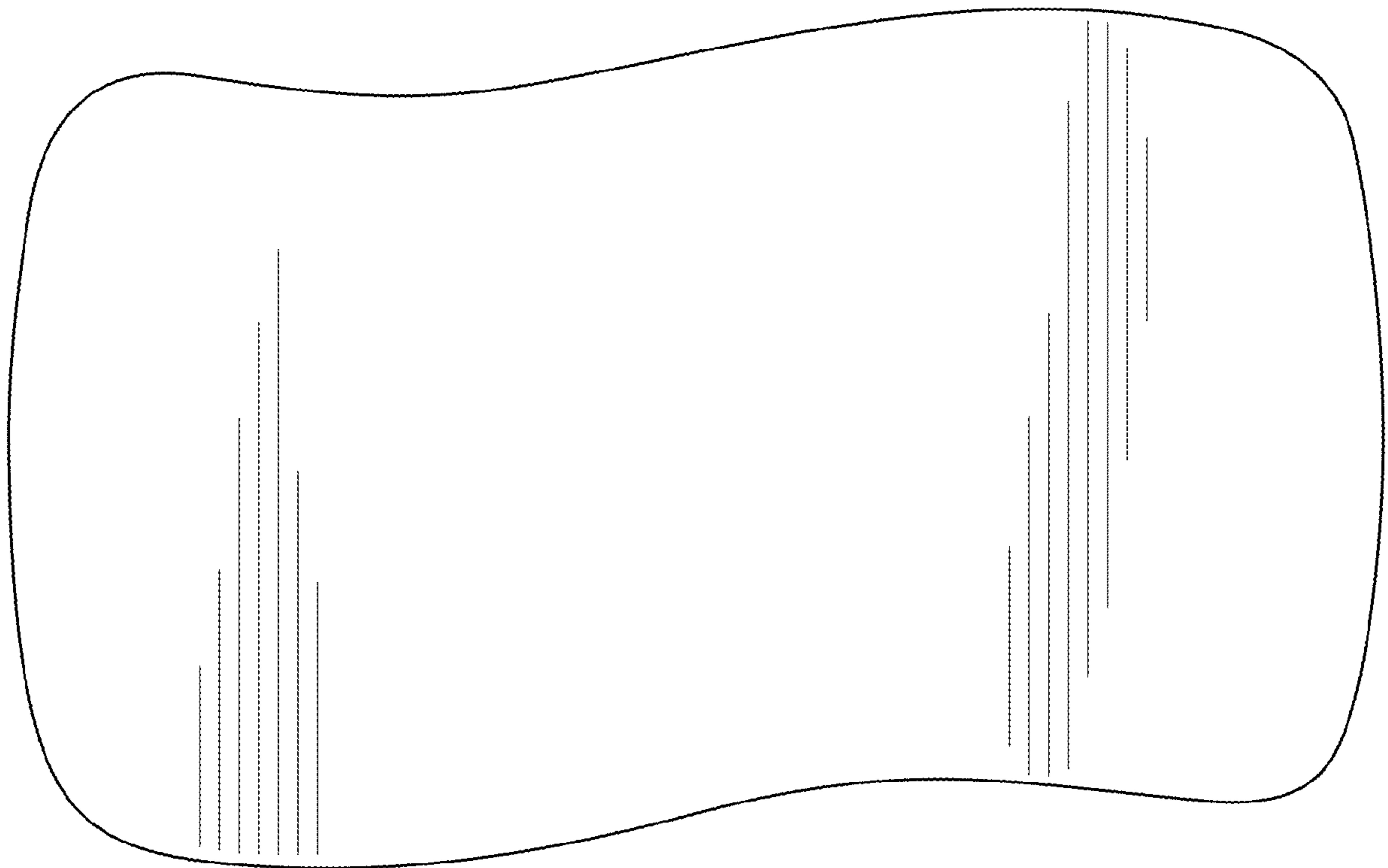

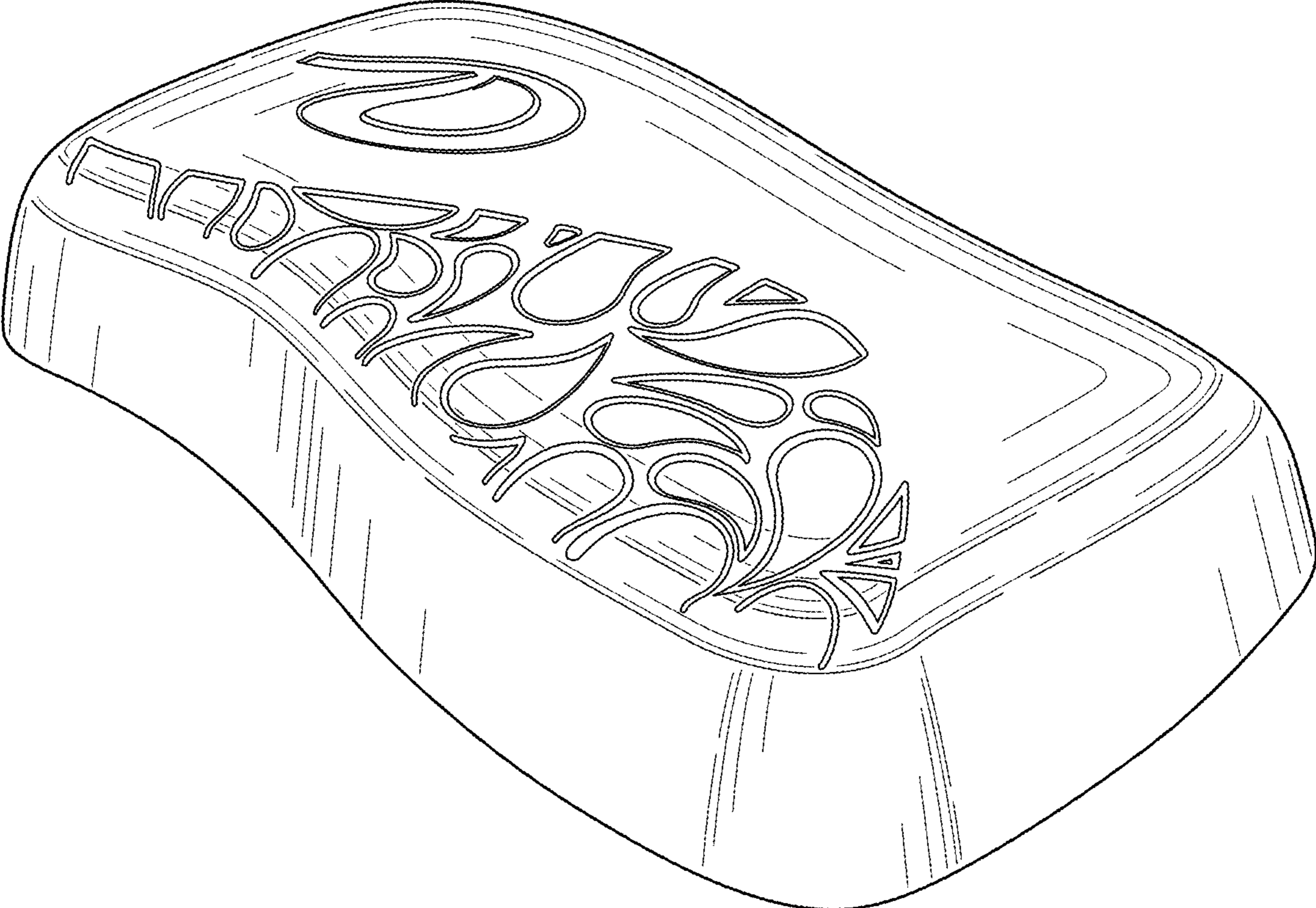

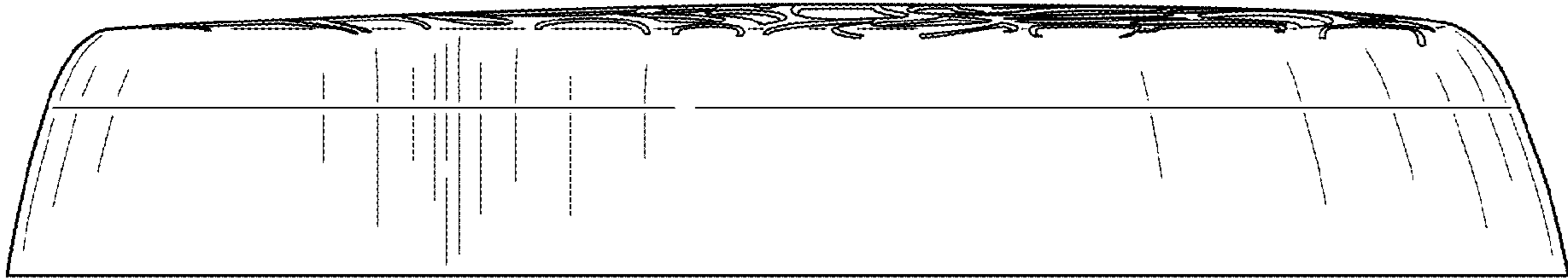

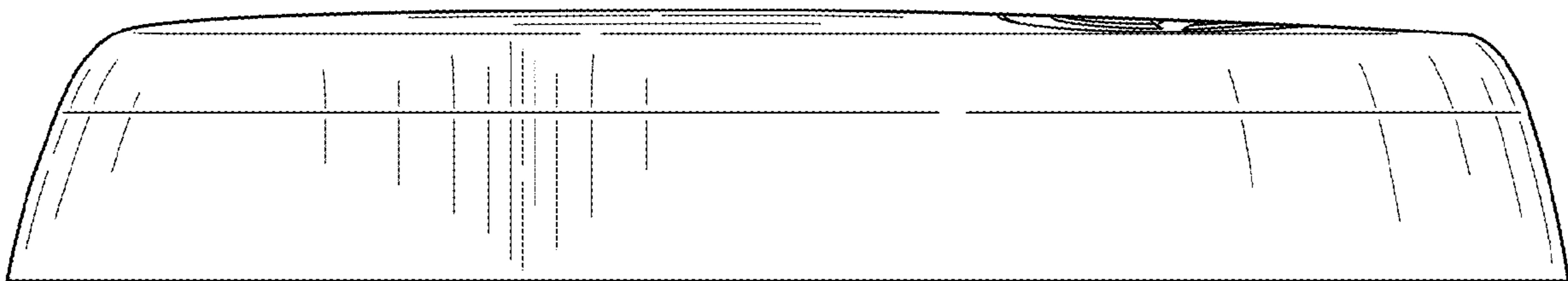

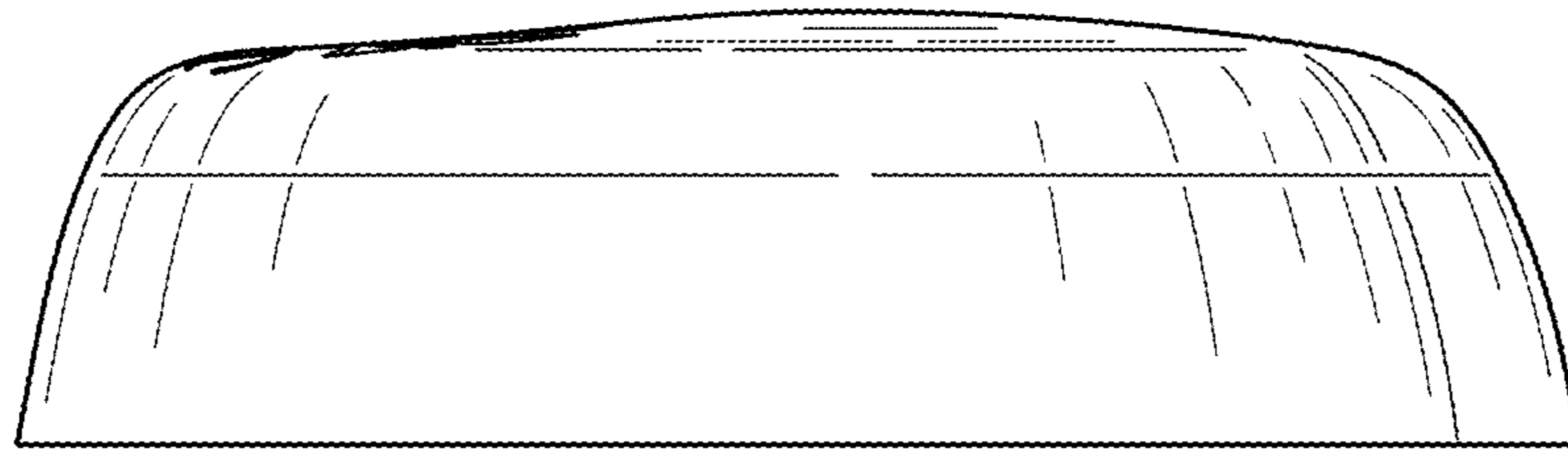

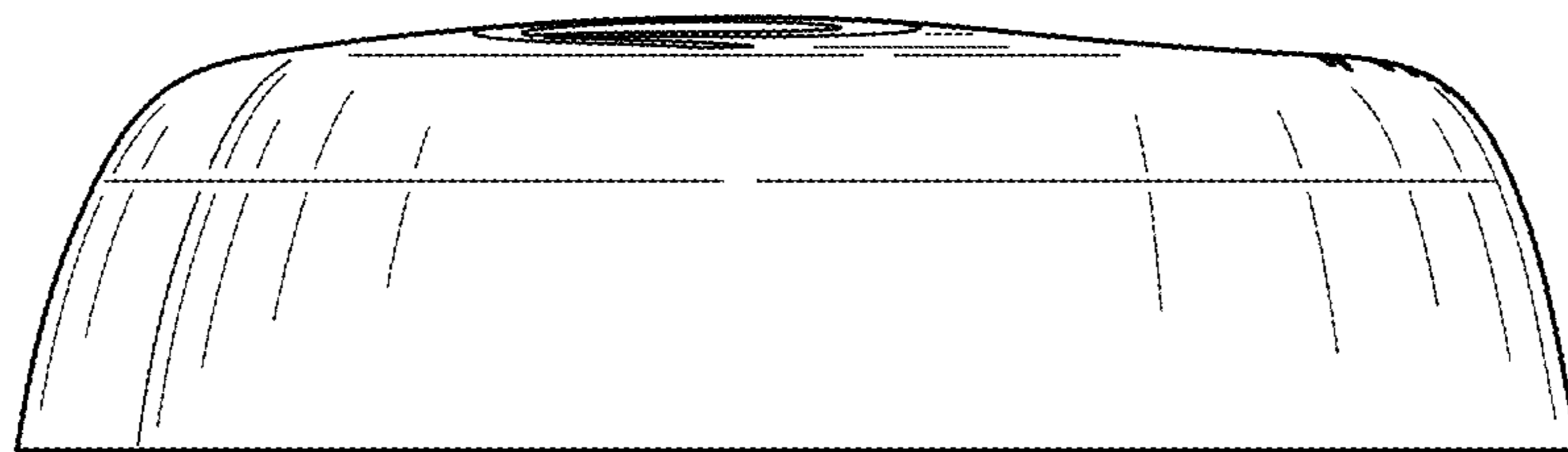

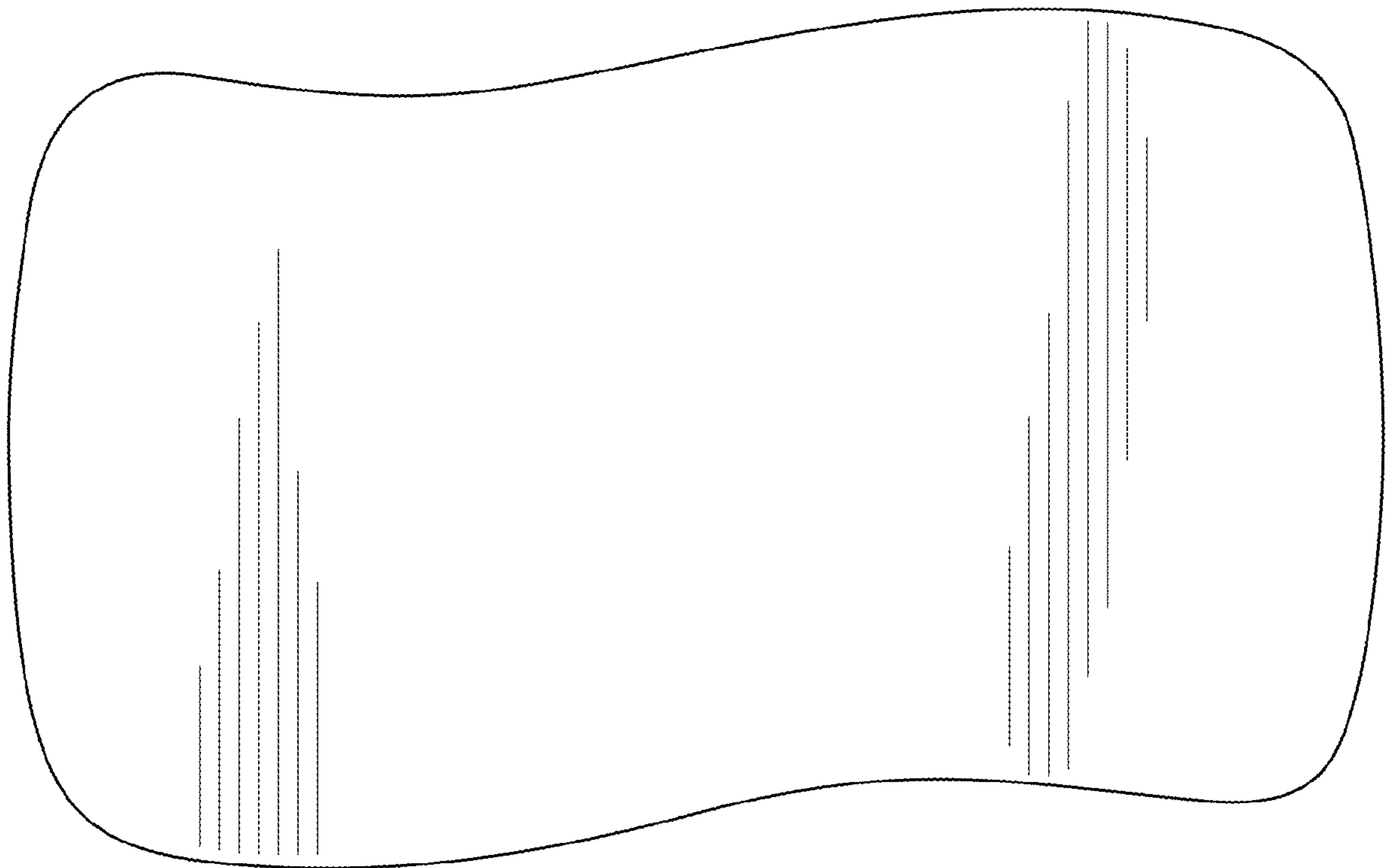
