(57) **CLAIM**

I claim the ornamental design for panels for slimming top garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a first panel for a slimming top garment;

FIG. 2 is a back elevation view of a second panel for the slimming top garment;

FIG. 3 is a left elevation view of the first and second panels for the slimming top garment;

FIG. 4 is a right elevation view of the first and second panels for the slimming top garment;

FIG. 5 is a front elevation view of the first and second panels worn in the front of the slimming top garment;

FIG. 6 is a back elevation view of the first and second panels worn in the front of the slimming top garment;

FIG. 7 is a left elevation view of the first and second panels worn in the front of the slimming top garment;

FIG. 8 is a right elevation view of the first and second panels worn in the front of the slimming top garment;

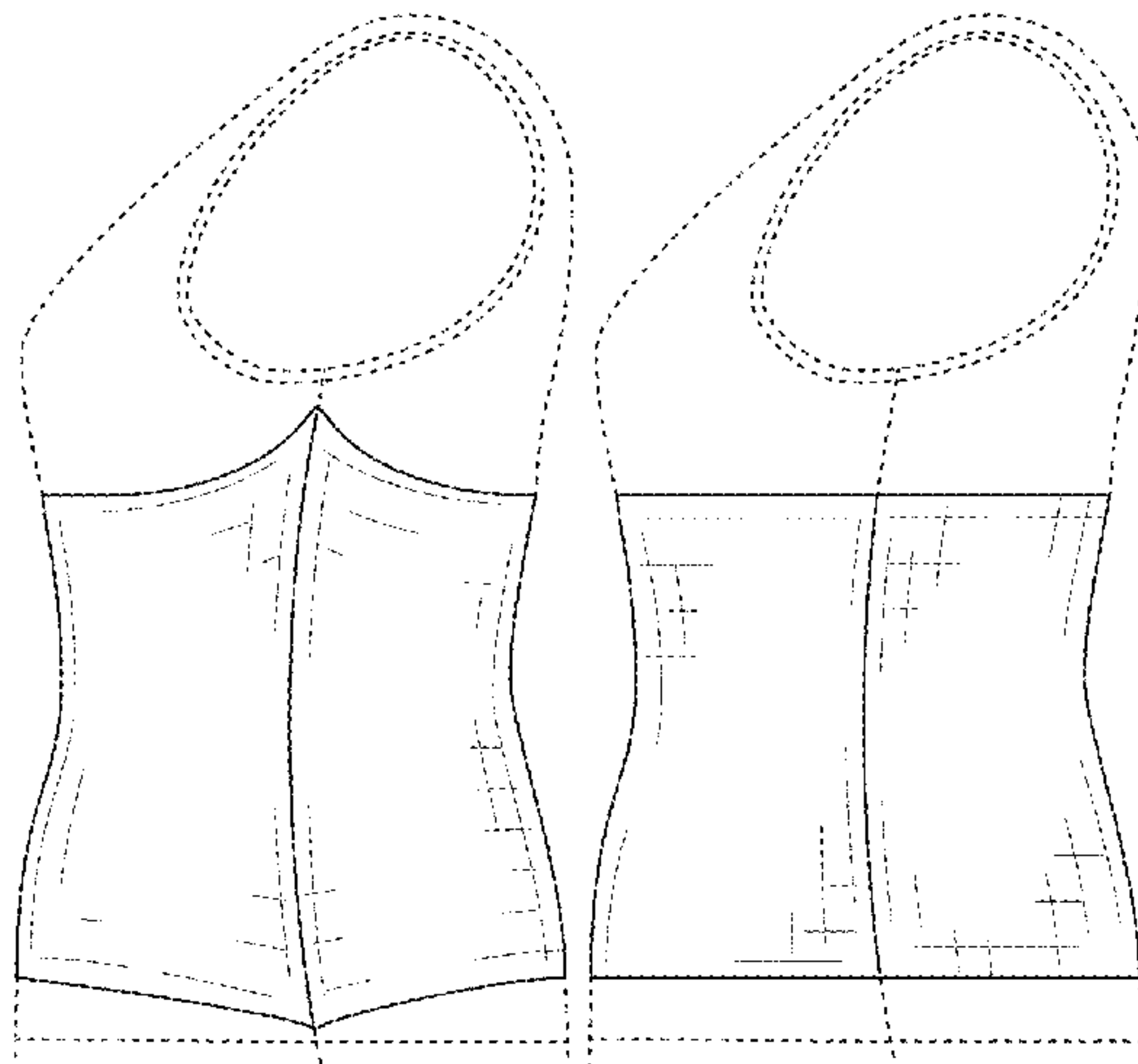


FIG. 18 is a back elevation view of the first and second panels worn in the front of the slimming top garment of the second embodiment;

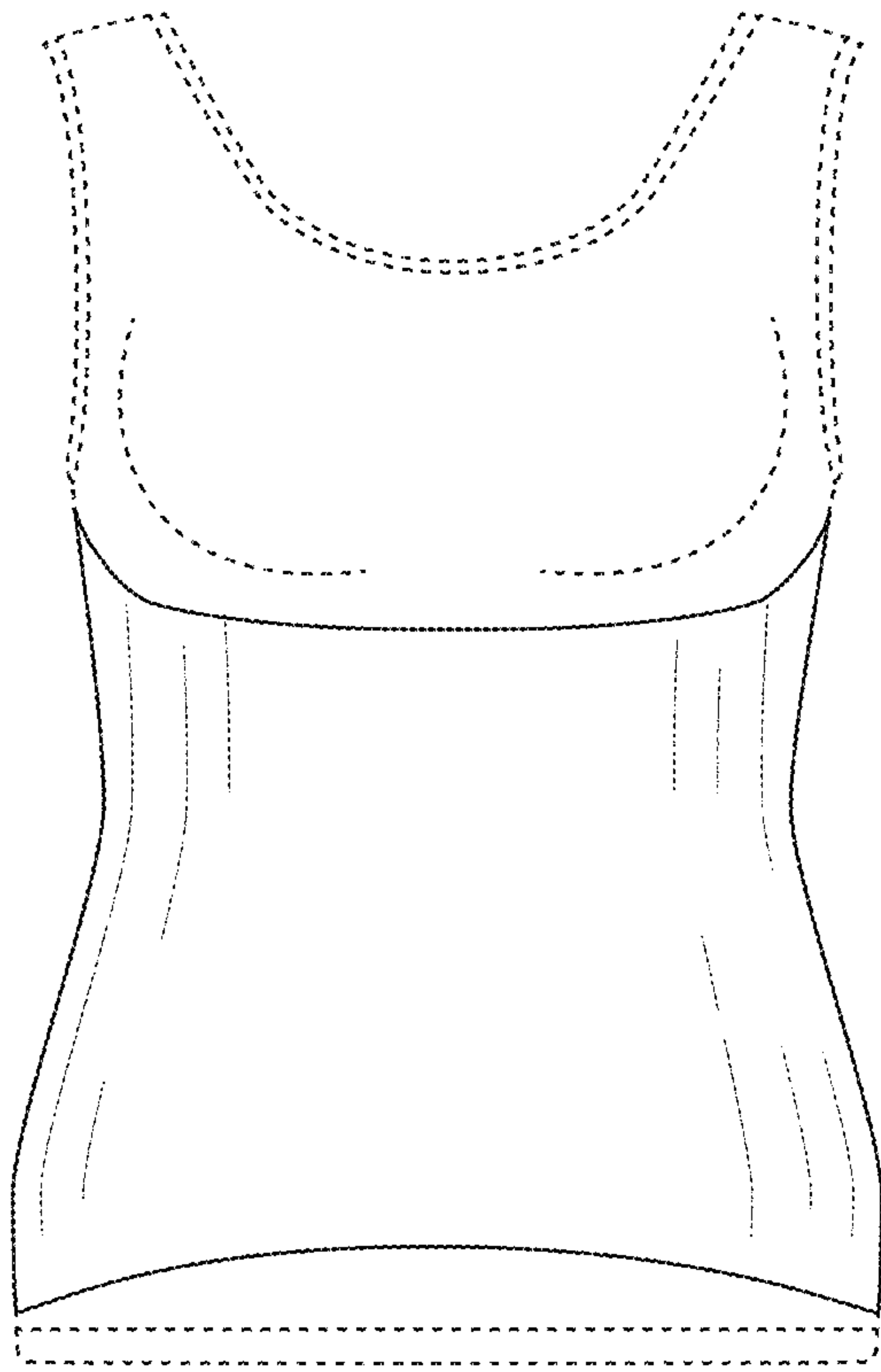

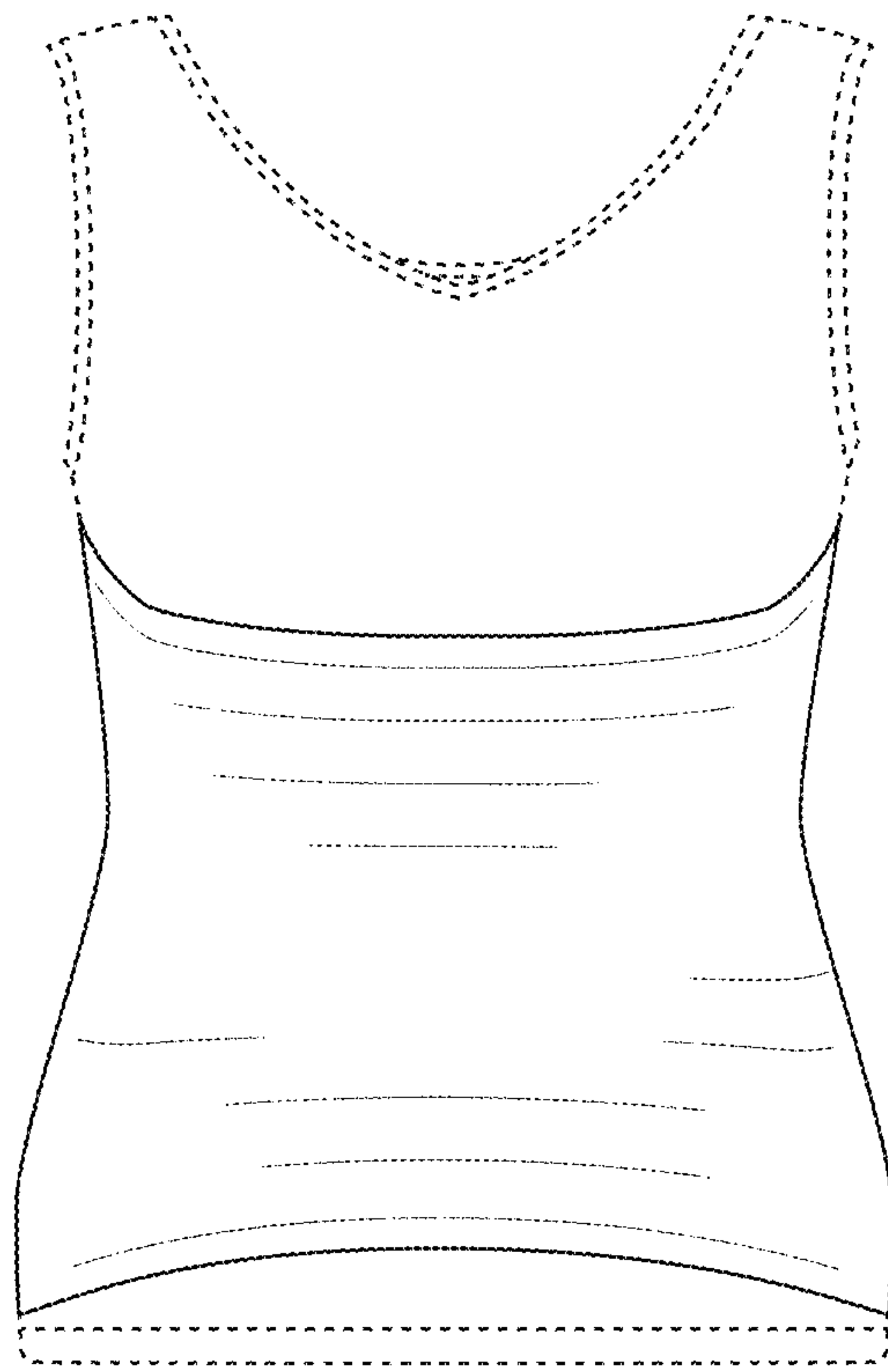

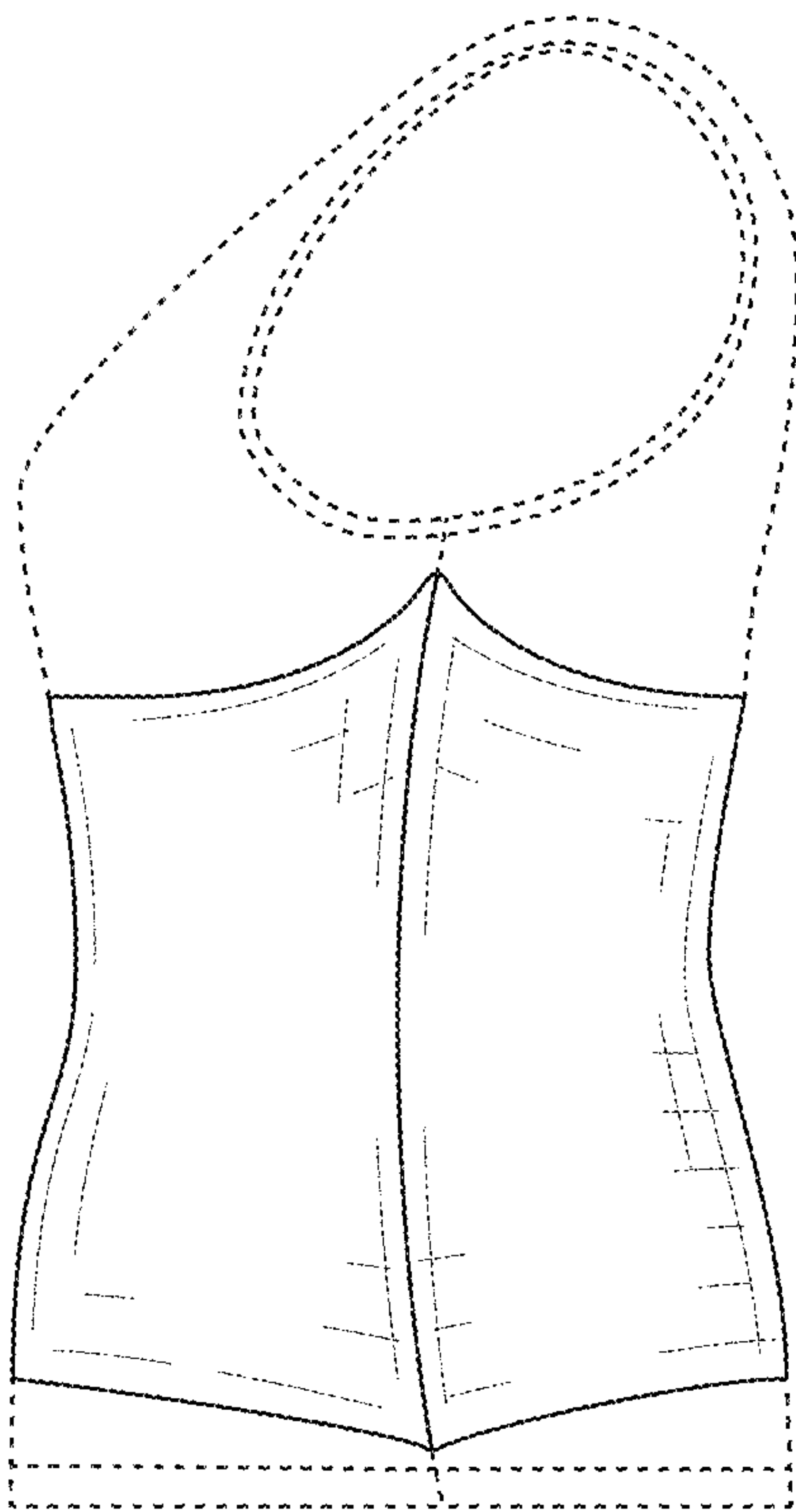

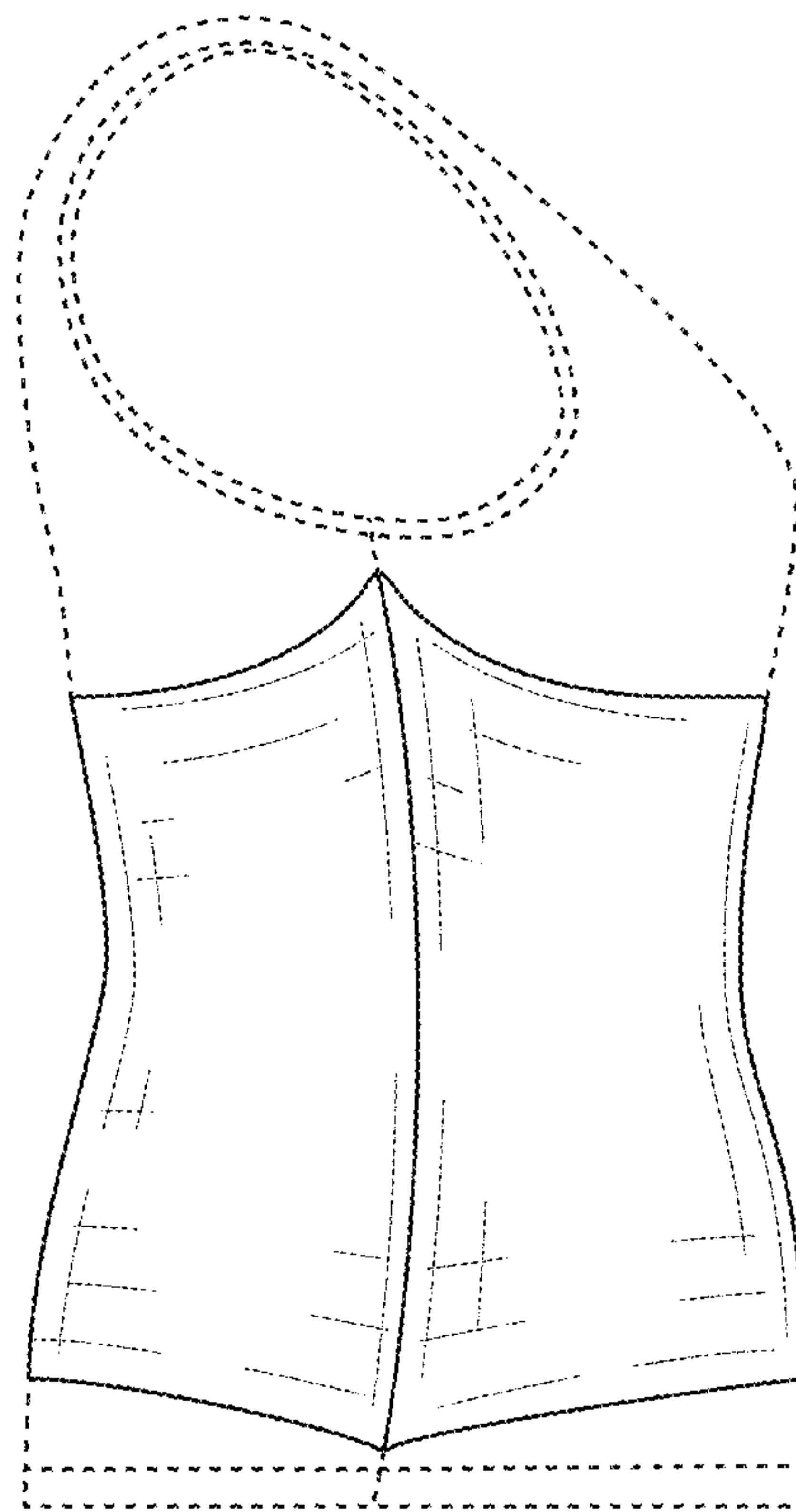

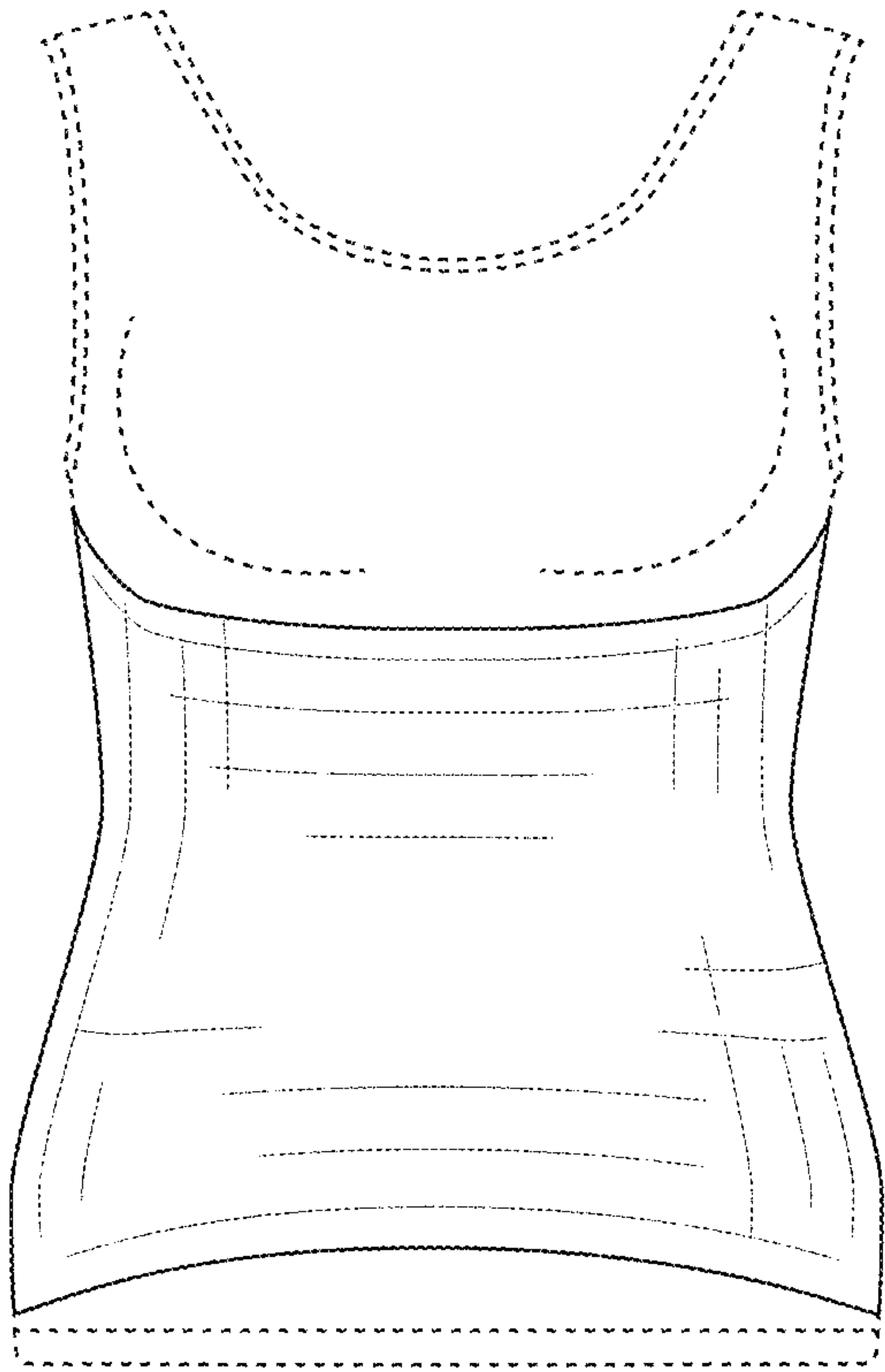

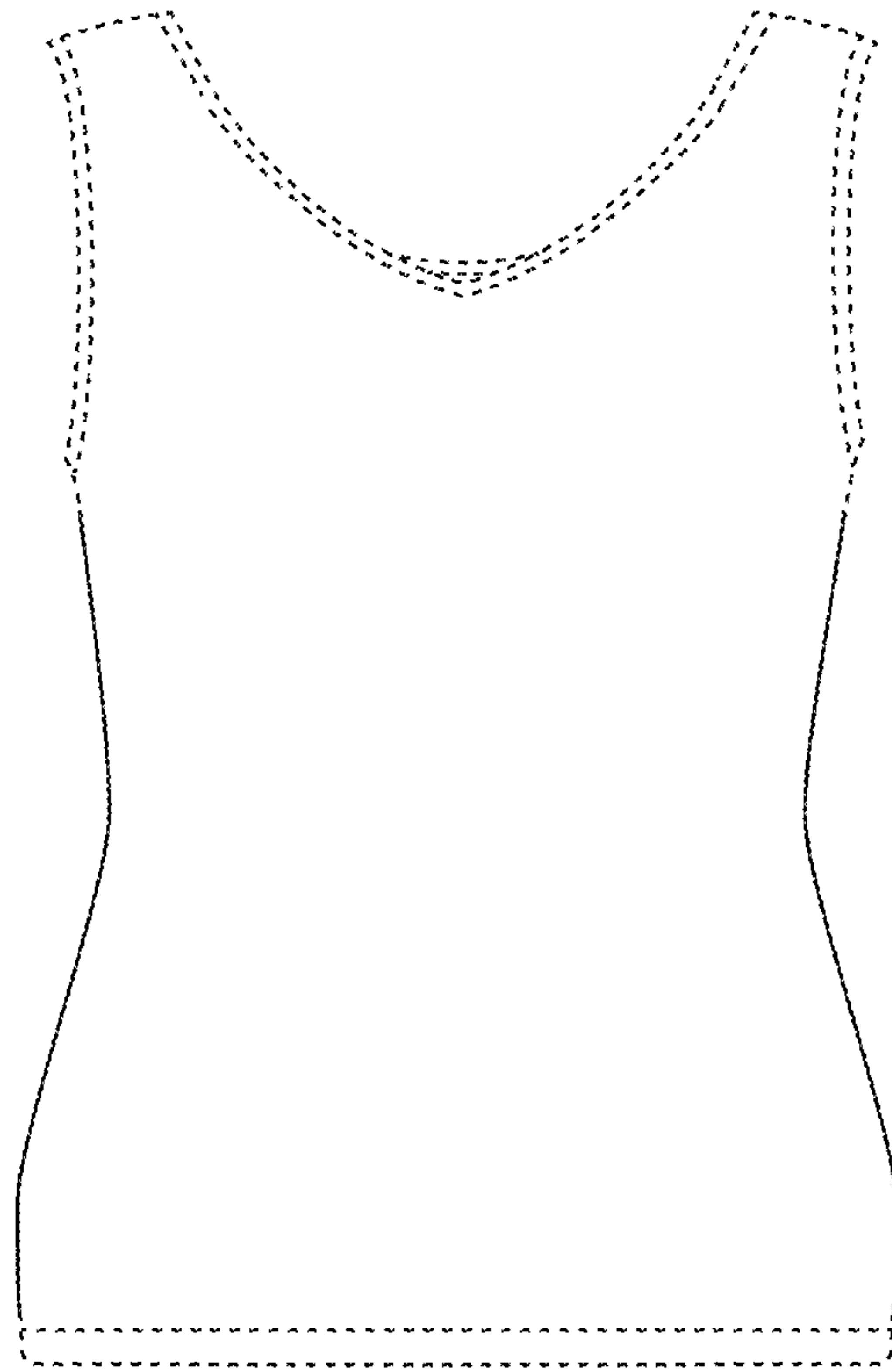

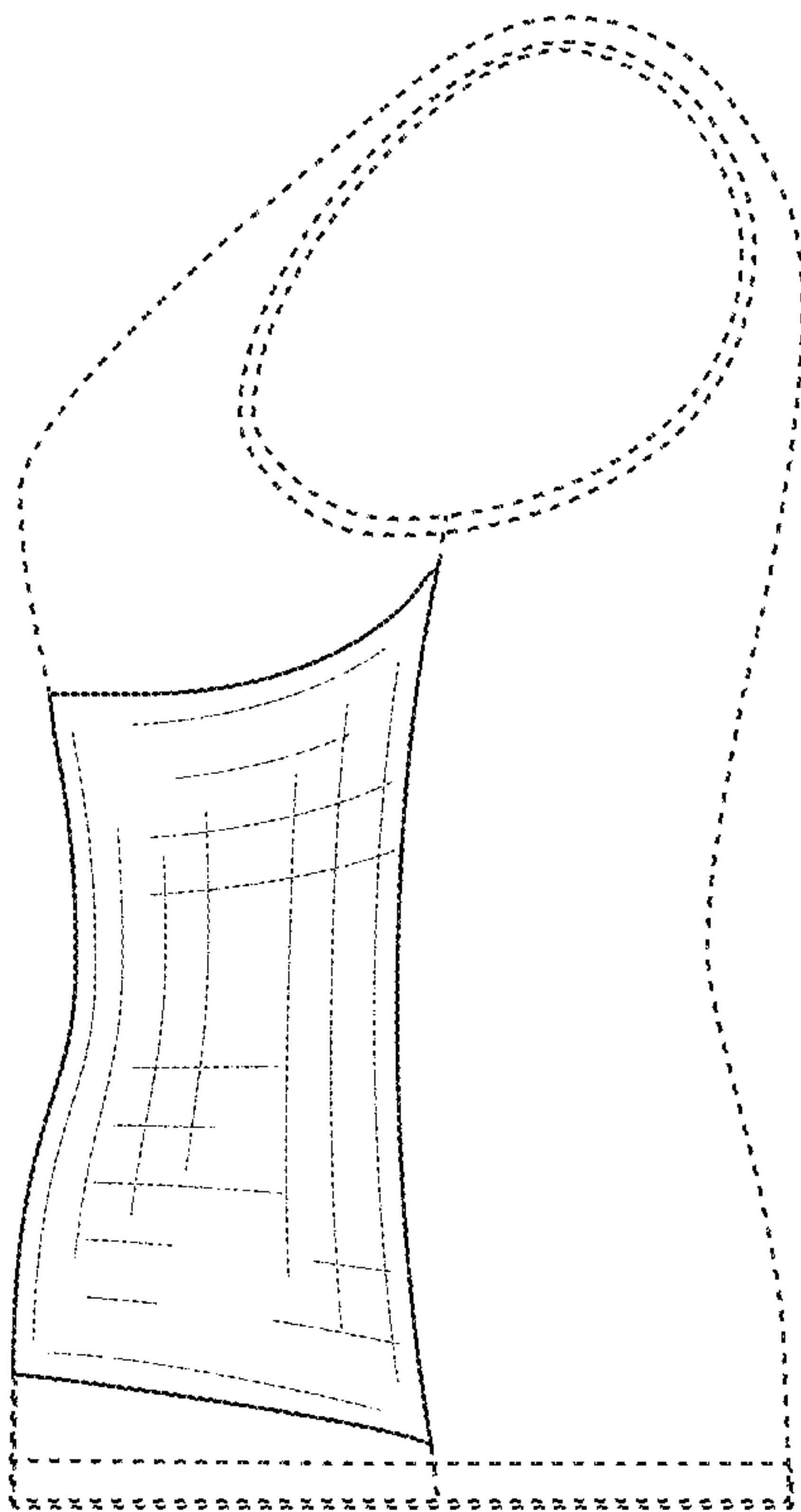

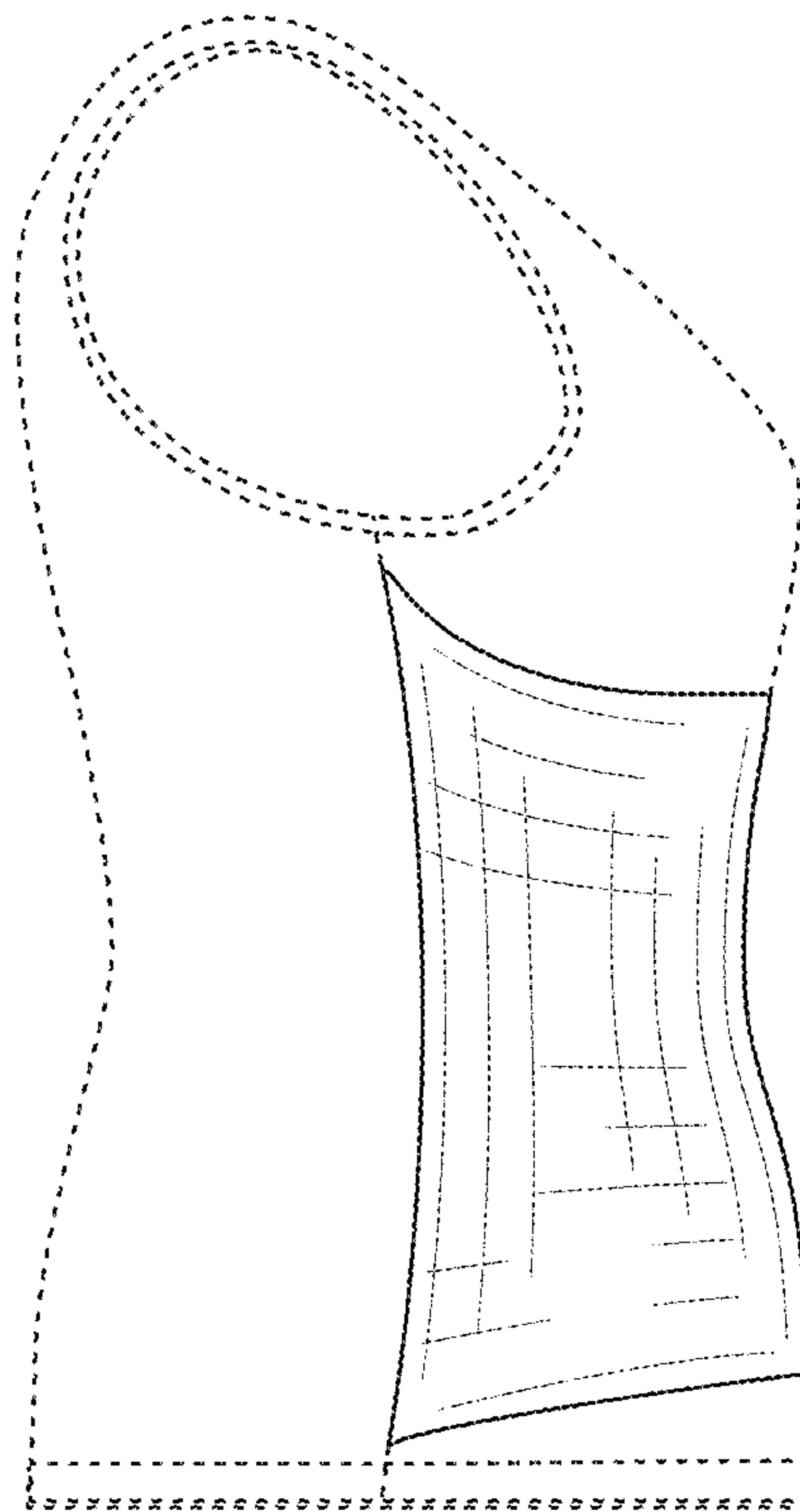

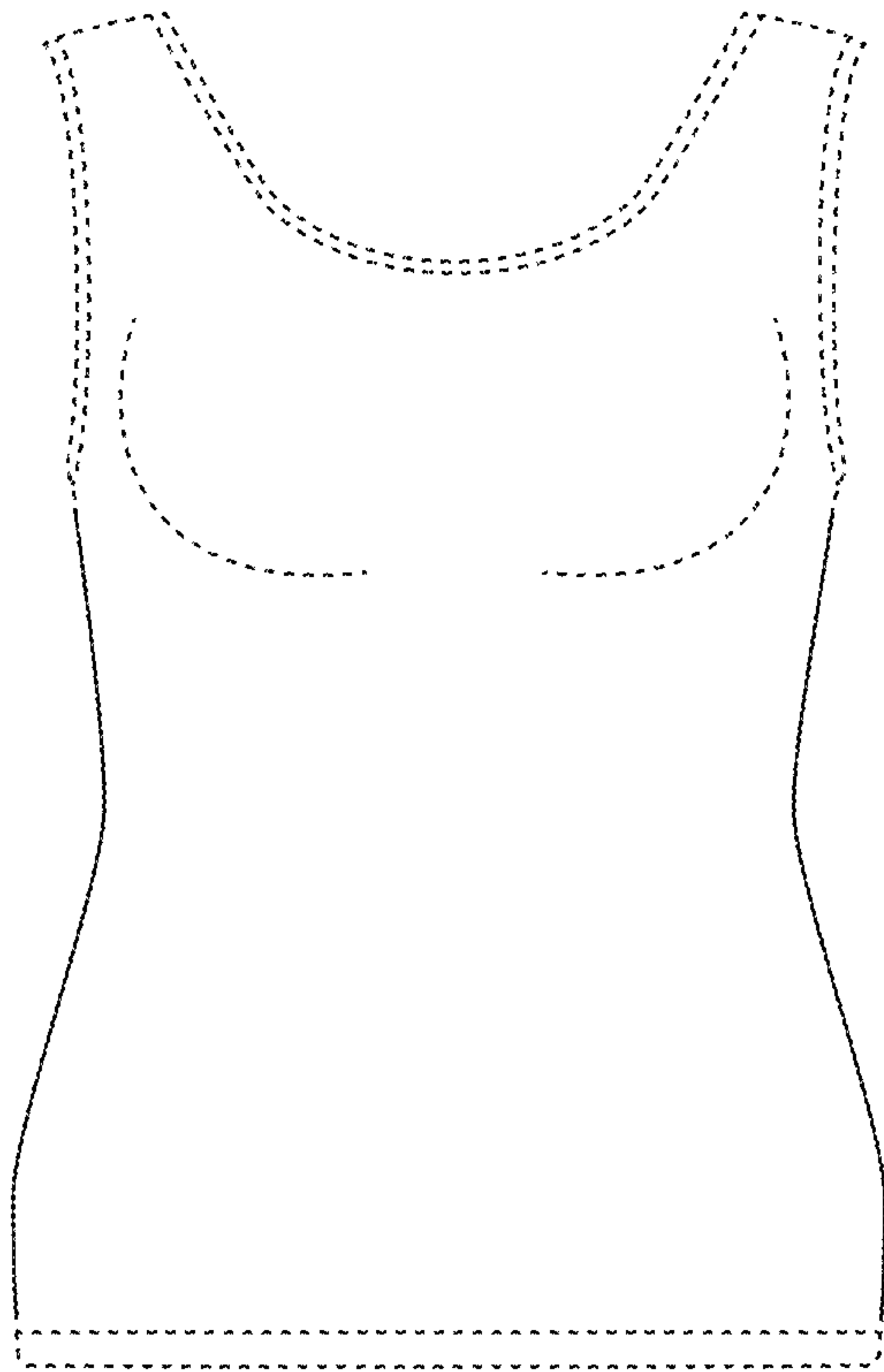

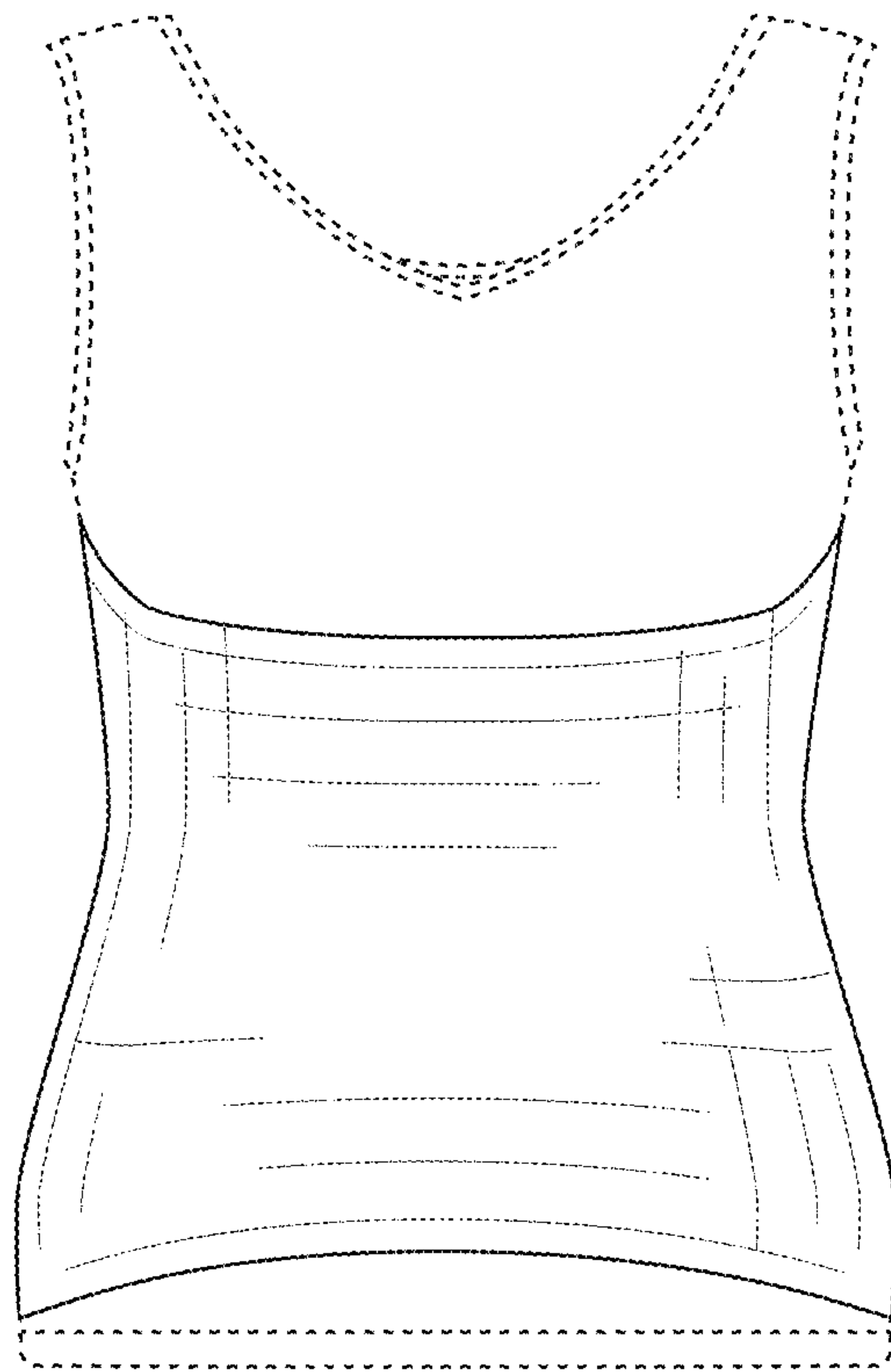

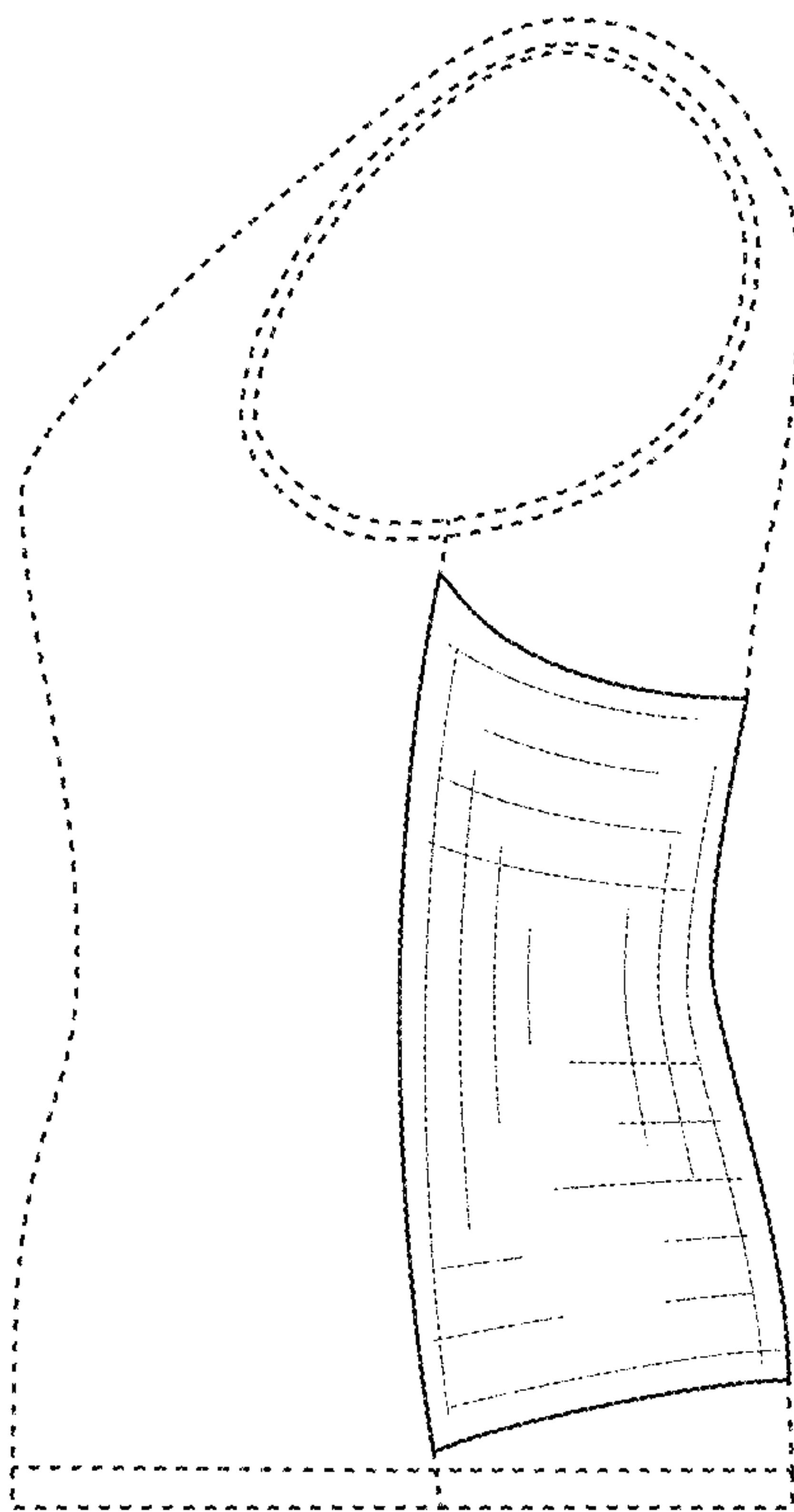

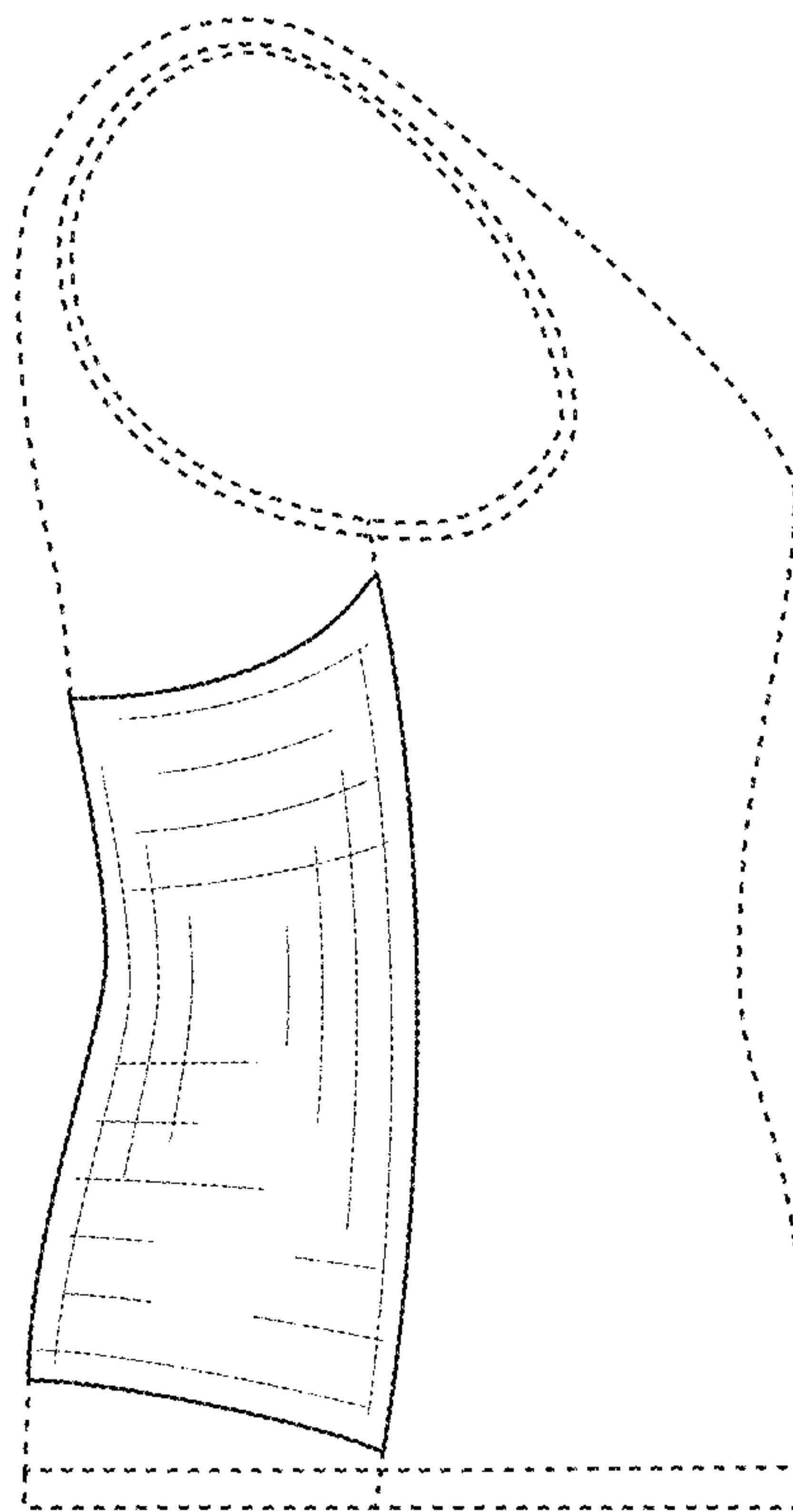

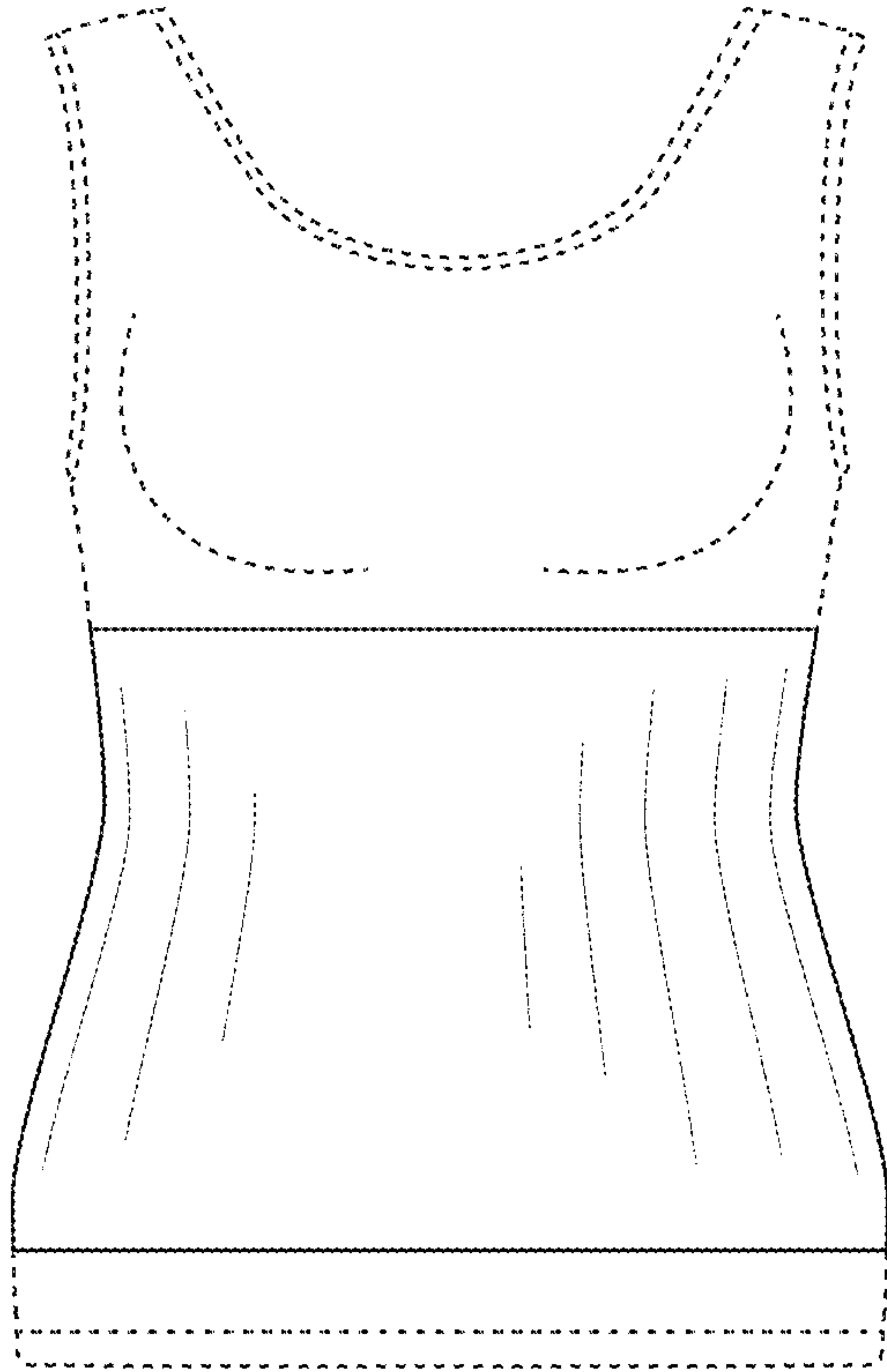

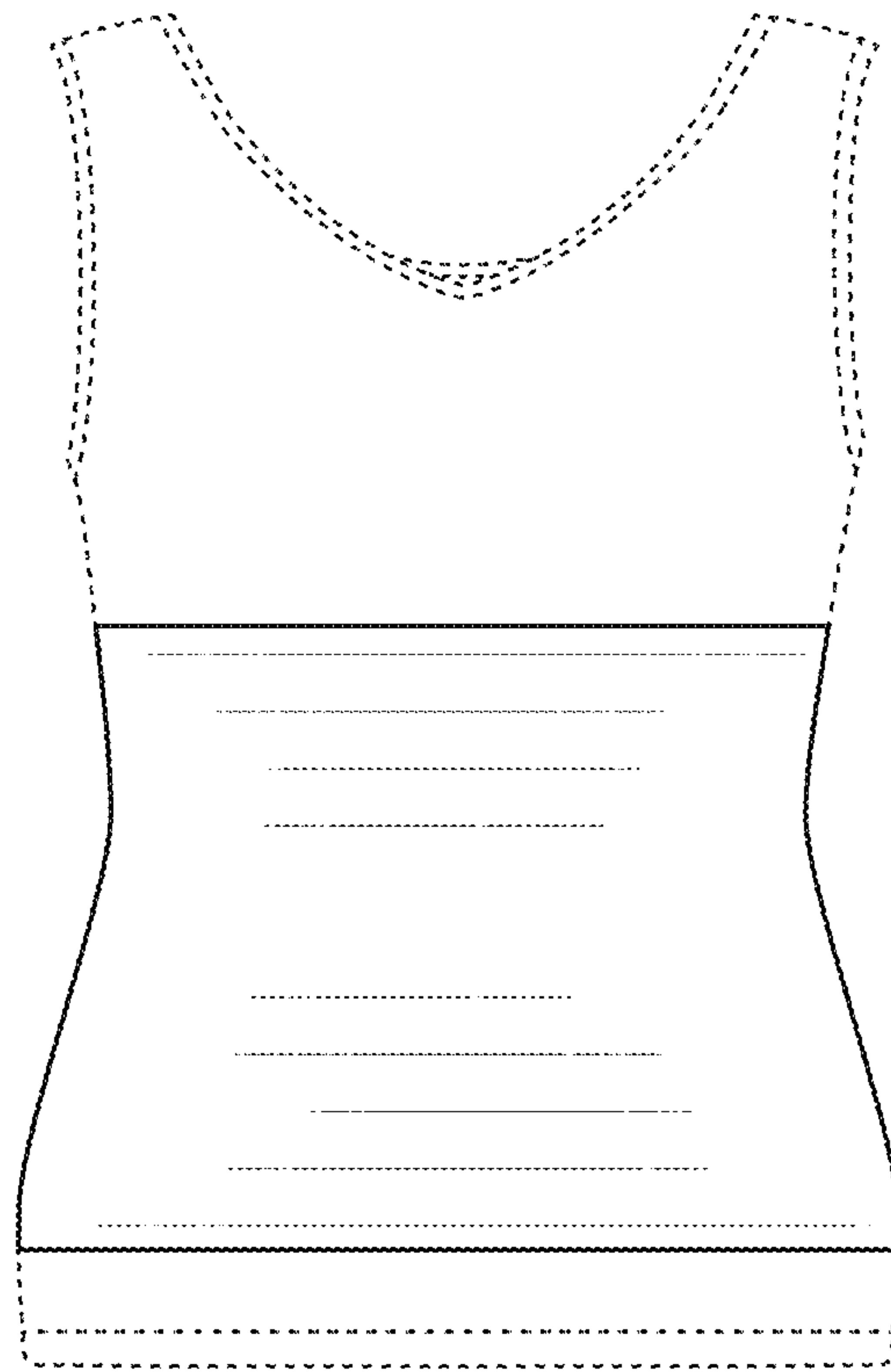

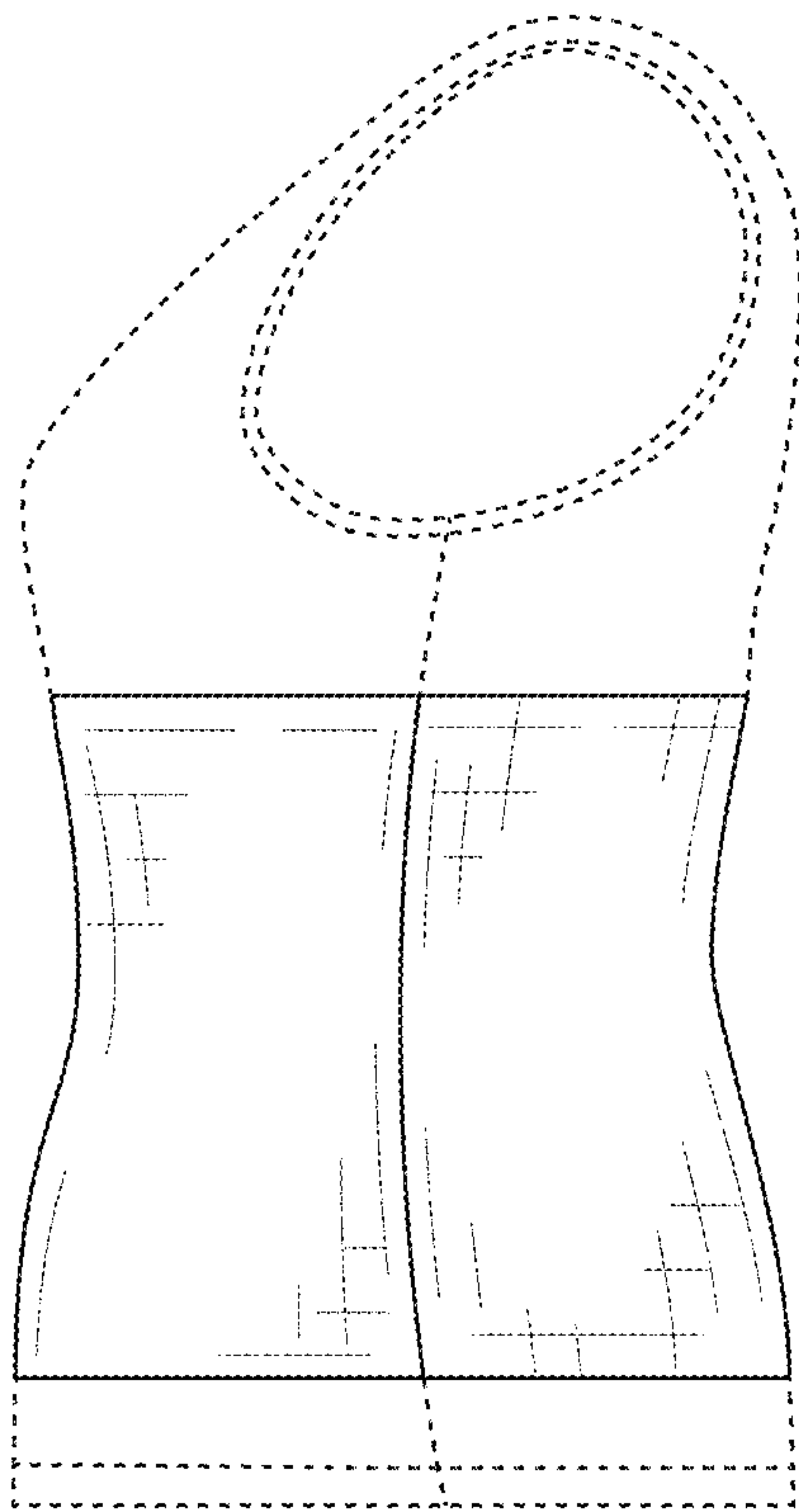

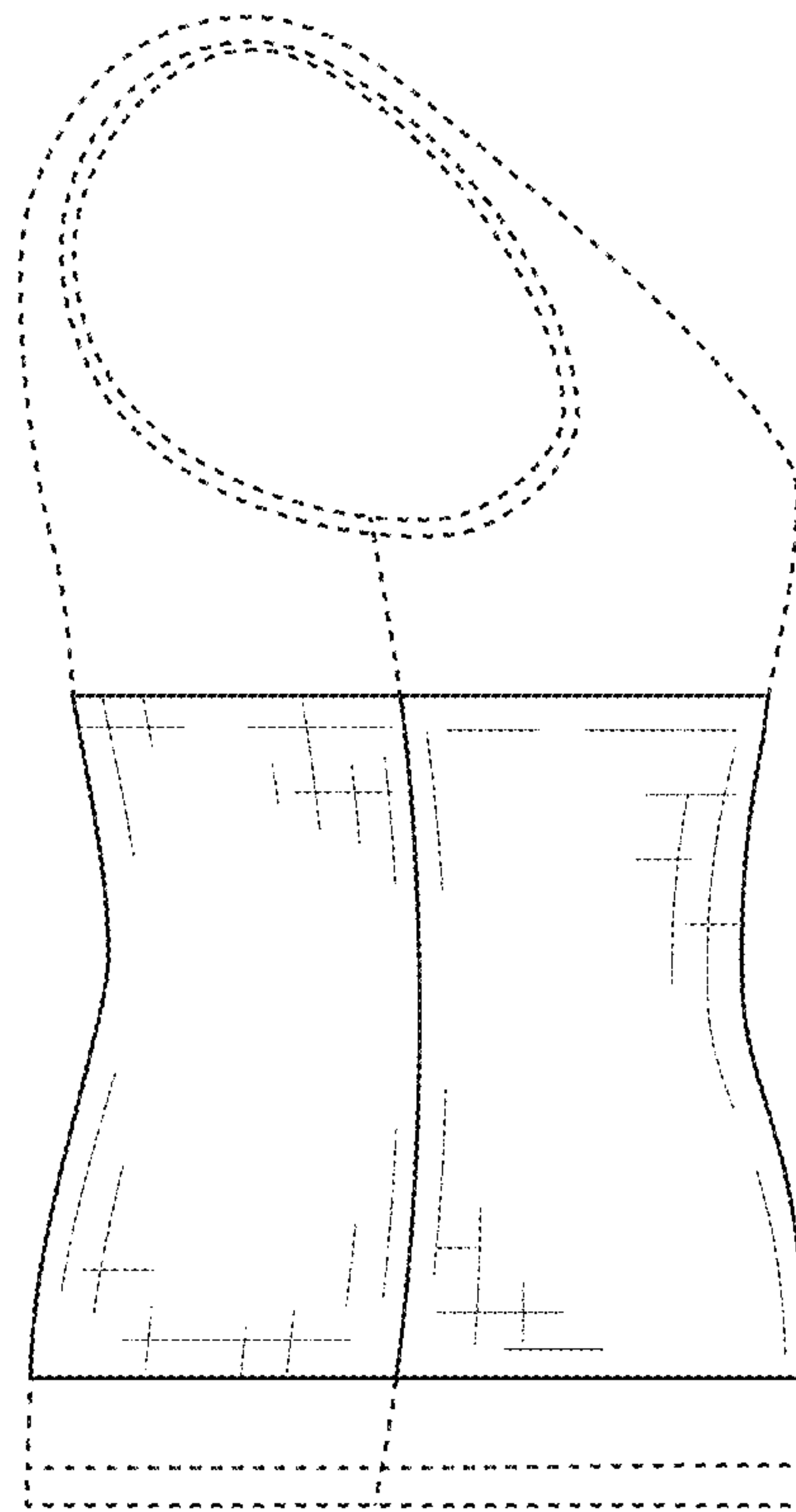

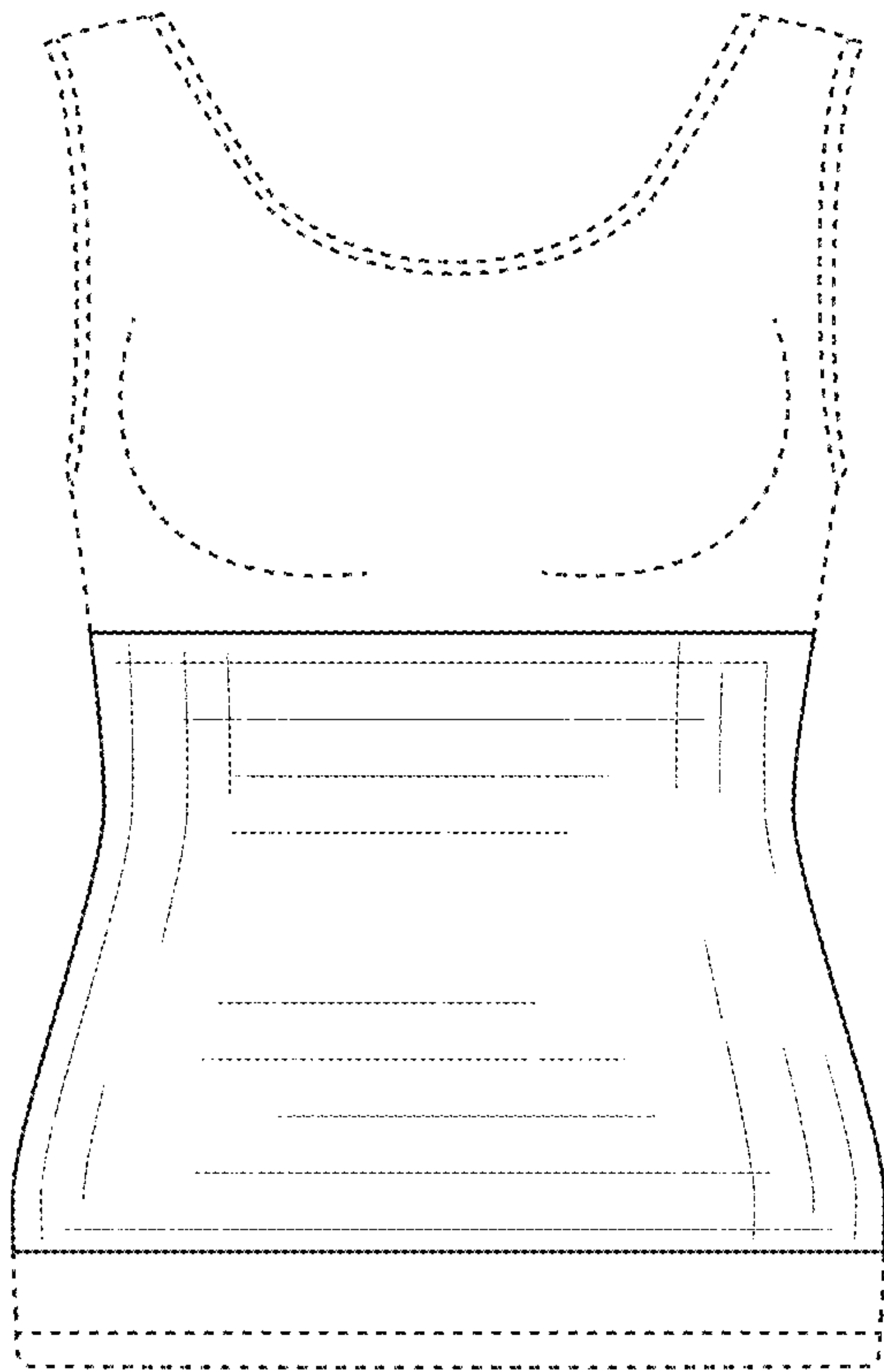

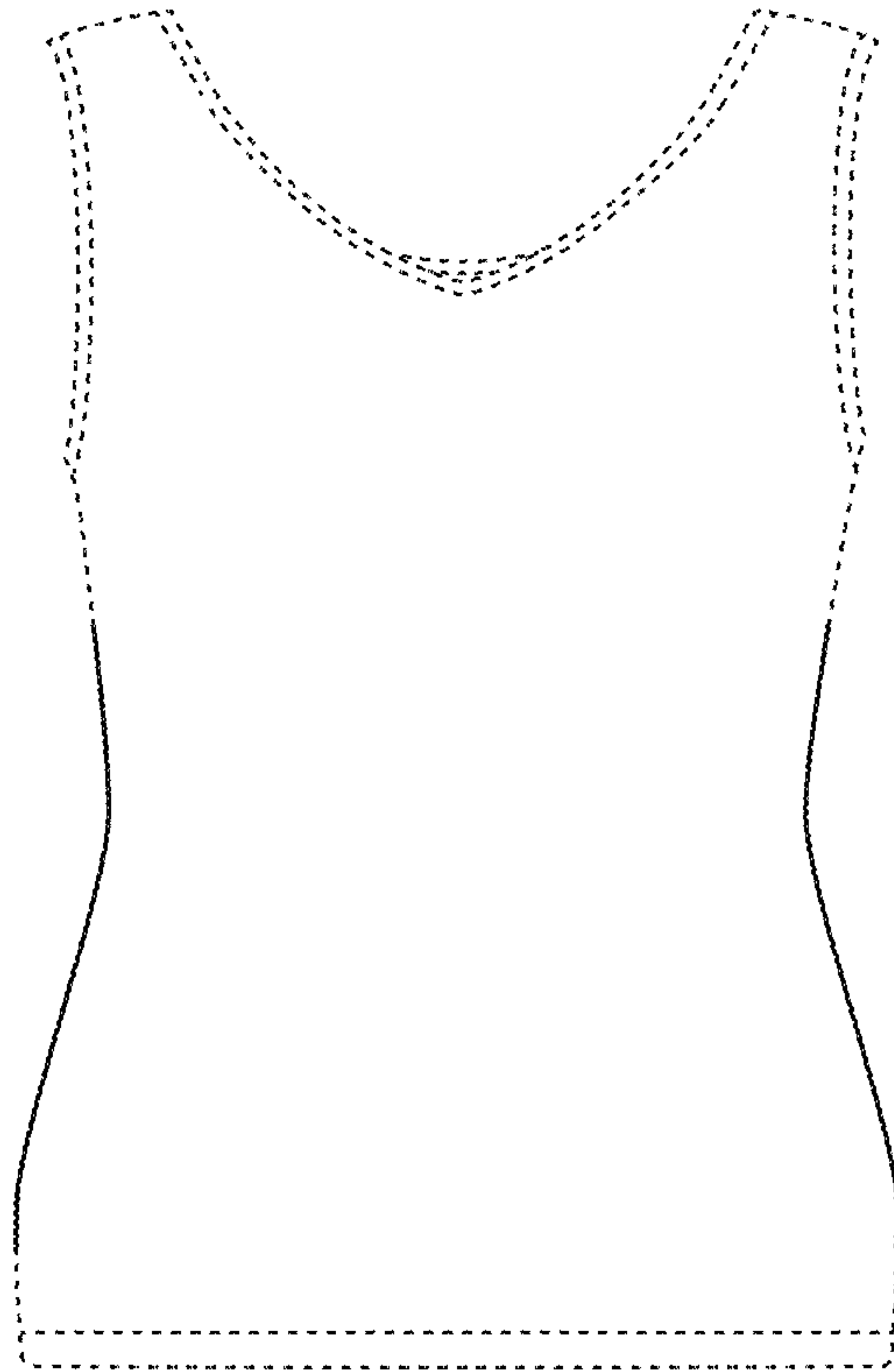

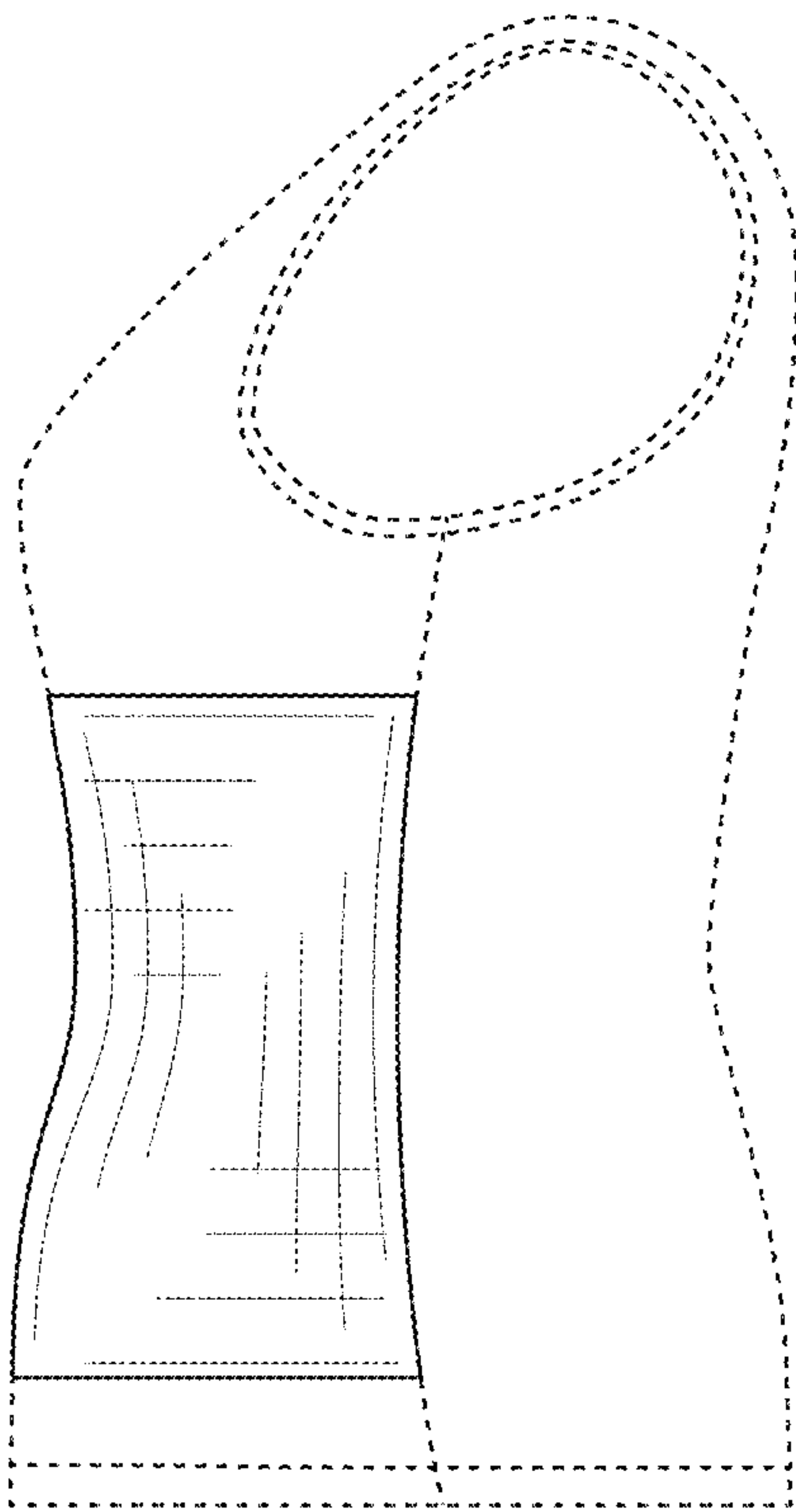

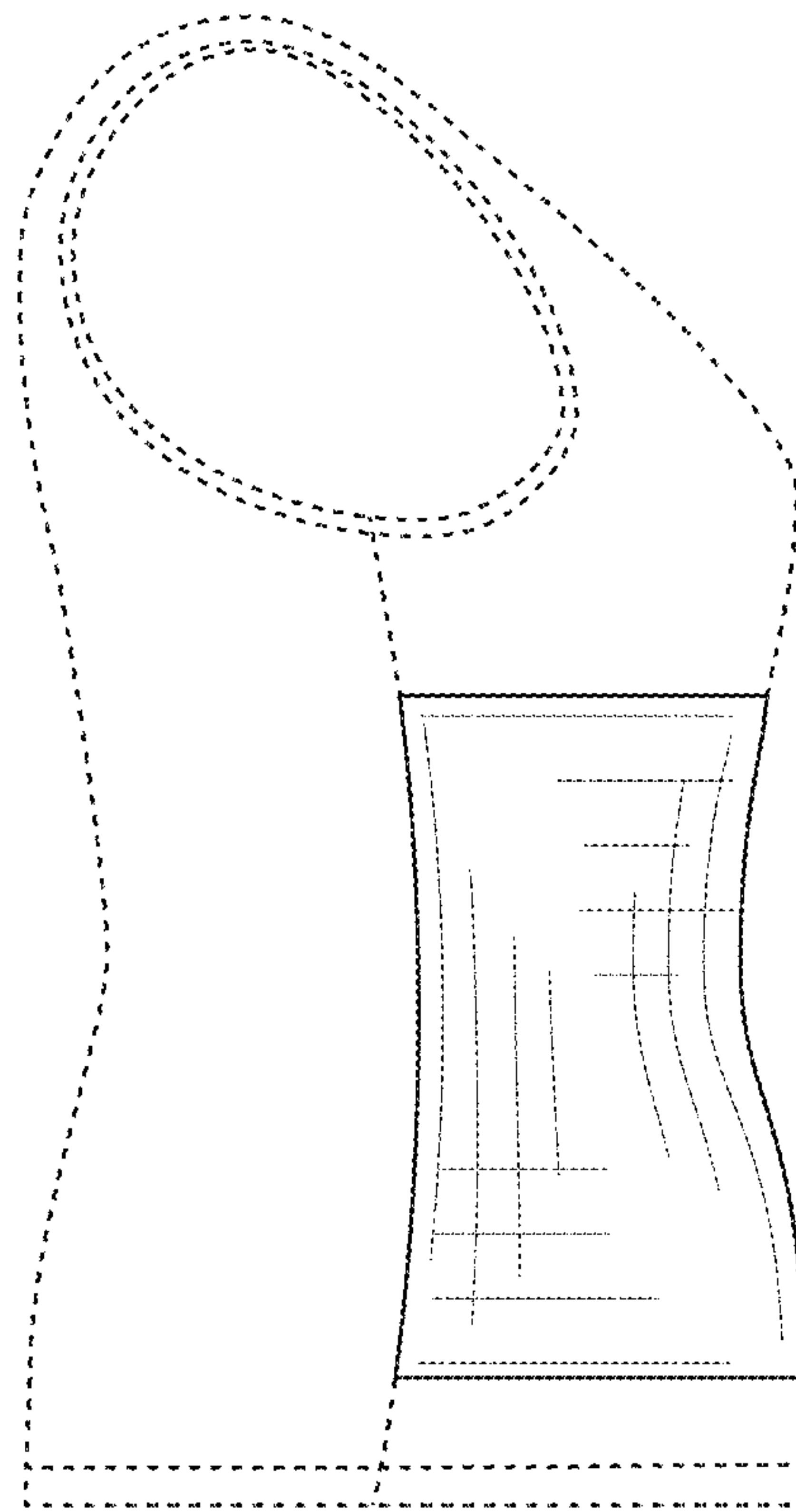

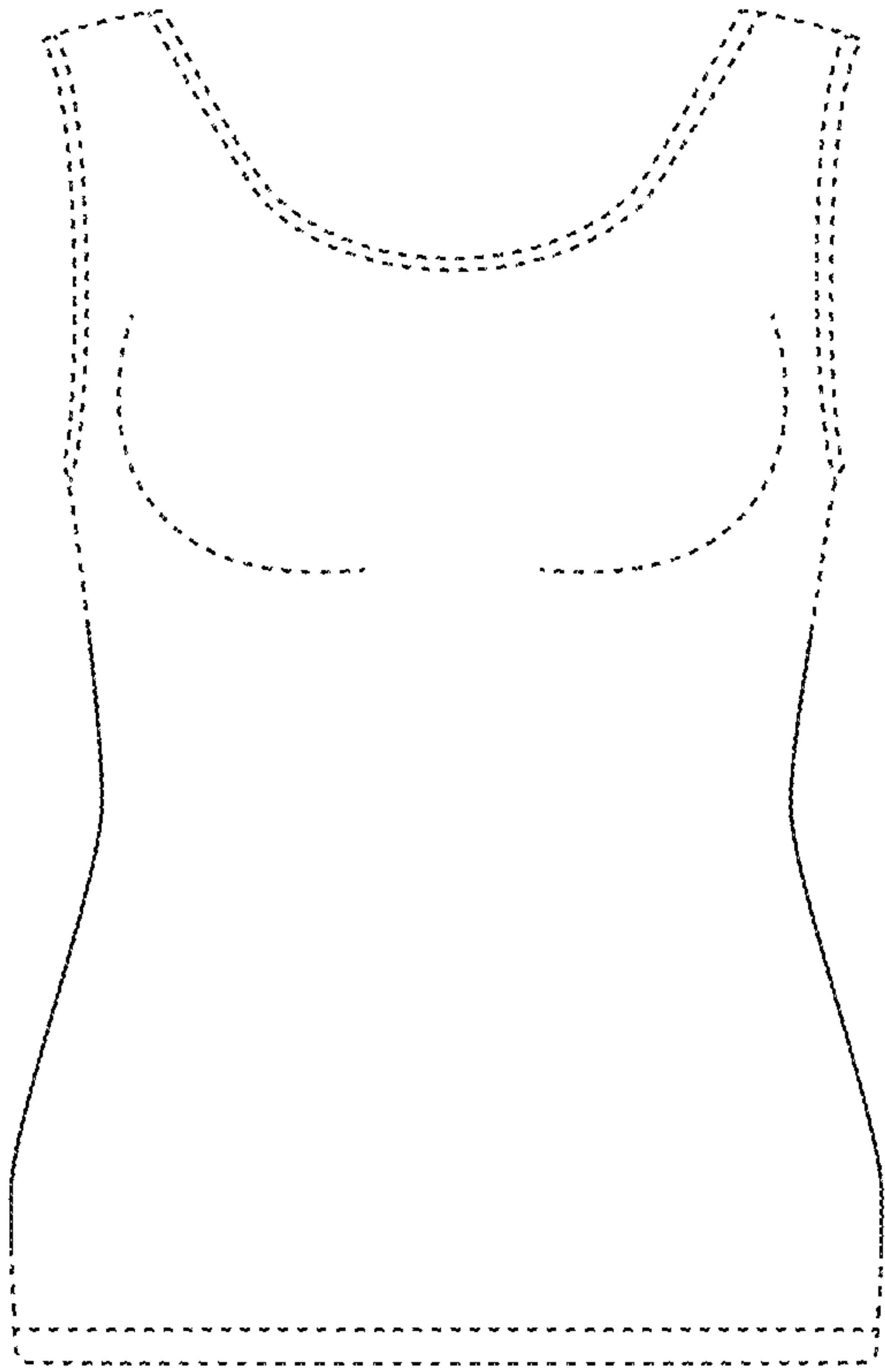

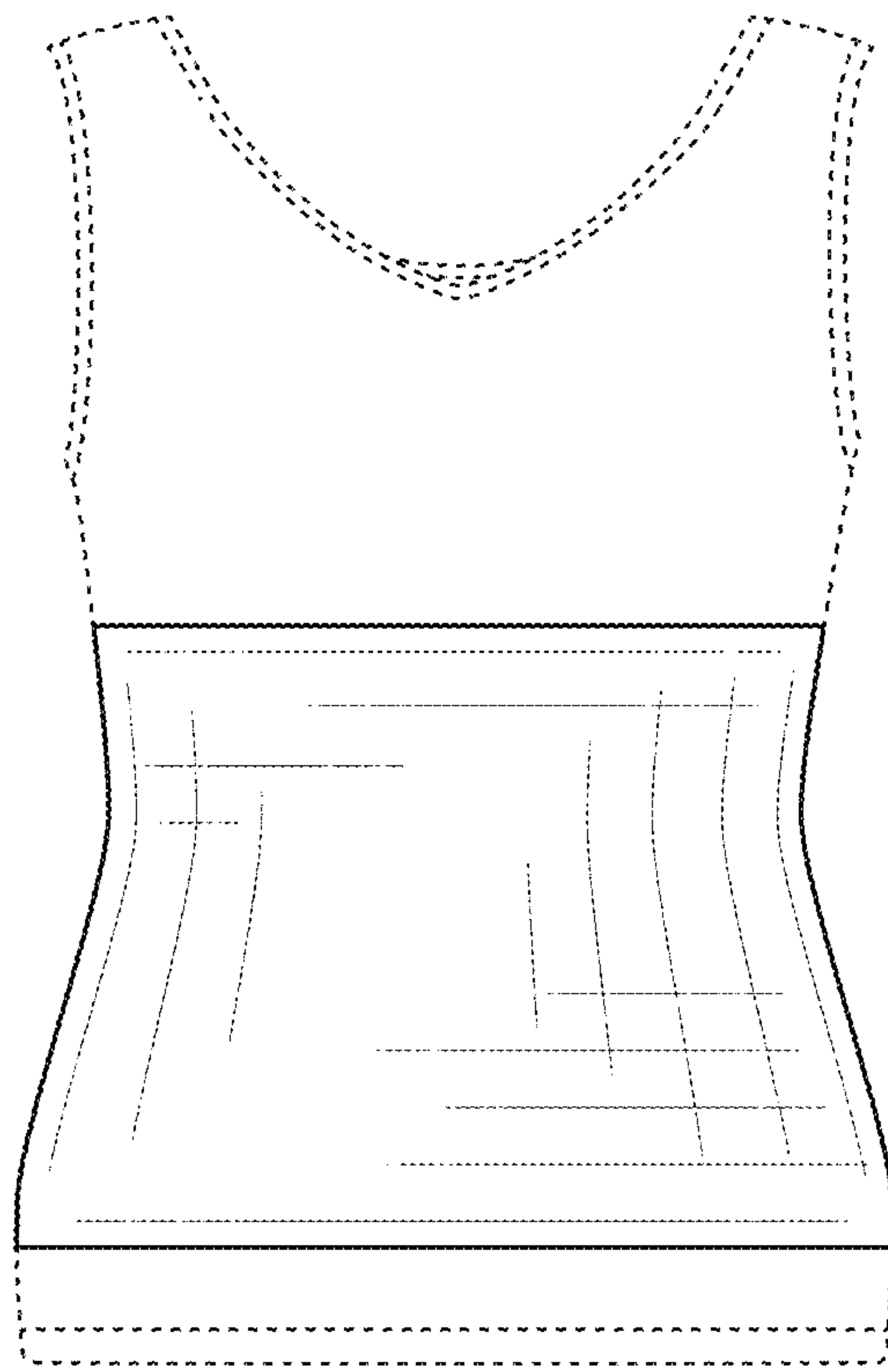

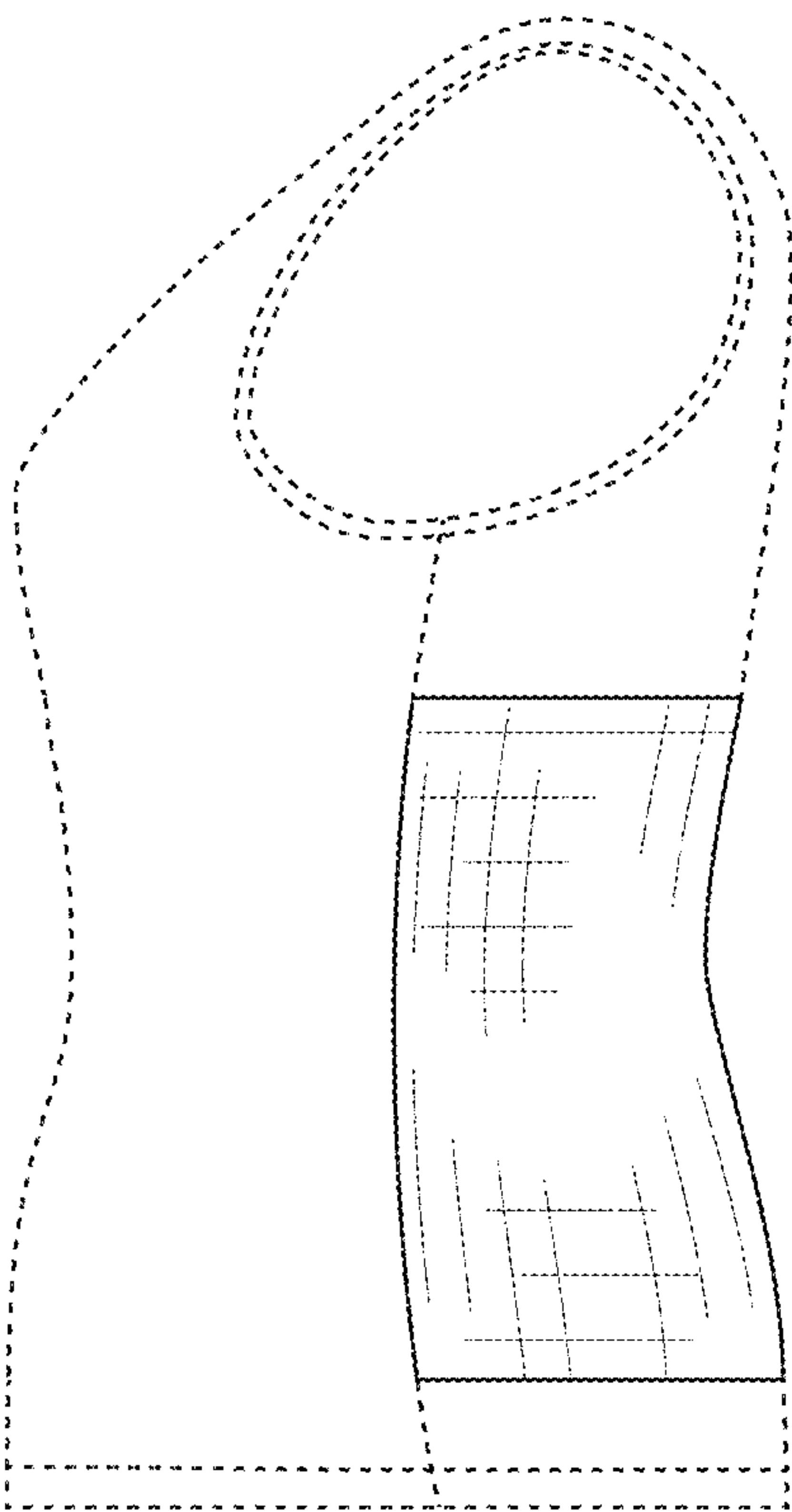

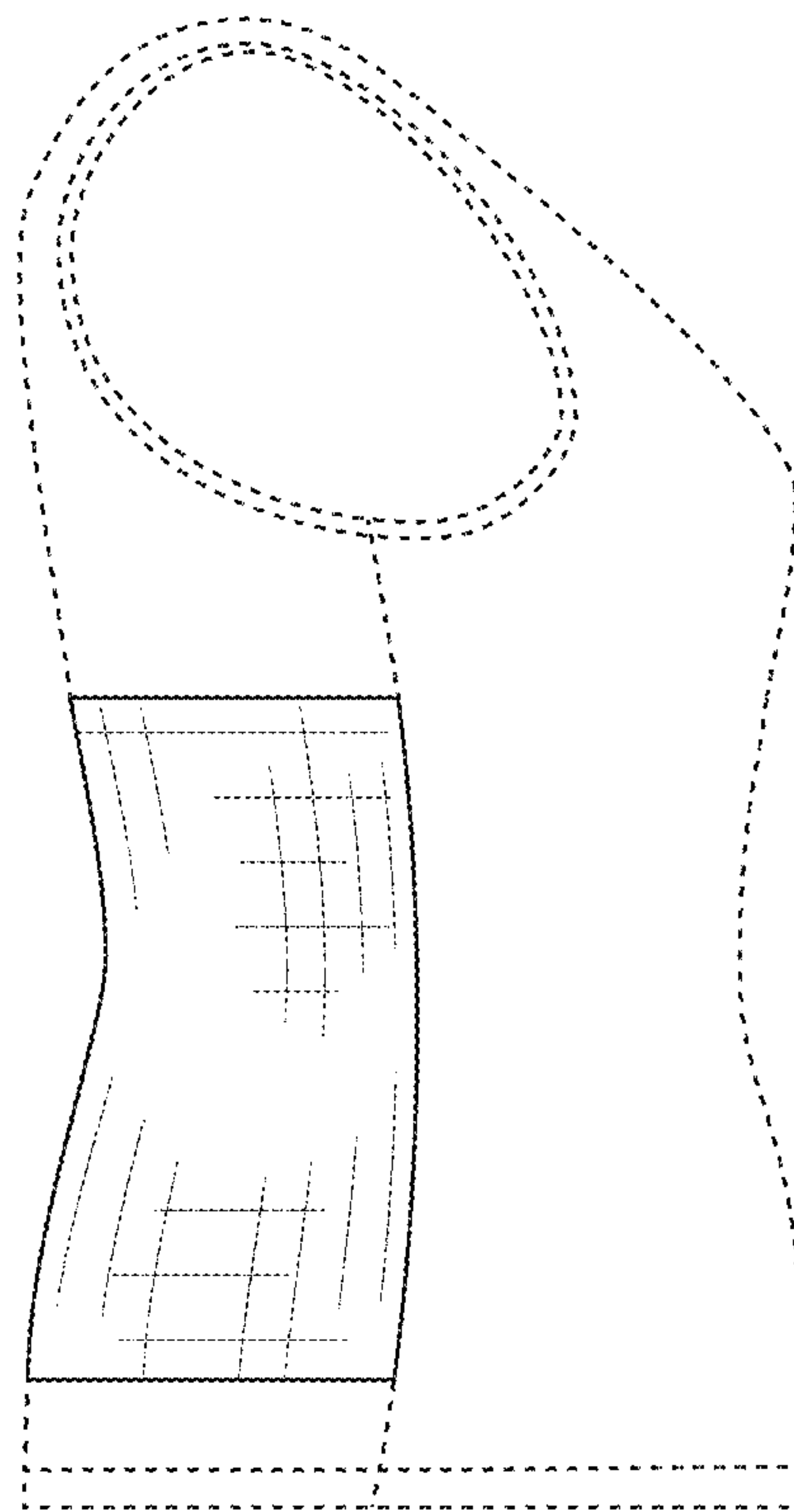
