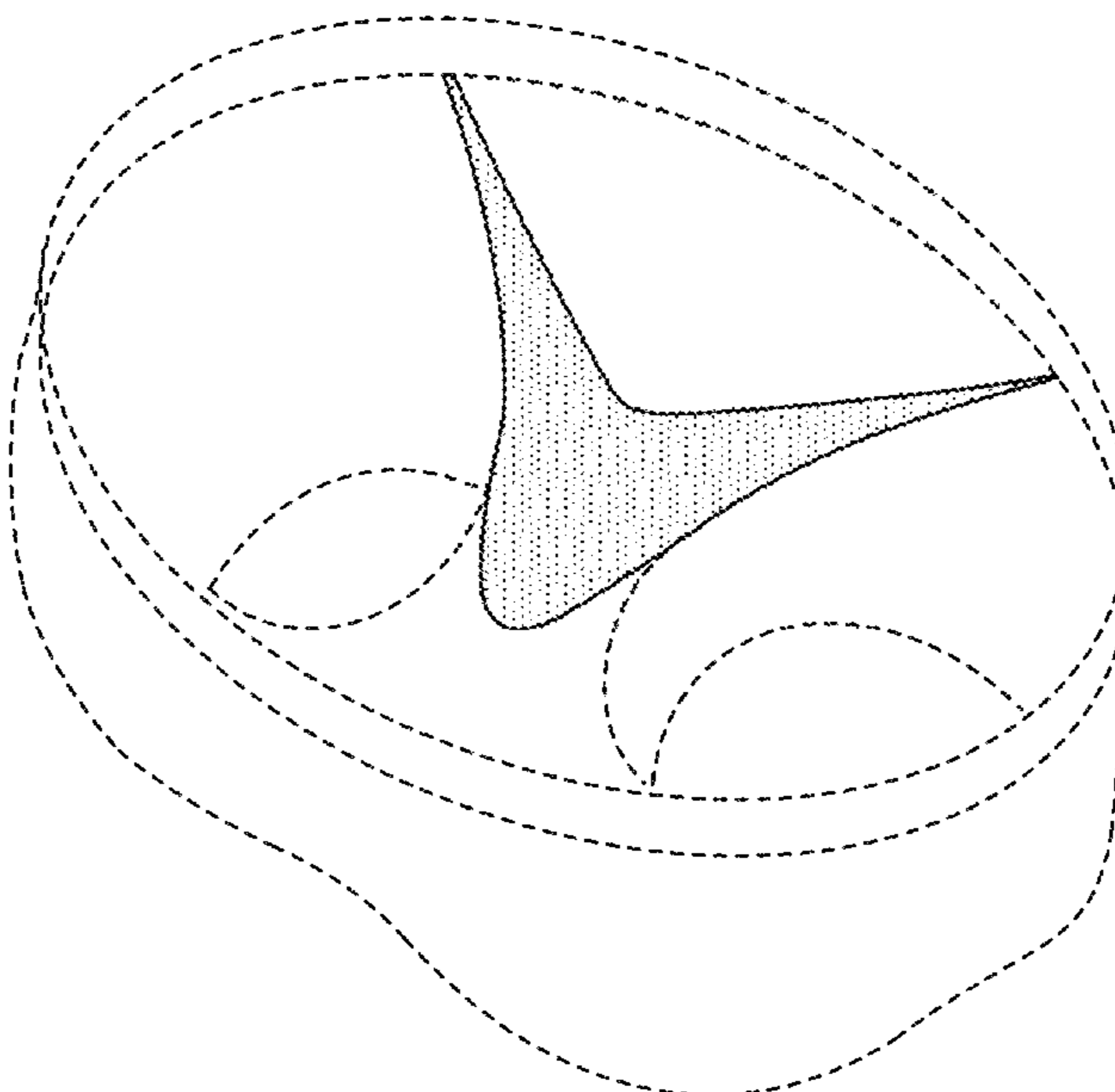
(57) **CLAIM**

The ornamental design for an interior sling for a man's brief, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an interior sling for a man's brief;  
FIG. 2 is front view of an interior sling for a man's brief;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a top plan view of an interior sling for a man's brief; and,  
FIG. 7 is a bottom view thereof.

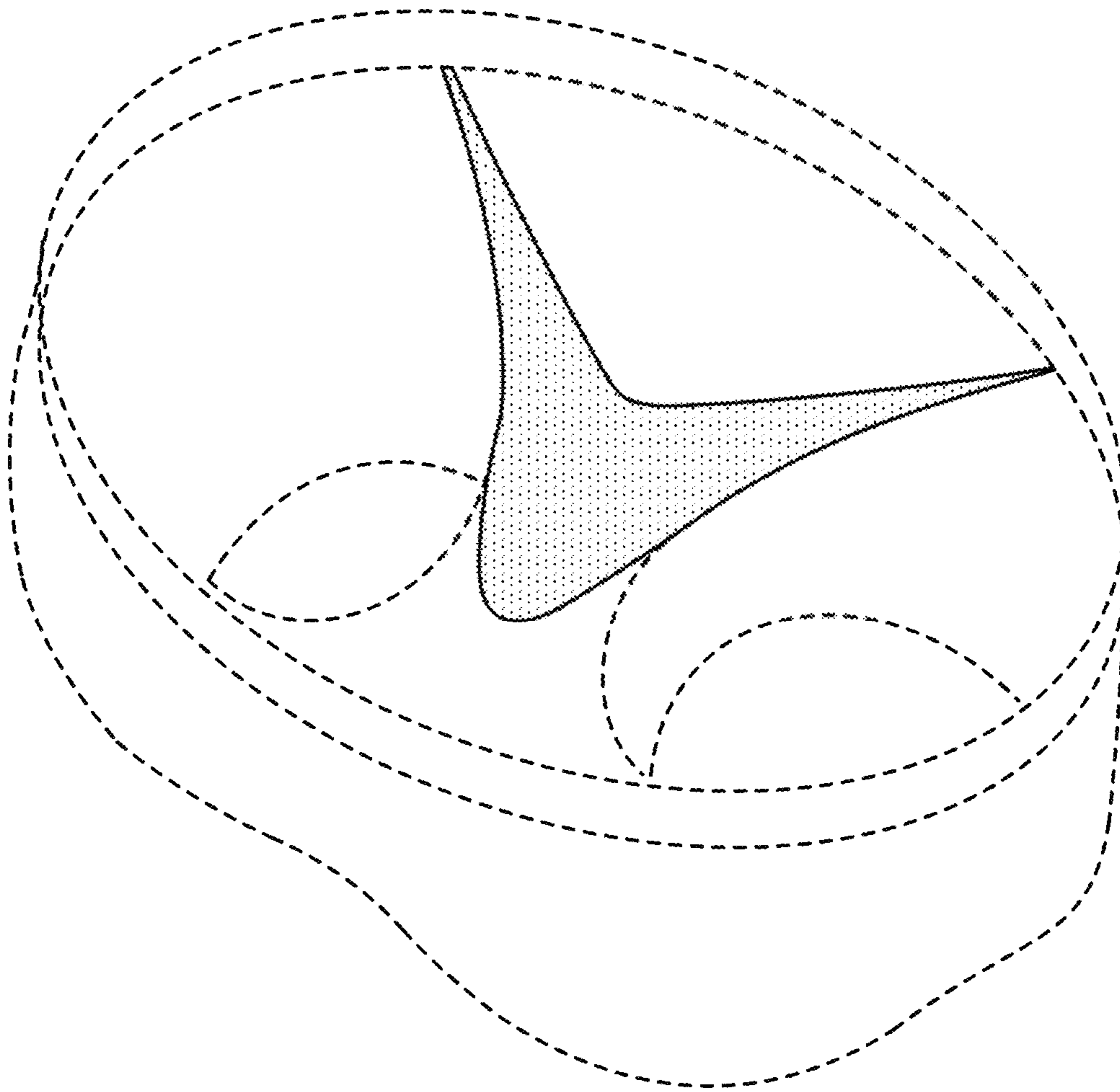

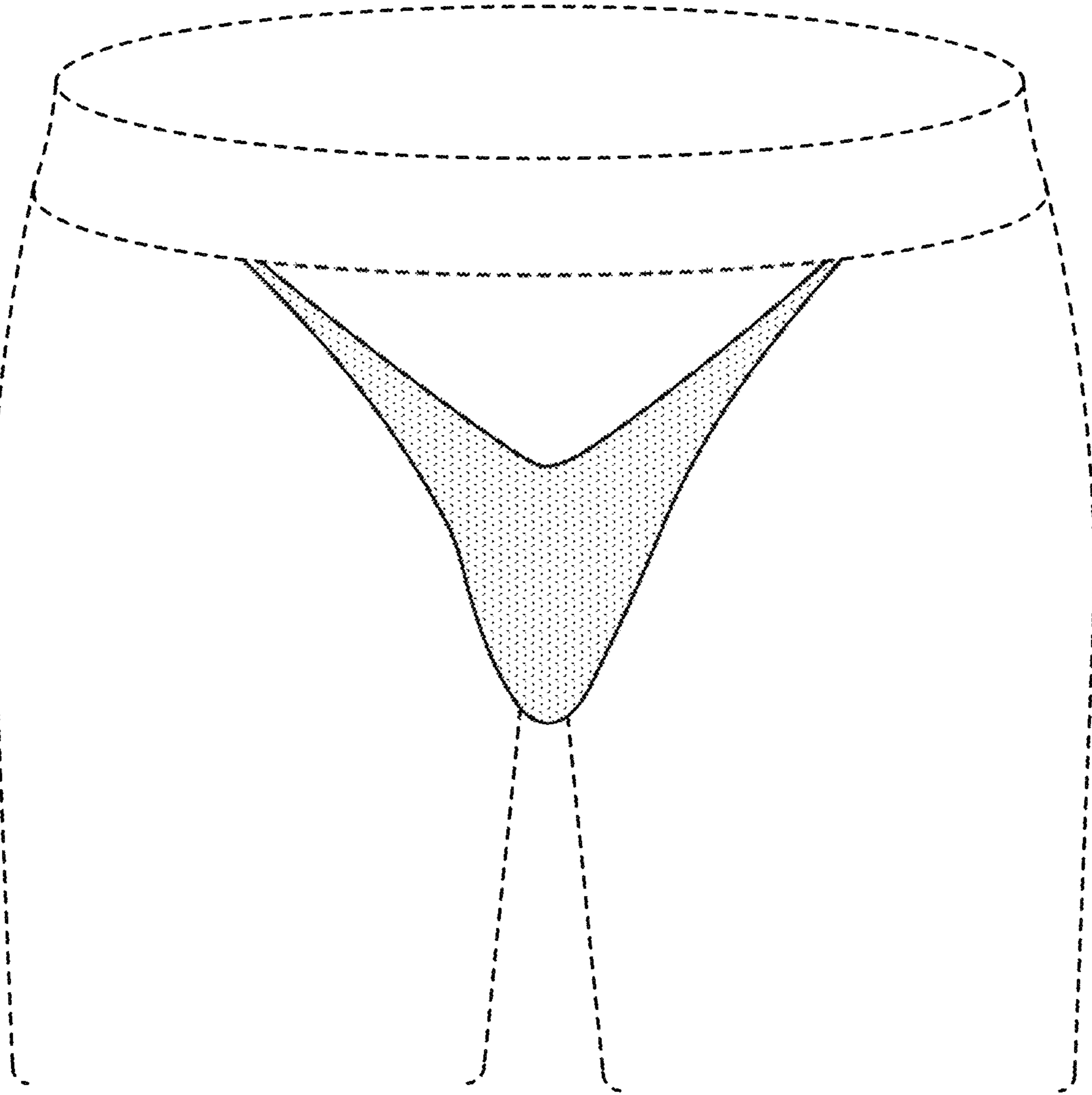

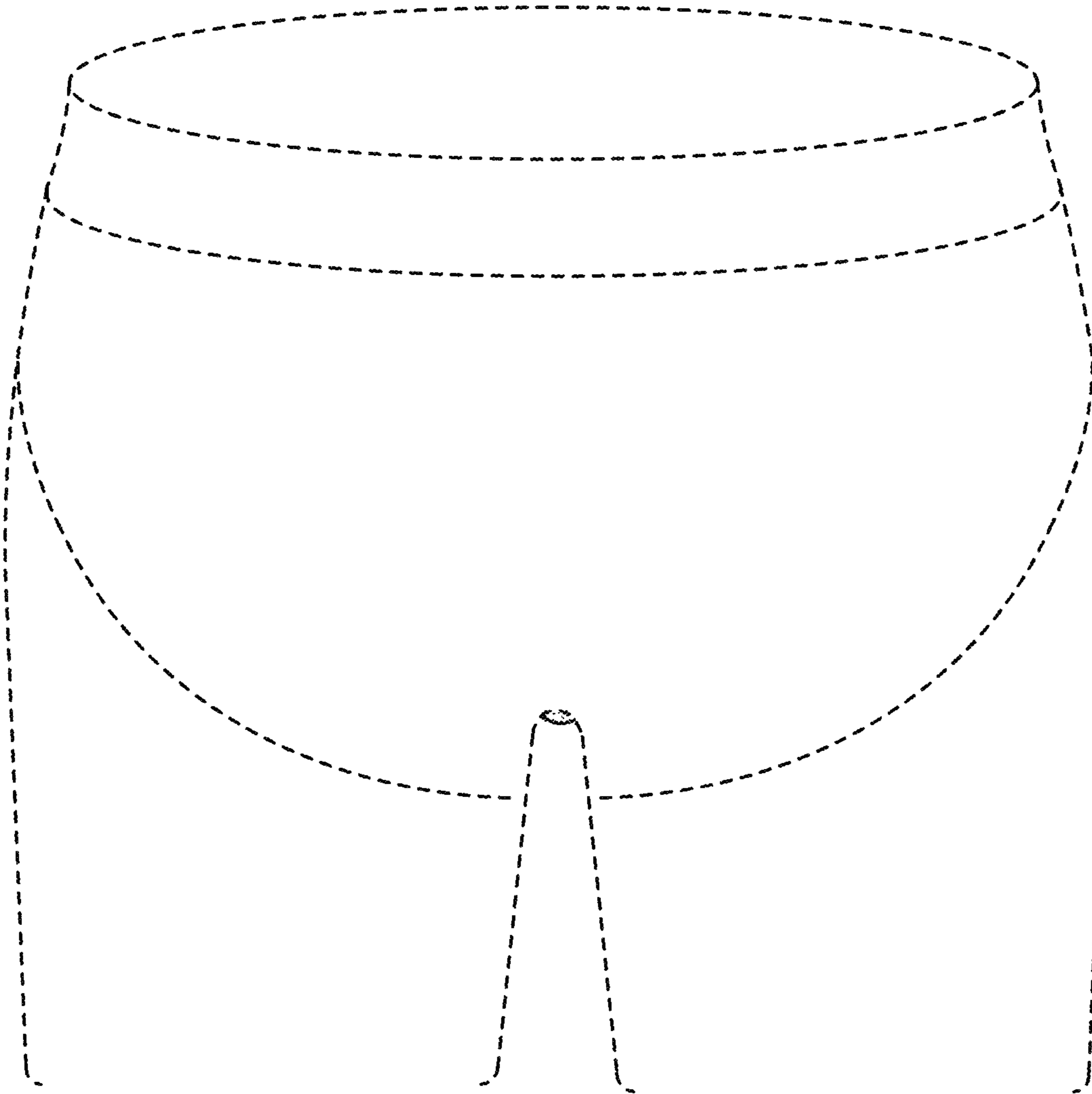

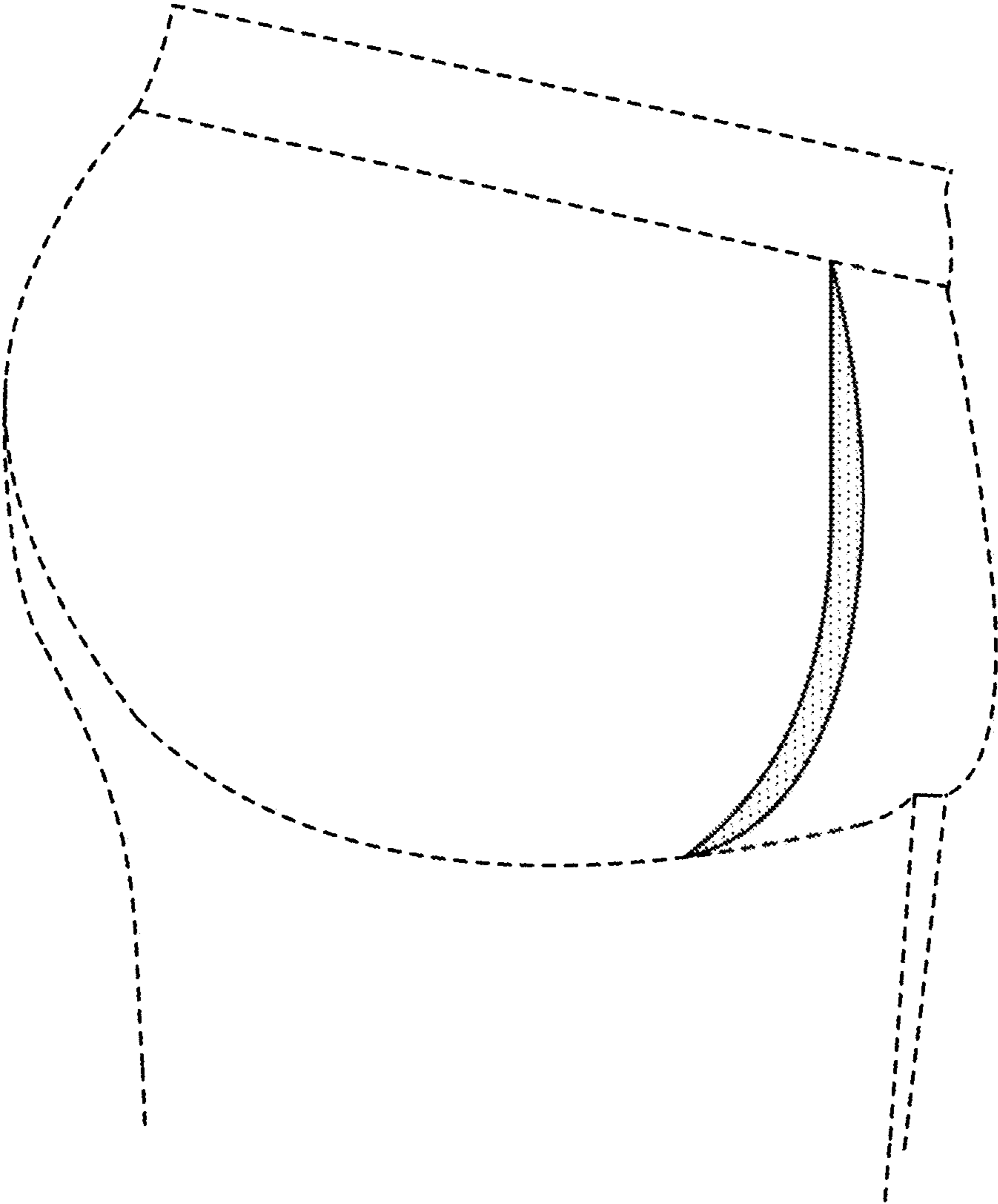

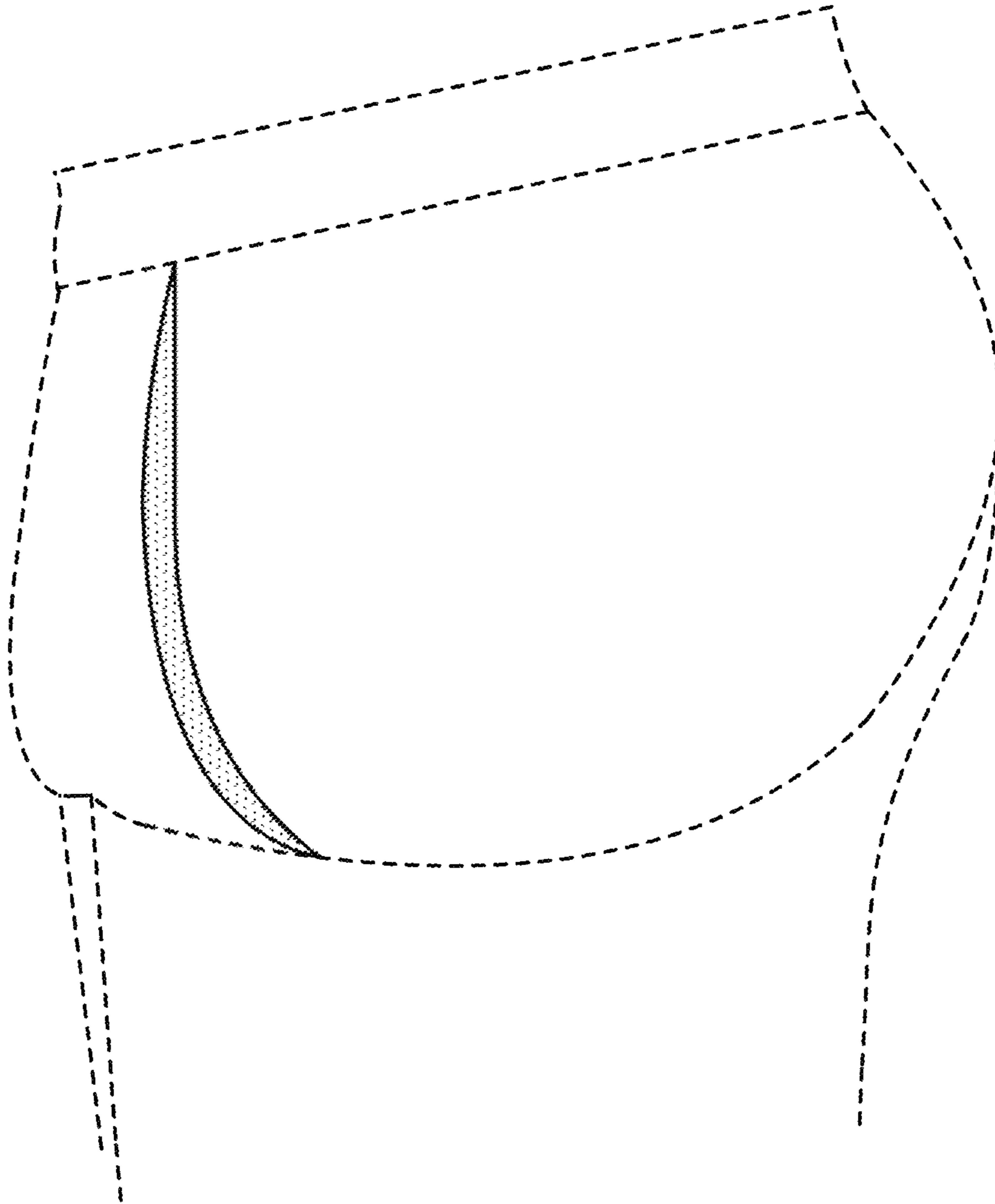

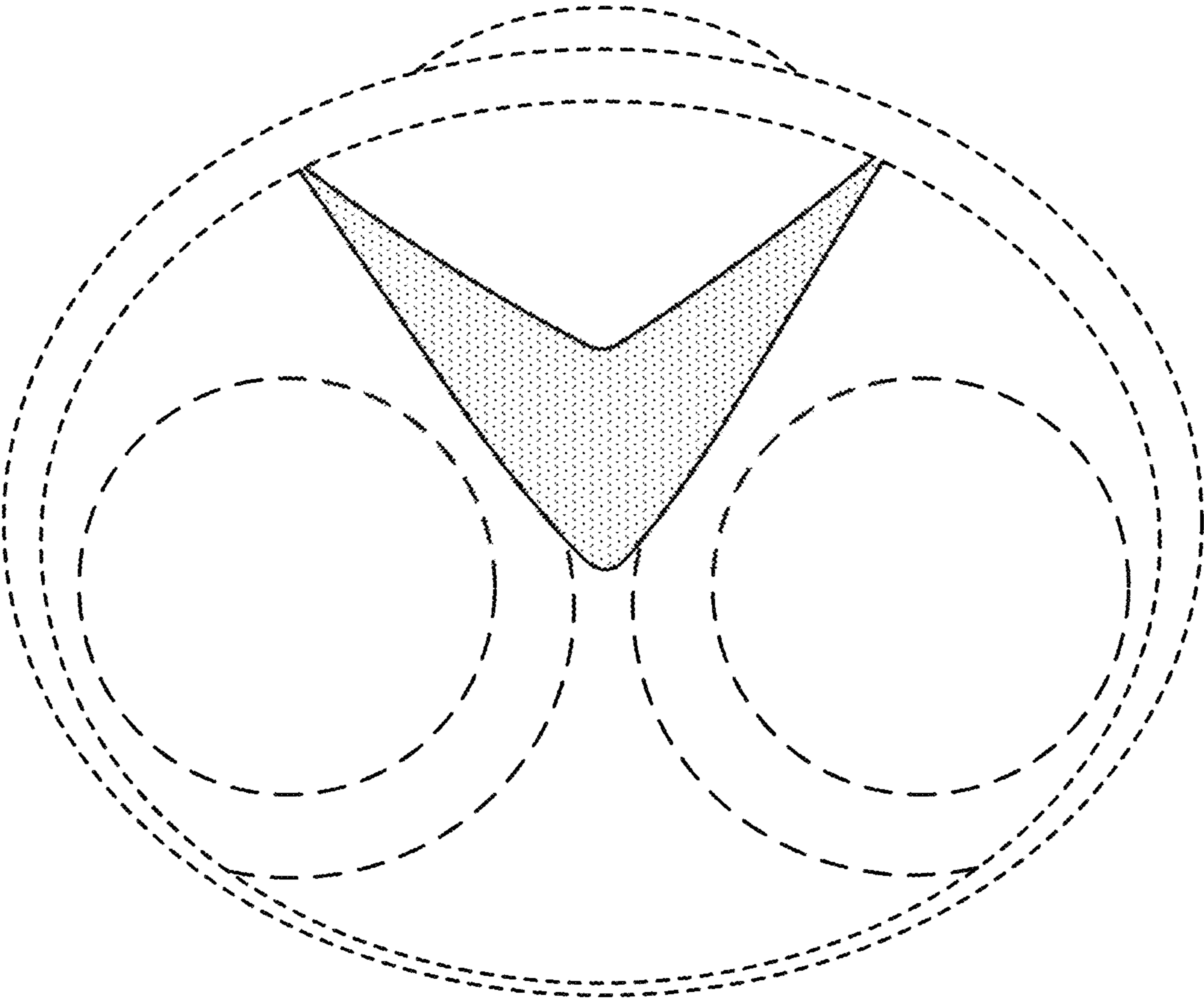

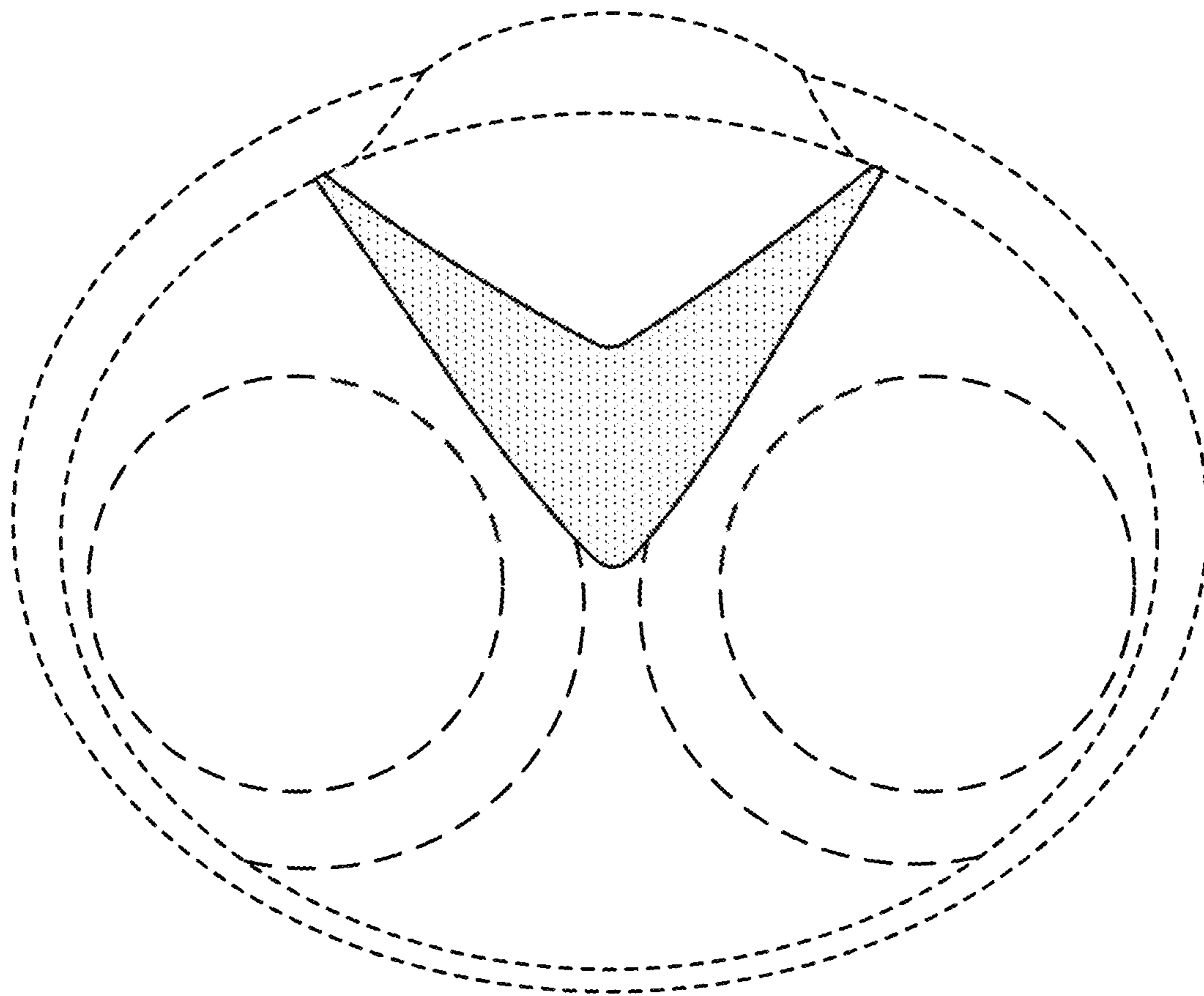
