(57) **CLAIM**

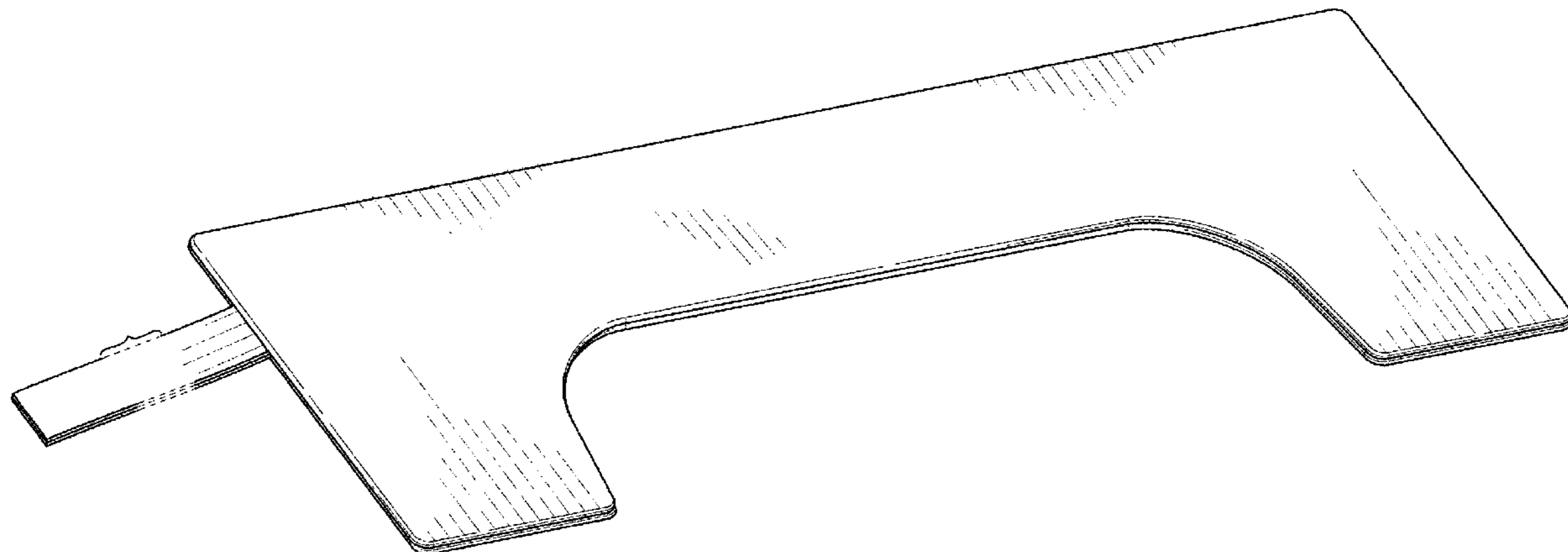
We claim the ornamental design for a shoulder and lap burp pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoulder and lap burp pad, showing our new design in a flat configuration; FIG. 2 is a top platy view of FIG. 1, the bottom plan view being a mirror image thereof; FIG. 3 is a right-side elevational view of FIG. 1; FIG. 4 is a left-side elevational view of FIG. 1; FIG. 5 is a rear elevational view of FIG. 1; FIG. 6 is a front elevational view of FIG. 1; and, FIG. 7 is a perspective view thereof, illustrated in a rolled and tied configuration. The broken lines showing a portion of the tie strap in FIGS. 1, 2, and 5-7 depict portions of the shoulder and lap burp pad that form no part of the claimed design.

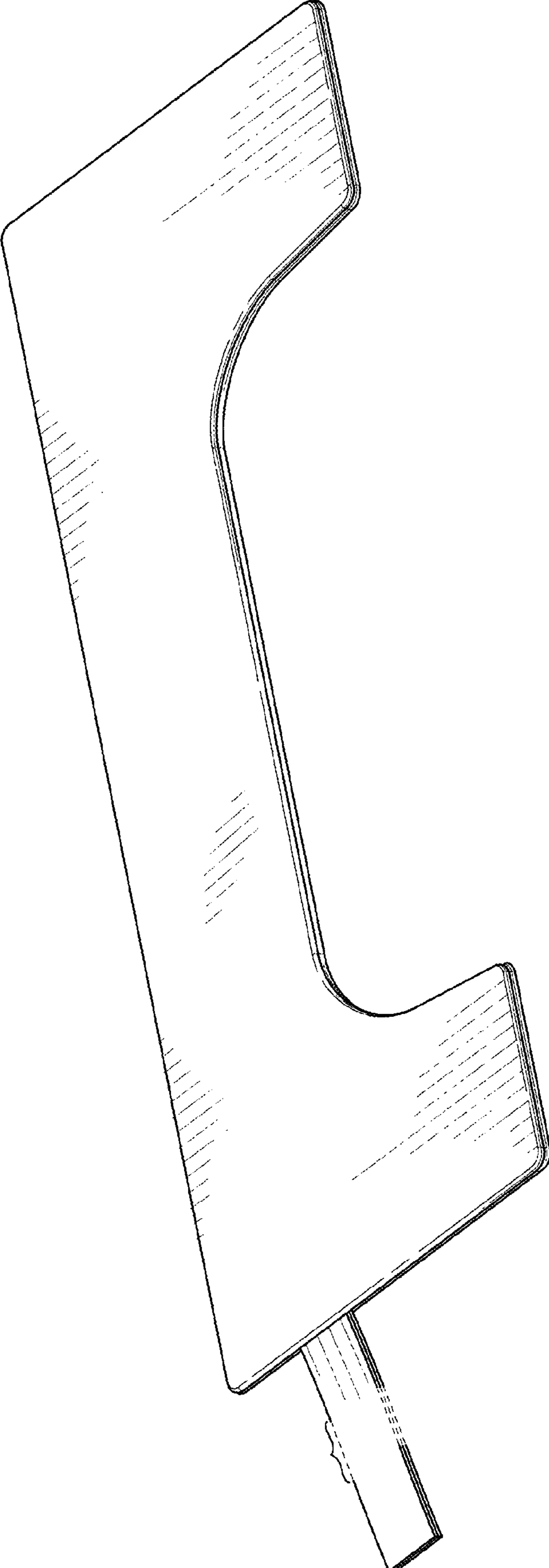

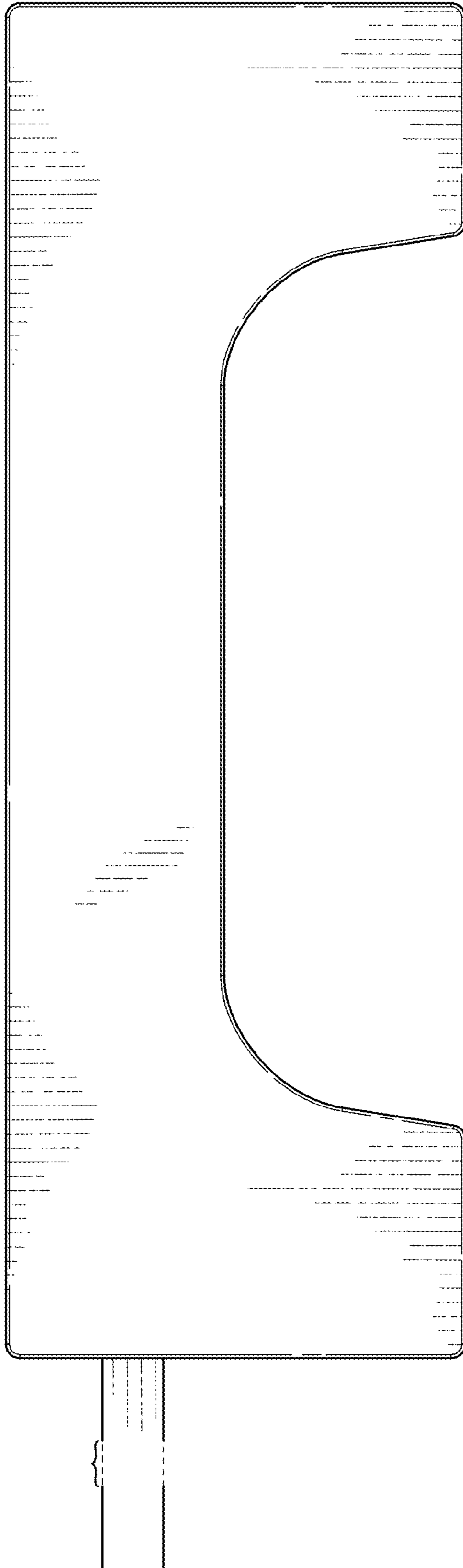

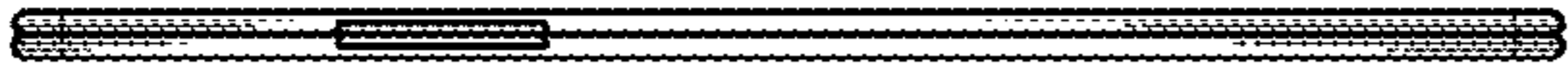

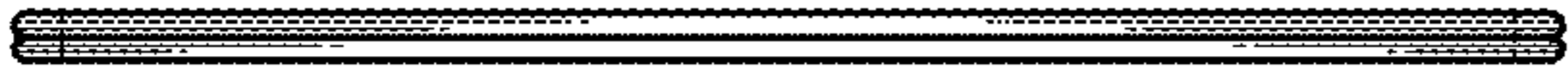

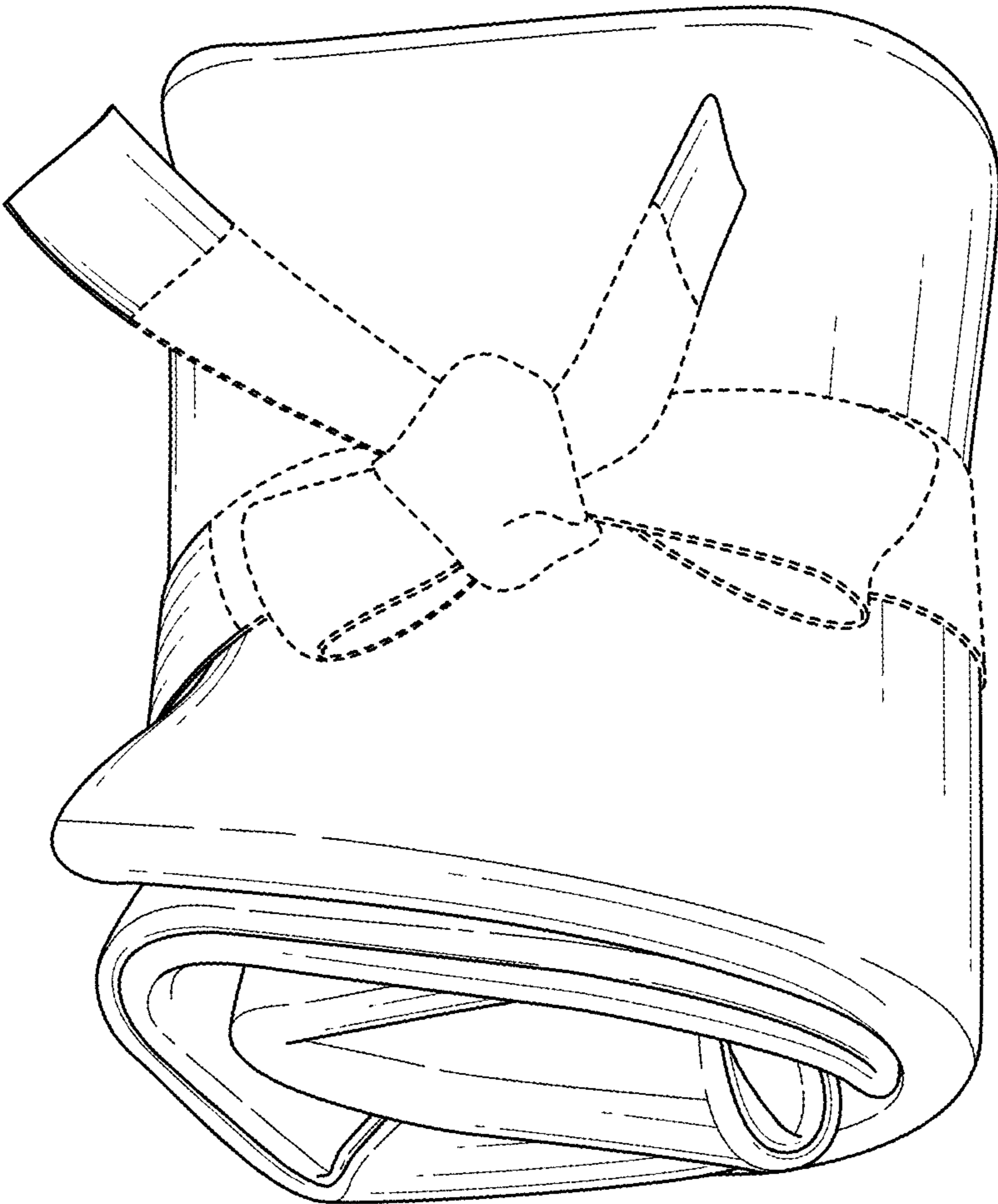
