FIG. 3 is a rear perspective view thereof.

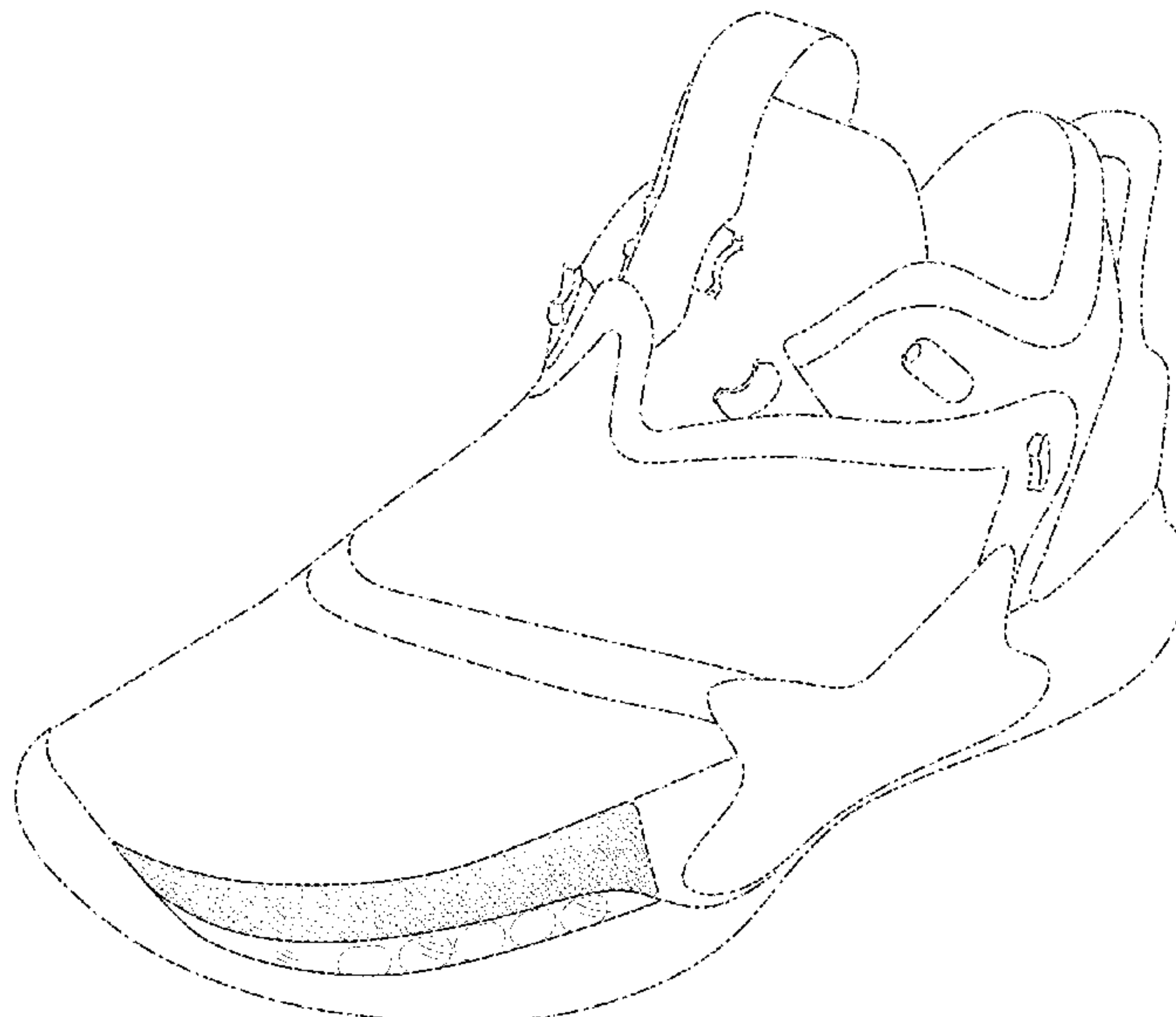
The broken line immediately adjacent to the shaded area

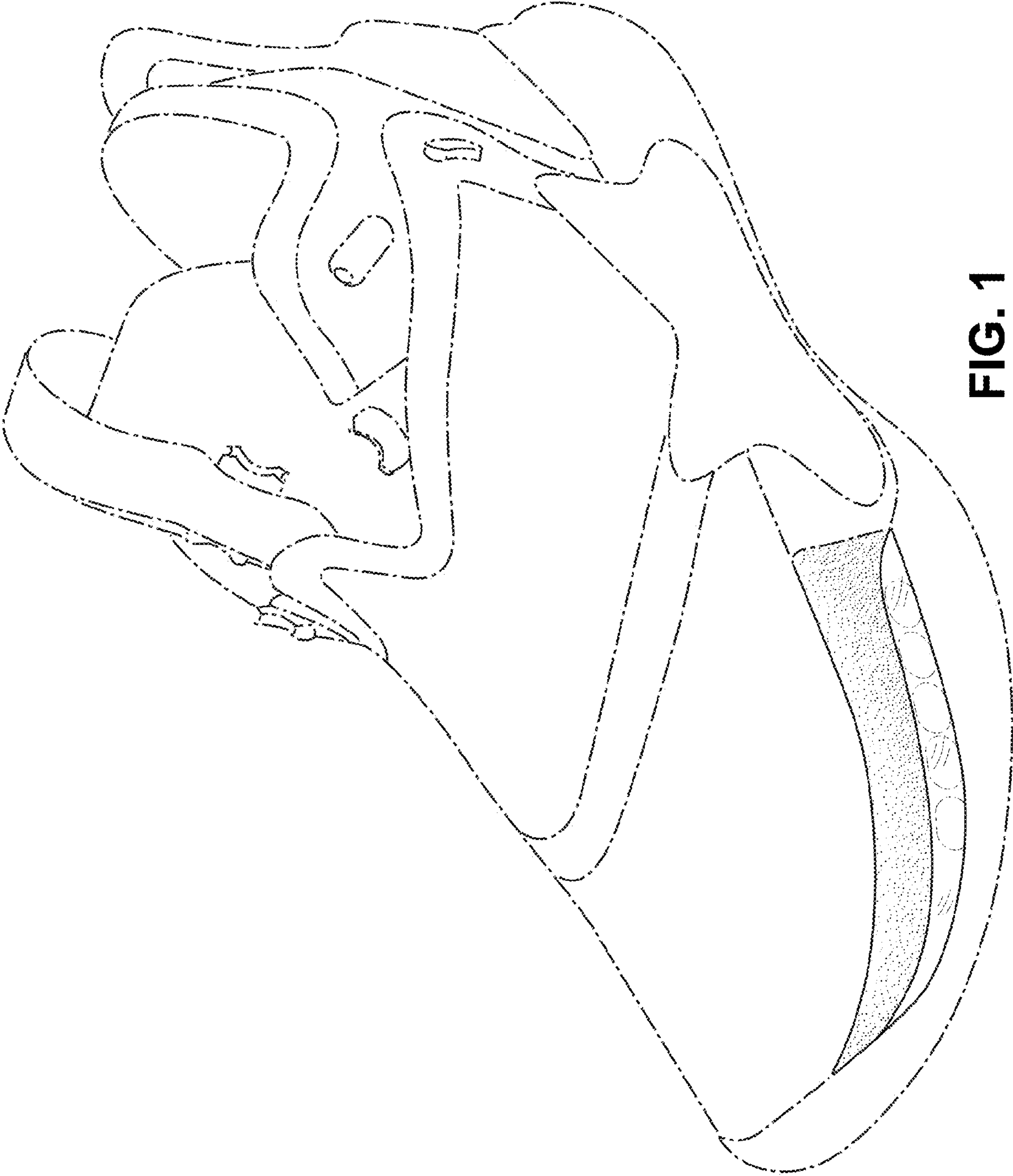

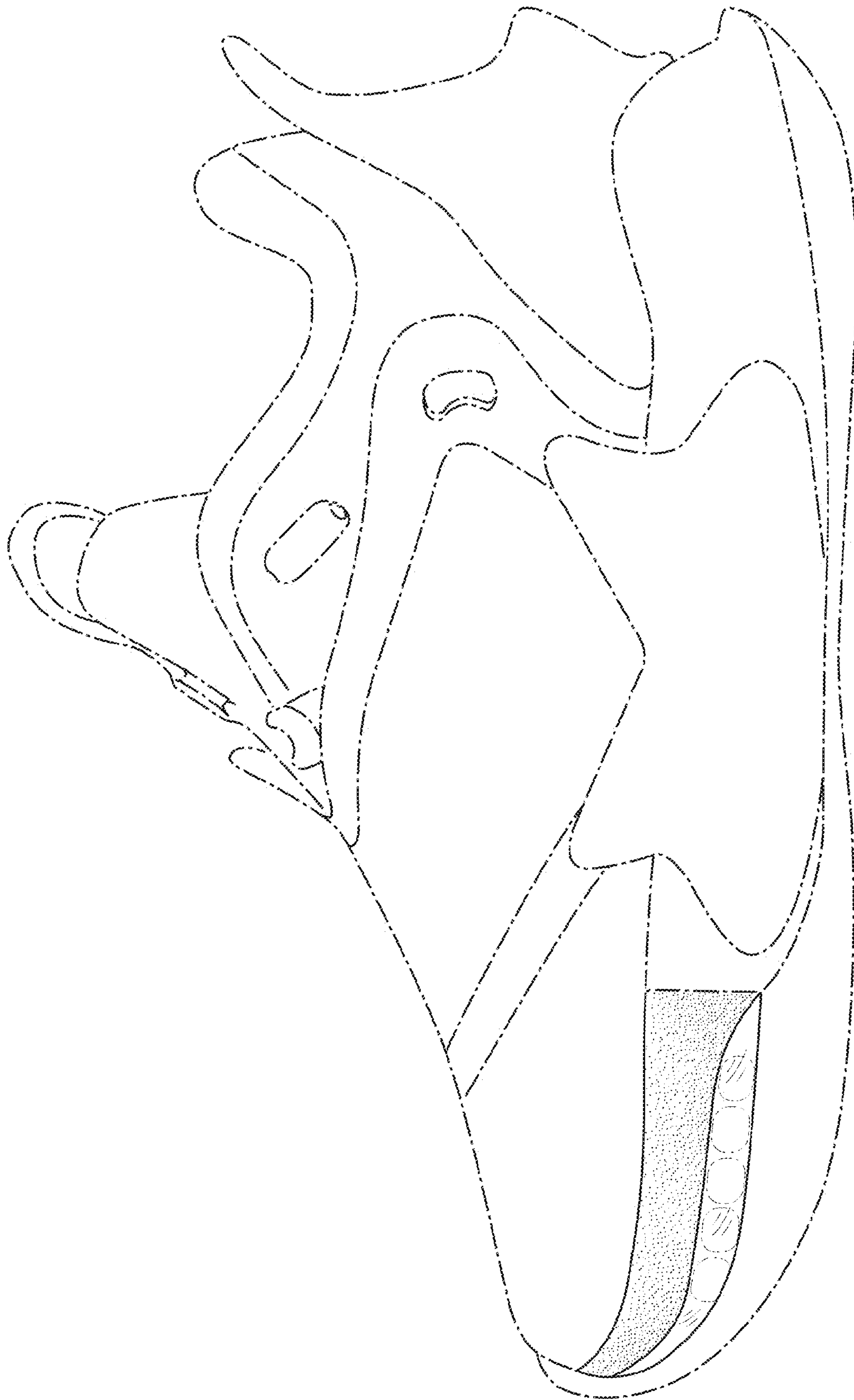

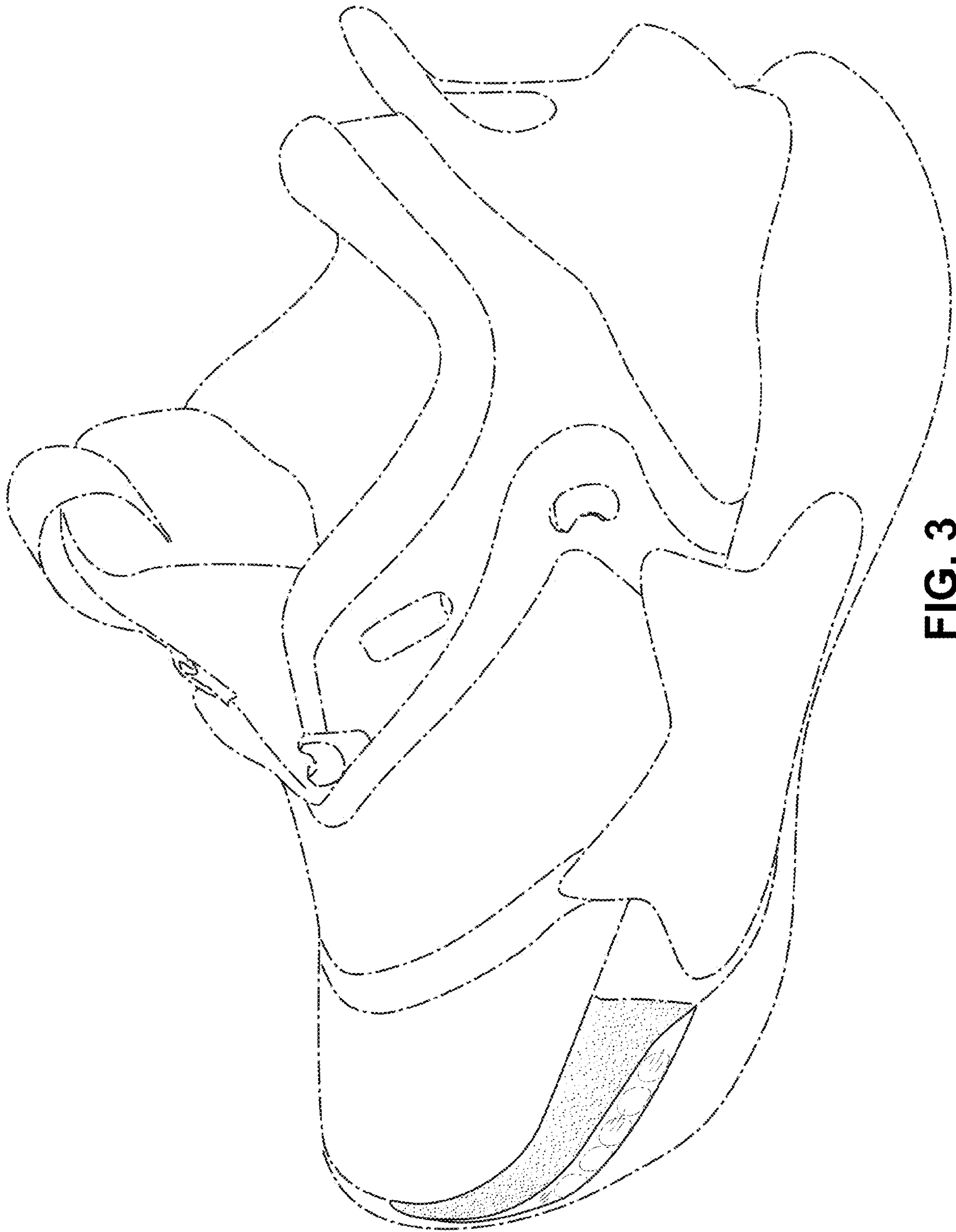
