DESCRIPTION

FIG. 1 is a perspective view of a shoe. The dashed lines illustrate unclaimed surface texturing on the midsole and other unclaimed portions of the shoe.

FIG. 2 is a medial side view of the shoe of FIG. 1.

FIG. 3 is a lateral side view of the shoe of FIG. 1.

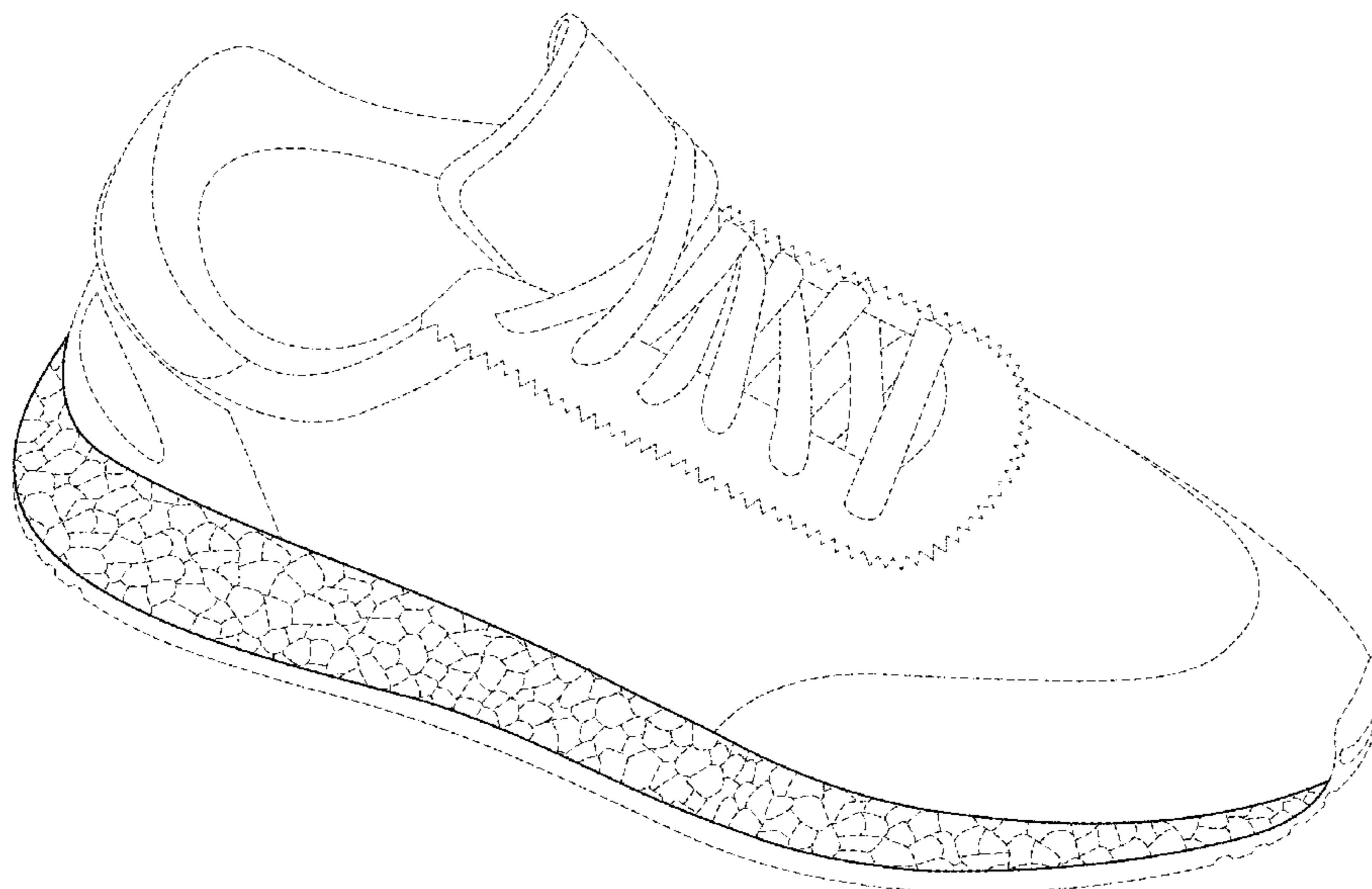
FIG. 4 is a front view of the shoe of FIG. 1.

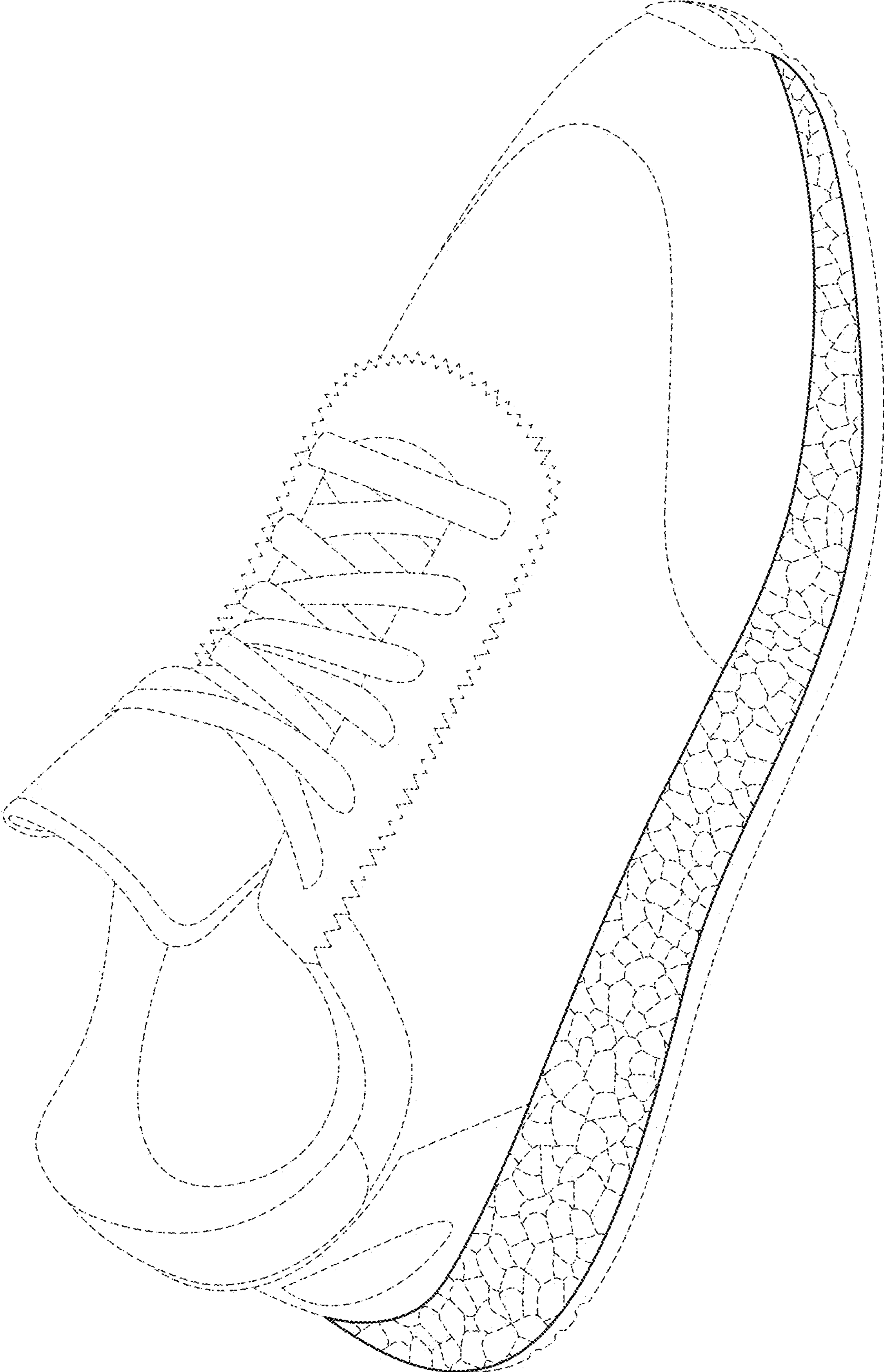

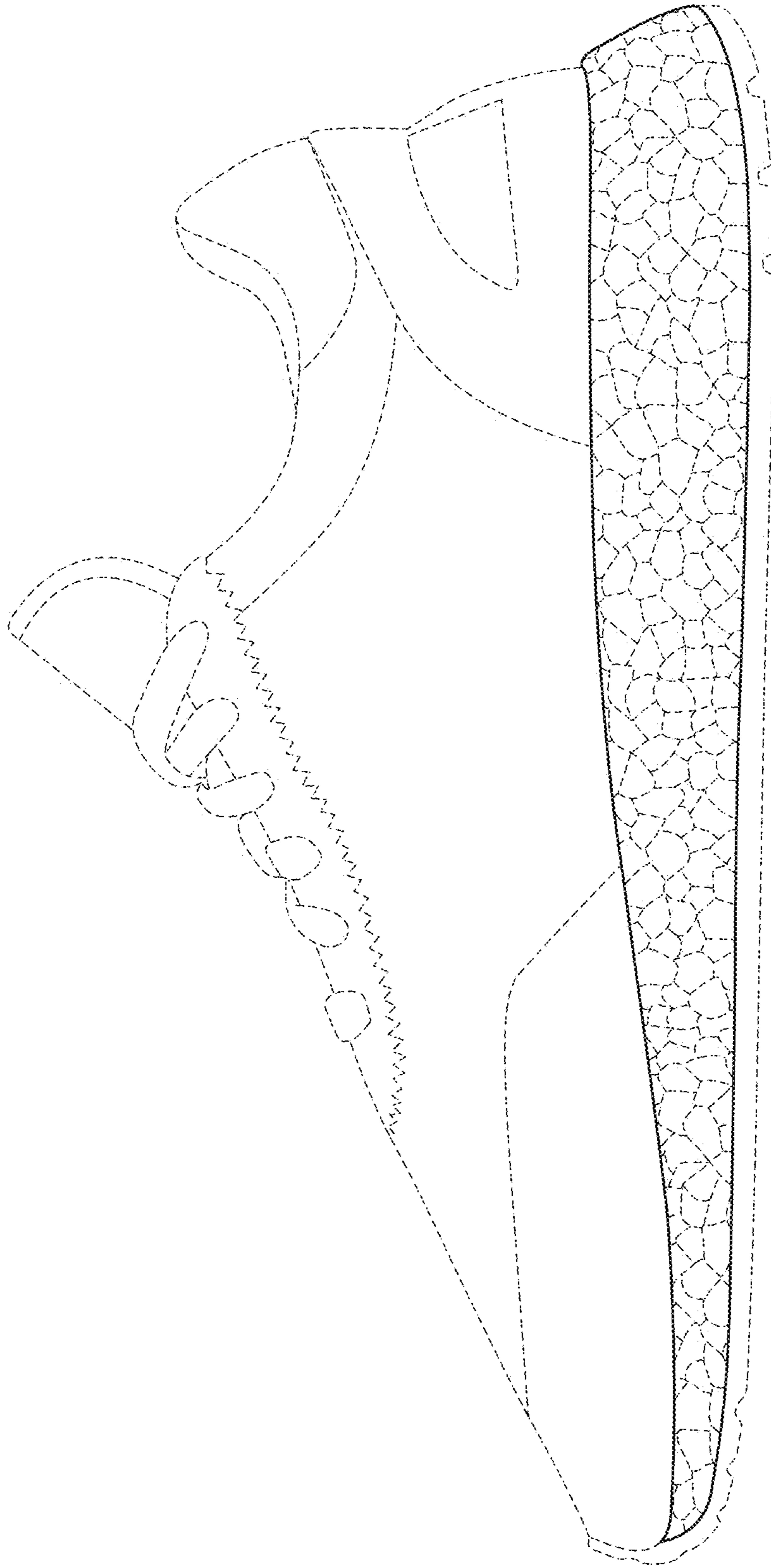

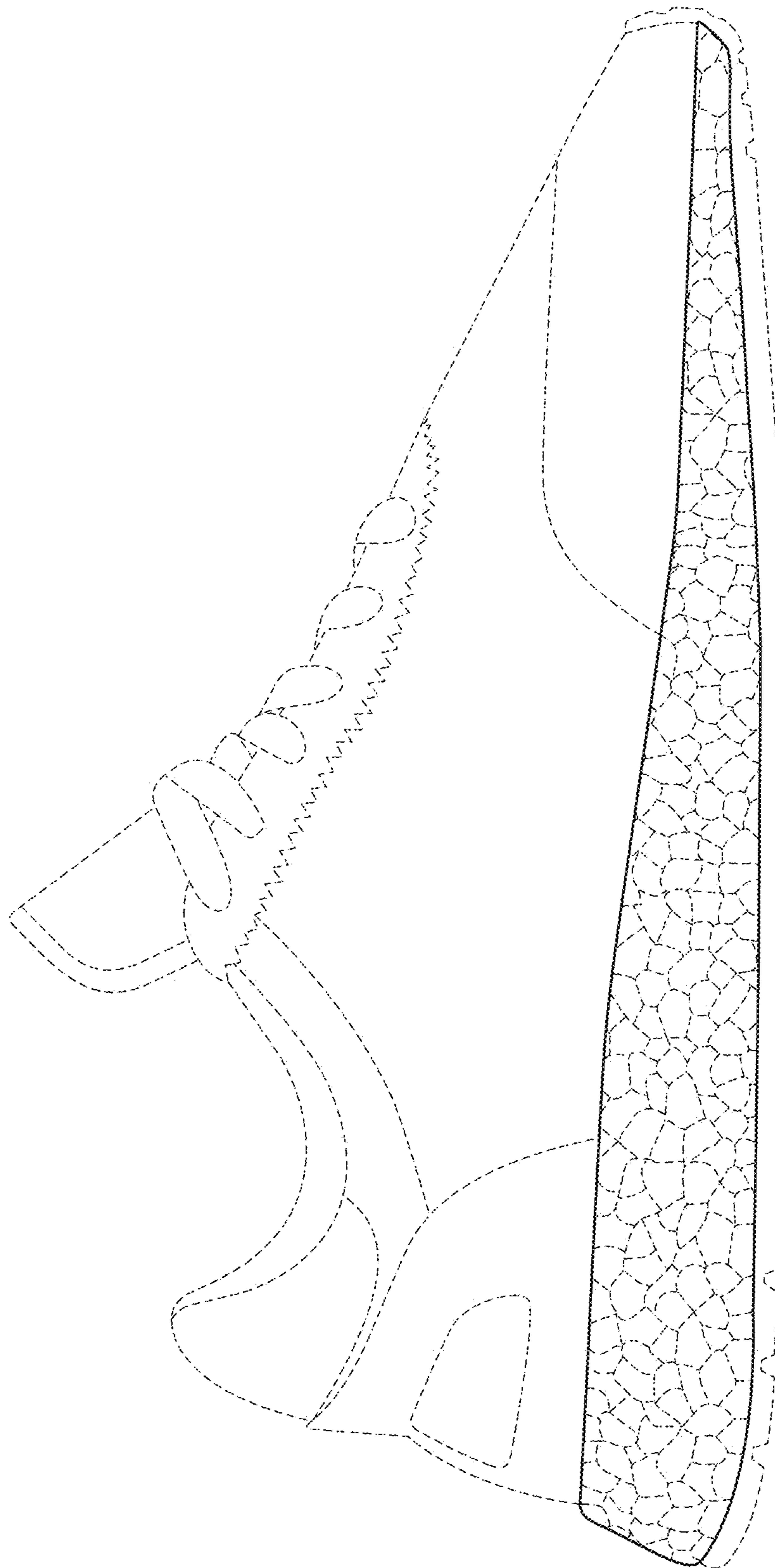

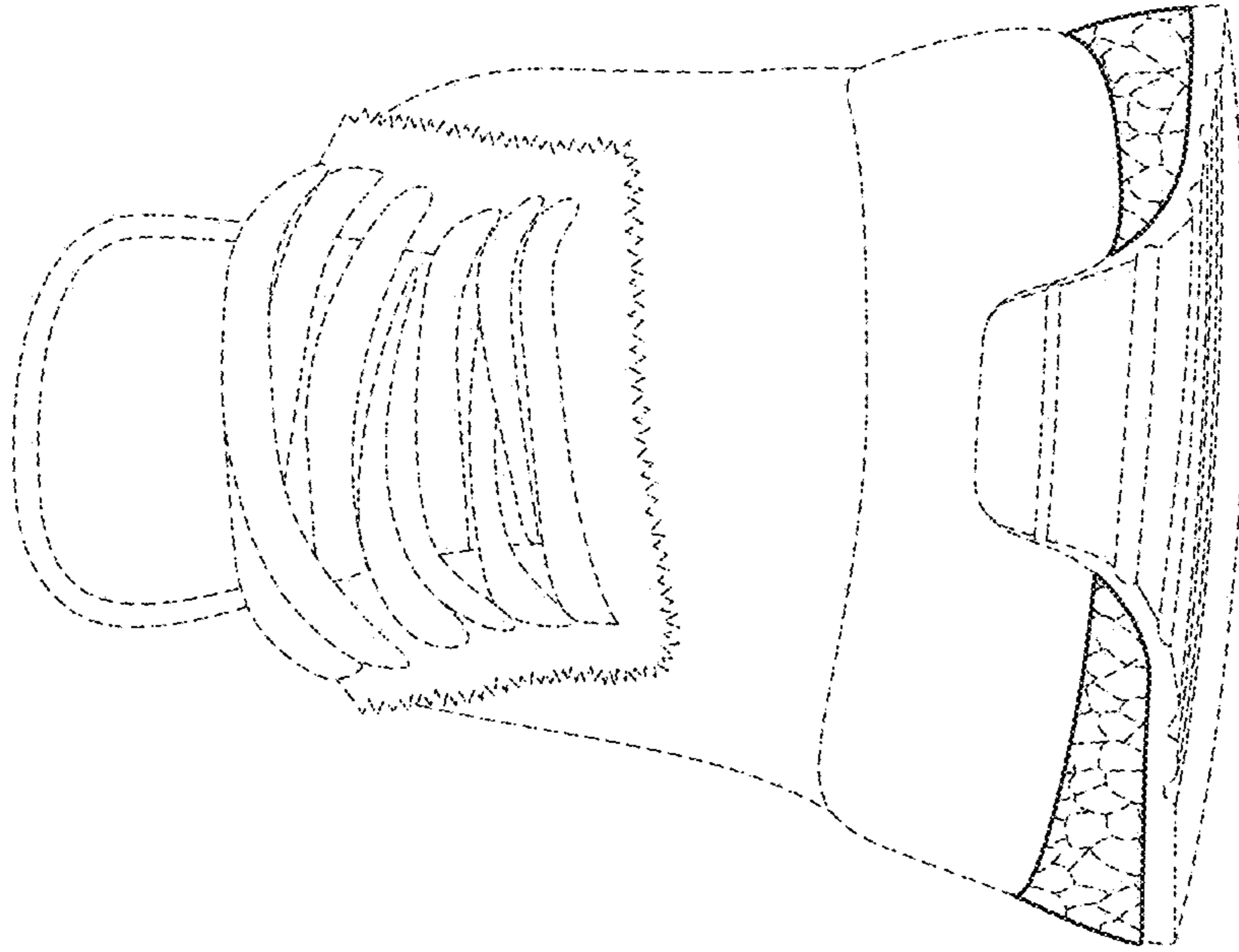

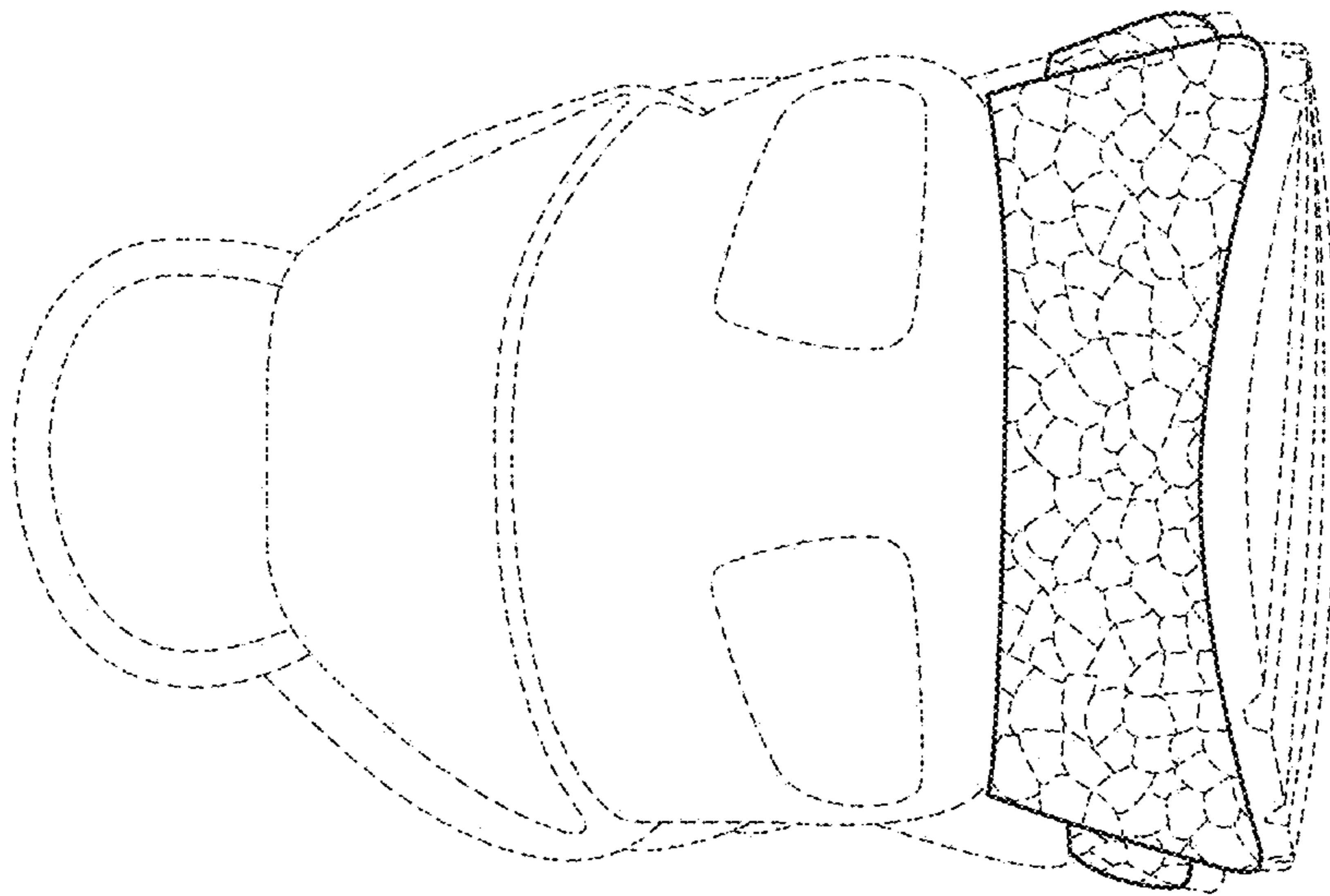

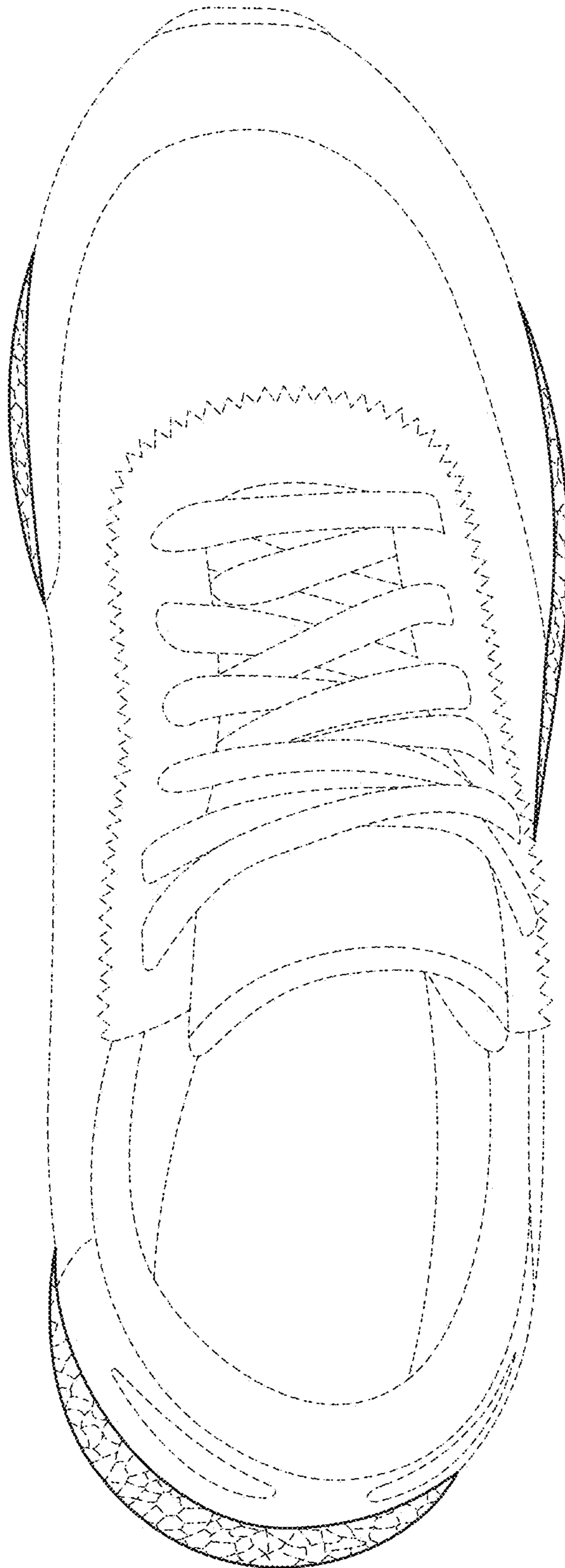

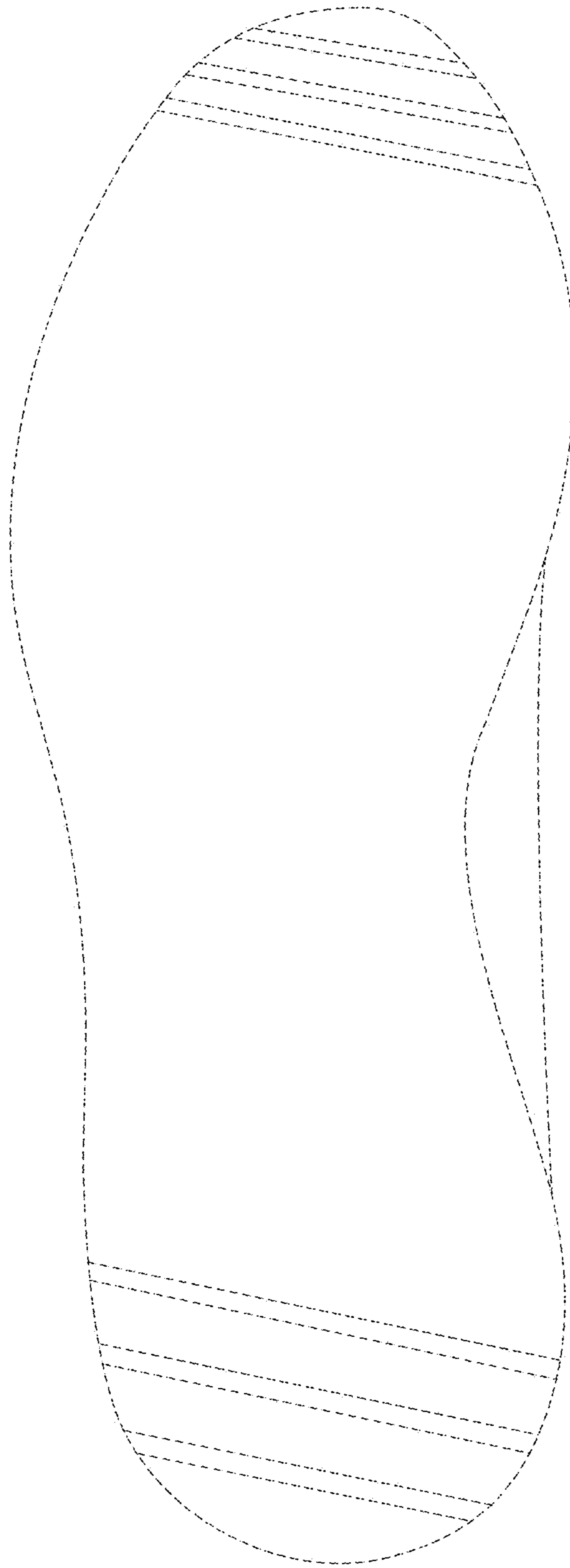
