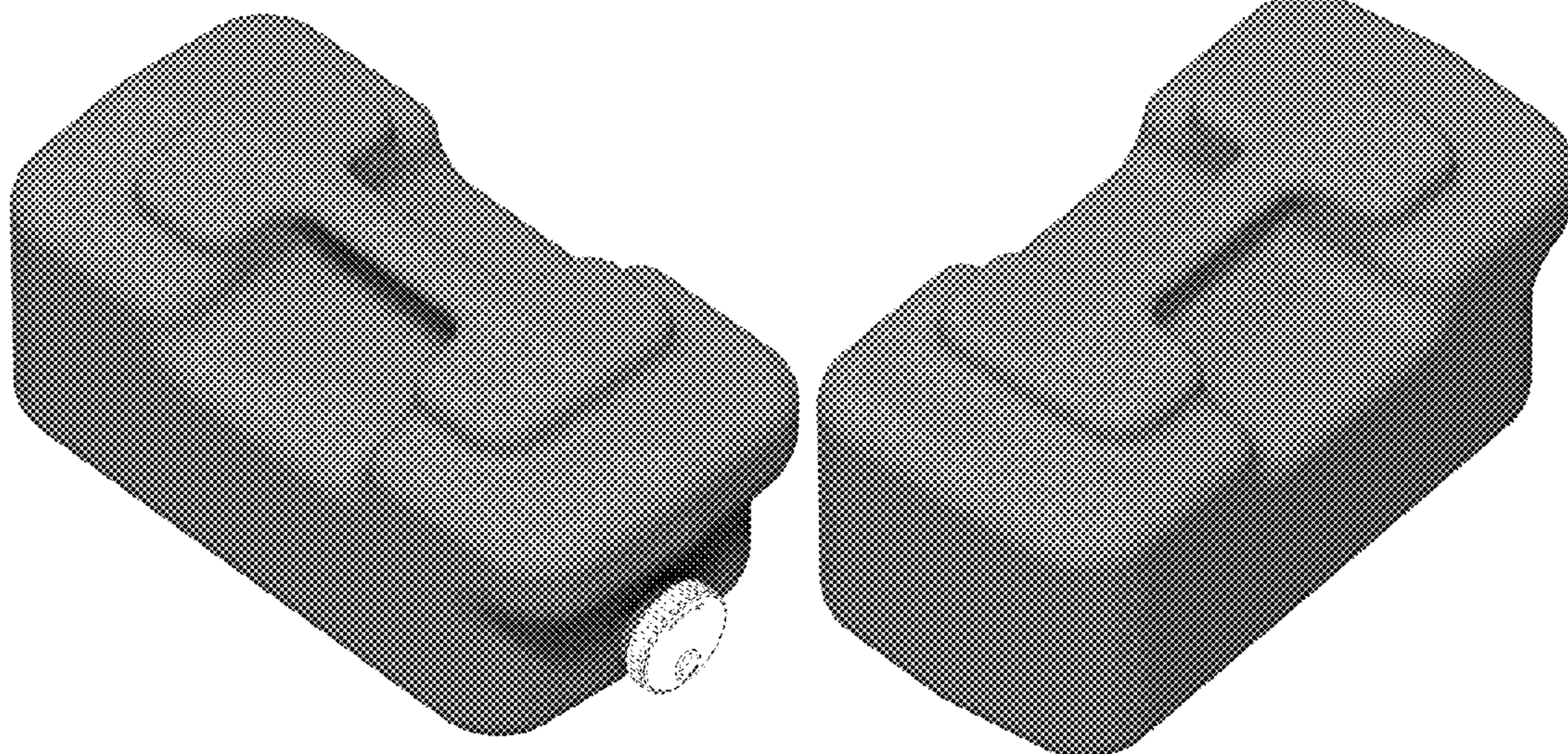
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-top-right perspective view of a container showing my new design;
FIG. 2 is a front-top-left perspective view thereof;
FIG. 3 is a front-bottom-left perspective view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a right-side elevational view thereof; and,
FIG. 9 is a left-side elevational view thereof.
The broken lines showing of tap in FIGS. 1, 3-5 and 7-8 are included for the purpose of showing environmental structure and form no part of the claimed design.

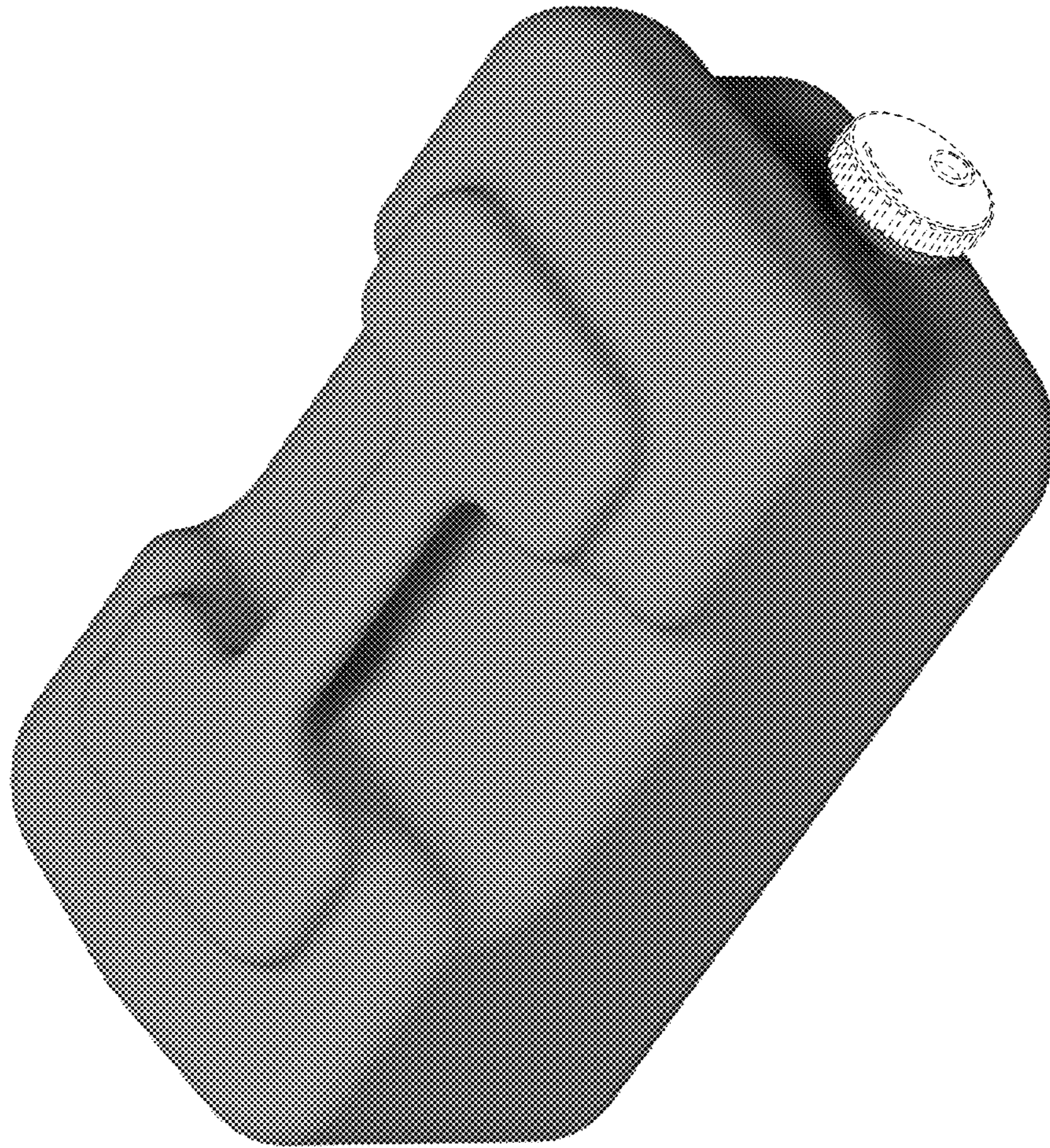

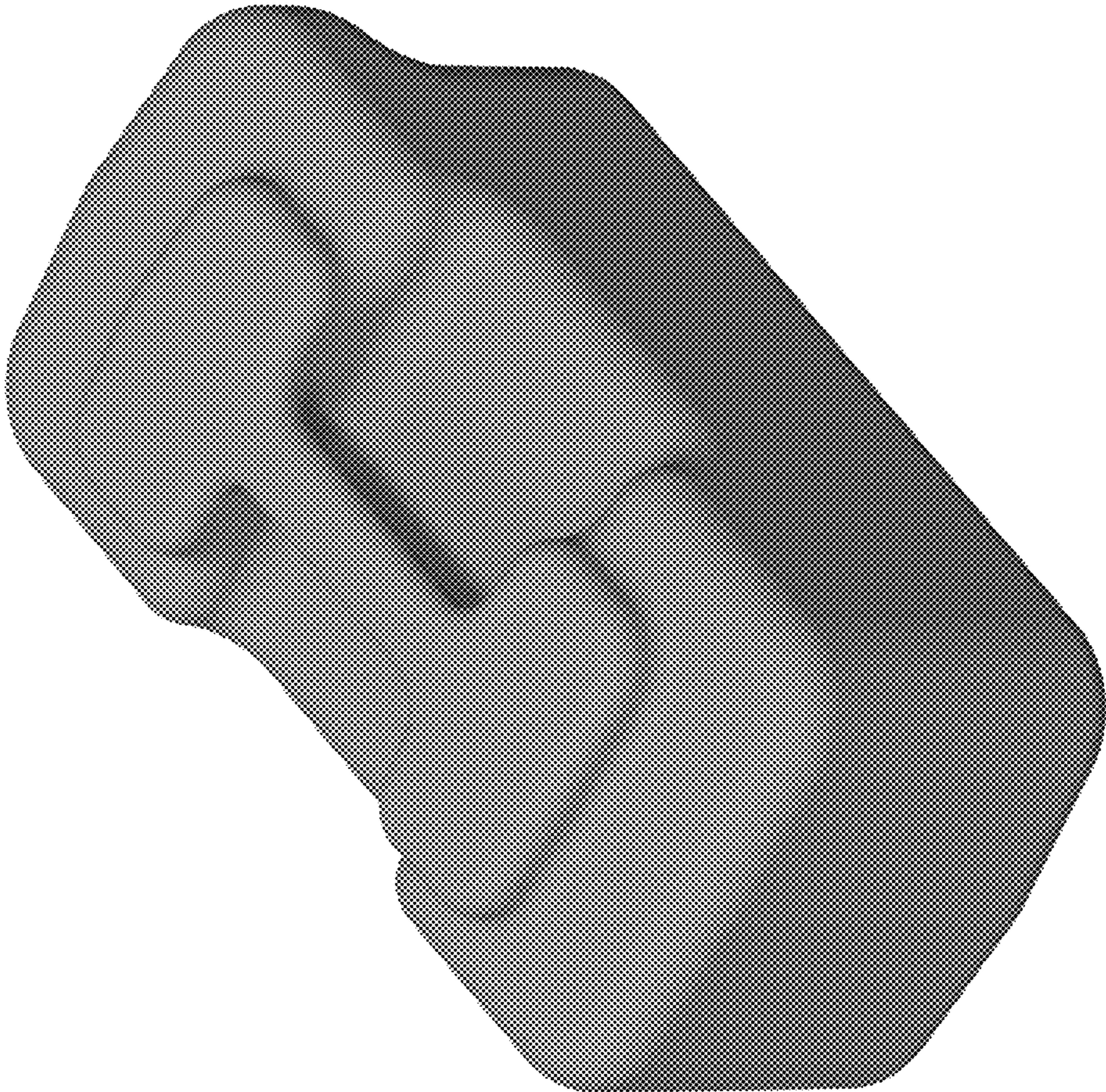

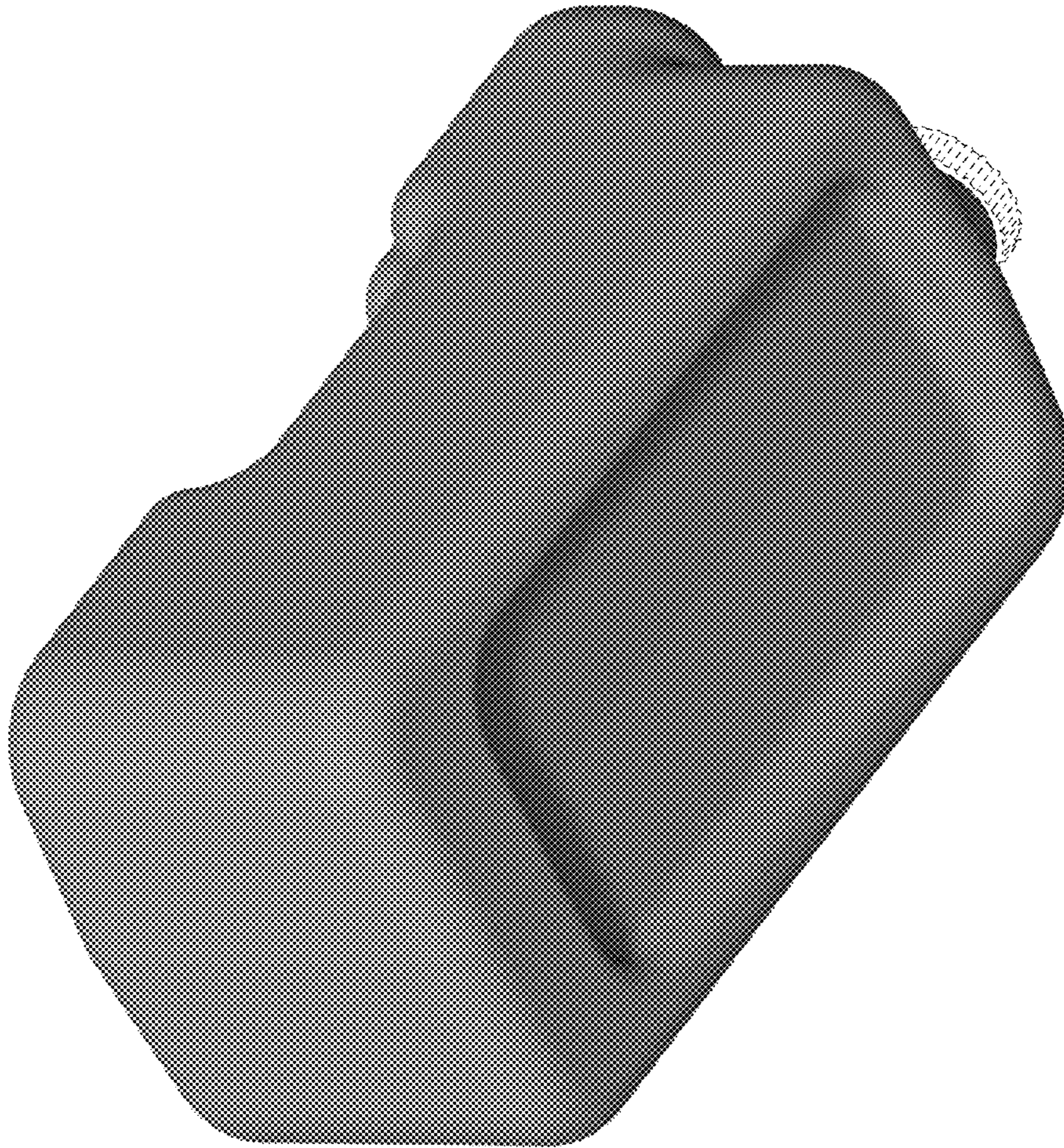

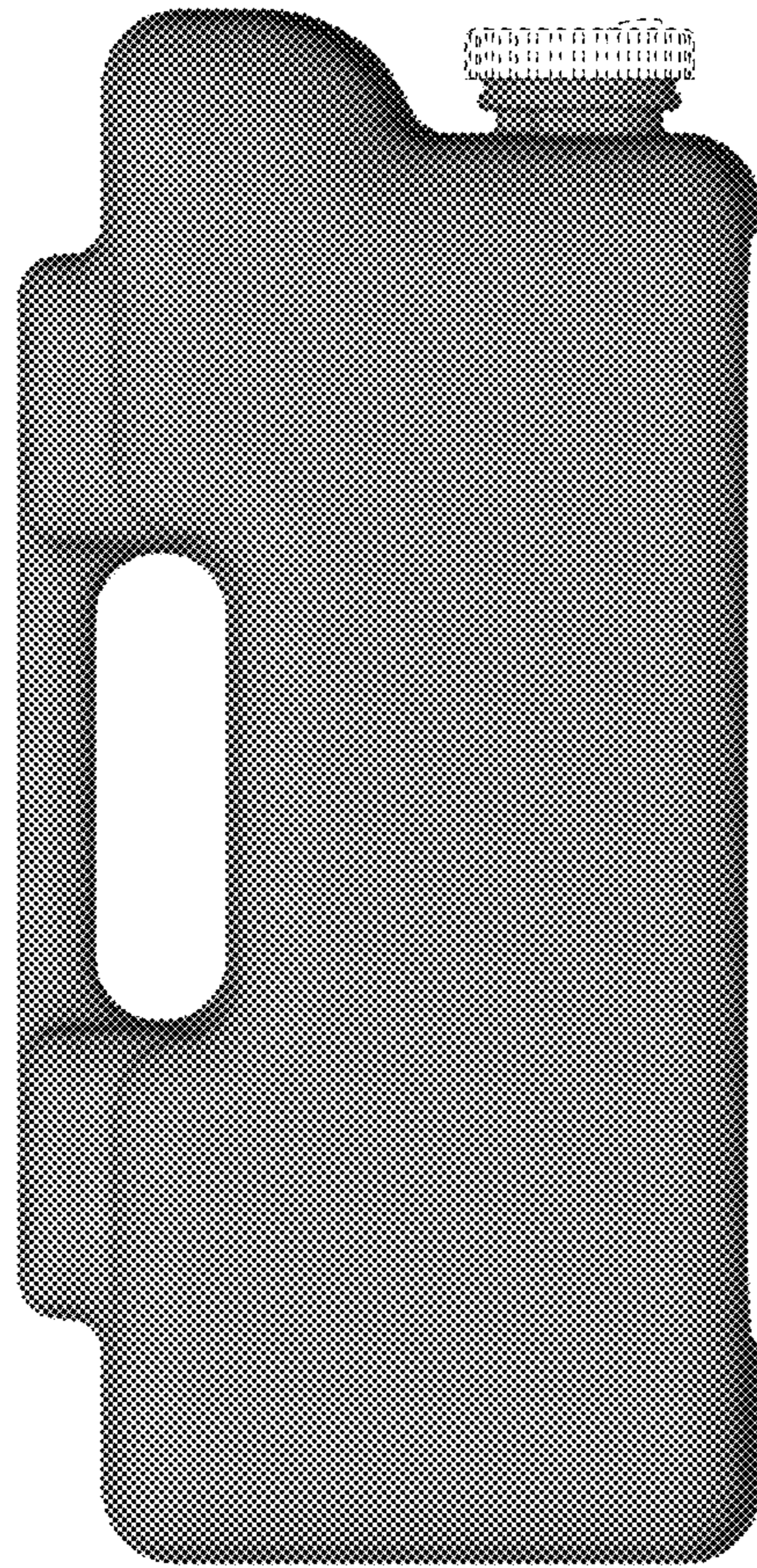

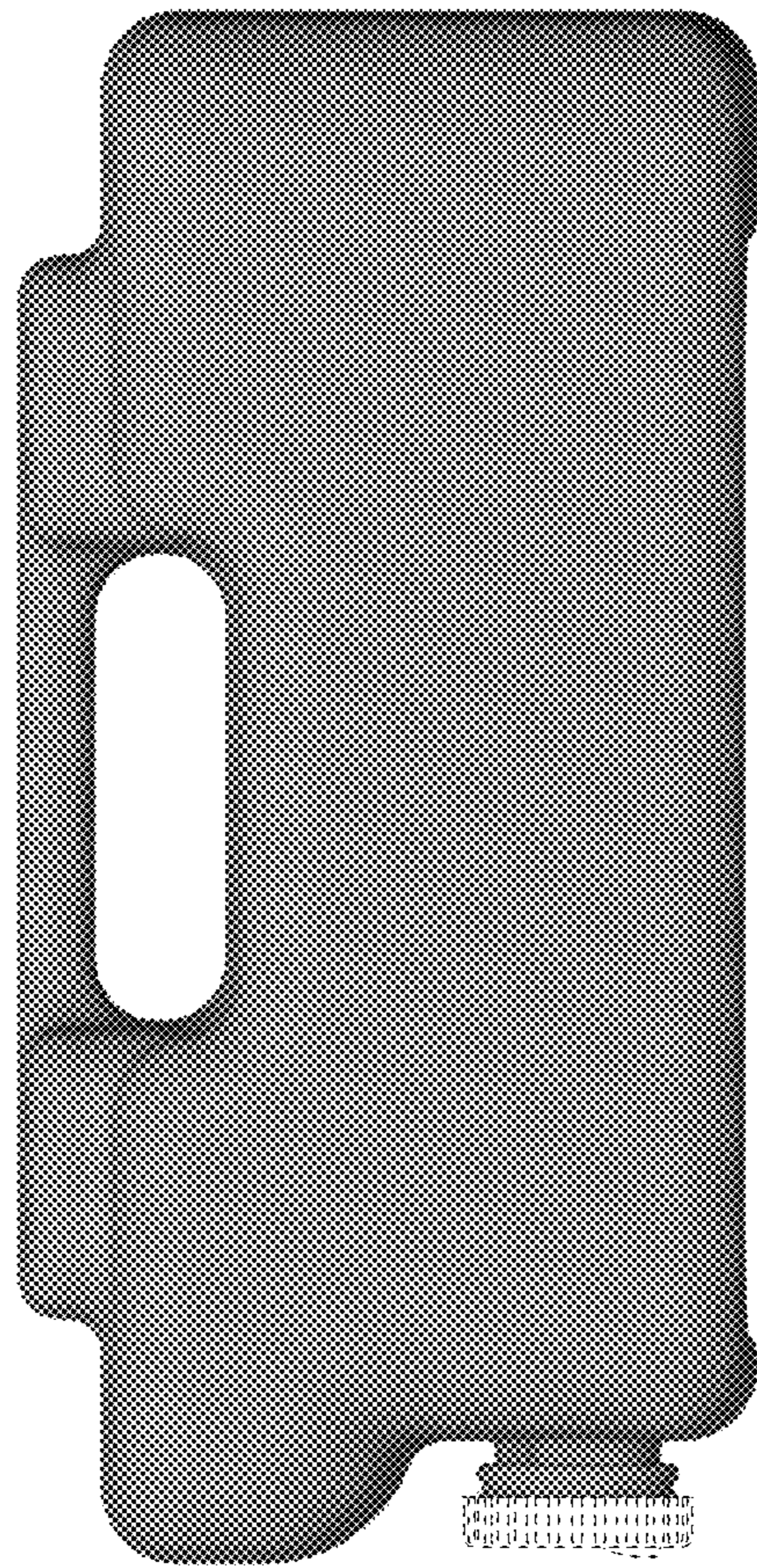

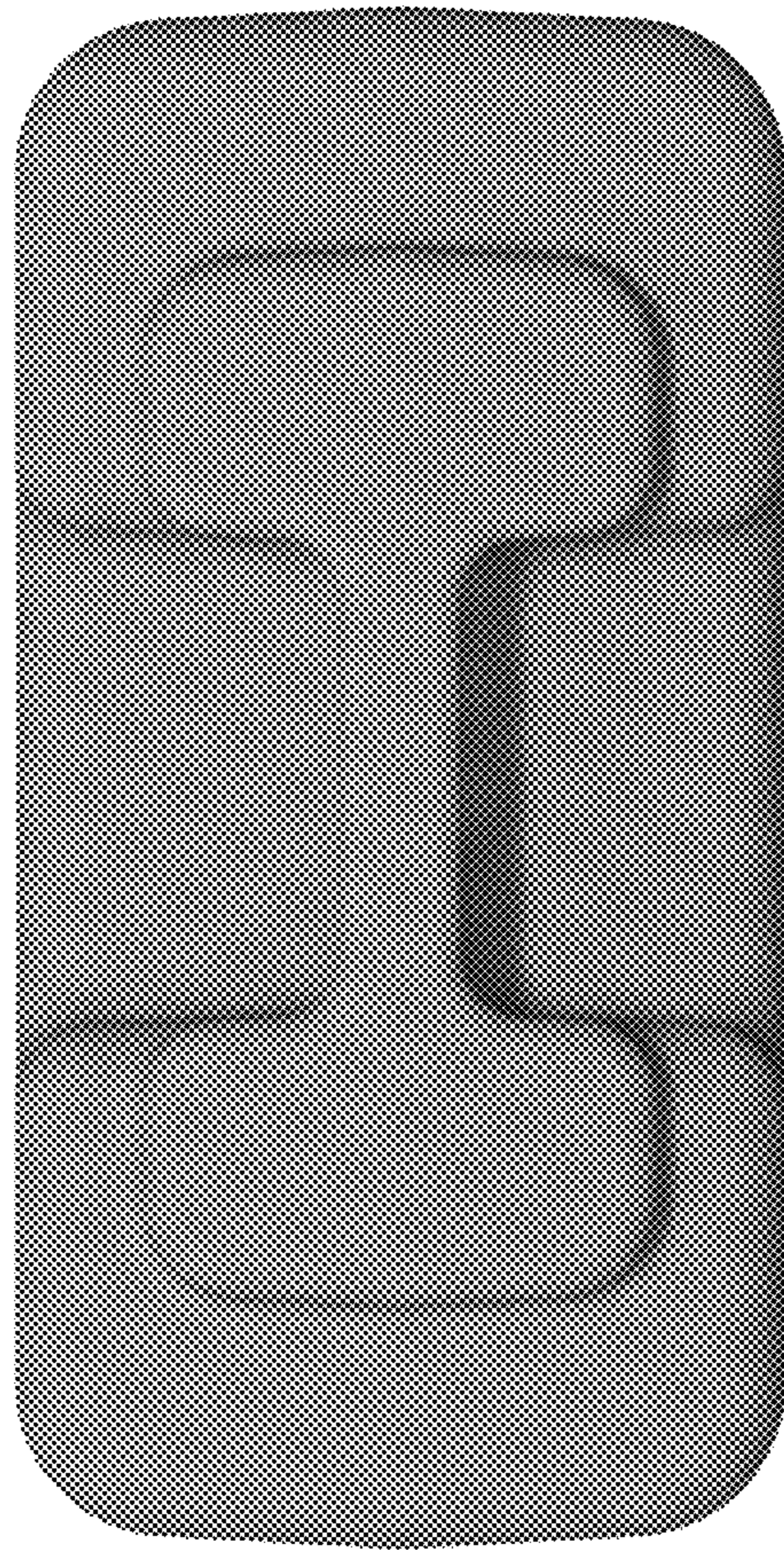

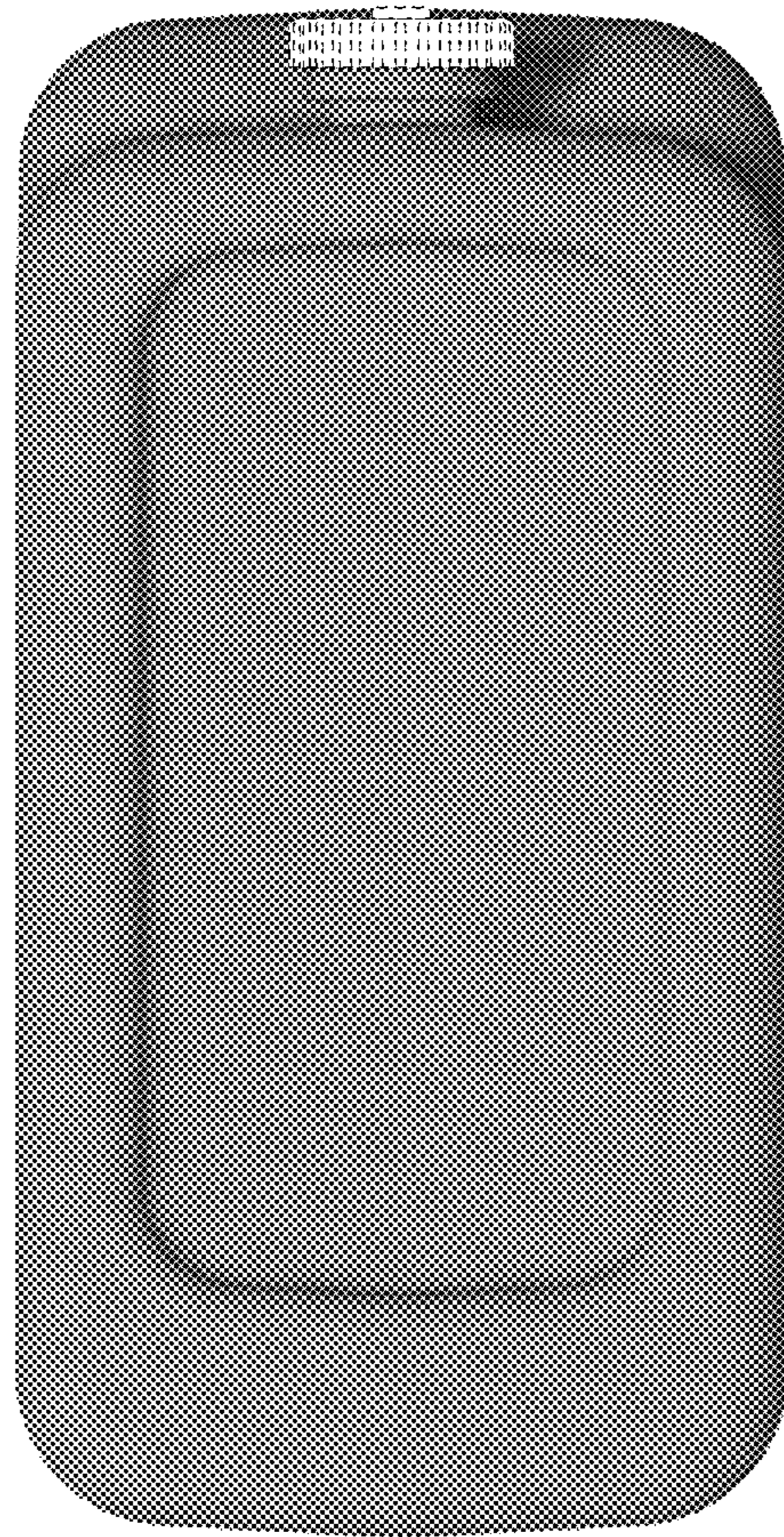

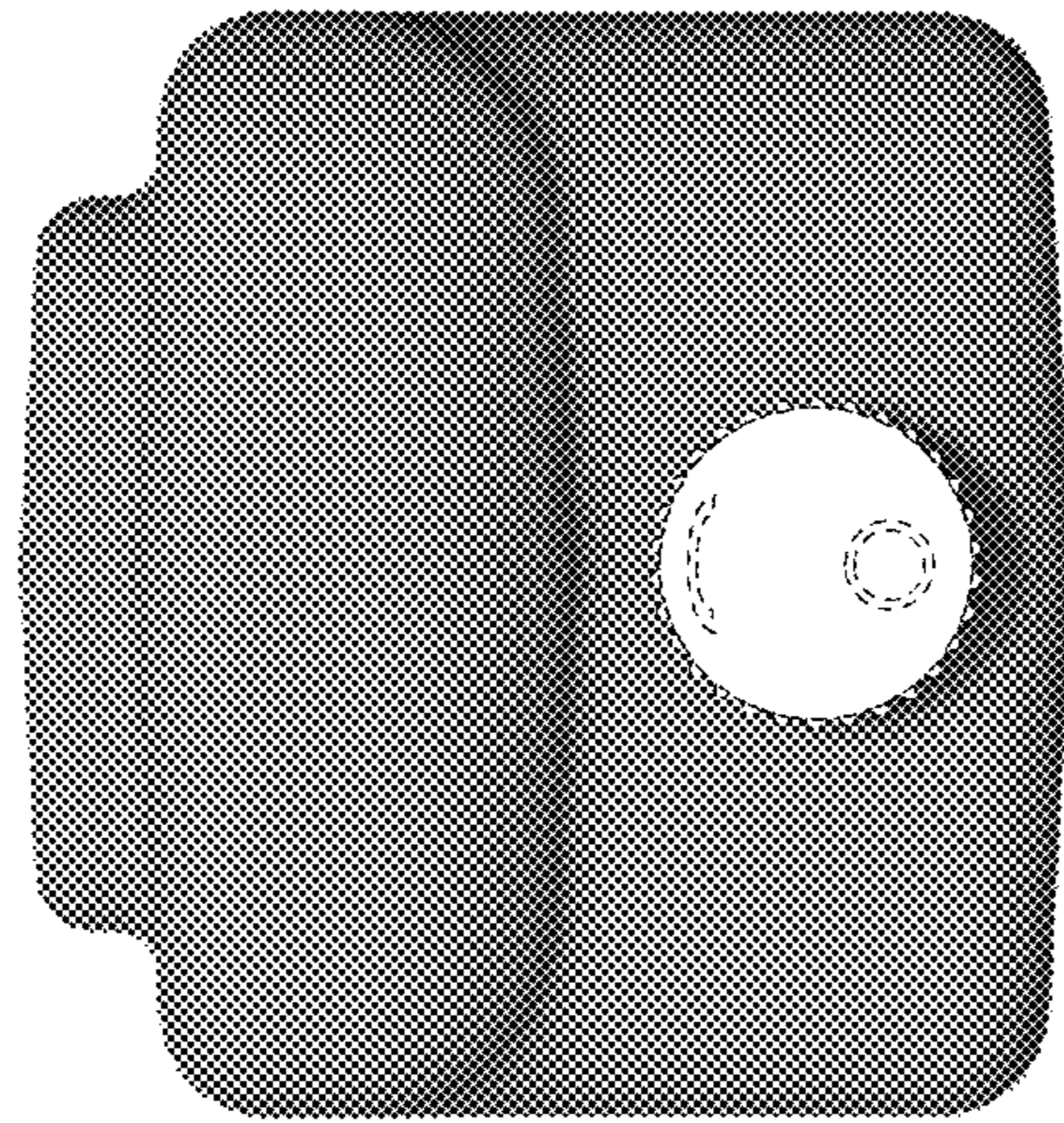
