FIG. 6 is a side view of the article of jewelry illustrated in FIG. 4.

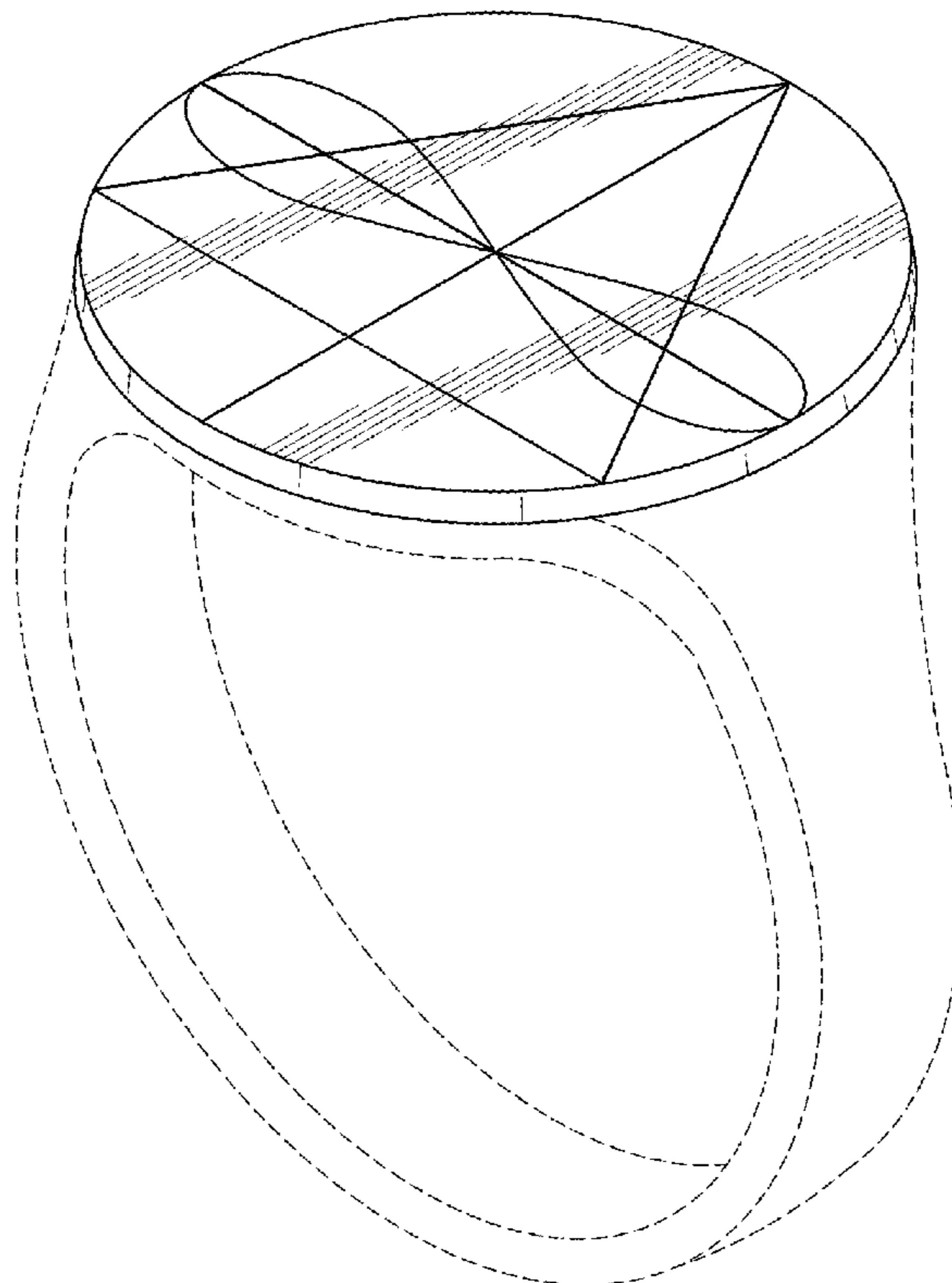

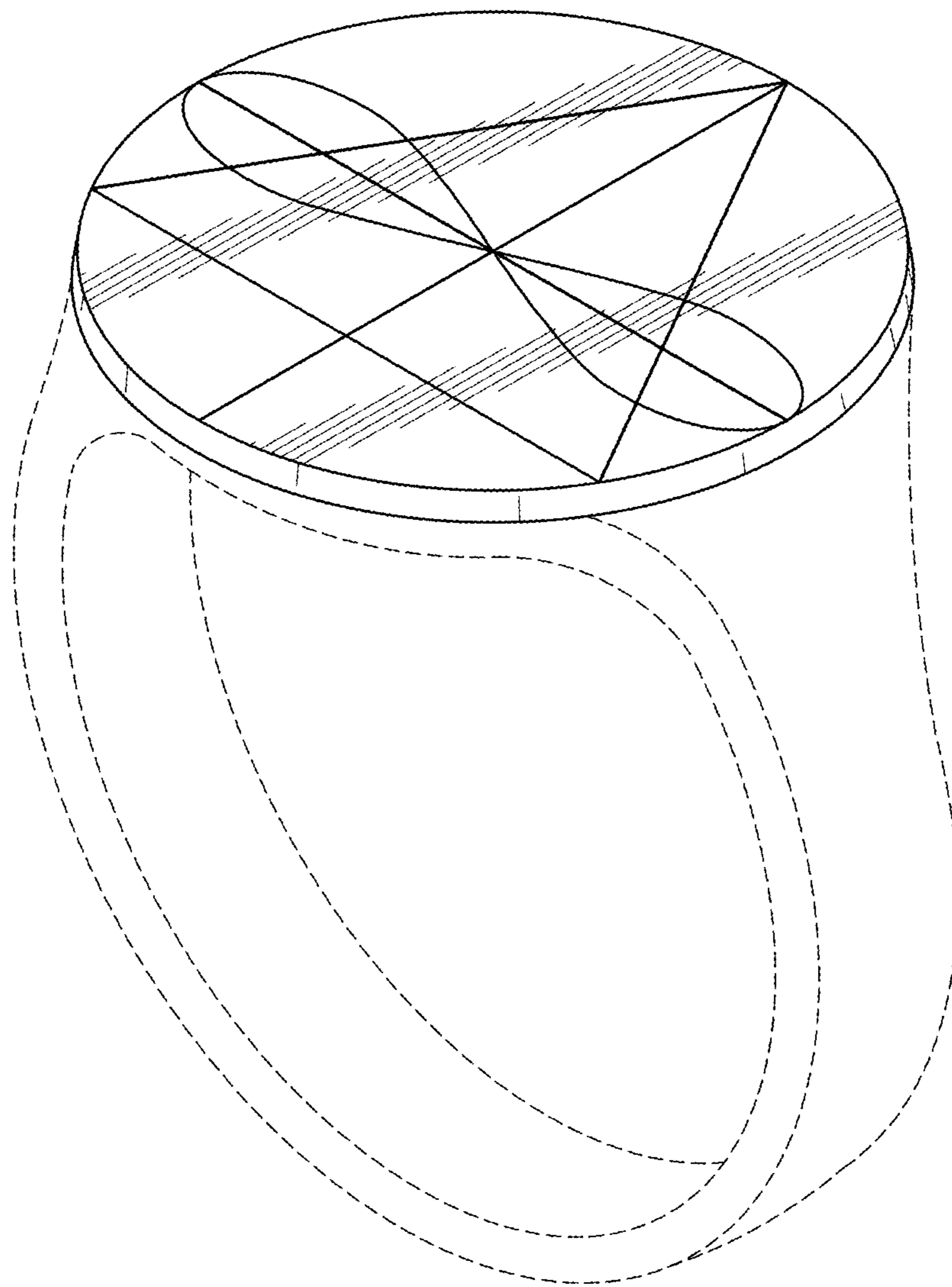

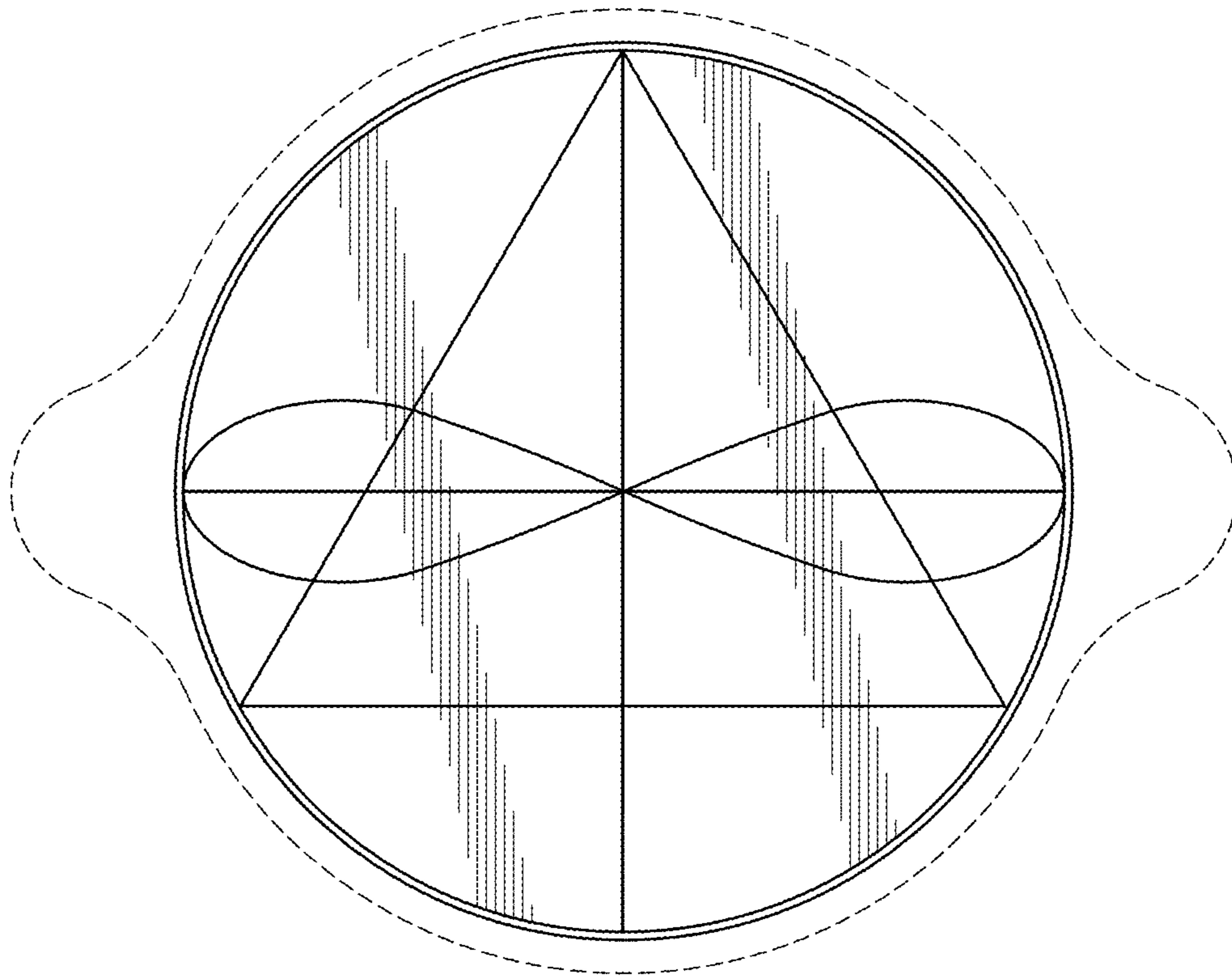

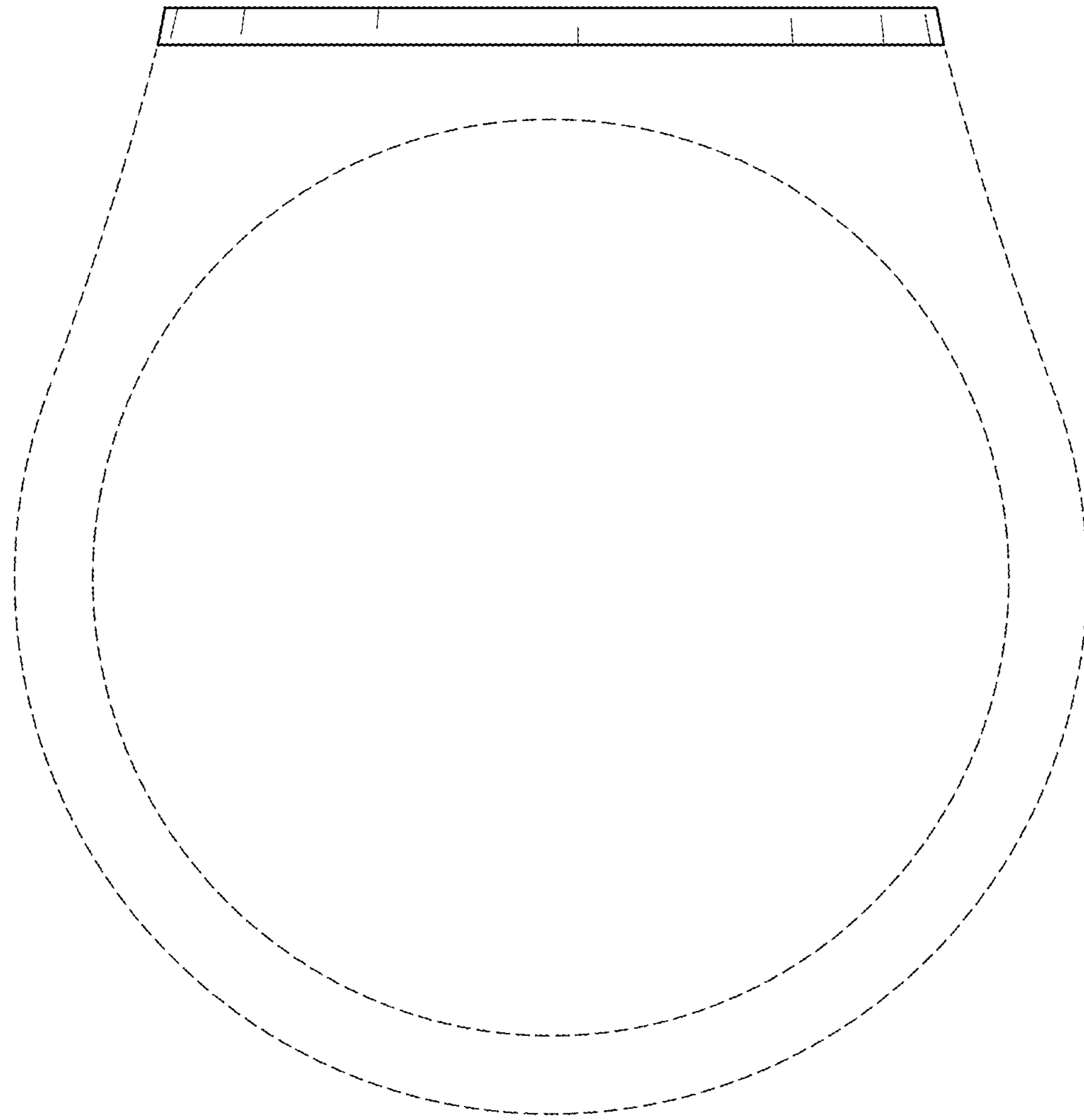

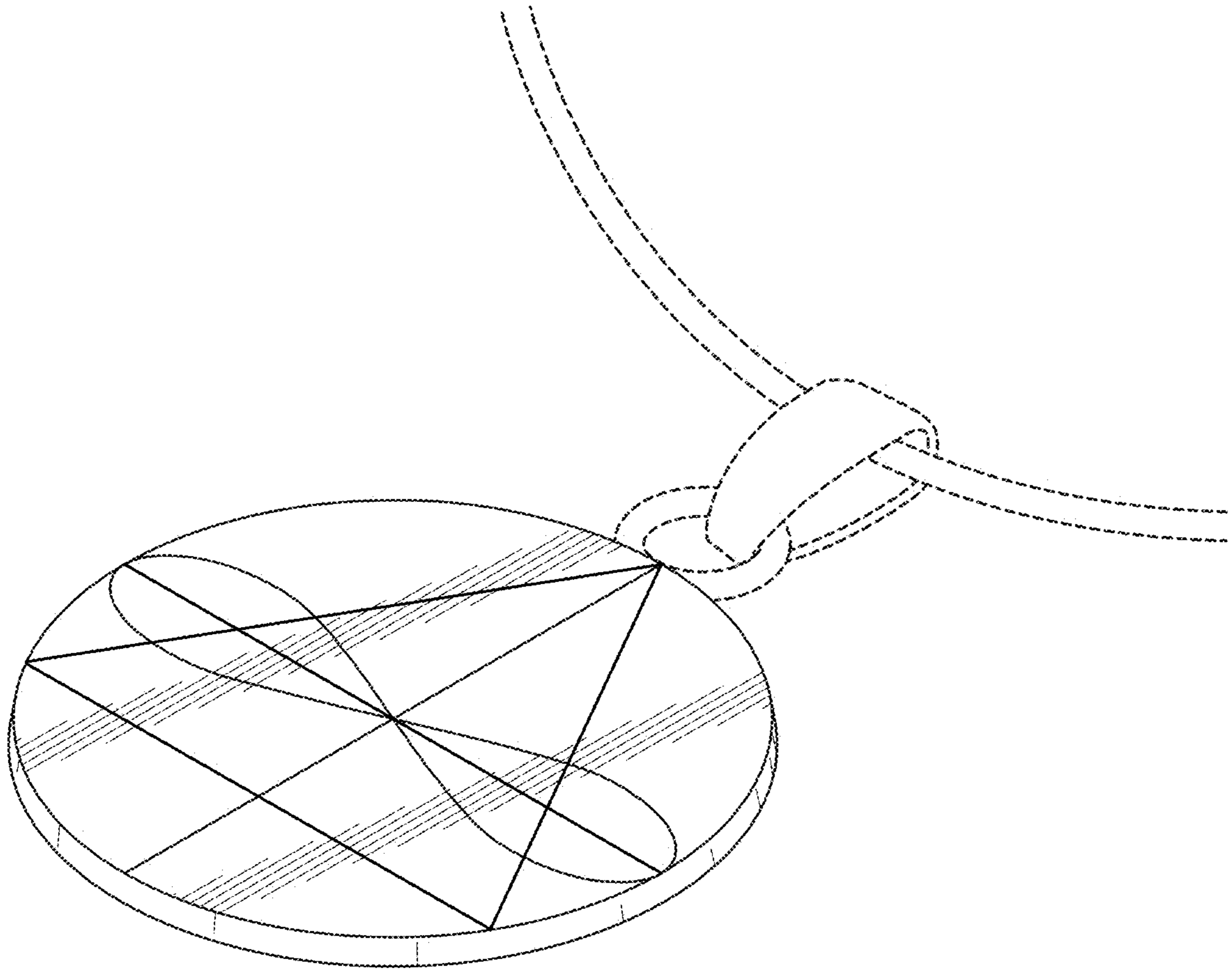

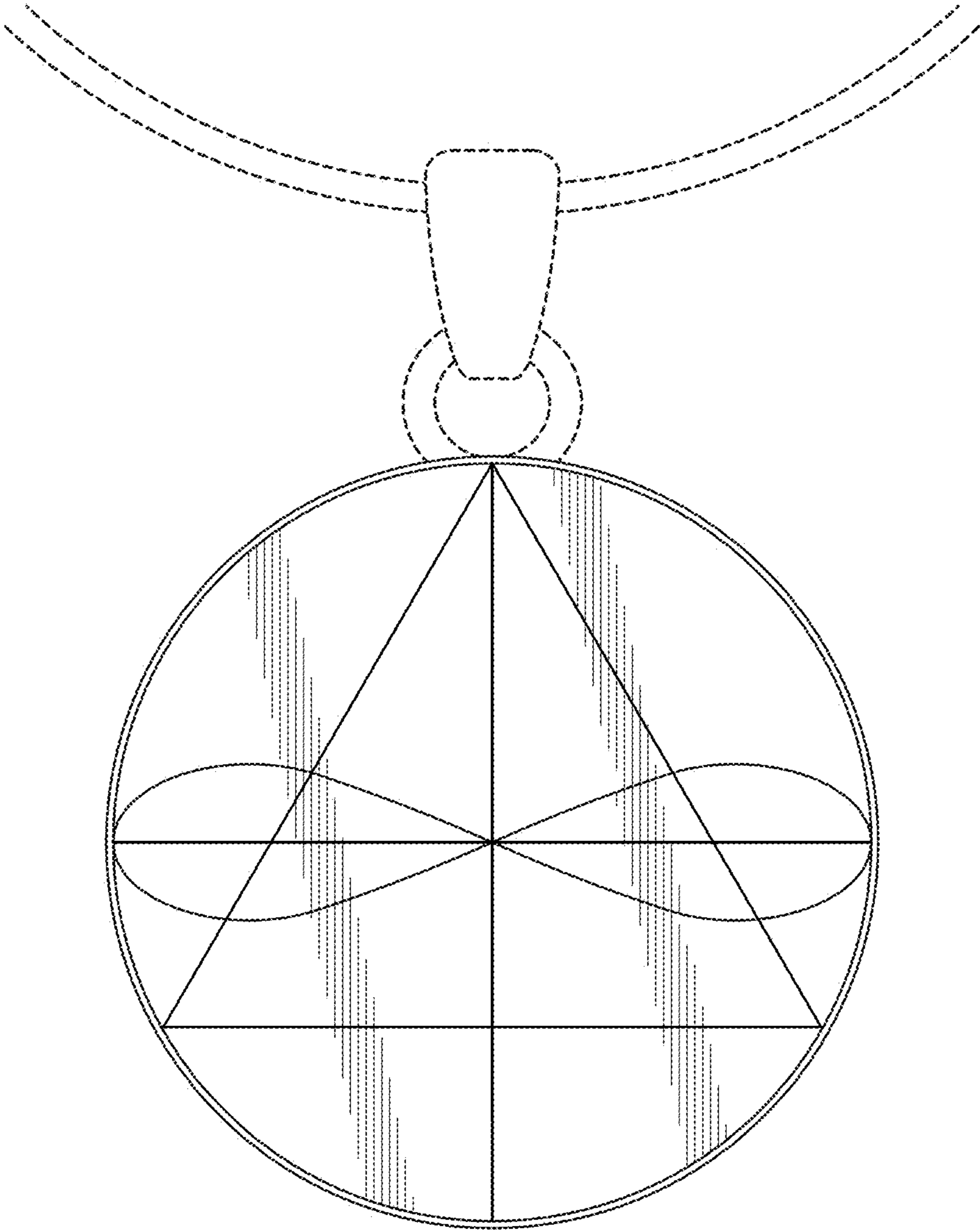

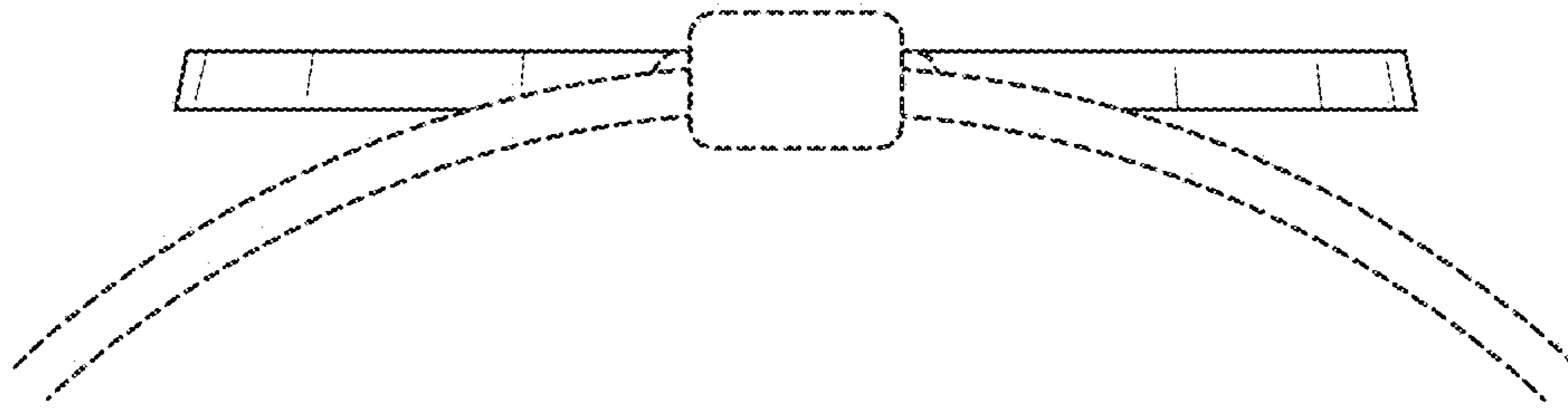
