(57) **CLAIM**


The ornamental design for a wireless loudspeaker, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a wireless loudspeaker showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom, rear and left side perspective view thereof;


















