We claim the ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone showing our new design;

FIG. 5 is a right-side view thereof;

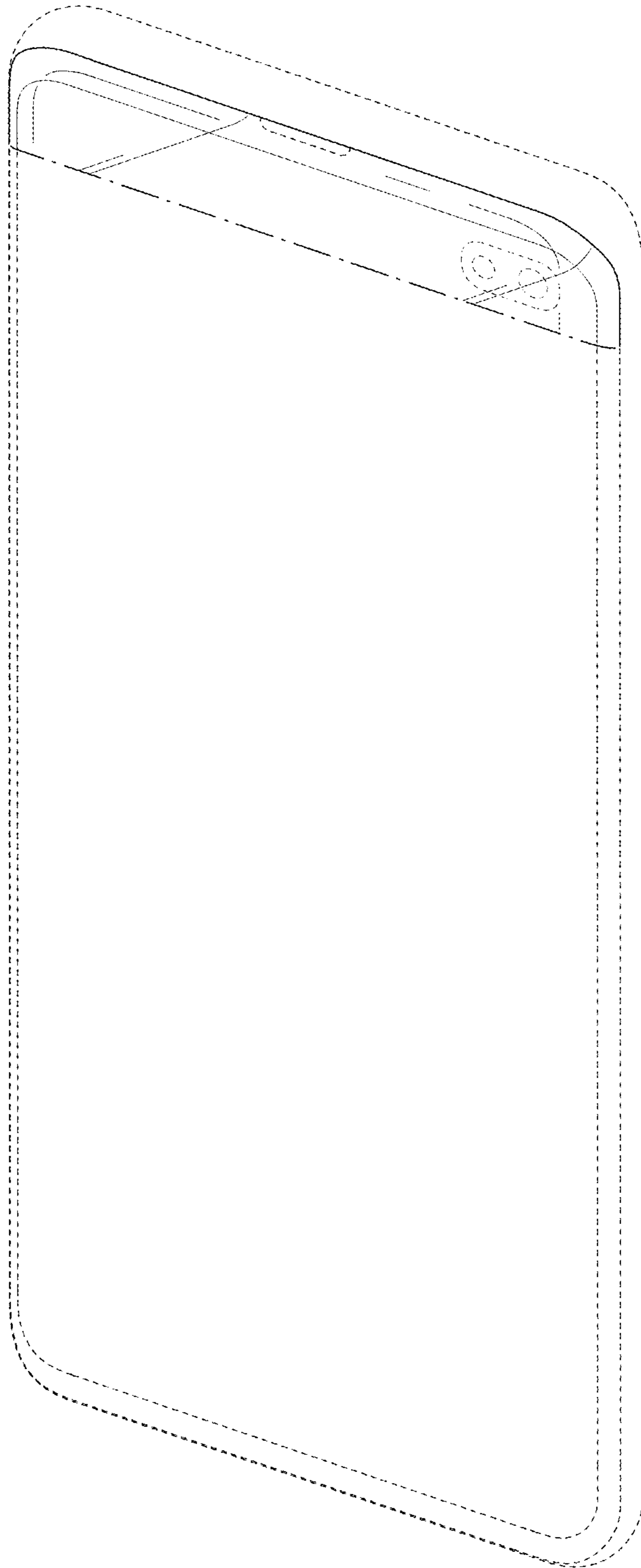

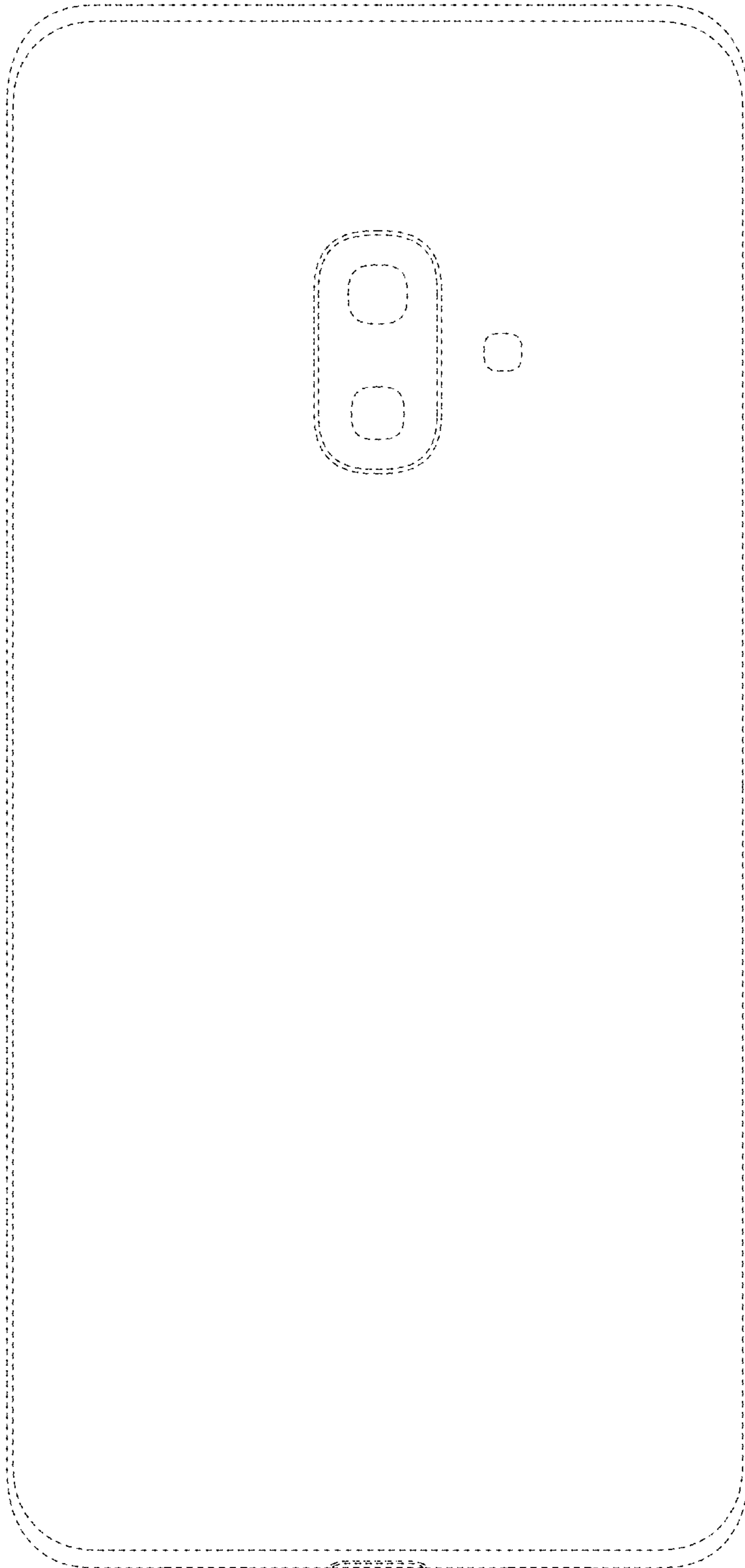

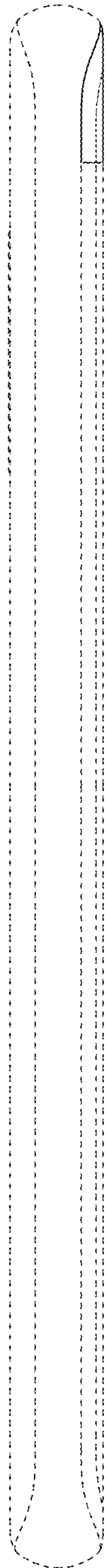

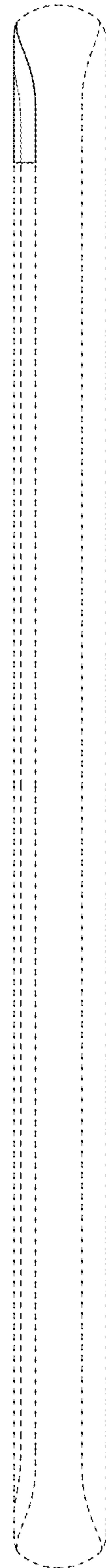

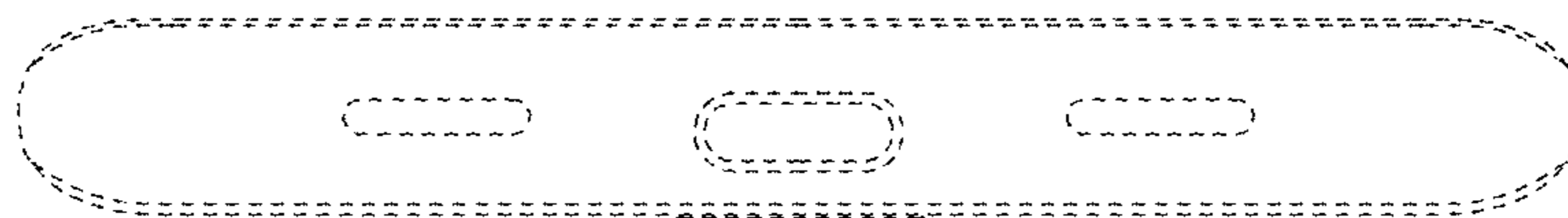
