FIG. 4 is a rear view of the smart glasses of FIG. 1.

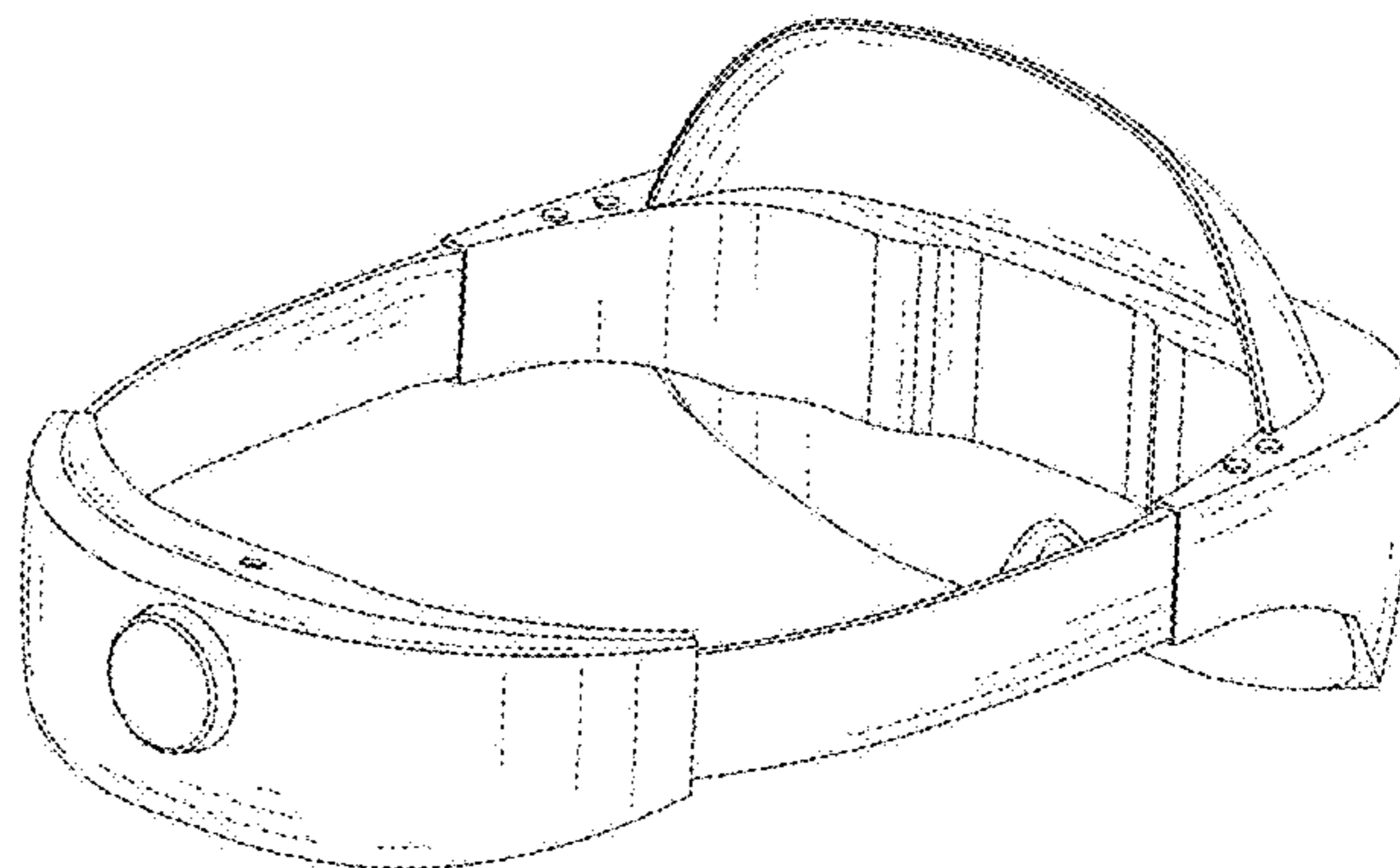
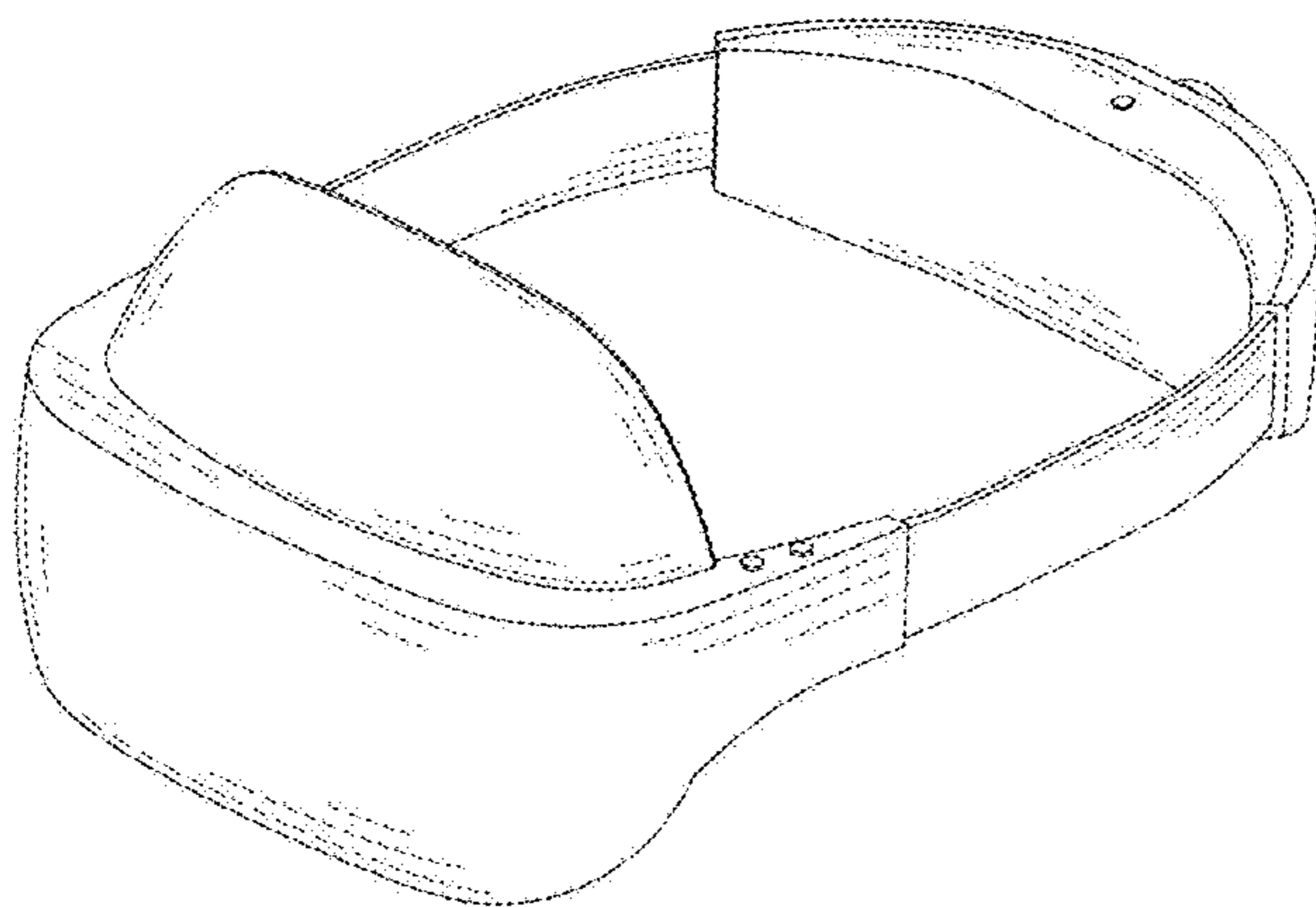
FIG. 5 is a left side view of the smart glasses of FIG. 1.

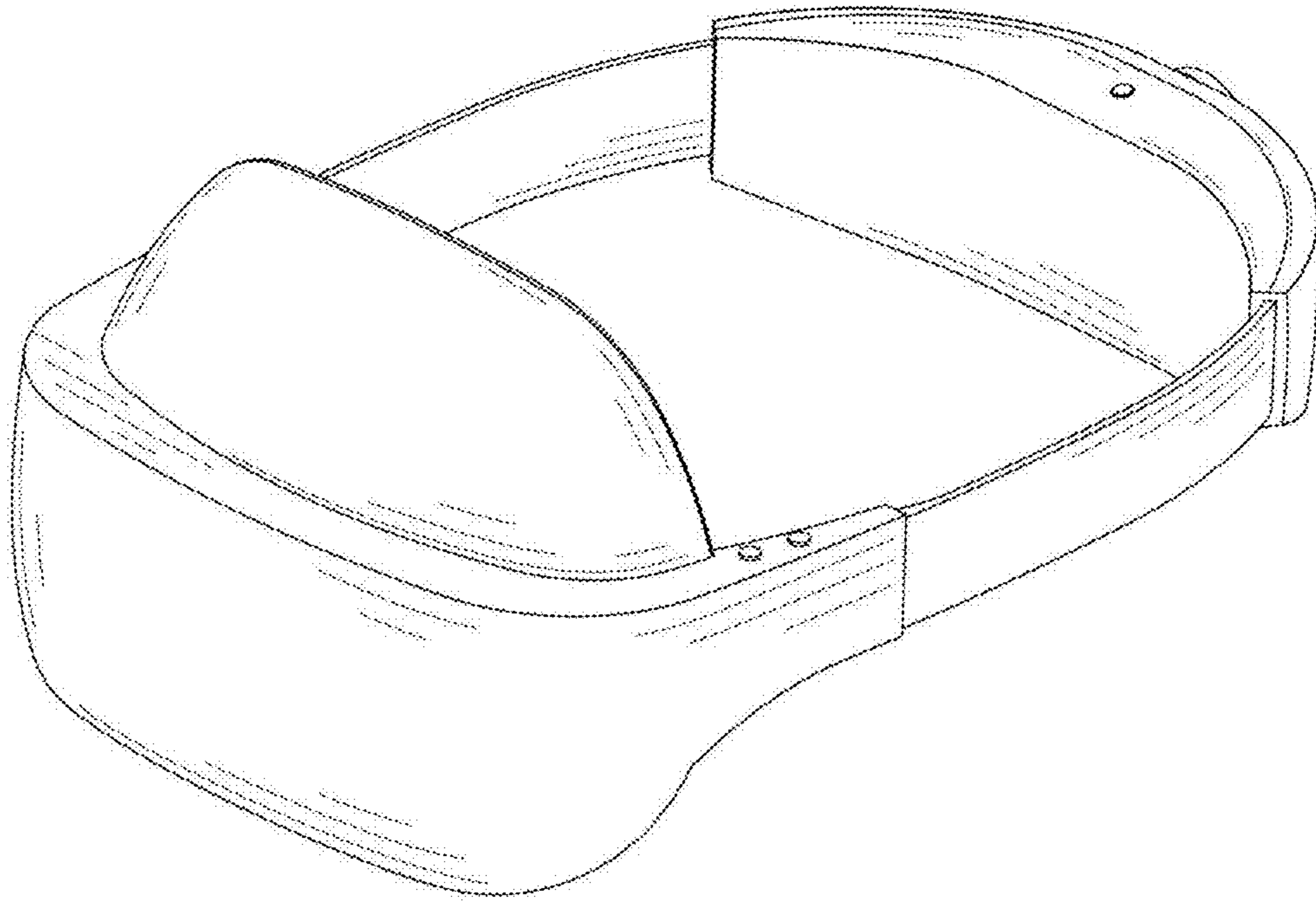

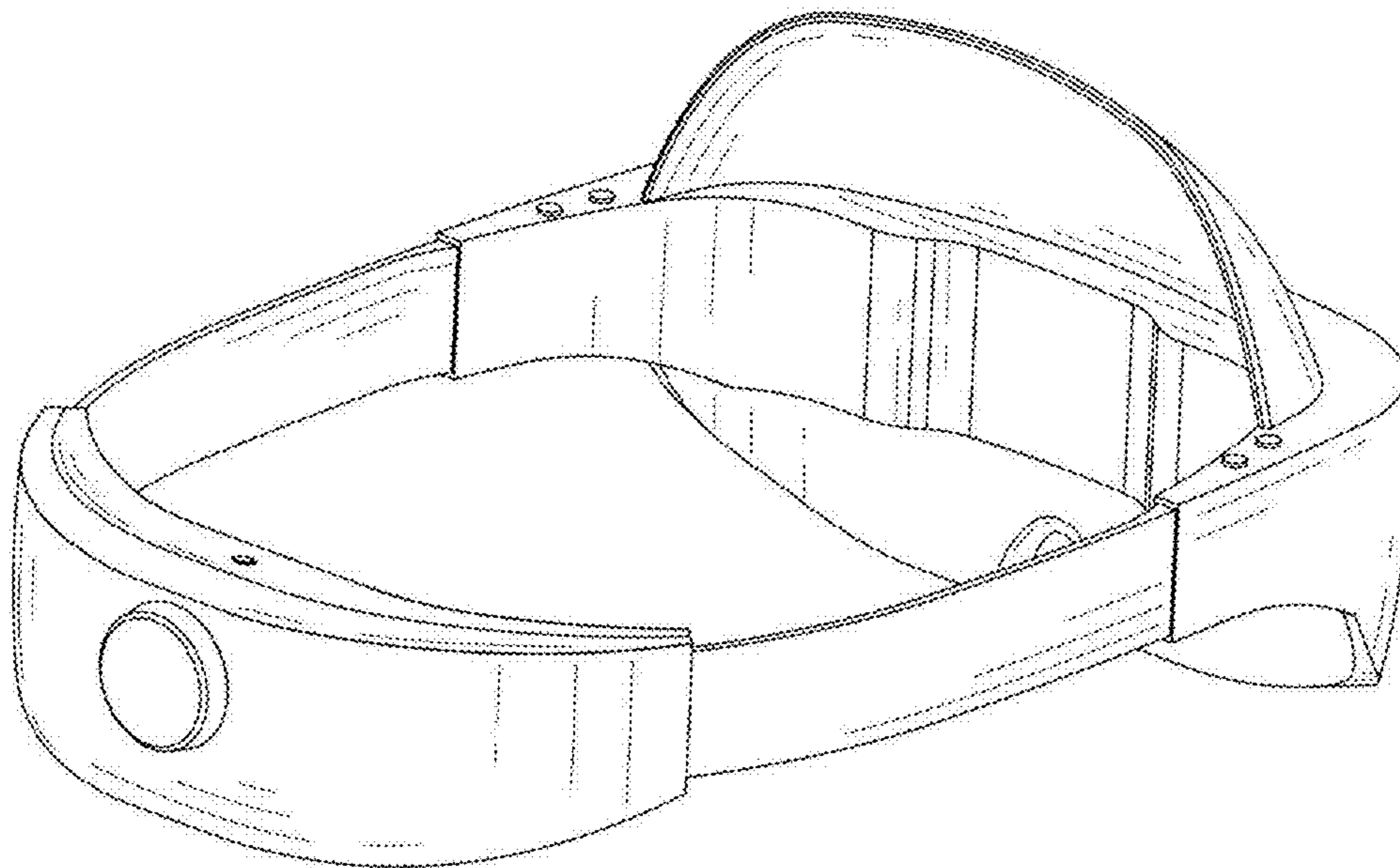

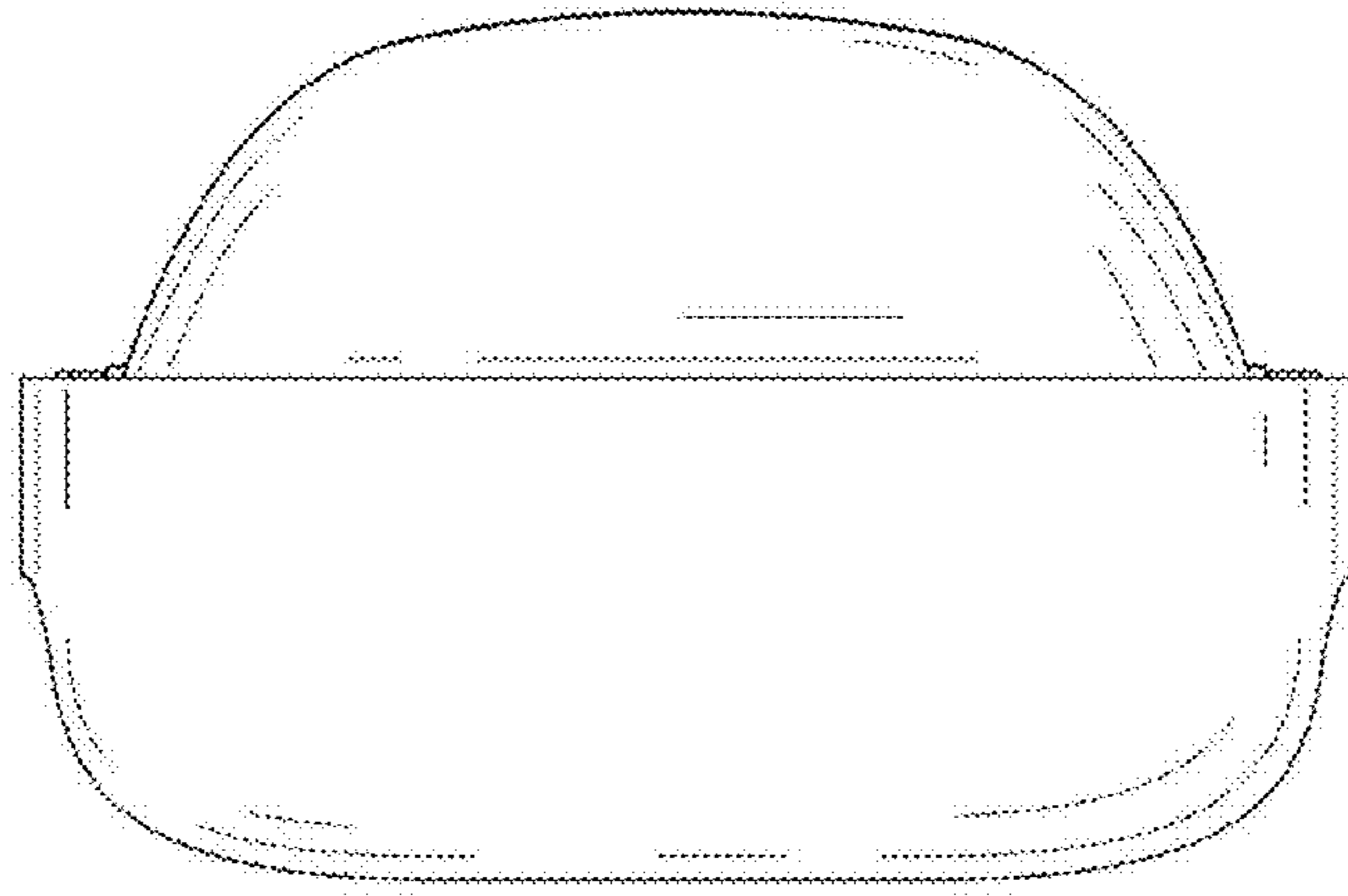

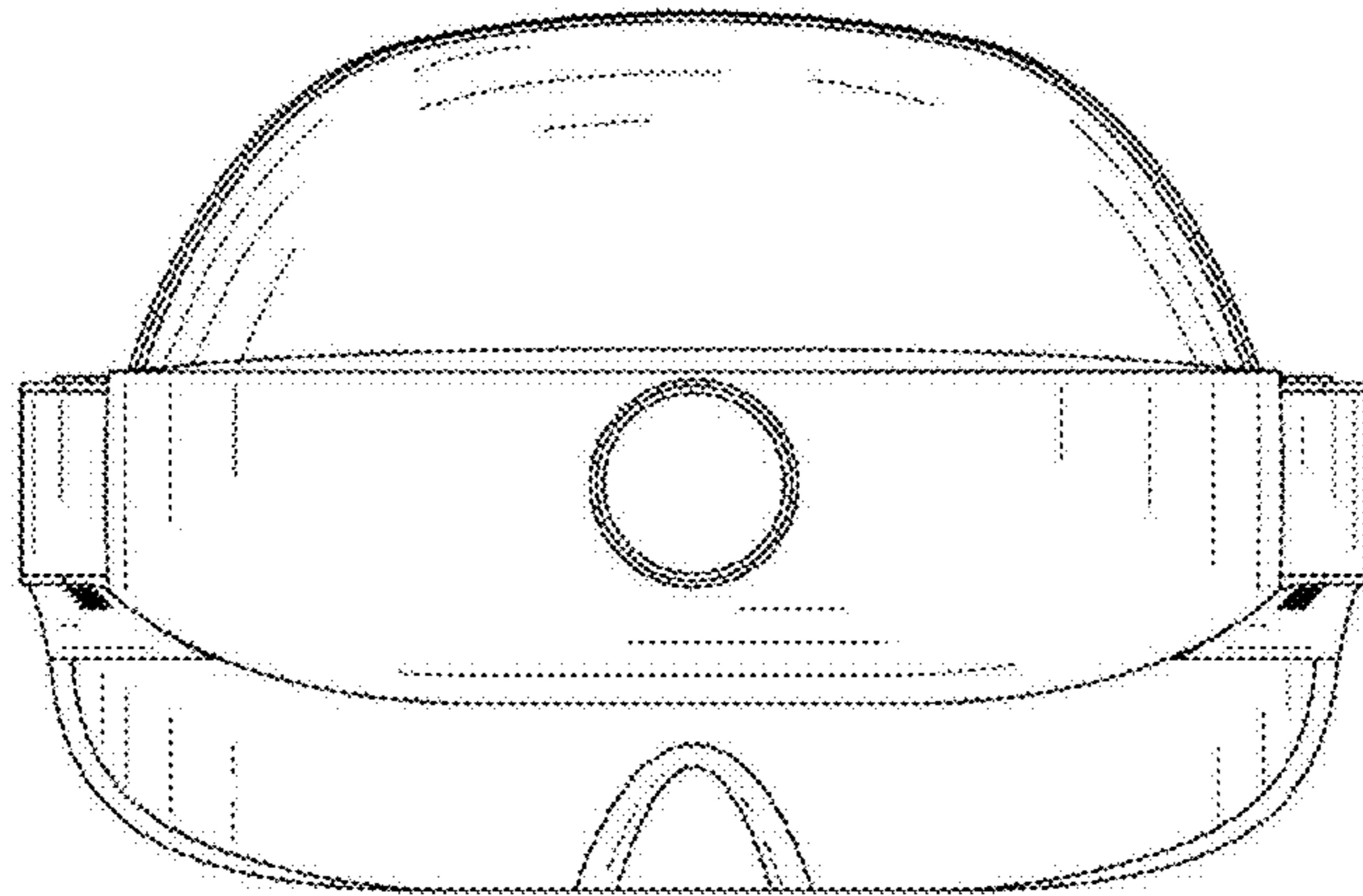

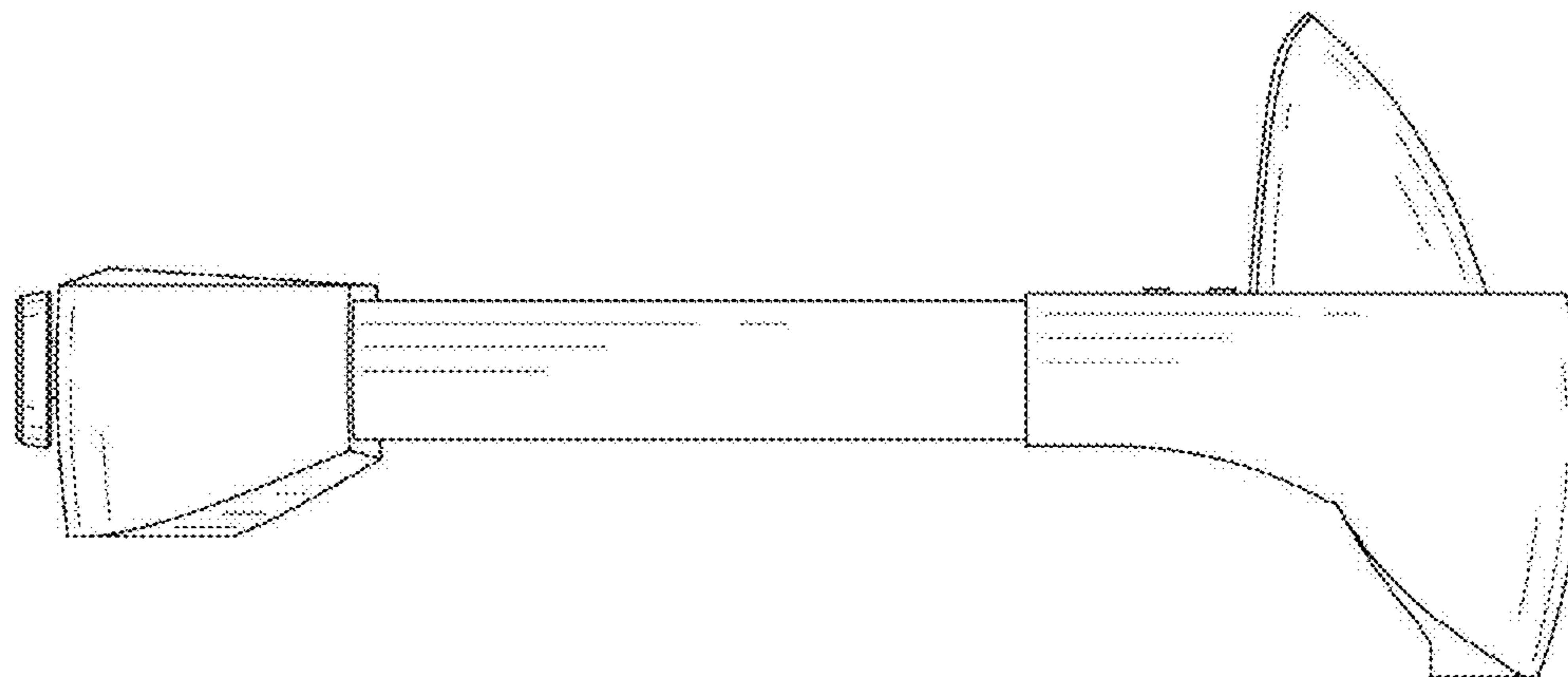

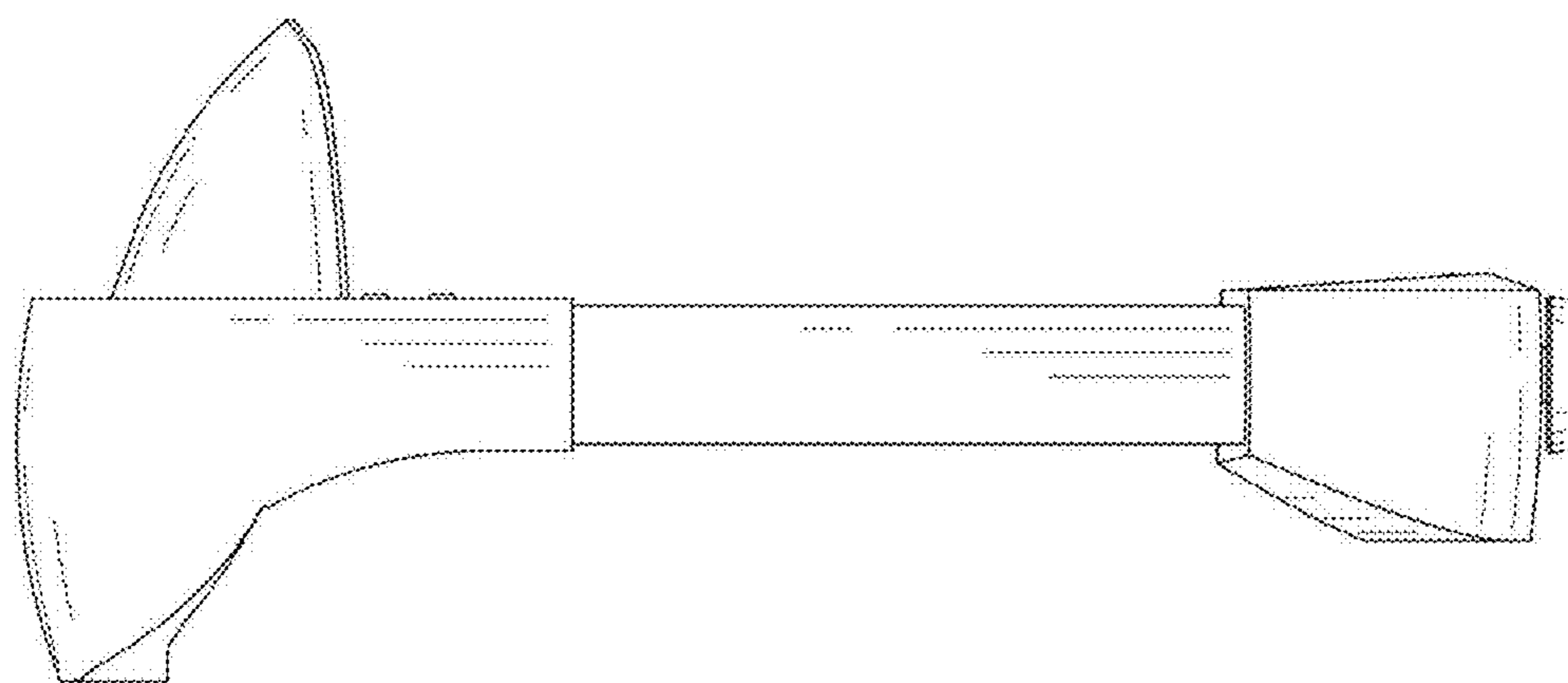

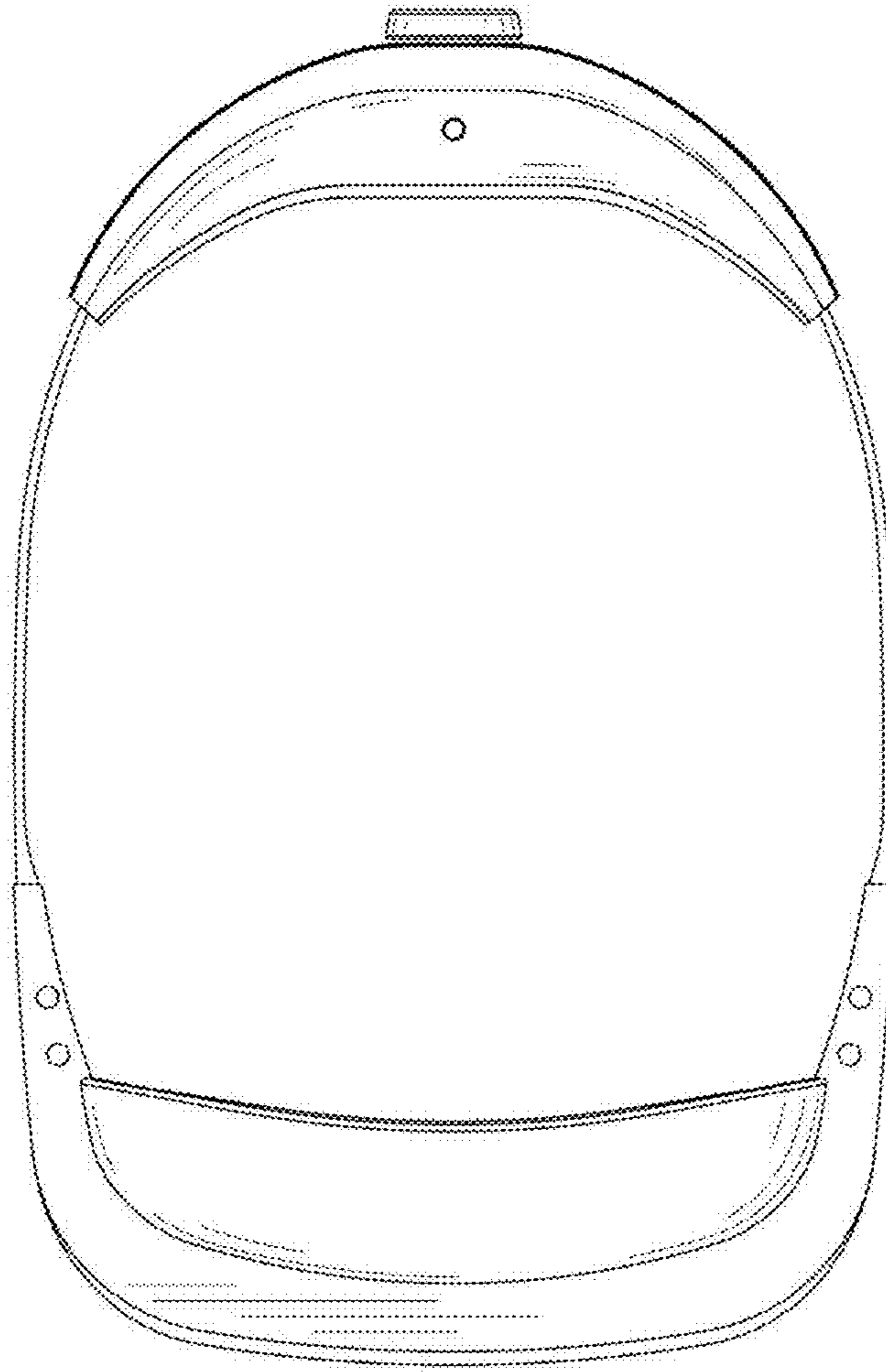

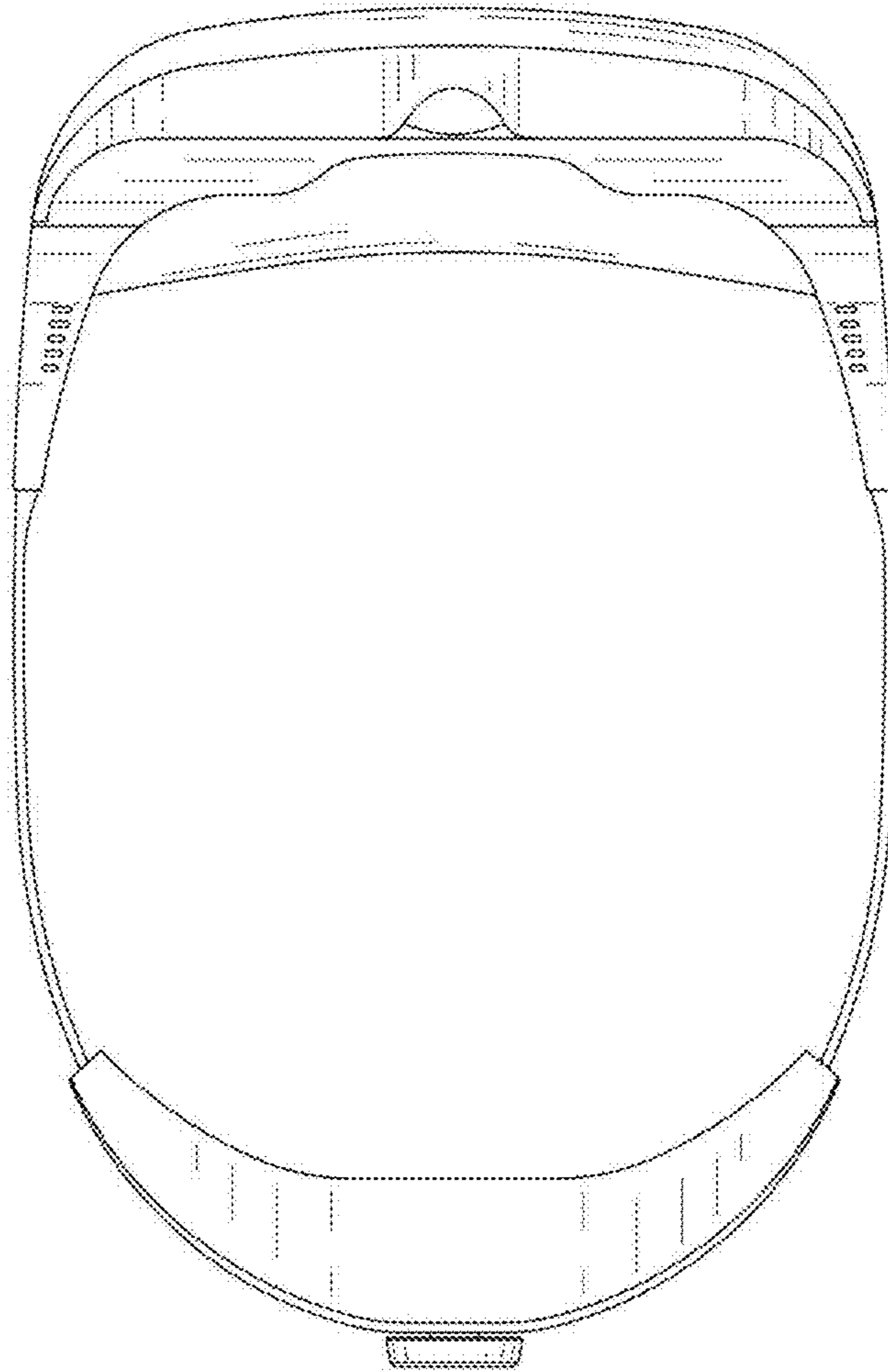
