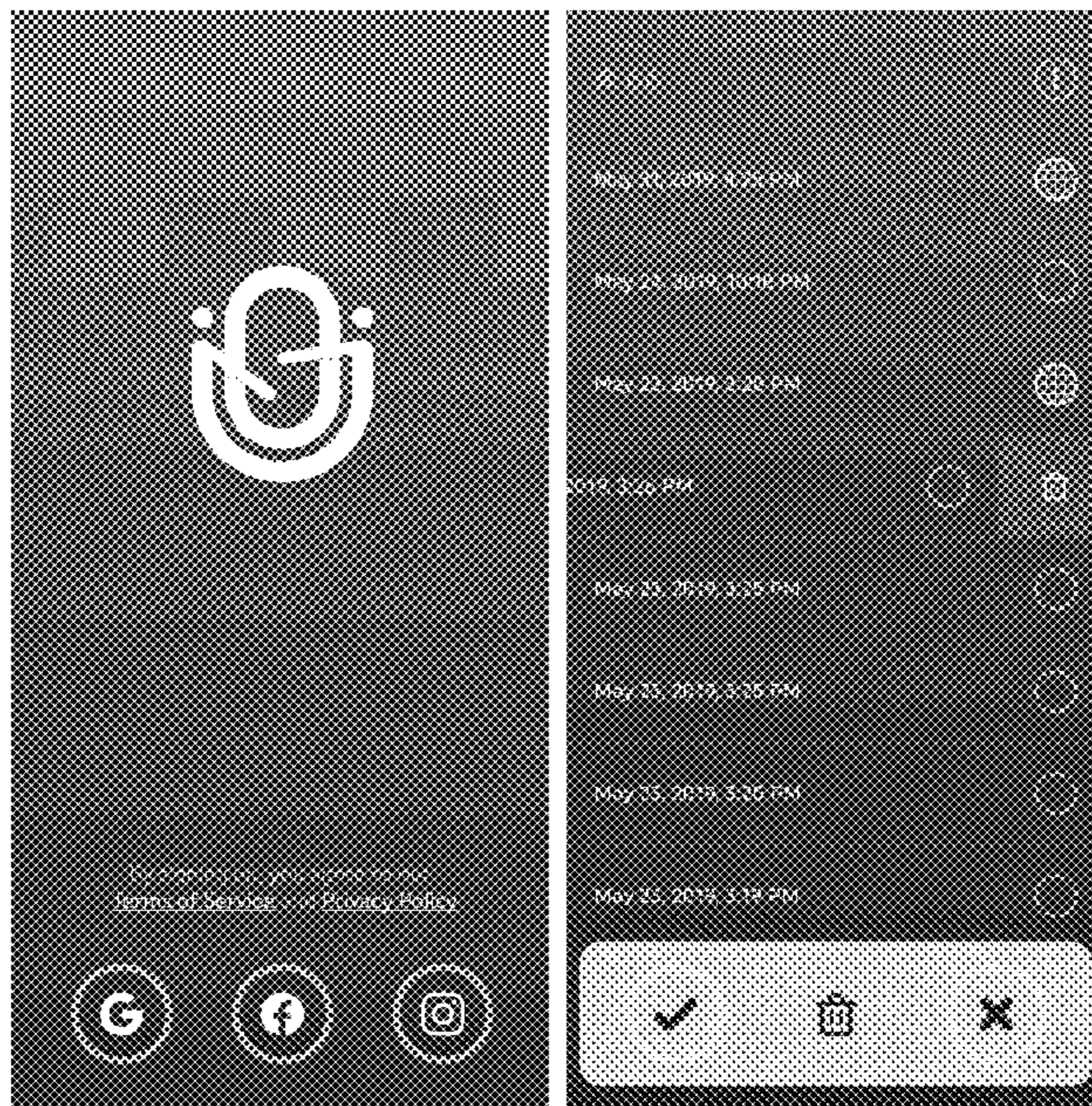
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 of the drawings is a first image in a sequence of the display screen or portion thereof with graphical user interface showing, in particular, the ornamental design thereof; FIG. 2 of the drawings is a second subsequent image thereof; FIG. 3 of the drawings is a third subsequent image thereof; FIG. 4 of the drawings is a fourth subsequent image thereof; FIG. 5 of the drawings is a fifth subsequent image thereof; FIG. 6 of the drawings is a sixth subsequent image thereof; FIG. 7 of the drawings is a seventh subsequent image thereof; FIG. 8 of the drawings is a eighth subsequent image thereof; and, FIG. 9 of the drawings is a ninth subsequent image thereof. The outer edge of the portion of the display screen is understood to be congruent with the outer edge of the graphical user interface. The appearance of the animated image sequentially transitions between the images shown in FIGS. 1 through 9. The process or period in which one image transitions to another forms no part of the claimed design. The actual characters of text of the images form no part of the claimed design.

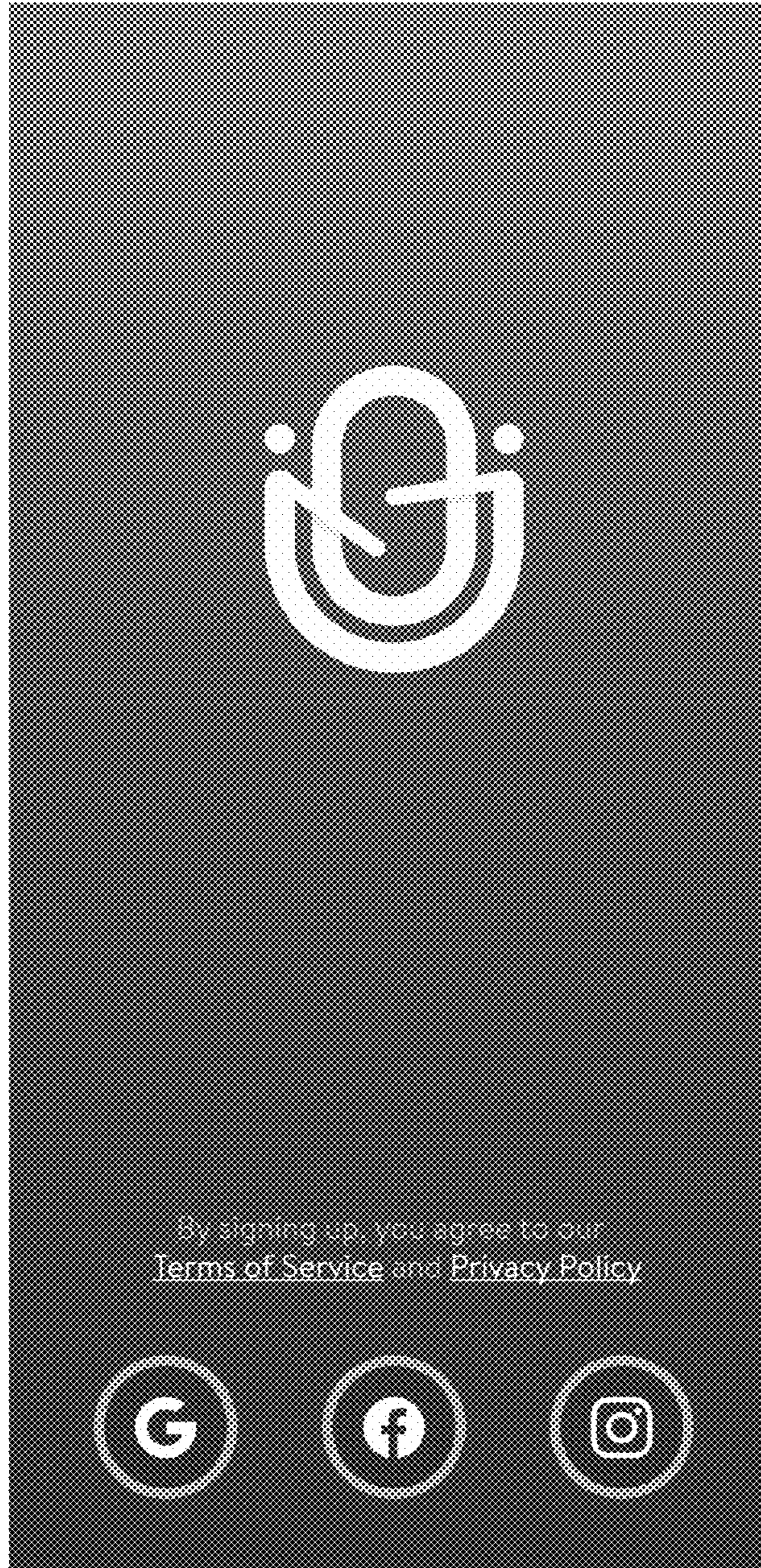

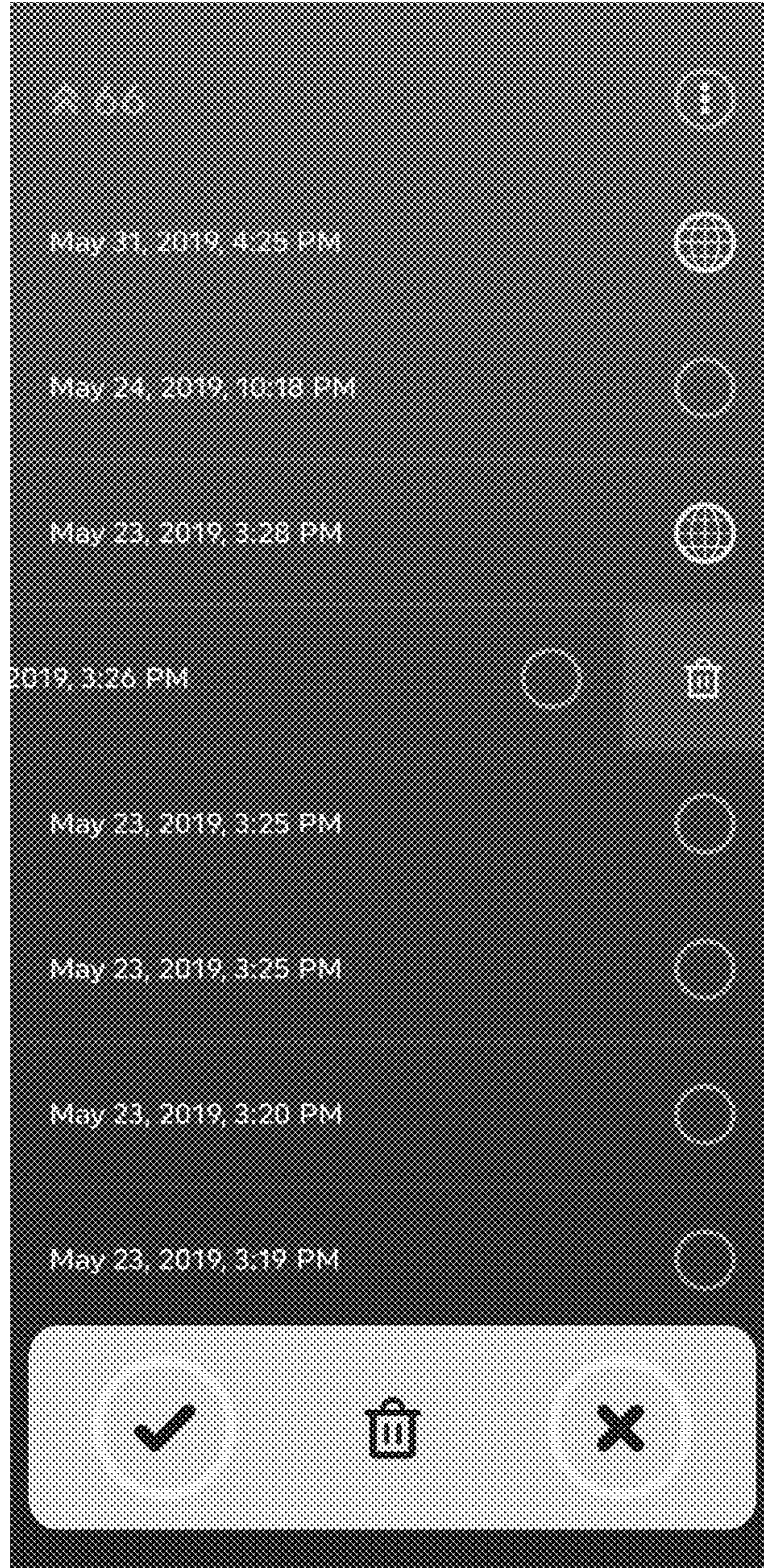

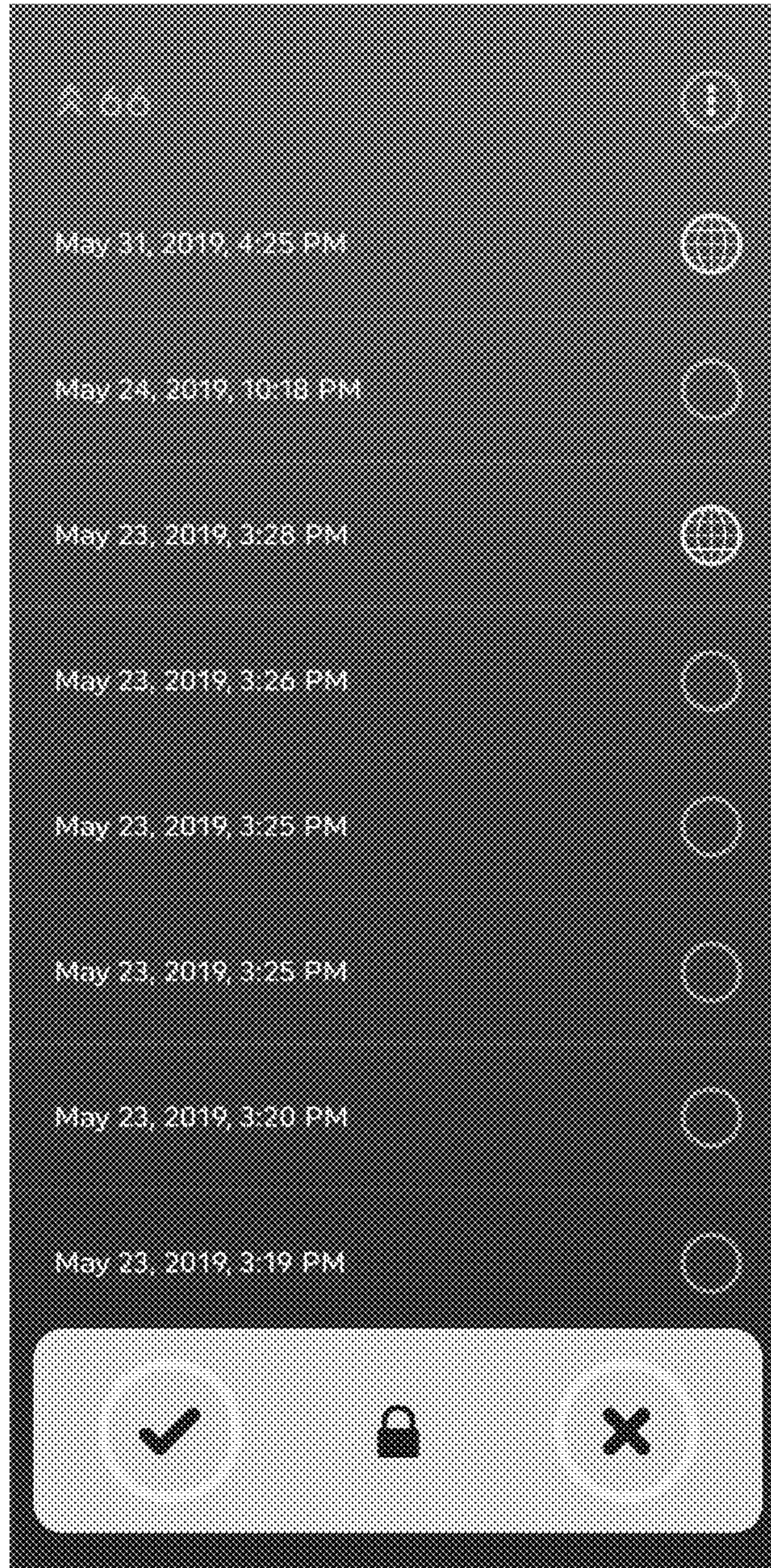

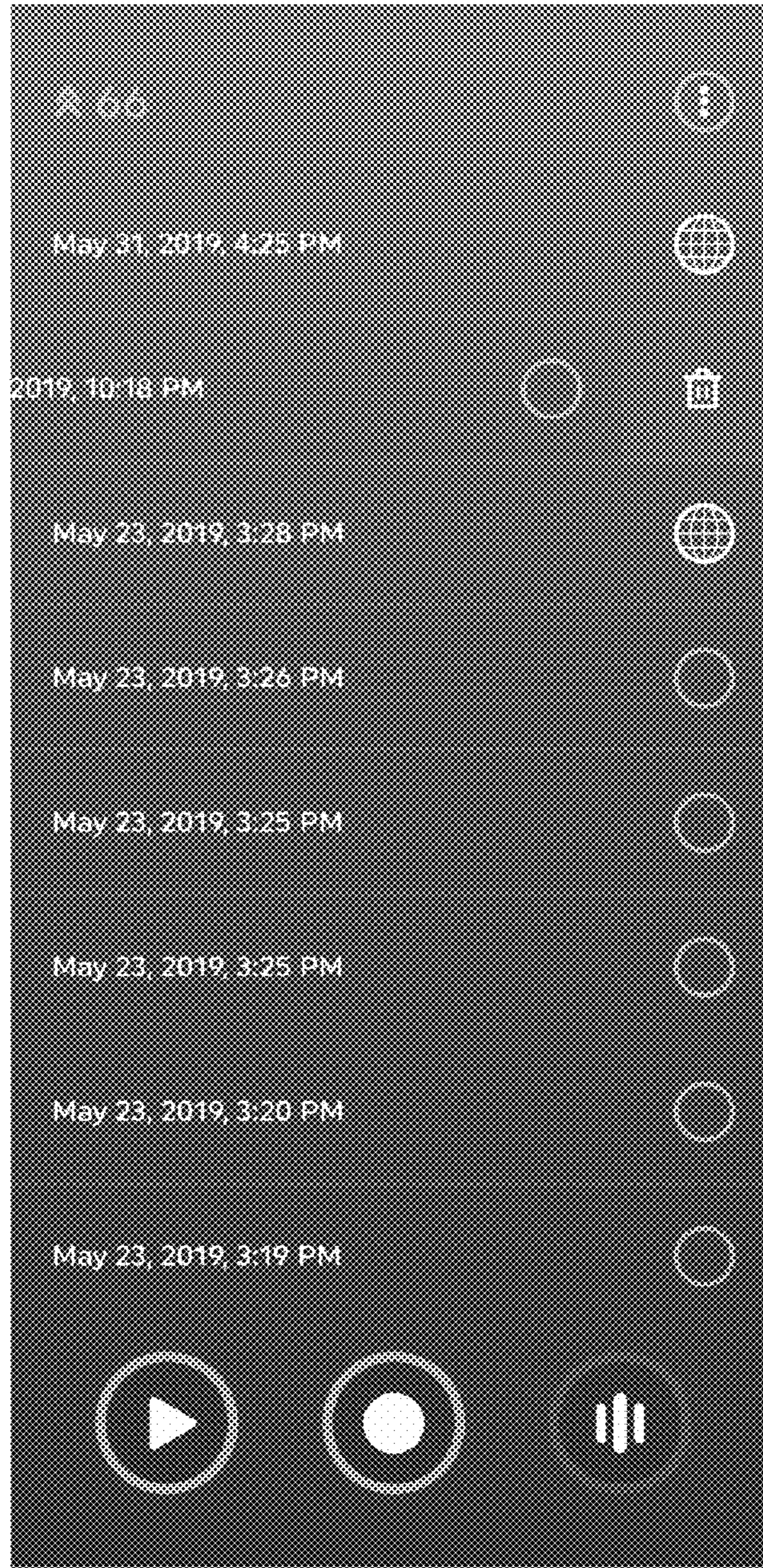

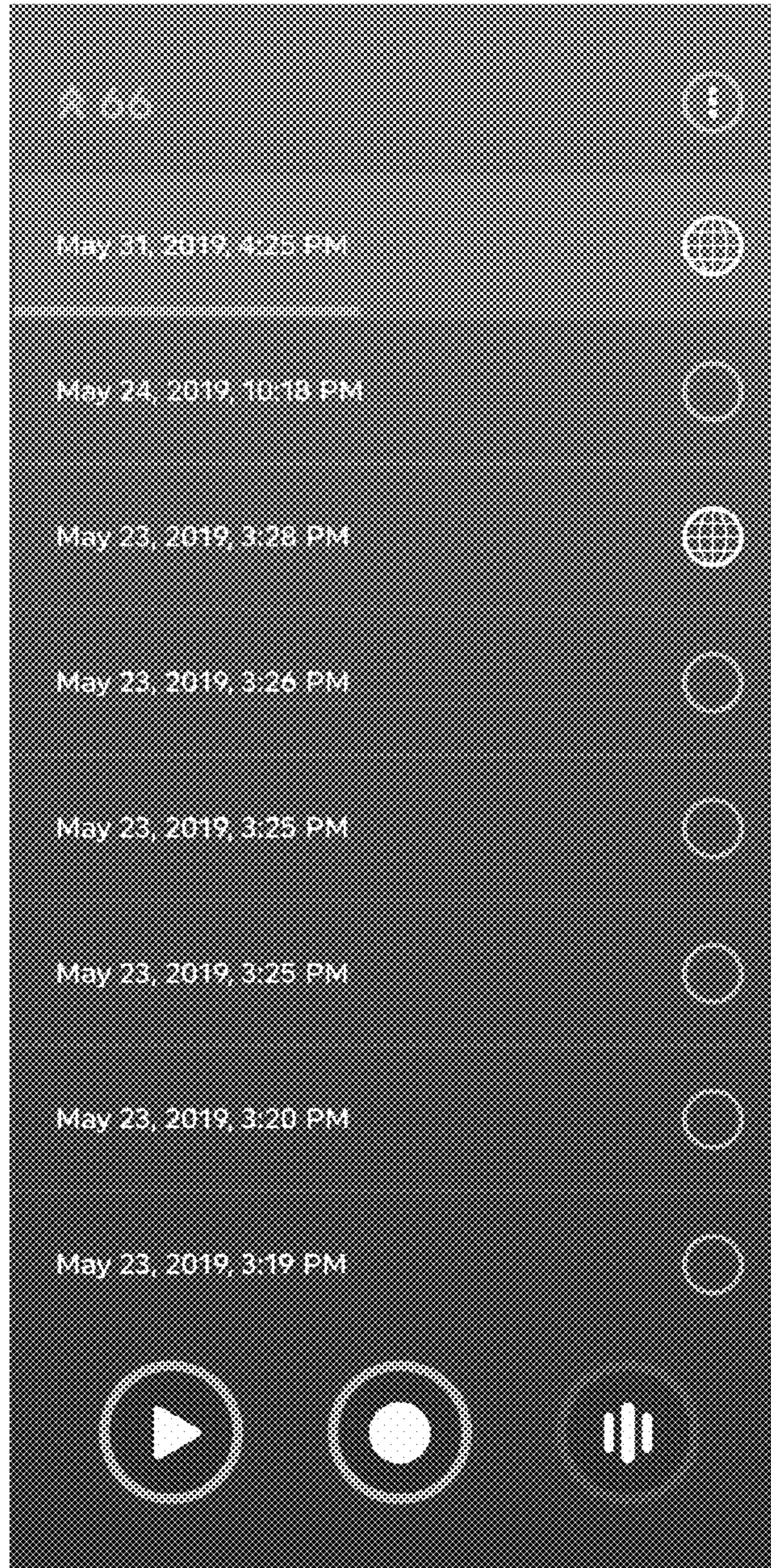

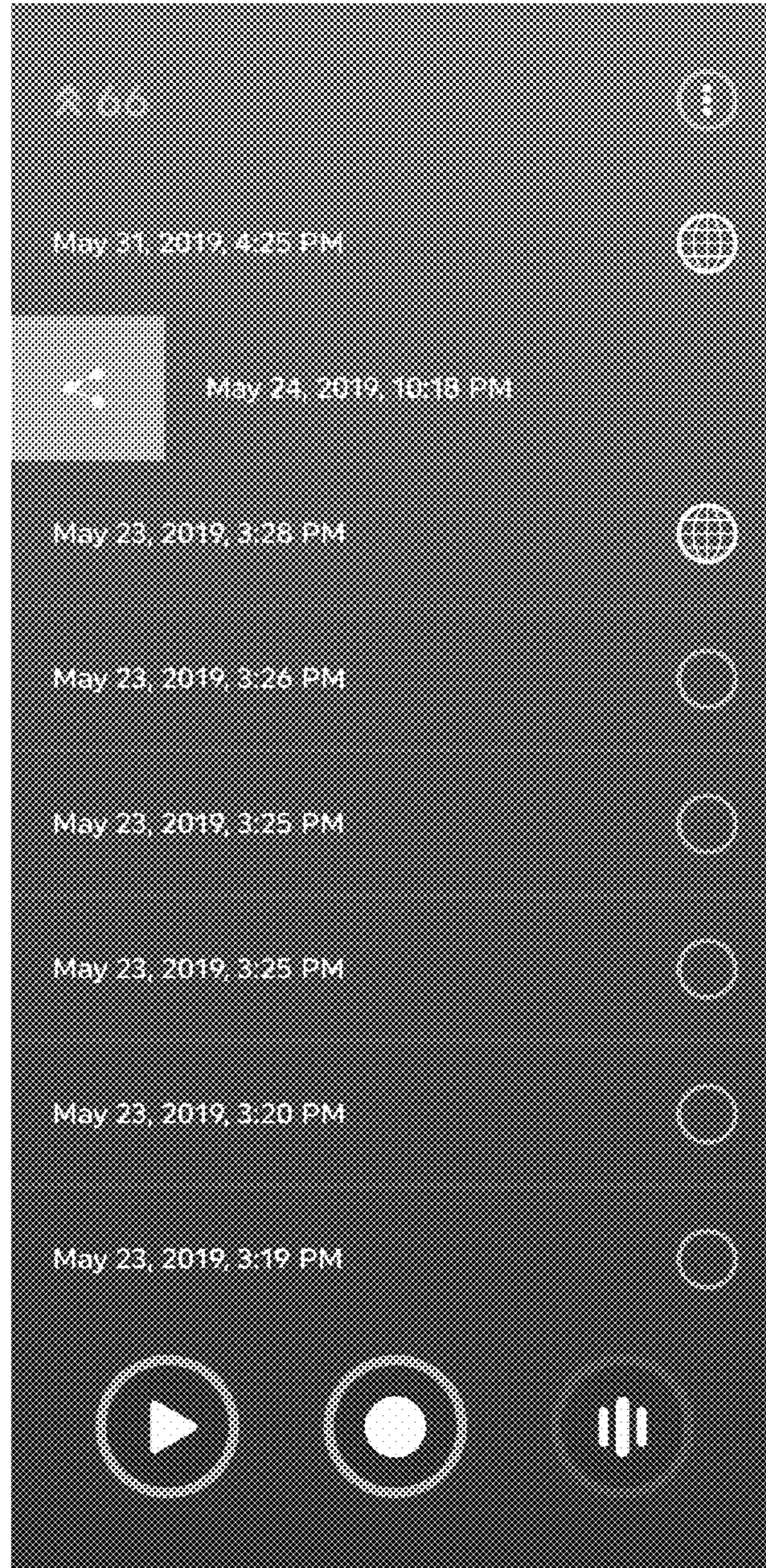

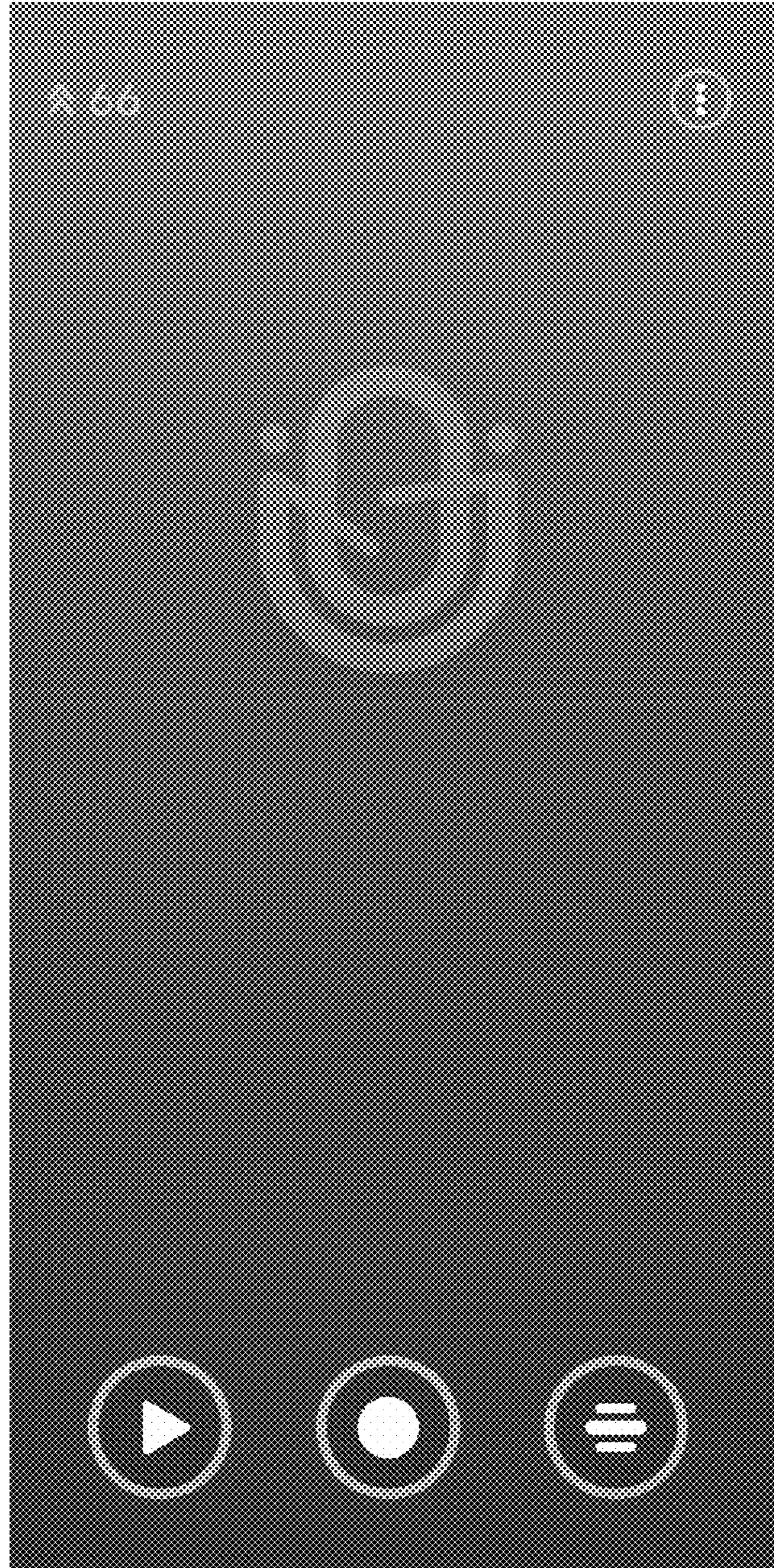

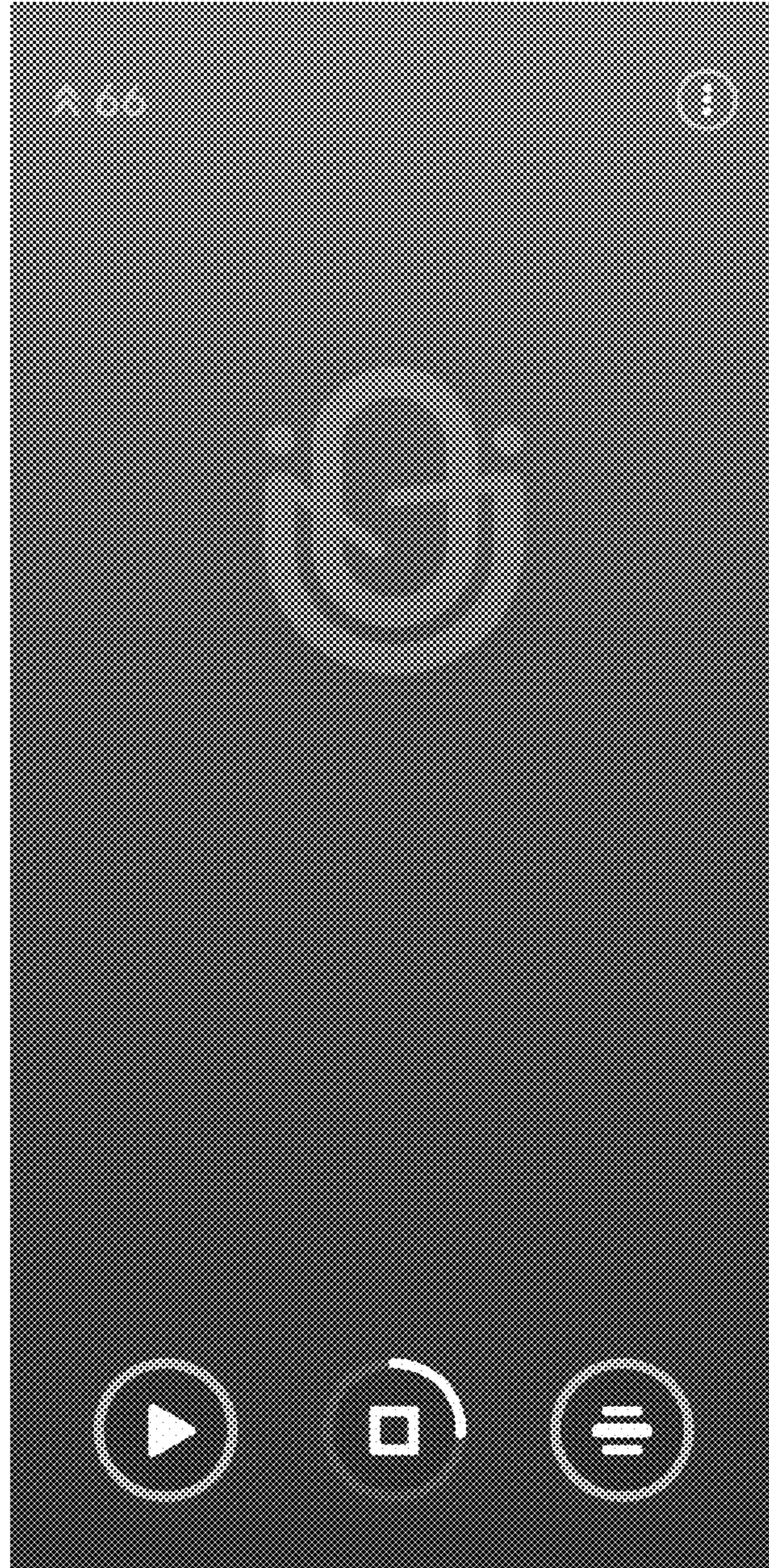
