DESCRIPTION

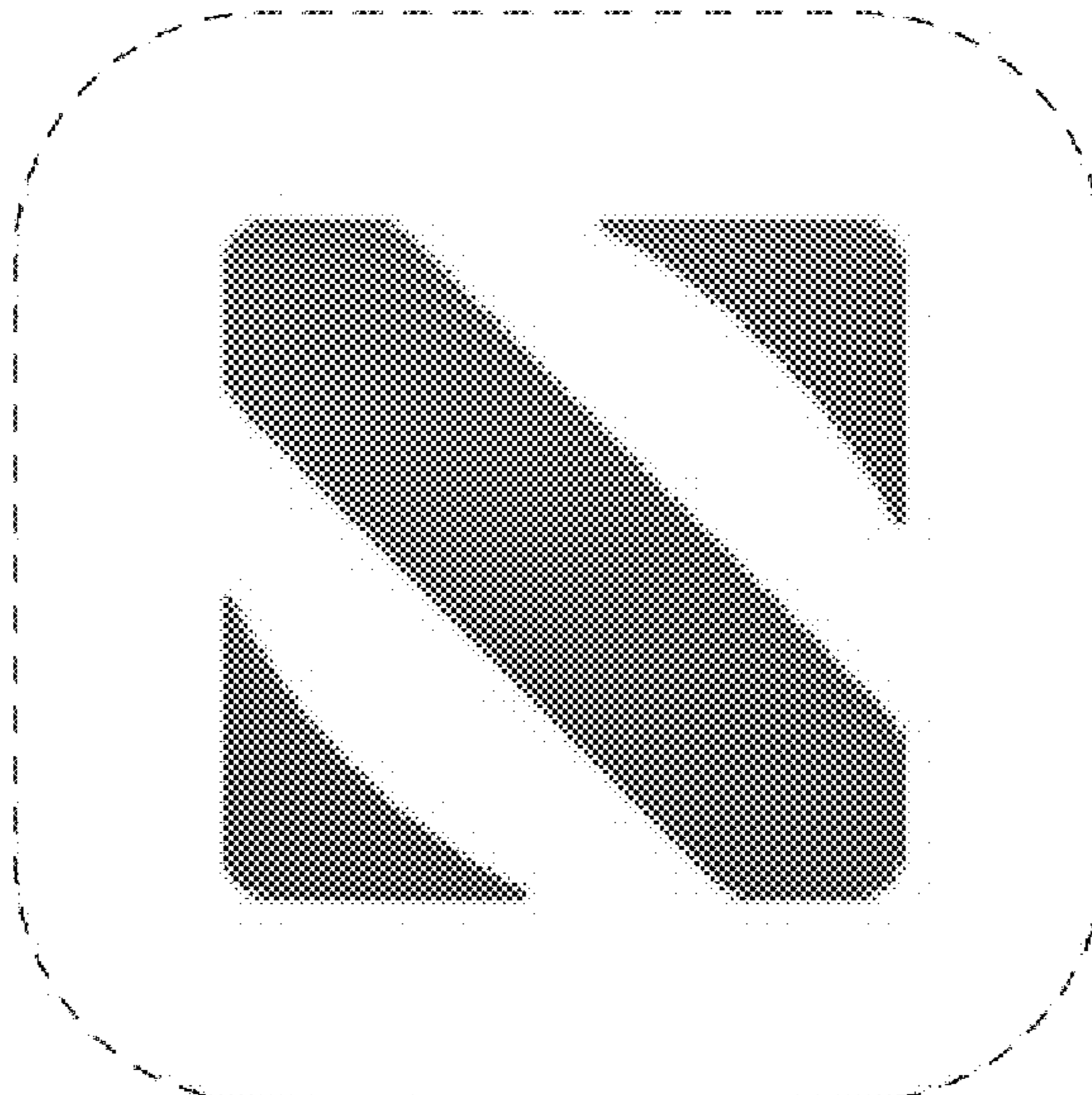

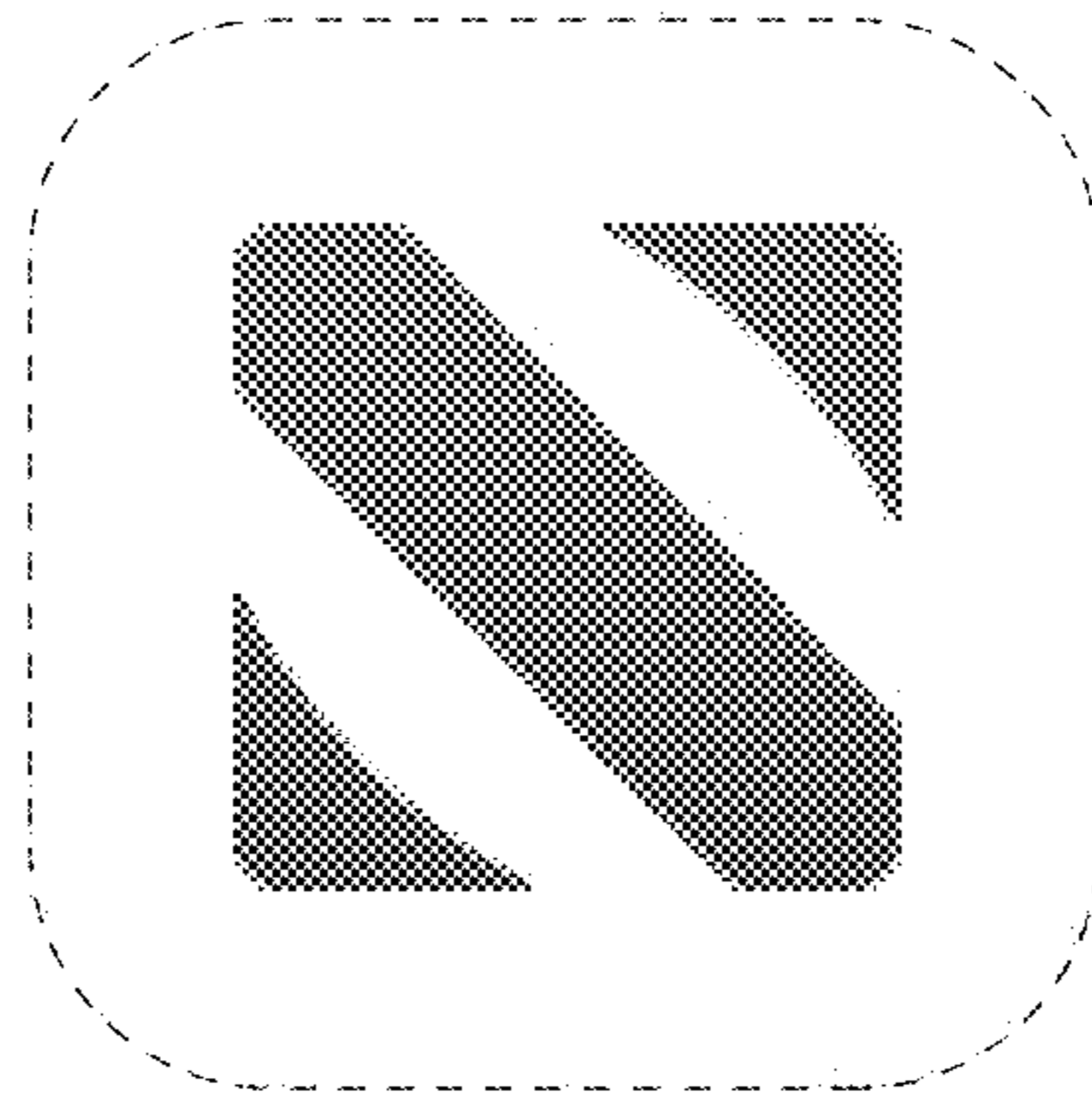
